# Therm alization of an anisotropic granular particle

W e investigate the dynam ics of a needle in a two-dim ensional bath com posed of therm alized point particles. C ollisions between the needle and points are inelastic and characterized by a norm al restitution coe cient < 1. By using the Enskog-Boltzm ann equation, we obtain analytical expressions for the translational and rotational granular tem peratures of the needle and show that these are, in general, di erent from the bath tem perature. The translational tem perature always exceeds the rotational one, though the di erence decreases with increasing m om ent of inertia. The predictions of the theory are in very good agreem ent with num erical sim ulations of the m odel.

## I. IN TRODUCTION

The dissipative nature of the collisions in granular systems leads to fundam entally di erent behavior from their therm al analogues. A striking example is the lack of energy equipartition between the degrees of freedom in granular systems. For example experiments [1, 2] and computer simulations [3, 4, 5] have shown that in binary mixtures of isotropic inelastic particles, the granular tem – peratures of the two species are di erent.

These results have prompted theoreticians to investigate some simple model systems. For example, M artin and P iasecki[6] exam ined the behavior of a spherical tracer particle immersed in a homogeneous uid in equilibrium at a temperature T. They showed that the Enskog-Boltzm ann equation of the tracer particle possesses a stationary M axwellian velocity distribution characterized by an elective temperature that is smaller than T.

A lthough m any granular system s contain particles that are m an ifestly an isotropic, m ost studies have been conned to spherical particles. A notable exception is the work of A spelm eier, H uthm ann and Z ippelius [7, 8] that exam ines the free cooling of an assem bly of inelastic needles with the aid of a pseudo-Liouville operator. They predicted an exponentially fast cooling followed by a state with a stationary ratio of translational and rotational energy. This two stage cooling was con med by event driven simulations.

In this work we exam ine the breakdown of equipartition in a steady state granular system containing an anisotropic particle. Motivated by the studies of Martin and Piasecki[6] and Aspelmeier, Huthmann and Zippelius[7, 8], we consider an in nitely thin inelastic needle immersed in a bath of point particles. Starting from the collision rules of this model, we derive the Enskog-Boltzmann equation. By assuming that the points are thermalized and that the velocity and angular velocity distributions of the needle are Maxwellian, we derive analytical expressions for the translational and rotational granular temperatures as a function of the m asses of the two species, the moment of inertia of the needle and the normal restitution coe cient. Both these tem peratures are sm aller than that of the bath. The rotational granular tem perature is usually lower than the translational one, except for very light bath particles for which the two are equal.

W e also report essentially exact num erical results obtained using a stochastic simulation m ethod. The theory is in very good agreement with the simulation, which validates the assumption of the M axwellian shape of the distribution functions.

#### II. MODEL

W e exam ine a two-dimensional system consisting of an in nitely thin needle of length L, mass M and moment of inertia I immersed in a bath of point particles each of mass m. The vector position of the center of mass of the needle and a point particle are denoted by  $r_1$  and  $r_2$ , respectively. The orientation of the needle is specified by a unit vector  $u_1$  that points along its axis. Let  $r_{12} = r_1 r_2$  and  $u_1^2$  denote a vector perpendicular to  $u_1$ . A collision between a needle and a point occurs when

The pre- and post-collisional quantities (the latter are labeled with a prime) obey the usual conservation laws:




FIG.1: G eom etry of the needle and a point in the plane:  $r_{12}$  denotes a vector joining the point labeled 2 and the center of the needle;  $u_1$  is a unit vector along the axis of the needle, is the algebraic distance between the center of the needle and the point of impact and  $u_1^2$  is a unit vector perpendicular to the axis of the needle. For a collision to occur one requires that j j L=2 when the point lies on the line de ned by the needle; i.e. when Eq.(1) is satisfied.

where k is a unit vector perpendicular to the plane such that  $k = u_1 \wedge u_1^2$ .

As a result of the collision, the relative velocity of the contacting points changes instantaneously according to the following relations:

where denotes the norm al restitution  $\cos$  cient. For the sake of simplicity we have taken the tangential restitution  $\cos$  cient equal to one. This choice is rejected in the form of Eq. (6).

By combining Eqs. (2)- (5) one obtains, after some algebra, the change of the needle momentum  $p = M (v_1^0 v_1)$

## III. PSEUDO-LIOUVILLE EQUATION

For particles with hard-core interactions, the kinetic evolution of N -particle distribution  $f(r^N; v^N)$  is described by a pseudo-Liouville operator, where  $r^N$  is a short-hand notation for the positions (and internal degrees of freedom, i.e. angle  $_1$  with the x-axis for the needle) of N particles and  $v^N$  for their velocities (and angular velocities for the needle). Originally derived for spheres and elastic collisions[9], the form alism has been extended to system s com posed of inelastic particles. Since collisions are instantaneous[10, 11], the pseudo-Liouville operator L  $(r^N; v^N) = L^0 (r^N) + \sum_{i < j} T_{ij}$  is the sum of the free particle stream ing operator  $L^0 (r^N)$  and of the sum of two-body collision operators  $T_{ij}$ . Since we are interested in the hom ogeneous state, the distribution function  $f(v_1; !_1)$  of the needle system is described by

where N is the total number of points,  $f(v_1; !_1; v_2)$  the distribution function of the needle and a point, and  $\overline{T}_{12}$  is the collision operator between a needle and a point.

The assumption of molecular chaos yields a factorization of the two body distribution  $f(v_1;!_1;v_2) = f(v_1;!_1)$  ( $v_2$ ), where ( $v_2$ ) denotes the point distribution function. Since the point particles are therm alized, a stationary state for the system (tracer needle and points) can be reached, and one nally obtains for the needle distribution

where T is the tem perature of the bath.

To build the point-needle collision operator,  $T_{12}$ , one must include the change in quantities (i.e. velocity and angular momentum) produced during the in nitesimal time interval of the collision. This operator is die erent from zero only if the two particles are in contact and if the particles were approaching just before the collision [7]. The explicit form of the operator is

where  $b_{12}$  is an operator that changes pre-collisional quantities to post-collisional quantities and (x) is the H eaviside function.

The other terms of the collision operator correspond to the necessary conditions of contact (L=2  $\,$

For an isotropic tracer particle in an isotropic particle bath, M artin and P iasecki[6] solved the stationary Enskog-Boltzm ann equation, showing that the velocity distribution of the tracer particle remains gaussian in a thermalized bath. It is worth noting that for nite dilutions, the velocity distribution function is not M axwellian  $\beta$ ], but the deviations from the gaussian shape of the distribution function of the velocities (that can be calculated in a perturbative way) yields small corrections to the estimate of the granular temperature. M ore signi cant deviations are expected for nite dilution system s[12].

For a mixture of a needle and points, one can show that a M axwell distribution of the needle angular and translational m om enta cannot be a solution of the stationary Enskog-Boltzm ann equation even for the case of an in nitely diluted needle. This is due to the fact that the change ofm om entum depends on the location of the point of im pact on the needle (the right-hand side of Eq. (7) depends on ). However, we im pose gaussian distributions for the translational and angular velocities of the needle. W e show below that this is a very good approxim ation.

In the stationary state, the loss of translational and rotational kinetic energies is on average zero and can be expressed by m eans of the collision operator

where the brackets denote an average over the independent variables. This corresponds to taking the second m om ents of the distribution function of the needle. A fter substitution of the collision operator (Eq.(13)), one obtains explicitly for the translational kinetic energy Z Z

A similar equation can be written for rotational kinetic energy. The needle distribution function  $f(v_1;!_1)$  is then given by

where  $_{\rm T}$  and  $_{\rm R}$  are the ratios of the translational and rotational needle tem peratures to the bath tem perature, respectively.

By inserting Eq. (16) in Eq. (15) and in the corresponding equation for the rotational energy one obtains, after som e tedious but straightforward calculation (outlined in Appendix A), the following set of equations



Explicit expressions for the integrals appearing in Eqs. (17) and (18) are given in Appendix B. Eq. (18) is an implicit equation for a that, for a given value of , can be solved with standard num ericalm ethods. b is then easily obtained by calculating the ratio of integrals of Eq. (17). Finally, from the values of a and b,  $_{\rm T}$  and  $_{\rm R}$  can be obtained from Eqs.(20)-(21).

# IV. RESULTS

We rst note that for the elastic case, = 1, we have the solution a = b = 1 which gives  $_{T} = 1$  and since  $a=b=_{R}=_{T}$ ,  $_{R} = 1$  which corresponds to the equilibrium case[13, 14].






FIG. 2: Ratio of the translational (full curve)  $_{\rm T}$  and rotational  $_{\rm R}$  (dashed curve) granular temperature to the tem – perature of the bath versus the norm all restitution coelection for a hom ogeneous needle with M = m.

Figure 2 shows the ratio of the translational tem perature to the bath tem perature and of the rotational tem – perature to the bath tem perature for a hom ogeneous needle (I = M  $L^2=12$ ) whose m ass is equal to the m ass of a bath particle. As the norm al restitution coe cient decreases from 1 to 0 both ratios decrease m onotonically from 1 to a strictly positive value, such that the translational tem perature is always larger the rotational tem – perature. An analogous situation has been noted for the free cooling of needles in three dim ensions[7].

Figure 3 shows the same ratios for an inhom ogeneous needle (I = M  $L^2=16$ ) corresponding to relatively lighter ends and a heavier center. A gain the translational tem – perature is always larger than the rotational tem perature, and the di erences are greater than for a hom ogeneous needle. The di erence between the two tem – peratures vanishes in the lim it of very large m om ent of inertia. Contrary to the free cooling state of needles [7], there is no \critical" value of the m om ent of inertia above which the rotational tem perature is larger than the translational tem perature.

W e now return to consideration of a hom ogeneous needle and investigate the e ect of varying the mass ratio, m = M, at constant norm all restitution coe cient. W hen m = M ! 0, k ! 0, which gives a = b = (1 + )=2. Hence, for very light bath particles, equipartition between translational and rotational granular tem peratures is asymptotically obtained and we have


[6]. We conjecture that the result is independent of the shape of the tracer particle and the dimension.




FIG. 4: Ratio of the translational (full curve)  $_{\rm T}$  and rotational  $_{\rm R}$  (dashed curve) granular temperature to the tem – perature of the bath versus the ratio of the m asses m =M for a hom ogeneous needle (I = M L<sup>2</sup>=12) and = 0.9.

Figure 4 displays the variation with the mass ratio of the translational and rotational tem perature of the tracer needle. Note that when the mass of the bath particles is very small compared to the needle particle, the two curves go to the limit given by Eq. (22).

## V. SIM ULATION

In order to assess the accuracy of the theory we developed a D irect Sim ulation M onte C arlo (D SM C) code to obtain num erical solutions of the non-linear hom ogeneous B oltzm ann equation. The sim ulation generates a sequence of collisions with a variable time interval between each.

At the beginning of each step, we rst calculate the total ux of colliding particles on both sides of the needle which is a function of the component of the velocity of the center of m as norm al to the length of the needle  $v_1 u_1^2$  and the angular velocity !. Next a waiting time to the next collision is sampled from an exponential distribution with rate constant equal to the total ux. The needle is rotated at its current angular velocity to the point of collision. The location of the collision is then selected with a probability proportional to the position dependent ux. The ratio of the ux on the left hand side to the total ux is then compared to a uniform random number between zero and one. If the ratio is greater than the random number, the collision occurs on the right; otherw ise is occurs on the left. The norm al

component of the colliding point is then selected from a gaussian ux. Finally, the collision rules are applied and the norm alvelocity and angular velocity of the needle are updated.

The simulation results for  $10^7$  collisions per run are compared with the theory in Figs. 2-3. A lthough the theory is not exact, the agreem ent is excellent. The discrepancy between simulation and theory is never greater than 1% whatever the value of the restitution coe cient. In Fig. 4, when the mass of the needle increases, the granular temperatures obtained by simulation are slightly sm aller than the analytical result.




FIG. 6: Sam e as 5, except the angular velocity is shown.

Fig. 5 and Fig. 6 show the translational and angular velocity distributions, respectively, for two di erent values of the normal restitution coe cient (0.5 and 0.9). On the scale of the plot, the simulated distributions are in quantitative agreem ent with gaussian distributions at the corresponding theoretical granular tem perature, con-

m ing the validity of employing the latter in the theory.

# VI. CONCLUSION

We have shown that the translational and rotational granular temperatures of an anisotropic tracer particle immersed in a bath of point particles depend on the ratio of the masses of a point and the needle and the moment of inertia. They are, in general, not equal and differ from the bath temperature. In addition, we found that equipartition is obtained asymptotically, regardless of the normal restitution coe cient, for very light bath particles. We expect this to be a general feature, i.e. in

higher dimensions and for arbitrary shaped anisotropic particles. It should be possible to test this prediction experimentally.

# APPENDIX A:NEEDLE AVERAGE ENERGY LOSS

As for binary m ixtures of spheres[3], we use a gaussian ansatz for the distribution functions and introduce two di erent tem peratures corresponding to the translational and rotational degrees of freedom of the needle. The hom ogeneous distribution functions of the needle and of the points are then given respectively by

where T is the temperature of the bath,  $_{\rm T}$  and  $_{\rm R}$  the ratio of the translational (and rotational) temperature of the needle to the bath temperature.
