Second Quantized R educed B loch Equations and the Exact Solutions for Pairing H am iltonian

A bstract

In this article, we present a set of hierarchy B loch equations for the reduced density operators in either canonical or grand canonical ensembles in the occupation number representation. They provide a convenient tool for studying the equilibrium quantum statistical mechanics for som e m odel system s. As an example of their applications, we solve the equations for the m odel system with a pairing H am iltonian. W ith the aid of its symplectic group symmetry, we obtain the statistical reduced density matrices with di erent orders. As a special instance for the solutions, we also get the reduced density matrices of the ground state for a superconductor.

1 Introduction

The language of the second quantization is a convenient and ubiquitous tool for studying the quantum m any-body systems in m odern physics. The quantum statistics of the identical m any particles is automatically satis ed by the commutation relations of the creation or annihilation operators, and the complicated m athematical m anipulation with wavefunctions such as Slater determinants and with matrix elements of operators is significantly simplied. It is no surprise that a familiarity with the related know ledge of the occupation number representation is a must for a serious theorist.

In a recent paper, we have developed an equation of motion approach for a direct determ ination of the reduced density matrices for the statistical ensem bles under the fram ew ork of equilibrium quantum statistical mechanics [1-4]. We have derived the hierarchy B loch equations which provide the laws according to which the reduced statistical density operators vary in tem perature. We also take the orbital approximation, and solve the equations for the identical ferm ion systems with two-body interaction in a grand canonical ensemble. We have gained signi cant new physical insights. We nd that the usual Ferm iD irac statistics for the free ferm ion gas holds also for the interacting ferm ions, and that the usual Hartree Fock equation at zerotemperature can be extended to the case of any nite temperature. The mean force eld that every orbital or particle is subject to will be from the contribution of both coherent and incoherent superpositions of the wavefunctions of other orbitals or particles, and is therefore tem perature-dependent [5-8]. This opens a way for investigating the interplay between the microscopic structure and m acroscopic therm odynam ic quantities for m olecules

and solids [5-9]. In addition, the Ferm i-D irac distribution for interacting particles dem onstrates that there exists an elective one-particle description for the interacting m any-body system [2,10].

In the current paper, we begin the presentation of the scheme for an exact solution of the reduced B loch equations which will be developed in a second quantized form. In quantum many-body theory, the systems are offen represented by the model H am iltonians in an occupation number representation. We study the pairing H am iltonian, which is a useful model for the study of nuclear structure [11,12], m icroscopic state of superconductors [13,14], and electronic structure of molecules [15,16].

We organize this paper as follows. In the next Section, starting from the B loch equation, we deduce a set of hierarchy equations in the occupation number representation for the reduced density operators in the canonical ensemble. The derivation is based on the second quantized form of the contraction operator which is presented in the Appendix. We also extend it to the case of a grand canonical ensemble. In Section 3, we rest brie y review the sym plectic group sym metry of the pairing H am iltonian and present the second quantized form of its eigenvectors characterized by the particle number, the weight and the seniority number. Then using the sym metric conditions am ong D¹, D² and D³, we solve the reduced B loch equations in the canonical ensemble for the pairing H am iltonian and obtain its canonical reduced density matrices with di erent orders. As a special situation, they yield the reduced density matrices of the ground state for the superconductor. We conclude our discussion in the nal Section.

2 Reduced Bloch Equations in the Occupation Number Representation

We consider an identical N -ferm ion system with a two-body interaction. Its Ham iltonian has the following form ,

where h (i) and v (i; j) are one- and two-particle operators, respectively. A sum e a generic and complete set of single-particle states $f_{jl} > g$, which form a single-particle H ilbert space V. For each $j_l >$, the corresponding creation or annihilation operators are de ned as

This is a set of second quantized reduced Bloch equations for the reduced density matrices in the grand canonical ensemble.

- 3 Reduced Density Matrices with Di erent Orders for Pairing Hamiltonian
- 3.1 The Pairing Ham iltonian and its Eigenvalues and Eigenstates

Prior to solve the reduced B loch equations in the case of the canonical ensemble for a pairing H am iltonian, we need to review its eigenvalue problem as well as related symmetry properties which is discussed in details in paper [26].

 (2). The second term of the H am iltonian indi-
cates that the interaction is only for the pairing states of the particles, and
is therefore called the pairing force. The matrix element of the interaction
is represented by a constant G. W hen G > 0, the interaction is repulsive;
when G < 0, the interaction is attractive.

Since the pairing Ham iltonian Eq. (22) exhibits a symplectic symmetry, its N-particle eigenstates should be the basis vectors of the irreducible representation space of the symplectic group, and can be characterized by its weight [30]. For the symplectic group Sp(2) and its corresponding Lie algebra C , the weight is the eigenvalue for the generator,

which is the di errence of occupation numbers between the pairing spin orbitals $ji > and ji^{\circ} >$, with the value being 1, 0, or 1. They can be grouped together as a vector

Furtherm ore, every irreducible representation can be characterized by the maxim alweight. For the sym plectic group Sp(2), this maxim alweight takes the form of $(1 \ 0 \)$, where the number is called the seniority number, and the irreducible representation of the sym plectic group can be written as < 1 >. However, there is a possibility that the same weight might still correspond to the di erent basis vectors. To com pletely distinguish all the basis vectors of an irreducible representation space for the sym plectic group, we therefore need to classify the N-particle eigenstates according to the follow ing group chain

This means that each basis vector will further be characterized by a group of seniority numbers:

Thus, the eigenvectors of the pairing H am iltonian will be completely identi ed by the particle number N, the weight (S), and seniority number (∇): \Re ; (S); (∇) > . In Eq. (28), the k_i is the positive number which gives the difference of two consecutive seniority numbers in the (∇) which is two: $k_{k-1} = 2$; the j_i m eans the same thing but its value equals one: $j_{jj} = j_{jj-1} = 1$. The sign of j_i is decided by the sign of s_{jjj} : if $s_{jjj} = 1$; j > 0; while if $s_{jjj} = 1$; j < 0. In other words, k_1 ; ...; k_y are the pairing numbers in the corresponding symplectic table W, while j_1 ; ...; j_k are the unpairing numbers appearing in the table, which captures all the features of the basis vectors (28) classified according to the group chain (24) [26,31,32].

3.2 The Exact Solutions of R educed B loch E quation

W e are now in a position to solve the reduced B loch equation (15) for the pairing H am iltonian (22). For the case of p = 1, the set of hierarchy equations can be written as

These density matrices decide the microscopic states of the system, from which we can calculate the therm odynamic properties.

4 Conclusions

We have derived the second quantized form of the reduced B loch equations for both the canonical and grand canonical ensembles. The deduction is based on the occupation number representation of the contraction operator, and is similar to the ones we used before as described in papers [1] and [2]. The equations obtained provide a direct route for exactly solving the reduced density matrices for the systems represented by the model Ham iltonian in the occupation number representation. They thereby open an avenue for investigating the m icroscopic structures of these systems and their relations to the equilibrium therm odynamic properties.

As an example for exactly solving the reduced B loch equations, we have obtained the reduced density matrices of the pairing H am iltonian with different orders as shown in Eqs. (66), (67) and (68). One very interesting conclusion we can make is that these reduced density matrices can yield the projection of the ground state of a superconductor in the N -particle space V^{N} . This is the case when G < 0 and N is an even number, and the ground state of the paring H am iltonian (22) is an AE G P (Antisymmetrized Extrem e G em inal Power) function N; (0); (0) > . Therefore, if we choose E (0) as the energy zero point and let = 0 and ! 1 in Eqs. (66), (67) and (68), we can obtain the reduced density matrices of the ground state for the superconductor as follows

These results are identical to Colem an's [33].

Since there are m any other interesting physical systems offen m odelled in an approximate way by the H am iltonians with a second quantized form, we expect that the ideas and m ethodologies we have discussed in this paper can be further explored, and that the fundam ental equations (15) or (19) we have derived will nd wide applications in the study of their m icroscopic states as well as their interplay with m acroscopic therm odynam ic properties.

A Appendix: Second Quantized Form of Contraction and Expansion Operators
