#### Abstract

W e m odel certain features of hum an language com plexity by means of advanced concepts borrow ed from statistical m echanics. U sing a tim e series approach, the di usion entropy $m$ ethod ( D ) , we com pute the com plexity of an Italian conpus of new spapers and $m$ agazines. $W$ e nd that the anom alous scaling index is com patible w ith a sim ple dynam icalm odel, a random walk on a com plex scale-free netw ork, which is linguistically related to Saussurre's paradigm s. T he model yields the fam ous Z ipf's law in term s of the generalized central lim it theorem.


## 1 Introduction

Sem iotics studies linguistic signs, their m eanings, and identi es the relations betw een signs and $m$ eanings, and am ong signs. The relations am ong signs (letters, w ords), are divided into tw o large groups, nam ely the syntagm atic, and the paradig$m$ atic, corresponding to what are called Saussurre's dim ensions '11. These dim ensions are analogous to physical conœepts like tim e and space. O ne can grasp an understanding of them by looking at $F$ ig. $\overline{1} 1 \mathbf{1}$. . The abscissa ax is represents the syntagm atic dim ension, while the ordinate axis represents the paradigm atic one. A long the abscissa gram $m$ atical rules pose constraints on how words follow each other. This dim ension is a tem poral one, w th a casual order. A $n$ article (as \a" or \the"), e.g., m ay be followed by an adjective or a noun, but not by a verb of nite form. At a larger \tim e-scale", pragm atic constraints rule the succession of concepts, to give logic to the discourse. The other axis, on the other hand, refers to a $\backslash m$ ental" space. The speaker has in $m$ ind a repertoire of $w$ ords, divided in $m$ any categories, which can be hierarchically com plex and refer to syntacticalor sem antic \interchangeability". D i erent space-scales of w ord paradigm s can be associated to di erent levels of this hierarchy. A fter an article, to follow the preceding exam ple, one can choose, at a syntactical level, am ong allnouns of a dictionary. H ow ever, at a deeper level, sem antic constraints reduce the available words to be chosen. For instance, after \a dog" one can choose any verb, but in practice only am ong verbs selected by sem antic constraints (a dog runs or sits, but does not read or sm oke). The sentence \a dog graduates", for instance, ts paradigm atic and syntagm atic
rules behind Fig. 1, but the sem antics would in general forbid the production of such a \nonsensical" sentence.

The two dim ensions are therefore not quite orthogonal, and connect, e.g., at a cognitive level. Them ain focus of this paper is to show that this connection is in fact reproduced at all scales. W e shallalso show that both dim ensions are scale free and that the com plexity of linguistic structures in both dim ensions can be taken into account in a uni ed model, which is able to explain $m$ ost statistical features of hum an language, including, at the largest scales, the celebrated Z ipf's law '2.


Figure 1. Saussurre's dim ensions. In th is exam ple the rst position in the syntagm atic axis is an article, the second a noun and the third a verb in the third person.

Z ipf's law relates the rank rofw ords to their frequency $f$ in a corpus. Rem arkably, this does not $m$ ean that the probability of a word is actually de ned. In fact, a word $m$ ay have a sm all or large frequency depending on the genre of the corpus (i.e. a large collection of written text) under study, and even two extrem ely large conpora of the sam e type fail in reproducing the sam e word frequencies. It is how ever rem arkable that the occurrence of words is such that for any corpus and for any natural language a property em erge so that one nds only few frequent words and a large num ber of words encountered once or tw ice. Let us de ne word rank $r$, a property depending on the conpus adopted, as follow s. O ne assigns rank 1 to the $m$ ost frequent word, rank 2 to the second frequent one, and so on. E ach w ord is uniquely associated to a rank, and, although this num ber varies form corpus to corpus, one always nds that

$T$ his property $m$ eans that word frequencies do not tend to well-de ned probabilities. $W$ e assum $e$ that what can be de ned is a \probability of having a frequency" $P$ ( $f$ ) for a random ly selected word. O peratively, one $m$ easures $P$ (f) by counting how $m$ any words have a certain frequency f. In Section III we show that a P (f) com patible w th the Zipf's law can be derived from the m odel proposed herein, thus
providing our m odel an experim ental support. For our scopes, we assum e a statisticalm utual independence for the occurrence of di erent concepts. This hypothesis is appealing, since it $m$ eans that every and each occurrence of a concept $m$ akes entropy increase, thus identifying the $m$ athem aticalinform ation (i.e. entropy) with the com $m$ on-sense inform ation (i.e. the occurrence of concepts). Unfortunately, a concept is not, a priori, a wellde ned quantity. H erein we assum e that concepts are represented by w ords (or better by lem mata) or by groups of sem antically sim ilar w ords or lem m atalal.

Because of the $m$ utual independence am ong di erent concepts, we can extract from a single corpus as $m$ any \experim ents" as the num ber of concepts. For each experim ent we select only one concept and we m ark the occurrence of the selected word or group of words corresponding to this concept. For the analysis we use the recently developed Di usion Entropy (DE) m ethod, which is able to identify whether a m arker is a \realevent", i.e. it carries $m$ axim al inform ation, and to extract the scaling properties of the language dynam ics. W e show here that anom alous scaling (di erent from B row nian $m$ otion) is an indication of long-range correlations of the series, and that in fact these properties are wellm easured by the DE, even if the $m$ arker is not identi ed $w$ th absolute precision.

The overall dynam ics, given by the ow of concepts over tim e, experim entally $m$ irrors the dynam ics of interm ittent dynam icalsystem $s$, like the $M$ anneville'sM ap: $T$ hese system s have long periods of quiescence follow ed by bursts of activity. This variability of,w aiting tim es betw een $m$ arkers of activity is responsible for long-range correlations ${ }^{\text {® }}$.

The second aspect of the paper is the connection betw een space and tim e com plexity, and its application to linguistics. W e will assume that atom ic concepts exist and represent nodes of a com plex netw ork, connected by arcs representing, when existing, sem antic associations betw een a concept and another. W e assum e that ourm arkers are actually de ned as a group of neighboring nodes. W e then assum e that language can be produced by a random walker, \associatively" traveling from concept to concept. T he scale-free properties of the netw ork, independently $m$ easured by our research group, provides a bridge to understand the interm ittent dynam ics earlier described. In this uni ed model the netw ork is a representation of Saussurre's paradigm $s$, whose com plexity $m$ irrors the syntagm atic one in the asym ptotic lim it.

## 2 D E and concepts

Let us review the DE m ethod sequences, and studies the probability $p(x ; t)$ of having a num ber $x$ ofm arkers in a $w$ indow of length $t$. $T$ his statistical analysis is done by $m$ oving $a \mathrm{w}$ indow of length $t$ along the sequences, counting how $m$ any tim es one nds x markers inside this $w$ indow, and dividing this num ber by the total num ber $N \quad t+1$ ofw indow s of size $t$, where $N$ is the total length.
${ }^{a}$ A lem $m$ a is de ned as a representative word of a class of words, having di erent morphological features. For instance the w ord \dogs"has lem ma \dog", and word \sleeping" has lem ma \sleep".
$H$ aving large num ber values for $x$ and $t$, we can adopt a continuous approxim ation. M oreover, in the ergodic and stationary condition, a scaling relation is expected, nam ely

$w$ here $w$ is the overallm arker density, is the scaling index and $F$ is a function. If $F$ is the $G$ auss function, is the known H urst index, and if the further condition
$=0: 5$ is obeyed, then the process is said to be Poissonian, and the dynam ics of $x$ is called \B rownian $m$ otion". If this condition applies, there is no long-range $m$ em ory regulating the occurrence of $m$ arkers in tim e.

It is straightforw ard to show that $S(t)={ }_{1} d x p(x ; t) \ln p(x ; t)$, nam ely the Shannon Inform ation, w ith condition (2,), leads to ${ }^{1}$

where $k$ is a constant. The evaluation of the slope according to which $S$ increases $w$ ith $\ln t$ provides therefore a $m$ easure for the anom alous scaling .

Let us brie y m ention what we know about applying DE to tim e series w ith known long-range correlation. W e construct an arti cial series by letting $i=1$ (this $m$ eans that we nd the $m$ arker at the ith position), or $i=0$ (the $i$-th sign is not a $m$ arker). $W$ e then assum $e$ \inform ativity" for the $m$ arker ( $m$ arkers are then called \events"), nam ely that the distance betw een a \1" and the successive does not depend on the such previous distances. Then, if the distances $t$ betw een events are distributed as

( ( $t$ ) $t$ asym ptotically is a su cient condition), then the theory based on continuous-tim e random walk and on the generalized centrallim it theorem yields for $p(x ; t)$ a truncated Levy probability distribution function (PDF) ${ }_{L}^{u_{1}^{\prime}}$. DE detects the scaling of the central part, nam ely

The condition $2 \ll 3 \mathrm{~m}$ eans long-range correlation, since for truncated Levy PD Fs asym ptotically $h x^{2}(t) i \quad h x(t) i^{2} / t^{4}$ and therefore the correlation function decays ast ${ }^{2}$. N ote that the decay of this correlation function is non-integrable, yielding an in nite correlation time. The theory rests on a dichotom ous, and experim entally this $m$ eans the presence or absence of a certain $m$ arker. O ne $m$ ay, for instance look for a certain letter, so that the tim e is the ordinal num ber of the typographical characters in the text. A s later shown, we have better results by looking at lem m ata, where the \tim e" is the ordinal num ber of words. W e shall show that, w th a good choice of sem antic m arkers, Eq. (4') is a good model for concepts dynam ics in natural language.


#### Abstract

 if tw o $m$ arkers are separated by intervals of words of duration $k$ (the distance in words betw een the $k$-th and the $k+1$-th occurrence of the $m$ arker) then $h_{i} j^{i} /$ ij, where $i_{i j}$ is the $K$ roeneker delta. Under these conditions each event carries the sam e am ount of in form ation. T he statistical independence betw een the $k$ intervals $m$ eans that the inform ation carried by the events is $m$ axim al for a given $w$ aiting time distribution ( ). In a linguistic jargon, we can say that if in a corpus we nd a marker (e.g. a list of words) such that $\quad 1=(1)$ then this $m$ arker is in form ative in that corpus. For didactical purposes, we shall see that certain m arkers, e.g. punctuation m arks, are not real events, but are rather m odeled by a C opying $M$ istake $M$ ap (CM M) 81. This $m$ eans that discourse com plex dynam ic is such that the punctuation m arks actually carry long-range correlations, and anom alous scaling in the PDF, while the waiting tim es between such marks are correlated. Punctuation $m$ arks are not inform ative. Their com plexity is just a pro jection of a com plexity carried by \concept dynam ics" .


### 2.1 The CMM and non-inform ative $m$ arkers

The C opying $M$ istake $M$ ap (CM M) "is is a m odel originally introduced to study the anom alous statistics of nucleotides dispersion in coding and non-coding D NA regions. The CM M is a com bination of tw o sequences: $W$ e have an \original" tim e sequence like e.g. the long-range-correlated series earlier discussed, corresponding to the waiting tim e distribution ( $\overline{4} \mathbf{4})$. Then, for any i we either leave it unchanged w ith probability or change it with a com pletely random value $w$ ith probability 1 (copying $m$ istake).

The resulting w aiting tim e distribution decays exponentially, since the probability of nding a 1 after a tim et from the preceeding one, is given by tw o term s . T h is is because the 1 can be associated to two kinds of origin: it $m$ ay be an \original" 1, or an original \zero" ipped by the copying $m$ istake. W e can $w$ rite the \experi$m$ ental" waiting-tim e distribution $\mathrm{psi}_{\exp }(\mathrm{t})$, in tem s of $\mathrm{psi}_{\text {corr }}(\mathrm{t})$ of the $m$ entioned

Since rand ( $t$ ) and consequently rand ( $t$ ) decay as an exponential function, so it does, in .the asym ptotic lim it, exp ( $t$ ). W hat about the DE curve? The theory predicts's' a random ( $=0: 5$ ) behavior for short tim es, a knee, and a slow transition to the totally correlated behavior. A $n$ exam ple of CM M is given by punctuation $m$ arks in N atural Language. W e choose punctuation marks as markers for an Italian corpus of new spaper and $m$ agazines, of $m$ ore than 300,000 words length, called Italian Treebank (hereafter TB). In this experim ent we look at words, and
we put a 0 for every word which is not a punctuation $m$ ark, and a 1 when we nd such a mark (fiull stops, com $m$ as, etc.). A sentence like $\backslash$ Felix, the cat, sleeps!" is therefore transform ed into $\backslash 0100101$ ".

Fig. 2 show $s$ that this $m$ arkers lead to a tim e series $w$ ith all the earlier exposed features of a CMM. This means that the waiting tim es $k$ are correlated, and therefore punctuation $m$ arks are not events. N otice how ever that an asym ptotic anom alous is detected by DE, and therefore there is a long-range correlation in the text, which $m$ ay be carried by som $e$ other $m$ ore in form ative $m$ arker.

### 2.2 C onœpts as in form ative $m$ arkers

M ore experim ents, not reported here, show that the CM M behavior is typical for m any characters, and are shared by all the letters of the alphabet, w ith a $0: 6$. Passing from a \phonetic" (in Italian we can assume that alphabetic characters $m$ irror the phonetic) to a monpho-syntactic level is linguistically interesting. To do so, a text has to be lem $m$ atized and tagged $w$ ith respect to its part of speech. A fter this procedure we can identify as a $m$ arker the occurrence of certain part of speech (e.g. article, adverb, ad jective, verb, noun, preposition, num eral, punctuation etc.) . For instance, the sentence $\backslash F e l i x$, the cat, sleeps!" is now transform ed into $\backslash \mathrm{N} P$ R N P V P ", where N, P, R and V stand for nouns, punctuation, article and verb. If we select the occurrence of verb as a marker, then we have 10000010 ". $F$ ig 3 show s the result of this experim ent for verbs and for num erals. W e notice that we have a sim ilar behavior for the DE, and a com pletely di erent behavior for the evaluation of the waiting-tim es distribution ( $t$ ) (where $t$ is the number of words betw een $m$ arkers). We notice that DE reveals a long-tim e correlation, while, ( $t$ ) show s an exponential truncation at long tim es. H ow ever, in the case of num erals we nd a large transient with a slope num erals $<2$, and therefore a non-stationary behavior. This is in fact due to the uneven distribution of num erals in the corpus, since they are encountered more often in the econom ic part of the Italian new spapers. H ow ever, this still unsatisfactory result for num erals reveals that this kind of $m$ arkers is $m$ ore inform ative than a phonetic one or than the presence of verbs. T his is linguistically interesting, since num erals denote a part of speech, but also a \sem antic class".
$W$ e are therefore led to suppose that inform ative $m$ arkers are the ones associated w ith a sem antically coherent class of words. This is how ever a problem, since every single concept is too rare in a balanced conpus (a long text with a variety of genres). The next level of our exploratory search for events is therefore to look at the occurrence of \salient words" in a specialistic text. Such a conpus has been m ade available as the Italian corpus relative to the E uropean project P O ESIA 11. POESIA is a E uropean Union funded pro ject whose aim is to protect children from o ensive web contents, like, e.g. pomography in W W W URLs. Salient \pomographic" words were autom atically extracted by com paring their frequency in an o ensive corpus, w ith respect to the balanced TB-compus. The de nition adopted was

$w$ here $f_{E C}\left({ }^{(l)}\right.$ is the frequency, in the erotic corpus, of the lem mal, and $f_{T B}$ (l) is the sam e property in the reference Italian corpus (Italian T reebank). Salient lem $m$ ata were autom atically chosen as the $5 \%$ w th the highest value of $s$. $N$ otice that in this experim ent all \dirty" words are not taken into consideration, because they do not appear in the reference conpus, and therefore $s$ cannot be properly

de ned. H ow ever an o ensive $m$ etaphoric use of term $s$ is in fact detected, leading to a com pletely new way to autom atic text categorization and ler 110 , using $a$ $m$ ethod, based on DE analysis, called CASSA NDRA 111.

Salient words were therefore used as markers for our analysis, as earlier described. The results are shown in Fig. 4, clearly show ing that in a specialized corpus, salient w ords of this genre, pass the test of in form ativeness. Salient w ords, and plausibly words in general, are therefore distributed like m arkers generated by an interm ittent dynam ical model, with $2: 1$ and, in agreem ent $w$ ith ( $5 \mathbf{5}$ ),
$1=(\quad 1)=0: 91 . W$ e see in the next section how this behavior is plausibly connected w ith a topological com plexity at the paradigm atic level, and in Section III we derive the Zipf's law from the resulting model.

3 Scale-free netw orks, interm ittency and the $Z$ ip f's law
In this section wne build a cognitive $m$ odel for connecting structure and dynam ics. A llegrini et al. ${ }^{12}$ identi ed sem antic classes in the Italian corpus, by looking at paradigm atic properties of interchangeability of classes of verbs $w$ ith respect to classes of nouns. They de ned \superclasses" of verbs and nouns as \substitutabiltity islands", nam ely groups of nouns and verbs sharing the properties that in the corpus you, nd each verb of the class co-occurring, in a context, with each noun of the class ${ }^{21}$. This is precisely a direct application of the notion of $\backslash$ paradigm ". Let us call $p_{v}$ (c) and $p_{n}$ (c), respectively, the num ber of verbs or nouns belonging to $a$ num ber c of classes. T hey found that

where is a num ber whose absolute, value is ( $m$ uch) sm aller than 1., ,
On the sam e line, other authors $1^{3}=$ found a \sm allw orld" topology ${ }^{14}$, by looking at the num ber of synonym $s$ in an English thesaunus, for each English lem ma. We can therefore assum $e$ that this kind of structure is general for any language. Let us therefore im agine that the paradigm atic structure of concepts is a scale-free netw ork and consider a random walk in this \cognitive space". Let us $m$ ake the follow ing assum ptions:

1) T he statistical weight of the $i$-th node is ! $i_{i}$;
2) E rgodicity, and therefore that the characteristic recurrence time is $i \quad c_{i}{ }^{1}$;
3) The same form for all nodes, $i(t)=\left(1=_{i}\right) F\left(t=i_{i}\right)(e . g . F(x)=\exp (x))$. $N$ ow we im agine that selecting a conœept m eans selecting a few neighboring nodes. $T$ his collection of nodes, due to the scale-free hypothesis, shares the sam e scaling properties of the com plete scale free netw ork, nam ely p(c) c. Therefore we have that

W e recovered the interm ittent model ( $\overline{4} \mathbf{4} \mathbf{I}^{\prime}$ ).
Let us now $m$ ake the exercise of deriving the $Z$ ipf's law $f / r{ }^{a}$, with a close to unity. Let us de ne a probability of frequency $P$ (f)

$N$ ext, let us notioe that $P$ (f) m ust be a stable distribution. In fact, the $Z$ ipf's law is valid for every conpus. In particular if it is valid for conpus A and for corpus B,
it is valid also for the conpus $A+B$ where $+m$ eans the concatenation of conpora. If $w e$ continue $w$ th concatenating $w e w i l l$ have a conpus

i.e., the $G$ eneralized $C$ entrallim it $T$ heorem ${ }^{-15}$ applies. This $m$ eans that the probability of frequency $P(f)$ is a Levy -stable distribution. This probability of nding $f$ occurrences of a word in a conpus of a given length can be identi ed with $p$ ( $x$; $t$ ) of Section II, if we take into consideration the param eter $t$. W e have earlier noticed that $p(x ; t)$ in language is Levy process, w ith 1 , and therefore $w$ ith a tail


## 4 C onclusions

In this paper we have show $n$ that a cognitive process goveming hum an language $m$ ay be identi ed, and that it has a com plexity both in the syntagm atic and in the paradigm atic axis. The scaling properties of both axes are related to each other, and are re ected by the celebrated Z ìpf's law. T his study w as conducted using Italian w ritten conpora, but decades of studies on the generality of the $Z$ ipf's law lead us to suppose that our results are language independent, and that the language com plexity that we are revealing is genuine and im portant. In fact, for any concept, we have a scaling index associated with an interm ittent dynam ical $m$ odel that rests at the border betw een ergodicity and non-ergodicity, since the Zipf's law is theoretically consistent with = 1. M oreover, in a specialistic test we see a tendency to drift, for salient words, tow ards ergodicity ( 0:91 in the reported experim ent). This behavior can be interpreted as the balance between two opposite needs for hum an language, nam ely leamability, i.e. the possibility for a child to leam a language by exam ples, and variability, to explore an in nite cognitive space.

W e propose as a future work to study language com plexity in children during leaming years, and in psychopathological sub jects. W e im agine, if the theory presented herein is validated by m ore extensive work, that the sim ple study of the individual $Z$ ipf's law $s$ can provide a reasonable non-invasive diagnostic $m$ ethod for certain $m$ ental diseases.

From a Language Engineering point of view, this study provides a theoretical background for a com pletely new strategy of autqm atic text categorization. A prototype is being im plem ented as a sem antic lertia. We think that the proposed test for inform ativeness for a set ofm arkers can also be im portant form any exploratory studies in tim e series analysis. For instance, it $m$ ay becom e im portant to identify crucial sem antic $m$ arkers in a ow ofdata.
