# C haotic Q uantum Vortexes In A W eakly N on Ideal B ose G as. Therm odynam ic Equilibrium A nd Turbulence

#### Abstract

W e study the stochastic behavior of a set of chaotic vortex loops appeared in im perfect B ose gas. D ynam ics of Bose-gas is supposed to obey $G$ ross $P$ itaevsk ii equation w ith additional noise satisfying uctuation-dissipation relation. The corresponding Fokker-P lanck equation for probability functionalhas solution $P(f(r) g)=N \exp (H f(r) g=T)$; where $H \quad f(r) g$ is the $G$ inzburg-Landau free energy. C onsidering vortex lam ents as topological defects of eld (r) we derive a Langevin-type equation of $m$ otion of the line $w$ ith the correspondingly transform ed stirring force. The respective Fokker-P lanck equation for probability functional P (fs()g) in vortex loop con guration space is show $n$ to have a solution in the form off $(f s() g)=N \exp (H f s g=T)$; where $N$ is the nom alizing factor and H fsg is energy of vortex line con gurations. A nalyzing this result we discuss possible reasons for destruction of the them odynam ic equilibrium and follow the $m$ echanism $s$ of transition to the turbulent state

Q uantized vortices (Q V) play a fundam ental role in the properties of super uids and other quantum system $s$. P hase transitions, kinetic properties and many other physical phenom ena can be e ected by QV.For that reason, they have been the object of intense study for $m$ any years (for review and bibliography see [ill ${ }_{1}^{2}$ ). Studies of the $Q \mathrm{~V}$ dynam ics have been $m$ ost successful in sim ple cases such as vortex array in rotating helium and vortex rings. These sim ple cases,how ever, are very rare. D ue to com plex dynam ics, in itially straight lines or rings can evolve into highly entangled structures called vortex tangle (VT), To describe any phenom ena involving VT, some inform ation about its structure and statistics $m$ ust be know $n$. O ne of the $m$ ost popular ways to overcom $e$ that problem is to treat the vortex loops as a kind of them alexcitation and to use the them odynam ic $m$ ethods. The rst exam ple of that $w a y$ $w$ as the use of the Landau criterium for critical velocity where vortex energy and $m$ om entun were used in the relation having purely therm odynam ic sense. The m ore recent exam ple is the K osterlitz-T houless theory, as well as its $3-D$ variant, currently being developed for review and bibliography see [3] $]$ ). Besides of vortioes in the condensed $m$ atter, the view of strings as a set of topological defects being in them odynam ic equilibrium, is intensively elaborating now


O n the other hand, num erous experim ents involving counter ow ing $H$ ell, as well as num erical sim ulation of vortex

 of a cascade transfer of energy both in space of the sizes of vortex loops, and in space of $K$ elvin waves on every individual loop. Furtherm ore, in the experim ents involving vortioes in quenched ${ }^{3} \mathrm{He}$ and ${ }^{4} \mathrm{He}$ (see [12]] [13]), the decay of vortex tangle was observed rather than a them alization as expected for norm al statistical system s . T here are also serious discrepancies in the statistical description of system s. A s follow s from theoretical predictions founded
 density of vortioes, or their total length in unity of volum e) occurs by the law $1=t$. Though this law agrees w ith
 [ $\overline{5}_{1}^{\prime}$ ]). B esides, to describe decay of the turbulent tangle, $V$ inen has applied argum ents used in the theory of classical turbulence. Furtherm ore, distribution of vortex loops w ith respect of their lengths $n(1)=d N(1)=d l$ in turbulent helium obeys to the law $n(1) / l^{4=3}$ (see [1] [1]), while the equilibrium vortices obey to the law $n(1) / l^{5=2}$ (see [16] $]$ [ []$\left._{1}\right]$ ). The very im portant question is generation of turbulent vortioes in the system. In the them odynam ic approach vortexes arise due to them al uctuations of the order param eter, or rem ain at prom pt quench through the lam bda line. The $m$ echanism s of appearing of turbulent vortices are not understood. Therefore, the transition phenom ena in the super uid turbulence described by the $V$ inen equation term whose origin is not clear.

[^0]E xam ples listed above show, that chaotic vortex tangle, appearing in quantum uids can display both the them odynam ic equilibrium features and the extrem ely nonequilibrium, turbulent properties. $N$ aturally, there is a question: "W hat state, equilibrium or turbulent, is realized in each concrete experim ent, and what sorts of the theory is required to use at description of one or another phenom enon?" $T$ he answ er to this question can give the investigation devoted to study of speci cmechanism $s$, responsible for establishm ent of them odynam ic equilibrium and $m$ echanism $s$ featuring destroying the equilibrium and transition to the turbulent state. In this work wemainly concentrate on the rst part of investigation form ulated above and follow how the vortiges appeared in a weakly non-idealB ose gas are driven in them odynam ic equilibrium state. The second part of investigation is intended to be studied in further publication. H ere we only discuss, at a qualitative level, how equilibrium state can be destroyed and point out possible m echanism s of transition to the turbulent state.

A $s$ it was already $m$ entioned, supposition about therm odynam ic equilibrium state can be founded by considering vortex loops as a subsystem subm erged into a them ostat w ith which they exchange energy. From the very fundam ental physicalprinciples it follow s that a set ofvortex loop should be driven in equilibrium state and, accordingly, to obey the G ibbs statistics. T he underlined physical eld plays a role of a therm ostat in this case. In case of a B ose condensate, which we consider in given paper, the order param eter ( $x, t$ ) plays the role ofsuch eld. Vortex lam ents in this study are described as crosses of the surfaces where both real and im aginary parts of the order param eter ( $r, t$ ) vanish. O ther excitations of the order param eter (phonons, and rotons in case of real HeII) interact with an ensemble of vortex loops, driving the latter to them odynam ic equilibrium. In accordance w ith the principle ofm axim alentropy, the probability distribution function (functional) obeys the $G$ ibbs form ula. The given reasoning, how ever, bears a rather general character. It gives no details conceming dynam ics of the system since they are hidden behind the tem perature and chem ical potential de nitions. Therefore it does not answer the question: " how the system of vortioes is driven in therm odynam ic equilibrium ? " W thout know ing dynam ical details we also can not to answer another question: " how the them odynam ic equilibrium state for a set of vortex loops is destroyed and the transfer to a strongly nonequilibrium (turbulent) state occurs? " W e stress that we are interested in analytical results, since there ia a num ber of num erical works (see [ underlined eld was dem onstrated.

It is well know $n$ how ever that $G$ ibbs distributuion can be altematively obtained in the fram e of reduced $m$ odels like kinetic equations or the Fokker $P$ lanck equation (FPE). T hese $m$ ethods are not as general as a principle of maxim al entropy, but instead they allow s us to follow the details of how the G ibbs distribution is established. In th is study, FP E w as used to exam ine how chaotic vortex loops generated by the therm odynam ic equilibrium B ose E instein condensates


To achieve that goalwe propose the follow ing steps. First, we state a problem of stochastic dynam ics for the order param eter ( $r, t$ ). D ynam ics ofquantity $(r, t)$ is supposed to satisfy the $G$ ross $P$ itaevskiiequation $\left[1 \bar{d}_{1}^{1}\right]\left[\overline{1}_{1}^{1}\right]$. To im pose the stochastic behavior of a BEC, the random stirring force $f(x ; t)$ was added to the right side of the G ross $P$ itaevsk ii equation. The random force obeys the uctuation-dissipation theorem. This guarantees that the $G$ ibbs distribution for probabillity functionalP ( $f(r) g$ ) $=N \exp (H f(r) g=T)$ is followed. Here $H f(r) g$ is an energy of particular con guration $f(r) g$ of the order param eter, $T$ tem perature, and $N$ is a nom alization factor. $T$ hen, starting from that dynam ics, we derive an equation ofm otion for a vortex lines elem ents cosidering the latter as zeroes of the order param eter. The random force acting on the order param eter transform $s$ into random velocities for elem ents of the vortex line. Then we derive the FokkerP lanck equation for probability distribution function functional $P$ (fs( )g) in a vortex loop con guration space. F inally we show that the Fokker $P$ lanck equation is satis ed by the $G$ ibbs distribution $\exp (\mathrm{H} f s g=T)$; where $H$ fsg-is functional of energy due to the vortex loops. A nalyzing this result we discuss the possible reasons for destruction of them odynam ic equilibrium and suggest the possible m echanism s of transition to the turbulent state.

## I. LANGEVIN EQUATION FOR THEORDER PARAMETER

In this section we brie $y$ describe the problem of the stochastic $m$ otion of Bose-condensate on the basis of $G$ ross$P$ itaevskiim odel [1] [1] [1] []. In the fram e of reference w here the norm alvelocity is absent the $G$ ross $P$ itaevskiiequation reads

Here is (dim ensionless) kinetic coe cient, is chem ical potential (energy per particle) and $V$ o is the potential describing an interaction of particles. The order param eter is de ned here so that

T he stochastic problem described above is the well studied problem, so called modelA. It has a solution describing them al equilibrium, where probability of som e con guration of - led is proportional to $\exp (\mathrm{H} f(r) g=T$. It im $m$ ediately follow s from the correspondent FokkerP lanck equation [id].

## II. LANGEVIN EQUATION FOR THEVORTEXFILAMENT

In this section we derive equation of the stochastic motion of quantized vortex lines in Bose-condensate on the basis of the problem form ulated in $\bar{N}_{1} \overline{1}$ and $\overline{1} 1 \mathbf{1}$. Vortioes are crosses zeroes of the both real and im agine parts of the param eter, and the problem is just to describe the $m$ otion of zeroes of the (complex) function varying in tim e and space. That problem, as well as other $m$ ore general problem $s$ of that kind have been considered $m$ any tim es by $m$ any
 new $m$ ethod, not too rigorous from $m$ athem aticalpoint $o \bar{f} v i e w$, but convenient for the $m$ ain punpose of the paper.

Vortioes in quantum uids are very slender tubes (except of the phase-transition region) and their dynam ics is analogous to that of the strings. This im plies that we have to aim our e orts at integrating out the radial degrees of freedom. It can be reached by the follow ing procedure. As any m otion of topological defects, the vortex line dynam ics is determ ined by the underlying eld theory. On the other hand, if one ignores for a while a presence of other excitations except of the vortices one can say that all $m$ otion of $B$ ose-condensate is determ ined by a $m$ otion of (all elem ents) of (all) quantum vortices. H ence, there is a m utual correspondence and the order param eter ( $x$; $t$ ) can be considered as a functional of the whole vortex loop con guration ( $\mathrm{x} j \mathrm{~s}(; \mathrm{t})$ ): In particular, the tem poral dependance of eld is connected w ith the $m$ otion of lines and its rate of change (at som e point $x$ ) is expressed by the follow ing chain rule.

The integral in the second line of ( $\overline{1} / \overline{1})$ expresses a chain rule for functional derivative $H(s)=S(0 ; t)$, where $H$ ( $s$ ) is the energy of B ose-condensate expressed via vortex line position. C onsequently considering them to be very slender
tubes (which is justi ed when the radius of the curvature $R$ is $m$ uch larger of the core size $r_{0}$ ), and neglecting the part of energy associated w th the core, the quantity H (s) is just the kinetic energy of the super uid ow created by vortices (see e.g. [2] $\underline{2}_{1}^{1}$ ], [25]

Integral (12-1) depends on the whole vortex loop con guration. N evertheless this integral, (and other sim ilar integrals including squared gradients of the order param eter) can be evaluated approxim ately in a general form, provided that the line is slightly curved (see e.g. [2] $]$ ). The relevant calculations, how ever, are rather cum bersom e, and, to not block up the basic text, we have taken out them in the A ppendix. As follow s from the calculations given in the A ppendix

Thus, we again expressed the considered term (rst line of $\left(\underline{g_{1}^{\prime}}\right)$ in term $s$ of variable $s(; t)$, describing the vortex line con guration.

Let us now discuss the rest term of equation ( $(\overline{-})$ ) including the random foroe $f(x ; t)$ (the third line). C onsequently considering that all $m$ otion of Bose-condensate is connected to $m$ otion of line ( $W$ e rem ind, that we do not include acoustic e ects), we have to consider Langevin force $f(x ; t)$ as som e secondary quantity stem $m$ ing from random displacem ents of all elem ents of all loops. This im plies that the sm all casual variations of the order param eter are connected to the sm all casual displacem ents of lines $s w$ ith the help of the follow ing chain rule:

Equation (21) describes the $m$ otion of vortex line in term $s$ of line itself. It is the rem arkable fact (not obvious in advance) that noise $f(0 ; t)$ acting on the line is also additive (does not depend on line variables).

Thus, starting from dynam ics of Bose-condensate ( equation (3) ) w ith uctuation-dissipation theorem ( equation ( ${ }_{2}^{2} 1_{1}^{1}$ ) describing $m$ otion of the vortex line in term $s$ of line itself $w$ ith the additive noise obeying (241). These relations com plete a statem ent of the stochastic problem of quantized vortex dynam ics under random stirring velocity stem $m$ ing from the random force acting on the underlying eld. In the next subsection we dem onstrate that this problem has the equilibrium solution given by $G$ ibbs distribution $\exp \left(\mathrm{H} f s g=\mathrm{k}_{\mathrm{B}} \mathrm{T}\right.$ ); . H ere H fsg- is the functional of energy due to the vortex loop (equation $(\underline{g})$ ) and $T$ is the tem perature of $B$ ose-condensate.

## A. The Fokker-P lanck equation

To show it we, rst, derive the Fokker $P$ lanck equation corresponding to Langevin type dynam ics obeying (211) and (244). . Let us introduce the follow ing probability distribution functional

Thus, the reversible term gives no contribution to the FP equation ( $\left[2 \overline{1}_{1}\right.$ ), one can say it is a divergent free term (see e.g. [2] ${ }^{-1}$ ]). It is clear, that the said above refers only to a case of them àl equilibrium s, i.e. it is valid only for the $G$ ibbs solution.
$T$ he last term in the FP equation (2-1) can be transform ed by use of uctuation-dissipation relation for line (2-4, in the follow ing way:

Thus, we have proved that the them alequilibrium ofB ose-condensate results in the therm alequilibrium of a set of vortex loops. In the next section we will review the basic steps of our derivation. On that ground we w ill discuss how the therm alequilibrium can be destroyed and consider (qualitatively) a possible scenario of transition to a turbulent state.

A nalyzing our proof one can see that the follow ing steps w ere crucial:

1. The additive white noise $\mathrm{f}(\mathrm{x} ; \mathrm{t})$ acting on eld ( $\mathrm{x} ; \mathrm{t})$ is transform ed into the additive white noise $\mathrm{f}($; t ) acting on vortex line position $s(; t)$.
2. The intensity ofnoise $f(; t)$ expressed by (24) exactly com pensates the dissipative ux ofprobability distribution functional in the Fokker $P$ lanck equation (211). Furthem ore, the com pensation occurs in integrand, in other words the detailed balance betw een pum ping and dissipation takes place.
3. T he non-dissipative part ofequation ofm otion of the line elem ents gives no contribution to the ux of probability FP equation ( $2 \overline{2}_{1}$ ) , it is divergent free (. [2] $\left.{ }^{[ }\right]$).

Resum ing the said above, it is possible to say, that by the basic reason for an establishm ent of the them al equilibrium in set of the vortex loops is the detailed balance between pum ping and dissipation which occurs for all scales. It certainly agrees w ith the basic principles of the statistical physics (see, for exam ple, [281]). It should be realized that the rest part of the equilibrium problem, nam ely evaluation of the partition function (and,accordingly, all physics) basing on the $G$ ibbs solution $P(f s() g)=N \exp (H f s g=T)$; is the farm ore di cult problem. The real success is achieved $m$ ainly in num erical sim ulations [6] [ $[1]$ G]. A s for analytical studies, we would like to point out a series of works by $W$ illiam $s$ w th collaborators who uses 3D variant of the K osterlitz-T houless theory (for review and biblography see $\left[\begin{array}{l}{[1]} \\ ]\end{array}\right)$. We appeal to results of the cited works to continue our investigation. O ne of the $m$ ost striking results obtained in these works is an observation that in equilibrium there are vortex loops of appreciably large sizes. T hat result can be hardly foreseen by naive estim ation that probability of appearing of long loop is B oltzm ann suppressed, $\exp (\quad l=k T)$, where is energy per unit of length. That im plies, that, rst, there is strong screening and, second, vortex loops have a polym er like structure w ith folding of line elem ents. B oth phenom ena reduce greatly the e ective energy per unit of line length. A ctually distribution of loops $w$ ith respect to their lengths obey the law n (1) $/ 1^{5=2} \mathrm{w}$ th som e exponential factor (see [1]]).

W e think, that the presence of the long vortex loops is responsible for possible destruction of them odynam ic equilibrium . Indeed, the sm all vortex loops (rings), of order a wave length of phonons, have quite de nite energy and $m$ om entum. D egrees of freedom due to an extent of these ob jects are expressed weakly. In other words, the sm all vortex loops (ring) can be interpreted, as som e kind of therm al excitations, which just renorm alize a density of the nom al com ponent. Interaction $w$ th other quasi-particles (phonons and rotons) is reduced to usual collisions, that leads to a renorm alization of usualkinetic coe cients. $Q$ uantitatively this renorm alization is $s m$ all, and can be appreciable only very close to the lam bda transition (see ["] $]$ ).

As opposed to the $s m$ all loops, the long loops, rst, have a very large am ount of interior degrees of freedom . Secondly, the long weakly curved lam ent interact w ith the norm alcom ponent under the law sapplied to m acroscopic rectilinear vortices (see, for exam ple [1] [1]). Thus, the long and sm all loops interact with a quantum uid in di erent $m$ anners. The situation here is quite sim ilar to a 2 D case, where an interaction $w$ th third sound arises only from the vortex pairs of the large sizes, while sm all vortex - antivortex pairs just renorm alize the density of the super uid com ponent (see [][1]). B ecause of a presence of long vortiges, the detailed balance can be easily destroyed. Indeed, the strong enough large-scale perturbation (appeared e.g. due to nonuniform extemal stream) can violate the equilibrium state. Two scenarios, leading to the turbulent state are possible. First of them is connected to developm ent of nonlinear K elvin w aves on the vortex line. B ecause of a nonlinear character of the equation ofm otion, the large-scale perturbations on initially sm ooth line interact, creating higher harm onics. T hey, in tum, produce higher harm onics, etc. In real space this process corresponds to the tangling of a long vortex loop and form ation of parts with very high curvature (kinks or hairpins), which are sub jected to the strong dissipation. Thus, in space of the $K$ elvin waves a nonequilibrium state is established. This state is characterized by the K olm ogorov ux of curvature along scale in


O ther scenario, leading to violation of the equilibrium state due to the presence of long loops, consists in the follow ing. In the presence of the norm al com ponent the long vortexes are exposed to mutual friction, and, as a consequence to the $M$ agnus force. A s a result, "ballooning" (in average) of the vortex loops is possible. E nlargem ent of an am ount of the long loops displaces the law $n(1) / l^{5=2}$, by slower dependence. Uncom pensated long vortex loops are exposed to "redundant" reconnections, breaking dow $n$ into sm aller loops. $T$ his process can be interpreted, as the nonequilibrium K olm ogorov cascade in space of the loop sizes. T he reader fam iliarw th the theory of super uid turbulence, easily nds out, that the second scenario coincidesw ith the one, introduced by Feynm an fornonequilibrium
 di erence is that we consider the given process on a background of therm al equilibrium, and the cascade arises from deviation from $n(1) / 1^{5=2}$ distribution.

C ertainly, both scenarios described above are not independent. For exam ple, at the $m$ om ent of reconnection there are strong deform ations on sm ooth lines, generating the $K$ elvin waves. On the other hand, intemaldynam ics of the
vortex lam ents in uences frequency and details of reconnection. Thus, analyzing the received equilibrium solution, we have o ered the scenarios, according to which, the transition to strongly nonequilibrium, turbulent state, is possible. W e would like to stress, that realization of these scenarios is due to the presence of very long (actually macroscopic) vortex loops in the equilibrium solution.

Let's discuss now, what sorts of the $m$ acroscopic perturbations are capable to destroy therm odynam ic equilibrium . $F$ irst ofall, it w ould be nonuniform ities appearing during a ow ofsuper uid in channels. O ther case is the counter ow of the norm al and super uid com ponents appearing in the heat ux. Super uid turbulence can be also generated by intensive rst and second sounds [32]. Furtherm ore, the vortioes, which have arisen in fast transition throw lam bda-
 $T$ here are other, $m$ ore exotic, $m$ echanism $s$ of destroying of them odynam ic equilibrium, for exam $p l e$, w ith use of the ion current.

In Introduction w e have m entioned about the problem of initialvorticity, which w as faced by V inen in his description of the transient super uid turbulence (see [1] [1] ). In order to $m$ ake his equation to be self-consistent, he introduced the phenom enological, "generative" term, whose origin is not clear. U nder the scenarios described above, the transition in turbulent state is just developm ent of instability of long vortex loops w ith respect to the large-scale perturbations. Since instabilities develop very rapidly (usually exponentially), a presence of a plenty in itial loops is not necessary. $T$ hus, the phenom enological "generative" term in the $V$ inen equation is just somecom position of a sm all am ount of the long vortex loops and instabilities increm ents. Of course, the con m ation of that point of view requires the quantitative analysis of the problem of stability of vortex loops, in the ow ing (counter ow ing) super uids, this is supposed to be studied in the further w ork.

## IV. CONCLUSION

E xploring the Langevin dynam ics of a chaotic set of quantized vortex lam ents appearing in a weakly nonidealB ose gas, we have followed the $m$ echanism of establishm ent of therm odynam ic equilibrium . W e have conchuded, that the equilibrium state arises due to the additive random foroes, acting on the order param eter, transform $s$ into additive random velocities, acting on the lines in a proper $m$ anner, to satisfy the uctuation-dissipation relation for the lines dynam ics. It guarantees the detailed balance betw een random velocity and dissipation. $N$ oting, further, that in the vortex tangle there present very long vortex loops, subjected to large-scale perturbations, we o er the qualitative scenarios of a destruction of the them odynam ic equilibrium and transition to the turbulent state.
