On bipartite Rokhsar-Kivelson points and Cantor decon nem ent

Q uantum dimermodels on bipartite lattices exhibit Rokhsar-Kivelson (RK) points with exactly known critical ground states and decon ned spinons. We exam ine generic, weak, perturbations around these points. In d = 2 + 1 we nd a rst order transition between a \plaquette" valence bond crystaland a region with a devil's staircase of commensurate and incommensurate valence bond crystals. In the part of the phase diagram where the staircase is incomplete, the incommensurate states exhibit a gapless photon and decon ned spinons on a set of nite measure, almost but not quite a decon ned phase in a compact U (1) gauge theory in d = 2 + 1! In d = 3 + 1 we nd a continuous transition between the U (1) resonating valence bond (RVB) phase and a decon ned staggered valence bond crystal. In an appendix we comment on analogous phenomena in quantum vertex models, most notably the existence of a continuous transition on the triangular lattice in d = 2 + 1.

I. IN TRODUCTION

Q uantum dim er models (Q DM s) were introduced by Rokhsar and K ivelson¹ to capture the low energy dynamics of valence bond dom inated phases of quantum H eisenberg antiferrom agnets.² W ork on these models has established that their behavior on bipartite and non-bipartite lattices is fundamentally dierent. On the latter, they adm it RVB phases with liquid dim er correlations and decon ned (test) spinons^{3,4,5} which have topological order of the Z₂/BF variety.⁶ On the form er they adm it only crystalline phases^{1,7,8,9,10,11,12} (valence bond crystals) in d = 2, while supporting RVB phases of the U (1) or C oulom b variety in d > 2.^{13,14,15}




FIG.1: Phase diagram of the square lattice quantum dimermodel. In the top part of the gure, the mean tilt of the height surface is plotted as a function of v=t (see Section II). The corresponding dimer phases are sketched on the bottom part. The at side (columnar and plaquette solids) term inate in the RK critical point (v=t = 1), which has no dimer long-range order. Here, for the RK quantum dimermodel (dashed line), the tilt jumps discontinuously, corresponding to a rst order transition into the staggerred solid. U pon inclusion of longer-ranged interactions, how ever, the tilt will ascend a devil's staircase from the at region, through a succession of incommensurate and commensurate phases. This phenomenon, (and the resulting structure factor) are discussed in detail in the text.

One of the elegant features of the class of quantum dimer models introduced in Ref. 1 is the existence of special points, christened RK points, at which the exact ground state wavefunctions are trivially determined and take the form of equal amplitude superpositions over sets of states connected by the dynamics | the classic RVB form. A dditionally, test monomers have a vanishing interaction at these points, which translates into the decon nem ent of gapped spinons in RVB language.³ The appropriate phase diagram for the square lattice case is sketched in Fig.1.

In this paper we study quantum dimermodels \near" the RK points on bipartite lattices, i.e. QDM s that consist of the RK point H am iltonians plus sm all, but generic, perturbations. The restriction to bipartite lattices brings an important simplication. In a sense that we will make precise below, bipartite RK points are described by gapless G aussian eld theories and this will greatly simplify the task of analyzing perturbations.

O ur basic new results are twofold. First, we establish the degree of criticality of the RK points \mid more precisely of the associated G aussian eld theories which are xed points of the obvious renorm alization group and to which we shall refer for clarity as the RK xed points (RKFPs). In d = 2 + 1 we show that on the honeycom b and square

lattices the RKFPs describe multicritical points with two relevant symmetric operators. In d = 3 + 1, the cubic lattice RKFP describes a critical point with just one relevant symmetric operator. Second, we show that the purely \staggered" phase that borders the RK points in the sim plest QDM s can be pushed a nite distance away in the perturbed models and for d = 2 + 1 the interm ediate region is lled in by a devil's staircase of commensurate and incom m ensurate valence bond crystals which exhibit staggered order but also additional Bragg peaks. The commensurate crystals are gapped and con ning. The incommensurate crystals exhibit a gapless photon (phason) and are decon ning, for su ciently weak perturbations. Further, although they occur at (boundary) points, they form a generalized Cantor set of nite measure in the same lim it. We refer to this phenomenon, which comes remarkably close to a decon ned phase in a compact U (1) gauge theory in d = 2 + 1, as Cantor decon nem ent. In fact, near the RK point this region is practically a decon ned phase, as the commensurate con ned phases occupy an asym ptotically sm all fraction of the phase diagram in this lim it. In addition, the gap in the con ned phases is extremely small. The possibility of such phases was pointed out previously by Levitov¹⁰ based on a mapping to the roughening problem .

This paper is organized as follows. In Section II we discuss the height action for a 2 + 1-dimensional (generalized) quantum dimermodels on the square and honeycomb lattices. In Section III we discuss in detail the case of the honeycomb lattice and the mechanism that drives the quantum phase transition rst order in that case. In Section IV we discuss the development of the tilted phase and in Section V we show that due to the strong coupling nature of these generalized dimermodels, their tilted incommensurate phases generically exhibit a fully developed devil's staircase analogous to the one discussed in two-dimensional classical systems. In Section V I we discuss the phase diagram for the case of the square lattice, and in Section V III we discuss the

violation of the Landau nules in these quantum phase transitions, and the decon ning nature of these quantum critical points, including the relationship of RK points to the \decon ned critical points" discussed recently by Senthil and collaborators.¹⁶ W e sum marize our conclusions in Section IX. In the appendix, we provide a brief discussion of analogous phenom ena in quantum vertex models. Here, we nd that the RKFP in d = 2 + 1 that controls the transition between a crystalline state and a C antor decon ned region is critical (rather than multi-critical).

II. HEIGHT ACTION IN d = 2 + 1 D IM ENSIONS

The Ham iltonian of the sim plest quantum dimerm odel introduced in Ref. 1 has the form :

for the square and honeycom b lattices respectively. Here, a sum over all plaquettes of the lattice is implicit. On the honeycomb lattice,^{12,17} and with less con dence on the square lattice,^{1,7,8,9,10,11} it is known that the model exhibits three phases.

t it is in a \columnar" crystal phase which Forv gives way by a rst order transition to a \plaquette" phase as v=t is increased. The plaquette phase is characterized by an order parameter that vanishes continuously at v = t, the RK point. At the RK point there are multiple ground states the exact ground state wavefunctions are the equal amplitude superpositions of states in each sector of dimer con gurations connected by the (o -diagonal) resonance term in Eq. (2.1). It is generally assumed that these sectors are dened by two winding num bers (see Ref. 18 for details) although a proof of ergodicity within sectors exists only for the zero winding sector.¹⁹ For v > t the system enters a \staggered" phase where the ground states contain no ippable plaquettes. Cartoons of these three phases { colum nar, plaquette and staggereed { for the square and honeycom b lattices can be found in Figs. 1 of Refs. 11 and 12, respectively. The square case is reproduced in Fig.1.

On bipartite lattices the hardcore dim er constraint can

be converted into a Gauss law, r = 0. This is ac-

com plished by endowing the links of the lattice with an orientation, so that they point from one sublattice to the other. Identifying an empty link with an electric ux = 1 a link occupied by a dimerwith a ux = z = 1 (where z is the coordination of the lattice) one obtains a lattice electric eld E with the desired property. In d = 2 + 1 this can be solved by writing E = r h in terms of a

In terms of h, the properties of the above QDMs in the vicinity of their RK points are reproduced by the imaginary time Lagrangian

with $_2$ / (v=t) + 1 changing sign precisely at the RK points. The last term keeps track of the discreteness of the m icroscopic heights, as is usual in height representations of problem s in d = 2, and we will have m one to say on that later. The square and honeycom b lattice problem s di er in the relevant values of $_4$ which are (=32)² (square lattice) and (=18)² (honeycom b).

To determ ine the operator content of these theories, one also needs to specify the compactication radius of the height variables. This is determined by the minimal uniform shift of the heights which leads to an identical dimer con guration. For the case of the honeycomb and square lattices, the compactication radius equals 3 and 4, respectively.

Finally, the details of the lattice structure enter in the relationship between lattice quantities and operators in the eld theory. Speci cally, long wavelength correlations of the dim er densities n_i (where i labels the dim er direction) on the honeycom b lattice can be reconstructed by m eans of the leading operator identi cations,

In these expressions, x and y denote C artesian coordinates, the x axis being perpendicular to one dim er direction. The unit of length is given by the separation of two neighbouring parallel dim ers. The corresponding expressions on the square lattice are

The elective Lagrangian of Eq. (22) was also considered in Ref. 22 in the context of the theory of classical Lifshitz (multi)critical points in three dimensions and, for this reason, this elective theory has been dubbed the quantum Lifshitz model in Ref. 23. This elective Lagrangian exhibits a three-dimensional analog of the physics of two-dimensional classical critical isotropic systems. Thus, the action dened by Eq. (22) exhibits a line of xed points parametrized by $_4$ with $_2 = 0$ and = 0, under the natural momentum and frequency shell renormalization group with z = 2. The RK points on both lattices ow under this renormalization group, to RKFPs on this line with the above values of $_4$. This accounts for their critical correlations and a mode spectrum k^2 . In the U (1) gauge theoretic interpretation of the

dim erm odel, this mode is a photon with an anom abusly soft dispersion. The irrelevance of the cosine is the necessary vanishing of the instanton e ects that otherwise gap the spectrum of such compact con ning theories²⁴ and this also accounts for the decon ned spinons. The height action further accounts for two other non-trivial features of the RK points, namely that they have degenerate ground states in all winding number sectors (the RKFP point action is insensitive to gradients of heights) and that for the zero-winding states the equaltim e height correlations are logarithm ic,

and precisely those of the classical dim er problem . This

in turn allows us to x the values of $_4$ quoted earlier as the classical dimer problem is exactly solvable. (I his also clari es that these values are really the xed point values.)

O n both lattices, the action (Eq.2.2) accounts for the plaquette crystals for v < t as at states of the height variable with di erent local uctuations: when $_2 > 0$, is relevant, i.e. it is dangerously irrelevant at the RKFPs. The selection of plaquette states indicates that > 0 for v=t < 1 on both lattices. For v > t, $_2 < 0$: the height tilts, and in the absence of any restoring term in Eq.2.2 it attains its maximum tilt consistent with the m icroscopic constraints. This tilted phase translates into staggered dim er correlations which break translational symmetry on the square lattice and only rotational symmetry on the honeycom b.

The transition between the plaquette and staggered phases is somewhat unusual. As 2 goes smoothly through zero at the RK point, the plaquette order vanishes continuously there. Further, as v ! t , there 1^{j=2} and are two divergent length scales: jv=t $\frac{1}{p^2}$, with = 6; $\frac{5}{2}$ on the square and honeycom b с lattices, respectively. The latter arises from the dangerously irrelevant cosine and is the length scale on which the plaquette order appears; the value of follows from the dimension of the irrelevant cosine at the xed point. However, the staggered phase emerges at full strength immediately and the ground state energy density has a derivative discontinuity at the RK point which indicates a rst order transition in the therm odynam ic classi cation.

Let us comment brie y on the origins of the elective action of Eq. (2.2). The height representation for dimers was used by several workers on this problem; the recognition that it can be extended to capture the physics of the RK point is due to Henley and a more complete account of the properties of the RK point and the transition about it was given in Ref. 2. Henley's basic observation was that the Ham iltonian Eq. 2.1 also governs the master equation for the probability distribution of the classicaldimer problems endowed with the simplest plaquette ip dynamics.²⁵ In height variables the classical dimer problems are in the rough phase and so it is reasonable that the dynamics is captured at long wavelengths by the Langevin equation

where $S[h] = \int_{-\infty}^{\infty} d^2 x (r h)^2$ is the coarse grained entropy functional of the classical dim er problem. For G aussian white noise distributed the average over trajectories is weighted by the Lagrangian,

which, upon dropping a total time derivative, is the action governing the RK points.

This construction shows that the RK point action has higher dim ension operators than one m ight have guessed on symmetry grounds alone. Indeed, the action (2.2)doesn't distinguish our two lattices with their di erent symmetries. As advertised, we are interested in this paper in weak, but otherwise generic perturbations of the Ham iltonians (2.1) about their RK points. Such generic perturbations of the RK point H am iltonians will give rise to all operators allowed by symmetry and so we shall include them in the analysis, with the proviso that they enter with sm all couplings. A second im plication of considering perturbed models will be that the values of the couplings in (2.2), in particular the marginal coupling 4 will also be som ew hat di erent from their values quoted earlier these di erences will again be small. In the follow ing we will refer to this set of modi cations as working near the RKFPs without further explanation.

A nalcomment is in order on an unusual aspect of the RKFPs. These xed points, and indeed the entire xed line, exhibit an enlarged symmetry in which the height eld is free to tilt with any magnitude in any direction | which is then spontaneously broken by the ground states. W hile this appears to be non-generic, such extra symmetries are a feature of any purely G aussian xed point. For instance at and above d = 4, the Ising transition is controlled by a G aussian xed point that is invariant under constant shifts of the scalar eld. M uch as in that case we work near zero tilt. In both cases this is the correct choice for a sector of the space of couplings the sector in which the transition is continuous in mean eld theory.

III. EXPANDED ACTION ON HONEYCOMB LATTICE

We turn now to the honeycomb lattice. For honeycomb dimers, the heights live on the triangular lattice, which naively indicates an action rotationally invariant to fourth order in gradients. However, the microscopic heights have a sublattice structure: they take values 0,1 and 2 modulo 3 on the three sublattices of the triangular lattice. Consequently, the symm etries of rotation by =3 and inversion also involve sending h ! h. It follows then that the allowed non-irrelevant operators at the RKFP include the relevant cubic term,

The growth of g_3 in the infrared indicates that the criticality of the RK point does not survive its inclusion | the form of the interaction indicates that when g_3 is nonzero the system has already entered the tilted phase, although with the tilt now locked to the lattice. This leads us to

conclude that the transition between the at plaquette phase and the tilted phase goes truly rst order.

If we tune g_3 to zero, we can exam ine the stability of the multicritical RK point. In a renorm alization group treatment, where we keep a cuto in space alone, the lowest non-trivial order ows of the two interactions are

whence both interactions are irrelevant for $g_4 > 0.^{22}$ As g_4 is marginally irrelevant it produces logarithm ic corrections and the ows also renormalize $_4$ thus parking the system elsewhere on the xed line. W ith these observations we see that the multicritical behavior represented by the RK point is stable on a surface of codimension 2, provided the long wavelength $_4$ (=4)². The latter condition holds for small perturbations of Eq. (2.2).

IV. THE TILTED PHASE

Once g_4 is large enough, the tilt no longer jumps to its maximum value on leaving the at phase. When g_3 is nonzero, the tilt prefers to point along one of the dimer directions or in between two dimer directions depending on the sign of this coupling. A similar role is played by g_4 on the square lattice (see below). Here the restriction to small tilts is crucial: the states for $g_3 > 0$ and $g_3 < 0$ are not related by symmetry; in particular, at large tilts there are only states with one sign of the tilt, i.e. with the dimers dominantly oriented along the three bond directions. We also note that on traversing the multicritical point with $g_3 = 0$, the same orientational selection is now e ected by the fill order term,

which is thus dangerously irrelevant at the multicritical xed point.

The properties of the tilted phase can be analyzed by expanding in small uctuations about the weakly tilted state (henceforth we assume $g_3 < 0$, so that the tilt is along the x-axis, and that $jg_3 j$ is small)

Higher order terms (in h) are irrelevant due to nondivergence of uctuations. Provided $j_2 j < g_3^2 = g_4$ then

 v_t ' v_1 and a single correlation length can be de ned, = $v_1 = \frac{v_1}{4}$, so that for su ciently large momenta, q > 1, the spectrum is quantum critical, while as q! = 0the modes acquire a stiness, their dispersion is linear with longitudinal and transverse velocities given by v_1 and vt. The average tilt of the height variable translates into new Bragg peaks appearing in the structure factor for the dim er densities (as deduced from Eqs. 2.3 and 2.4). They are of two types: rst is the commensurate Bragg peak at the wavevector of the maxim ally \staggered" state located at the origin for the honeycomb case (and at (;) in the case of the square lattice), the second type are the incom m ensurate peaks displaced from the characteristic wavevectors of the colum nar/plaquette pattern (e.g. (4 = 3; 0) and (; 0) on honeycom b and square lattices, respectively) by an amount proportional to C . In the tilted regime the intensity of the com m ensurate peak varies as C², while that of the incom m ensurate peaks as $\frac{3^{p}}{4}$ (on the square lattice as

 16^{p} (a). Generally, as a result of quantum critical uctuations, the two peaks di er in intensity param etrically. Both their intensities are C² for 4 corresponding to the the purely short range H am iltonian of Eq. 2.1. The existence of gapless modes has in portant in plications, one of them is that test monom ers (spinons) interact through a potential that generally grow s only logarithm ically with distance, as opposed to the linearly grow ing con ning potential encountered in com mensurate valence bond solids.

V. IN COM M EN SURATE LOCKED CRYSTAL PHASES: THE DEVIL'S STAIRCASE

The actual state of the system involves an interplay between the propensity of the system to establish a tilt discussed thus far and the discreteness of the m icroscopic heights. As we will quantify a little later, the operators encoding the discreteness are much more irrelevant (although dangerously so, see below) at the RKFP than those responsible for the selection of the tilt m agnitude and direction. Therefore, near the RKFP the problem can be treated in the order in which we have discussed it. A way from this lim it one can worry about more com – plex phase diagram s.

In order to treat height discreteness properly, we need to generalize our treatment of the discreteness of the height in Eq. (2.2). There we included a potential that favors discrete at con gurations of the height eld but in doing so we ignored the possibility of the height locking into tilted con gurations. To identify the full set of locking potentials, we note that the height and the lattice points together de ne a three dimensional lattice with points (h;x). A general locking potential, in particular the one generated from the microscopic constraints under renorm alization, can be expanded in the set of reciprocal lattice vectors fG g of this three-dim ensional lattice,

and thus each G de nes a locking potential. Nicely enough, the height-space lattice for the honeycom b dim er problem is the simple cubic lattice with the [111] direction m easuring height, so working out the set of locking potentials is particularly simple.

As discussed in the previous section, in the tilted phase the mean-square uctuations of the height are nite. As a consequence of this, whenever the average tilt of the height surface is com m ensurate with the lattice, the corresponding terms in the locking potential (above) are asym ptotically relevant. At such points the ground state is a commensurate valence bond crystal with a gapped spectrum. At incom m ensurate tilts the outcom e depends upon the strength of Vlock relative to the rem aining quantum uctuations. W hen the latter are strong, as is the case for small tilts, the ground state at most tilts is an incommensurate valence bond crystal with a Bragg peak at the incom m ensurate w avevector but with a gapless (phason) spectrum . In the gauge theoretic interpretation of the dimermodel, this excitation is a photon and correspondingly test monomers are decon ned in that they experience the logarithm ic interaction of free two-dimensional electrodynamics. If the locking potential is increased and/or the quantum uctuations decreased, we expect a version of Aubry's \breaking of analyticity"26 transition beyond which the incommensurate ground states are pinned, their low -lying excitations are localized though still gapless, and the incommensurate ground states occupy a set of measure zero in the phase diagram .

The weak locking regime exists, parametrically, at small tilts near the RK point. For concreteness, consider approaching the multicritical surface by tuning g_3 with $_2$ set equal to zero. The closer we get to the transition, the higher order the commensuration that leads to locking, with jG j 1=C or larger. This has various e ects: rst the coe cients of the corresponding locking potentials generally decrease as one goes to larger G ; second, the operators become increasingly irrelevant at the Rokhsar-Kivelson xed point; and third, the length scale increases at the crossover from the quantum critical regime where the locking potential is irrelevant to the tilted regime where it becomes relevant. These e ects combine together to make the renormalized strength of the locking potential, and thus the size of the gap in each com m ensurate phase, as well as the width of the param eter range in the phase diagram occupied by the phase, all vanish at small tilts C exponentially in 1=C $^2\colon$ e.g., the gap

As the correlation length / 1=C, this is equivalent to

an ordering length that grows rather fantastically,

where $a;a^0$ are positive constants. Consequently, even the commensurate phases are for all practical purposes gapless in this weak-tilt regime. Thus when the tilting transition is either continuous or very weakly rst-order, there is a decon ned, weakly-ordered dimer-crystalphase near the RK point where the ordering is generically incommensurate! By contrast, the existence of the strong locking regime will need to be determined by actual solution of the relevant models the existence of the fully tilted states is not proof of strong locking, merely of the existence of a maximum tilt as a consequence of the periodicity of the height variable.

Returning to the in nite volum e and zero tem perature phase diagram, the commensurate and incommensurate states will be interleaved in the classic manner of the devil's staircase studied in a variety of commensurateincommensurate problem s.27 At weak locking, close to the RK point, the staircase is incomplete, i.e. the decon ned incommensurate points will form a set of nite m easure as the control parameter, $_2$ or g_3 , is varied. In fact, the fraction of the phase diagram occupied by the incommensurate decon ned states approaches unity as the RK point is approached. This is the phenom enon we have term ed Cantor decon nem ent. Farther away from the RK point the staircase could become complete, with the incommensurate points being a set of zero measure, before the maxim ally tilted phase is reached. Needless to say, this scenario assumes that no rst order transitions intervene.

Finally, a brief comment on Bragg peaks. The actual details of the ordering periodic in the commensurate states and quasiperiodic in the incommensurate states will cause the second peak to fragment into multiple and even a dense set of higher-order Bragg peaks.

VI. EXPANDED ACTION ON THE SQUARE LATTICE

O n the square lattice the generic case requires that we (a) allow $_4$ to vary, (b) include the quadratic and strictly m arginal term ,

The impact of (a) and (b) together is that we are interested in ows about a two dimensional surface of xed points. Unlike on the honeycom b lattice, there is no cubic invariant so that the transition is continuous at the level of mean eld theory for the height action. How ever, there are two tree-level marginal couplings whose fate needs to be decided by uctuations. Let us focus for now on the ow around the xed line with $\sim_4 = 0$.

The lowest non-trivial order ow s of interest are:

Interestingly, the ows in the $(g_4; g_4)$ plane are attracted to the origin only along the positive g_4 axis; generically the ows run away to the region where the action is unstable at quartic order in gradients. From this we conclude that it is highly likely that the transition is driven

rst order by uctuations in the generic case. Now the RK point behavior requires a further ne tuning, $g_4 = 0$, and hence it represents the behavior of a multicritical surface of codimension two. We not that the inclusion of a small \sim_4 does not alter the topology of the ows and there remains only one trajectory owing into the xed point at the origin.

For the runaway ows, the pattern of sym m etry breaking is indicated by the initial sign of g_4 and depending on that we nd four states with the tilt either aligned or at angle =4 to the lattice axes. All of them exhibit, necessarily, a modulation of the dimer density at wavevector (;). If $g_4 = 0$, the sixth order term is now responsible for the orientational selection.

The analysis of the tilted phase now requires identifying the reciprocal lattice vectors of the diam ond lattice, with its [100] direction m easuring the height. The qualitative features of the devil's staircase are exactly as in the honeycomb case. Bragg peaks now appear at (;) and near (;0) and (0;).

VII. THE CUBIC LATTICE

We turn nally to the case of the d = 3 cubic lattice. Now the constraint is solved by introducing a gauge eld A, in terms of which the action is of the form, 1^{4}

with $_2 = 0$ again signaling the RK point. In gaugeinvariant notation, the quadratic terms become the squares of the electric and the corresponding magnetic eld in d = 3 + 1.

The discreteness of the m icroscopic elds is irrelevant in a nite interval around the RK point and hence can be ignored in its proxim ity. The only non-irrelevant term consistent with cubic symmetry m issing from Eq.7.1 is

which is strictly marginal. Hence the critical behavior represented by the RK point is (marginally) stable. The additional coupling leads to rotationally non-invariant critical points.

For $_2 < 0$, we need to include the (dangerously) irrelevant terms that control the magnitude of the \magnetic eld", B = r A. These are B^4 and $B_x^4 + B_y^4 + B_z^4$ and lead to staggered crystals (now with a modulation of the dimer density at (;;)) aligned parallel or interm ediate to the lattice axes. The connected correlations of the dimer density exhibit distorted dipolar correlations. This spectrum exhibits a gapless photon with uctuations of the elds about their ground state values, and decon ned spinons. A ltogether, one obtains critical points separating a liquid of dimers from a crystal. At larger tilts connem ent and further symmetry breaking can be expected to set in, but that is outside the validity of our analysis.

W e also note that other related problem s, such as the two-dim erm odelon the bipartite diam ond lattice studied by Herm ele et al.¹⁵ in its incarnation as a pyrochlore Ising antiferrom agnet with Ising dynam ics, will mutatis mutandis exhibit the same phase diagram .

VIII. LANDAU RULES AND ORDER PARAM ETER THEORIES

In R ef. 2, three of us com m ented that the RK point in the sim plest bipartite QDM s in d = 2+1 sat at the transition between two sym m etry incom patible valence bond crystals and attributed the divergence of the correlation length at it to the decon nem ent of the gauge/height eld at the RK point. Recently Senthil et al.¹⁶ have considered a sim ilar scenario for the transition between a Neel state and a valence bond crystal, although now with dynam ical spinons, and christened the intervening critical point a decon ned critical point.

At issue in these discussions are two distinct but closely related possibilities. First, the violation of the Landau rule that a phase transition between two symmetry incompatible phases must generically be rst order, except at multicritical points. Second, the formulation of the theory of the phase transition in terms of elds other than the order parameters of the proximate phases. At a technical level this happens when the ordering is driven by dangerously irrelevant operators.

A swe have discussed in this paper, the situation near the RK points is more complicated than was assumed in Ref. 2. Instead of a single tilting transition between the plaquette phase and the staggered phase there is a devil's staircase of com mensurate incom mensurate transitions. Nevertheless, su ciently close to the RK point, any commensurate ordering is extremely weak and for practical purposes one can think of the RKFPs controlling a continuous transition between a at phase with plaquette order and a tilted phase with staggered order as well as incommensurate order with a continuously varying wavevector. The weakly tilted phase how ever is (logarithm ically) decon ned, unlike the fully tilted staggered phase.

In the quantum dimermodels analyzed in this paper, the RKFPs controlmulticritical surfaces in contradiction with the claim in Ref. 2. However this is not inevitable in this class of problems. A quantum vertex model discussed in the appendix exhibits a critical surface controlled by RKFPs. In either case the underlying height action (2.2) is not derived from the order parameters of the proximate phases. In this sense they lie outside the Landau paradigm when applied to quantum phase transitions.

Finally, we note that in the d = 3 + 1 cubic QDM, the tilting transition remains continuous for weakly perturbed QDMs and the tilted phase exhibits only staggered correlations. This is now a continuous transition inside a decon ned region where Landau theory predicts a continuous transition. That said, the critical theory is still not what one would naively deduce from an order param eter analysis of the ordered (staggered) phase the correlations of the order param eter at criticality have a dipolar form. The complication is the need to properly treat the local constraint r E = 0, which is accounted for in the action Eq. 7.1 by the introduction of the vector potential A . It is also the case that the ordered phase breaks rotational symmetry due to a dangerously irrelevant operator. A ltogether while the three dim ensional problem isn't quite as unusual as the two dimensional one, it also furnishes an instance where the critical theory requires a departure from the standard cookbook.

IX. SUMMARY

We have analyzed the phase diagram in the vicinity of the RK points in the bipartite QDM s. In d = 2we nd a rst order transition separating con ning plaquette phases from a devil's staircase of commensurate/incommensurate and con ning/decon ning valence bond crystals on both the honeycom b and square lattices with the RK points sitting on a multicritical surface of codim ension two. In d = 3 the RKFP controls a continuous transition between an RVB phase and a deconned staggered valence bond crystal. QDM s that exhibit these phenomena can be constructed by adding multidim er potential energies to the RK point Ham iltonians. W hether the phenom ena here can be identied in a spin m odelor in other physical system s, is an interesting topic for future work. Finally, we note that as we were writing up this work there appeared Ref. 28 which has considerable overlap with our work but which diers from our conclusions on som e points.

APPENDIX A:QUANTUM VERTEX MODELS

Q uantum vertex models are close cousins of quantum dimer models. Here we begin with a Hilbert space labelled by con gurations of a classical vertex model, i.e. each bond hosts an Ising variable which we picture as an arrow marked on it. Then we introduce a local quantum dynamics which consists of reversing local closed loops of arrows. In cartoon form, the resonance move analogous to the one captured in Eq. 2.1 is given by

As the bond variables here are oriented their physical origins will neccessarily be distinct from those of dim ers. For example, a quantum six vertex m odel was introduced in Ref. 29 as a model for quantum e ects in two dimensional ice as well as via a mapping from a planar pyrchlore Ising magnet placed in a transverse magnetic eld. Subsequently it also been argued to arise as an e ective theory of the quantum uctuations in the ddensity wave state where the microscopic variables are oriented currents.³⁰

An exhaustive analysis of the RK point manifold in the quantum eight vertex model is contained in Ref. 23. W hen critical, the model is equivalent to the six vertex model. In this case the conservation law at the vertices leads straightforw ardly to a height representation in which the two sublattices of the square lattice host even and odd values of a height eld with circum ference two. A nice feature of the quantum six vertex problem is that one can nd a fam ily of RK points at which the value of 4 can be tuned continuously; the ground state w avefunctions in these cases are no longer equal am plitude superpositions but still exhibit isotropic critical correlations. The analysis of perturbations of these RK points now closely parallels our discussion of the square lattice Q D M and we conclude that they govern a multicritical surface, likely between a plaquette phase³¹ and a devil's staircase region. The signi cant di erences from the dimer case involve a) the degeneracies of the phases and b) the varying dimension of the vertex operator piece of the dim er operator. The latter causes the relative strengths of the staggered order and incom mensurate order to vary in the tilted phase. For example, near the equal am plitude RK point, the staggered order is quadratic in the

tilt as against cubic for the incom m ensurate piece.

O f the 32 possible vertices on a triangular lattice, 20 respect the 'ice rule' of having the same number of arrows pointing in an out. The corresponding 20-vertex m odel (the ice m odel on the triangular lattice) thus permits a height representation. The heights live on the dual honeycom b lattice and are even and odd on its two sublattices with compacti cation radius two. The sym - m etries now force the height action to be even in h and isotropic to fourth order in gradients. Consequently the line of RK xed points is now stable with a dangerously irrelevant sixth order term picking one of six lattice directions to orient the tilted phase. The (h;x) lattice is an hop structure with in-plane bonds deleted and its re-

ciprocal lattice vectors govern the commensurate states in the devil's staircase region.

The values of $_4$ stem m ing from particularm icroscopic m odels in this fam ily are under investigation and will be reported m ore fully elsewhere;³² here we content ourselves with noting that at the equal am plitude RK point the height is rough³² and hence in its neighborhood we now have an exam ple of critical behavior governed by RK xed points and a C antor decon ned region which can be accessed without dialing the extra param eter needed in the dimer m odels discussed previously in this paper. Based on experience with this class of m odels, it seems s likely that the at phase is again a plaquette phase which is symmetry incom patible with the C antor region.
