## D i usion and m ixing in gravity-driven dense granular ows

We study the transport properties of particles draining from a silo using imaging and direct particle tracking. The particle displacements show a universal transition from super-di usion to norm aldi usion, as a function of the distance fallen, independent of the ow speed. In the super-di usive (but sub-ballistic) regime, which occurs before a particle falls through its diameter, the displacements have fat-tailed and an isotropic distributions. In the di usive regime, we observe very slow cage breaking and P eclet num bers of order 100, contrary to the only previous microscopic m odel (based on di using voids). O verall, our experiments show that di usion and mixing are dom inated by geometry, consistent with uctuating contact networks but not therm al collisions, as in norm al uids.

G ranular ow is an attractively simple and yet surprisingly complex subject [1]. Fast, dilute ows are known to obey classical hydrodynamics (with inelastic collisions), but slow, dense ow spose a considerable challenge to theorists, due to many-body interactions and non-therm al uctuations. Beyond their fundam ental scientic interest, such ow shave important engineering applications [2], e.g. to new pebble-bed nuclear reactors [3], whose e ciency and safety depend on the degree of m ixing in very slow granular drainage (< 1 pebble/m in).

Although dense granular drainage is very fam iliar (e.g. sand in an hourglass), it is far from fully understood. Over the past forty years, a number of theoretical approaches have been proposed for steady state ow [4, 5, 6, 7, 8]. Continuum approaches are based on the critical-state theory of soilm echanics and yield only mean velocity elds [7,8]. On the other hand, the diusive void model [4, 5] takes a particle approach, in which voids' injected at the ori ce cause drainage by di using upward and exchanging position with particles along the way. A veraging over the void trajectories yields the same continuum velocity eld for particles as the kinematic model' [6, 8], which provides a reasonable t to experimental data with only one thing parameter (the di usion length, b) [5, 6, 9, 10], although the void model on a regular lattice (as in Ref. [11]) underpredicts its value [12]. Remarkably, these models depend only on geom etry and not on m om entum, energy, etc.

In spite of the success of the kinematic model, however, its only microscopic basis, the void model, greatly overpredicts di usion. To see this, consider the Peclet number,  $Pe_x = v_z d=D_x$ , the dimensionless ratio of advection in uniform downward ow of speed,  $v_z$ , to di usion with a horizontal di usivity,  $D_x$ , at the scale of a particle diameter, d. In the void model, when a particle falls a distance h,  $Pe_x = (h=t)d=(h x ^2 i=2 t) =$ h 2d=h x <sup>2</sup> i, is of order one for any conceivable packing since h px d, and therefore it di uses horizontally by roughly h. This prediction is contradicted by ev-




FIG.1: An initially at, o -center interface between two regions of di erently colored beads (a) stretches and roughens after draining half of the silo (b), but little m ixing is observed. (c) C ontour plot of the average downward velocity eld,  $v_z$ , with an ori ce width, W = 16 mm = 5.3 d, where d is the particle diam eter. The white box indicates a region of nearly uniform ow where all subsequent m easurem ents are m ade.

eryday experience and our experiments below, which exhibit far less mixing. An attempt to resolve this paradox with a new model appears in a companion paper [12].

In this Letter, we describe particle-tracking experiments on silo drainage using similar techniques as in a recent (lower-resolution) study of the velocity eld [13]. We focus on the statistical evolution of particle displacements and topological \cages", which should aid in developing new microscopic models. Our data may also have implications for recent attempts to apply therm odynamic approaches from glassy dynamics to granular ows [14, 15, 16]. A lthough we do not de ne a \granular temperature", we observe the presum ably related e ect of varying the ow rate in all of our measurem ents.

Our experim ental apparatus involves glass beads (d = 0:1 mm) in a quasi-two dimensional silo (20:0 3:0 83 d). The particles are 90:0 2:5 cm = 67300 observed near the front wall made of transparent glass, where the slight polydispersity reduces the tendency for hexagonal packing. (As seen in Fig. 1, there is no longrange order, although the wall induces som e short-range order that may a ect our results.) We nd that varying the thickness of the silo has insigni cant e ect on the di usion properties and therefore we report our data for a single thickness. We track individual particles using a high-speed digital camera with a maximum resolution of 512 1280 pixels at 1000 fram es/sec. Particle positions are obtained to sub-pixel accuracy using a centroid technique (0:003d, d = 15 pixels).

Our rst experiment provides a visual demonstration that particles m ix much less than predicted by the void model. We bad the silo with black and white (but otherwise identical) glass beads, forming two separate columns, as shown Fig.1(a). From Fig.1(b), where half of the particles have drained (in 30 sec), it is clear that the black-white interface has not sm eared signi cantly, although it has roughened. The sm all degree of mixing is consistent with the segregation of bi-disperse beads in a similar apparatus [10].

The mean downward velocity eld,  $v_z$ , is shown in Fig.1(c) throughout the silo, as measured by direct particle tracking. A distributed lling procedure similar to that in Ref. [17] was used to add grains to the silo. Then the ori ce was opened and steady state ow was allowed to develop before acquiring the data used for subsequent analysis. The ow speed is highest at the center-line, with a maximum near the ori ce, and decays to zero toward the sides. Fairly good agreem ent with the kinem atic m odel is obtained with b = 1.3d.

In order to investigate particle dynamics in a simple setting, we focus on a small 17 87 d region of nearly uniform ow, the white box in Fig. 1 (c). For the measurem ents below, we track about 1370 particles through this window for 4 seconds in steps of 1 m s. The average ow speed  $v_z$ , the only control parameter in this study, is varied by changing the width of the orice, W. The ow is fairly sm ooth for W 8 mm (about 3d) and nearly continuous for W 16 mm. For sim plicity, we vary W in the range 8 m m W 32 mm, in increm ents of 4 mm, to avoid the complicated regime of interm ittent ow [18]. This corresponds to 1:38 d=sec 18:39 d=sec, and ¥ data is consistent with  $v_{\rm z}$  / (W d)<sup>1:5</sup>. We compile statistics from all tracked particles in six experiments per ow speed (except two for W = 32 mm).




FIG.2: (a) A typical particle trajectory sampled at 1 m s intervals in a fram e m oving with the average ow speed,  $v_z$ . (b){(c) N orm alized PDFs for the 1 m sparticle displacements, x and z, for various ow speeds,  $v_z$ , compared to a standard G aussian distribution (dotted line); standard deviations, x and z, are of order 10 <sup>3</sup>d. (d) The kurtosis of x versus the m ean distance fallen,  $v_z$  t.

From the positions of the particles sam pled at 1 m s intervals, we calculate the horizontal and vertical displacements, x and z, relative to a frame moving with the mean speed of the ow. A typical trajectory computed in this way in Fig. 2 (a) shows periods of sm all uctua-

tions with occasional, much larger steps. This suggests that the probability density functions (PDFs) for x and z (for t = 1 m s) should have fat tails compared to a G aussian, which is con med in Fig. 2 (b) { (c).

Fat-tailed PDFs have also been observed in colloidal glasses and attributed to cage-breaking [19], but a spe-




FIG. 3: (a) { (b) M ean squared horizontal (h x  $^2$  i) and vertical (h z  $^2$  i) displacements versus mean distance dropped, which collapse onto a single curve for dierent ow speeds, v<sub>z</sub>, except for the smallest where the ow is interm ittent. (c) { (d) D i usion coe cients (D) and Peclet numbers (Pe) in the horizontal (x) and vertical (z) directions versus v<sub>z</sub>.

cial feature here is the asymmetry of the PDF for z in Fig.2(c). Downward uctuations (z < 0) are larger than both upward (z > 0) and horizontal (x) uctuations. We attribute this to the fact that particles are accelerated downward by gravity while being scattered in other directions by dissipative interactions with neighbors.

Looking again at Fig.2(a), it seems that the large uctuations in particle displacements would be reduced by coarse-graining in time, perhaps enough to recover standard Gaussian statistics. Indeed, as shown in Fig.2(d), the normalized kurtosis,  $_{x} = h x^{4} i=3h x^{2} i^{2}$  1, which measures how the shape of the distribution of x di ers from a G aussian, decreases tow and zero as  $v_z$  t increases. (The data uctuates som ewhat for  $v_z = 1:38d=sec$ , presum ably due to interm ittency.) This suggests a transition from super to norm aldi usion.

As shown in Fig. 3(a){(b), the scaling of the meansquare displacements does, in fact, change from superdiusive, h x  $^{2}i$  / t<sup>1:5</sup> and h z  $^{2}i$  / t<sup>1:6</sup>, to diusive, h x  $^{2}i$  / h z  $^{2}i$  / t. The normal diusion in long time scales is consistent with previous studies of dense drainage where particles were tracked with lower time resolution [20, 21]. Curiously, the super-diusion is slower than in the usual case of ballistic transport in uids, h x  $^{2}i$  / h z  $^{2}i$  / t<sup>2</sup>, where particles m ove freely between collisions. Sub-ballistic scaling and non-Gaussian statistics at short times suggest that dense granular ows di er from classical uid ows.

The di erences becom e even m ore obvious upon varying the ow rate. In a uid, this causes a linear increase in Pe because the mean ow has no a ect on molecular di usion due to therm al uctuations. Here, as shown in Fig. 3(c) { (d), the measured diusion coe cients, e.g. D  $_x$  = lim  $_{t! 1}$  h x  $^2$  i=2 t, are actually proportional to the ow speed (with D  $_z$  2:1D $_x$ , consistent with the discussion above), so the Peclet numbers, 321 and  $Pe_z = v_z d=D_x$  $Pe_x = v_z d=D_x$ 150, are roughly constant. This suggests that di usion and advection are caused by the same physicalm echanism, such as a passing void. The measured Peclet numbers, however, are two orders of magnitude larger than predicted by the void m odel.

Since  $D_x$ ;  $D_z / v_z$ , we plot the mean square displacements versus the mean distance dropped in the laboratory frame,  $v_z$  t. Remarkably, as shown in Fig. 3(a) { (b), this collapses all of our data for dierent ow speeds onto a single curve, not only in the di usive regime, but also in the super-di usive regime. (The data for the sm allest ow speed again diers som ewhat.) A sm ooth crossover from superto normal di usion occurs after particles have fallen roughly one particle diameter.




FIG. 4: (a) The topological cage correlation function, C (t), versus the mean distance fallen,  $v_z$  t, and (b) the average over all experiments in the continuous- ow regime (W 16 mm), compared with an exponential t in the diusive regime (dotted line).

Although advection dominates particle dynamics (Pe 1), di usion causes a gradual rearrangem ent of the 'cage' of nearest neighbors. To investigate this mixing directly, we measure the topological correlation function, C (t), de ned as the fraction of nearest neighbor pairs preserved from times t to t+ t, averaged over all t.We chose the cuto for a nearest neighbor, 1:5d, as the rst m in im um of the radial distribution function. (which yields coordinations near 0.59). As shown in Fig. 4(a), the data for C (t) collapses when plotted versus  $v_z$  t, in the sense that no system atic dependence on  $v_z$  is observed (except perhaps for the smallest orice widths), so in Fig. 4 (b) we plot the average over all experiments in the continuous ow regime (W 16mm orvz 5:59 d=sec).

The cage correlation function in Fig. 4(b) exhibits a clear crossover, which closely parallels the ones for mean displacements in Fig. 3(a) { (b). In the superdifference of the super

fusive regime, C (t) decreases fairly quickly (with a decay length of roughly 20d), but after falling more than one particle diam eter the rate of decrease (neighbor loss) slows considerably. Since the topology remains more than 90% intact within the observation window, the precise form of the long-distance decay is uncertain, but a least-squares exponential t, hC i 0:976 exp(  $v_{\rm E}$  t=200d), yields a \cage breaking length" of 200d. This gives direct evidence that the ow is characterized by long-lasting contacts, as is obvious to the naked eye. It also m ly rejects the void model because any void-particle exchange rem oves roughly half of the neighbors of a particle as it falls by on ly one diam eter.

To counter the argum ent that a collisional regim e m ay exist below the experimental resolution (t 1 m s), we show that this is inconsistent with the fact that di usion and mixing depend only on geometry (Figs. 3{4). In the standard model of a collisional gas, a particle dropping a distance, L, experiences an average of N collisions which must dissipate its gravitational potential energy:  $m gL = (1=2) N (1 e^2) m v_r^2$ , where m is the mass, g the gravitational acceleration, e the restitution coe cient, and  $v_{\rm r}$  the mean relative velocity. To be consistent with our data, N should depend on L, but not the ow speed,  $v_z$ . Although  $v_r$  is unknown, we can make two estimates both of which lead to a contradiction. The rst starts from the natural form  $u la, v_r^2$  $(h x^2 i + h z^2 i) = t^2 w ith$ xed t = 1 m s, which suggests  $v_r / v_z^{0.8}$  by looking at the initial slope of h z  $^{2}$  i in Fig. 3 (b). The second follows from direct measurements [22] of  $v_r$  yielding  $v_r / v_z^{2=3}$ . In either case, N would not be constant. (Note that  $(1 \neq 2)$ 

would typically correlate with  $v_r^2$ , so velocity-dependent restitution cannot compensate for the changes in  $v_r$ .)

M ore generally, in slow granular ows it seems that \granular temperature" may not be a useful concept. Figures 3 and 4 clearly show that uctuations depend only on the distance fallen, and yet any notion of tem perature should increase with the ow speed. The fact that the nearest-neighbor topology persists for distances comparable to the system size also seems to cast doubt on the assumption of ergodicity.

Instead, our experimental data suggests that cage rearrangements are caused by the relaxation of contact networks, as are believed to occur in C ouette cells [23]. Such networks could absorb potential energy via rolling and sliding neighbors. The breaking of a contact could cause non-G aussian uctuations and small-scale superdi usion among the particles in a network, while the gradual destruction of a network (and reform ation of a new one) as a particle falls farther than its own diameter could cause the observed transition to norm aldi usion. All of these e ects are dom inated by the geometry of random close packings, which is not fully understood, even w ithout any dynamics [24].

In sum m ary, we have experimentally investigated particle dynamics in dense granular ows | as they occur in silo drainage. Consistent with the void model, we observe di usion after drainage by more than a particle diameter and Pecket numbers which are independent of the ow rate, suggesting that advection and di usion have the same physical source. The Pecket numbers and cage-breaking lengths, however, are much larger than predicted, so the question of an appropriate microscopic model is left open.
