SU (4) Skyrm ions and A ctivation Energy A nom aly in Bilayer Quantum Hall Systems

The bilayer QH system has four energy levels in the lowest Landau level, corresponding to the layer and spin degrees of freedom. We investigate the system in the regime where all four levels are nearly degenerate and equally active. The underlying group structure is SU (4). At = 1 the QH state is a charge-transferable state between the two layers and the SU (4) isospin coherence develops spontaneously. Quasiparticles are isospin textures to be identified with SU (4) skyrm ions. The skyrm ion energy consists of the Coulomb energy, the Zeem an energy and the pseudo-Zeem an energy. The Coulomb energy consists of the self-energy, the capacitance energy and the exchange energy. At the balanced point only pseudospins are excited unless the tunneling gap is too large. Then, the SU (4) skyrm ion evolves continuously from the pseudospin-skyrm ion limit into the spin-skyrm ion limit as the system is transformed from the balanced point to the monolayer point by controlling the bias voltage. Our theoretical result explains quite well the experimental data due to Murphy et al. and Sawada et al. on the activation energy anomaly induced by applying parallel magnetic eld.

I. IN TRODUCTION

Exchange Coulomb interactions play key roles in various strongly correlated electron systems. They are essential also in quantum Hall (QH) systems[1,2], where spins are polarized spontaneously as in ferrom agnets. Much more interesting phenomena occur in bilayer QH systems due to exchange interactions. For instance, an anomalous tunneling current has been observed [3] between the two layers at the zero bias voltage. It may well be a manifestation of the Josephson-like phenomena predicted a decade ago [4]. They occur due to quantum coherence developed spontaneously across the layers [4, 5, 6].

Electrons in a plane perform cyclotron motion under strong magnetic eld $B_{?}$ and create Landau levels. When one Landau level is led up the system becomes incompressible, leading to the integer QH electron position is specified solely by the guiding center X = (X;Y) subject to the noncommutative relation, $[X;Y] = i\frac{\hat{x}}{B}$, with the magnetic length $\frac{\hat{y}}{B} = \frac{\hat{y}}{\sqrt{B}}$. The QH system provides us with a simple realization of noncommutative geometry. It follows from this relation that each electron occupies an area $2\frac{\hat{y}}{B}$ labelled by the Landau-site index. Electrons behave as if they were on lattice sites, among which exchange interactions operate.

In QH ferrom agnets charged excitations are spin textures called skyrm ions[7]. Skyrm ions are identified experimentally [8, 9, 10] by measuring the number of ipped spins per one quasiparticle. Indeed, by tilting samples, the activation energy increases by the Zeem an elect, which is roughly proportional to the number of ipped spins. On the contrary, an entirely opposite behavior has been observed by Murphy et al.[11] in the bilayer QH system at the lling factor = 1, where the activation energy decreases rapidly by tilting samples. It is called the activation energy anomaly because of this

unexpected behavior. Note that we expect an increase since the = 1 bilayer QH system is a QH ferrom agnet with spins spontaneously polarized. This anom alous decrease has been argued to occur due to the loss of the exchange energy of a pseudospin texture based on the bim eron model[6], where the spin degree of freedom is frozen. Here, the layer degree of freedom is referred to as the pseudospin: It is said to be up (down) when an electron is in the front (back) layer.

We investigate physics taking place in the lowest Landau level (LLL). Since each Landau site can accommodate four electrons with the spin and layer degrees of freedom, the underlying group structure is enlarged to SU (4). Let us call it the isospin SU (4) in contrast to the spin SU (2) and the pseudospin SU (2). We study charged excitations in the = 1 bilayer QH system. A natural candidate is the SU (4) isospin texture to be identified with the SU (4) skyrm ion [1, 12]. A specie feature of the SU (4) isospin texture is that it is reduced to the spin and pseudospin textures in certain limits.

At = 1, electrons are transferable between the two layers continuously without breaking the QH e ect[13]. Namely, the bilayer QH system can be continuously brought into the monolayer QH system by changing the density imbalance. It implies that a pseudospin texture at the balanced point must be continuously transformed into a spin texture at the monolayer point. It is natural that a pseudospin texture evolves into an isospin texture and then regresses to a spin texture in this process. The corresponding continuous transformation of the activation energy has already been observed experimentally by Sawada et al.[13, 14, 15]. In this paper we explain these experimental data [11, 14, 15] based on the excitation of SU (4) skyrmions.

In Section II we derive the Landau-site Ham iltonian governing bilayer QH systems, by extending the algebraic method employed previously to investigate multi-

component monolayer QH systems [16]. In Section III we rewrite the Landau-site Ham iltonian into the exchange-interaction form. The Coulomb potentials associated with the direct and exchange interactions are obtained analytically.

In Section IV the ground state is explored in the regim ewhere the SU (4) isospin coherence develops spontaneously. It is shown that the capacitance energy consists of two terms arising from the direct interaction, which is the standard one made of two planes, and from the exchange interaction, by way of which the capacitance energy becomes considerably smaller than the standard one for a small layer separation.

In Section V the excitation energy of an electron-hole pair is calculated exactly. A hole (electron) is the small size lim it of a skym ion (antiskym ion), which is realized when the Zeem an gap $_{\rm Z}$ and the tunneling gap $_{\rm SAS}$ are very large. The exchange energy is very dierent whether the pair excites the spin or the pseudospin. Due to this dierence the pseudospin excitation occurs at the balanced point even if the tunneling gap is quite large. Our result explains why pseudospin ips were observed in the experiment due to Terasawa et al.[15] in a sample having a very large tunneling gap ($_{\rm SAS}$ ' 33K). In Section VI we study skym ions in a microscopic theory, extending the approach [17] previously known for the monolayer system .

In Section V II the e ective H am iltonian is derived from the Landau-site H am iltonian by making the derivative expansion. We introduce composite bosons together with the CP³ eld[12] to describe coherent excitations. In Section V III we carry out an analysis of SU (4) isospin textures identified with topological excitations called CP³ skyrm ions or equivalently SU (4) skyrm ions. A spin texture (spin-skyrm ion) and a pseudospin texture (spin-skyrm ion) are special limits of an SU (4) skyrm ion. We estimate the excitation energy of one SU (4) skyrm ion. We show that, if a ppin-skyrm ion is excited at the balanced point, it evolves continuously into a spin-skyrm ion at the monolayer point via an SU (4) skyrm ion as the density in balance is increased between the two layers.

In Section IX we investigate the activation energy anomaly by applying the parallelm agnetic eld between the two layers. We calculate explicitly the loss of exchange energy of one SU (4) skyrm ion, which is shown to be proportional to the capacitance term. Our theoretical result explains quite well both experimental data due to Murphy et al.[11] and Sawada et al.[14,15].

Section X is devoted to discussions.

II. LANDAU-SITE HAM ILTONIAN

E lectrons perform cyclotron motion under perpendicular magnetic eld $B_{?}$. The number of ux quanta passing through the system is N $$B_{?}\:S=_{D}$, where S is the area and $_{D}$ = 2 ~=e is the ux quantum. There are N Landau sites per one Landau level, each of which is

associated with one ux quantum and occupies an area S=N=2 $^{12}_{B}$. In the bilayer system an electron has two types of indices, the layer index (f, b) and the spin index (";#). One Landau site m ay accomm odate four electrons. The lling factor is =N=N with N the total number of electrons.

The kinetic Hamiltonian is

where stands for the four-component electron eld, and D $_k = i \sim Q_k + e A_k$ is the covariant momentum . The kinetic H am iltonian, which is invariant under the global SU (4) transform ation, creates Landau levels. A ssuming a large Landau level separation we focus on physics taking place in the LLL. Then we may neglect the kinetic energy since it is common to all states.

We introduce 4 4 matrices $_a^{\rm spin}$ and $_a^{\rm ppin}$ generating the spin and pseudospin (ppin) SU (2) groups, as summarized in Appendix A; in particular, $_z^{\rm spin}={\rm diag}\,(1;\ 1;1;\ 1)$ and $_z^{\rm ppin}={\rm diag}\,(1;1;\ 1;\ 1)$. To avoid confusions we use S_a for the spin SU (2) eld, P_a for the pseudospin SU (2) eld (a=x;y;z) and I_a for the isospin SU (4) eld (A=1;2; 15).

The total H am iltonian consists of the C oulomb term , the Zeem an term , the tunneling term and the bias term . The role of the bias term is to transfer electrons from one layer to the other by applying the bias voltage V_{bias} between the two layers.

The Coulomb interaction is decomposed into the SU (4)-invariant and SU (4)-noninvariant terms,

We investigate the regime where the SU (4)-invariant Coulomb term H $_{\rm C}^+$ dominates all other interactions. Note that the SU (4)-noninvariant Coulomb term vanishes, H $_{\rm C}$! O, in the lim it d! O.

It is impossible to choose an orthonormal complete set of one-body wave functions ', (x) in the LLL [18]. Hence

(x) does not satisfy the standard canonical anticommutation relation, as implies that an electron cannot be localized to a point within the LLL. Various interactions are projected to the LLL [16, 18, 19, 20] by expanding the electron eld as in (2.8).

All of the density operators b (p) and $\frac{1}{2}$ A (p) form an algebra, which we have called [16] W $_1$ (4) since it is the SU (4) extension of W $_1$. It gives the fundam ental algebraic structure of the noncommutative system made of 4-component electrons. In general there arises the W $_1$ (N) algebra in the N-component Q H ferromagnet.

III. EXCHANGE INTERACTIONS

In classical theory the C oulomb energy is simply given by (2.2) with the use of the classical density $^{\rm cl}(x)$, but this is not the case in quantum theory. The exchange interaction emerges as an important interaction from the exchange integral over wave functions. We present a rigorous treatment of the direct and exchange energies valid in QH systems.

For this purpose we rewrite the microscopic Coulom b Hamiltonians (2.11) and (2.12) into entirely dierent forms. Based on an algebraic relation,

In (3.8) and (3.10) the sum mation ($_{\rm a=xyz}$, $_{\rm b=xyz}$) over the repeated indices a and b is understood. We call (3.10) the exchange—interaction form of the Coulomb H am iltonian $\dot{P}_{\rm C}$.

We have demonstrated that the Landau-site Ham iltonian H $_{\rm C}$ possesses two entirely dierent form s, the direct-interaction form H $_{\rm D}$ given by (2.20) and the exchange-interaction form H $_{\rm X}$ given by (3.10). They are equivalent, H $_{\rm D}$ = H $_{\rm X}$, as the microscopic Ham iltonian. In this paper we are interested in the excitation energy hS ${\rm H}$ ${\rm S}$ i of a skyrm ion state ${\rm S}$ i. In a previous paper [16] we have presented a heuristic argument showing that

W e present a proof of this form ula for the skymmion state in Appendix B. Thus, the energy of a charge excitation consists of two well-separated pieces, the direct energy and the exchange energy.

IV. GROUND STATE

We rst determ ine the ground state of the bilayer system in this section. For simplicity we start with the spin-frozen SU (2) bilayer system. We are concerned about the regime dominated by the SU (2)-invariant C oulomb interaction H $_{\rm C}^+$. Hence we de ne the ground state as an eigenstate of H $_{\rm C}^+$ given by (2.11), and treat all other interactions as small perturbations.

We take $^0_{\rm C}$ as the Coulomb energy unit in this paper. The unperturbed system is equivalent to the monolayer

SU (2) QH ferrom agnet, where all pseudospins are spontaneously polarized into one arbitrary direction in the SU (2) pseudospin space. The ground state may be expressed as

by introducing two constant parameters $_0$ and $\#_0$. We call $_0$ the imbalance parameter since it represents the density imbalance between the two layers. The ground state is a coherent state due to an in nite degeneracy with respect to $_0$ and $\#_0$.

We then study the elect due to the SU (2)-noninvariant interaction. First, due to the capacitance elect ($V_{m \ n \ ij}$) all pseudospins are polarized into one arbitrary direction within the pseudospin xy plane, in plying that the electron density is balanced between the two layers ($_0=0$). The symmetry SU (2) is broken into U (1). It is thus said that the bilayer Q H system is an easy plane ferrom agnet. Next, we apply the bias voltage to generate an imbalanced density state ($_0 \in 0$), where the symmetry is still U (1). Finally, the tunneling interaction breaks the symmetry completely by xing $\#_0=0$ in the state (4.4). Consequently, the ground state is the bonding state $\#_1$ parametrized by the imbalance parameter $_0$, which is (4.4) with $\#_0=0$.

The generalization to the SU (4) bilayer system is trivial by adding the spin component. The ground state turns out to be the up-spin bonding state β "i due to the Zeem an e ect. It is convenient to represent the up-spin bonding state β "i and the up-spin antibonding state β "i as




FIG. 1: The LLL contains four energy levels corresponding to the two layers and the two spin states. (We call them the g-level, s-level, p-level and r-level.) At = 1 the ground state is the up-spin bonding state. An electron may be moved to any one of the other three levels to form an electron-hole pair excitation.

V. ELECTRON AND HOLE EXCITATIONS

As we see in the succeeding section, a skyrm ion and an antiskyrm ion are reduced to a hole and an electron in their small size limit. We analyze electron and hole excitations in this section to derive some exact results.

A. Electron-Hole Pair Excitation

One electron may be excited from the up-spin bonding state into the down-spin bonding state, the up-spin antibonding state or the down-spin antibonding state FIG .1]. These electron-hole states are




FIG. 2: The energy of an electron-hole pair state is depicted as a function of the imbalance parameter $_0$ based on the formulas (5.5) and (5.10) with typical sample parameters as indicated. Three curves corresponds to the state j $_{\rm s}$ i, j $_{\rm sr}$ i and j $_{\rm p}$ i. We have normalized the activation energy of the pseudospin excitation to zero at $_0$ = 0.

VI. SKYRM IONS IN M ICROSCOPIC THEORY

W e study skyrm ions in a m icroscopic theory of the SU (2) QH ferrom agnet, and then extend the scheme to the SU (4) bilayer QH ferrom agnet. We set $^{\backprime}_{\rm B}$ = 1 throughout in this section, where $_0$ = 1=2 .

There are important SU (2) lim its of SU (4) skyrm ions. When we set $u_p(n) = u_r(n) = 0$, $\mathfrak{F}^s_{sky}i$ and $\mathfrak{F}^s_{asky}i$

describe a skym ion and an antiskym ion where only spins are excited. We call them the spin-skym ion and the spin-antiskym ion. We call them the ppin-skym ion and the ppin-antiskym ion.

It is a dynam icalproblem which skyrm ion-antiskym ion pairs are excited therm ally. As we have shown, as far as electron-hole pairs are concerned, only pseudospins are excited at the balanced point unless the tunneling gap is too large, while only spins are excited at the monolayer point. This is the case also for skyrm ion-antiskyrm ion pair excitations. However, in general, alloom ponents are excited to lower the total energy, which leads to genuine SU (4) skyrm ions. Contrary to the case of the electronhole limit, the transition from the ppin-skyrm ion at the monolayer point ($_0$ = 0) to the spin-skyrm ion at the monolayer point ($_0$ = 1) will occur continuously via a genuine SU (4) skyrm ion since the matrix elements of the total Hamiltonian HD between various skyrm ion states are nonvanishing.

VII. EFFECTIVE HAM ILTONIANS

It is very hard to calculate the skyrm ion excitation energy with use of the microscopic states (6.21) and (6.23) since they involve in nitely many functions $u_s(n)$, $u_p(n)$, $u_r(n)$ and v(n). In this paper we construct the elective theory by making the derivative expansion of the H am iltonian. Thus, strictly speaking, our approximation is good only for large skyrm ions. Nevertheless, its application even to small skyrm ions would present us invaluable results otherwise unavailable. We wish to develop a microscopic theory in a future work.

Our analysis is based on the decomposition formula (3.12) into the direct and exchange energy terms. In what follows we represent the classical density $^{cl}(x)$ simply by (x) since we use only classical elds.

The exchange effect m akes the capacitance energy quite small for a small layer separation [25]. We note that our capacitance formula (4.8) is different from the one assumed in some literature [6, 26].

VIII. SEM ICLASSICAL ANALYSIS

We use bosonic variables to describe coherent excitations such as spin and pseudospin textures. In so doing we introduce the composite-boson (CB) eld [27, 28]. This approximation reduces the validity of some of our results. Indeed, we have found that the mixing between the excitation modes to the s-level and the r-level lowers the energy of the electron-hole pair state [FIG 2]. Nevertheless, we use this approximation to reveal an essential physics of SU (4) skymmions, because otherwise various formulas become too complicated to handle with. By an essential physics we mean a continuous transformation of the SU (4) skymmion from the ppin-skymmion limit to the spin-skymmion limit in contrast to the case of the electron-hole excitation.

Thus we study a skyrm ion param etrized by two shape param eters $_{\rm S}$ and $_{\rm p}$ with 2 = $_{\rm s}^{2}$ + $_{\rm p}^{2}$. We calculate the SU (4) generators (8.4) for this eld con guration,




FIG. 3: The skyrm ion energy is estimated as a function of the imbalanced parameter $_0$ with sample parameters $_{\rm SAS}=1{\rm K}$, and $_0=1.2$ $10^{11}/{\rm cm}^2$. The experimental data are taken from Terasawa et al.[15]. Solid lines show the energies of a ppin-skyrm ion and a spin-skyrm ion, normalized to the data at the balanced point and the monolayer point, respectively. The experimental data would be explained by the excitation of a genuine SU (4) skyrm ion.

ppin-skym ions are excited at the balanced point ($_0$ = 0): See (D 3). Then, it evolves continuously into a spin-skym ion at the monolayer point ($_0$ = 1) via a generic skym ion ($_s$ $_p$ $_{\rm f}$ 0). As we have stated, to simplify calculations we have set $_{\rm r}$ = 0 in the SU (4) skym ion (8.11). When we allow a skym ion to be excited into the r-level ($_{\rm r}$ $_{\rm f}$ 0), a genuine SU (4) skym ions ($_s$ $_p$ $_r$ $_f$ 0) would be excited except at the monolayer point, as illustrated in FIG 3. Compare this with FIG 2.

We exam ine the condition (8.36) numerically. When we adopt typical values of sample parameters ($_{0}$ = 10^{11} /cm² and d = 231A), we not the capacitance (4.8) to be $_{\text{cap}}$ ' 132K while the exchange-energy difference to be $4 J_s = 3 ' 5:4K$. The condition is hardly satis ed. Here, we question the validity of the standard identi cation of the layer separation, $d = d_B + d_W$, where d_W ' 200A is the width of a quantum well and d_B ' 31A is the separation of the two quantum wells. In this identication the electron cloud is assumed be localized in the center of each quantum well. However, it is a dynamical problem. Let us m in im ize the ppin-skym ion energy as a function of d. The minimum is found to be achieved at $d < d_B$. Namely, the energy increases monotonously for $d > d_B$. Then, it would be reasonable to use $d = d_B$ as the layer separation to estimate the energy of the ppinskymmion. W hen we choosed $^\prime$ 31A we nd $_{
m cap}$ $^\prime$ 4.5K . Then, the condition (8.36) is satis ed in some parameter regions, where ppin-skym ions are excited.

However, the condition (8.36) cannot be taken literally, because it rules out excitations of large ppin-skyrm ions ($^2\mathrm{N}$ 1) against experimental indications[11, 14, 15]. It seems that the exchange energy has been underestimated by making the derivative expansion. It is necessary to go beyond the present approximation to fully understand the problem .

We proceed to estim ate the energies of a spin-skyrm ion and a ppin-skyrm ion in all range of $_{\rm 0}$, because their estimation is much more reliable than that of a generic SU (4) skyrm ion. We use sample parameters $_{\rm 0}=1.2$ $10^{11}/{\rm cm}^{\,2}$, d=31A and $_{\rm SAS}=1{\rm K}$, and normalize the energy to the experimental data [15] at the monolayer point for a spin-skyrm ion and at the balanced point for a ppin-skyrm ion. Recall that the absolute value of the activation energy cannot be determined theoretically because they depends essentially on samples.

First, we calculate the energy of a spin-skyrm ion as a function of $_0$ by setting = $_{\rm s}$ and $_{\rm p}$ = 0 in (8.35). The skyrm ion scale , to be determ ined by m inim izing this, depends on $_0$ very weakly. We obtain N $_{\rm spin}$ () ' 3.5 as in the monolayer Q H ferrom agnet [1, 12]. We have depicted the excitation energy E $_{\rm sky}^{\rm spin}$ in F IG 3, where it is norm alized to the data at the monolayer point.

Next, we calculate the energy of a ppin-skyrm ion as a function of $_0$ by setting = $_p$ and $_s$ = 0 in (8.35). There is an important remark. The elective tunneling gap diverges as $_0$! 1 unless $_{SAS}$ = 0. Furthermore, the minimum pseudospin ip is N_{ppin} = 1 for a skyrm ion-antiskyrm ion pair. IX. ACTIVATION ENERGY ANOMALY

We have studied how one skyrm ion evolves continuously from the balanced point ($_0=0$) to the monolayer point ($_0=1$) by changing its shape. It is important how to distinguish various shapes of skyrm ions experimentally. As is well known, as the sample is tilted, the activation energy of a spin-skyrm ion increases due to the Zeem an energy. On the contrary, the activation energy of a ppin-skyrm ion decreases due to the loss of the exchange energy. Thus, the tilted-eld method provides us with a remarkable experimental method [11, 14] to reveal the existence of various shapes of a skyrm ion in bilayer QH systems.

As the sample is tilted, the parallel magnetic eld B_k is penetrated between the two layers. We take the symmetric gauge generalized as




FIG. 4: The activation energy at = 1 is plotted as a function of the tilting angle in several sam ples with dierent tunneling gaps $_{SAS}$. It shows a rapid decrease towards the critical angle , and then becomes almost at. The data are taken from Murphy et al.[11]. They are well tted by the theoretical formula (9.11), where the activation energy decreases in the commensurate phase and becomes at in the incommensurate phase. To the data, we have adjusted the activation energy at = 0 with the experimental value, and assumed that the number of ipped pseudospins $N_{\rm ppin}$ is constant for all values of the tilting angle.

It has been shown [1, 6] that, when the parallel magnetic eld B_k increasesm ore than a certain critical point, the phase transition occurs in the bilayer Q H system: It is the commensurate—incommensurate transition point B_k . In the incommensurate phase the penetrated magnetic eld is not increased more than B_k , because the excess magnetic eld $B_k=B_k$ B_k is eaten up to create penetrated sine-G ordon vortices between the layers. At each angle , in principle, it is necessary to m inim ize the total excitation energy (9.11) and determ ine the scale parameter . However, since the energy change (9.12) is quite small compared with the total energy, we may treat it as a small perturbation. Namely, we may assume that the ipped pseudospin number $N_{\rm ppin}$ is a constant independent of . This reminds us of experimental data [32, 33], where the ipped spin number $N_{\rm spin}$ is nearly constant by tilting the sample in the excitation of spin-skyrm ions.

We have tted the data due to M urphy et al.[11] in FIG A by assuming an appropriate ipped pseudospin number N $_{\rm pp\,in}$ per one skyrm ion-antiskyrm ion pair. We sum marize the result in a table.




FIG.5: The activation energy at = 1 is plotted as a function of in one sample ($_{\rm SAS} = 11~{\rm K}$, $_{\rm 0} = 0.6 - 10^{11}/{\rm cm}^2$) with dierent imbalance parameter $_{\rm 0}$. It shows a decrease towards the critical angle $_{\rm 0}$, and then begin to increase for $_{\rm 0} = 0.3$ and $_{\rm 0} = 0.7$. The data are taken from Sawada et al.[14]. To $_{\rm 0}$ the data by the theoretical formula (9.15), we have adjusted the activation energy at $_{\rm 0} = 0$ with the experimental value, and assumed that the ipped spin number N $_{\rm ppin}$ and the ipped pseudospin number N $_{\rm ppin}$ are constant for all values of the tilting angle.

Experim ents have been carried out by Saw ada et al.[14] in bilayer sam ples (FIG.5), where the activation energy was measured at $\,=\,1$ by controlling both the tilting angle $\,$ and the imbalance parameter $_0$. Their data are interpreted based on the theoretical result (9.15) as follows. As seen in FIG 5, the $\,$ tting is quite good when by assuming constant values of N $_{\rm sp\,in}$ and N $_{\rm pp\,in}$ throughout the range of . A deviation of the theoretical curve from the data for large tilting angles $\,>\,70\,$ would be due to e ects not taken into account in the above analysis. For instance, when the parallelm agnetic $\,$ eld become too large, the soliton lattice becomes too dense in the incommensurate phase and would destabilize skyrm ions. We summarize the numbers N $_{\rm sp\,in}$ and N $_{\rm pp\,in}$ per one skyrm ionantiskyrm ion pair determ ined by this $\,$ tting in a table.

As the sample is tilted, N $_{\rm spin}$ increases and N $_{\rm ppin}$ decreases. In particular, both spins and pseudospins are ipped unless $_0$ = 0 or $_0$ = 1. We conclude that the SU (4) skyrm ion evolves continuously from the ppin-skyrm ion lim it to the spin-skyrm ion lim it as $_0$ increases from 0 to 1.




FIG. 6: The activation energy at = 1 is plotted as a function of in a sample ($_{\rm SA\,S}=33{\rm K}$, $_{\rm 0}=1.0~10^{11}/{\rm cm}^2)$. The data are taken from Terasawa et al.[15]. To the data by the theoretical formula, we have adjusted the activation energy at = 0 with the experimental value. We have also assumed that N $_{\rm Sp\,in}$ and N $_{\rm Pp\,in}$ are constant for all values of the tilting angle. A better thing is obtained as indicated by a solid line when both spins and speudospins are excited.

It is interesting to study the same problem in a sample having a very large tunneling gap. Terasawa et al.[15] have measured the activation energy by controlling the tilting angle—at the balanced point in a sample with $_{\rm SAS}$ ' 33K. We have—tted their data [FIG.6] by the ppin-excitation formula (9.11) and by the generic formula (9.15). It is discult to—t the data if pure pseudospin excitations are assumed since it is required that N $_{\rm ppin}$ —1 per one pair. A better—tting is obtained if spins and pseudospins are excited simulaneously since N $_{\rm ppin}$ may take a smaller value than 1. Such a simultaneous excitation is allowed at the balanced point as explained in Appendix D .

In passing we comment on the original mechanism [6, 35, 36] proposed to explain the activation energy anomaly based on the exchange-energy loss of bimeron excitations.

A bim eron has the sam equantum num bers as a skyrm ion, and it can be viewed as a deformed skyrm ion with two m eron cores with a string between them. The bim eron excitation energy consists of the core energy, the string energy and the Coulomb repulsive energy between the two cores. It is argued that the parallel magnetic eld decreases the string tension and hence the bim eron activation energy. Clearly the mechanism works well only when the string length is much larger than the core size. A microscopic calculation has already revealed [37] that them eron core size is large enough to invalidate the naive picture. Furtherm ore, the skyrm ion is alm ost as small as the hole itself in samples with large tunneling gap. On the contrary, in our mechanism the decrease of the exchange energy follows simply from the phase di erence induced by the parallelm agnetic eld between the wave functions associated with the two layers, and it is valid even for small skym ions.

X. DISCUSSION

We have investigated the dynam ics of bilayer Q H systems based on an algebraic method inherent to the noncommutative plane with [K;Y] = i_B^2 . The noncommutativity induced by the LLL projection implies that the electron position cannot be localized to a point but to a Landau site occupying an area 2 i_B^2 . We have derived the Landau-site Hamiltonian H $_C$ akin to the lattice Hamiltonian. It has two entirely different forms, the direct-interaction form H $_D$ and the exchange-interaction form H $_X$. They are equivalent, H $_D$ = H $_X$, as the microscopic Hamiltonian. Nevertheless, the energy of a charge excitation consists of two well-separated pieces, the direct energy H $_D^{c1}$ and the exchange energy H $_X^{c1}$.

One of our new contributions is the derivation of vari-

ous LLL-projected C oulom b potentials in analytic form s. For instance, we have revealed a new form of the capacitance energy (7.12) with $_{\rm cap}=4\,(_{\rm D}\,_{\rm X}\,)$. It is a sum of the direct and exchange C oulom b interaction e ects, where the direct e ect yields the well-known result from the planar condenser proportional to the layer separation, while the exchange e ect gives a quite large negative contribution to it when the layer separation is small enough.

We have explored various aspects of SU (4) skyrm ions at = 1. In particular we have studied a skyrm ion-antiskyrm ion pair in its small size lim it (electron-hole pair) and its large size lim it.

The excitation energy of an electron-hole pair is exactly calculable. We have obtained the excitation energy as a function of the imbalance parameter $_{0}$. The result is quite interesting: At the balanced point ($_{0}=0$) the pseudospin excitation occurs provided the tunneling gap is not too large ($_{\rm SAS}$ $_{\rm Z}$ < 2 $_{\rm X}$). A peculiar feature is that, as $_{0}$ increases, the spin excitation occurs suddenly because the excitation involves just one electron or hole. At the monolayer point ($_{0}=1$) only spins are excited always. We have also extended the microscopic theory of skyrm ions[17] to our framework. However, a quantitative analysis is yet to be carried out.

We then have estimated the SU(4) skyrm ion excitation energy as a function of $_0$ based on the e ective H am iltonian valid for very smooth isospin textures. In typical sam ples it ips only pseudospins at the balanced point. As o increases, it evolves continuously to ip both spins and pseudospins, and nally ips only spins at the monolayer point. We have then calculated how the excitation energy changes as the sam ple is tilted. Our form ula has explained quite well the activation energy anomaly found by M urphy et al.[11] at the balanced point by excitations of pseudospins, and also found by Sawada et al.[14] at various values of o by simultaneous excitations of spins and pseudospins. Though our formulas are derived for su ciently am ooth skyrm ions, they have turned out to be quite good at least with the use of phenomenological values of N $_{\rm sp\,in}$ and N $_{\rm pp\,in}$. W e w ish to develop a m icroscopic theory to analyze small skyrm ions in a future work. In conclusion, the activation energy anomaly is explained by the loss of the exchange energy of SU (4) skyrm ions, which are reduced always to spin-skyrm ions at the monolayer point and mostly to pseudospin-skym ions at the balanced point.

Based on the skyrm ion-energy formula (8.35) we verify that, if a ppin-skyrm ion ($_{\rm S}$ = 0, $_{\rm p}$ =) is excited at the balanced point, it evolves continuously into a spin-skyrm ion ($_{\rm S}$ = , $_{\rm p}$ = 0) via a generic skyrm ion ($_{\rm S}$ p \in 0) as the imbalance parameter $_{\rm 0}$ increases.

The transition occurs continuously as illustrated in FIG 3, with the critical points $_p$ and $_s$ being xed by (D 3) and (D 6). On the other hand, generic skym ions are excited at the balanced point if A (; $_0$) < 0 and $z_{m \ in}$ < 1 at $_0$ = 0, and spin skym ions are excited at the balanced point if A (; $_0$) < 0 and $z_{m \ in}$ < 1 at $_0$ = 0.
