### Shape m em ory ferrom agnets

In ferrom agnetic alloys with shape m em ory large reversible strains can be obtained by rearranging the m artensitic dom ain structure by a m agnetic eld. M agnetization through displacement of dom ain walls is possible in the presence of high m agnetocrystalline anisotropy, when m artensitic structure rearrangement is energetically favorable compared to the reorientation of m agnetic m om ents. In ferrom agnetic H eusler alloys N  $i_{2+x}$  M  $n_1$   $_x$  G a the C urie tem perature exceeds the m artensitic transformation tem perature. The fact that these two tem peratures are close to room tem perature o ers the possibility of m agnetically controlling the shape and size of ferrom agnets in the m artensitic state. In N  $i_{2+x}$  M  $n_1$   $_x$  G a single crystals, a reversible strain of 6% is obtained in elds of 1 T.

#### I. IN TRODUCTION

In this review we exam ine the properties of ferrom agnets that exhibit shape m em ory and hyperelasticity (superplasticity) and that m ake it possible to control these e ects m agnetically. Shape m em ory in such substances is related to a m artensitic phase transition, and the e ect of a m agnetic eld on the param eters of the m artensitic phase is caused by m agnetoelastic interaction. The speci c feature of the m agnetoelastic interaction is that the entities that participate in the interaction are large intercorrelated ensembles of structural and ferrom agnetic dom ains. In this respect the m agnetoelastic interaction in shape m em ory ferrom agnets, which leads to giant m agnetically induced strains, di ers signi cantly from m agnetostriction, which is essentially a one-particle e ect.

The possibility that certain substances can be reversibly controlled both in shape and size by mechanical stresses and electric or magnetic eld places them into a separate class of functional materials. Representatives of this class are magnetostrictive materials, piezoelectric materials, and materials with shape memory. The hierarchy of the attainable reversible strains in crystals caused by magnetostriction (MS), the piezoelectric e ect (PE), and shape memory (SM) is as follows:

Each of these m ethods of controlling the size of sam ples of such m aterials has its advantages and draw backs and its own area of application. M agnetostrictors are used as em itters and detectors of sound, frequency stabilizers, and delay lines in w ireless and acoustic devices, as m icroactuators and as m agnetom echanical relays. M aterials with shape m em ory are used in therm osensitive force-sum m ing elem ents, detachable and nondetachable joints that do not require welding or soldering, and in various types of clam ps used in m edicine. An advantage of m agnetostrictive m aterials is the sm all response tim e, while an advantage of m aterials with shape m em ory is the large reversible strains.

Studies of shape m em ory ferrom agnets focus on ways to produce m aterials in which short response times are combined with large reversible strains. Several Heusler alloys and the interm etallic compounds Co{Ni, Fe{Pd, Fe{Pt, and Fe{Ni{Co{Ti have been investigated in this connection. The most promising results have been obtained with the ferrom agnetic Heusler alloy Ni<sub>2</sub>M nG a. This unique alloy (m ore exactly, the family of Ni<sub>2+x+y</sub>M n<sub>1 x</sub> Ga<sub>1 y</sub> alloys) has made it possible to achieve m agnetically controlled variations in the linear size of crystals up to 6%, which is the theoretical lim it of strains for m artensitic transform ations in this m aterial.

The general ideas about martensitic transform ations and the related special features of the mechanical behavior of alloys with therm oelastic martensitic behavior are examined in Section 2. In Section 3 we discuss the crystal structure of the H eusler alloys N  $i_{2+x+y}$ M  $n_1 \ge G a_1 \ge y$ and in Section 4, the magnetic properties of these alloys. Section 5 is devoted to a description of the main physical properties of N  $i_{2+x+y}$ M  $n_1 \ge G a_1 \ge y$  as a function of composition. In Section 6 we describe experimental implementations of the magnetically controlled shape mem ory e ect in N  $\frac{1}{2}$ + x+ yM n<sub>1</sub> x G a<sub>1</sub> y. A sum - m ary of the data on other m aterials for which m agnetic control of the shape mem ory e ect is possible is given in Section 7. Section 8 is devoted to the theory of structural and m agnetic phase transitions in cubic ferrom agnets. In Section 9 we discuss the prospects of further investigations in this eld and the possibilities of using this class of m aterials in applications.

#### II. M ARTEN SIT IC TRAN SFORM AT ION S AN D THE SHAPE MEMORY EFFECT

## A. Therm oelastic and nontherm oelastic martensitic transform ations

M artensitic transform ations are structural phase transitions of the di usionless, cooperative type. The characteristic features of such transform ations are the cooperative displacem ents of neighboring atom s by distances sm aller than the atom ic separation, a rigorous crystallographic connection between the lattices of the initial and nalphases, and changes in the shape of the transform ed

region [1]. M artensitic transformations were rst discovered in iron-based alloys (steel). Initially they were interpreted as structural transformations of a high-tem perature facecentered cubic (fcc) phase ( -phase, austenite) into a low tem perature body-centered cubic (bcc) phase ( -phase, m artensite). The m ain laws governing such transform ations have been established without doubt. It was found that transform ations sim ilar to the m artensitic transform ation in steel occur in solids of a di erent nature (m etals, insulators, sem iconductors, and organic com pounds) and belong to one of the m ain types of phase transfor-

mations in the solid state  $[2\{4]$ .

The most general feature of martensitic transform ations is that they occur in the solid medium at low tem peratures, when all di usion processes are frozen. The conditions under which martensitic transform ations take place (elastic m edium, low tem peratures) determ ine all the main features of the transform ations. The manifestations of m artensitic transform ations are multivarious. They may proceed athermally with a rate equal to the speed of sound, or they can be therm ally activated and develop with a measurable rate, be reversible or irreversible, or lead to form ation of morphologically di erent structures that depend on the crystal geom etry and properties of the initial and nalphases and on the developm ent of relaxation processes. A m ong transform ations that are called m artensitic are those that m ay be considered "nearly second-order" and transform ations that are clearly rst-order accompanied by large heat and volum e e ects and a sizable hysteresis between the direct and reverse transform ations.

The emergence of a new-phase crystal inside the initial matrix leads to the appearance of elastic and surface energies. If the di erence in the crystal lattices is

slight and the accomm odation of the new -phase and matrix crystals is not accompanied by an irreversible plastic strain, the transform ation may be considered fully reversible. The hysteresis between the direct and reverse transform ations in this case is small, so that the structure of the initial phase is completely restored as a result of the reverse transform ation. The sm all elasticity modulus and the high elastic limit of the phases (which ensures elastic accommodation of the intrinsic transformation strain), in addition to the small di erence in the lattices of the initial and nal phases, are conducive to the reversible nature of the transform ation. M artensitic transform ations of this type are called thermoelastic. The reversible nature of the transform ation is the necessary condition for emergence of reversible effects under an external load: hyperelasticity, rubber-like behavior, and the shape memory e ect.

If the di erence in the crystal lattices of the phases is large and cannot be elastically accom m odated, the transform ation is accompanied by plastic strain and the emergence of structural defects, which hinder the easy m otion of interphase boundaries. Here the reverse transform ation proceeds not so much because of the gradual decrease in the size of the martensite crystals but largely because of nucleation and the grow th of austenite crystals inside the martensitic matrix. This process is accompanied by an increase in the number of orientations of the high-tem perature phase, in contrast to the reproduction of the initial orientation in a therm oelastic transform ation. M artensitic transform ations of this type are called nontherm oelastic.

Since m artensitic transform ations are rst-order phase transitions, the tem peratures of their beginning and end are their characteristic param eters. The transform ation of austenite into m artensite (direct transform ation) is characterized by the tem perature M  $_{\rm s}$  of the appearance of nuclei of the m artensitic phase in the austenitic m atrix and the tem perature M  $_{\rm f}$  at which the form ation of them artensite ends. In the reverse transform ations these tem peratures are denoted A  $_{\rm s}$  and A  $_{\rm f}$ .

There is no well-de ned boundary between therm oelastic and nontherm oelastic transform ations: to one extent or another all martensitic transform ations are reversible | the question is how large the size of the hysteresis between the direct and reverse transform ations is. In some cases (with Cu{Sn,Fe{Pt, and Fe{Co{Ni{Tialloys}} thermal treatment can change the size of the hysteresis and thus change the type of martensitic transform ation.

A nom alies in the mechanical properties are inherent in all low-temperature structural phase transform ations, irrespective of the nature of the material and the electrical and magnetic properties of the phases. Speci c effects related to the action of an electric or magnetic eld manifest them selves only when one of the phases exhibits ferroelectric or ferrom agnetic properties, respectively.

If, due to the crystal geom etry, the m artensitic transform ation is of the "nearly second-order" type and the intrinsic transform ation strain " is the order param eter, the elastic constant corresponding to this strain vanishes at the start of the transform ation or becom es sm all. Examples are the low-tem perature structural transitions in the superconductors  $Nb_3Sn$  and  $V_3Si$  [5]. In substances in which the crystal geometry of the transform ations is such that they could, in principle, be second-order transitions but proceed as rst-order transform ations (transformations in the In{Tl, Au{Cd, and Mn{Cu alloys), the elastic constants decrease as the point at which the transform ation begins is approached but rem ain nite 5, 6]. Finally, if the transform ation is clearly a rst-order one, as it happens to be in Li, Na, and Cs [7] or in the transition of the high-tem perature face-centered phase to the low-tem perature body-centered phase in iron alloys, the elastic constants have no anom alies as the martensite point is approached.

#### B. Hyperelasticity and superplasticity

Above the martensite point a transform ation can be caused by applying external stresses [8]. An external stress perform swork along the path determ ined by the intrinsic transform ation strain ". This work provides an additional contribution to the therm odynam ic driving force of the transform ation. The shift in the tem perature  $T_0$  of the therm odynam ic equilibrium of the phases and, respectively, in the martensite point M  $_{\rm s}$  is described by the generalized C lapeyron equation

where ij are the external stresses corresponding to " and S is the change in entropy at the transform ation. For xed " and S, the shift of the martensite point is greater, the higher the external stresses. However, under stresses greater than the elastic lim it plastic strain sets in, and this hinders therm celastic transform ation. This lim its both the level of adm issible stresses and the greatest possible rise in the martensite point at which the transform ation remains therm celastic. If the tem perature M (the tem perature at which the transform ation can be caused by stresses not exceeding the elastic  $\lim it$ ) is higher than the tem perature A<sub>f</sub> at which the reversible transform ation ends, when the external stresses are lifted the martensite that form ed under the stresses transform s into the initial phase, i.e., the transform ation proves to be m echanoelastic. Thus, within a certain tem perature range that adjoins the martensite point, under an external load there occur a mechanoelastic martensitic transform ation and a reversible "hyperelastic" strain associated with this transform ation.

In some alloys subjected to external stresses there can be one or several martensitic transformations of one martensitic phase into other martensitic phases. In this case hyperelasticity caused by these mechanoelastic transform ations m ay be observed even below the m artensite point.

In some alloys subjected to an external load in the tem perature interval from M  $_{\rm s}$  to A  $_{\rm s}$ , the m artensite that was produced as a result of external stresses does not disappear when the load is rem oved and, instead of hyperelasticity, there is residual strain caused by the em ergence of martensite (superplasticity). At  $M_s$  the stresses that initiated the transform ation and brought on pseudoplastic strain are close to zero. As the tem perature is raised, the stresses that caused superplastic strain increase, too, in accordance with the generalized C lapeyron equation. At a certain "distance" from the martensite point the stresses that initiated the transform ation may exceed the yield stress of the material and ordinary plastic strain sets in along with the transform ation. Under certain conditions the interaction of plastic strain and martensite transformation may lead to a substantial increase in plastic strain, which precedes the breakup of the sam ple.

#### C. Shape memory e ect

In most alloys with a therm oelastic martensite transform ation the application of a load in the martensitic phase leads to residual strain in the material. This strain sets in because of the transform ations in the martensitic structure (via twinning, growth of martensite crystals favorably oriented with respect to the external load at the expense of less favorably oriented crystals, etc.). As the temperature is increased, the initial orientation and structure of the high temperature phase, and thus the initial shape of the sample, are restored in the reverse transform ation. The e ect of restoration of the shape of the deform ed sample as a result of a reverse martensitic transform ation in the process of heating the sample is called the shape memory e ect.

Restoration of shape in the reverse transform ation is observed in them oelastic martensitic transform ations as well as in nontherm oelastic martensitic transform ations. A speci c feature of alloys with them oelastic transform ation is that the degree of shape restoration in them is very high and approaches 100%. All factors that favor the them oelastic nature of a martensitic transform ation also favor the maximum manifestation of the shape memory e ect.

Since the form ation of nuclei of the low-tem perature phase at a m artensitic transform ation is heterogeneous, a fact corroborated by the m icrostructural reversibility of the transform ation, the creation of the m ost favorable locations of nucleation of m artensite can determ ine the entire sequence of the em ergence of m artensite crystals and, consequently, the overall change of shape of the sam ple in the transform ation. The creation and pinning of the centers of heterogeneous nucleation m akes it possible to control the process of m artensitic transform ation under cyclic variations in the tem perature. As a result, the transform ation follows the same path in cooling and in heating, so that a two-way (reversible) shape mem – ory e ect emerges. There are several ways in which a reversible shape memory e ect can be achieved: through strains that lie outside the lim its of reversible strain in the austenitic orm artensitic state [9, 10]; through multiple repetition of the cooling (deform ation {heating cycles that lead to the shape memory e ect [11]; through multiple repetition of the loading cycles at a temperature above  $A_f$  (the nal temperature of the reversible transform ation) that lead to hyperelasticity (pseudoelasticity) [11]; through repetition of the cycles "heating above  $A_f$ 

cooling under load to M  $_{\rm f}$  (the naltern perature of the martensitic transform ation) removing the load heating above  $A_f$  " [12]; and through therm altreatment under load. All these treatments lead to the emergence of spontaneous strain upon cooling, and the value of this strain is smaller than in the ordinary shape memory effect. M oreover, the stresses generated in the direct transform ation are much smaller than those characteristic of the reverse transform ation. R eversibility disappears even under a sm all load, although without a load it can be reproduced several hundred times. The explanation of the easy disappearance of the shape memory e ect in a direct transform ation under load is that for a direct transformation there are several crystallographic variants, and the variant chosen is the one that reduces the external stresses. In view of these crystallographic factors, it is practically in possible to increase the stress that appears in the direct transform ation.

All these e ects, which are realized in the stress vs tem perature plane, have been thoroughly studied for various classes of materials and form the basis of our discussion. The subject of the present review is a description of m artensitic transform ations and the accom panying shape memory e ects in ferrom agnets. The presence of a magnetic subsystem in substances that undergo such transform ations enriches the picture and makes it possible to study the phenom ena that occur in them using three coordinates: load, magnetic eld strength, and tem perature. The e ect of a magnetic eld does not amount solely to a modi cation of these e ects { it opens up new possibilities in controlling the shape and size of shape m em ory ferrom agnets. A m agnetic eld can be used to shift the tem peratures of structural phase transitions and to a ect the topology of the martensitic phase. Here the param eters of the magnetic subsystem of a ferrom agnet play the leading role. The di erence in the magnetization of austenite and martensite determines the size of the shift in the temperature of a phase transition in a m agnetic eld. The m agnetoelastic coupling and m agnetocrystalline an isotropy constants determ ine the possibility of transform ing the martensitic variants by applying a magnetic eld.

The same phenom ena that are observed in nonm agnetic m aterials in the load vs tem perature plane can, in principle, be realized in the magnetic eld strength vs tem perature plane. M agnetically induced strains that




FIG.1:  $L2_1$  structure of the austenitic phase of N  $i_2$ M nG a.

are greater than simple single-ion m agnetostriction have been observed in som e H eusler alloys and in a number of interm etallic compounds. The H eusler alloy N  $i_2$ M nG a, in which the m artensitic transform ation takes place in the ferrom agnetic state [13], has so far attracted the greatest attention.

## III. HEUSLER ALLOY N $\mathrm{I}_2 M$ NGA:ELASTIC SUBSYSTEM

### A. Crystal structure

Heusler alloys are ternary intermetallic compounds with the general formula  $X_2 Y Z$ . The N  $\frac{1}{2}$  M nG a alloy, which belongs to this fam ily, has the  $L2_1$  structure at room temperature, which, as shown in Fig. 1, can be represented by a bcc lattice in which the Ni atom s occupy the position at the center of the cube, while the M n and G a atom s alternatively occupy the positions at the apexes [14]. The form ation of such a structure from the melt (the melting point of N b M nG a is roughly 1380 K) is, in principle, possible either from the fully disordered phase A2 (A2 !  $L2_1$ ) or through the partially ordered intermediate phase  $B2^0$  (A2 !  $B2^0$  !  $L2_1$ ), in which the Niatom salready form the frame of the lattice, while the Mn and Ga atom s still occupy arbitrary positions. But with N i/M nG a the situation is di erent [15]. As the tem perature decreases, this compound passes from the melt directly into the partially ordered phase  $B2^0$ , and this phase then experiences a second-order phase transition of the disorder (order type [16]. The  $B2^0$   $L2_1$ transition temperature for N 1/M nG a is about 1070 K. Down to T<sub>m</sub> 200 K Ni2MnGa remains in the L21 phase, and this Heusler alloy then undergoes a rst-order phase transition to a martensitic tetragonal phase, with c=a < 1. At room temperature the cubic lattice constant a of N i/M nG a is 5.825 A and the unit cell volum e 198 A<sup>3</sup> (the num ber of form u la units per unit cell Vcub

is Z = 4). At low temperatures the parameters of the tetragonal lattice are a = b = 5.920 A and c = 5.566 A, with c=a = 0.94, and the unit cellvolum e is  $195 \text{ A}^3$  [14].<sup>1</sup>

This does not exhaust the sequence of phase transitions in N  $i_2$ M nG a, since these alloys can experience a premartensitic transition and intermartensitic transformations.

N ote that in studies of the crystal structure of the nonstoichiom etric N  $\frac{1}{2}$ M nG a alloys by the X-ray (or electron) di raction m ethod no re ections corresponding to the L2<sub>1</sub> structure have been observed because the atom ic scattering factors of the constituent elements are close to each other. A lthough the re ections observed in Xray di raction patterns represent only the short-range order corresponding to the B2 structure, traditionally the crystal structure of the cubic phase of the fam ily of N  $\frac{1}{2}$ + x+ yM n<sub>1</sub> x G a<sub>1</sub> y alloys is considered as L2<sub>1</sub> structure. It must also be noted that for sam ples of nonstoichiom etric composition a m artensitic phase with orthorhom bic and m onoclinic distortions has been reported (see Section 3.3).

Before we discuss the physical properties of N i/M nG a any further, a rem ark concerning the chem ical com position of this Heusler alloy is in order. A lm ost all param eters of N 1/2 M nG a have proven to be very sensitive to the chem ical composition of the samples. The sample's com position strongly a ects the tem peratures of phase transform ations and the form ation of superstructures in the austenitic and martensitic states. In many original publications, the exact composition of the sample is not given and is assumed to be stoichiom etric. This has led to a situation in which, for instance, the temperatures (known from the literature) of the martensitic transformation vary from less than 4.2 K to 626 K [17]. Bearing all this in m ind, we will give, where possible, not only the nom inal composition but also the tem peratures of the investigated phase transition. The fact that these param eters do not agree with each other m ay m ean, for one thing, that the chem ical composition of the investigated sam ples does not agree with the com ponent ratio in the working mixture. The dependence of the most im portant param eters of the N i2M nG a alloy on com position is discussed in Section 5.

#### B. Prem artensitic phenom ena

Various pretransitional phenom ena occur prior to the structural transform ations of the martensitic type observed in a broad class of materials. Among these are the form ation of soft modes in the lattice, anom alous broadening of the rejections in the X-ray spectrum, the emergence of a tweed structure, etc. Pretransitional phenom ena are observed in superconductors with an A15 structure and in ferroelectrics with a perovskite structure [5] and in a broad class of shape memory alloys [6, 18]. W hat sets the H eusler alloy N ½M nG a apart from all other compounds that experience martensitic transform mations is that, in addition to pretransitional phenom ena [19, 20], there can be a premartensitic phase transition.

The physical nature of the premartensitic transition has been the topic of theoretical [21, 22] and experim entalwork, including neutron di raction [23{25], transport [26, 27], m agnetic [28], m echanical [29{31], and ultrasonic m easurem ents [32{35], and electron m icroscopy [36, 37].




FIG.2: (a) D ispersion curves of the phonon  $[0] TA_2$  m ode in N i<sub>2</sub>M nG a [20], (b) tem perature dependence of the squared frequency of the phonon 0.33 [110] TA<sub>2</sub> m ode in N i<sub>2</sub>M nG a [20], and (c) tem perature dependence of the squared frequency of the phonon 0.33 [110] TA<sub>2</sub> m ode in N i<sub>51:5</sub>M n<sub>23:6</sub>G a<sub>24:9</sub> [38].

The focus in the inelastic neutron scattering study [20] of a N i<sub>2</sub>M nG a single crystal with a martensitic transition  $T_m = 220$  K was on the transverse acoustic phonon TA<sub>2</sub> m ode in the [0] direction. At = 0 this mode corresponds to the elastic constant C<sup>0</sup> = (C<sub>11</sub> C<sub>12</sub>=2, which, in turn, is determined by the speed of transverse sound propagating in the [110] direction and polarized along the [110] axis. In contrast to the longitudinal LA mode and the transverse [00] TA mode, the dispersion curve of the [0] TA<sub>2</sub> mode exhibits substantial softening at  $_0 = 0.33$ . The development of this feature with decreasing temperature is shown in Fig.2a.

The tem perature dependence of the squared frequency of the soft phonon m ode is shown in F ig.2b. This dependence is non-m onotonic, with the frequency of the TA<sub>2</sub> m ode reaching its m inimum (but not vanishing) at the premartensitic transition tem perature  $T_P = 260~K$  and increasing, as tem perature is decreased further. Since  $T_P$  is m uch higher than the martensitic transform ation tem perature  $T_m$ , this means that in the interval from  $T_P$  to  $T_m$  the N  $i_2$ M nG a crystal is in an interm ediate phase between austenite and martensite.

The unconventional temperature dependence of the soft phonon m ode indicates that tendencies toward the formation of a m icrom odulated superstructure in the N i<sub>2</sub>M nG a lattice develop long before the transition to the m artensitic state. E lectron m icroscopy studies suggest that the overall cubic sym m etry of the crystal lattice is conserved in the interval from  $T_m$  to  $T_P$  but that in this lattice a m odulation with a period of six atom ic separations develops in the [220] direction, d<sub>220</sub> 2 A [30, 37].

Further developm ent of these neutron di raction studies [20, 23] was the work done by Zheludev and Shapiro [24], who studied the e ect of uniaxial stress on the transverse phonon [0] TA<sub>2</sub> m ode in N i<sub>2</sub>M nG a. The uniaxial stress was applied along the crystallographic [001] axis. In the unstressed sample the m inim um in the dispersion

curve was also achieved at  $[0 \ 0 \ 0]$ , 0 = 0.33. As the stress increased, the minimum in the dispersion curve shifted toward higher values, and at = 95 M Pa the minimum was at 0 = 0.36. The tem perature dependence of the energy of the anom alous phonons was found to be nonmonotonic. The greatest softening of the mode was achieved at T 300 K, and with a further decrease in tem perature the energy of the anom alous phonons grew. This indirect indication of the rise in the premartensitic transition tem perature was corroborated by data on elastic neutron scattering.

0 n the m icroscopic level the softening of the  $[0]TA_{2}$  m ode at a certain value  $_{0}$  m eans that  $[_{0} _{0}0]$  is a special wave vector of the Ferm i surface, and the fact that these vectors coincide in the phonon and electron subsys-

tem s (this is known as nesting) of the metal leads to an enhancement of the electron (phonon interaction. When pressure is applied to the sample, the parameters of the unit cell change, which leads to deform ation of the Ferm i surface. Nesting in this case is achieved at another value of the wave vector, and the anom aly in the phonon dispersion curve shifts to another value of [24].

Neutron di raction studies of N 1 M nG a single crystals with substantial deviations from stoichiom etry have identi ed several interesting features of these alloys. The tem perature dependence of the squared frequency of the phonon mode in a sample of N i<sub>51:5</sub>M n<sub>23:6</sub>G a<sub>24:9</sub> com position ( $T_m = 284$  K and  $T_c = 364$  K) at = 0.33 [38] is depicted in Fig. 2c. C learly, at  $T_m$  the soft acoustic phonons have a nite energy, and the squared phonon energy increases linearly with temperature up to the Curie point  $T_{\rm C}$  . For  $T~>~T_{\rm C}$  the dependence is also linear, but its slope is much smaller: at T <  $T_C$  the slope is 0.039 m eV  $^2$ K  $^1$  , while at T  $\,>\,$  T  $_{\rm C}\,$  it is 0.019  $m eV^2 K^{-1}$ . The temperatures to which these lines are extrapolated from the ferrom agnetic and param agnetic phases are 264 K and 175 K, respectively. All this points to a substantial e ect of magnetic ordering on the elastic subsystem of N i/M nGa. Softening of the phonon mode with the same wave vector was also observed in a sample of N  $i_{52:9}$ M  $n_{26:6}$ G  $a_{20:5}$  composition with close tem peratures of the structural ( $T_m = 351 \text{ K}$ ) and m agnetic ( $T_c = 360 \text{ K}$ ) phase transitions [39]. In contrast to the sam ples whose compositions were close to stoichiometric, which were studied by Zheludev et al. [20, 23], where the energy of the soft mode was found to increase as  $T_m$  was approached, in the samples with compositions  $N i_{51:5}M n_{23:6}G a_{24:9}$  and  $N i_{52:9}M n_{26:6}G a_{20:5}$  no such e ect was observed. This indicates that in the samples in question there was no premartensitic transition.

Ultrasonic measurements have demonstrated that the tem perature dependencies of the elastic moduli are qualitatively similar to the temperature dependence of the phonon modes discovered in neutron di raction studies. For instance, in Ref. [40] it was reported that in nonstoichiom etric N 1/2 M nG a the elastic constants exhibit an anom alous tem perature dependence at  $T_m = 275 \text{ K}$  approached from higher tem peratures; precisely, C<sub>12</sub> increases and C<sub>11</sub> and C<sub>44</sub> decrease, pointing to a softening of the shearm odulus C<sup>0</sup> = (C<sub>11</sub> C<sub>12</sub>=2, which characterizes the stability of the lattice under shear deform ation. The anom alously sm all value of  $C^{0}$  is a distinctive feature of m any alloys undergoing m artensitic transitions [41], and, in addition to the tweed structure, broadening of the re ections in the X-ray spectrum and the soft phonon mode, is one of the pretransitional phenom ena. No premartensitic transition was observed in the sample studied in Ref. [40], apparently because of the relatively high m artensitic transition tem perature. U ltrasonic m easurem ents involving single-crystal samples with smaller deviations from stoichiom etry have shown the presence of additional anom alies in the tem perature dependencies of the elastic constants, anom alies that owe their em ergence to a prem artensitic transition.




FIG.3: (a) Temperature dependencies of the elastic constants in single crystal N izM nG a with  $T_m = 175$  K and  $T_P = 230$  K [33], and (b) temperature dependence of the elastic constant C<sub>44</sub> under the following uniaxial bads (in units of M Pa): 0 ( ), 1 ( ), and 4.5 (N) [35].

A nom alies in the tem perature dependencies of the elastic constants have been observed at the premartensitic transition temperature  $T_P = 230 \text{ K}$  for a sample whose composition is close to stoichiom etric ( $T_m = 175$  K and  $T_C = 381 \text{ K}$ ) [33]. Figure 3a shows that the substantial softening of the shear moduli  $C_{44}$  and  $C^{0}$  occurs as we move closer to  $T_P = 230 \text{ K}$  . Further cooling only increases these moduli. Such behavior of the elastic constants, especially C<sup>0</sup>, is sim ilar to the tem perature dependence of the phonon [0] TA<sub>2</sub> m ode at = 0.33 [20]. M easurem ents of the speed and dam ping of ultrasound involving a N  $\frac{1}{2}$ M nG a single crystal with T<sub>m</sub> = 220 K and  $T_P = 265 \text{ K} [32, 34]$  have shown that the elastic properties of this sample are qualitatively sim ilar, within a broad tem perature interval, to those of a single crystal with lower tem peratures of the premartensitic and martensitic transitions studied by Marrosa et al. [33].

The investigations of G onz alez-C om as et al. [35] of the e ect of uniaxial compression on the temperature of the premartensitic transition in N  $i_{49:5}$ M  $n_{25:4}$ G  $a_{25:1}$  with  $T_m = 175$  K and  $T_P = 230$  K have revealed that the minimum in the temperature dependence of the elastic modulus C<sub>44</sub> shifts toward higher temperatures when a load is applied along the crystallographic direction [110] (Fig. 3b). Note that this experiment revealed the presence of pronounced hysteresis phenomena (8 K at 9 M Pa) at the premartensitic transition temperature. In the absence of uniaxial compression no temperature hysteresis was observed near  $T_P$ . The fact that hysteresis phenomena appear in the premartensitic transition [35] agrees with the data on the e ect of uniaxial compression on the soft phonon [0]  $TA_2$  mode (=0:33) [24]. An interpretation of this e ect was done by M anosa et al. [42], who found that external pressure applied to the sample results in the singularities characteristic of rstored phase transitions becoming more pronounced.

M easurements of the magnetic-eld dependencies of the elastic constants  $C_L$ ,  $C_{44}$ , and  $C^0$  for single-crystal N  $i_{49:5}$ M  $n_{25:4}$ G  $a_{25:1}$  in magnetic elds up to 10 kO e applied along the crystallographic directions [001] and [110] revealed [35] that the elastic constants increase in the magnetic eld and reach saturation in elds 1 kO e for H k [001]. For H k [110], saturation was reached at 3 kO e. The results of magnetization measurements done with the same sample [43] suggest that the variation of the elastic constants in a magnetic eld is proportional to the square of magnetization, M<sup>2</sup>.

#### C. Superstructural m otives

Almost all X-ray and neutron di raction studies involving N i/M nG a reveal the presence of superstructural re ections, in addition to the main re ections of the low tem perature martensitic phase. For instance, in the st neutron di raction studies of a sample of stoichiom etric composition [14] it was found that there are additional re ections of the tetragonal phase and it was assumed that this phase is modulated along, apparently, the [100] direction. Further studies of the crystal structure of the low-tem perature phase in non-stoichiom etric com pounds revealed a complex pattern of formation of di erent m artensitic phases and the presence of interm artensitic phase transitions in the system Ni<sub>2+x+y</sub>Mn<sub>1 x</sub>Ga<sub>1 y</sub> [44-57]. In the early stages of such studies the superstructural motifs were described as static displacement waves (modulations) [44], although lately an alternative approach is being developed, in which the superstructural re ections of martensite are interpreted as long-period rearrangem ents of closely packed planes of the f100g type [25, 57]. A comparative analysis of these two approaches in describing the crystal structure of martensite in Ni-Mn-Ga is given in Ref. [56], where it is shown that they often lead to the sam e results.

As of now, the existence of an unm odulated m artensitic phase and m artensite with ve- and seven-layered m odulations along the crystallographic direction [110] has been established. There have also been reports about observations of longer-period m odulations and about interm artensitic transform ations in N  $i_{2+x+y}Mn_1 \ge Ga_1 \ge induced$  by tem perature or uniaxial strain.

Five-layered modulation of the low-temperature

tetragonal phase was observed by the method of di raction of electrons and X-rays on single crystals of N i<sub>51:5</sub>M n<sub>23:6</sub>G a<sub>24:9</sub> (M s = 293 K) [44, 48, 53], N i<sub>49:2</sub>M n<sub>26:6</sub>G a<sub>24:2</sub> (M s 180 K) [51, 52], N i<sub>52:6</sub>M n<sub>23:5</sub>G a<sub>23:9</sub> (M s = 283 K) [51], N i<sub>52</sub>M n<sub>23</sub>G a<sub>25</sub> (M s = 227 K) [25], and N i<sub>48:5</sub>M n<sub>30:3</sub>G a<sub>21:2</sub> (M s = 307 K) [58]. In the process of form ation of superstructures in the martensitic phase of these H eusler alloys, the X-ray patterns showed, besides the main di raction re ections, a number of additional re ections. M odulation occurs in such a way that each fth (110) plane does not undergo displacements, while the other four are displaced from their regular positions in the body-centered tetragonal lattice along the [110] direction.

Seven-layered m odulation of the m artensitic phase was observed in single crystals of N  $i_{52}$ M  $n_{25}$ G  $a_{23}$  (M  $_{\rm S}$  = 333 K) [44] and N  $i_{48:8}$ M  $n_{29:7}$ G  $a_{21:5}$  (M  $_{\rm S}$  = 337 K) [59]. X-ray studies of N  $i_{48:8}$ M  $n_{29:7}$ G  $a_{21:5}$  have shown that, as in the case of ve-layered m artensite, besides the m ain re-

ections there are additional di raction re ections that lie along the [110] direction. The crystal structure of the seven-layered martensite in N  $i_{48:8}$ M  $n_{29:7}$ G  $a_{21:5}$  was found to be orthorhom bic with the lattice parameters a = 6:19 A, b = 5:80 A, and c = 5:53 A [59]. In contrast to this, the crystal structure of seven-layered martensite in N  $i_{52}$ M  $n_{25}$ G  $a_{23}$  was interpreted as monoclinic with the lattice parameters a = 6:14 A, b = 5:78 A, and c = 5:51 A and with = 90:5 [44].

U nm odulated m artensite was observed in single-crystal sam ples and thin lm s of alloys of the following compositions: N  $i_{53:1}$ M  $n_{26:6}$ G  $a_{20:3}$  (M  $_{\rm S}$  = 380 K) [54, 60] and N  $i_{48:5}$ M  $n_{30:3}$ G  $a_{21:2}$  (M  $_{\rm S}$  = 307 K) [58]. The crystal structure of the unm odulated m artensitic phase proved to be tetragonal, but the ratio c=a 1:18 for it is much higher than for the tetragonalm artensitic phases considered above.

The experimental data on modulations of the crystal lattice in the martensitic phase suggest that the type of martensite (modulation period) depends on the com – position of the alloys. It is convenient to classify these types according to the martensitic transition temperature M  $_{\rm s}$  [56]. Five-layered martensite has a crystal lattice of tetragonal symmetry and is formed in the process of cooling in alloys that have M  $_{\rm s}<270$  K . Seven-layered martensite is formed in alloys with a higher M  $_{\rm s}$  and has a crystal structure di erent from the tetragonal one.

## IV. HEUSLER ALLOY N $\mathrm{L}_2M$ NGA: MAGNETIC SUBSYSTEM

#### A. M agnetization

The results of band structure calculations for the H eusler alloys X  $_2M$  nZ [61, 62] suggest that the M n spinup 3d-states are almost completely occupied and that the M n 3d-wave functions overlap with the 3d-wave functions of the X atom s. The same calculations show that M n spin-down 3d-states are almost entirely unoccupied. Recently these calculations have been corroborated by the data from photoem ission spectroscopy [63-65]. Webster et al. [14] showed that the magnetic moment in the Heusler alloy N  $\frac{1}{2}$ M nG a is localized primarily on the manganese atom s, Mn 4:17 B, while the magnetic moment on nickel atoms Ni 0:3 B.




FIG. 4: Temperature dependencies of magnetization of N  $\frac{1}{2}$ M nGa.1 { 1 kO e, 2 { 4 kO e, 3 { 8 kO e, and 4 { 16 kO e [14].

The temperature dependencies of the magnetization of N  $_{2}M$  nG a measured in  $\,$  elds ranging from 1 kO e to 16 kO e [14] are shown in F ig. 4. C learly, this alloy transforms to the ferrom agnetic state at the C urie temperature  $T_{\rm C}~=~376~{\rm K}$ . In the martensitic transform ation region at  $T_{\rm m}~=~202~{\rm K}$  in weak  $\,$  elds there is a sharp decline in the magnetization, which corresponds to an increase in magnetocrystalline anisotropy, while measurements in strong  $\,$  elds have shown that the saturation magnetization in the martensitic phase is somewhat greater than the saturation magnetization in the austenitic phase.

The reports of system atic studies of the e ect of deviation from the stoichiom etric composition on the magnetic properties of N  $i_{2+x}M n_{1-x} G a$  can be found in R efs [66-68]. Substitution of Ni atoms for Mn atoms is accompanied by a decrease in magnetization, an increase in  $T_{\rm m}$  , and a decrease in  $T_{\rm C}$  . The decrease in the Curie tem perature and m agnetization can be explained by the decrease in the num ber of atom s that carry the m agnetic m om ent, while the increase in the martensitic transformation temperature is, probably, caused by the increase in the number of conduction electrons. Nickel atoms have three m ore electrons in the d-shell than m anganese atom s. Substitution of Niatom s for M n atom s leads to an increase in the volum e of the Ferm isurface and thus to an increase in the tem perature at which the structural phase transition takes place. Note that the martensitic transform ation disappears even when a sm allnum ber ( 10%) of M n atom s are replaced by V atom s [69].




FIG. 5: Tem perature dependence of low – eld m agnetic susceptibility of a N  $i_{52:6}$ M  $n_{23:5}$ G  $a_{23:9}$  single crystal that was preloaded and then unloaded at liquid nitrogen tem perature [49].

In addition to the anomalies caused by the martensitic transformation, speci c features in the temperature and eld dependencies of the magnetic properties of N  $i_2$ M nG a caused by interm artensitic and premartensitic transitions have also been observed. The anom alies associated with interm artensitic transitions manifest them selves most vividly in the temperature dependencies of the low - eld magnetic susceptibility [49, 59, 70], which is an indication that the magnetocrystalline anisotropy changes upon the transition of one martensitic phase into another. For instance, a sequence of interm artensitic transitions has been observed in the reheating of a N  $i_{52:6}$ M  $n_{23:5}$ G  $a_{23:9}$  single crystal that was

rst prebaded along the [110] crystallographic direction and then unloaded at liquid nitrogen temperature [49]. Figure 5 shows that, in addition to the anomalies in the low - eld magnetic susceptibility at the Curie tem perature  $T_C = 370$  K and the martensitic transition tem perature  $T_m = 290 \text{ K}$ , there are two more anom alies, at 190 K and at 230 K. These new anom alies were interpreted as being caused by interm artensitic transitions from the unm odulated martensitic phase to seven-layered m artensite at 190 K and then from seven-layered m artensite to ve-layered martensite at 230 K. The results of the m easurements of magnetization in a 15 kO e eld that Kokorin et al. [71] conducted on a single crystalline sam ple of the same composition and in the same experim ental conditions (preloading and unloading at 77 K) suggested that the martensitic phases have di erent magnetizations. However, since the change in magnetization was detected only for one interm artensitic transition, the researchers assumed that the magnetizations of the other twom artensitic phases have close values.

C ertain anom alies in the vicinity of the prem artensitic phase transition have also been observed at tem perature dependencies of the low – eld m agnetic susceptibility and m agnetization of N  $\frac{1}{2}$ M nG a [27, 28, 33, 72]. Since the form ation of the prem artensitic phase is accompanied by the form ation of a static displacem ent wave [37], we can




FIG. 6: Temperature dependence of the magnetization M of polycrystalline N  $i_{2:02}$ M  $n_{0:98}$ Ga in a eld of 100 O e in the vicinity of premartensitic transition. The inset depicts the behavior of M (T) within a broad temperature range.

assume that the magnetic anisotropy in the premartensitic phase is higher than in the cubic phase, which is rejected by a drop in magnetization at  $T_{\rm P}$ , as shown in Fig.6.




FIG. 7: Field dependencies of magnetization of the martensitic phase of the N  $i_{48}$  M  $n_{31}$  G  $a_{21}$  single crystal at T = 290 K [74].

The transform ation of the m artensitic dom ains with a m agnetization vector oriented unfavorably with respect to the external magnetic eld may lead to anom alies in the eld dependencies of magnetization [73-75]. Figure 7 depicts the eld dependencies of magnetization for a single crystal N  $i_{48}$ M  $n_{31}$ G  $a_{21}$  sample with the follow – ing temperatures of the ferrom agnetic and m artensitic transitions:  $T_C = 371$  K and M  $_s = 300$  K [74]. M easurem ents done at 290 K have shown that the slow increase in m agnetization is replaced by a rapid increase at a critical value of the eld, H 3:5 kO e. The magnetization is replaced by a rapid increase at a critical value of the eld, H

tization reaches saturation in a eld of the order 5 kO e. In the subsequent reduction of eld strength, m agnetization remains practically the same down to 1.3 kO e, which results in large hysteresis. Hysteresis is observed only during the rst magnetization cycle, while during the second cycle the magnetization reaches its saturation value in a weak magnetic eld. The anom alous behavior of the magnetization curves can be explained by the fact that at a certain critical eld strength the martensitic dom ains are redistributed even before the magnetization vector has time to fully rotate into a position parallel to the magnetic eld. The redistribution of the martensitic dom ains proceeds in such a way that the caxis, which is the easy magnetization axis of the tetragonalm artensitic phase, aligns itself with the externalm agnetic eld.

A lthough N  $i_{2+x+v}M n_{1-x} G a_{1-v}$  alloys basically exhibit m agnetic properties typical of ferrom agnets, som e alloys of this system dem onstrate unusual magnetic characteristics, such as, say, hysteresis of the ferrom agnetic transition and "m etam agnetic" anom alies in alloys with the sam e tem peratures of structural and m agnetic phase transitions [76, 77]. Such a situation can be achieved if some of the manganese atoms are replaced by nickel atoms or some of the gallium atoms are replaced by nickel atoms. In the st case the coupled magnetic and structural transition is realized in N  $i_{2+x}M n_{1-x} G a$ 0:20) [67, 78], while in the second case (x = 0:18)it is realized in Ni<sub>53</sub>M n<sub>25</sub>G a<sub>22</sub> [79]. Hysteresis of the ferrom agnetic transition and the metam agnetic behavior of magnetization near the magnetostructural transition are an indication that for Ni2:18M no:82Ga and N 12:19M no:81G a the magnetic transition has the characteristics of a rst-order phase transition [76, 77]. The reason for this is that these alloys undergo a st-order phase transition from the tetragonal ferrom agnetic phase into the cubic param agnetic phase.

#### B. M agnetocrystalline an isotropy

M agnetocrystalline anisotropy can be considered as the determ ining param eter for the achievem ent of giant strains induced by a magnetic eld in shape mem ory ferrom agnets. A lthough it seems, at rst glance, that the form ation and grow th of the structural dom ains favorably oriented with respect to the magnetic eld are in no way related to this param eter, it is precisely this param eter that determ ines the path along which the system proceeds and reaches the state with the low est possible energy.

M easurements of magnetization in a N  $i_{51:3}$ M  $n_{24:0}$ G  $a_{24:7}$  single crystal have shown that the easy magnetization axis in the cubic phase is oriented along the crystallographic [100] axis and that the magnetocrystalline anisotropy constant K<sub>1</sub> in this phase is relatively moderate. As a result of the transition to the martensitic phase the magnetocrystalline anisotropy changes signi cantly. The eld dependencies of the




FIG. 8: (a) Field dependencies of magnetization of the N  $i_{51:3}M n_{24:0}G a_{24:7}$  single crystal for a multivariant martensitic state; 1 { H k [100], 2 { H k [110], and 3 { H k [111]. The orientation of the single crystal was done in the austenitic phase. (b) Field dependencies of magnetization of the N  $i_{51:3}M n_{24:0}G a_{24:7}$  single crystal for a single-variant martensitic state: 1 { easy magnetization axis, and 2 { hard magnetization axis [80].

m agnetization of N  $i_{51:3}$ M  $n_{24:0}$ G  $a_{24:7}$  in the martensitic phase are shown in Fig. 8a. In these curves one can isolate intervals within which the displacement of the domain walls and rotation of the magnetization vectors in the domain occur.

The redistribution of the martensitic variants that is induced by a magnetic eld is superim posed on the intrinsic magnetization processes. To exclude this factor, Tickle and James [80] em ployed the following procedure in their measurements of magnetocrystalline anisotropy.

A thin single crystalplate measuring  $5.2 \ 5 \ 0.64 \text{ mm}^3$ whose faces coincided with the crystallographic planes of the f100g type was fabricated for the measurements. The strategy of the experiment consisted in compressing the sample to a single-variant state in a spring minipress [80]. Measurements of the M vs H dependence were done in a magnetic eld that was parallel or perpendicular to the direction along which the sample was compressed. The sample was rst cooled below the martensitic transformation temperature in a 6 kO e magnetic eld directed along the compression axis in such a way that both the magnetic eld and the applied stress facilitated the form ation of a single variant of m artensite. The sam ple size in the direction of compression was selected in such a way that in the m artensitic phase the sam ple would be of a square shape. In this case the dem agnetization factors for two orientations of the m agnetic eld proved to be the sam e, and the uniaxial anisotropy constant K<sub>u</sub> could be evaluated by the area between the curves. The eld dependencies of the m agnetization of the single-variant m artensite (Fig. 8b) show that the c axis is indeed the easy m agnetization axis and that the curves dem onstrate uniaxial anisotropy.

The results of m easurements under a 1.9 MPa load were used to calculate the areas between the M axis and the curves ofm agnetization along the easy and hard axes. The uniaxial anisotropy constant in them artensitic phase calculated in this manner (K  $_{\rm u}$  = 2:45 10<sup>6</sup> erg/cm<sup>3</sup> at T = 256 K) proved to be greater than the constant K  $_{\rm 1}$  in the austenitic phase by a factor of 100.

Studies of the m agnetocrystalline an isotropy of single crystals N  $i_{2+x+y}M n_{1 x} G a_{1 y}$  of di erent compositions (the samples were converted to a single-variant state) have shown that the values of K<sub>u</sub> at room temperature vary from 1:7  $10^6 \text{ erg/cm}^3$  for N  $i_{48}M n_{31}G a_{21}$  [74] to 2:48  $10^6 \text{ erg/cm}^3$  for N  $i_{49:7}M n_{28:7}M n_{21:6}$  [81].

The temperature dependencies of the uniaxial magnetocrystalline anisotropy constant for martensite have been measured for polycrystalline N i/M nG a [82] and for a N i48:8 M n28:8 G a22:6 single crystal [83]. For the polycrystalline sample it was found that  $K_u = 2.5 \quad 10^6 \text{ erg/cm}^{-3}$ at T = 220 K. As the tem perature is low ered, the value of K<sub>11</sub> increases linearly and at 77 K reaches the value of 3:8  $10^6 \text{ erg/cm}^3$ . The increase in K<sub>u</sub> with decreasing tem perature has also been observed for a single-variant single crystalline sam ple of N i48:8 M n28:6 G a22:6 com position. At 283 K the magnetocrystalline anisotropy constant K<sub>u</sub> = 2  $10^6$  erg/cm<sup>3</sup>, while at 130 K its value proved to be equal to 2:65  $10^6$  erg/cm  $^3$ . The theoretical analysis of magnetocrystalline an isotropy done by Enkovaara et al. [84] showed that magnetic anisotropy changes sign at c=a = 1, which corresponds to a change in the easy magnetization axis from [100] for c=a < 1 to [110] for c=a > 1.

Just as the other physical parameters, the magnetocrystalline anisotropy of the N  $i_{2+x+y}M n_{1-x} G a_{1-y}$  alloys varies with the chemical composition of these com – pounds. The lack of experimental data, however, does not allow us to express this dependence more speci-cally.

#### C. Structure of m agnetic dom ains

The structure of the magnetic domains in N $i_{2+x+y}Mn_{1x}Ga_{1y}$  has been studied in single crystalline thin lms [85-87] and bulk single crystals [88] faceted along planes of the floog type. The results of these studies show that the domain structure of the austenitic phase is formed primarily by 180 domains with magnetization vectors M k [100]. The magnetic

dom ain structure changes dram atically upon m artensitic transformation, when martensitic variants are formed. In the low-tem perature phase several magnetic dom ains are located within a single martensitic variant. Since adjacent martensitic variants are separated by a twin boundary, this leads to the appearance of a relief on the sample's surface, and the magnetization vectors in adjacent martensitic variants prove to be directed at a certain angle with respect to each other [85]. The domain structure within a single martensitic variant consists of 180 domains, just as in the austenitic phase. The width of magnetic domains varies from 5 to 40 m [88]. When a magnetic eld is applied to the sample, the ferrom agnetic and martensitic domain structures change. A weak eld changes the topology of the ferrom agnetic domains which come to resemble a "herring-bone" structure with a common domain wall coinciding with the twin boundary [85]. As the magnetic eld strength is increased further, the processes of reorientation of the magnetic moment in the ferrom agnetic domains and of displacem ent of the boundaries between the martensitic variants begin to com pete.

### V. DEPENDENCE OF PROPERTIES ON COM POSITION

System atic studies of the ferrom agnetic shape m em ory alloysN i2M nG a have show n that m agnetic and structural transitions occur not only in the stoichiom etric alloy but also in cases with signi cant deviations from stoichiom etry [17]. Hence it is only natural to exam ine the entire system of Heusler alloys N  $i_{2+x+y}M n_{1-x} G a_{1-y}$  in which shape memory can be magnetically controlled. Obviously, nding the composition dependencies of the main physical properties is important in order to e ectively use these materials in applications. Since the compositions of studied N  $i_{2+x+y}M n_{1-x} G a_{1-y}$  alloys are located on the triple phase diagram of this system in an arbitrary manner, their main properties are considered in the literature as functions of the average electron concentration per atom, e=a. Such an approach was used by Chemenko [89], who built an em pirical dependence of the martensitic transition temperature Tm on the electron concentration e=a. The electron concentration in  $N_{2+x+y}M_{n_{1}x}Ga_{1y}$  alloys was calculated using the following electrons con gurations of the outer shells and the following numbers of electrons per atom (in parentheses): Ni  $3d^84s^2$  (10), Mn  $3d^54s^2$  (7), and Ga  $4s^2 4p^1$  (3).

#### A. Ferrom agnetic transition

In examining the magnetic properties of  $N_{2+x+y}M_{n_1 x}G_{a_1 y}$  alloys, the approach based on using the total electron concentration e=a has certain limitations, since the magnetic moment in these alloys




FIG. 9: (a) Concentration dependencies of the temperatures of martensitic ( $T_m$ ) and magnetic ( $T_c$ ) transitions in N  $i_{2+x+y}M$  n<sub>1</sub>  $_x$ Ga<sub>1</sub>  $_y$  alloys [89], and (b) concentration dependence of tetragonal distortion of the crystal structure in N  $i_{2+x+y}M$  n<sub>1</sub>  $_x$ Ga<sub>1</sub>  $_y$  alloys [97].

is on the manganese atoms. For instance, e=a can be increased in two ways: without changing the Mn content (substituting Ni for Ga), or by changing the Mn content (substituting Ni for Mn). Obviously, the two ways of changing the electron concentration are not equivalent in the e ect on the magnetic properties of N  $i_{2+x+y}M n_{1-x} G a_{1-y}$ . With the exception of N  $i_{2+x}M n_{1-x} Ga$  (y = 0) alloys, no system atic studies of the composition dependence of the Ni<sub>2+x+y</sub>M  $n_{1 x}$  G  $a_{1 y}$ alloys have been done. The dependence of the Curie tem perature  $T_C$  on the electron concentration e=a is shown in Fig. 9a for a large number of Ni<sub>2+x+v</sub>Mn<sub>1 x</sub> Ga<sub>1 v</sub> alloys [89]. The Curie temperature was found to depend weakly on electron concentration in the interval 7:6; at higher values of e=a the Curie 7:3 e=a tem perature decreases.




FIG.10: Curie temperature  $T_{\rm C}~(1)$  and the temperatures of prem artensitic  $T_{\rm P}~(2)$  and martensitic  $T_{\rm m}~(3)$  transitions in N  $i_{2^+}\,_xM$  n<sub>1</sub> $_x$ G a alloys as functions of composition.

The composition dependencies of magnetic properties for N  $i_{2+x}$ M  $n_{1-x}$  G a alloys have been studied in Refs [26, 67, 68, 90, 91]. The phase diagram of these alloys (Fig. 10) clearly shows that the Curie temperature decreases as Ni is substituted for M n in the interval 0 < x < 0.18; with a further increase in the Ni content the Curie temperature and them artensitic transition temperature merge, and an increase in  $T_C$  is observed in the interval 0.18 < x < 0.20. W ang et al. [68] studied N  $i_2 \ge M n_{1+x=2}G a_{1+x=2}$  alloys (x = 0 0.1) and found that within this concentration range the Curie temperature lowers from roughly 384 K (x = 0) to roughly 370 K

(x = 0.1). The decrease in the Curie tem perature is accompanied by a decrease in the saturation m agnetization M  $_0$  and the m agnetic m om ent on M n atom s.

Com parison of the experim ental data on the magnetic properties of N  $i_{2+x}$  M  $n_{1-x}$  G a and N  $i_{2-x}$  M  $n_{1+x=2}$  G  $a_{1+x=2}$ shows that any deviation from stoichiom etry results in a decrease in the Curie tem perature and the saturation m agnetization. M any experimental observations, such as the decrease in  $T_C$  in N  $i_{2+x}M n_1 x G a$  alloys [67], the increase in  $T_C$  in N i<sub>2</sub>M nZ (Z = A l, G a, In, Sn, Sb) alloys under pressure [92], the decrease in T<sub>c</sub> upon isoelectronic substitution of In atoms for Ga atoms, which leads to an increase in the crystal lattice parameter [93], can be explained by the change in the average distance between the M n atom s, the carriers of m agnetic m om ent. At the same time, the results of W ang et al. [68] show that a simple increase in the number of M n atom sper form ula unit does not lead to rise in the Curie tem perature or to an increase in the magnetic moment of the alloy.

#### B. M artensitic transition

For Heusler alloys the m artensitic transition tem perature changes substantially under deviations from stoichiom etry [17, 67, 68, 91] and under doping [69, 89, 93– 95]. As a result of their analysis of the experimental data on N  $i_{2+x+y}$ M n<sub>1 x</sub> G a<sub>1 y</sub> alloys, Chemenko et al. [17] concluded that for xed M n content the increase in G a content lowers the m artensitic transition tem perature T<sub>m</sub>. The same e ect can be achieved by substituting M n atom s for N i atom s with the G a content constant. Substitution of M n for G a with the N i content constant increases the m artensitic transition tem perature. The next step in establishing the com position dependencies of T<sub>m</sub> was done in Ref. [89], where the m artensitic transition tem perature of N  $i_{2+x+y}$ M n<sub>1 x</sub> G a<sub>1 y</sub> alloys was studied as a function of the electron concentration e=a (F ig. 9a).




FIG.11: Tem perature dependence of electrical resistivity in N  $i_{2+x}M n_1 _xGa$  alloys for x = 0 (curve 1), x = 0.02 (2), x = 0.04 (3), x = 0.06 (4), and x = 0.09 (5).

7:7, the martensitic transition tem -In alloys with e=a perature increases with electron concentration with a coe cient of roughly 900 K (e=a)<sup>1</sup>, while for alloys with 7:7 this coe cient is of the order 500 K (e=a)<sup>1</sup>. e=a In Ref. [96] the e=a-dependence of  $T_m$  is described as  $T_m = [702:5(e=a) 5067] K$ , which makes it possible to de ne the empirical dependence of  $T_m$  on the molar M n content (X  $_{\rm M \, n}$  ) and the m olar G a content (X  $_{\rm G \, a}$  ) as  $T_m = (1960 \quad 21:1X_{Mn})$  $492X_{Ga}$ ) K. This approach can also be used in examining the composition dependence of the martensitic transition temperature  $T_m$  in  $N_{2+x}M_{n_1}$  G a alloys (x = 0 0.2) (see Fig. 10), since substitution of N i for M n increases the electron concentration. The results of W ang et al. [68] are an exception to this empirical form ula: they found that under isoelectronic change in composition in N i<sub>2 x</sub> M  $n_{1+x=2}$ G  $a_{1+x=2}$  $(x = 0 \quad 0:1)$  alloys the martensitic transition temperature rises from 190 K to 280 K in the interval 0 x 0:06. With further increase in x the temperature T<sub>m</sub> rapidly decreases (T<sub>m</sub> 200 K at x = 0.08 and T + m < 100 K at x = 0:1).

#### C. Prem artensitic transition

As noted in Section 3.2, premartensitic transitions have been observed in N  $i_{2+x+y}M n_1 \ge G a_1 \ge y$  the alloys with relatively small deviations from the stoichiom etry and martensitic transition temperatures lower than 270 K. For the family of N  $i_{2+x+y}M n_1 \ge G a_1 \ge alloys$ , the phase diagram swhich represent the temperatures of them agnetic, premartensitic, and martensitic transitions as functions of e=a, show that the premartensitic transition temperature  $T_P$  increases with electron concentration [31, 35, 72].

P ronounced anomalies at the martensitic transition temperature  $T_P$  have been observed, as Fig.11 shows, in

the tem perature dependencies of the electrical resistivity of N  $i_{2+\,x}$  M  $n_{1\,x}$  G a (x=0~0.09) alloys [27]. The observation of these anom alies has made it possible to modify the phase diagram of N  $i_{2+\,x}$  M  $n_{1\,x}$  G a alloys so that it allows for the presence of a modulated premartensitic phase. Figure 10 shows that the premartensitic transition tem perature  $T_{\rm P}$  is weakly dependent on the substitution of M n atom s for N i atom s in N  $i_{2+\,x}$  M  $n_{1\,x}$  G a alloys, which leads to a gradual narrowing of the tem perature range within which the premartensitic phase exists, and the phase com pletely disappears in the N  $i_{2:09}$  M  $n_{0:91}$  G a (x=0.09) alloy.

Zheludev et al. [23] suggested that premartensitic transitions emerge because of nesting singularities in the Ferm i surface. Since the premartensitic transition tem – perature  $T_P$  is weakly dependent on deviations from stoichiom etry and such a transition is observed only in N  $i_{2+\,x+\,y}M\,n_{1\,\,x}\,G\,a_{1\,\,y}$  alloys with  $T_m\,<\,270$  K [31], variations in conduction electron concentration have, probably, only a slight e ect on the nesting section of the Ferm i surface. In alloys with  $T_m\,>\,270$  K, m artensitic transitions, accompanied by a drastic change of the Ferm i surface, occur even before the nesting singularities in the cubic phase have tim e to manifest them selves. No prematensitic transition is observed in this case.

#### D. Structural distortions

The data in R efs [56, 97, 98] suggest that the ratio c=a, which gives the tetragonal distortion of the cubic lattice caused by the transition to the martensitic state, depends on alloy composition. As F igure 9b shows, c=a 0:94 for alloys in which the electron concentration e=a 7:4 7:6. An abrupt change in the tetragonality parameter from c=a < 1 to c=a > 1 takes place in alloys with e=a 7:7. In contrast to the alloys with e=a < 7:6, for which  $T_m < T_c$ , in alloys with e=a 7:7 the martensitic transition takes place in the param agnetic state.

The exact position of the "dividing line" for electron concentration, e=a = 7.62, between the tetragonal phases with c=a < 1 and c=a > 1 is given in Ref. [98]. This value is characteristic of alloys in which there occurs a combined magnetostructural phase transition, i.e., Tm  $T_{\rm C}$  . It may be assumed that the fact that these two temperatures coincide, which results in an enhancem ent of magnetoelastic interaction, leads to a considerable increase in the degree of tetragonal distortions of the cubic lattice. In this connection it must be noted that  $N_{2:16}M n_{0:84}Ga$  ( $T_m < T_C$  and e=a = 7:62) and Ni<sub>2:19</sub>M n<sub>0:81</sub>Ga (T<sub>m</sub>  $T_c$  and e=a = 7:64) alloys have di erent mechanical properties and, possibly, different martensitic transformation kinetics [99]. Polycrystalline samples of the Ni2:19M no:81G a alloys have been known (through experiments) to rapidly disintegrate under therm ocycling through the martensitic transition tem perature, while the polycrystalline sam ples of the N 1/2:16 M no:84 G a alloy prepared by the same method

endure multiple therm ocycling through  $T_{\rm m}\,$  without substantial degradation of mechanical properties. Possibly, the rapid disintegration of the N  $\rm i_{2:19}M\,n_{0:81}G\,a\,$  sam ples can be explained by the fact that these sam ples undergo larger distortions (com pared to those in N  $\rm i_{2:16}M\,n_{0:84}G\,a$ ) of the cubic lattice in the martensitic transform ation.

#### VI. MAGNETOSTRAINS IN NI<sub>2</sub>MNGA

## A . M agnetostrain caused by the shift of the $$\rm m$$ artensitic transition

The existence of a structural phase transition in the ferrom agnetic matrix opens up new possibilities in magnetically controlling the temperature of this transition. The extent of this control is determ ined by the di erence in the magnetizations of the high-and low-temperature phases. The maximum variation in the linear dimensions of the sample achieved through shifting the structural transition tem perature is equal to V=3, where V is the variation of the sam ple volum e caused by the structural transition. This is also true for a structural transition of the martensitic type if the distribution of the martensitic variants that form upon the austenite { martensite transform ation induced by the magnetic eld is isotropic. However, even in polycrystalline samples of a ferrom agnetic shape m em ory the special features of the texture may lead to substantial dilatom etric e ects of martensitic transformation (up to 0.2%) [100]. In the case of single crystals or highly textured polycrystalline sam ples, the dilatom etric e ects can be much stronger. The experim ental data taken from Refs [101-105] suggest that upon them ocycling through the martensitic transition tem perature the form ation of martensitic variants whose orientation is favorable with respect to the applied m agnetic eld is predom inant. Hence the variations of linear dim ensions caused by the shift in the martensitic transition temperature in such materials may be much larger than simple transition striction.

If the magnetization of the martensitic phase differs from that of the austenitic phase, application a magnetic eld shifts the structural transition temperature, stabilizing the phase with larger magnetization [106]. This e ect can be used to obtain giant magnetostrains within the tem perature interval of the martensitic transformation. Reports of studies aimed at developing functional N  $i_{2+x+y}M n_1 x G a_1 y$  -based m aterials in which giant magnetostrains are obtained through the shift of martensitic transition temperature can be found in Refs [107-111]. Dikshtein et al. [108] observed a reversible shift of the martensitic transition temperature for  $N_{2+x}M n_1 x Ga$  (x = 0:16 0:19) alloys that was controlled by a magnetic eld. The shape memory e ect induced by the magnetic eld and the related giant magnetically induced strains have been studied by Cherechukin et al. [109], who used polycrystalline  $N_{2+x} M_{n_1} Fe_y Ga$  samples. The researchers found




FIG.12: (a) Tem perature dependencies of the relative elongation of a N  $i_{2:18}$ M  $n_{0:82}$ G a sam ple prepared by the pow derm etallurgy m ethod w ithout precom pression (1) and after precom pression of 2% in the m artensitic state (2); (b) m agnetically induced strain (m easured at T = 351 K) in a N  $i_{2:18}$ M  $n_{0:82}$ G a sam ple w ith a two-way shape m em ory e ect.

that an adm ixture of iron im proves the mechanical properties of N  $i_{2+x}$  M  $n_{1-x}$  G a alloys. Sam ples in the shape of plates were trained for a two-way shape memory e ect by them ocycling under a load. The training resulted in an increase in the attainable bending strain from 2% for an untrained sam ple to 4.5% for the trained sam ple after multiple therm ocycling. The shape memory e ect caused by a shift of the martensitic transition temperature induced by a magnetic eld was observed for the trained plate of N i2:15 M no:81 Fe0:04 G a with Tm 313 K.The experim ent proceeded as follows. The plate, which in the m artensitic state had a curved shape, was subjected to a magnetic eld H = 100 kO e at room temperature. The plate was then heated in this eld to 315 K and the tem perature was stabilized. In these conditions the bending strain am ounted to roughly 3%. When the magnetic eld was switched o , the plate passed into the austenitic state and became unbent. Thus, the bending strain e = 3%had been induced by the magnetic eld H = 100 kOe.

The type of processby which N  $i_{2+x}M n_{1-x}$  G a alloys are prepared strongly a ects the magnetom echanical properties of these alloys. One method used in powder metallurgy amounts to sintering the ne powder by an electrical discharge under pressure. The reversible change in the linear dimensions of such samples upon a martensitic transformation reaches 0.2%. Giant magnetostrains in  $N_{2+x}M_{n_1}$  G a (x = 0:16 0:20) alloys fabricated by this m ethod have been attained only after prelim inary training [111, 112]. The training of a Ni<sub>2:18</sub>M n<sub>0:82</sub>G a sample am ounted to the following. The sample in the martensitic state was subjected to a uniaxial compression of up to 2%. A fter the sam ple was unloaded, the residual strain amounted to 1.1%. Upon the st heating - cooling cycle, the sample dem onstrated a shape memory e ect and alm ost com pletely restored its initial shape. Subsequent heating - cooling cycles revealed the presence of a twoway shape memory. Figure 12a shows that the multiple reversible change in the length of this sample in the m artensitic transition am ounted to 0.5% . M easurem ents of magnetostrains in the given sample were conducted at a tem perature xed in the interval of direct m artensitic transform ation. It was found that the increase in the dilatom etric e ect of the martensitic transform ation in the sample with two-way shape memory leads to a rise in the value of magnetically induced strains. In the untrained Ni2:18M no:82Ga sample the magnetically induced strain m easured in the tem perature interval of the m artensitic transition did not exceed 0.02%, while in the sam ple with two-way shape memory the values of magnetically induced strain under the same conditions were 0:12%. However, such a strain, as shown as high as in Fig. 12b, was observed only during the rst on -omagnetic eld cycle, while upon subsequent cycles the reversible value of magnetically induced strain am ounted to 0.05% .

These results suggest that the value of magnetically induced strains caused by the shift in the martensitic transition temperature brought on by the magnetic eld directly depends on the dilatom etric e ect of the transformation. A lthough obtaining large magnetically induced strains through the shift of the martensitic transition temperature requires high magnetic elds, this method has certain potential since the magnetically induced strains in this case are comparable to the striction of the phase transitions induced by a magnetic eld in the following alloys, which are being actively

investigated: Fe-Rh [113], M n-As [114], La (Fe<sub>x</sub>Si<sub>1</sub> x )<sub>13</sub> [115], and G d<sub>5</sub> (Si<sub>x</sub>G e<sub>1</sub> x )<sub>4</sub> [116]. Am ong these m aterials, La (Fe<sub>x</sub>Si<sub>1</sub> x )<sub>13</sub> exhibits the highest value of linear m agnetostriction, L=L 0:3% in a 70 kO e m agnetic

eld [115]. The advantage of the N  $\frac{1}{2}$ +  $_x$ M n<sub>1</sub>  $_x$  G a alloys is the possibility of attaining giant magnetically induced strains at temperatures much higher than room temperature, which is important in some applications.

# ${\ensuremath{\mathsf{B}}}$ . M agnetostrain caused by the reorientation of m artensitic variants

Shape m em ory ferrom agnetic alloys are unique in the sense that they m ake it possible to attain giant m agnetically induced strains caused by the reorientation of the

m artensitic variants by a magnetic eld. This mechanism was rst proposed by U llakko [117] and was realized by U llakko et al. [102], who observed a 0.2% strain induced by a 8 kO e magnetic eld in a N  $\pm$ M nG a single crystal of nonstoichiom etric composition with a martensitic transition temperature T<sub>m</sub> 276 K. This was followed by the paper of T ickle et al. [118], who used this mechanism to achieve irreversible (1.3%) and reversible cyclic (0.5%) strains induced by a magnetic eld H < 10 kO e in a N  $\pm_{51:3}$ M n<sub>24:0</sub>G a<sub>24:7</sub> single crystal. Finally, in the year 2000, H eczko et al. [74] and M urray et al. [119] reported a 6% magnetic eld induced strain in the martensitic phase of single crystalline sam ples of nonstoichiom etric com positions.

The mechanism by which a magnetic eld transforms the magnetic domains is illustrated schematically in Fig. 13 [120]. As is known, the cooling of shape memory alloys to tem peratures below M  $_{\rm f}$  leads to the form ation of self-accom m odated m artensitic variants (Fig. 13a). In this representation, the boundaries of the ferrom agnetic dom ains coincide with those of the martensitic variants. Under certain conditions a magnetic eld H can lead to grow th of m artensitic variants whose m agnetic m om ent is oriented favorably with respect to the magnetic eld (Fig. 13b). This process changes the shape of the sam ple. Ideally, at a certain critical value of the magnetic eld,  $H_{\rm C}$  , all m artensitic variants align them selves along the direction of the magnetic eld (Fig. 13c). Such behavior is corroborated by the results of direct optical observations done by Chopra et al. [121] on a N i53:8M n23:7G a22:5 single crystal. Indeed, when a magnetic eld is applied to the sample, the volum e fraction of favorably oriented martensitic variants was found to increase at the expense of the volum e fraction of the unfavorably oriented m artensitic variants.

Them axim um value of the magnetically induced strain caused by redistribution of martensitic variants is determined by the intrinsic strain in the initial cubic lattice in the martensitic transition, 1 c=a. For instance, for the system of N  $i_{2+x+y}$  M  $n_{1 x}$  G  $a_{1 y}$  alloys the typical value c=a 0:94 m akes it possible to attain strains of the order of 6%. M agnetic elds needed to achieve such strains are roughly 10 kO e. The giant values of the m agnetically induced strain observed in these alloys are caused not only by the large distortions of the initial phase in the m artensitic transition but also by the favorable ratio of the e ective elastic m odulus that blocks the m otion of the m artensitic dom ain walls to the uniaxialm agnetocrystalline anisotropy constant K  $_{\rm u}$ .


To observe the giant strains induced by magnetic eld in N  $\frac{1}{2}$ + x+ yM n<sub>1</sub> x G a<sub>1</sub> y alloys, sam ples are usually placed in a biasing magnetic eld or are subjected, prior to experiments, to uniaxial stresses. The same e ect can be achieved by changing the orientation of the magnetic

eld. M oreover, there have been reports about cyclic reproducible m agnetically induced strains observed in unstressed sam ples.

The typical values of magnetically induced strains observed in experiments with unstressed samples are 0.2{ 2% [68, 70, 94, 102, 104, 122–128]. The highest magnetically induced strains have been observed within tem perature ranges from M  $_{\rm s}$  to M  $_{\rm f}$  and from A  $_{\rm s}$  to A  $_{\rm f}$ ; outside these ranges m agnetically induced strains are negligible [104, 123]. This suggests that in this case the leading role in generating magnetically induced strains is played by the mobility of the boundaries of the martensitic variants. In addition to observations of magnetically induced strains within the tem perature range of the martensitic transition, there have been reports about large ( 5%) reversible variations of the linear dim ensions of sam ples upon therm ocycling through the tem peratures ofm artensitic [103, 104] and interm artensitic [70] transitions in the presence of a magnetic eld. Such a two-way shape memory e ect observed in the presence of a magnetic eld can be explained by the predom inant growth of martensitic variants that are favorably located with respect to the magnetic eld.

The magnetically induced strains observed in experiments involving prestressed samples or samples placed in a biasing magnetic eld or changes in the orientation of the magnetic eld may be as high as 6% when  $T < M_f$ [58, 74, 75, 81, 83, 118, 119, 120–140]. Such high values of magnetically induced strains can be explained by the fact that uniaxial compression [119] or the application of a biasing eld that is perpendicular to the operating magnetic eld [118] facilitates the formation of a single-variant martensitic state. A sample prepared in this way consists of practically one martensitic variant (or, perhaps, several equivalent variants) with the easy magnetization axis directed along the vector of the biasing magnetic eld. The application of a magnetic

eld in the perpendicular direction leads to grow th of the martensitic variants whose easy magnetization axes are directed along the operating magnetic eld. This occurs if the magnetocrystalline anisotropy energy density exceeds the elective elastic modulus of the displacement of martensitic domain boundaries. Such a process leads to magnetically induced strains of the order of 1 c=a.

W hen the operating magnetic eld is switched o in the absence of an external load or a biasing magnetic eld, the acquired magnetostrains are preserved. Reversible magnetically induced strain is achieved in the presence of an external load [119, 129] or a biasing magnetic eld [118, 122]. Since the magnetically induced strain caused by the transform ation of the martensitic variants is observed in weak magnetic elds, it can easily be suppressed by external loads, as shown in Fig. 14.

A comparison of the experimental data for dierent single crystals shows that the e ect of redistribution of martensitic variants depends on many factors. The mobility of martensitic domain walls depends on the method by which the sample was prepared and on the therm al treatm ent of the sam ple. For instance, Tickle et al. [118] reported on a reversible magnetically induced strain of 0.5% in single crystalN i<sub>51:3</sub>M n<sub>24:0</sub>G a<sub>24:7</sub>  $(M_s = 263 \text{ K})$ , and M urray et al. [119] observed a reversible m agnetically induced strain of 6% in single crystalN  $i_{49:8}$ M  $n_{28:5}$ G  $a_{21:7}$  (M  $_{s}$  = 318 K), although the prelim inary training that the samples underwent so that a single-variant state could be achieved was alm ost the same (an external load of about 1 M Pa). It is also interesting that the composition of the single crystal used by M urray et al. [119] varied along the direction of grow th and that the 6% magnetically induced strain was observed in a sample cut from the beginning of the crystal; for samples cut from the middle of the single crystals no magnetically induced strain was observed [141].

The existing data on magnetically induced strains (M F IS) in single crystalline N  $i_{2+x+y}$ M  $n_{1-x}$  G  $a_{1-y}$  caused by the redistribution of the martensitic variants are system atized in Table 1. These data suggest that giant magnetically induced strains are observed as in alloys with slight deviations from stoichiom etry, as in alloys with a considerable excess of manganese. The largest values of magnetically induced strains have been achieved in sam –

ples with M n content higher than 28 but lower than 31 at % [58, 74, 75, 81, 83, 119, 131-140].

Shanina et al. [81] assumed that the free electron concentration plays an in portant role in achieving giant m agnetically induced strains in N  $i_{2+x+y}$ M n<sub>1 x</sub> G a<sub>1 y</sub> alloys. Studies of non-stoichiom etric alloys with di erent values of m agnetically induced strain revealed that alloys with a high concentration of free electrons exhibit the largest m agnetically induced strain. Such alloys have the m ost pronounced m etallic nature of the interatom ic bonds.

#### VII. SHAPE M EM ORY IN TERMETALLIC COM POUNDS

In addition to the H eusler alloys N  $i_{2+x+y}M n_{1 x} G a_{1 y}$  discussed above, structural phase transform ations of the m artensitic type in the ferrom agnetic m atrix occur in several other H eusler alloys, in temary interm etallic com – pounds C o-N i-A land C o-N i-G a, and in iron-based alloys such as Fe-P d, Fe-P t, and Fe-N i-C o-T i. In this section we w illalso m ention som e ferrom agnets in which them artensitic transition is of a nontherm oelastic nature.

The giant magnetically induced strains achieved in

N  $i_{2+x+y}$ M n<sub>1 x</sub> G a<sub>1 y</sub> alloys have stimulated the search for, and intensive studies of, shape memory ferrom agnets based on other representatives of Heusler alloys. In this respect the alloy that is being most actively investigated is N  $i_2$ M nA L A s for C u<sub>2</sub>M nA Hoased Heusler alloys, they retain their ferrom agnetic properties only when deviations from stoichiom etric composition are small. A H though a substantial decrease in M n content in these alloys does lead to the emergence of a martensitic transition, it is accompanied by degradation of the ferrom agnetic properties, so that the compounds begin to resem – ble a superparam agnet or spin glass.

M any interm etallic compounds experience ferrom agnetic and structural transitions of the m artensitic type. In some of these compounds, however, the type of m artensitic transition (therm celastic or nontherm celastic) has yet to be established. In m any compounds the structural transform ation temperature  $T_m$  exceeds the C unie temperature  $T_c$ , which m akes it in possible to attain giant m agnetically induced strains via the shift of the m artensitic transition temperature. The processes of redistribution of m artensitic variants in the compounds described in the sections below have never been studied, which m akes it possible to think of these compounds as m aterials in which m agnetic controlof the shape m em ory

e ect is possible.

#### A. Fe{Ni{Co{Ti

The low-temperature body-centered tetragonal phase in iron and its alloys is ferrom agnetic. Hence for iron alloys one of the necessary conditions for strain caused by the redistribution of martensitic variants in a magnetic eld to appear is met. If such elements as nickel, manganese, ruthenium, carbon, or nitrogen are added to iron, the tem perature of the polym orphic transform ation lowers, and with a su ciently high content of doping elements this transform ation proceeds according to the martensitic mechanism. It would seem that iron alloys are ideal materials for attaining giant strains induced by a magnetic eld. This is not the case, how ever: neither a pronounced shape memory e ect nor a giant m agnetically induced strain has been observed in iron alloys. The reason is that the martensitic transform ation in iron alloys is not therm celastic. The high-tem perature phase has a low elastic limit. The Bain strain, which describes the transform ation of the high-tem perature foc lattice into the low-tem perature body-centered tetragonallattice, incorporates com pression of 17% along the cubic axis of the high-tem perature phase and elongations of roughly 12% in the directions perpendicular to this axis. The symmetry of the low-temperature phase allows for the form ation of several crystallographic variants of the high-tem perature phase in the reverse transform ation.

The situation can be improved by narrowing the gap between the lattices of the austenitic and martensitic phases and by raising the elastic limit of both phases. To achieve this, the alloy should be doped in such a way so as to cause particles that are coherently coupled to the matrix to precipitate in the high-tem perature phase. A fter the martensitic transformation is completed, the precipitate is inherited by the martensite, and the lowtem perature phase experiences tetragonal distortions. A s a result, the structures of the initial and martensitic phases resemble each otherm ore closely and the intrinsic strain in the transformation diminishes. The presence of a precipitate strengthens both the austenitic phase and the martensitic phase and, as a result, ham pers the process of generation of plastic strain in the transform ation. This idea was expressed by Kokorin and Chuistov [142] and was soon corroborated by experiments: a therm oelastic martensitic transform ation was realized in  $Fe_{57}Ni_{23}Co_{10}Ti_{10}$  after aging of the low-tem perature martensitic phase of this alloy [143].

Kakeshita et al. [144] reported their observations of a martensitic transformation induced by a magnetic

eld in an  $Fe_{i3}N i_{33}C o_{10}T i_4$  alloy (weight fractions) with  $M_s = 127 \text{ K}$ . Since the magnetic eld was switched on when  $T > M_s$ , the rise in the martensitic transform ation temperature is caused by the di erence in the magnetizations of the austenitic and martensitic phases. The martensitic transform ation induced by the magnetic eld

m ay be accompanied by changes in the linear dimensions of the sample, but such a measurement was not performed in Ref. [144].

#### B. Fe{Pd

Fe{Pd alloys, which are close in composition to Fe<sub>3</sub>Pd, can undergo a therm oelastic martensitic transform ation with small hysteresis from the fcc phase to the face-centered tetragonal phase with c=a < 1 [145–147]. The structural transform ation is preceded by a softening of the elastic modulus C<sup>0</sup> [148, 149]. The highest temperature at which the martensitic transition occurs in the Fe{Pd system, M<sub>s</sub>, is approximately 273 K and rapidly decreases with increasing Pd content [147, 150]. Admixture of N i or Co also signi cantly lowers M<sub>s</sub> [150]. The tetragonality parameter c=a of the martensitic phase rapidly increases with decreasing temperature [151] and in Fe<sub>70.3</sub>Pd<sub>29:7</sub> reaches the value of 0.91 at 153 K.

System atic studies of the composition dependence of the Curie tem perature for Fe{Pd alloys have yet to be carried out. For the Fe<sub>70</sub>Pd<sub>30</sub> alloy, the Curie tem perature  $T_c = 573 \text{ K}$  [152] and varies little with Pd content. At 333 K in the austenitic phase of Fe<sub>70</sub>Pd<sub>30</sub> the saturation m agnetization is roughly 1100 em  $u/\mbox{cm}^3$  and the  $5 10^3$ m agnetocrystalline an isotropy constant is K 1 erg/cm<sup>3</sup> [152]. The fact that  $K_1$  is negative in plies that the easy magnetization axis is directed along the h111i axis. The alteration of the crystal structure in the process of martensitic transformation strongly a ects the magnetic properties of Fe{Pd alloys. The saturation m agnetization of the martensitic phase of Fe3Pd is equal to 1400 em u/cm<sup>3</sup> and is weakly tem perature-dependent [153, 154]. M easurem ents of the uniaxial m agnetocrystalline anisotropy constant of the martensitic phase carried out on polycrystalline sam ples by M atsuiand A dachi [155] and K lem m er et al. [156] revealed a large value of  $K_u$ , roughly  $10^7$  erg/cm<sup>3</sup>, which implies that the coupling of the elastic and magnetic subsystems is su ciently strong for the emergence of magnetically induced strains caused by the redistribution of the martensitic variants. Note, however, that Cui and Jam es [152] recently observed a much smaller uniaxial magnetocrystalline an isotropy constant K  $_{\rm u} = 3:1 \quad 10^5 \text{ erg/cm}^3$  in an Fe<sub>70</sub>Pd<sub>30</sub> single crystal. There is also contradictory inform ation about the direction of the easy magnetization axis in the martensitic phase. For instance, Matsui and A dachi [155] and M uto et al. [157] reported that the easy magnetization axis in the martensitic phase is directed along [001]. On the other hand, there have been reports (see Refs [152, 154]) of measurements involving single crystalline samples converted to a single-dom ain state in which the [001] axis was found to be the hard m agnetization axis, while the easy magnetization axis was found to be directed along [100]. These contradictions are probably a re ection of the experimental di culties in determ ining the magnetic parameters of the low-temperature

phase, di culties caused by the existence of martensitic variants with di erent crystallographic orientations.

Studies of magnetically induced strains in the martensitic phase of  $Fe_{70}Pd_{30}$  have been conducted by James and W uttig [154]. Under the combined action of uniaxial stresses and the operating and reference magnetic elds, a 0.6% strain caused by the redistribution of martensitic variants was reached in the martensitic phase of a singlecrystal sample.


M agnetically induced strain in an  $Fe_{68:8}Pd_{31:2}$  single crystal alloy with a martensitic transition temperature of 225 K has been studied by K oeda et al. [158]. The experiment was conducted in the following way: rst the sample was cooled to liquid nitrogen temperature, and then it was subjected to a cyclic magnetic eld with a strength of up to 40 kO e (the direction of the magnetic

eld was changed from positive to negative). In the rst on {o magnetic- eld cycle the sample elongated by 3%, while in the subsequent cycles the reversible value of the magnetically induced strain amounted to roughly 0.1%.

Furuya et al. [159] and Kubota et al. [160] studied the magnetically induced strain in ribbon samples of the  $Fe_{70:4}Pd_{29:6}$  prepared by quenching from melt. The grains of the quenched samples were elongated along the direction of rolling, and the variable parameters were the rate of quenching from the liquid state and the annealing time; these parameters determ ine the size distribution of the grains, the nature of the grain boundaries, and the extent to which the grains are texturized. A magnetic

eld of up to 10 kO e was applied perpendicularly to the surface of the ribbon. The greatest strain was observed in sam ples with grains whose (100) plane was parallel to the sam ple surface. The strain induced by the magnetic

eld increased with tem perature up to 0.18% (note, for the sake of com parison, that the magnetostriction of the TerfenolD, Fe<sub>2</sub>Tb<sub>0:37</sub>D y<sub>0:23</sub>, in a 10 kO e eld is 0.17%).



### C. Fe{Pt

In disordered Fe{Pt alloys, which are close in composition to the stoichiom etric alloy Fe<sub>3</sub>Pt, the martensitic transform ation from the high-tem perature fcc phase to the low-tem perature body-centered tetragonal phase proceeds with substantial (up to 450 K in the Fe<sub>76</sub>Pt<sub>24</sub> alloy [161]) hysteresis. The degree of shape restoration in the heating of a sam ple that had been deform ed in the martensitic state is small. Annealing leads to the ordering of these alloys in a Cu<sub>3</sub>Au (L1<sub>2</sub>) structure. Such ordering is accompanied by a rise in the Curie temperature [162] and a drop in the martensitic transition temperature and leads to a substantial decrease in hysteresis [161] and the appearance of the shape memory e ect [163-168].

As a result of atom ic ordering, the martensitic transform ation changes from non-therm oelastic to therm oelastic. The transition proceeds to the low-temperature face-centered tetragonalphase and is preceded by a softening of the lattice of the high-temperature phase as the martensitic transform ation temperature is approached [169]. The ordering makes the lattices of the initial and martensitic phases resemble each other more closely, facilitates elastic accommodation, and eliminates plastic relaxation of the stresses generated in the process of form ation of martensite crystals in the initial phase.

The Curie tem perature of  $Fe_3Pt$  is roughly 450 K, so that the austenitic and m artensitic phases in alloys close in composition to the stoichiom etric alloy are ferrom agnetic [170]. Thus, the conditions needed for observing m agnetically induced strains (therm clastic m artensitic transform ation and the ferrom agnetism of the m artensite) in ordered Fe{Pt alloys are met.

M agnetically induced strains in the single crystal  $Fe_3Pt$ , whose m artensitic transform ation temperature is 97 K, have been studied by K akeshita et al. [171]. The lattice constant a of the cubic  $L1_2$  phase at 100 K is 3.73 A, and the lattice parameters of the body-centered tetragonalm artensitic phase at 77 K are a = 3:77 A and c = 3:66 A, so that c=a = 0:97. The researchers did not determ ine the direction of the easy m agnetization axis { it was assumed that this is the c axis, as in N  $i_2$ M nG a.

The sample cooled to liquid helium temperatures was subjected to a cyclic magnetic eld with a strength of up to 40 kO e. As Figure 15 shows, when the eld was switched on for the rst time, the sample contracted by 1.5% along the direction of the eld, and became 0.5% longer when the eld was switched o . Subsequent on {o magnetic-eld cycles revealed a reversible change in the sam ple length of 0.5%, but hysteresis was substantial (up to about 10 kO e).

### D. Ni<sub>2</sub>MnAl

The ordered high-temperature phase of the ternary system N i{M n{A lundergoes a therm celastic m artensitic transform ation upon cooling [172-174]. The degree of or-

dering of the high-tem perature phase depends on therm al treatm ent: under quenching from tem peratures higher than 1000 C austenite has a B2 structure which, how – ever, changes to L2<sub>1</sub> structure after ageing the sam – ples at tem peratures ranging from 350 to 400 C [174]. The crystal structure of the m artensitic phase and the m artensitic transform ation tem peratures in N i{M n{A l alloys depend on composition [172–175]. For instance, for N i<sub>50+ x</sub>M n<sub>25</sub>A l<sub>25 x</sub> alloys the tem perature of the on-set of the m artensitic transition, M <sub>s</sub>, is in the interval from 200 to 250 K for 0 x 3 [176, 177].

Neutron di raction studies at liquid helium tem peratures have shown [178] that N  $i_2$ M nA l of stoichiom etric com position has antiferrom agnetic ordering. The type of m agnetic ordering in N i{M n{A l alloys strongly depends on the chem ical ordering of the high-tem perature phase, which changes under therm al treatm ent. Q uenched sam – ples have the B2 structure of the austenitic phase, and they exhibit either antiferrom agnetism or a spin glass state. A geing the sam ples after quenching leads to the form ation of the L2<sub>1</sub> structure of the austenitic phase, which has a ferrom agnetic ordering with a C urie tem perature T<sub>C</sub> 330 K [176].

Fu jita et al. [179] used the capacitance dilatom eter m ethod to study the strains induced by m agnetic ekls in polycrystalline and single crystalline N  $i_{53}$ M  $n_{25}$ A  $l_{22}$ . For polycrystalline sam ples of this alloy with M f 226 K the value of the m agnetostrain was found to be tem peraturedependent. The m axim um strain of roughly 0.01% was observed at 228 K. The researchers assumed that this was due to the presence of a sm all am ount of the austenitic phase near M f, which facilitates the m ovem ent of the boundaries of the m artensitic variants [104]. In a 70 kO e

eld, the m agnetically induced strain in the single crystal sample amounted to 0.1% .

#### E. Co{N i{A l, Co{N i{G a

E nam i and N enno [180] established that the N i{A lalloy with a B2 structure exhibits the shape m em ory e ect. The in uence of a cobalt admixture on the shape m em – ory e ect in N i{A lwas studied by K ainum a et al. [181], who found that  $C \circ \{N i \}$  lalloysm ay undergo a therm oelastic m artensitic transition and that the tem perature of this transition decreases with increasing the C o content. The researchers also found that austenite in these alloys is actually a two-phase solid solution, and because of this the polycrystalline C o{N i{A lalloys exhibit good plastic properties.

In addition to the  $Co\{N i\{A lalloys, temary Co\{N i\{G a alloys have been studied. It was found [182–184] that these alloys also exhibit shape m em ory and, in the case of a two-phase m icrostructure, have good plastic properties. Shape m em ory in <math>Co_{45}N i_{25}Ga_{30}$  and  $Co_{40}N i_{33}A l_{27}$  was studied by the three-point bending m ethod involving lam ellar sam ples whose austenitic phase had a two-phase m icrostructure. It was found that the initial shape of

the sam ples was not restored after the stresses were rem oved, which, probably, is due to the presence of residual "inclusion phases".

The eld and temperature dependencies of the magnetization of Co{N i{A l and Co{N i{G a exhibit a behavior typical of ferrom agnetic materials. The dependence of the martensitic and ferrom agnetic transition temperatures on composition in Co{N i{A l and Co{N i{G a has been studied in Refs [182-185]. In Co{N i{A l with xed A l content (at 30 at.%), the martensitic transition tem perature  $T_m$  increases and the Curie temperature  $T_C$  decreases as N i content grows from 30 to 45 at.%. An important feature of the phase diagram built by the researchers is that, as in the case of N  $i_{2+x}M n_1 x G$  a alloys,  $T_m$  and  $T_C$  merge at 250 K when N i content reaches

35 at.%. A further increase in N i content makes  $T_m$  higher than  $T_{\rm C}$  and the martensitic transition takes place in the paramagnetic phase. Such concentration dependencies of  $T_m$  and  $T_{\rm C}$  were also found to exist for Co{ N i(G a alloys. For instance, with G a content xed (at 30 at.%), the martensitic transition temperature  $T_m$  increases and the C urie temperature  $T_{\rm C}$  decreases as N i content grows from 18 to 33 at.%. For the C  $o_{47}N$   $i_{23}G$   $a_{30}$  alloy, the temperatures  $T_m$  and  $T_{\rm C}$  merge at 370 K.

M orito et al. [186] found that the value of the m agnetocrystalline anisotropy of the martensitic phase of Co{ N i{A l, when measured in single crystal  $Co_{37}Ni_{34}Al_{9}$ , amounts to  $3.9 \quad 10^7 \text{ erg/cm}^3$ . This value is comparable to the magnetocrystalline anisotropy constants of N i<sub>2+x+v</sub>M n<sub>1 x</sub> G a<sub>1 v</sub> alloys [81]. M easurem ents of m agnetically induced strain caused by the redistribution of martensitic variants have shown, however, that the reversible magnetically induced strains in this intermetallic com pound do not exceed 0.06%, which is sm aller than the values for N  $i_{2+x+y}M n_{1-x} G a_{1-y}$  alloys by a factor of 100. M orito et al. [186] assum ed that this is because the sam ple was not in a single-variant state and hence only a fraction of the maximum attainable magnetically induced strain was detected. The crystal structure of martensite in  $Co_{37}Ni_{34}Al_{9}$  (L1<sub>0</sub>, c=a = 0:816) also di ers signi cantly from that in N  $i_{2+x+y}$  M  $n_{1x}$  G  $a_{1y}$  alloys, a factor that could a ect the mobility of the martensitic variants.

#### F. Co<sub>2</sub>NbSn

The ferrom agnetic H eusler alloy C o<sub>2</sub>N bSn undergoes a m artensitic transform ation when it is cooled. The tem – perature of this m artensitic transition,  $T_m = 253$  K, is much higher than the ferrom agnetic ordering tem perature  $T_C = 119$  K [187]. In the low-tem perature phase this com pound has an orthorhom bic crystal lattice with param eters a = 4:436 A, b = 4:397 A, and c = 5:939 A [69, 188]. The m agnetic m om ent in C o<sub>2</sub>N bSn is on the cobalt atom s and am ounts to approximately 0:36 <sub>B</sub> at 4 K [189]. Studies of the m agnetic properties of the m artensitic phase of C o<sub>2</sub>N bSn have shown (see Refs [188, 190, 191]) that m agnetization does not reach saturation in

elds up to 5 T .Such m easurem ents conducted with the C  $o_{50:4}N\,b_{25}Sn_{12:9}G\,a_{11:7}$  alloy which does not undergo a m artensitic transform ation, have shown that m agnetization becomes saturated in elds of approximately 0.5 T. O htoyo et al. [188] assumed, on the basis of these m easurem ents, that large m agnetocrystalline anisotropy is a characteristic feature of the m artensitic phase of the C  $o_2N\,bSn$  alloys. Variations in composition [188] and doping of C  $o_2N\,bSn$  with N i [69], V, G a, and A 1 [192] do not lead to a rise in the C unie tem perature  $T_{\rm C}$ . How ever, the tem perature of the m artensitic transition decreases. For instance, in the C  $o_{50}N\,b_{25}Sn_{20}G\,a_5$  alloy,  $T_{\rm m}$  = 43 K but  $T_{\rm C}$  = 101 K [192].

#### VIII. THEORY OF PHASE TRANSITIONS IN CUBIC FERROMAGNETS

The experimental data suggest that both structural and magnetic phase transformations occur in ferrom agnetic alloys with shape memory. Moreover, within certain intervals of structural and magnetic parameters of ferromagnets these transformations overlap. Intensive experimental studies of shape memory ferrom agnets have stim ulated the development of the theory of coupled structural and magnetic transformations.

Theoretical investigations of the interaction of the structural and m agnetic order param eters in various crystals have been carried out by m any researchers. The results of earlier work of this kind have been gathered and generalized in Izyum ov and Syrom yatnikov's monograph [193]. M any theorists have also exam ined the transition from the cubic phase to the tetragonal in various crystals. Landau theory of phase transitions has been used to describe the given transition. This theory was used to study transitions only in the elastic subsystem [193–198] and transitions in system s where the structural and m agnetic order param eters interact [22, 199]. A sapplied to phase transitions in N  $i_{2+x}$  M n<sub>1 x</sub> G a alloys, Landau theory has been developed in R efs [66, 67, 91, 200–215].

### A. Totalenergy

The sequence of phase transformations in N  $i_{2+x}Mn_{1-x}$  Ga alloys observed in experiments can be described by Landau theory for coupled structural and m agnetic phase transitions. The special features of the crystal and m agnetic structures of the ferrom agnetic H eusler alloys N i{M n{Ga require the introduction of three interacting order parameters describing the variation of the structure of the crystal lattice, its m odulation, and the m agnetization. W ithin this system

of param eters, both the ferrom agnetic cubic state and the ferrom agnetic tetragonal state (both m odulated and unm odulated) can exist at low tem peratures.

The distortions of the cubic lattice upon structural transitions are described by hom ogeneous strains written in the form of linear combinations of the components  $e_{ii}$  of the strain tensor [216]:

The strain  $e_1$ , which re ects changes in volum e, does not violate lattice sym m etry. Sym m etry breaking occurs because of the strains  $e_2$  and  $e_3$ , responsible for the transition of the lattice from the cubic phase to the tetragonal. The given transition is accompanied by the softening of the elastic m oduli combination  $C_{11}$   $C_{12}$ . The complete expression for the free energy density, which describes the transition to the tetragonal state, m ust contain the strains  $e_4 = e_{xy}$ ,  $e_5 = e_{yz}$ , and  $e_6 = e_{zx}$ , which lead to the distortion of the unit cell to a sym m etry lower than the tetragonal.

In describing the modulated state in the crystal brought on by the presence of acoustic phonon modes of the type  $(\frac{1}{3}, \frac{1}{3}, 0)$ , we must bear in m ind that there are six di erent directions of the modulation wave vector. They can be written as follows:  $k_1 = (110), k_2 =$ (011),  $k_3 = (101), k_4 = (110), k_5 = (011), and k_6 =$ ¢10), where = 1=3. In view of this, there should, as a rule, exist an order param eter containing twelve com ponents (six am plitudes and six phases):  $_1$ ;...;  $_6$  and  $'_1$ ;...;  $'_6$ , where  $j = j_j j exp(i'_j)$ . The atom ic displacements corresponding to each of these order parameters have the form  $u_j(\mathbf{r}) = j_j \mathbf{p}_j \sin(k_j \mathbf{r} + \mathbf{j})$ , where  $p_1; \ldots; p_6$ are the unit polarization vectors directed along the axes [110], [011], [101], [110], [011], and [101], respectively.

The expression for the free energy density, which describes structural transitions from the cubic phase, must be invariant under spatial transform ations of the point symmetry group  $O_h$ . It consists of terms of three types:

Here  $F_e(e_j)$  is the elastic energy density, which contains terms responsible for the anham onicity of the elastic subsystem with respect to the order parameter ( $e_2;e_3$ ). The expression for it has the form [216]

Since the right-hand side of Eqn (3) contains term softhe third order, the phase transition in the parameter (e<sub>2</sub>, e<sub>3</sub>) is a rst-order transition. As the point of the structural transition to the tetragonal phase is approached, the elastic m odulus a =  $C_{11}$   $C_{12}$  tends to zero, and near the transition point (T !  $T_m$ ) it can be represented in the form a =  $a_0$  (T  $T_m$ ), where  $T_m$  is the temperature of the m artensitic transition.

The complete expression for F ( $_j$ ) can be found in Refs [217, 218]. Here we consider the simplest version of modulation, which allows for only one phonon mode  $\frac{1}{3}$  (110). It is described by the order parameter = j jexp(i') (to simplify the notation, we have dropped the index j), which makes it possible to write the expression for the density of the modulation part of the free energy in the form

The m inimum of the energy (5) occurs at ' = =6, =2, 5 =6 if  $C_1 > 0$  and at ' = 0, =3, 2 =3, if  $C_1 < 0$ . In equation (5) we introduce the quantity  $C^0 = C_0$   $\mathcal{J}_1$  jand, for the sake of stability, assume that  $C^0 > 0$ . The parameter A is tem perature-dependent, and near the tem perature of transition to them odulated state (T !  $T_P$ ) it can be written in the form A =  $A_0$  (T  $T_P$ ) [20, 219, 220].

The part of the free energy density,  $F_e$ , that connects the strain,  $e_i$ , and the order parameter describing modulation must be invariant under all symmetry operations related to  $e_i$  and  $_j$ . If we allow for the phonon mode  $\frac{1}{3}$  (110) only, the expression for  $F_e$  has the form

Equations (3), (5), and (6) completely determ ine the free energy density of a cubic crystal, which makes it possible to describe structural phase transitions from the cubic phase to phases of lower symmetry.

Experiments have shown that structural transform ations in N  $i_{2^+\,x}M\,n_{1\,x}$  G a alloys take place in the ferrom agnetic matrix, which makes it necessary to take into account the elect that the magnetic subsystem has on the structural transitions. In these alloys M n atoms are them ain carriers of magnetic moments, both in the cubic and in the tetragonal phases [14]. This makes it possible to describe N  $i_{2^+\,x}M\,n_{1\,x}$  G a alloys using the model of a single-sublattice magnetic subsystem with a macroscopic magnetic subsystem we introduce, for the sake of convenience, the dimensionless magnetization vector m = M =M  $_0$ , where M  $_0$  is the saturation magnetization.

The contribution of the magnetic subsystem to the totalenergy of the cubic ferrom agnet consists of two parts. The st is of exchange origin and is needed to allow for the dependence of the magnetization vector m on tem perature. This term can be written as follows:

Here and  $_1$  are the exchange constants. The parameter of the exchange interaction is temperature-dependent and near the Curie point,  $T_{\rm C}$ , can be written as  $_0$  (T $_{\rm C}$ ). The second term is the magnetic anisotropy energy of the cubic ferrom agnet, which can be written as

The expression for the free energy must also contain a term s that relate the components of M with the other order parameters of the system. The rst of such term s connects the magnetization components m  $_{\rm i}$  with the strains  $e_{\rm i}$  and has the form

This form ula is the simplest expression for magnetoelastic energy with phenom enological magnetoelastic constants  $B_1$ ,  $B_2$ , and  $B_3$ .

The second term describes the interaction between the magnetization vector components  $m_i$  and the order parameter and can be written as follows:

This expression for the free energy density contains variables that are not responsible for phase transitions, i.e., variables that are indirect order parameters:  $e_1$ ,  $e_4$ ,  $e_5$ , and  $e_6$ . A first the free energy is minimized in all these variables, som e of the constants in Eqn (11) become renormalized:

B. Phase diagram at  $T_{\rm m}\,<\,T_{\rm C}$ 

In N  $i_{2+x}M n_{1-x}$  G a alloys the temperatures of the structural and magnetic phase transitions strongly depend on composition. In view of this it would be interesting to study the phase diagram s at  $T_m < T_C$  (compositions close to stoichiom etric) and at  $T_m - T_C$  (compositions with x = 0.16 - 0.20). The review of the experimental research in magnetic anisotropy measurements (see Section 4.3) suggests that the rst cubic-anisotropy constant K also depends on composition. For instance, in alloys close to the stoichiom etric composition, the constant K is positive [80], while in alloys with considerable deviations from stoichiom etry it proves to be negative

[81]. In view of this, when describing phase transitions in N  $i_{2+x}M n_{1-x}$  G a alloys by theoretical means, both cases, K > 0 and K < 0, must be considered. It has turned out that the second case leads to more complicated phase diagram sthan the rst (see Refs [66, 67, 91, 200–210] and [211–215] for K < 0 and K > 0, respectively). In view of this we will focus on the case where K > 0. The interested reader can nd material on the K < 0 case in the above-cited works [66, 67, 91, 200–210]. To be more de - nite, we assume e in what follow sthat the magnetostriction constant B<sub>2</sub> is positive (this follows from the measurements of magnetostriction constants [80]) and that the fourth-order elastic modulus c > 0. But rst we assume that there is no lattice modulation, i.e., j j= 0.

W e begin with the case where the structural transition takes place in a ferrom agnetic matrix ( $T_{\rm m}~<~T_{\rm C}$ ). Here in formula (12) we can put m $^2$  = 1 and go from the Cartesian coordinates m $_x$ , m $_y$ , and m $_z$  to the polar and azimuthal angles of this vector. M inimization of the free energy (12) in respect to  $e_2, e_3$ , , and leads to the following equilibrium states.

For b > 0 there is a region in which a metastable phase R<sup>0</sup> coinciding in symmetry with the phase R is stable, while for b < 0 there is a region in which a metastable phase C<sup>0</sup>(T<sup>0</sup>) coinciding in symmetry with the phase C (T) is stable. The signs of the strains  $e_3$  in the metastable phases are opposite to those of the given strains in the phases R and C (T). The existence regions of the m etastable phases are bounded by the following curves. At b > 0 (phase  $R^{0}$ ),

N ote that according to Eqn (1), the sign of the strain  $e_3$  determ ines the sign of  $c=a \ 1$  (here c and a are the structural lattice param eters). At  $e_3 > 0$  the quantity  $c=a \ 1$  is positive, while at  $e_3 < 0$  it is negative. If we assume that the elastic m odulialso depend on the com position of the N  $i_{2+x}$ M  $n_{1-x}$  G a alloys, equations (16) { (18) suggest that at certain values of x stable and m etastable phases of di erent sym m etries m ay coexist in these alloys. This fact agrees with the experim ental results of Inoue et al. [221, 222], who observed m artensitic phases of di erent sym m etries.

Sym m etry considerations suggest that in addition to the above states in the ferrom agnet there can be sim ilar phases w ith m agnetizations along the [100] and [010] axes, states w hose energies and regions of existence coincide w ith those given above.

A nalysis of distortions of the initial cubic lattice in phases C and T shows that these phases have the sam e tetragonalsymmetry and dier only in the values of spontaneous strains. In the C phase these strains are determined by the distortions of the cubic lattice caused by magnetostriction, while in the T phase they are determined by structural distortions in the transition to the martensitic state. The phase transition lines between the states C, T, and R are determined by the condition that the phase energies (12) be equal.




FIG.16: Phase diagram of a cubic ferror agnet with  $T_{\rm m} < T_{\rm C}$  in the (a;b) plane. C is the cubic phase with sm all tetragonal distortions, T is the tetragonal phase, and R is the orthorhom – bic phase. The magnetization in all phases is directed along the [001] axis. The solid curves represent the phase transition lines and the dashed curves the lines of loss of stability of the phases.

The phase diagram of the cubic ferrom agnet in the (a;b) plane at  $T_m < T_C$  is depicted in Fig.16. Depending on the values of the elastic m oduli of the second (a) and third (b) orders, the following structural transform ations can occur in the ferrom agnet. At b > 0, a rst-order phase transition from phase C to phase T occurs on the line AE determined by the equation

This transition is accompanied by a discontinuity of the strain  $e_3$  and is a martensitic transform ation. In relation to sym m etry, it is an isostructural transition and ends at point A (the critical point) with coordinates  $(18 \text{ cB}_2^2)^{1=3}$ and  $(9^{\circ} 6B_2c^2)^{1=3}$ . To the left of point A the transition from phase C to phase T proceeds sm oothly, without discontinuity in e<sub>3</sub>. At b 0, a martensitic transform ation (a rst-order structural phase transition) from the cubic phase  $\ensuremath{\mathsf{C}}$  to the orthorhom bic phase  $\ensuremath{\mathsf{R}}$  , accompanied by discontinuities in the strains  $e_2$  and  $e_3$ , occurs on the line C H . O n the line C L a second-order structural phase transition between these two phases occurs. The expression for the line CH of a rst-order phase transition can be found by equalizing the energies of phases C and R. Line CL of a second-order phase transition is determined by using the equal sign in Eqn (14). The critical point C where the rst-order phase transition is term inated has the coordinates

C learly, the coordinates of the points A and C are determined by the size of the magnetostriction  $B_2$ . At  $B_2 = 0$  the phase diagram coincides with that of a nonmagnetic cubic crystal [193].

#### C . Phase diagram at $T_{\text{m}}$ $\quad T_{\text{C}}$

Now let us exam ine the phase diagram of the cubic ferrom agnet for the case where the tem peratures of the m artensitic ( $T_m$ ) and m agnetic ( $T_c$ ) transitions are close. In this situation, to nd the equilibrium states of the cubic ferrom agnet, the free energy (12) m ust be m inim ized with respect to the variables  $m_x$ ,  $m_y$ ,  $m_z$ ,  $e_2$ , and  $e_3$ . To be m ore de nite, we will assume here that b > 0 and that the signs of the other quantities are the same as in the case where  $T_m < T_c$  (the case with b < 0 and K < 0 has been examined in Ref. [207]).

M inimization of Eqn (12) leads to the following equilibrium states of the ferrom agnet.

Symmetry considerations suggest that, in addition to the above states, other equilibrium phases with energies and stability regions coinciding with the former ones can take place in the crystal. Am ong these are tetragonal param agnetic phases with strains along the [100] and [010] axes, ferrom agnetic cubic phases with m agnetizations along the [100] and [010] axes, and tetragonal phases with strains and m agnetizations along the [100] and [010] axes.

As in the case where  $T_{\rm m} < T_{\rm C}$ , in the stability regions of the stable phases there can also be metastable phases of other symmetries with energies close to those of the stable phases. Similarly, analysis of the distortions of the cubic lattice in the FC and FT phases, which are determined by equations (24), show sthat, from the view – point of symmetry, these phases have the same, tetragonal, symmetry. The two phases di er in the values of the spontaneous strains  $e_3$ . In the FC phase they are determined chie  $\,y$  by magnetostriction, while in the FT phase they are determined chie  $\,y$  by structural distortions that emerge as a result of the transition to a martensitic state.




FIG.17: Phase diagram of a cubic ferrom agnet at  $T_{\rm m}$   $T_{\rm C}$  in the (;a) plane. PC is the param agnetic cubic phase, PT is the param agnetic tetragonal phase, FC is the ferrom agnetic cubic phase with sm all tetragonal distortions, and FT is the ferrom agnetic tetragonal phase. The magnetization in FS and FT is directed along the [001] axis. The solid curves represent the phase transition lines and the dashed curves the lines of loss of stability of the phases.

Figure 17 is the phase diagram of a cubic crystal at  $T_{\rm m}$   $T_{\rm C}$  in the ( ;a) plane. The following phase transitions from the cubic phase PC are possible. On the line BK, given by the equation  $a=b^2=4c$ , there occurs a rst-order structural phase transition to a paramagnetic tetragonal phase PT with large lattice distortions (a m artensitic transform ation). A long the line DM (=0) there proceeds a second-order m agnetic phase transition to a ferrom agnetic cubic phase FC with sm all tetragonal lattice distortions. On the line D B there occurs a

rst-order coupled structural and m agnetic phase transition to a ferrom agnetic tetragonal phase FT with large tetragonal lattice distortions. The equation of this line can be found by equalizing the energies of the phases PC and PT. In addition to the above PT {PC transition on the line BK, there can occur a second-order isostructural m agnetic phase transition from the param agnetic tetragonal phase PT to a ferrom agnetic tetragonal phase FT along the line BH. The equation of this line follows

from the second condition of stability of the FT phase in Eqn (26) if the inequality sign is replaced by the equality sign. Between the ferrom agnetic phases FC and FT there can occur a rst-order isostructural phase transition on the line GD. The equation of this line is

The given transition is accompanied by a discontinuity in the strain  $e_3$  and is a martensitic transformation. Its term ination point in the (;a) plane may be the point G. This happens if the point G is located to the right of the line of stability of the FC and FT phases in Eqn [27] (we have not depicted this line so as not to clutter up the gure). Analysis of inequality (27) and equation (28) combined with conditions (25) and (26) of stability of the FC and FT phases shows that the point of term ination of the phase transition of FT and FC phases will exist only at large values of the magnetoelastic constant  $B_2$  $b^3=c^2$ . In this case the transition between the FT and FC phases to the left of point G proceeds sm oothly, without a discontinuity in the strain  $e_3$ .

The region of absolute stability of the PC phase is  $\lim$  - ited by the lines OM and ON. For the PT phase this region is  $\lim$  ited by the lines LC and CH. The FT phase

is absolutely stable in the region to the left of the line G H and the FC phase above the curve G F M . The points D and B are critical: at these points the line of second-order phase transitions splits into two lines of rst-order phase transitions. The coordinates of points D and B are

O ur analysis of the e ect of magnetoelastic interaction on the phase diagrams of the cubic ferrom agnet shows that when the rst anisotropy constant K is positive, structural phase transitions are not accompanied by reorientation of magnetization. The explanation is that, strictly speaking, the magnetoelastic interaction already in the cubic phase lowers the symmetry of this phase to tetragonal. The symmetry of the low-temperature phase proves to be either tetragonal (b > 0) or orthorhom bic (b < 0). And because the high- and low - temperature phases contain the same symmetry elements (say, 2-fold and 4-fold axes), no reorientation of magnetization occurs in structural transitions.

When the symmetries of the high- and lowtem perature phases coincide perfectly (b > 0), the line of structural phase transition may have a term ination point. To the right of this point a structural transition is accompanied by a discontinuity of strains and by hysteresis and represents a martensitic transform ation. To the left of this point there is no transition the strains gradually change their nature from quasicubic to tetragonal, and there is no hysteresis. W hen b < 0, the sym m etries of the low - and high-tem perature phases do not coincide. In this case, at large values of bj the structural transition between the phases is a st-order phase transition (a martensitic transform ation), while at small values of jbj the transition is of the second order. Thus, at b < 0we have a critical point in the phase diagram (at this point the type of transition changes). The coordinates of the structural-transition term ination point at b > 0 and the critical point at b < 0 are determ ined by the magnetostriction constant B<sub>2</sub>. The presence of m agnetoelastic interaction leads to a situation in which within a certain interval of the param eters of the cubic ferrom agnet there occur rst-order coupled structural and magnetic phase transitions. The size of this interval in the phase diagram where such transitions occur is determ ined by the m agnitude of the magnetoelastic interaction.

#### D . T vs.x phase diagram at $T_{m}$ $\quad T_{C}$

The experimental data (e.g., see Refs [66, 67, 91]) suggest that in N  $i_{2+x}M n_{1-x}$  G a alloys the Curie temperature and the martensitic transformation temperature vary with concentration x almost linearly. This fact can be used to build a theoretical T vs x phase diagram of the

given alloys. To this end we write the coe cients a and in the free energy (12) in the form

where  $T_m$  =  $T_{m\ 0}+~x$  and  $T_C$  =  $T_{C\ 0}~~x$ , with  $T_{m\ 0}$  and  $T_{C\ 0}$  the temperatures of the martensitic and magnetic transitions at x = 0, and and are proportionality factors. The values of  $T_{m\ 0}$ ,  $T_{C\ 0}$ , , and can be found from experiments.




FIG. 18: Theoretical T vs. x phase diagram of cubic ferrom agnetic alloys N  $i_{2+x}M n_1 _x G$  a without modulation of the crystal lattice (a) [(b) shows the region where the tem peratures  $T_m$  and  $T_c$  intersect on a larger scale], and with modulation of the crystal lattice (c).

Figure 18a shows a phase diagram of N  $i_{2+x}$  M  $n_{1-x}$  G a alloys built num erically with allow ance for Eqn (29). The following values of the parameters in Eqns (12) and (29) (see Refs [14, 20, 21, 23, 66, 67, 80, 91, 123, 223]) were used in calculating this diagram :

In view of the smallness of the magnetoelastic constant B<sub>2</sub>, the region in Fig. 18a where the tem peratures  $T_m$  and  $T_C$  intersect is not resolved on the given scale. To resolve it, in Fig. 18b we show this region on a larger scale. Figures 18a and 18b suggest that with the param eters chosen according to Eqn (30), the region D B where structural and magnetic phase transitions coexist is sm all and is located near x 0:187. The size of this interval is determ ined by the magnetoelastic constant B<sub>2</sub>. The phase diagram in Figs 18a and 18b is in good agreem entwith the experim ental T vs x diagram [66, 67, 91] (see Fig. 10). We also note that in the region where a coupled structural and magnetic phase transition exists (line DB in Fig. 18b), the Curie tem perature increases with concentration. Outside this region the Curie tem perature always decreases (with x increasing or decreasing). This fact also agrees with the experimental data (see Section 5.1).

As noted earlier [see Eqn (18)], within the region of existence of stable phases in which the lattice parameter ratio c=a is less than unity, there can also be metastable phases (with energies close to those of the stable phases), in which the lattice parameter ratio c=a is greater than unity. Figures 18a and 18b show that within a narrow interval of concentrations x 0:19 near the point of intersection of  $T_m$  and  $T_c$ , phases with cubic symmetry may exist in addition to martensitic phases of di erent symmetries and di erent lattice parameter ratios c=a. C rystal phases of di erent symmetries and di erent values of c=a have indeed been observed in experiments [99, 221, 222] in alloys with x 0:19.

E. T vs.x phase diagram at  $T_{\rm m}$   $~T_{\rm C}$  with allow ance for the m odulation order param eter

To nd all the equilibrium states of the N  $\frac{1}{2}$ +  $_{x}$  M n<sub>1</sub>  $_{x}$  G a alloys when the modulation order parameter is taken into account, we must minimize expression (12) in the order parameters  $e_{2}$ ,  $e_{3}$ ,  $j j m_{x}$ ,  $m_{y}$ , and  $m_{z}$ . The resulting system of nonlinear algebraic equations can be solved only numerically. To do the necessary numerical calculations, the following values of parameters in equation (12) were chosen on the basis of the existing experimentaldata [14, 20, 21, 23, 66, 67, 80, 91, 123, 223] (in units of erg/cm  $^3$ ):

The other parameters were taken from Eqn (30). The experimental data (see Fig. 10) suggest that the premartensitic transformation temperature  $T_P$  is practically independent of the composition of the alloys investigated. This makes it possible to write the parameter A in Eqn (12) in the form  $A = A_0 (T - T_{P,0}) = T_{P,0}$ , where  $T_{P,0} = 260 \text{ K}$ .

The T vs. x phase diagram of Heusler alloys  $N i_{2+x} M n_{1-x} Ga$  calculated with the given values of the parameters is shown in Fig. 18c. Clearly, with the param eters chosen in this way the following phases em erge as a result of concentration and tem perature variations: the param agnetic cubic (PC), the param agnetic tetragonal (PT), the ferrom agnetic quasicubic (FC), the ferrom agnetic tetragonal (FT), the ferrom agnetic quasicubic modulated (FCM), and the ferrom agnetic tetragonalmodulated (FTM). In all the ferrom agnetic phases m agnetization is directed along the [001] axis. M B and BH are the lines of second-order magnetic phase transitions between the param agnetic and ferrom agnetic cubic and tetragonal phases, respectively. FS is the line of the rst-order phase transition between the ferrom aqnetic phases FC and FCM . SR is the line of a similar transition between the tetragonal phases FT and FTM. These rst-order phase transitions are accompanied by the emergence of lattice modulation. The hysteresis of the given transitions with the selected values of param eters is very sm alland therefore is not resolved on the scale ofFig.18c.GS,SB, and BK are the lines of the martensitic phase transitions FCM {FTM, FC {FT, and PC {PT, respectively. A characteristic feature of these transitions is that they are accompanied by the emergence of large tetragonal strains of the lattice. GL and GN are lines of loss of stability of the phases FTM , FT , PT and FCM , FC, PC, respectively. Figure 18c shows that, com pared to a transition to a modulated state, the martensitic transition is accompanied by a large hysteresis. This fact is in good agreem ent with the experim ental data from resistivity measurements (see Fig. 11). In the concentration intervalx 0:06 0:1, the hysteresis regions of the prem artensitic and m artensitic transitions overlap, with the result that these transitions are partially superimposed and are poorly resolved in experiments.

#### F. E ect of m agnetic eld on m artensitic structure

Analysis of the phase diagrams done in the previous sections shows that at T <  $T_m$  the Heusler alloys N  $i_{2+x}M n_{1-x}$  G a divide into structural domains. D effects in the crystal lattice play an important role in the nucle-

ation of martensitic structures [224-226]. Detailed analysis of martensitic domain structures has been carried out in Refs [226-228]. Cumoe and Jacobs [229] proposed a model of a twin boundary separating two tetragonal variants. The structural domains in the ferrom agnetic alloys N  $i_{2+x}$  M  $n_{1-x}$  G a, in turn, divide into magnetic domains. When an external magnetic eld is applied, both them agnetic and the structural domains undergo a transform ation [75, 154, 230-238].

L'vov et al. [231] calculated the tem perature curves for the magnetization of a ferrom agnetic martensite at di erent values of the external magnetic eld strength. They found that the presence of a martensitic domain structure helps to explain the tem perature dependences of magnetization observed in experiments (see Fig. 4).

Jam es and W uttig [154] found the eld dependence of the strains induced in an alloy by num ericalm in in ization of the alloy energy averaged over the di erent martensitic variants. They assumed that each martensitic variant that is possible for the speci c sample enters into the total magnetization and strain with its own volume fraction. The total energy was expressed by the sum of Zeem an energy, the external stresses energy and the dem agnetization energy, which, in turn, were expressed in term s of the averaged m agnetization and strain. Num ericalm in in ization of the total energy m ade it possible to determ ine the volum e fractions of the optim alm artensitic variants for the given value of the magnetic eld, which made it possible to construct the eld dependencies of the strains induced by the magnetic eld in the sam ples. A fuller analysis of the e ect of an external magnetic eld on the martensitic domain structure of N  $i_{2^+\,x}M$   $n_{1\ x}$  G a alloys was carried by O 'H and ley [230], who, how ever, did not exam ine the speci c m agnetic dom ain structure observed in experim ents.

The structural and magnetic domains in the martensitic phase of ferrom agnetic Heusler alloys N  $i_{2+x}M n_{1 x} Ga$  have been observed in experiments by Chopra et al. [121] (who used the photom icrography method) and by Pan and James [85] (who used the magnetic-force microscopy method). On the basis of the experimental results [85, 121] and the theoretical analysis of the phase diagram of N  $i_{2+x}M n_{1 x} Ga$  alloys [66, 67, 91, 200-215] Buchel'nikov et al. [236-238] proposed a model of the self-consistent structure of martensitic and magnetic domains, studied the behavior of this structure under an applied magnetic eld, and calculated the strains induced by the magnetic eld in the N  $i_{2+x}M n_{1 x} Ga$  alloys.

As a result of the transition from the high-tem perature cubic modi cation to the low-temperature tetragonal modi cation, the N $\frac{1}{2}$ +  $_x$ M n<sub>1 x</sub> G a single crystal divides into three types of m artensitic dom ains, each of which corresponds to a strain (compression or extension) of the crystal lattice along directions of the f100g type. In the ferrom agnetic crystal, the structural dom ains, in turn, divide into m agnetic dom ains. The direction of the m agnetization in each m agnetic dom ain coincides with the

principal crystallographic axis of the structural dom ain. For de niteness, in the structural dom ain of the rst type the tetragonal axis is directed along the x axis, while in the dom ains of the second and third types this axis is directed along the y and z axes, respectively. It is assumed that each structural dom ain divides into 180-degreem agnetic dom ains.

W hen there is no magnetic eld, all structural domains have the same energy, with the result that the volum es occupied by each type of dom ain are the same, too. W hen a magnetic eld directed along the x axis is switched on, the volum e of dom ains of the rst type increases at the expense of the dom ains of the second and third types. In the presence of the eld the volum e fractions of dom ains of di erent types can be written as follow s:

where  $f_1$  is the volume fraction of domains of the second type,  $f_{23}$  is the volume fraction of domains of the second and third types, and is a parameter that takes into account the variation of domain volumes under the applied magnetic eld.

The results obtained in the previous sections suggest that in a zero magnetic eld the cubic ferrom agnet can transform into tetragonal phases with magnetizations along axes of the f001g type. For instance, in the phase with m<sub>z</sub> = 1 (M jj[001]) the spontaneous strain tensor has the form

For the other two phases with m agnetizations along the [100] and [010] axes, the spontaneous strain tensor can be obtained from Eqn (32) through a cyclic permutation of the indices. Thus, in the ferrom agnet there can exist three tetragonal phases with the same energy, with the result that there can be three types of structural domains in the crystal. The rst terms in the expressions for  $e_{ik}$  describe the changes in strains caused by bulk

m agnetostriction. C om pared to e ects associated with structural lattice distortions, these terms are sm all and can be ignored.

P lugging Eqn (32) into the total energy (12) of the cubic ferrom agnet leads to the following expression for the energy of each type of dom ains in the system of coordinates associated with the crystal lattice:

Tickle and James [80] measured the magnetic anisotropy of N  $i_{2+x}Mn_1 x$  Ga alloys and found that the uniaxial anisotropy is much larger than the cubic one, so that in all further calculations the cubic anisotropy is dropped.

W e write the energy of the domain structure in the following form :

A coording to our choice of the direction of the externalm agnetic eld, magnetization in domains of the rst type is directed parallel or antiparallel to the eld, while in domains of the second and third types it is perpendicular to the eld. In view of this, in domains of the rst type under magnetization there can only be processes in which the domain walls are displaced while in domains of the second and third types there can only be processes in which magnetization is rotated. In this case the anisotropy energy and the Zeem an energy can be written as follows:




FIG.19: Field dependencies of the magnetization M (a), and the volume fraction of the favorably located martensitic domains and of the induced strains  $e_{xx}$  (b) for di erent values of the elective elastic modulus C (in units of erg/cm<sup>3</sup>): 1 5 10<sup>9</sup>, 2 5 10<sup>8</sup>, 3 3 10<sup>8</sup>, and 4 5 10<sup>7</sup>; the black squares represent the experimental data of W u et al. [123].

, and the strain  $h_{xx}$  i for dierent values of the elective elastic modulus C and the dem agnetization factor N are shown in Fig. 19. The following values of the parameters of N  $i_{2+x}$  M  $n_{1-x}$  G a alloy [80, 85] were used in the calculations:

These calculations also took into account the fact that when the parameter reaches the value of 2/3, the alloy becomes a single-dom ain alloy, the strain  $he_{xx}$  i reaches the value of roughly 0.06 (this is determined by the ratio of the crystal lattice parameters in the tetragonal phase, c=a = 0.94), and no further strain of the alloy under a magnetic eld occurs.

The eld dependencies of  $M_x i_{t}$ , and  $h_{xx} i$  have kinks at eld strengths  $H_0$  $H_{\rm C}$  and  $H_{\rm 0}$  $H_{1} =$  $H_A + 8$  N hM x i, where  $H_A = 2K = M_0$ . The explanation is as follows. W hen H  $_{

m C}$  , the increase in m agnetization is caused by the displacem ent of the magnetic domain walls in structural domains of the rst type and by rotation of magnetization vectors in structural domains of the second and third types. At H  $_0$  = H  $_C$  the m agnetic dom ains in the structural dom ains of the structural dom ains of the disappear completely, and the further increase in magnetization in elds  $H_C < H_0 < H_1$  is due solely to the rotation of magnetization in the structural domains of the second and third types. At  $H_0 = H_1$  the vectors M in the structural dom ains of the second and third types align them selves with the direction of the external eld, so that the sam ple's magnetization reaches its saturation value.

Figure 19 suggests that the transform ation of magnetic dom ains under an external eld takes place simultaneously with the transform ation of the structural dom ains. As the magnetic eld gets stronger, the structural dom mains of the rst type grow bigger. In elds higher than H<sub>1</sub>, when the magnetization is the same e in all structural dom ains, the Zeem an energy of these dom ains is also the same. Since it is due to the increase in the Zeem an energy that structural dom ains, walls begin to move under a magnetized of the same and the same and

Figure 19 clearly shows that at large values of the elective elastic modulus C the values of  $_{m ax}$  and  $h_{xx} i_{m ax}$ are smaller than the maximum values determined by changes in the lattice. From equations (44) and (45) it follows that to achieve maximum strains induced by a magnetic eld in N  $\frac{1}{2}$ +  $_x$ M n<sub>1</sub>  $_x$  G a alloys, the elastic energy must be of the order of the anisotropy energy. This can be achieved at small values of the elastic modulus Cnear the martensitic transform ation point. The results of the calculated eld dependencies of magnetization and strain are in good agreement with the experimental data [80, 19, 123].

## G . Shift in the structural phase transition tem perature caused by a magnetic eld

The shift in the temperature of a martensitic transformation caused by a magnetic eld H and by mechanical

m (T<sub>am</sub> ;H )

stresses P has been studied in Refs [108-111, 198, 206, 239-245]. The T vs. P and T vs. H phase diagrams of som  $e N i_{2+x} M n_{1-x} G a$  alloys have been calculated in Refs [198, 206, 239, 240, 242-245].

There are two reasons why a magnetic eld shifts the martensitic transition temperature. The st is the displacem ent of the phase transition line caused by changes in the free energies (12) of the austenitic and martensitic phases in the presence of a magnetic eld. The second reason is the change in the therm odynam ic equilibrium tem perature of the austenitic and martensitic phases in a magnetic eld. The rst factor changes the phase transition tem perature only slightly but considerably narrows the hysteresis of the martensitic transition in relatively weak magnetic elds [202, 206, 239]. This happens because the energy of the magnetoelastic interaction is low compared to the Zeem an energy already in elds of severalkOe. The second factor can signi cantly change the phase transition temperature. It is this e ect that we will now consider.

Experimenters usually measure the temperatures of the beginning of the martensitic ( $T_{m\,a}$ ) and austenitic ( $T_{am}$ ) transformations. Their dependence on the magnetic eld strength can be found from the phase equilibrium condition (the Clausius{ Clapeyron equation) [109]. At T =  $T_{am}$  the phase equilibrium condition can be written as

Here,  $_{a,m}$  are the therm odynam ic potentials of the austenitic and martensitic phases, M  $_{a,m}$  and V  $_{a,m}$  are the magnetizations and the volum es of these phases,  $_{C;s}$  are additional energies related to the emergence of additional stresses due to phases matching at the austenite{ martensite twin boundaries and to the surface energy of these twin boundaries, and (Y) = Q (T  $T_{\rm m}$ )=T\_m, with Q and  $T_{\rm m}$  are, respectively, the latent heat and the tem perature of the phase transform ation.




FIG.20: Experim ental and theoretical dependencies  $T_{am}$  (H ) and  $T_{m\ a}$  (H ) for the N $\pm_{15}M$   $n_{0:81}Fe_{0:04}Ga$  alloy [109]. The solid lines represent the theoretical results and the black squares the experim ental data.

To nd the unknown quantities  $M_{a,m}$  and  $T_m$  in Eqn (48), Cherechukin et al. [109] used the results of m inimization of the free energy (12) with allowance for the Zeem an term  $M_Z H$ . Figure 20 shows the eld dependencies of temperatures  $T_{m,a}$  and  $T_{am}$  calculated by using Eqn (48) with the numerical values of the parameters in the expression for the free energy (12) adopted by Cherechukin et al. [109]. Here we also sow the experimental results for a N  $i_{2:15}M n_{0:81}Fe_{0:04}G$  a alloy. C learly, there is good agreem ent between theory and experiment.

#### IX. CONCLUSION

Extensive studies of shape memory ferrom agnets has led to the discovery of a new mechanism of controlling the size and shape of a solid by subjecting the samples to a magnetic eld. The strains that develop as result of such action exceed the record values of magnetostrains in m agnetostrictors. There are already certain advances in the practical applications of shape m em ory ferrom agnets (see, e.g., Ref. [246]). The introduction of actuators and sensors whose operation is based on this class of materials requires, how ever, solving a whole range of problem s. Them ain factors here are the increase of durability of the m aterials, the reproducibility of reversible m agnetically induced strains, the study of the role of aging, etc. An im portant area of research of N  $i_{2+x+y}M n_{1-x} G a_{1-y}$  alloys is the study of ways of in proving the dynam ic characteristics of actuators and sensors whose operation is based on giant magnetically induced strains [140].

In conclusion we would like to note that, notwithstanding the enomous body of information that has already been gathered, some of the physical properties of Heusler alloys N  $i_{2+x+y}Mn_1 \ge Ga_1 \ge require$  further investigation. This is true, rst and foremost, of the phase diagram of the given ternary compound, the information about which is fragmentary [15, 141, 247, 248]. It would

be especially interesting to establish the main laws goveming the concentration dependence of magnetically induced strains in N $i_{2+x+y}$ M n<sub>1 x</sub> G a<sub>1 y</sub> alloys. Since many characteristics of N $i_{2+x+y}$ M n<sub>1 x</sub> G a<sub>1 y</sub> alloys depend on composition, it is in perative that the concentration dependencies of the anisotropy constant, elastic moduli, and other characteristics be measured. In the area of theory, further developm ent of the statistical model of phase transformations in N $i_{2+x+y}$ M n<sub>1 x</sub> G a<sub>1 y</sub> alloys is necessary so as to make it possible to model the speci c tem poral behavior of sam ples (the kinetics of the transformation) subjected to external stresses and magnetic elds [249, 250].
