G eneralized therm ostatistics based on deform ed exponential and logarithm ic functions

A bstract

The equipartition theorem states that inverse tem perature equals the log-derivative of the density of states. This relation can be generalized by introducing a proportionality factor involving an increasing positive function (x). It is shown that this assumption leads to an equilibrium distribution of the Boltzmann-G ibbs form with the exponential function replaced by a deformed exponential function. In this way one obtains a formalism of generalized therm ostatistics introduced previously by the author. It is shown that T sallis' therm ostatistics, with a slight modi cation, is the most obvious example of this form alism and corresponds with the choice (x) = x^q .

1 W hat is therm ostatistics?

See [1] for a conceptual foundation of them ostatistics. The presentation here emphasizes the role of the density of states.

A model of therm ostatistics is described by a density of states (E) and a probability distribution p(E), both functions of energy E. For a system in therm all equilibrium at temperature T, the probability distribution is given by the Boltzm ann-G ibbs expression

 with (1)

$$Z(T) = dE(E)e^{E-T}$$

(Boltzm ann's constant k_B is set equal to 1). Therm all averages are dended by

$$hfi = dE (E)p(E)f(E):$$

Conserved quantities, other than energy, m ight be important. It is tradition to give a simplied treatment involving only energy. To keep notations simple the temperature dependence of p(E) is not made explicit: p(E) stands for p(E;T).

A microscopic model of therm ostatistics is specified by an energy functional H () over phase space , which is the set of all possible microstates of the system. Using (E) dE = d the integration in expressions (2, 3) can be replaced by an integration over phase space

In the quantum case the integration is replaced by a trace over operators. The form ulas are

$$hfi = \frac{1}{Z(T)} Trexp(H=T)f \quad with$$

$$Z(T) = Tr exp(H=T):$$

Paraphrasing the words of C. T sallis during this conference, one can state that the Boltzm ann-G ibbs distribution is not just an exponential distribution, but that it is in portant that it is a sum over all states of phase space, and that the exponential contains energy divided by temperature. In particular, if a m icroscopic m odel reproduces the experimentally observed probabilities p() at one given temperature then one can predict their value at all other temperatures. This predictive power is the main asset of therm ostatistics.

2 W hy Boltzm ann-G ibbs?

In relevant examples of therm ostatistics the density of states (E) increases as a power law (E) E^{N} with N the number of particles and with > 0.

This increase in the density of states is essential to understand the paradox that according to the Boltzm ann-G ibbs distribution the ground state is always the most probable state. Still, one never observes that the molecules of the air in a class room lie all on the oor. Moreover, energy uctuations of a gas in equilibrium, away from any phase transition temperature, are negligible. The solution to the paradox is known as the entropy-energy balance. The increase of density of states (E) compensates the exponential decrease of probability density p(E). The maximum of the product (E)p(E) is reached at some macroscopic energy far above the ground state energy. Indeed, one can write

(E)
$$p(E) = \frac{1}{Z(T)} \exp(\log(E) = T)$$

The argum ent of the exponential function is maximal if E satis es

$$\frac{1}{(E)} {}^{0}(E) = \frac{1}{T}$$
(10)

 $(^{0}(E))$ is the derivative of (E) w.r.t. E). If $(E) = E^{N}$ then E' = NT follows, which is the equipartition theorem.

As a consequence of the equipartition theorem it is not easy to verify the Boltzm ann-G ibbs distribution experimentally. Indeed, the energy of the system under study is always equal to the value predicted by (10), with negligible uctuations. This indicates that the actual form of the probability distribution p(E) is not may established and, in fact, is not very essential. A lternative expressions forp (E) are acceptable provided they satisfy the equipartition theorem and reproduce therm odynamics. An indication of the need for a generalization of Boltzm ann-G ibbs is the ubiquitous use of tem perature-dependent H am iltonians in applied statistical physics. As stressed in the previous section, (1) predicts the probability density p(E) at all tem peratures. In many cases this prediction is not very accurate, probably because of an incom plete know ledge of the density of states (E). However, instead of making (E) tem perature-dependent, which is not supported by theory, one can as well try to replace the Boltzm ann-G ibbs distribution by another expression more appropriate for the problem at hand.

3 The basic postulate

The present generalization of therm ostatistics starts with generalizing the equipartition result (10). Let us postulate the existence of an increasing positive function (x), de ned for x = 0, such that

holds for all energies E and tem peratures T. Then the equation for the m aximum of (E)p(E) becomes

$$0 = \frac{d}{dE} \quad (E) p(E)$$

= ⁰(E) p(E) $\frac{1}{T} \quad (E) \quad (p(E)):$ (12)

This can be written as

$$\frac{{}^{0}(E)}{(E)} = \frac{1}{T} \frac{(p(E))}{p(E)};$$
(13)

The latter expression generalizes the equipartition theorem (10). The Boltzm ann-G ibbs case is recovered with (x) = x.

The postulate (11) xes the form of the probability distribution p(E). To see this, introduce a function, denoted ln (x), by

$$\ln (x) = \int_{1}^{Z^{x}} dy \frac{1}{(y)}$$
(14)

There are good reasons for calling this function a deform ed logarithm. If

(x) = x then it coincides with the natural logarithm log(x). Because (x) is positive for all positive x one has that ln(x) is negative for 0 < x < 1 and positive for x > 1. With some further technical conditions this function becomes a deformed logarithm in the sense of [2].

The inverse of the function ln (x) is denoted exp (x). From the identity $1=\exp^0$ (ln (x)) \ln^0 (x) follows

$$(x) = \exp^{0} (\ln (x)):$$
 (15)

Hence (11) can be written as

$$p^{0}(E) = \frac{1}{T} \exp^{0} [\ln (p(E))]:$$
 (16)

This expression can be integrated. The result is

$$p(E) = \exp (G (T) E = T)$$
: (17)

The function G (T) is the integration constant. It must be chosen in such a way that the norm alization condition

$$1 = dE (E)p(E)$$
 (18)

is satis ed. Positivity p(E) = 0 is autom atic because the range of the function exp (x) is the domain of $\ln (x)$, with possibly 0 and +1 added. Expression (17) resembles the Boltzm ann-G ibbs distribution (1). An important di erence is that the norm alization constant appears inside the function exp (x). In case (x) = x then one has G (T) = log (Z (T)).

Starting from (17) a generalized therm ostatistics can be developed \mid see [3]. M ost of the results that follow below are reform ulations of the results found in the rst part of [3]. The variational principle obeyed by (17) is not discussed below.

4 E scort probabilities

In general it is di cult to calculate the integration constant G (T). A useful expression for its temperature derivative can be obtained in terms of escort probabilities. They originate from [4] and have been introduced in Tsallis' therm ostatistics in [5]. The generalized de nition is

$$P(E) = \frac{1}{Z(T)} (p(E))$$
 (19)

with normalization factor

$$Z(T) = dE(E)(p(E)):$$
 (20)

Expectation values w .r.t. P (E) are denoted

$$hfi = dE (E)P(E)f(E)$$
: (21)

Note that P (E) coincides with p(E) in the Boltzm ann-G lbbs case (x) = x for all x.

Now calculate, using (15) and (19),

$$\frac{d}{dT}p(E) = \exp^{0}(G(T) E = T) \frac{d}{dT}G(T) + \frac{E}{T^{2}}!$$

$$= Z(T)P(E) \frac{d}{dT}G(T) + \frac{E}{T^{2}}!$$
(22)

From (18) and (22) follows

$$0 = {}^{Z} dE \quad (E) \frac{d}{dT} p(E)$$

= Z (T) $\frac{d}{dT} G (T) + \frac{1}{T^{2}} Z (T) hE i$: (23)

Hence one has

$$\frac{\mathrm{d}}{\mathrm{d}\mathrm{T}}\mathrm{G} \quad (\mathrm{T}) = \frac{1}{\mathrm{T}^2}\mathrm{h}\mathrm{E}\mathrm{i}: \tag{24}$$

For further use note that (22) and (24) together give

$$\frac{d}{dT}p(E) = \frac{1}{T^2}Z(T)P(E)(E - hEi):$$
(25)

5 Therm odynam ic relations

O ne goal of them ostatistics is to give a m icroscopic derivation of the laws of them odynam ics. This raises immediately the question in how far generalized them ostatistics is still compatible with them odynam ics.

Let us start with establishing therm alstability. Internal energy U (T) is dened by U (T) = hE i, with p(E) given by (17). Using (25) one obtains

$$\frac{d}{dT}U(T) = \sum_{Z}^{Z} dE \quad (E)E\frac{d}{dT}p(E)$$

$$= dE \quad (E)E\frac{1}{T^{2}}Z(T)P(E)(E hEi)$$

$$= \frac{1}{T^{2}}Z(T) hE^{2}i hEi^{2}$$
0: (26)

Hence, average energy is an increasing function of tem perature. However, therm al stability requires more. De ne -entropy (relative to (E)dE) by

$$S(p) = dE(E)[(1 p(E))F(0) F(p(E))]$$
(27)

with

$$F(x) = \int_{1}^{2x} dy \ln (y):$$
 (28)

Let us postulate that therm odynam ic entropy S (T) equals the value of the above entropy functional S (p) with p given by (17). Then one $\$ nds

$$\frac{d}{dT}S(T) = \begin{bmatrix} Z \\ dE \\ Z \end{bmatrix} (E) (In (p(E))) F (0)) \frac{d}{dT}p(E)$$

$$= dE (E) G (T) + \frac{E}{T} F (0) \frac{d}{dT}p(E)$$

$$= \frac{1}{T}\frac{d}{dT}U(T):$$
(29)

To see the latter use that $p \in J$ is norm alized to 1. This shows that tem perature T satis es the therm odynam ic relation

$$\frac{1}{T} = \frac{dS}{dU}$$
(30)

Because energy is an increasing function of temperature one concludes that entropy S is a concave function of energy U.This property is known as therm al stability.

O ne can introduce the Helm holtz free energy F (T) by the well-known relation F(T) = U(T) TS(T).From (29) follows that

$$\frac{d}{d}$$
 F (T) = U (T) with $=\frac{1}{T}$: (31)

Now let us come back to (24), which is very similar to (31), with F (T) replaced by TG (T) and with U (T) = hE i replaced by hE i. The comparison shows that TG (T) equals the free energy associated with the escort probability distribution P (E), up to a constant independent of tem perature T.

6 T sallis' therm ostatistics

The most obvious generalization of Boltzm ann-G ibbs therm ostatistics is obtained by the choice $(x) = x^q w$ if q > 0. It reproduces T sallis' therm ostatistics

tics with some m inor changes. The corresponding deformed logarithm ic and exponential functions are

$$\ln_{q}(\mathbf{x}) = \int_{1}^{2^{\mathbf{x}}} dy \, y^{q} = \frac{1}{1 q} \, x^{1 q} \, 1$$
$$\exp_{q}(\mathbf{x}) = [1 + (1 q)x]_{+}^{1=(1 q)} :$$
(32)

These have been introduced in [6]. The probability distribution (17) becomes

$$p(E) = [1 + (1 q)(G_q(T) E = T)]_{+}^{1 = (1 q)}$$
(33)

$$= \frac{1}{z_{q}(\Gamma)}^{h} (1 - q)_{q}(\Gamma) E_{+}^{i_{1=(1-q)}}$$
(34)

with

$$z_{q}(T) = (1 + (1 \quad q)G_{q}(T))^{1 = (q \ 1)} \quad \text{and} _{q}(T) = z_{q}(T)^{1 \quad q} = T:$$
(35)

Originally [7], (34) was introduced with q replaced by 2 q. The present expression was proposed in [8], be it with a di erent expression for $_{q}$ (T).

A nice feature of T sallis' them ostatistics is that the correspondence between p(E) and the escort P(E) leads to a dual structure, called the 'q 1=q'- duality [5,9]. Indeed, from

$$P(E) = \frac{1}{Z_{q}(T)} p(E)^{q} \quad \text{follow s} \quad p(E) = \frac{1}{Z_{1=q}(T)} P(E)^{1=q}$$
(36)

However, there exists also a 'q $\qquad 2$ q'-duality the origin of which has been clari ed in [2]. Given ln (x), a new deformed logarithm ic function ln (x) is obtained by

$$\ln (x) = (x \ 1)F \ (0) \ xF \ (1=x); \tag{37}$$

with (x) given by

$$\frac{1}{(x)} = F(0) \quad F(1=x) + \frac{1}{x} \ln \frac{1}{x} :$$
(38)

In case $(x) = x^q$ follows $(x) = (2 \ q)x^{2 \ q}$. Hence, the deformed logarithms $\ln_q(x)$ and $\ln_{2 \ q}(x)$ can be deduced from each other, up to a constant factor, by the relation (37).

Now note that the de nition (27) of entropy S (p) can be written as

$$S(p) = dE(E)p(E) \ln (1=p(E)):$$
 (39)

W ith $(x) = x^{q}$ this expression is T sallis' entropy

$$S_{q}(p) = {}^{Z} dE (E) \frac{1}{1 q} (p(E))^{q} p(E)):$$
 (40)

However, as noted above, (x) $x^{2 q}$ is needed. This leads to an expression for entropy with q replaced by 2 q. In the T sallis literature one has preferred to use always the same expression (40) for the entropy functional. Instead, the de nition of average energy has been changed [5] from hE i to hE i. For m ost physicists the latter change is unacceptable. During this conference F. Baldovin suggested to interchange the roles of p(E) and P(E) so that the need for changing the de nition of average energy disappears. This is what happened in the present paper.

7 Conclusions

It is possible to form ulate a generalized therm ostatistics in which the equipartition theorem holds in a modi ed form. Some aspects of therm odynamics, like therm all stability, are recovered. O ther aspects, like extensivity, have not been considered because they will not hold in the generalized context. In the presentation, the role of the density of states (E) has been emphasized. By doing so the link is made between probability distribution functions p(E) depending on energy E and the distributions p() depending on points in phase space.

The generalized form alism is determ ined by the choice of an increasing positive function (x), de ned for x 0. The standard form alism corresponds with (x) = x for all x. T sallis' therm ostatistics, with some m inor changes, corresponds with the obvious choice $(x) = x^q$. The function (x) can be used to de ne deform ed logarithm ic and exponential functions. The equilibrium probability distribution function p(E) is then a generalization of the Boltzm ann-G ibbs distribution, obtained by replacing the exponential function exp (x) by the deform ed exponential function.

O ne of the advantages of form ulating a rather general theory is that it claries some aspects of T sallis' therm ostatistics by putting them in a broader context. In particular, the 'q 1=q' and 'q 2q'-dualities have been discussed. The former one concerns the role of escort probabilities. The latter concerns

the observation that from each deformed logarithm one can deduce another deformed logarithm. Clarifying these points makes clear that there is no need to modify the de nition of average energy, as has been done in the recent T sallis literature. Rather one should replace T sallis' entropy $S_q(p)$ by $S_{2q}(p)$. In this way one obtains a formalism which is satisfactory both from a physical and from a mathematical point of view, and which can be generalized to a much broader scope when needed.
