GEOMETRY DEPENDENCE OF CASIM IR FORCES BEYOND THE PROXIMITY APPROXIMATION

Casim ir interactions between macroscopic objects are strongly in uenced by their geometrical features as shape and orientation as well as by their material properties. The e ect of geometry is commonly obtained from the proximity approximation (PA). Here we present a path integral quantization for the electromagnetic eld in the presence of deformed metallic surfaces. From the resulting e ective action the Casimir force between the surfaces can be calculated without the PA. For corrugated surfaces the force is obtained both perturbatively for small deformations and by a numerical approach for general deformation amplitudes. For general dielectric materials with at surfaces a path integral based derivation of the Lifshitz theory is outlined, pointing towards a possible approach to study the combined e ect of deformations and material properties.

1 Introduction and Sum m ary

Casim ir's sem inal prediction of an universal attractive force between two uncharged m etallic plates has been con m ed recently in the distance range from 100nm to severalm icrom eter with increasing accuracy in a number of beautifull high precision experim ents. 1;2;3;4;5;6;7 H igh accuracy could be only achieved by a careful inclusion of the corrections to Casim ir's ideal result from nite conductivity of the materials, surface roughness and non-zero temperature. Except one, 6 the above cited experiments deviate from the at-plate geometry in that they use a plane-sphere con guration in order to avoid the di culty of maintaining a constant plate separation over the entire surface area. The plane-sphere con guration is the standard situation where the proximity (or Derjaguin) approximation (PA) 9 is commonly employed to calculate geometry induced changes of the force. Consider a non-planar surface above a planar surface where their local distance, measured normal to the planar surface, is given by $H + h(y_k)$ with y_k the 2D in-plane coordinates, i.e., $h(y_k) = 0$ corresponds to two parallel at plates. The PA assum es that the Casim ir energy can be computed as the sum of local contributions between at surface elem ents at their local distance, yielding the total energy per unit surface area

where E_0 (H) = (2 =720)(~c=H 3) is the C asim ir energy per unit area between two plane surfaces. This approximation is ambiguous since one could just as wellm easure the local distances normal to the curved surface, yielding a dierent result. Below, we will discuss this point further when comparing the PA to our perturbative and numerical results. The PA is expected

to hold if both the local surface curvature radii are much larger than the local distance and strongly non-parallel surface elements are at larger separations than more parallel ones. A conceptual dierent approximation is the pairwise summation of renormalized retarded van der Waals forces. For the geometry considered here it yields exactly the PA result of Eq. (1). To for the plane-sphere geometry used in experiments, one can set h $(y_k) = y_k^2 = 2R$ with radius of curvature R, yielding the approximate force $F_{PA} = 2RE_0$ (H). The latter formula is used in experiments, and there it is justified for that R is much larger than H.

For more general geometries the collective nature of the Casim ir force suggests it to have a non-trivial and unexpected dependence on the shape of the interacting objects. Whereas the van der Waals force between electrically polarizable particles is always attractive, even the sign of the Casim ir force is geometry dependent. There is little intuition for the value of the sign as dem onstrated by the repulsive force for a thin conducting shell. 12;13 Due to the importance of Casim ir forces in many fundamental and applied contexts, it is highly desirable to obtain a better understanding of its strong geom etry dependence, including distinctions from pairwise additive interactions and possibly repulsive forces between disconnected surfaces. A promising and experim entally testable route to this end is via modications of the parallel plate geom etry. ¹⁴ In an experim ental search for novel shape dependencies, M ohideen et al. measured the force between a sphere and a sinusoidally corrugated plate with a wave length being larger than the studied range of sphere-plate separations. Their results showed clear deviations from the PA prediction. While it has been suggested that lateral forces caused this deviations 16, our results indicate a much stronger sensitivity to geometry at smaller corrugation wave lengths.




Figure 1. Geometry composed of a at and a corrugated surface which is studied by perturbation theory (a) and a numerical approach (b). For this two cases the corrections to the proximity approximation scale dierently to zero for increasing .

W e dem onstrate that a path integral quantization of the electrom agnetic eld subject to appropriate boundary conditions is a powerful method both for perturbative $^{14;10}$ and num erical 17 computations of C asim ir interactions. While the well-known boundary conditions for idealm etals are local, we derive non-local boundary conditions for general dielectric materials which reproduce the standard Lifshitz theory in the lim it of at surfaces. For the force between deformed surfaces of ideal metals we not the following results. For general uniaxial deform ations we obtained the C asim ir force perturbatively to second order in the deformation amplitude a. At this order, signicant deviations from the PA result are found if the deform ation wavelength is of the same order or smaller than the mean surface distance H. We apply the perturbative results to sinusoidally corrugated surfaces, see Fig. 1 (a). The deform ation H a slower decay induced change in the force shows for pared to the H 6 behavior from the PA. However, the perturbative approach is limited to the cases where a is smaller than both H and . This can be

understood by comparing the perturbative approach to the multiple scattering approach of Balian and Duplantier13 which yields the Casim ir energy as a sum over waves propagating along closed paths which scatter at an even number of positions on the surfaces. Each path contributes with a geometric factor which measures at each position the scattering direction relative to the local surface normal. For a series of scatterings on the same surface with all scattering directions being almost perpendicular to the surface normal the geom etric factor is small. Our perturbative approach allows in principle for paths with an arbitrarily large number of scatterings. However, it corresponds to an expansion of the geom etric factor to second order in the surface deform ations. This am ounts to the restriction to two successive scatterings on one surface before the wave propagates to the other surface and experiences for the rest of its path only scatterings normal to the surface. This expansion is only justiled for surface geometries where a is smaller than so that the scattering directions lie nearly in the mean surface plane. The restriction can be bypassed by an exact evaluation of the path integral by an algorithm which was developed for corrugated surfaces. This numerical approach is applied to the rectangular grating of Fig. 1 (b). It con mms the crossover of the force change from a decay H^{-6} to H^{-5} at $H^{-\prime}$. In the \lim it of . a strong corrections to the perturbative results are found. For ! 0 the force corresponds to that of two planar plates at a reduced distance H a and provides an upper bound to the force at xed H . For large both the perturbative and the num erical results approach the PA prediction. However, we nd that corrections to the PA decay slower with increasing =a for the pro le with edges [Fig.1 (b)] as compared to the smooth pro le [Fig.1 (a)]. For this nding we provide an interpretation in terms of classical ray optics 18.

2 Path Integral Approach

Due to the lack of space we give only a very brief account of the path integral approach and focus instead on explicit results for corrugated surfaces. For the uniaxial geometries considered here, the electrom agnetic eld can be split into transversal electric (TE) and magnetics (TM) modes which can both be

described by a scalar eld . After a W ick rotation to imaginary time, the eld is quantized using the Euclidean action

The change in the ground state energy due to the presence of boundaries depends on the type of modes. TM modes are described by D irichlet boundary conditions, $j_S=0$, and TE modes correspond to Neumann boundary conditions, θ_n $j_S=0$, where θ_n is the normal derivative on the surface pointing into the space between the plates. The C asim ir interaction between the two surfaces due to TM modes can be obtained from the restricted partition function

where Z $_0$ is the partition function in the absence of boundaries. For TE m odes one obtains Z $_{\text{TE}}$ by replacing the argument of the delta-function by $@_n$ (X). The position of the surfaces are parameterized in the 4D Euclidean space by X $_1$ = [y;h(y_k)], X $_2$ = [y;H], y = (ict y_;y_k), where H is their mean distance, and the upper surface is planar. The partition functions can be computed by expanding the delta-functions as [(X)] = D exp[i $_S$ dX] with an auxiliary eld de ned on each surface. Via the relation F = \sim c=(AL)@H ln Z, with L the Euclidean system size in time direction, one nds for the force F per unit area the result

This formula holds separately for both types of modes. For TM and TE modes, respectively, the 2-2 m atrix kernel read

with G $(y;z) = (y^2 + z^2)^{-1} = 4^{-2}$ the free G reen's function. Below, we will evaluate the force from Eq. (4) both perturbatively in h (y_k) and numerically.

So far we applied the path integral approach only to ideal metal surfaces. If one assumes a splitting into TE and TM modes, arbitrary dielectric surfaces can be described by a path integral with non-local boundary conditions for the scalar eld 20 . Planar surfaces with dielectric function (!) are described by a mixed boundary condition which reads in momentum (k_0 ; k_k) representation

with = [$(ik_0)k_0^2 + k_k^2$] $^{1=2}$ and = (ik_0) [$(ik_0)k_0^2 + k_k^2$] $^{1=2}$ for TM and TE m odes, respectively. In the lim it of idealm etals, ! 1, this condition reduces to the above treated D irichlet and Neum ann boundary condition for TM and

TE m odes, respectively. The condition of Eq. (6) together with the action of Eq. (2) provide a simple derivation of the standard Lifshitz theory. 21 M ore interestingly, the application of more general non-local boundary conditions to gauge eld path integrals m ight prove useful for studying correlations between geom etrical and material dependencies of C asim ir forces.

3 Perturbative Results

The logarithm of the partition function of Eq. (3) can be expanded in the height pro le. 19 W ith the choice that $d^2y_kh(y_k)=0$ there is no contribution at linear order in $h(y_k)$. At second order the H-dependent part of $\ln Z$ has the form

with a kernelK which is di erent for TM and TE m odes. 10 From this general result the force for the sinusoidal geometry of Fig. 1(a) can be computed. A ssum ing h (y_k) = a cos(2 y_1 =), the total force from TM and TE m odes assumes the form

with F $_{\rm at}$ = (2=240)~c=H 4 the force per unit area between two at plates. A lthough the full form of the function G (H =) is available $^{14;10}$, we focus here on two limiting cases. For small and large corrugation lengths , one nds

Therefore, for small the change of the force decays only like H $^{-1}$ as compared to H $^{-2}$ in the previously known limit of large for which the PA is expected to hold. The divergence for small is an artifact of the perturbative approach as we will show below. Next we compare these results to the predictions of the PA.D epending on which surface this approximation is based, one obtains from Eq. (1) to second order in a for the force

for the at and cornugated plate based PA, respectively. As expected, the later result is smaller due to the increased surface separations when measured normal to the cornugated plate. For $\ ! \ 1$ both results coincide and agree also with the perturbative inding. It is instructive to study how the dierence between the full perturbative result of Eq. (8) and the PA decays to zero at

large. For this dierence we not the following expressions which have opposite sign,

Thus, the at surface based PA overestim ates the force while the corrugated surface based PA yields a force which is too small. This underlines the ambiguity of the PA, even for large or small surface curvature. Similar observations have been made for a sphere-plane geometry. However, even the exponent of a can depend on details of the corrugated surface. As we will show below, for the rectangular corrugation of Fig. 1 (b) the decay towards the PA result is slower as for the present geometry. In the next section we provide an explanation of this strong geometry sensitivity in terms of geometric optics.

4 Exact Numerical Results

We have seen that the perturbative approach is \lim ited to smooth surface proles where the deform ation am plitude a sets the smallest of the geometrical length scales. The condition for the applicability of perturbation theory is that two arbitrary points on the deformed surface are connected by a vector which is nearly parallel to the reference plane. This is certainly not true for the prole of Fig. 1(a) if a but is more generally violated if the prole has vertical segments as it is the case for the rectangular corrugation of Fig. 1(b). For the latter prole, the perturbative expression of Eq. (7) indeed diverges. However, the general result of the path integral approach, Eq. (4), can be used for a precise numerical computation of the force even in cases where perturbation theory fails. For periodic proles one can apply the following approach. First, the Fourier transformed kernel M $(y;y^0)$ of Eq. (5) is decomposed into contributions from momenta which are integer multiples of 2 = 1, i.e.,

with $p_? = (p_0; p_2)$. The 2 2 m atrices N_m are completely determined by a given uniaxial surface pro leh (y_1) . Using Eq. (4), the force per unit area can be then obtained from

where the lower case symbol tr denotes a partial trace with respect to the discrete indices k, l, and the matrix B is given by $B_{kl}(p_2; p_1) = N_{k-1}(p_2; p_1 +$

 $2~\rm l=$) with the N $_m$ de ned by Eq. (12). In the following, we will apply this form ula to the pro $\rm le$ of Fig. 1 (b) for which the matrices N $_m$ can be obtained analytically. 17

For ! 0, i.e., if is the smallest length scale, the function $g(p_2; p_1)$ can be calculated analytically, leading to $g(p_2; p_1) = 2p = (e^{2p(H-a)} - 1)$ for both TM and TE modes. A firer insertion into Eq. (13), one nds the simple result

for the force from TM or TE m odes, respectively. This result can be obviously interpreted as the force between two planar plates at a reduced distance H $\,$ a which rejects that the relevant modes do not "feel" the narrow valleys of the projet in the limit $\,$ a; H $\,$ a. In the opposite limit of very large , the PA should be reliable, with the result

for both TM and TE m odes. Here the PA yields the same result for the at and the corrugated surface based approximation.




Figure 2. Casim ir force F_{TM} from TM modes for the geometry of Fig.1(b). (a) Relative change compared to the force between two at plates for dierent corrugation lengths . (b) Crossover between the proximity approximation at large <code>Eq.(16)</code>] and the reduced distance result of Eq. (15) at small .

For all interm ediate values of , the force can be calculated num erically from Eq. (13) by de ning the M -th order approximation g_M ($p_?$; p_1) to the function $g(p_?$; p_1) by truncating the matrix B_{k1} symmetrically around (k; l) = (0;0) at order M so that the trace in Eq. (14) extends only over k, l= (M 1)=2;:::; (M 1)=2. This in turn, by numerical integration of Eq. (13), yields a series of forces which can be extrapolated to the actual force at M ! 1 .

The results for TM modes have been obtained in Ref. 17 and are shown in Fig. 2. The force F_{TM} at xed H =a is found to be monotonous in =a and its minimal value is given by the PA result F_{PA} of Eq. (16). At small =a the exact result of Eq. (15) is recovered, and the divergence seen in perturbation theory, Eq. (9), is removed. However, in agreement with perturbation theory for the sinusoidal prole, the relative change F_{TM} =F at 1 of the force shows a crossover at 'H from a H 2 decay at H. to a H 1 decay at larger H. Fig. 2(b) shows how the limits of Eqs. (15), (16) are approached with decreasing or increasing at xed H =a. In the range of studied values for H =a the crossover between the two limits appears at =a of order 10. As shown by the inset of Fig. 2(b) for H =a = 10, we not that the corrections to the results of Eqs. (15), (16) obey power laws,

for =a 1 and =a 1, respectively. For TE modes we expect in the rst case a decay (=a)¹⁼² while in the latter case the exponent will be the same as for TM modes. Comparing to Eq. (11) we observe that the PA \lim it is approached with a dierent exponent for large. This scaling behavior can be understood from classical ray optics. Following a recently proposed "optimal" PA for a scalar ekl^{18} , the Casimir energy is not obtained from the normal distance based on one of the surfaces [cf. Eq. (1)] but from the shortest surface-to-surface ray (of length ' $(y_k;z)$) through given positions $(y_k;z)$ between the two surfaces of area A,

Of course, this is still an approximation even for small surface curvature since the surfaces are treated as locally at. However, we expect that this approxim ation yields the correct scaling behavior for large =a. For the rectangular corrugation the lengths of the shortest paths can be computed analytically. For smalla=H the dominant deviation from the standard PA comes from rays through positions located in equal sectors of alm ost triangular cross section for which the rays end exactly on the upper edges of the corrugated prole. For large the volume of a sector becomes independent of . In this case, a simple calculation yields, using Eq. (18), the correction to the PA force, $(F_{opt} F_{PA}) = F_{at} = \frac{112}{9} \frac{P}{a = H} =$, which reproduces our num erically observed decay a= of Eq. (17). How can this be reconciled with our perturbative result of Eq. (11) for the sinusoidal pro le? The crucial point is that the latter pro le has a nite slope across the entire surface. Thus, the shortest length 'deviates for all positions between the surfaces from the distance used in the standard PA. Using Eq. (18), a model calculation for a corrugation with a piecewise constant slope indeed reproduces a decay correction to the standard PA result.




Figure 3. Ratio of the Casim ir force from TM and TE m odes, respectively, for the geometry of Fig. 1 (b).

So far, we presented num erical results for TM modes only. For TE modes the same approach can be applied to the matrix of Eq. (5). The full electrodynam ic C asim ir force is then obtained as $F_{\,\text{T\,M}}\,+\,F_{\,\text{T\,E}}$. Instead of presenting the results for TE modes independently, it is more useful to look at their relative contribution compared to TM modes. Fig. 3 displays the ratio $F_{TM} = F_{TE}$ of the force from TM and TE modes for dierent corrugation lengths. Since the force is again bounded from below by F_{PA} and from above by F_0 , one has $F_{TM} = F_{TE} ! 1$ for both =a! 1 and =a! 0. However, for intermediate corrugation lengths the ratio can dier from one, with the amount depending on the mean surface distance ${\tt H}$. We observe the tendency that ${\tt TM}$ mode contributions dominate at smaller while for larger the TE modes provide a larger force. In contrast, for a sinusoidal pro le the force from TM modes is larger at all , at least to second order in a. For very small separations H & a the segments of the rectangular corrugation which are closer to the at surface yield the main contribution and the PA is expected to hold, implying 1 which indeed can be observed in Fig. 3. In the opposite case of $F_{TM} = F_{TE}$ large H a, one obtains the at plate geom etry, and again $F_{TM} = F_{TE} ! 1$. The latter \lim it is approached for both types of corrugations w ith a power law $(H = a)^{1}$ which we not in perturbation theory as well as in the numerical approach.
