# GEOM ETRY DEPENDENCE OF CASIM $\mathbb{R}$ FORCES BEYOND THE PROXIM ITY APPROXIMATION

#### Abstract

C asim ir interactions betw een m acroscopic ob jects are strongly in uenced by their geom etrical features as shape and orientation as w ell as by theirm aterialproperties. $T$ he e ect of geom etry is com $m$ only obtained from the proxim ity approxim ation (PA). H ere we present a path integral quantization for the electrom agnetic eld in the presence of deform ed $m$ etallic surfaces. From the resulting e ective action the C asim ir force betw een the surfaces can be calculated w ithout the PA. For corrugated surfaces the force is obtained both perturbatively for sm alldeform ations and by a num erical approach for general deform ation am plitudes. For general dielectric m aterials $w$ ith at surfaces a path integralbased derivation of the L ifsh itz theory is outlined, pointing tow ards a possible approach to study the com bined $e$ ect of deform ations and $m$ aterial properties.


## 1 Introduction and Sum m ary

C asim ir's sem inal prediction of an universalattractive force betw een tw o uncharged $m$ etallic plates has been con $m$ ed recently in the distance range from 100 nm to severalm icrom eter wher theasing accuracy in a num ber of beautifulhigh precision experim ents by a careful inclusion of the corrections to C asim ir's ideal result from nite, conductivity. of the m aterials, surface roughness and non-zero tem peraturei' E xœept one, ' $'$ ' the above cited experim ents deviate from the at-plate geom etry in that they use a plane-sphere con guration in orderto avoid the di culty of $m$ aintaining a constant plate separation over the entire surface area. The plane-sphere con guration is the standard situation where the proxim ity (or D erjaguin) approxim ation (PA) ' is comm only em ployed to calculate geom etry induced changes of the force. C onsider a non-planar surface above a planar surface where their local distance, $m$ easured norm al to the planar surface, is given by $H+h\left(y_{k}\right) w$ ith $y_{k}$ the 2D in-plane coordinates, i.e., $h\left(y_{k}\right)=0$ corresponds to two parallel at plates. T he PA assum es that the $C$ asim ir energy can be com puted as the sum of local contributions betw een at surface elem ents at their local distance, y ielding the totalenergy per unit surface area

where $E_{0}(H)=\quad\left({ }^{2}=720\right)\left(\sim c=H^{3}\right)$ is the C asim ir energy per unit area betw een two plane surfaces. This approxim ation is am biguous since one could just as w ellm easure the localdistances norm al to the curved surface, yielding a di erent result. Below, we will discuss this point further when com paring the PA to our perturbative and num erical results. T he PA is expected
to hold if both the local surface curvature radii are much larger than the local distance and strongly nop-parallel surface elem ents are at larger separations than $m$ ore parallel ones $1^{111}$ A conceptual di erent approxim ation is the pairw ise sum $m$ ation of renorm alized retarded van der $W$ aals forces ${ }^{8 / 4}$ For the geom etry considered here it yields exactly the PA result of Eq. (11) 12 For the plane-sphere geom etry used in experim ents, one can set $h\left(y_{k}\right)=y_{k}^{2}=2 R$ with radius of curvature $R$, yielding the approxim ate force $F_{P A}=2 R E_{0}(H)$. The latter formula is used in experim ents, and there it is justi ed for that $R$ is m uch larger than $H$

For $m$ ore general geom etries the collective nature of the $C$ asim ir force suggests it to have a non-trivial and unexpected dependence on the shape of the interacting ob jects. W hereas the van der $W$ aals force betw een electrically polarizable particles is alw ays attractive, even the sign of the C asim ir force is geom etry dependent. There is little intuition for the value of the sign as dem onstrated by the repulsive force for a thin conducting shell $1^{121} 12.1$ D ue to the im portance of $C$ asim ir forces in $m$ any fundam ental and applied contexts, it is highly desirable to obtain a better understanding of its strong geom etry dependence, including distinctions from pairw ise additive interactions and possibly repulsive forces betw een disconnected surfaces. A prom ising and experim entally testable route to this end is via $m$ odi cations of the parallelplate geom etry $1^{14}$ In an experim entalsearch fornovelshape dependencies, $M$ ohideen et al. $m$ easured the force between a sphere and a sinusoidally cornugated plate with a-wave length being larger than the studied range of sphere-plate separations ${ }^{151}$ Their results showed clear deviations from the PA predirtion. W hile it has been suggested that lateral forces caused this deviation ${ }^{1}{ }^{1}=$, our results indicate a much stronger sensitivity to geom etry at sm aller corrugation w ave lengths.

W e dem onstrate that a path integralquantization of the electrom agnetic eld sub ject to appanpriate boundary, conditions is a pow erfulm ethod both for perturbative $\frac{14120}{4}$ and num erical 17 com putations of $C$ asim ir interactions. W hile the well-know $n$ boundary conditions for idealm etals are local, we derive non-localboundary conditions forgeneraldielectricm aterials w hich reproduce the standard Lifshitz theory in the lim it of at surfaces. For the force betw een deform ed surfaces of ideal $m$ etals we nd the follow ing results. For general uniaxial deform ations we obtained the C asim ir foroe perturbatively to second order in the deform ation am plitude a. At this order, signi cant deviations from the PA result are found if the deform ation wavelength is of the sam e order or sm aller than the $m$ ean surface distance H.We apply the perturbative results to sinusoidally corrugated surfaces, see $F$ ig. ${ }^{-111}(a)$. T he deform ation induced change in the force shows for $H$ a slower decay $H^{5}$ compared to the H ${ }^{6}$ behavior from the PA. H ow ever, the perturbative approach is lim ited to the cases where $a$ is sm aller than both $H$ and. This can be

understood by com paring the perturbative approach to the m ultiple scattering approach of B alian and D uplantient which yields the C asim ir energy as a sum over w aves propagating along closed paths which scatter at an even num ber of positions on the surfaces. Each path contributes with a geom etric factor $w$ hich $m$ easures at each position the scattering direction relative to the local surface norm al. For a series of scatterings on the sam e surface with all scattering directions being alm ost penpendicular to the surface norm al the geom etric factor is sm all. O ur perturbative approach allow s in principle for pathsw ith an arbitrarily large num ber of scatterings. H ow ever, it corresponds to an expansion of the geom etric factor to second order in the surface defor$m$ ations. This am ounts to the restriction to tw o successive scatterings on one surface before the wave propagates to the other surface and experiences for the rest of its path only scatterings nom al to the surface. This expansion is only justi ed for surface geom etries where $a$ is sm aller than so that the scattering directions lie nearly in the $m$ ean surface plane. T he restriction can be bypassed by an exact evaluation of the path integralby an algorithm which w as developed for corrugated surfaces ${ }^{471} \mathrm{~T}$ his num erical approach is applied to the rectangular grating of F ig. $\mathrm{I}_{1}^{\prime \prime}(\mathrm{b})$. It con m s the crossover of the force change from a decay $H^{6}$ to $H^{5}$ at $\mathrm{H}^{\prime}$. In the lim it of . a strong corrections to the perturbative results are found. For ! 0 the force corresponds to that of tw o planar plates at a reduced distance $H \quad a \quad$ and provides an upper bound to the force at xed H. For large both the perturbative and the num erical results approach the PA prediction. H ow ever, we nd that corrections to the PA decay slowerwith increasing =a for the pro le with edges $\mathbb{F}$ ig $\left.{ }_{12}^{11}(b)\right]$ as com pared to the sm ooth pro le $\mathbb{F}$ ig ${\underset{1}{1}}_{1}^{1}(a)]$ - For this nding we provide an interpretation in term $s$ of classical ray optics $1^{18}$.

## 2 Path Integral A pproach

D ue to the, lack of space we give only a very brief account of the path integral approachis ${ }^{19}$ and focus instead on explicit results for corrugated surfaces. For the uniaxial geom etries considered here, the electrom agnetic eld can be split into transversalelectric (TE) and m agnetics (TM) m odes which can both be
described by a scalar eld. A fter a $W$ ick rotation to im aginary tim $e$, the eld is quantized using the Euclidean action

The change in the ground state energy due to the presence of boundaries depends on the type ofm odes. TM m odes are described by D irichlet boundary conditions, $j_{s}=0$, and TE m odes correspond to $N$ eum ann boundary conditions, $@_{n} j_{s}=0$, where $@_{n}$ is the norm alderivative on the surface pointing into the space betw een the plates. The C asim ir interaction betw een the tw o surfaces due to TM m odes can be obtained from the restricted partition function

where $Z_{0}$ is the partition function in the absence of boundaries. For TE m odes one obtains $Z_{\text {TE }}$ by replacing the argum ent of the delta-function by $@_{n}(X)$. The position of the surfaces are param eterized in the 4D Euclidean space by $X_{1}=\left[y ; h\left(y_{k}\right)\right], X_{2}=[y ; H], y=$ (ict $y 0 ; y_{k}$ ), where $H$ is their $m$ ean distance, and the upper surface is planar. So far we applied the path integral approach only to idealm etal surfaces. Ifone assum es a splitting into TE and TM m odes, arbitrary dielectric surfaces can be described by a path integralw th non-localboundary conditions for the scalar eld 2.2.'P lanar surfaces w ith dielectric function (!) are described by a $m$ ixed boundary condition which reads in $m$ om entum $\left(k_{0} ; k_{k}\right)$ representation

 interestingly, the application ofm ore generalnon-localboundary conditions to gauge eld path integralsm ight prove useful for studying correlations betw een geom etrical and $m$ aterial dependencies of $C$ asim ir foroes.

Therefore, for sm all the change of the foroe decays only like $H^{1}$ as com pared to $H^{2}$ in the previously known lim it of large forwhich the PA is expected to hold. The divergence for sm all is an artifact of the perturbative approach as we will show below. Next we com pare these results to the predictions of the PA. D epending on which surface this approxim ation is based, one obtains from Eq. (İ1) to second order in a for the force

for the at and corrugated plate based PA, respectively. A s expected, the later result is sm aller due to the increased surface separations when $m$ easured norm al to the cormugated plate. For ! 1 both results coincide and agree also w ith the perturbative nding. It is instructive to study how the di erence betw een the full perturbative result of Eq. (잉) and the PA decays to zero at
large . For this di erence we nd the follow ing expressions which have opposite sign,

Thus, the at surface based PA overestim ates the force while the corrugated surface based PA yields a force which is too sm all. This underlines the am biguIty of the PA, even for large or sm all surface clurvature. Sim ilar observations have been $m$ ade for a sphere-plane geom etry ${ }^{111}$ H ow ever, even the exponent of $\mathrm{a}=$ can depend on details of the corrugated surface. A s we w ill show below, for the rectangular corrugation of $F$ ig. $\overline{1}_{1}^{\prime}(\mathrm{b})$ the decay tow ards the PA result is slow er as for the present geom etry. In the next section we provide an explanation of this strong geom etry sensitivity in term s of geom etric optics.

## 4 E xact $N$ um erical $R$ esu lts

W e have seen that the perturbative approach is lim ited to sm ooth surface pro les w here the deform ation am plitude a sets the sm allest of the geom etrical length scales. The condition for the applicability of perturbation theory is that tw o arbitrary points on the deform ed surface are connected by a vector which is nearly parallel to the reference plane. This is certainly not true for the pro le of Fig . ${ }_{1}^{11}(\mathrm{l})$ if a but is m ore generally violated if the pro le has vertical segm ents as it is the case for the rectangular corrugation
 indeed diverges. H ow ever, the general result of the path integral approach, Eq. (4, $\underline{4}^{-1}$ ), can be used for a precise num erical com putation of the force even in cases where perturbation theory fails. T his result can be obviously interpreted as the force betw een tw o planarplates at a reduced distance $H$ a which re ects that the relevant $m$ odes do not "feel" the narrow valleys of the pro le in the lim it $a ; H \quad a$. In the opposite lim it of very large, the PA should be reliable, w th the result

 a series of forces which can be extrapolated to the actual force at $M \quad 1 \quad 1$.

The results for TM m odes have been obtained in Ref. $\mathrm{I}^{-1}$ ? and are shown in $F$ ig. its $m$ inim alvalue is given by the PA result $F_{P A}$ of Eq. (1]). At sm all =a the exact result of Eq. (1-5) is recovered, and the divergence seen in perturbation theory, Eq. $(\underline{1})$, is rem oved. H ow ever, in agreem ent w ith perturbation theory for the sinusoidalpro $l e$, the relative change $F_{T M}=F$ at 1 of the foroe show $s$ a crossover at ${ }^{\prime} \mathrm{H}$ from a H ${ }^{2}$ decay at H. to a H ${ }^{1}$ decay at larger
 decreasing or increasing at xed $H=a$. In the range of studied values for $\mathrm{H}=\mathrm{a}$ the crossover between the two lim its appears at $=\mathrm{a}$ of order 10. As show $n$ by the inset of $F$ ig. the results of Eqs. (15), (1] ) obey power law $s$,

(1111) we observe that the PA lim it is approached $w$ th a di erent exponent for large. $T$ his scaling behavior can be understood from classicalray optics. Follow ing a recently proposed "optim al" PA for a scalar eld ${ }^{81}-1$, the $C$ asim ir energy is not obtained from the norm al distance based on one of the surfaces [cf.E q. [ $[1])$ ] but from the shortest surface-to-surface ray (of length ${ }^{\prime}\left(y_{k} ; z\right)$ ) through given positions $\left(y_{k} ; z\right)$ betw een the tw o surfaces of area A,

O fcourse, this is stillan approxim ation even for sm all surface curvature since the surfaces are treated as locally at. H ow ever, we expect that this approxim ation yields the correct scaling behavior for large $=a$. For the rectangular corrugation the lengths of the shortest paths can be com puted analytically. Forsm all $a=H$ the dom inant deviation from the standard PA com es from rays through positions located in equal sectors of alm ost triangular cross section for which the rays end exactly on the upper edges of the corrugated prole. For large the volum e of a sector becom es independent of. In this case, a simple calculation yields, using Eq. (1 $\overline{1} \bar{q}_{1}^{\prime}$ ), the correction to the PA force, ( $F_{\text {opt }} \quad F_{P_{A}}$ ) $=F$ at $=\frac{112}{9}, \frac{a}{a} \mathrm{H} a=$ which reproduces our num erically observed decay $a=$ of Eq. $(1, \eta)$. How can this be reconciled $w$ ith our perturbative result ofE q. (111) for the sinusoidalpro le? The crucialpoint is that the latter pro le has a nite slope across the entire surface. $T$ hus, the shortest length ' deviates for allpositions betw een the surfaces from the distance used in the standard PA. U sing Eq. (1-1), a model calculation for a corrugation w ith a piecew ise constant slope indeed reproduces a decay $(a=)^{2}$ of the correction to the standard PA result.

So far, we presented num erical results for TM m odes only. For TE m odes the sam e approach can be applied to the $m$ atrix ofE q. ( $(\underset{5}{\prime})$. T he fullelectrodynam ic $C$ asim ir force is then obtained as $\mathrm{F}_{\mathrm{TM}}+\mathrm{F}_{\mathrm{TE}}$. Instead of presenting the results for TE m odes independently, it is m ore useful to look at their relative contribution com pared to $T M$ m odes. $F$ ig. ${ }_{1}^{-3}$ displays the ratio $F_{T M}=F_{T E}$ of the force from TM and TE m odes for di erent corrugation lengths. Since the force is again bounded from below by $\mathrm{F}_{\mathrm{PA}}$ and from above by $\mathrm{F}_{0}$, one has $\mathrm{F}_{\mathrm{TM}}=\mathrm{F}_{\mathrm{TE}}$ ! 1 for both $=\mathrm{a}!1$ and $=\mathrm{a}!0$. H ow ever, for interm ediate corrugation lengths the ratio can di er from one, $w$ ith the am ount depending on the $m$ ean surface distance $H . W$ e observe the tendency that TM m ode contributions dom inate at sm aller while for larger the TE m odes provide a larger force. In contrast, for a sinusoidal pro le the force from TM m odes is larger at all , at least to second order in a. For very sm all separations H \& a the segm ents of the rectangular corrugation which are closer to the at surface yield the $m$ ain contribution and the PA is expected to hold, im plying $\mathrm{F}_{\mathrm{TM}}=\mathrm{F}_{\mathrm{TE}} \quad 1$ which indeed can be observed in F ig large $H \quad a$, one obtains the at plate geom etry, and again $F_{T M}=F_{T E}!1$. The latter lim it is approached for both types of corrugationsw ith a pow er law
$(H=a)^{1}$ which we nd in perturbation theory as well as in the num erical approach.
