Phase-Transition in Binary Sequences with Long-R ange Correlations

M otivated by novel results in the theory of correlated sequences, we analyze the dynamics of random walks with long-term memory (binary chains with long-range correlations). In our model, the probability for a unit bit in a binary string depends on the fraction of unities preceding it. We show that the system undergoes a dynamical phase-transition from normal di usion, in which the variance D_L scales as the string's length L, into a super-di usion phase (D_L L^{1+j}), when the correlation strength exceeds a critical value. We demonstrate the generality of our results with respect to alternative models, and discuss their applicability to various data, such as coarse-grained DNA sequences, written texts, and nancial data.

D ynam ical system s with long-range spatial (and/or tem poral) correlations are attracting considerable interest across m any disciplines. They are identi ed in physical, biological, social, and econom ic sciences (see e.g., [1-6] and references therein). Of particular interest are situations in which the system can be m apped onto a m athem atical object, such as a correlated sequence of sym bols, preserving the essential statistical properties of the original system.

O ne of the m ethods m ost frequently used to obtain insight into the nature of correlations in a dynam ical system consists of mapping the space of states onto two symbols [5]. Thus, the problem is reduced to the exploration of the statistical properties of correlated binary chains. This can also be viewed as the analysis of a history-dependent random walk. Random walk is one of the m ost ubiquitous concepts of statistical physics. It lends applications to num erous scientic elds (see e.g., [7{13] and references therein).

It is well established that the statistical properties of coarse-grained DNA strings and written texts significantly deviate from those of purely random sequences [2,14]. Financial data (such as stock market quotes) are similarly far from being pure-di usive. Moreover, these systems exhibit \super-di usive" behavior in the sense that the variance D (L) grows a sym ptotically faster than L (where L is the length of the considered text). Specifically, D L, with > 1 [5]. Such a remarkable (and essentially universal) phenom enon can be attributed to long-range positive correlations. System s with such correlationsm ay be anticipated to exhibit a dynam icalphase transition (from norm al to super di usive behavior) at som e critical correlation strength.

Thus, the problem of random walk where the jumping probabilities are history-dependent is of great interest for understanding the behavior of system s with long-range correlations, such as DNA strings, written texts, and – nancial data. The aim of the present Letter is to analyze this problem, and to provide a simple yet generic analytical description of the statistical properties of these system s.

We begin by solving a simple model which incorporates long-range correlations into an otherwise random sequence. We consider a discrete binary string of sym – bols, $a_i = f0;1g$, in which the conditional probability of a given symbol (say, a unit bit) occurring at the position L + 1 is history-dependent, and given by

where k is the number of such symbols (unities) appearing in the preceding L bits. The correlation parameter , where 1 < < 1, determ ines the strength of correlations in the system. The persistence condition > 0 implies that a given symbol in the preceding sequence promotes the birth of a new identical symbol. On the other hand, in the anti-persistence region < 0, each symbol inhibits the appearance of a new identical sym - bol. The parameter $L_0 > 0$ is a constant transient time. For L L_0 the sequence is approximately random (uncorrelated), whereas for L L_0 the e ect of correlations takes over [15].

In thism odel, the conditional probability $p(k;L;;L_0)$ depends on the fraction of unities (or zeroes) in the preceding bits, and is independent of their arrangement. This allows one to obtain an analytical description of the system's dynamical behavior. As we shall demonstrate below, this simple model provides a good quantitative description of the observed statistical properties of various natural systems, such as coarse-grained DNA strings, written texts, and nancial data.

The probability P (k; L + 1) of nding k identical sym bols (say, unities) in a sequence of length L + 1 follows the evolution equation

C rossing to the continuous lim it, one obtains the Fokker-P lanck di usion equation for the correlated process

where x 2k L. The evolution equation (3) along with the initial condition P (x;t= 0) = (x), has a solution in the form of a Gaussian distribution

where the variance D (L) is given by

E quation (5) breaks down at the special case $=\frac{1}{2}$, in which case the variance is given by

D (L; _c;L₀) = (L + L₀) ln
$$\frac{L + L_0}{L_0}$$
 : (6)

Remarkably, one nds that the correlated system undergoes a dynamical phase transition at the critical correlation strength $_{\rm c}$ $\frac{1}{2}$. The variance D (L) of the correlated sequence has three qualitatively di erent asymptotic behaviors (in the L L_0 lim it)

Thus, for $< _{\rm c}$ the asymptotic variance scales linearly with the string length, whereas for a history-dependent chain with strong positive correlations ($> _{\rm c}$) the system is characterized by a super-di usion phase, in which case D (L) grows asymptotically faster than L [16].

The analytical model can readily be extended to encompass situations in which the binary sequence is biased. Let

with 1 < q < 1. The distribution P (x;L) corresponding to this conditional probability is given by a G aussian function, centered about the position

Thus, the drift velocity approaches an asymptotically constant value $\frac{q}{1}$. The variance D (L), unaltered by the bias is given by Eqs. (5) and (6).




FIG. 1. The scaled variance L 1 D (L) as a function of the string length L. We present results for = 0.8; 0.4;0;0.2;0.5;0.8, and 0.9 (from bottom to top), with L₀ = 100. The num erically computed asymptotic slopes agree with the analytical predictions [see Eqs. (5) and (6)] to within less than 1%.

In order to con m the analytical results, we perform numerical simulations of (discrete) binary sequences. Figure 1 displays the resulting scaled variance L ${}^{1}D$ (L) of correlated strings with various di erent values of the correlation parameter . We nd an excellent agreem ent between the analytically predicted results [see Eqs. (5) and (6)] and the numerical ones.

Robustness of the linear model.{ In order to show the generality of the model discussed above, we consider situations in which the (history-dependent) jump probability is an arbitrary odd function [17] of the fraction $\frac{x}{L+L_0}$ of unities (zeroes) that appeared in the previous L symbols




FIG.2. The scaled variance L ${}^{1}D$ (L) for three di erent forms of the function F (): , ${}^{2}\sin(\frac{1}{2})$, and $\tanh()$. We present results for = 0.8 and = 0.8, with L₀ = 100. The di erent curves are alm ost indistinguishable.

For asymptotically large L, one always nds ! 0 for non-ballistic di usion, justifying a power-law expansion of F (). As long as this expansion includes a linear term, the original di erential equation (3) is recovered for large L. We therefore expect the previous analytical results [Eqs. (5) and (6)] to hold true for generic (non-linear) m odels as well. The generality of the m odel is illustrated in Fig. 2, in which we depicts results for various choices of the probability function F (). As predicted, the results are found to agree with the linear m odel.

A pplications.{ The robustness of the linear model (see Fig. 2) suggests that it may capture the essence of the underlying correlations in a diversity of system s in nature. We therefore exam ine the use of the results derived in the present work as an analytical explanation for the observed statistical properties of natural system s, such as DNA strings, written texts, and nancial data.

As mentioned, it is well established that these systems often exhibit a signi cant deviation from random sequences [2,14], and are characterized by a \superdi usive" behavior in which D L, with > 1 [5]. In such systems, super-di usion may be attributed to long-range (positive) correlations. In fact, the analytical

m odel allows one to determ ine the correlation strength of these chains.




FIG.3. The scaled variance L ${}^{1}D$ (L) as a function of the string length L, for coarse-grained DNA sequences of various organism s. The mapping and parameters used are given in Table I. Theoretical results [see Eq. (5)] are represented by curves.

Figure 3 depicts the scaled variance L ${}^{1}D$ (L) calculated from DNA sequences of various organisms, as a function of the string length L. It is of considerable interest to exam ine in such methods the statistical properties characterizing the DNA of organisms in various evolutionary levels: Bacillus subtilis (Bacteria), Methanosarcina acetivorans (Archaea), and Drosophila melanogaster (Eukarya) [5,18]. The theoretical model provides a good description of the empirical data [19], attributing di erent correlation strengths to di erent organisms, as sum marized in Table I.

The super-di usive behavior, shown in Fig. 3 to persist across very long sequences is highly suggestive of long-range correlation extending overmore than one gene (e.g., $5 ext{ 10}$ base-pairs in D rosophila).

Next, we have applied the results of the analytical model to various coarse-grained written texts [2,14,5]. It has long been recognized that the corresponding binary strings are highly self-correlated. The present analytical model enables one to determ ine quantitatively the strength of these inner correlations; see Table I.




FIG.4. The scaled variance L 1 D (L) as a function of the sequence length L, for coarse-grained nancial data: DJIA and NASDAQ daily quotes [20]. The mapping and parameters used are given in Table I. Theoretical results [see Eq. (5)] are represented by curves.

In Figure 4 we show the scaled variance of coarsegrained nancial data (daily quotes of the Dow Jones Industrial Average, and the NASDAQ [20]). We note that the linear m odel underestim ates the empirical variance at short time scales. This fact can be traced back to short-term correlations in the markets. (It is interesting to note that the DJIA maintains an approximately normaldi usive behavior for a period of about one month). How ever, this short-term memory is washed out at longer time scales, in which case the analytical model provides a good description of the empirical results, as evident

from Fig. 4. The corresponding values of the correlation parameter are sum marized in Table I.

In summary, in this Letter we have analyzed the dynamics of random walks with history-dependent jump probabilities. Our work was motivated not only by the intrinsic interest in such dynamical processes, but also by the urry of activity in the eld of long-range correlated system s, and by som e universal statistical features observed in many di erent natural system s.

We have broadened the study of binary strings to include long-range correlations, extending throughout the length of the chain. U sing a simple and exactly solvable model, we identify a dynam ical phase transition, from norm aldi usion $\mathbb{P}(L) = L$ to super-di usive behavior $\mathbb{P}(L) = L^2$], taking place as the correlation parameter exceeds its critical value. We show that in spite of the simplicity of the model, it is robust, and can easily be extended to describe various features (such as a biased

history-dependent random walk or sub-di usion).

Next, we have applied the analytical results of the model to various binary strings, extracted from very di erent natural systems, such as coarse-grained DNA sequences, written texts, and nancial data. We nd that the model adequately describes the long-term behavior of these systems. Furtherm ore, the model provides a straightforward method to measure the correlation strength of these systems. Our results can be applied to various natural systems, and may shed light on the underlying rules governing their dynamics. For example, the super-di usive behavior of DNA sequences (see Fig. 3) suggests long-range correlations extending acrossm ore than one gene. The model attributes di erent correlation strengths to di erent organisms.

These systems are characterized by norm aldi usion D (L) L] for small L values, and by a super-di usive behavior D (L) L, with > 1] for large L values.
- [16] The model may be broadened to describe sub-di usive behavior as well, by considering the conditional probability $p(k;L) = ff\frac{1}{2} [l] \frac{L}{(L+L_0)^{1-m}}]g$, where f(u)u (u) (u 1) (u 1) and (u) is the Heaviside step-function. This yields, for L l_0 , m > 0, and < 0 a G aussian distribution of variance D (L) L^{1-m} .
- [17] For the probability distribution P (x;L) to be an even function of x (and thus hxi = 0), the function F () should be an odd function of its argument.
