# In uence of a Uniform Current on Collective M agnetization D ynam ics in a Ferrom agnetic M etal

W e discuss the in uence of a uniform current, j, on the magnetization dynamics of a ferrom agnetic metal. We not that the magnon energy (g) has a current-induced contribution proportional to q J, where J is the spin-current, and predict that collective dynamics will be more strongly damped at nite j. We obtain similar results for models with and without local moment participation in the magnetic order. For transition metal ferrom agnets, we estimate that the uniform magnetic state will be destabilized for  $j \& 10^9 A$  cm<sup>2</sup>. We discuss the relationship of this elect to the spin-torque elects that alter magnetization dynamics in inhom ogeneous magnetic system s.

#### IN T R O D U C T IO N

The strong and robust magnetotransport e ects that occur in m etallic ferrom agnets (an isotropic, tunnel, and giant magnetoresistance for example [1]) result from the sensitivity of m agnetization orientation to external elds, combined with the strong magnetization-orientation dependent potentials felt by the current-carrying quasiparticles. This fundamentally interesting class of e ects has been exploited in information storage technology for some time, and new variations continue to be discovered and explored . Attention has turned more recently to a distinct class of phenom ena in which the relationship between quasiparticle and collective properties is inverted, e ects in which control of the quasiparticle state is used to manipulate collective properties rather than vice-versa. Of particular importance is the theoretical prediction [2, 3] of current induced m agnetization switching and related spin transfere ects in ferrom agnetic multilayers. The conditions necessary to achieve observable e ects have been experim entally realized and the predictions of theory largely con med by a number of groups [4, 5, 6, 7, 8, 9] over the past several years.

Current-induced switching is expected [2, 3, 10] to occur in magnetically inhom ogeneous systems containing two or more weakly coupled magnetic layers. The work presented in the present paper was motivated by a related theoretical prediction of Bazaily, Jones, and Zhang (hereafter BJZ), who argued that the energy functional of a uniform bulk half-metallic ferrom agnet contains a term linear in the current of the quasiparticles [11], i.e. that collective magnetic properties can be in uenced by currents even in a hom ogeneous bulk ferrom agnetic metal. The current-induced term in the energy functional identi ed by BJZ im plies an additional contribution to the Landau-Lifshitz equations of motion and, in a quantum theory, to a change proportional to q j in the magnon energy (q). (Here q is the m agnon or spin-wave wavevector and j is the current density in the ferrom agnet.) The BJZ theory predicts that a su ciently large current density will appreciably soften spin waves at nite wavevectors and eventually lead to an instability of a uniform ferrom agnet. The current densities necessary to produce an instability were estimated by BJZ to be of order  $10^8$  A cm<sup>2</sup>, roughly the same scale as the current densities at which spin-transfer phenom ena are realized [4, 5, 7, 8, 9], apparently suggesting to some that these two phenom ena are deeply related.

In this paper we establish that modi cation of spinwave dynamics by current is a generic feature of all uniform bulk metallic ferrom agnets, not restricted to the half-metallic case considered by BJZ.We nd that, in the general case, the extra term in the spin wave spectrum

where J is the spin current, i.e., the current carried by the majority carriers minus the current carried by the minority carriers [12]. In the half metallic case J = j, recovering the result of Reference 11. For reasons that will become apparent later, we refer to the extra term in the spin wave dispersion as the spin wave D oppler shift, although this term inology ignores the role of underlying lattice as we shall explain. We also study the e ect of a uniform current on spin-wave damping. The usual G ilbert damping law / (q = 0), has an additional contribution proportional to the spin-current density. In our picture, a uniform current modi es collective magnetization dynam ics because it alters the distribution of quasiparticles in momentum space.

O ur paper is organized as follows. In Section II we present two general qualitative arguments which partially justify Eq.(1), independent of any detailed microscopic model. In Section III we substantiate the arguments with

a m icroscopic calculation of the spin wave spectrum for a ferrom agnetic (but not necessarily halfm etallic) phase of a Hubbard model, including the e ect of the current. W e derive Eq.(1), and dem onstrate explicitly that when generalized from the half-m etallic case to the general case, the spin wave D oppler shift is proportional to the spincurrent not the total current. The microscopic calculation of Section III uses an e ective action approach, which separates collective and quasiparticle coordinates in a natural way and is well suited to study their interplay. In Section IV we specialize to the half-m etallic case and re-derive the results of reference [11] for the case of ans dm odelferrom agnet. This serves the purpose of establishing a clear form al connection between the derivations presented in Sections II and III and the derivation presented by BJZ, which appear super cially to be quite distinct. In Section V we discuss the e ect of a current on spin wave dam ping. We consider both dam ping due to the coupling of spin waves with the quasiparticles and two magnon damping, which we argue is enhanced by the spin wave Doppler shift of Eq.(1). In Section VI we discuss the relationship between the spin wave Doppler shift and spin-transfer in inhom ogeneous ferrom agnets. Finally, in Section VII we summarize our main results and present our conclusions.

# QUALITATIVE EXPLANATION OF THE CURRENT-INDUCED MAGNON ENERGY SHIFT

The low energy collective dynamics of the magnetization orientation in a ferrom agnet is described by the Landau-Lifshitz equation:

where ~(r;t) is an unimodular vector eld which describes the orientation of the collective magnetization and E  $\sim$ ;  $e_{i}$  is an energy functional of  $\sim$  (r;t) and its derivatives. The generic applicability of this equation follows from the collective nature of spin-dynamics in ferrom agnets. It can be derived from a number of dierent microscopic models in a number of dierent ways. In particular, this equation describes the lowenergy long-wavelength dynamics of the two models of m etallic ferrom agnetism that we consider in later sections. Normally E is minimized by a collinear con gurations  $\sim (r;t) = \sim_0$  along som e privileged easy direction. The Landau-Lifshitz equations linearized around  $\sim_0$  have solutions which describe distortions of the magnetization orientation that propagate like waves with wave q and frequency ! (q) [13]. In a quantum treatment, magnetization orientation uctuations are quantized in units of (q) = ~!~(q).

In a metallic ferror agnet, the quasiparticles occupy bands[14] that are energetically split by an elective Zeem an-coupling magnetic eld oriented along the direction ~. Non-collinear con gurations are penalized because band-electron kinetic energies are raised by an inhom ogeneous elective eld ~(r;t). The easy axis is determ ined by spin-orbit interactions of the band electrons and by the magnetostatic energy, which because of its long range depends on the overall shape of the sam ple.

The dynamics generated by the rst term in square brackets in Eq. (2) is energy conserving whereas the second term, proportional to the dimensionless coe cient , transfers energy from the collective coordinate to other degrees of freedom . In a m etallic ferrom agnet, the dam ping is partly due to the excitation of electron-hole pairs in response to the tem poral evolution of ~. It is clear, therefore, that there is an intim ate relation between the dynam ics of the collective coordinate and the state of the quasiparticles. W hat's more, when current ows inside a ferrom agnet, the m om entum -space distribution functions that describe quasiparticle state occupation probabilities are altered. It is natural, therefore, to expect that the dissipative dynam ics of the collective m agnetization will be a ected by current ow. In Ref. 11 it was shown that, in a halfm etallic ferrom agnetm odeled by a s-dm odel (a model with a single band coupled by exchange interactions to local m om ents), the energy functional E has a term linearly proportional to the quasiparticle current, j. In the following paragraphs we present three arguments to support the idea that the spin wave spectrum of any m etallic ferrom agnet is modi ed by a uniform current in a manner similar to that suggested by Eq.(1).

W e start with the simplest case, a half-m etallic ferrom agnetic electron gas, in which the current e ect can be understood simply in terms of G alilean invariance. The current carrying state of this system is simply one in which the entire electronic system s m oves along with a drift velocity  $v_{\rm D}$ . A spin wave excitation is one in which the magnetization orientation precesses around the easy axis with frequency !~(q):

In the lab frame, the system is seen as moving with velocity  $\mathbf{v}_D$ , and carrying current j = new\_D. The xed position  $\mathbf{r}_L$  in the lab frame, has position  $\mathbf{r}_L$  w\_D t in the moving frame. The precession frequency seen at a xed lab frame position is therefore D oppler shifted to  $!_D(\mathbf{g}) + \mathbf{q}$  w.

This simple e ect is the essence of the spin-wave D oppler shift. In terms of the current density the spin-wave D oppler shift in the magnon energy is  $\sim q$  j=en. System s of practical interest are neither G alilean invariant nor, with a few possible exceptions, half metallic,

how ever so a more detailed analysis is required to determine how the spin-wave Doppler shift is manifested in real system s.

A second useful point of view follows from considering a single-mode-approximation for the quantum spin-wave energy (q) = ~! (q). E lementary magnon excitations of a ferrom agnet reduce the total spin projection along the easy axis by one unit and add crystalm om entum ~q. A state with the correct quantum num bers can be generated starting from the ferrom agnetic ground state (or from a state that carries a uniform current) j \_0 i by acting on it with the 'm agnon creation operator'

where s<sub>i</sub> is the spin-low ering operator for the i-th particle. Two-particle G reens functions constructed from this operator have poles with large residues at m agnon excitation energies. The single-m ode approximation consists of using j (q)i s (q)j\_0 i as a variational wavefunction for the m agnon state at wavevector q. G iven this approximation for the m agnon state, its excitation energy

can be expressed in terms of the expectation value of a commutator between the generalm any-particle H am iltonian H and either m agnon creation or annihilation operators and simplied to the following form:

The second term on the right hand side of Eq.(6) is the magnon D oppler shift term. In this term s  $_i$  and  $p_i$ are the spin raising and lowering and momentum operators for particle i. The numerator and denom inator of this term are, in general, complex two-particle correlation functions. The correlation functions are simplied when the ferrom agnetic state is approxim ated by a Slater determ inant with de nite occupation numbers for both m a jority (") and m inority (#) spin momentum states, i.e. by the electron gas Stoner m odel ferrom agnetic ground state. Then to leading order in qwe nd that them agnon D oppler shift has the value

Eq. 7 is most easily obtained by writing the operators whose expectation values need to be evaluated as a sum of one-body and two-body term s and then using standard

second quantization identities. The most important conclusion suggested by this equation is that, at least for parabolic bands, in generalizing the magnon D oppler effect from half-m etallic ferrom agnets to ferrom agnets with states of both spins occupied, the current is replaced by the spin-current  $\mathcal{J}$ , and the density by the spin-density.

Finally, the same result can be derived by considering a variational wave function for the spin-wave state of a ferrom agnetic m etal in w hich all quasiparticle states that are singly occupied share a comm on spinor that describes long-wavelength spatial precession around the easy direction. For example if the & direction is the easy direction the spinor that describes small amplitude precession is <sup>2</sup>=2; exp(iq r)). The qJ correction (u;v) = (1)then follows by observing that the magnon energy equals the energy change divided by the change in the & direction magnetization component, with both quantities being proportional to <sup>2</sup> at small . This ndings suggest that the explicit approxim at eexpression for the magnon Dopplershift, derived from the SMA for parabolic bands, is likely to qualitatively correct even for realistic ferrom agnets with m ore com plicated band structures. Indeed, that is the conclusion that follows from the more microscopic derivations in the following two sections.

# CURRENT DRIVEN SPIN WAVES IN A HUBBARD MODEL FERROMAGNET

In order to explain our theory of the in uence of uniform currents on the spin-wave spectrum, we rst recall how spin-waves and quasiparticle states are related in equilibrium. This development will also establish the notation we use for the non-equilibrium case. The description we use is one in which a collective uctuation eld interacts with fermionic quasiparticle elds. It allows us to borrow from standard theories of quantum harmonic oscillators weakly coupled to a bath, in order to generalize the theory of collective dynamics from equilibrium to non-equilibrium cases.

# H am iltonian and e ective action

In the previous section we discussed three general argum ents in support of the existence of a spin wave D oppler shift in a m etallic ferrom agnet that is proportional to the spin current as in Eq.(1). We now look more closely at the underlying physics by carrying out an explicit m icroscopic calculation of the spin waves for a Hubbard m odel in the presence of a current. U nlike the s-d m odel considered in R ef. 11, the Hubbard m odel allows for ferrom agnetism in a system with only itinerant electrons. The Hubbard model Ham iltonian is [16]:

The elementary excitations of a metallic ferrom agnet are quasiparticles and spin waves. We want to derive the propagator for the spin waves of the ferrom agnetic phase of thism odel and to see how is a ected by a quasiparticle current. To do so, it is convenient to use the functional integration approach, [15, 16, 17, 18], in which the quasiparticles are integrated out and an e ective action for the spin waves is obtained. This procedure is sketched below, the details can be found in Refs. 15, 16, 17, 18, 19. The nalresult for the spin wave spectrum is equivalent to that obtained by doing a Random Phase Approxim ation (RPA) [20] calculation. However, the e ective action approach provides a convenient conceptual fram ework to understand the connection between spin waves and nonequilibrium quasiparticle states, the central focus of this paper.

The interaction term in the Hubbard model can be written as [16]

We represent the partition function of this model as a path integral over ferm ion coherent states [22], labeled by f ; g, where i; . The key idea which allows quasiparticle and collective degrees of freedom to be separated, while still treating the magnetization as a quantum eld, is the introduction of a Hubbard-Stratonovich transform ation [21] to represent the interaction term . By making this transform ation, we trade a problem of interacting ferm ions for a problem of independent ferm ions whose spin is coupled to a bosonic spin-splitting e ective magnetic eld  $\sim_i$ (), which acts as the collective magnetic coordinate. The partition function reads:

is the inverse of the G reen's function operator.

The action (9) is the sum of three terms, i) noninteracting tight binding fermions (with a Hartree shift), ii) a term quadratic in the bosonic eld and iii) their coupling  $\tilde{i}_{i}$   $S_{i}$ , where  $S_{i}(i)$ ,  $\tilde{i}_{2}$  i;  $\sim$ ;  $\tilde{i}_{2}$ ;  $\tilde{i}_{3}$ ;  $\sim$ ;  $\tilde{i}_{3}$  Since the action is quadratic in the ferm ion variables, the ferm ion functional integral can be form ally evaluated. This allows to write the partition function as a path integral over the auxiliary eld  $\sim$  only,

where the e ective action reads:

Eqs.(11) and (12) are one of the m any possible representations of the exact partition function for the Hubbard M odel. The elective action (12) describes a complicated quantum eld theory for  $\tilde{}_{i}$  ().

# M ean Field theory: Spin-split bands

The rst step in a eld theory of ferrom agnetism is usually to look for classical solutions, i.e. for eld con guration  $\stackrel{\rm cl}{_{\rm i}}$ ( ) for which the eld con guration  $\stackrel{\rm cl}{_{\rm i}}$ ( ) for which the eld con gtransformation is stationary. The saddle point equation reads  $\stackrel{\rm cl}{_{\rm i}} = \frac{40}{3} h S_{\rm i} i$ , where the average is computed with a Green function G ( $\stackrel{\rm cl}{_{\rm o}}$ ) obtained by replacing, in Eq.(10), the uctuating eld  $\stackrel{\sim}{_{\rm i}}$ ( ) by the saddle point solution.




FIG.1: Mean eld quasiparticle bands. Dashed line shows the Ferm iEnergy. is the spin splitting energy.

A ssum ing the existence of a ferror agnetic mean-eld state, the classical solution for a perfect crystal is static (independent of ) and hom ogeneous (independent of i). It is therefore characterized by a direction n and a length  $j^{\circ cl}j$ . Because of the spin rotational invariance of the Hubbard H am iltonian, n is arbitrary. In real system s n is determ ined by spin-orbit interactions and magnetostatic e ects. The mean-eld G reen's function, G ( $^{\circ cl}$ ), describes ferm ions which occupy bands that are spin-split by an e ective magnetic eld along n (See Fig.(1)). The magnitude of the spin splitting, , is obtained from the saddle point equations, which, for this sim ple model, reduce to the following form :

where  $\kappa = k$ )  $\frac{1}{2}$  are the quasiparticle energies of the spin-split bands and N is the number of lattice sites. Notice that the majority band has spins parallel to n, denoted by ". The saddle point equations show explicitly that the auxiliary eld  $^{cl}$  is proportional to the average ferm ion magnetization, which usually appears as the fundamental eld in classical micromagnetic theories for realistic magnetic materials. Hereafter we refer to  $^{()}$  as the

## Spin waves without current

W e are interested in the dynam ics of the collective coordinate, so that the static solution obtained by solving the mean eld approximation is insu cient. To describe the elementary collective excitations we need to study small amplitude dynamic uctuations of the collective coordinate around the static solution:

W e introduce Eq.(14) into the e ective action (Eq.(12)) h  $^{l_3}_{l_3}$  and neglect terms of order  $^{-1}_i$ () and higher. The resulting actionS<sub>cl</sub>( $^{-cl}$ ) + S<sub>SW</sub>, where the rst term is the classical approximation to the e ective action and the uctuation correction is:

where Q is a shorthand for q; i<sub>n</sub>, and a; b stand for C artesian coordinates. Note that the bosonic elds, ~(Q) are dimensionless and the K emelK has dimensions of inverse energy. This action de ness a eld theory for the spin uctuations. The equilibrium M atsubara G reen function, D<sub>ab</sub>(q; i<sub>n</sub>), is given [22, 23] by the inverse of spin uctuation K emel, K<sub>ab</sub>(Q). A nalytical expressions for K<sub>ab</sub>(Q) are readily evaluated for the case of parabolic bands and are appealed to below. We obtain the retarded spin uctuation propagator by analytical continuation of the M atsubara propagator: D  $_{ab}^{ret}(q; !) = D_{ab}(q; i_n ! ! + i0^+)$  The imaginary part of the retarded propagator sum marizes the spectrum and the damping of the spin uctuations m ost directly.

The theory de ned by Eq.(15) includes two types of spin uctuations which are very di erent: i) longitudinal uctuations (parallel to n), or am plitude m odes and ii) transverse uctuations (perpendicular to n), or spin waves. The am plitude m odes involve a change in the m agnitude of the local spin splitting, , and are either over dam ped or appear at energies above the continuum of spin-diagonal particle-hole excitations. In contrast, the spin waves are gapless in the lim it q = 0, in agreement with the G oldstone theorem, and are often weakly dam ped even in realistic situations. Note that the am plitude m odes decouple from the spin wavem odes for sm all am plitude uctuations. For x = n, we can write

Since the low energy dynamics of a metallic ferrom agnet is governed by transverse spin uctuations, we do not discuss longitudinal uctuations further. A fiter analytic continuation, we obtain the following result for the inverse of the retarded transverse spin uctuation G reen function ( $D^{\text{ret}}$ )<sup>1</sup>, which is diagonal when we rotate from  $\dot{\gamma}$ ;  $\dot{z}$  to  $+\dot{z}$  if chiral representations. The diagonal elements are then

where (g;!) is the Lindhard function evaluated with the spin-split mean-eld bands:

where  $n_{k}$  is shorthand for the Ferm i-D irac occupation function  $n_{F}$  for the quasiparticle occupation num – bers. Eqs. (17) and (18) make it clear that the spin wave spectrum is a functional of the occupation function  $n_{F}$  for the quasi-particles in the spin-split bands. The in uence of a current on the spin-wave spectrum will enter our theory through non-equilibrium values of these occupation num bers.

In the case of parabolic bands (still w ithout current), the Taylor expansion of the Lindhardt function in the low-energy low-frequency lim it gives the following result for the spin wave propagator:

where is the spin sti ness which is easily computed analytically for the case of parabolic bands. The poles of Eq.(19) give the wellknown result for the spin wave dispersion,  $! = q^2$ . Several remarks are in order: i) In real systems, spin-orbit interactions lift spin rotational invariance, resulting in a gap for the q = 0 spin waves. The size of the gap is typically of order of 1 eV [24]. ii) The interplay between disorder and spin orbit interactions, absent in the above m odel, gives rise to a broadening of the spin wave spectrum, even at sm all frequency and m om entum. In Section V we address this issue and discuss how dam ping is changed in the presence of a current.

## Spin waves with current

In the previous subsection we derived the spin wave spectrum of a metallic ferrom agnet in therm al equilibrium. Equations (17) and (18) establish a clear connection between spin waves and quasiparticle distributions. In order to address the same problem in the presence of a current, a non-equilibrium form alism is needed. By taking advantage of the form ulation discussed above in which collective excitations interact with ferm ion particle-hole excitations we are able to appeal to established results for harm onic oscillators weakly coupled to a bath. In the equilibrium case, the fact that the lowenergy H am iltonian form agnetization-orientation uctuations is that of a harm onic oscillator follows by expanding the uctuation action to leading order in ! to show that  $\hat{y}$  and  $\hat{z}$  direction uctuations are canonically conjugate. In our model magnons are coupled to a bath of spin- ip particle-hole excitations. Following system bath weak coupling master equation analyses [25] we nd that the collective dynamics in the presence of a nonequilibrium current-carrying quasiparticle system di ers from the equilibrium one simply by replacing Ferm ioccupation num bers by the non-equilibrium occupation num bers of the current-carrying state. The quantity  $J_i$ , the component of the spin current polarized along the magnetization direction  $n = \hat{x}$  and owing along the i axis, is the di erence between the current carried by majority and minority carriers. In equilibrium there is no current and no linear term occurs in the wavevector Taylor series expansion, leading to quadratic magnon dispersion as obtained in Eq.(19). When (charge) current ows through the ferrom agnet, the di erence in carrier density and mobility between majority and minority bands inevitably gives rise to a nonzero spin current [30]. We therefore obtain the following spectrum for spin waves in the presence of a current:

This equation is the central result of our paper. Notice that it is in precise agreement with the single-mode-approximation expression since  $= \frac{2U}{3} (n_* n_{\#})$ ; in that case, however, the explicit expression was derived for the case of free-particle parabolic bands only. Eq.(23) states that the spin wave spectrum of metallic ferrom agnet driven by a current is modiled in proportion to the resulting spin current.

In the half metallic case, when the density of minority carriers is zero, the spin current is equal to the total current and we recover the result of BJZ [11]. In that  $\lim_{n \to \infty} \lim_{n \to$

where we have expressed the current as  $\tilde{j} = en v_D$  with  $v_D$  the drift velocity, generalizing the half-m etallic simple D oppler shift result to non-parabolic bands.

## Spin wave instability

Eqs. (23) and (24), taken at face value, predict that the energy of a spin waves is negative and therefore that the uniform ferrom agnetic state is destabilized by an arbitrarily sm all current. If this were really true, it would presum ably be a rather obvious and well known experim ental fact. It is not true because spin waves in real ferrom agnetic m aterials have a gap due to both spin-orbit interactions and m agnetostatic energy. Inserting by hand this (ferrom agnetic resonance) gap, the spin wave dispersion reads:




FIG.2: Current modi ed spin-wave spectrum

so that it takes a critical spin current to close the spin wave gap. In Fig.(2) we plot the current driven spin wave spectrum assuming  $!_0 = 1$  eV, the electronic density of iron (n = 1:17  $10^{23}$  cm<sup>-3</sup>) and a Doppler shift given by q v<sub>D</sub>. The critical current so estimated is 1:1  $10^9$  A cm<sup>-2</sup> for a typical system. This critical current could be much low er, perhaps by several orders of m agnitude, in m etallic ferrom agnets in which m aterial parameters have been tuned to minimize the spin-wave gap. Experimental searches for current-driven anomalies in permalby thin lm s, for example, could prove to be fruitful.

#### Spin wave action with current

In the small ! and small q lim it, the spin waves are independent and their action is equivalent to that of an ensemble of non interacting harm onic oscillators, indexed with the label q. The M atsubara action for a single os-

This representation makes it clear that the spin wave D oppler shift appears as a modi cation of the term which couples the canonically conjugate variables, y and z, i.e., the spin wave D oppler shift modi es the Berry phase. When expressed in this way, the spin-wave D oppler shift is partly analogous to the change in super uid velocity in a super uid that carries a nite mass current, and the stability lim it we have discussed is partly analogous to the Landau criterion for the critical velocity of a super uid. These analogies are closer in the case of ideal easy-plane ferrom agnets, which like super uids have collective modes with linear dispersion instead of a having a gap.

## ALTERNATE DER IVATION OF SPIN-WAVE DOPPLER SHIFT

In the previous section we have used a functional integral approach to calculate how the spin wave propagator of a Hubbard model metallic ferrom agnet is modied when current ows through the system. The BJZ derivation of the same e ect was based on an identity at the operator level. BJZ used as d model, i.e. a Ham iltonian for itinerant (s) electrons interacting with localized (d) spins via an exchange interaction. They considered the lim it of very large exchange interaction and low s

electron density, so that, in the ground state, the electrons are fully spin polarized. They then introduced a local spin rotation transform ation de ned so that at every point of the space the spin of the selectrons is parallel with the local value of the d electrons m agnetic m om ent. This unitary transform ation has been previously used for both s d and other m icroscopic m odels of ferrom agnetism [18, 26, 27, 28, 29]. In the transform ed fram e, the exchange interaction is always diagonal in the spin index but the expression for the kinetic energy is complicated, and includes new terms. One of the new terms couples the s electron current to a space derivative of the local spin magnetization. It is from this term in the exchange energy that BJZ derived the modi cation of the Landau-Lifshitz equations that we have identied as a spin-wave Doppler shift. In this section we bridge the gap between the two derivations. We recover the half metallic s-d Ham iltonian result of BJZ in a system atic way.

The continuum s-d m odel describes it inerant electrons, , interacting with a continuum of localized quantum spins, M (x), through a exchange interaction of strength J. The Ham iltonian for parabolic bands is given by:

Following BJZ, we perform a unitary transformation on the spins of the itinerant electrons so that, at each point of time and space, the quantization axis is parallel to M (x; ). BJZ considered only the limit of very strong ferrom agnetic J, so that the spins of the occupied electronic states are always parallel to M (x; ) and we can ignore the antiparallel electrons. This approximation is valid in halfmetallic systems for energies much smaller than J, the local spin splitting. In this approximation the action for the parallel fermions in the rotated frame, denoted by (x; ), can then be written as

In deriving this expression we allowed the mean-eld ferm ion quasiparticle occupation numbers to assume values consistent with a non-equilibrium current-carrying state. Equation (31) de nes a theory for the collective m agnetization of the ferrom agnet. The nst two terms are the Berry phase of the d spin and a renorm alization of the Berry phase due to the spin of the selectrons, sim ilar to that derived by M illis et al. for the double exchange m odel [27]. The third term describes the energy penalty for non collinear con gurations, or spin sti ness. The term s in the second line yield the coupling of the average (param agnetic and diam agnetic) currents to the collective m agnetization.

The sem iclassical equations of motion of (31) yield the Landau Lifshitz (LL) equations including the  $j_i r_i$ 

term derived by BJZ (equation (5)). In the case of BJZ, the LL equations are derived from a microm agnetic energy functional plus the param agnetic current term. In our case, the whole functional is derived from the microscopic H am iltonian. The main di erence between s d and Hubbard model result is the appearance here of both localmoment and itinerant electron (r=2) contributions to the Berry phase, which is proportional to the total spin density. Note that since A is quadratic in the spin wave variables, the term  $A^2$ in (31) gives no contribution to (32). A fier diagonalization of Eq. (33) we obtain the retarded propagator for the spin wave variables. The real and in aginary part of the poles of the retarded propagator give the spin wave dispersion and dam ping, respectively. In this theory, the im aginary part is zero, since the spin ip of quasiparticles is blocked. The real part reads:

Hence, we see how the spin wave dispersion in this theory has the q j term derived by BJZ. Since the system described by the theory is fully polarized, the current and the spin current (polarized along the ground state m agnetization direction) are identical. This result is to be compared with Eq. (24), derived with a di erent m ethod for a di erent m icroscopic m odel. We conclude that spin-wave D oppler shifts due to spin currents are generic, although their quantitative details can depend on the m icroscopic physics of the ferrom agnet.

# ENHANCED SPIN-WAVE DAM PING AT FINITE CURRENT

In Sections III and IV we have shown how the dispersion of spin waves in a metallic ferrom agnet is a ected by current ow, and we have obtained results compatible with those of BJZ [11]. In this section we address a problem which, to our knowledge, has remained unexplored so far: how does the current ow a ect the lifetime of the spin waves. In subsection A we analyze the damping of spin waves at zero current. In the subsections B and C we discuss how these results are modiled by the presence of a current.

A ferrom agnetic resonance (FMR) experiment probes the dynamics of the coherent or q = 0 spin wave mode. The signal linewidth is inversely proportional to the coherent mode lifetime, the time that it takes for a transverse magnetic uctuation to relax back to zero. Spin waves have a nite lifetime because they are coupled to each other and to other degrees of freedom, including phonons and electronic quasiparticles. In ferrom agnetic metals, the quasiparticles are an important part of the dissipative environment of the spin waves [31, 32, 33, 34]. and we can therefore expect that quasiparticle current ow a ects the spin wave lifetime to some degree. In order to discuss this e ect, it is useful to rst develop the theory of quasiparticle spin-wave dam ping in equilibrium.

## D am ping at zero current

The elementary excitation energies for the ferrom agnetic phase of the Hubbard model, are specified by the locations of poles in Eq.(17). The damping rate is proportional to the imaginary part of the transverse uctuation propagator. According to Eq.(17), the damping of a spin wave with frequency ! and momentum q, (q; !) = 2 Im [(!;q)] is given by:

In the absence of disorder, this quantity is nonzero when jqj is comparable to  $k_{\rm F}$  "  $k_{\rm F}$  # or when ! ', the band spin-splitting. Either disorder, which breaks translational sym m etry leading to violations of m om entum conservation selection rules, or spin-orbit interactions, which cause all quasiparticles to have m ixed spin character, w ill lead to a nite electronic damping rate at characteristic collective m otion frequencies. Because this damping is extrinsic, how ever, its num erical value is usually di - cult to estimate. It is often not know n whether coupling to electronic quasiparticles, phonons, or other degrees of freedom dom inates the damping.

Form ally generalizing Eq.(35) to the case with disor-

der and spin orbit interactions leads to

This result can be considered a microscopic justi cation of the G ilbert damping kw, which states that the damping rate is linearly proportional to the resonance frequency and vanishes at ! = 0. The proportionality between frequency and damping rate follows from phase space considerations: the higher the spin wave frequency !, the larger the number of quasiparticle spin ip processes compatible with energy conservation.

## Damping at nite current

W e analyze how a currentm odi es quasiparticle dam ping, we again appeal to the picture of m agnons as harmonic oscillators coupled to a bath of particle-hole excitations and borrow results from master equation results for oscillators weakly coupled to a bath [25] For magnetization in the "' direction, m agnon creation is accom panied by quasiparticle-spin raising and m agnon annihilation is accompanied by quasiparticle-spin lowering. It tums out [25] that only the di erence between the rate of quasiparticle up-to-down and quasiparticle down-to-up transitions enters the equation that describes the magnetization evolution. This transition rate di erence leads to the same combination of quasiparticle occupation num bers as in Eq.(38), except that the occupation numbers characterize the current-carrying state and are not Ferm i factors. For m etals we can use the standard approxim ate form [35] for the quasiparticle distribution function in a current carrying state: #

Because of the independent sums over  $\tilde{k}$  and  $\tilde{k}^0$  in Eq.(36), and because it is a simple di erence of Ferm i factors that enters the dam ping expression, we conclude that the quasiparticle dam ping correction will vanish to leading order in the spin-dependent drift velocities  $v_{p}$ . We reach this conclusion even though the phase space for spin-ip quasiparticle transitions at the spin-wave energy is altered by a factor  $1 \text{ when }_{F}$ VD VE 0, where F is a characteristic quasiparticle energy scale, i.e. the up-to-down and down-to-up transition rates change signi cantly when this condition is met, but not their di erence. To obtain a crude estim ate for the current at which this condition is satis ed we use the following data [35] for iron: n  $1.710^{23}$ , Ferm ivelocity  $1.9810^8$  cm s<sup>1</sup>. The drift velocity corresponding to a current density of 10 A cm <sup>2</sup> is  $v_d = \frac{j}{en}$  ' 10 <sup>4</sup> cm s <sup>1</sup>. The typical energy of a long-wavelength magnon is  $10^{-6}$  eV. Therefore, current densities of the order of  $10^6$  A cm  $^2$  and larger will substantially change the coupling of spin-waves to their quasiparticle environment. Although this change will in uence the spin-wave density-matrix, magnetization uctuation damping itself will not be altered by this mechanism until much stronger currents are reached.

## Twom agnon dam ping

In the previous subsections we have calculated the damping of the lowest energy spin wave due to its coupling to the reservoir of quasiparticles. In this section we study damping of the coherent rotation mode (q = 0 spin wave) due to its coupling to nite q spin waves. This mechanism is known as two magnon scattering and is efficient when the coherent rotation mode is degenerate with nite q spin waves [36], a circum stance that sometimes arises due to magnetostatic interactions. The main

tim es arises due to m agnetostatic interactions. The m ain point we wish to raise here is that because of the spinwave D oppler shift, precisely this situation arises when the ferrom agnet is driven by a current. As in the previous subsection, we assume that some type of disorder lifts m om entum conservation. The elective H am iltonian for the spin waves reads:

Equation (40) is the well H am iltonian known for a dam ped harm onic oscillator and can be solved exactly. The dam ping rate for the q = 0 spin wave reads:

where we have approximated  $g_q$  'g. Hence, in the presence of elastic spin wave scattering, renormalization of the spin wave spectrum due to the current will enhance the damping of the lowest spin wave mode. Unlike the G ilbert model, the damping rate given by equation (42) is independent of !0, im plying that the dimensionless G ilbert damping coe cient would decline with external eld if this mechanism were dominant.

## SPIN-WAVE DOPPLER SHIFT AS A SPIN-TORQUE EFFECT

In this section we explain how the in uence of an uniform current on magnetization dynamics can be understood as a special case of a spin-torque e ect [2, 3]. The latter takes place when a spin current com ing from a magnet spin polarized along M<sub>1</sub> enters in a magnet spin polarized along  $M_2$ . In this circum stance there is an imbalance between the incom ing and the outgoing transverse component (with respect to  $M_2$ ) of the spin currents in magnet 2. Because of spin conservation (resulting from the rotational invariance of the system), the imbalance in the spin ux across the boundaries of magnet 2 must be compensated by a change of the magnetization of that magnet, which is described by a new term in the Landau Lifshitz equation [2, 3]. The microscopic origin of the spin current im balance can be understood as a destructive interference e ect, originated by the fact that the steady state spin current is a sum over stationary states with broad distribution in momentum space [2]. A lternatively, it is possible to understand the spin current ux in balance as a destructive interference in the time domain. At a given instant of time, the outgoing current-carrying quasiparticles have elapsed a di erent am ount of time in magnet 2. This broadening in the interaction time distribution results in a broadening of the spin precession angle [37]. The average over that distribution results in a vanishing transverse spin component of the outgoing ux.

The above argument, connecting spin ux imbalance and spin-torque, applies to a system in which the inhom ogeneous magnetization is described by piecew is constant function. It is our contention that the spin wave D oppler shift can be understood by applying the same argument to the case of sm oothly varying magnetization. We consider again a magnet with charge current j, and spin current J. We assume that current ows in the  $\hat{x}$  direction and, importantly, that the spin current is locally parallel to the magnetization orientation J (x) =  $j_s^{(x)}$ . It can be shown that this is the case in a wide range of situations.

The spin density reads  $S(x) = S_0^{(x)}$  where  $S_0$  is the average spin polarization. We focus on the slab centered at x and bounded by x dx and x + dx. Spins are injected into the slab at the rate  $j_s^{(x)}(x + dx)$  and leave at the rate  $j_s^{(x)}(x + dx)$ . The resulting spin current in balance is  $2dx j_s e_x^{(x)}$ . Therefore, there must be a spin transfer to the local magnetization:

which is exactly the same result obtained in 11. Including this term in the Landau Lifshitz equation and solving for sm all perturbations around the hom ogeneous ground state (spin waves) results into the spin wave D oppler shift discussed in previous sections. In conclusion, this argum ent dem onstrates that the spin-wave D oppler shift and spin transfer torques are di erent lim its of the same physical phenomena, the transfer of angular momentum from the quasiparticles to the collective m agnetization whenever the latter is not spatially uniform.

#### D ISCUSSION AND CONCLUSIONS

The e ect of high current densities on the magnetization dynam ics of ferrom agnetic m etals have been explored experim entally in several con gurations. In point contact experiments, a large current density is injected from a norm alm etallic contact into a ferrom agnetic multilayer [4, 5] or single layer [8]. W hen a large ow of electrons (current density j' 10<sup>8</sup> A cm<sup>2</sup>) enters into the ferrom agnetic multilayer, the resistivity presents an abrupt increase which has been related to the coherent precession of spin waves [4] and/or phonons [5]. The fact that Ji and Chien [8] report sim ilar results when the current is injected into a a single ferrom agnetic layer dem onstrates that interlayer coupling is not essential for the anom alies observed in transport. It must be noted that when the current ow is such that the electrons go from the ferrom agnetic layer (s) tow ard the point contact, no anom aly is observed. Sim ilar transport anom alies at currents densities higher than those of current induced m agnetization switching are observed by a num ber of different groups [7] in a system of two adjacent ferrom agnetic nanopillars. In this system a large current density ows from one ferrom agnet to the other.

The fact that the current densities at which the anom alous behavior takes place is of the sam e order of m agnitude than the current at which the spin wave D oppler shift makes the collinear state unstable might lead to suggest a connection between the two. However, the experiments in the point contact geometry show that the transport anomalies only occur for one direction of the current, something which seems at odds with the spin wave D oppler shift instability.

In sum m ary, the focus of this paper is on the e ect of the current in the spin wave dynamics of a bulk ferrom agnetic m etal. W e have addressed two types of e ects: the change in the spin wave dispersion and change in the spin wave dam ping. These quantities are given, at a form al level, by the spin wave propagator. The centralidea is that the spin wave propagator is a functional of the quasiparticle occupation function. In the presence of the current the occupation function changes, affecting both the dispersion and the dam ping of the spin waves. Throughout the paper we have assumed that the functional relation between the quasiparticle occupation function and the spin wave propagator rem ains the same when the system is out of equilibrium. In that sense, the above derivations are heuristic. Our main conclusions are: i) A current j ow ing through a m etallic ferrom agnet results[30] in a spin current J which m odi es its spin wave spectrum by an amount proportional to q J. ii) This modi cation, which was derived by BJZ for a fully polarized s-d model, occurs as well in a non fully polarized Hubbard model, in which the d electrons are it inerant and, according to the arguments of section  $\Pi_{r}$ in typical real-world ferrom agnets. iii) In the presence of elastic two magnon scattering, the spin wave Doppler shift leads as well to a broadening of the low est spin wave mode (Eq. 42), which is proportional to the spin current. iv) Both the spin-wave Doppler shift in spatially hom ogeneous ferrom agnets and the spin torque e ect in inhom ogenoeus structures [2, 3] are a consequence of the spin transfer from the quasiparticles to the collective magnetization when the latter is spatially inhom ogeneous.
