Ehrenfest M odelwith Large Jumps in Finance

A bstract

Changes (returns) in stock index prices and exchange rates for currencies are argued, based on empirical data, to obey a stable distribution with characteristic exponent < 2 for short sampling intervals and a Gaussian distribution for long sampling intervals. In order to explain this phenomenon, an Ehrenfest model with large jumps (ELJ) is introduced to explain the empirical density function of price changes for both short and long sampling intervals.

#### 1 Introduction

This paper introduces a simple stochastic model, an Ehrenfest model with large jumps (ELJ), to explain the observed fact that the density function of price change to well to a symmetrical Levy stable distribution near the central part of the density function, while it has a truncated tail far from the center [7]. The proposed model also explains that it is close to a Gaussian distribution for long sampling intervals.

In the case of a short sam pling interval of empirical data, i.e. those for sam – pling intervals of several seconds, m inutes or hours, the price returns are not distributed according to a Gaussian law [2]. The value of for the empirical density function of the S&P 500 index estimated for short sampling intervals indicates that the density function follows a stable law (<2) [7,8].

The price changes are therefore said to be distributed according to a stable law with a characteristic exponent < 2 for short sampling intervals, and a Gaussian distribution ( = 2) for long sampling intervals [3].

## 2 Ehrenfest model with large jumps

The Ehrenfest model [1,4] envisages two boxes + and , with 2R particles distributed in these boxes. A particle is chosen at random and moved from one box to the other and the same procedure is repeated.

We consider a generalized Ehrenfest model in which  $ab^j$  steps of the Ehrenfest model take place with probability  $C = Q^j$  at each step, where a; b > 0; Q > 1; j = 0; 1; 2; ... and C is a normalization constant defined by:

For sim plicity, a is x = 1 in the following discussion. This generalized x = 1 model becomes identical to the original Ehrenfest x = 1.

Suppose that initially there are R + n ( R n R) particles in box + , after repeating the above procedure s times, there are R + m particles in box + . The probability of this event calculated in case of the original Ehren fest model [6] can be described as:

We denote the particle number in the box + afters steps as M (s), and de ne the changes as:

where s denotes the step interval. U sing the above Z  $_{\rm s}$  (s), we de ne the empirical density P  $_{\rm s}$  (z) as:

U sing Eq. (1), the probability density function of the changes Z  $_{\rm s}$  (s) for the proposed model P  $_{\rm s}^{\rm ELJ}$  (z) is expressed as:




Fig. 1. G raph of function  $f(t) = (1 e^t)$ :

A ssum ing that the initial density function is given by a G aussian density function g(x) = P(0;x;1), the probability density function of the change  $Z_t(t)$  in the original Ehrenfest model, obtained from the diusion approximation (2), is given by:

where (x) is the D irac delta function. The variance of the change Z  $_{\rm t}$  (t) is given by:

From this gure, we not that when both  $t_1$  and  $t_2$  are su ciently large, the di erence  $Var(Z_{t_1}(t))$   $Var(Z_{t_2}(t))$  remains small, even if  $t_1$  and  $t_2$  are very di erent.

The time series of the ELJ is interpreted as a time series chosen random ly from that of the original Ehrenfest model. Using Eq. (5), the probability density function of the ELJ is approximated as:

When z is large, the density of ELJ in Eq. (6) will be approximately given by:

where  $j_i$  of the sum m ation is an integer satisfying the condition  $(b^{j_1} + b^{j_3})$  1. From the above equation, we not that the density of the proposed model decays in proportion to  $\exp(-\hat{z})$  toward the end of the tail as seen in Fig. 3 (a), whereas in Fig. 3 (b), the tail decays in proportion to  $z^{-1}$  to

mid-way when sismall.

The Levy stable symmetrical density function is given by:

for the characteristic exponent (0 < 2) and positive scale factor. This reduces to a Gaussian density function when = 2. The Levy stable density is characterized by a fat tail and kurtosis, is consistent with empirical data, and satis es a scaling law. It is one of the most natural generalization of the Gaussian distribution which is stable with respect to convolution.

From Eq. (6), we not the reason that the stable density function < 2 is chosen for the best thing density function of the proposed model for shorter s by the maximum likelihood method that we will explain later. The large coecient of  $z^2$  in the exponential function gives a sharper peak at the origin, in contrast, the small coecient of  $z^2$  a ords a atterpeak, broadening the density function. Therefore, the density function given by the sum of these two types of terms with dissimilar coecients has a fatter tail than the Gaussian density function.

When s is su ciently large, the density function on proposed model becomes the sum of the Gaussian density functions of almost the same shape. Therefore, the density function in the proposed model is given by the Gaussian density function for longer sampling intervals.

The proposed model well describes the changes in the stock indices such as the S&P500, TOPIX and currency exchange rates. Let each particle in the box + represent a buy stance dealer and each particle in the box represent a sell

stance dealer. These dealers will get a lot of information from a new spaper, television, radio, business reports etc. on business conditions, weather reports, governmental decisions etc. and their view will be changed from buy to sell or from sell to buy on the basis of such information. These changes will generate a change in the stock price or the exchange rate. We assume that a change in the dealer's mind directly causes a change in the price so that M (s) is interpreted as the price.

A sthe inform ation is spatially and tem porally distributed, and any piece of inform ation m ay have a di erent im pact on the dealers, the price will sometimes change drastically within minutes, or sometimes only slightly over hours. The dierence between the progress of time in the ELJ and in the original Ehrenfest model describes this phenomenon. The parameters band Q might thus represent the dealers' (price change) sensitivity and frequency of information.

## 3 Maximum likelihood method




Fig. 2. Trajectory of the number of particles in box + (M (s)) for N = 10000, b = 3, Q = 2.



The maximum likelihood estimate of the parameters of the model is obtained by maximizing this quantity.

## 4 Numerical simulation

The results of a numerical simulation of the trajectory of M (s) is shown in Fig. 2, where N = 10000, b = 3, and Q = 2.B ig jumps that do not exist in the original Ehrenfest model are observed in the proposed model. Because of these big jumps, the empirical density P  $_{\rm S}$ (z) of the new model is a better to a stable distribution ( < 2), whereas the empirical density P  $_{\rm S}$ (z) is given by a Gaussian distribution in the original Ehrenfest model.






Fig. 3. Empirical densities  $P_s(z)$  for s=8; 64; 512 (dotted line). N=10000, and b=3; Q=2. The Lvy stable density estimated using the maximum log likelihood method is also shown (solid line). =1:310, 1.763, 2.0 and s=9:223, 335.0, 2418. (a) Sem i-log plot, (b) log-log plot.

In Fig. 3, the empirical density P  $_{\rm s}$ (z) is shown for diement time intervals  $\rm s=16$ ; 64, 512. These results were obtained for a sequence of about one million steps of the ELJ. The density obtained by simulation using the proposed model is well described by a symmetrical Levy stable density function (8).

The parameters and sofEq. (8) estimated using the maximum likelihood method for dierent time intervals are shown in Table 1. In the model, increase to 2:0 with increasing s for dierent values of N; Q and b, as can be clearly understood from Table 1. Here we used the results of numerical simulation and considered the numerical values for and t for several values on N, b or Q in Table 1. However, the probability density function of the proposed model can be approximately given by Eq. (6).

Consider a density function given by a combination of an in nite number of Gaussian density functions:

It is easy to con m from the knowledge of domains of attraction [4] that the density function of the above equation belongs to the domain of attraction of the symmetrical Levy stable density with characteristic exponent given by:

The density functions given by Eqs. (6) and (9) are identical under a rst order approximation in the limit ! 0 and s = 1. Therefore, the symmetrical Levy stable density with characteristic exponent given by Eq. (10) to the density function (6) well as far as the central part of the density function of the ELJ is concerned.

### 5 Exchange rate

In ordered to discuss the empirical density function, we should rede ne the empirical density function as a continuance version. Price changes (returns) are de ned by:




Fig. 4. Empirical density functions P  $_{\rm t}(z)$  for sampling intervals of  $t=2^{15}$ ,  $2^{18}$ ,  $2^{21}$  seconds (dots) and the corresponding stable density functions (lines, =1.451, 1.588, 1.900 and t=23.86, 184.5, 4276) estimated by the maximum log likelihood. Table 2

The empirical density of the exchange rate between the US dollar and the Japanese yen over one year (Jan. '94-Dec. '94) [10] is shown in Fig. 4, along

with the estimated stable density functions. This gure shows that the empirical density is close to the stable distribution with a characteristic exponent < 2 for short sampling intervals and a Gaussian distribution for long sampling intervals. Table 2 shows the maximum log likelihood estimate of and t. When the sampling interval is small, the return is distributed according to a stable law with characteristic exponent < 2. In addition, becomes larger with expansion of the sampling interval and approaches 2. Similar results were obtained for German stocks [3].

## 6 Concluding remarks

This paper introduced a simple stochastic model (ELJ) to understand that the observed density function of the price change is approximately given by a truncated symmetrical Levy stable distribution for short sampling intervals and a Gaussian distribution for long sampling intervals.

The elastic potential of the Ehrenfest model makes the tail of the density function decay rapider than that of the Levy stable density. The empirical density function of the price change should not have an in nitely long heavy tail. Thus, the empirical density function given by Eq. (6) seems to be reasonable.
