Motion in random elds - an application to stock market data

A bstract

A new model for stock price uctuations is proposed, based upon an analogy with the motion of tracers in Gaussian random elds, as used in turbulent dispersion models and in studies of transport in dynam ically disordered media. A nalytical and numerical results for thism odel in a special limiting case of a single-scale eld show characteristics similar to those found in empirical studies of stock market data. Speci cally, short-tem returns have a non-Gaussian distribution, with super-di usive volatility, and a fast-decaying correlation function. The correlation function of the absolute value of returns decays as a power-law, and the returns distribution converges towards Gaussian over long times. Some important characteristics of empirical data are not, how ever, reproduced by the model, notably the scaling of tails of the cumulative distribution function of returns.

1 Introduction

R andom uctuations in stock market prices have long fascinated investors and mathematical modelers alike. A lthough the investors' hopes of accurately predicting tom orrow's share price appear to be in vain, models which lim it them selves to statistical characteristics such as distributions and correlations have had some success. Bachelier's classical model [1] treats the stock price S (t) as a random walk, leading to the conclusion that the distribution of prices is G aussian. Sam uelson [2] instead describes the log-price

as a random walk, and therefore concludes that the stock price S (t) should have a log-norm all distribution. This model remains in common usage, despite

the shortcom ings listed below, not least because it perm its the derivation of an equation for pricing options and other nancial derivatives, e.g., the fam ous B lack-Scholes equation [3]. Nevertheless, empirical evidence from stock market data indicates that the random walk model inadequately describes many important features of the stock price process. The following stylized facts are accepted as established by these studies [3, 4]:

- (i) Short-term returns are non-G aussian, with 'fat tails' and high central peaks. The center of the returns distribution is well tted by Levy distributions [5]. R ecent studies indicate that the tails of the returns distribution decay as power-laws [6]. As the lag time increases, the returns distribution tions slow ly converge tow ards G aussian; recent analysis of the Standard & P oor 500 index (S& P 500) estimates this convergence is seen only on lags longer than 4 days [6].
- (ii) The correlation function of returns decays exponentially over a short tim escale, consistent with market e ciency. However, the correlation function of the absolute value of the returns shows a much slower (powerlaw) decay [6].
- (iii) The volatility (standard deviation of returns) grows like that of a di usion (random walk) process, i.e. as the square root of the lag time, for lag times longer than about 10 m inutes. However, higher frequency (shorter lag) returns demonstrate a super-di usive volatility, which can be tted to power-law swith exponents found to range between 0.67 and 0.77 [6, 7].
- (iv) The distribution of stock price returns exhibits a simple scaling: in [5] a power-law scaling of the peak of the returns distribution P (0) with lag time is shown to hold acrossm any magnitudes of lag times. The exponent of the power-law is approximately 0:7.

M ost of the references cited here exam ine data from the Standard & Poor 500 index (S & P 500), but other international markets are found to behave sim ilarly [6].

The predictions of the random -walk model can be investigated using the random di erential equation

which yields the log price x(t) from each realization of the random function $u_w(t)$. The classical random walk follows from taking $u_w(t)$ to be a Gaussian white-noise process with zero mean and (auto)correlation function [8]:

where (t) is the D irac delta function, and the angle brackets denote averaging over time or over an ensemble of realizations. W hite noise is the form alderivative of a W iener process, which connects (2) to rigorous m ethods for stochastic di erential equations [9]. Note that throughout this paper all stochastic processes are assumed (unless explicitly stated otherwise) to have zero mean, zero drift, and to be statistically stationary.

Equation (2) is easily solved, and leads to results which do not agree with the empirical facts (i)-(iv) listed above. Dening the return on the stock price S (t) at time t as the forward change in the logarithm of S (t) over the lag time :

it is found that the white-noise case leads to probability distribution functions (PDFs) for r which are Gaussian at all lags , in contrast to (i). The lack of m em ory e ects in white-noise leads to correlation functions which decay im m ediately to zero, unlike (ii). The volatility grows di usively for all lag values, and so has no super-di usive range, while the scaling of P (0) follows a power-law di erent from that found for actual prices, see (iv) above.

A natural generalization of the white-noise ${\tt m}$ odel again takes a form similar to (2)

but with u_c (t) now being a non-white or colored process, incorporating some memory e ects. For the particularly simple case of Gaussian noise, it can be described fully by its correlation function

Here R (t) decays from a maximum of unity at t = 0 to zero as t $! \ 1$, and

 2 is the variance of the process u_c . Gaussian noise is attractive because it appears naturally as the limiting sum of many independent noise sources under the central limit theorem [8], and because of its analytical tractability. Indeed equation (5) is again easily solvable for Gaussian u_c , but leads once more to Gaussian-distributed returns at all lag times, in contrast to (i). Moreover, the correlation of absolute returns does not decay more slow ly that the returns correlation, as required by (ii).

These failings of simple di erential equation models have inspired many attempts to reproduce the empirical facts (i)–(iv) using various stochastic models. As a sample of just a few of these, we list the truncated Levy ights model [10, 11], ARCH and GARCH models [12, 13], non-Gaussian Omstein-Uhlenbeck processes [14], and a model based on a continuous superposition of jump processes [15, 7]. The rst three of these were reviewed in [16]. An ideal model should reproduce all the experim ental facts (i)–(iv), by giving a simple picture of the stochastic process underlying the stock price time series, but no model has yet been found which fulls all these criteria [17]. In this paper we exam ine the results of generalizing the random walk models (2) and (5) to motion in a random eld:

Here u (x;t) is a G aussian random eld with zero m ean, which is fully described by its correlation function

For simplicity we take the eld to be hom ogeneous and stationary; the factorization in (9) of the correlation into separate tim e- and x-correlations is for ease of exposition only, and more complicated inter-dependent correlations can be considered. The averaging procedure in equation (8) is over an ensemble of realizations of the random eld u, or using a uniform measure over all possible (x;t) values.

Equation (7) in plies that the log-price x (t) changes in a random fashion, but the rate of change is random ly dependent on both time and the current value of x. Note that random -walk models (2) and (5) may be recovered by taking S (x) 1 and choosing the time correlation R (t) appropriately. We will show that the x-dependence in the noise term yields qualitatively dierent results to the random walk models, and that many of the empirical observations (i)-(iv) of stock markets may be reproduced by (7).

The x-dependent noise term in (7) is motivated by recent studies in turbulent dispersion [18] and transport in dynam ically disordered media [19]. These investigations employ equation (7), but with a rather di erent interpretation: x(t) is the position vector (in 2 or 3 dimensions) of a passive tracer, and u(x;t)is the velocity vector eld which transports the tracer. The tracer is called passive because it is assumed not to a ect the velocity eld by its presence, and so u(x;t) is a prescribed random eld. An instructive example is the motion of a small buoy on the surface of the ocean [20]: the two-dimensional vector x(t)then describes the position of the buoy (by its longitude and latitude, say) while the tracer is moved by the ocean waves according to (7), with the Gaussian eld u(x;t) providing an approximate description of the ocean wave eld.

The distribution of such tracers resulting from motion in a Gaussian eld is known to be non-Gaussian, at least over short to intermediate timescales [18, 21]. C nucial to understanding this e ect is the dierence between the Eulerian velocity u(x;t), i.e., the velocity measured at the xed location x at time t, and the Lagrangian velocity

which is the time series of velocity measurements made by the tracer itself as it moves through the random eld [22]. When there is no x-dependence in the velocity eld u, the Eulerian and Lagrangian velocities coincide, but otherwise a Gaussian Eulerian velocity eld can yield non-Gaussian Lagrangian processes. The relationship between Eulerian and Lagrangian random processes is an active research area, especially in the case of a compressible (non-zero divergence) velocity eld which is of interest here [23, 24, 25].

O urm odel of the log-price uses a scalar \position" x (t) and \velocity" u(x;t) rather than the vector-valued analogues in the turbulent dispersion problem s described above. N evertheless, the concept of Eulerian and Lagrangian velocities carries over to the one-dimensional case, and so we will refer to x (t) as the \price tracer", with its \velocity" u(x;t) related by equation (7). The fact that the Eulerian velocity eld u(x;t) is G aussian allows us to obtain analytical results, and may be justiled as a consequence of the central limit theorem applied to the sum of many independent forces on stock prices. In this paper we will not further pursue a microeconom ic justication [26, 27] for (7), but rather concentrate on demonstrating that it may yield some of the observed statistical properties of empirical stock market data.

The remainder of this paper is structured as follows. In section 2 the consequences of the x-dependence of the noise in equation (7) are examined through some simple examples, and a special limiting case (single-scale eld) is highlighted. The statistics of the Lagrangian velocity (10) in the single-scale case are found analytically in sections 3 and 4, and are related to the statistics of the returns r. Numerical simulations of equation (7) are considered in section 5, and a simple method for generating M onte-C arlo time series in the single-scale case is found. Results from such simulations are presented in section 6, and compared to the stylized facts (i)-(iv), as presented in [6] and [5]. Section 7 com prises of discussion of the results and directions for future work.

2 X -dependent velocity elds

The concept of x-dependence in the velocity of the log-price x (t) was introduce in section 1. To gain some intuitive understanding of the e ect of such xdependence, we rst return to the random walk model with colored noise u_c (t), independent of x, as in (5) and (6):

For clarity, we consider in this section a speci c form for the time correlation R (t):

R (t) = exp

where a characteristic decay time T has been introduced. Figure 1 shows the contours of a single realization of the x-independent $u_c(t)$, negative values of the velocity being denoted by shaded areas and dotted contour lines. T in e increases along the horizontal axis, with the stock log price x m easured on the vertical axis. The motion of a stock tracer with initial condition x(0) = 0 is shown also;

note the negative rate of change of stock price in the shaded regions (negative velocity), and the positive rate of change in the regions where u > 0. Because there is no x-dependence in (11), the velocity eld depends only on time, and so the contours are vertical lines. By contrast, a simple x-dependent velocity eld of the type proposed in (7) has a non-trivial x-correlation function S (x) in equation (9); for example in Fig. 2 we use

where lde ness a correlation scale (l! 1 recovers the x-independent case). The contours in Fig. 2 display a more complicated structure than in Fig. 1, and this is rejected in the observed motion of the stock prices. The three parameters , T and lcharacterizing the random eld may be combined into one dimensionless quantity

and if the time, log price and velocity are re-scaled using these parameters:

then the equation of motion (7) becomes

Note that the re-scaled velocity eld a has unit variance. In Fig 2. the stock price motions resulting from solving (16) are shown for values of = 1, = 0.1, and = 0.01. When is large, the length scale lofthe random ness in x is much larger than the elect T of the random variation in time | this is analogous to the case of weak space dependence in turbulent dispersion problems studied in [18] using perturbation theory. In the case of 1, sm all deviations of the stock price distribution from a G aussian shape are found, with kurtosis less than 3. How ever, the studies of empirical data mentioned in section 1 indicate that the kurtosis of stock returns is much larger than 3, and so the weakly space-dependent theory does not seem relevant here.

The opposite limit, i.e., 1 appearsmore promising. In Fig. 2, we observe that the stock prices for parameter values = 0:1 and = 0:01 display some interesting generic features. Constrained by the equation of motion to move downwards in shaded regions (where the velocity α is negative), and upwards in unshaded regions, the stock tracers tend to become trapped near curves of $\alpha = 0$, with α positive below them and negative above them. These stable positions disappear when the zero-velocity manifold Yolds over', and the stock tracer is then driven by equation (16) to move quickly to another slow manifold. A complete understanding of the dynamics of the system as ! 0 requires a singular perturbation approach [29] to equation (16), but the important feature for our work is the following of the zero-velocity manifold by the stock tracer, punctuated by fast jumps.

An analytical approach to the general ! 0 case has not yet been found, but som e interesting features are highlighted by choosing a particularly sim ple form for the x-correlation function:

where k is a constant. This correlation function corresponds to a so-called single-scale' Gaussian velocity eld, which (as shown in [30]) can always be written in the form

where f (t) and g (t) are independent G aussian random functions of time, each with zero m ean, variance 2 , and a given correlation function R (t):

An example of motion in such a single-scale eld is shown in Fig. 3. Note the periodicity in the vertical direction, and the lack of jumps. In the remainder of this paper we will concentrate on this simplied example and show that many of the statistical characteristics of the resulting stock returns are remarkably similar to those observed in empirical data.

3 Lagrangian velocity and PDF

In this section we consider the statistical characterization of motion along the u = 0 curves of the single-scale random eld (18), according to the equation of motion (7), and with the Gaussian random functions f(t) and g(t) dened as in (19). Again, the analogue with tracer motion on the surface of a turbulence ocean proves instructive. The Eulerian velocity at a point x at time t is de ned by the random eld (18). Each tracer particle moving through this eld will, how ever, experience its own time history of velocity variations; this is called the Lagrangian velocity of the tracer v(t). The crucial point in our use of random eld models of stock price motion is that the Eulerian eld may, as in (18), have Gaussian statistics, while the Lagrangian velocity (that is, the velocity Yelt by the tracer') need not be Gaussian. Som e intuitive notion of why this might be m ay be gained from considering the fact that the velocity at space-time points (x;t) picked at random from the Eulerian eld has a Gaussian distribution; on the other hand, the dynam ics of the tracer particles mean that they are m ore likely to cluster in regions of low velocity, with high-velocity transitions between, meaning both zero values of v and high values are more likely than for a Gaussian distribution. This argument holds for any random eld, but as we

show in this section, a quantizative description m ay be derived in the case of a single-scale eld (17) for the ! 0 lim it.

In the limit of small , we saw in the previous section that the stock tracer motion is conned to curves with u = 0. While the Eulerian velocity on these curves is zero by de nition, the Lagrangian velocity is non-zero, as the tracer moves to remain on the u = 0 curve. In fact, the Lagrangian velocity felt by the particle trapped on such a curve is given by

with the derivatives evaluated on the curve u = 0. For the single scale eld (18), an explicit expression for the Lagrangian velocity m ay be found in terms of the functions f (t) and g (t) and their derivatives:

W hen the Lagrangian velocity v(t) is known, the equation of motion for the tracer is simply

C learly the statistics of the returns follow from the statistics of the Lagrangian velocity, indeed for short time lags it m ight be expected from (24) that

so that the distribution of returns, for instance, can be related directly to the distribution of the Lagrangian velocity. W e shall see later that (25) is not fully accurate for large values of v, but the Lagrangian velocity distribution w ill still prove extrem ely useful.

To nd the probability distribution function P (v) of the Lagrangian velocity, we rst consider the cumulative probability that the Lagrangian velocity v at a given time is greater than some chosen value V. A coording to (21), v > V if and only if

where we use the symbolF to denote the right-hand-side. Since f, g, f^0 and g^0 are independent G aussian random variables at any single moment in time, we denote their PDFs by P_f , P_g etc., and the cumulative probability of the event (26) is

Noting that the variances of f^0 and g^0 both equal ${}^2R^{(0)}(0) = {}^2={}^2_0$, where we introduce the notation ${}_0$ for the timescale defined by the initial radius of curvature of the function R:

The PDF (31) of the Lagrangian velocity P (v) is symmetric in v, and so has mean zero. Note that the tails of P (v) decay as jvj ³ for large jvj so the variance of v does not exist. A lso, (31) e ectively contains only one free parameter k ₀, and is otherwise independent of the choice of correlation function R (t) for f and g.

4 Correlation of Lagrangian velocity and returns

The (norm alized) correlation of the stock returns with lag , at time t, is dened by averaging the product of the returns at times separated by :

and for stationary returns becomes independent of t. The correlation is normalized by the variance r $(t)^2\,$ of the returns at lag , which is known as the squared volatility [6]. In this section we derive analytical results to show how the volatility and the returns correlation for a single-scale eld with $\, ! \, 0$ depend on the time correlation function R (t) of the Eulerian eld, and on $\,$ and $\, k .$

Because of the dependence (24) of the returns on the Lagrangian velocity, the correlation of the returns can be written in terms of the correlation function of v:

where we have used the stationarity of the returns, and de ned the Lagrangian velocity correlation function

Note the Lagrangian velocity is assumed to be a stationary process this has not been proven to follow from Eulerian stationarity in the general case [23], but appears to hold in numerical simulations. We will proceed to calculate L (t), and then use (34) to not the volatility and returns correlation. We note here that when the separation time is much larger than the lag , the returns covariance (34) is approximated by

The correlation function of the stationary random process v is written as an eight-dimensional integral, using the denition (21) of the Lagrangian velocity:

Here the eight-fold integrals are over f, g, f^0 and g^0 evaluated at each of the two times t = 0 (with subscript 1) and t = t (subscript 2). The random functions f and g are independent of each other, but the joint probability functions for f

and its derivative at di erent tim es is found from the Gaussian joint PDF

U sing (38) and (40) in (37) enables us to calculate the Lagrangian correlation L (t). We brie y describe here the steps in the calculation of the multidimensional integrals. First, the four integrals over the variables f_1^0 , g_1^0 , f_2^0 , g_2^0 are performed – the dependence of the integrand on each of these variables is linear, so the G aussian integrals may be calculated straightforwardly. For the remaining four variables, we transform to polar coordinates in the (f_1 ; g_1) and (f_2 ; g_2) planes:

The integral is then trivial, and by integrating over , r, and , the nalresult emerges:

Equation (42) gives an explicit formula for the Lagrangian velocity correlation in terms of the time correlation R (t) of the single-scale Eulerian eld. W hen the function R (t) is given, L (t) follows immediately from (42), and hence the volatility and returns correlation can be calculated using (34). Before examining the results for the returns, we consider the limiting forms of L (t) for sm all and large arguments.

A ssum ing that R (t) is su ciently smooth near t = 0 to allow the de nition of $_0$ as in equation (30), a small-time expansion of (42) yields

Note this diverges as t approaches zero, so the variance of the Lagrangian velocity does not exist, in accord with our conclusion at the end of section 3. For large tim e arguments, we are particularly interested in power-law decays of correlations, and so consider how the decay of R (t) in uncess that of L (t). Taking a power-law decay with exponent :

the corresponding Lagrangian correlation is found from (42) to decay as

The negative sign here indicates that the Lagrangian correlation approaches zero from below at large times, being negative whenever R (t) has a power-law decay.

The squared volatility is found by setting = 0 in (34):

For short lags, with $_0$, it follows from (43) that the volatility may be approximated by

vol²()

Note that while this expression limits to zero as vanishes, it does not follow a simple power law in because of the logarithm ic term. A lthough empirical stock volatilities have been tted with power-laws [6, 7], we show in the next section that (47) can also m atch the data quite well.

For large time lags , empirical data shows a linear growth in vol^2 with . From (46), we can nd an expression for the rate of change of vol^2 with :

and hence conclude that the squared volatility grows linearly with for large lags if the integral

has a nite positive value. Assuming a power-law form of R (t) for large arguments, we use the result (45) for the asymptotic form of L (t). It immediately follows that the integral (49) is nite if > 1=2, and hence at large lags the squared volatility grows linearly with in this case.

In empirical stock data, correlations of nonlinear functions of the returns often display signicantly slower decay than the correlations of the returns them selves. One quantity of interest is the correlation of absolute returns, which, using (25), may be related to the correlation of absolute Lagrangian velocities (for short lags) as

Following similar procedures as in the calculation of L (t), it can be shown that the large-t asymptotics corresponding to a power-law R (t) t give a correlation of absolute Lagrangian velocities scaling as

In contrast to (45), this correlation remains positive at large times; note too that its rate of decay is slower than that of (45).

Before proceeding to numerical simulations, we brie y summarize the theoretical results. We have obtained the PDF of the Lagrangian velocity in (31), and related the Lagrangian velocity correlation L (t) to the given Eulerian correlation R (t) in (42). This permits estimates of the volatility as a function of lag. Finally, we expect a power-law scaling for the absolute returns correlation when R (t) has a power-law decay. In the following sections we perform numerical simulations to con m and extend these results.

5 Num erical simulations

To extend the analytical results found in the previous section, we consider the in plem entation of num erical simulations of motion in random elds. Random elds u (x;t) may be generated using standard techniques [31], with the ordinary di erential equation (7) being solved using Runge-Kutta methods. A verages may be calculated over an ensemble of realizations, or over a long time series x (t) in a single realization, to closely m in ic the statistical analysis of S& P 500 data perform ed in [5, 6].

A random eld with zero m ean and correlation function (9) m ay be generated using a superposition of random Fourier m odes [31]:

$$u(x;t) = \frac{1}{N} \sum_{n=1}^{N} A_n \cos(!_n t + k_n x) + B_n \sin(!_n t + k_n x); \quad (52)$$

with the amplitudes A_n and B_n chosen from independent G aussian distributions of zero mean and variance ². The $!_n$ and k_n are chosen from distributions of random numbers chosen so as yield the correlation (9). Speci cally, the the $!_n$ are chosen from a distribution shaped as the Fourier transform of R (t), with the distribution of the k_n being the Fourier transform of S (x). Thus, G aussian distributions with zero mean and unit variance are used for the $!_n$ and k_n to generate the random eld of F ig. 1, as the Fourier transform s yield R (t) = exp($t^2=2$) and S (x) = exp($x^2=2$) as required in equations (12) and (13).

For the special case of a single-scale eld considered here, the k_n are all k, and the eld may be written in the simpler form (18), see [30]. A coordingly

we only require a m ethod for generating the random functions of time f (t) and g(t), and this is easily derived from (52):

with a similar formula for g(t). The A_n , B_n are chosen as above. We are especially interested in the e ects of power-law correlations R (t), so we choose the $!_n$ in (53) from the G am m a distribution [31]:

Here () denotes the usual G am m a function. The Fourier transform of G $(!\,)$ is the correlation function R (t) of f :

R (t) =

which decays as R (t) t for t T.

The m ethods described above are su cient to simulate m otion in a random eld as described by (7), or equivalently by the rescaled equation (16), and indeed this is how the stock log curves in Figs. 1 to 3 are generated. However, in the idealized limit ! 0 considered in the previous sections, the tracer closely follows the contour u = 0. In this limit it is therefore not necessary to explicitly solve the di erential equation to determ ine x (t) in a single-scale eld, as this can be determ ined from the implicit equation u(x;t) = 0. From (18) we immediately obtain

form otion along the u = 0 contour. G iven the expression (53) for f (t) and g(t), equation (56) then generates the time series x (t). Some care must be taken to ensure continuity of x (t) near times when g(t) = 0, but overall this method is a very e cient way to create a model time series for x (t).

6 Num erical results

In this section we report the results of employing the algorithm (56) to generate a sample time series x (t) corresponding to a single-scale eld, with Eulerian time correlation function given by (55). Having decided upon a single-scale eld and the ! 0 limit, so that the stock tracer follows contours of u(x;t) = 0, our remaining choices to t empirical stock data is rather limited. We are free to choose the time correlation function R (t) and the spatial scaling factor k; note the standard deviation of the random eld has disappeared because we have take the limit ! 0.

O ur choice for R (t) is motivated by the empirical results such as those reported in [6], and by our analysis in previous sections. We have seen in section 4 that the Lagrangian velocity correlation becomes negative, with a power-law decay exponent of 2 2 when R (t) has a power-law decay exponent of 0 n the other hand, the correlation of absolute values of the velocity remains positive for large t, with a decay exponent 2. Studies of the corresponding returns correlations in [6] have concluded that the correlation decays exponentially quickly to the noise level, whereas the absolute returns correlation exhibits a slow decay with power-law exponent of approximately 1=3. M atching this to our result (51) motivates us to choose a power-law form for R (t) as given in (55), taking the value of = 1=6. The tim e-scaling T is chosen to be 10 m inutes, to approximately match the volatility results of [6]. Having thus de ned the function R (t), we are left with only the single parameter k. This is chosen to be 500, to approximately t the volatility results (see below) to those in [6].

Each realization consists of 1:6 10^6 values of x (t), m odelling the log price at 1-m inute intervals, to m im ic the S&P 500 data set used in [5]. A veraging is over time within each realization; we show results from dierent realizations only when statistical scatter is evident in the single-realization results. From the series for x (t), it is straightforward to calculate the series of returns over integer time lags

and to calculate various statistical properties of the returns.

The volatility

found by numerical simulation is plotted as a function of the lag in Fig. 4 (led circles). The parameter k is chosen as k = 500, in order to closely m atch the empirical = 1 volatility value as shown in Fig. 3 (c) of [6]. A lso shown in Fig. 4 is the analytical result (46), plotted as a dotted line, which con m s that the num erical method closely reproduces the exact results of section 4. The dashed line in Fig. 4 is the small-lag approximation (47), and shows that the super-di usive region of volatility (for lags under 10 m inutes) is well-m atched by the logarithm ic-corrected quadratic power law in . A nalysis of the empirical data frequently leads to thing the super-di usive volatility with a power-law, with exponents in the range 0.67 [6] to 0.77 [7]. At longer lags (> 10), random) is observed in all studies, and reproduced in our walk behavior (vol model as shown following equation (49). The solid lines in Fig. 4 show powerlaw scalings, with exponents 0.77 (for < 10), and 0.5 (for 10), which are found in [7] to m atch the S& P 500 volatility. C learly these scalings also m atch the results of our model quite well, indicating that the model predictions behave sim ilarly to the em pirical volatility curve. Indeed, our result (47) predicts that a log-corrected quadratic t should be superior to the power-law ts used in [6, 7]. Testing this prediction requires higher frequency analysis of the empirical m arket data.

The probability distribution function (PDF) of the one-m inute returns, r_1 (t), is plotted in Fig. 5.0 pen circles are from num erical simulations, and are welltted by the Lagrangian velocity PDF (31), up to high returns values. Note the returns are norm alized by their standard deviation vol(1) = 2 10⁴. The Gaussian distribution with this standard deviation is plotted with the dotted line: note the higher than G aussian central peak of the m odel results, and the fatter tails. Fig. 5 is remarkably similar to Fig. 2 of [5], which shows the one-m inute returns PDF from the S&P500. Indeed, in [5] it is demonstrated that the empirical results are well-tted near the center of the distribution by a Levy stable distribution with index = 1:4, and so in Fig. 5 we also show this distribution (dashed line), with scale factor chosen to m atch the peak value of the num erical distribution. Comparison with Fig. 2 of [5] shows that our num erical simulation returns have a very similar distribution to the S&P 500 data, at least within 10 .

In Fig. 6 we consider the correlation function of the one-m inute returns over a separation time \cdot , norm alized by the volatility:

As this quantity has both positive and (sm all) negative values, we plot its absolute value on a log-linear scale. Statistical scatter causes som e uncertainty in these num erical results, so the results of two di erent realizations (circles and triangles, respectively) are shown. A coording to (36) and (45), the returns correlation is negative for 10 m inutes, which is con med by plotting the analytical result (34): this is shown as a solid line where the correlation is positive, and a dashed line where it is negative. The num erical simulation results m atch the analytical form well for < 10 m inutes, but degrade in quality when the correlation is negative. It is possible that more advanced num erical sim ulation m ethods such as Fourier-W avelet [31] could alleviate this problem . Note lled symbols show positive numerical correlation values, with open symbols for negative values. The rapid decay of the correlation from = 0 to = 10m inutes (see dotted line showing exp(=3) for comparison) is rem iniscent of that found in S&P 500 data, see Fig. 3(a) of [6] and Fig. 8(a) of [28]. Unlike our model results, how ever, the empirical correlation does not exhibit negative values but instead reaches a \noise level" around 3 10³, where it attens out without discemable structure. Our model suggests that it might be fruitful to search for evidence of negative correlations in the empirical data, which may currently be screened by the noise level.

The correlation function of the absolute value of one-m inute returns (normalized to unity at zero separation) is

From empirical data, this is known to have a slow power-law decay with , with exponent of approximately 1=3, see Fig. 3 (b) of [6] and Fig. 8 (b) of [28]. The

analytical result (51) for the present model indicates that a similar power-law form holds, indeed this is what motivated our choice of parameter = 1=6 in (55). Fig. 7 shows numerical results from two separate realizations (circles and triangles), with the solid line showing a power-law decay with exponent 1=3. The numerical correlations are all positive, but show a slight deviation from the expected power-law scaling. Thism ay be related to the poor representation of the negative values of the returns correlation in Fig. 6. Comparison with empirical data (Fig. 3(b) of [6] and Fig. 8 (b) of [28]) also shows that the model's correlation decays faster than that of the S&P500 data for < 10 m inutes.

The non-G aussian distribution of returns over longer time lags is exam ined in Figs. 8 and 9, using the m ethods applied to S& P 500 data in Figs. 6 to 8 of [6]. The norm alized returns are de ned by dividing by the volatility:

g (t) =

and the m om ents

of the num erical sim ulations are plotted in Fig. 8 (a) as a function of m, for lags of 1, 16, 32, 64, and 128 m inutes. The extrem ely non-G aussian distribution at = 1 m inute relaxes to a shape which remains stable up to 128 m inutes

note the moments for lags from 16 to 128 m inutes are almost indistinguishable in Fig. 8 (a). This conclusion is supported by the cum ulative distribution of the norm alized returns shown in Fig. 8 (b). This is very similar to the behavior observed in empirical data, see Fig. 6 of [6], although the model does not produce power-law scaling of the distribution tails (except for the region with exponent -2 for lag = 1 m inute). The returns distributions eventually converge to a G aussian distribution, see the corresponding plots for lags of 390, 780, and 1560 m inutes (1 to 4 trading days) in Fig. 9. This convergence to G aussian is som ewhat faster that that observed in the S& P 500 in [6], where non-G aussian m om ents and cum ulative distributions persist until approxim ately 4 days. O ur corresponding estim ate for the m odel persistence time (based on the m om ents in Fig. 8 (a)) is 128 m inutes, an order of m agnitude sm aller that the S& P 500 value.

The scaling of the peak P (0) of the PDF of stock price returns S (t+) S (t) was examined in [5] for S& P 500 data. A power-law scaling of P (0) with lag was discovered, with exponent 0:7. In Fig. 10 we min ic this study, generating the time series S (t) from x (t) in order to calculate the stock price return. Results are shown from two separate realizations, along with a line indicating G aussian scaling of exponent 1=2. It is clear that, unlike the S& P 500 returns, the model P (0) does not scale as a single power-law with , although it appears to approach the G aussian scaling at the highest lags.

7 Conclusion

We have proposed a new model for the uctuations of stock prices, in which the rate of change of the log price is random ly dependent upon both time and the current price, see equation (7). This is a very general modelling concept, with the attractive feature that G aussian Eulerian elds may give non-G aussian Lagrangian statistics in the observable data, i.e. the time series of returns. As noted in section 5, M onte-C arlo simulations of equation (7) can be used to nd the model predictions for any random eld. In this paper we focus on a special case, the ! 0 limit of a single-scale random eld, for which exact analytical results are obtainable, and for which num erical simulations are particularly e cient.

O urm ain analytical results are the expression (42) for the Lagrangian velocity correlation L (t) in term s of the given Eulerian eld correlation R (t), and the quadrature form ulas (34) and (46) giving the correlation function and volatility of the returns. Num erical simulations of stock price time series are e ciently perform ed using equation (56), and allow us to exam ine features not am enable to exact analysis.

We nd that several of the important empirical stylized facts (i)-(iv) listed in the Introduction are reproduced by our model, using the correlation function (55) for computational convenience. The parameter values k and T are chosen by comparing them odel's volatility to the data in Fig. 3 (c) of [6]. With reference to the stylized facts listed in section 1, the results of the single-scale random eld model may be sum marized as follow s.

- (i) M odel returns are non-G aussian, with fat tails and the center of the distribution well- tted by the Levy distribution used in [5]. The tails of the cumulative distributions of model returns do not, how ever, have the power-law scaling found in [6]. The normalized model returns distributions exhibit a slow return toward G aussian, on timescales an order of m agnitude longer than the characteristic time of R (t). How ever, these timescales are an order of m agnitude sm aller those found for the convergence to G aussian in the S& P 500 returns in [6].
- (ii) The correlation function of model returns decays quickly (similar to exponentially) over a short timescale. Following the fast decay, the correlation becomes negative, with magnitude decaying more slow ly to zero. Although the fast decay for lags under 10 m inutes is very similar that found for the S& P 500 in [6], the empirical correlation function does not reach negative values, rather remaining at a constant \noise level". Whether this noise level could be masking negative correlation values as predicted by the model is a question requiring further extensive analysis of market data.
- (iii) The volatility of the model returns grows di usively for lag times longer than 10 m inutes. The super-di usive volatility at higher frequencies (shorter lags) is actually due to a logarithm ic correction to power-law growth (47),

but for the range of lags exam ined in [6, 7] it matches well to a superdi usive power-law. Higher frequency data is needed to determ ine which form best ts the actual stock market volatility.




Figure 1: M otion of a stock tracer in a random eld which depends only on time, as in (5). Shaded areas and dotted contour lines indicate negative values of $u_c(t)$.

(iv) Ourmodel does not have a simple scaling of P (0) with lag, in contrast to the case of S& P 500 prices as demonstrated in Fig. 1 of [5].

In sum m ary, the single-scale random eld m odel yields time series which have m any (but not all) of the important properties of empirical data. The m odel gives an appealingly intuitive picture of the causes of non-G aussian behavior in m arkets, and provides a simple algorithm for generating time series with m any m arket-like features. We anticipate that this algorithm will prove particularly useful in M onte-C arlo simulations to determ ine prices of options and derivatives when non-G aussian returns are particularly important [3, 4].

The concept of m odelling stock prices by m otion in a random eld is quite general, and suggests m any directions for further work. A m ong these are:

- (a) Examining the consequences of such models for the pricing of options and derivatives, and comparison with the standard Black-Scholes (random walk-based) results.
- (b) Further m arket data analysis, to determ ine if there is any evidence of the negative correlation or log-corrected volatility scaling discussed in (ii) and (iii) above.
- (c) Finding a microeconom ic basis for the random eld model (7), possibly based on the actions of multiple independent agents [26, 27].
- (d) Num erical simulations of (7) for more general eld correlations S (x) and di erent values, to determ ine which of the results detailed here are universal features of motion in random elds, and which are specic to the single-scale, ! 0 case analyzed here.




Figure 2: M otion of stock tracers in a random eld which depends on both time and x, as in (7). The correlation functions are (12) and (13), and the values of are: = 1:0 (dash-dotted), = 0:1 (dashed), and = 0:01 (solid).




Figure 3: Motion of stock tracers in a single-scale random eld. See Fig. 2 for description of line types.




Figure 4: Volatility of returns as a function of lag time \cdot . Symbols show the results of numerical simulation; dotted line is the analytical expression (46); dashed line is the small- approximation (47); solid lines show power-laws with exponent 0.5 (large lags), and 0:77 (small lags), as tted to empirical data in [7].




Figure 5: Probability distribution function of 1-m inute returns from num erical simulation (symbols). Dashed line is the Levy distribution tted to empirical data in [5]; solid line is the Lagrangian velocity PDF (31); dashed line is a Gaussian distribution with same variance as the data.




Figure 6: M agnitude of the correlation function of 1-m inute returns, as a function of separation time \cdot . Numerical results from two realizations are shown (circles and triangles), with the analytical form (34) (solid and dashed lines). Negative correlation values are shown with open symbols and dashed line. The dotted line shows exp(=3) for comparison.




Figure 7: Correlation function of absolute 1-m inute returns, as a function of separation time \cdot Numerical results from two realizations are shown (circles and triangles). The solid line is a power-law scaling as (51).




Figure 8: (a) M om ents of the norm alized returns, for lag times = 1, 16, 32, 64, and 128 m inutes. (b) C orresponding cum ulative distribution functions, with the dashed line showing a power-law with exponent -2.




Figure 9: (a) M om ents of the norm alized returns, for lag times = 390, 780, and 1560 m inutes. (b) C orresponding cum ulative distribution functions.




Figure 10: Scaling of the peak P (0) of the stock returns PDF with lag time . Solid line shows a Gaussian scaling, with exponent 0.5.
