# E ects of Random ness on P ower Law Tails in M ultiplicatively Interacting Stochastic P rocesses

Generally, random ness causes decrease of the exponent of tails and the grow th rate of processes. Explicit calculations are perform ed for tw o exam ples: uniform ly distributed and two peaked system s. Signi cant in uence is dem onstrated when a bare grow th rate is low and coupling is weak. It should be em phasized that even the sign of the grow th rate can be changed from positive to negative grow th.

KEYW ORDS: power law, randomness, multiplicative interaction, stochastic process

P ower law s are w idely observed not only in natural system s but also in social phenom ena [15. A num ber ofe orts have been $m$ ade to explain these behavior [8] but the underlying physics has not been clari ed yet. Recently, inelastic $M$ axwell m odels where random ly chosen particles collide inelastically w ith each other have been studied extensively in the context of granular $m$ aterials [9-11]. T hen it has been show $n$ that probability distribution functions of particle velocities have a non-integer pow er law tailasym ptotically. The exponent oftails is determ ined from a transcendentalequation and, generally, is a continuously varying function of a param eter, i.e., a coe cient of restitution. The system exhibits a kind of self-organized criticality. N on-integer pow er laws em erge not at a special (critical) value of a param eter but in a wide range of a param eter. ben-A vraham et al. [12] have extended these studies to m ultiplicatively interacting stochastic processes. Here the system is com posed ofn (1) particles w ith positive variables $x_{i}>0(i=1 ; 2 ; \quad ; N)$ and evolves $w$ ith $m u l t i p l i c a t i v e ~ i n t e r a c t i o n s ~$ between random ly chosen particles $i$ and $j$

where a and b are positive param eters. W hen the eigenvalue ${ }_{\mathrm{A}}=\mathrm{a}+\mathrm{b}$ of the m atrix $A$ is $m$ ore (less) than unity, the system grows (declines) totally. The case $a+b=1$ corresponds to inelastic $M$ axw ellm odels w here the totalam ount of variables ( $m$ om enta)
is conserved. Power law tails appear at $\mathrm{a}+\mathrm{b}<1$, $\mathrm{a}>1$, or $\mathrm{b}>1$ and the exponent varies continuously with a and b.

In actual processes, interactions som etim es accom pany random ness. Especially, $m$ esoscopic and/or $m$ acroscopic system such as granular m eterials are com posed of not identical but polydisperse particles. In social phenom ena, m oreover, individuality of agents inevitably results in random ness in interactions. $N$ ote that the process (1) is a reasonable $m$ odel describing wealth distribution in econom ical system $s$ [13]. In this Letter, therefore, we exam ine e ects of random ness on power law tails in multiplicatively interacting system s.

W e consider processes where $a$ and $b$ are random param eters $w$ th probability distribution (a;b). A master equation for probability distribution functions $f(x ; t)$ is given by

The Fourier transform of eq. (2) is

where $g(k ; t)={ }^{R} d x f(x ; t) e^{i k x}$. The im portant property ofeq. (3) is that its mom ent equations becom e a closed set [911]. Expanding as $g(k ; t)=1+{ }_{n=1}^{1} n(t)(i k)^{p}=n$ ! and substituting into eq.(3), we have

Here the bar denotes average with respect to (a;b). Equation (4) can be solved sequentially, which enable us to treat eq.(3) analytically. H ere we pursue a sim ilarity (scaling) solution of the type

where expresses a grow th rate of the system. Substitution of eq.(6) into eq.(3) leads to

The inverse Fourier transform of ( ) gives scaled distribution functions

W e pay our attention to tails in the sm all and large lim it. This lim it is classi ed into tw o cases and treated separately. In case I, we m ake the follow ing ansatz,

where represents a non-integer power. Substituting eq.(9) into eq. (7) and equating term s of each powers ', we get

The grow th rate is given by eq. (10) and the exponent is determ ined from the com bined equation of eqs.(10) and (12)

The transoendentalequation (13) alw ayshas a trivialsolution $s=1 . W$ hen a nontrivial solution $s=s$ exists in a region $s>1$, it gives the exponent $=s$. In case II where $\mathrm{s}<1$, we m ake the ansatz,

instead ofeq.(9). In this case, we have only the O ( ) term, eq. (12), and the transcendentalequation

H ere we need one $m$ ore condition to determ ine two variables and sfrom one equation (15). The answer is the selection of the $m$ inim um grow th rate originally reported by ben-A vraham et al. [12]. W hen the line $s$ and the curve $\overline{a^{s}}+\overline{b^{s}} 1$ come in contact at $s=s$, the grow th rate becom esm inim um and $s$ gives the exponent less than unity.

N ow we study e ects of random ness. First, we com pare the exponent and the grow th rate $w$ ith those 0 and 0 in the absence of random ness, which are determ ined from

where $a_{0}=\bar{a}$ and $b_{0}=\bar{b}$. $w$ hen $s>1, a^{s}$ is a downwards convex function of $s$ and $\overline{a^{s}}>\bar{a}^{s}$, while $a^{s}$ is upw ard convex and $\overline{a^{s}}<\bar{a}^{s}$ at $s<1$. It follow $s$ that solutions of eqs.(13) and (15) are alw ays sm aller than those of eqs. (16) and (17),

It becom es evident that random ess causes decrease of the exponent of tails. At the sam e tim e, the selection of the $m$ inim um grow th rate leads to possible decrease of the grow th rate

Next, we carry out explicit calculations for two exam ples. First exam ple is an uniform ly distributed system described by

The transoendental equations (13) and (15) read

where $a_{0}=\left(a_{1}+a_{2}\right)=2$ and $b_{0}=\left(b_{1}+b_{2}\right)=2$. C om puted values of the exponent and the grow th rate areplotted in F ig 11 as a function of $\quad\left(\begin{array}{ll}a_{2} & a_{1}\end{array}\right)=\left(\begin{array}{ll}2 a_{0}\end{array}\right)=\left(\begin{array}{ll}b_{2} & \mathrm{p}\end{array}\right)=\left(2 \mathrm{~b}_{0}\right)$. $W$ hen $a_{0}$ is close to unity and a bare grow th rate of system $s$ is quite low, dim inishes drastically $w$ ith increasing random ness , whereas decrease of is rem arkable at sm all bo and weak coupling. N otice that changes even its sign from positive to negative grow th.

Second exam ple is a two peaked process expressed as

where $a_{0}=p a_{1}+\left(\begin{array}{ll}1 & p\end{array}\right) a_{2}$ and $b_{0}=p b_{1}+\left(\begin{array}{ll}1 & \mathrm{p}\end{array}\right) \mathrm{l}_{2} . F$ igure 2 show s num erical results, where $\quad\left(\begin{array}{lll}1 & p)(2 & a_{1}\end{array}\right)=a_{0}=\left(\begin{array}{lll}1 & p\end{array}\right)(b \quad l)=b_{0}$. Sim ilarly in the case of uniform distribution, random ness exerts serious in uence at low bare grow th rates and weak coupling. In addition, we nd that when ( $1 \quad \mathrm{p}$ ) 1 , a few am ount of im purities (aliens) w th a large param eter $\mathrm{a}_{2}$ extrem ely reduce values of and.

From view points of econophysics, conclusions obtained in this work might be im portant for several reasons. (1) As m entioned before, individuality and associated random ness necessarily exist. (2) Low bare grow th rates and weak coupling are realistic conditions. (3) The decrease of the exponent of tails gives enlargem ent of wealth di erentials and has a signi cant econom icalm eaning as well as the decrease of the grow th rate. It would be interesting to analyze wealth distribution by taking into account individuality and random ness.
