E ects of Random ness on Power Law Tails in Multiplicatively Interacting Stochastic Processes

E ects of random ness on non-integer power law tails in multiplicatively interacting stochastic processes are investigated theoretically. Generally, random ness causes decrease of the exponent of tails and the growth rate of processes. Explicit calculations are performed for two examples: uniform ly distributed and two peaked systems. Signi cant in uence is demonstrated when a bare growth rate is low and coupling is weak. It should be emphasized that even the sign of the growth rate can be changed from positive to negative growth.

KEYWORDS: power law, random ness, multiplicative interaction, stochastic process

Power laws are widely observed not only in natural system s but also in social phenom ena [1-5]. A number of e orts have been m ade to explain these behavior (6-8] but the underlying physics has not been clari ed yet. Recently, inelastic M axwell m odels where random ly chosen particles collide inelastically with each other have been studied extensively in the context of granular m aterials [9-11]. Then it has been shown that probability distribution functions of particle velocities have a non-integer power law tail asym ptotically. The exponent of tails is determined from a transcendental equation and, generally, is a continuously varying function of a parameter, i.e., a coe cient of restitution. The system exhibits a kind of self-organized criticality. Non-integer power laws emerge not at a special (critical) value of a parameter but in a wide range of a parameter. ben-A vraham et al. [12] have extended these studies to multiplicatively interacting stochastic processes. Here the system is composed of N (1) particles with positive variables $x_i > 0$ (i = 1;2; ;N) and evolves with multiplicative interactions between random ly chosen particles i and j

where a and b are positive parameters. When the eigenvalue $_{A} = a + b$ of the matrix A is more (less) than unity, the system grows (declines) totally. The case a + b = 1 corresponds to inelastic M axwellm odels where the total am ount of variables (m om enta)

is conserved. Power law tails appear at a + b < 1, a > 1, or b > 1 and the exponent varies continuously with a and b.

In actual processes, interactions som etim es accom pany random ness. Especially, m esoscopic and/or m acroscopic system s such as granular m eterials are com posed of not identical but polydisperse particles. In social phenom ena, m oreover, individuality of agents inevitably results in random ness in interactions. Note that the process (1) is a reasonable m odel describing wealth distribution in econom ical system s [13]. In this Letter, therefore, we exam ine e ects of random ness on power law tails in multiplicatively interacting system s.

We consider processes where a and b are random parameters with probability distribution (a;b). A master equation for probability distribution functions f(x;t) is given by

The Fourier transform of eq.(2) is

where $g(k;t) = {}^{R} dx f(x;t) e^{ikx}$. The important property of eq.(3) is that its moment equations become a closed set [9-11]. Expanding as $g(k;t) = 1 + {}^{P} {}^{1}_{n=1 n}(t)$ (ik = n! and substituting into eq.(3), we have

Here the bar denotes average with respect to (a;b). Equation (4) can be solved sequentially, which enable us to treat eq.(3) analytically. Here we pursue a similarity (scaling) solution of the type

where expresses a growth rate of the system . Substitution of eq.(6) into eq.(3) leads to

We pay our attention to tails in the small and large limit. This limit is classied into two cases and treated separately. In case I, we make the following ansatz,

where represents a non-integer power. Substituting eq.(9) into eq.(7) and equating terms of each powers $\dot{}$, we get

The growth rate is given by eq.(10) and the exponent is determined from the combined equation of eqs.(10) and (12)

The transcendental equation (13) always has a trivial solution s = 1.W hen a nontrivial solution s = s exists in a region s > 1, it gives the exponent = s. In case II where s < 1, we make the ansatz,

instead of eq.(9). In this case, we have only the O () term , eq.(12), and the transcendental equation (12)

Here we need one more condition to determ ine two variables and s from one equation (15). The answer is the selection of the minimum growth rate originally reported by ben-Avraham et al. [12]. When the line s and the curve $\overline{a^s} + \overline{b^s}$ 1 come in contact at s = s, the growth rate becomes minimum and s gives the exponent less than unity.

Now we study elects of random ness. First, we compare the exponent $\$ and the growth rate $\$ with those $\$ and $\$ o in the absence of random ness, which are determined from

where $a_0 = \overline{a}$ and $b_0 = \overline{b}$. When s > 1, a^s is a downwards convex function of s and $\overline{a^s} > \overline{a}^s$, while a^s is upward convex and $\overline{a^s} < \overline{a}^s$ at s < 1. It follows that solutions of eqs.(13) and (15) are always sm aller than those of eqs.(16) and (17),

It becomes evident that randomess causes decrease of the exponent of tails. At the same time, the selection of the minimum growth rate leads to possible decrease of the growth rate

Next, we carry out explicit calculations for two examples. First example is an uniform ly distributed system described by




Figure 1: Calculated values of (a) exponents of tails and (b) growth rates of processes in uniform ly distributed system s at $a_0 = 1.01$, $b_0 = 0.001$ (| | {), $a_0 = 1.01$, $b_0 = 0.001$ () and a = 1.1, $b_0 = 0.001$ ().

The transcendental equations (13) and (15) read

where $a_0 = (a_1 + a_2)=2$ and $b_0 = (b_1 + b_2)=2$. Computed values of the exponent and the growth rate are plotted in Fig.1 as a function of $(a_2 - a_1)=(2a_0) = (b_2 - b_2)=(2b_0)$. When a_0 is close to unity and a bare growth rate of systems is quite low, diminishes drastically with increasing random ness, whereas decrease of is remarkable at small b_0 and weak coupling. Notice that changes even its sign from positive to negative growth.

Second example is a two peaked process expressed as




Figure 2: Calculated values of (a) exponents of tails and (b) growth rates of processes in two peaked systems at p = 0.9 (| | {), p = 0.5 () and p = 0.1 () w_0 its at 01 and $b_0 = 0.01$.

where $a_0 = pa_1 + (1 p)a_2$ and $b_0 = pb_1 + (1 p)b_2$. Figure 2 shows num erical results, where $(1 p)(a_2 a_1)=a_0 = (1 p)(b_2 b_2)=b_2$. Similarly in the case of uniform distribution, random ness exerts serious in uence at low bare grow th rates and weak coupling. In addition, we not that when (1 p) = 1, a few amount of impurities (aliens) with a large parameter a_2 extremely reduce values of and .

From view points of econophysics, conclusions obtained in this work m ight be im portant for several reasons. (1) As mentioned before, individuality and associated random ness necessarily exist. (2) Low bare grow th rates and weak coupling are realistic conditions. (3) The decrease of the exponent of tails gives enlargement of wealth di erentials and has a signi cant econom ical meaning as well as the decrease of the grow th rate . It would be interesting to analyze wealth distribution by taking into account individuality and random ness.
