A sym ptotic behavior of the Daily Increm ent Distribution of the IPC, the Mexican Stock Market Index

Abstract. In this work, a statistical analysis of the distribution of daily uctuations of the IPC, the M exican Stock M arket Index is presented. A sample of the IPC covering the 13-year period 04/19/1990 - 08/21/2003 was analyzed and the cumulative probability distribution of its daily logarithm ic variations studied. Results showed that the cumulative distribution function for extreme variations, can be described by a Pareto-Levy model with shape parameters = 3:634 - 0.272 and = 3:540 - 0.278 for its positive and negative tails respectively. This result is consistent with previous studies, where it has been found that 2:5 < 4 for other nancial markets worldwide.

P resentam os un analisis estad stico de la distribución de uctuaciones diarias del ndice de la Bolsa M exicana de Valores, el llam ado IPC (Indice de P recios y C otizaciones). E studiam os la función de distribución acum ulativa de las diferencias logar tm icas diarias calculadas a partir de una muestra del IPC que cubre un periodo de 13 años, que em pieza el 19/04/1990 y naliza el 21/08/2003. Hallam os que esta función de distribución acum ulativa puede describirse para los valores extrem os de estas diferencias mediante una distribución de Pareto-Levy (ley potencia) con exponentes = 3:634 0.272 y = 3.540 0.278 en sus colas positiva y negativa respectivam ente. E ste resultado es consistente con estudios previos que muestran que 2.5 < 4 para los mercados nancieros de diferentes partes del mundo.

1 Introduction

The behavior of extrem e variations of econom ics indexes, stock prices or even currencies, has been a topic of interest in nance and econom ics, and its study becomes relevant in the context of risk management and Financial Risk Theory. However, these analyses are usually dicult to perform due to the small number of extreme observations in the tails of the distributions of nancial time series variations. Recently, the interest of the physics community in the behavior of nancial markets, has strongly increased, boosted by the availability of worldwide, electronically recorded nancial data, giving rise to a dierent approach to confront problems arising from econom ics. The collection of methods and techniques originally developed in the area of physics, which are currently applied in the study of nancial complex systems, is now called

E conophysics and \pm is becoming an emergent branch of physics by \pm self [1,2,3,4,5,6].

In order to describe the behavior of the distribution of nancial time series variations, several models have been proposed. Some of them are:

- { Gaussian distribution [7].
- { Log-gaussian distribution (Geometric Brownian Motion) [8].
- { Stable Levy distribution [9,10,11].
- { Truncated Levy D istribution [12,13,14].
- { Poisson like distribution [15,16].
- { Power law Distribution with '3 [17] (A sym ptotically).

In this paper, a statistical analysis of the distribution of daily variations of the $\mathbb{P} \mathbb{C}^1$ is presented. It is organized as follows. In the remaining of this section, we brie y review

the Pareto-Levy distribution, and some of the phenomena it describes are mentioned. In next section, a very short introduction to the variables of common use in the study of nancial index and prices variations is given. In section 3, we introduce the sample data analyzed in this work and some important statistical properties of nancial time series variations (fat tails, clustering volatility, etc)² are discussed, all the above in the context of the IPC data. In section 4 we explain and justify the procedure to estimate the Pareto-Levy exponent from data and we show the results concerning the ton the tails of the cumulative distribution of the IPC daily logarithm ic variations. Finally, last section is devoted to compare our results with some other related studies of dierent international stock markets previously reported.

1.1 Pareto-Levy D istribution. Stable D istributions

At this point, it is convenient to make a review of the de nition of the Pareto-Levy distribution:

An absolutely continuous random variable Y, is said to follow a Pareto-Levy distribution W if its cumulative distribution function W has the form:

with y_i y_0 , y_0 = and > 0. When the condition > 2 holds, the mean and variance of Y are both nite and by the central limit theorem, the sum of independent Pareto-Levy distributed random variables, converges in probability to a gaussian law. On the other hand, when

< 2, the Pareto-Levy distribution has in nite variance, and it is said that the distribution is stable. For a mathem atical treatment of these topics, consult [19] and [20]. For a review from an econophysics point of view, references [6,21] are recommended.</p>

The Pareto-Levy distribution is offen known as the Powerlaw distribution, and its role in Physics and other areas seems ubiquitous. In particular, we can illustrate this point by the following examples taken from nance:

- { N $_{\rm t}$, the number of trades in a given interval of time t, follows a power-law distribution with exponent ' $\frac{3}{2}$ [22].
- { Pareto-Levy tails, with '3 for extreme variations of individual stocks prices [23] and also for indexes of dierent leading stocks markets [17,24,25].
- { Decay of volatility correlations follows a power law distribution [26,27].
- { The tail behavior of the cumulative distribution function of volatility, is consistent with a power law distribution with exponent '3 [28].

All the above suggests universality in nancial complex systems and in order to explain the above facts, new models and even theories, are currently being proposed [26,29, 30,31].

2 Study of variations of nancial time series

In the study of price variations of nancial assets, many observables can be analyzed [6]. If Y (t) is the value of the index at time t, some commonly used observables are:

{ Prices or indexes changes them selves, for som e interval of time t:

Where D (t) is a statistical factor or index called a discount or a de ation factor, and used to adjust the time value of money, enabling the comparison of prices while accounting for in ation, devaluation, etc. in dierent time periods.

Retums, de ned as:

{ Dierences of the natural logarithm of prices³, de ned for some interval of time tas:

$$S(t) := \ln Y(t+t) \quad \ln Y(t) \tag{5}$$

Each one having its own merits and disadvantages [6]. In this analysis, we have used the form er variable S (t).

3 Data sample and IPC variations




Fig. 1. IPC developm ent for the 13 year period 04/19/1990-08/21/2003.

The database containing the IPC series analyzed here is available at [32] and covers the 13-year period 04/19/1990 - 08/21/2003. Figure 1 shows the IPC evolution for this time period. We have used in our analysis the daily closure values of the IPC, that is, its recorded value at the end of each trading day

In this work, our observable is S (t) as de ned in equation 5, and we studied the tail behavior of P (S (t)) = $1 ext{ F (S (t)), for } t = 1; ext{:::;} N$, where N = 3337 is our sample size and t = 1 day.




Fig. 2. IPC variations.a) Histogram of Z(t), the daily changes of the IPC index. The distribution shows symmetry and fat tails. b) Histogram of S(t). Regions studied in this paper, S(t) > 0.035 and S(t) < 0.035, are indicated by two vertical lines.c) Same as above, but with a vertical logarithm ic scale. The broken line corresponds to a gaussian density with the same mean and standard deviation than the S(t) distribution.

Figure 2a shows the histogram of Z (t), the IPC daily changes. It is interesting that this strongly sym m etric and leptokurtic (fat tailed) distribution does not follow any well known m odel, which could appropriately describe the probability of events in its central region and in its tails at once.

² In nance, to these statistical properties of nancial time series, jointly with other such as the properties of interm ittency, asymmetry in time scales, absence of autocorrelations, gain/loss asymmetry etc., are called "Stylized facts" [18].

Figures 2b and 2c show the distribution of our observable S (t). Figure 2b shows that the distribution of S (t) appears to follow a gaussian. This is discarded after observing gure 2c, the same distribution with a vertical logarithmic scale. There are too many extreme events visible almost as far as ten standard deviations from its mean. To easily comparing with, gure 2c broken line is a gaussian scaled to the amplitude of S (t) and with the same mean and standard deviation than those of the S (t) series.

Figure 2 shows how IPC variations are distributed; however it does not give any insight about the dynam ics of the stochastic process that governs them . Evolution of the IPC daily log-di erences is displayed in gure 3a. We observe that large variations are not uniformly distributed over time, and that is possible to distinguish phases of higher

volatility ⁴ alternated with phases of a relative nancial calm .This is a characteristic of nancial time series called clustered volatility.

The clustering phenom enon has not been completely understood, however some successful models, such as the GARCH and Stochastic Volatility models have been proposed⁵ [33,34].

In order to appreciate the magnitude of these strong uctuations, gaussian values with the same mean and standard deviation than those of the S (t) distribution were simulated. In the simulation, nearly no clustering is appreciated, as is shown in gure 3b.




Fig. 3. a) S (t) behavior for the period of time under study. Large variations in S (t), some of them as far as eight standard deviations from its mean, can be appreciated. It can also be seen that large variations tend to form clusters in time; this phenomena is called clustered volatility. b) Gaussian simulation already shown as a broken line in gure 2c.C lustering is virtually not present.

4 Param eter estimation from IPC empirical data

The procedure to estimate , the Pareto-Levy exponent from empirical data is straightforward: Pareto-Levy tails behave as straight lines in a logarithm ic plot. Then, after performing a linear tof log P (S (t)) on log S (t), the obtained slope gives us an estimate of the exponent of the Pareto-Levy D istribution. C learly a distribution whose tails do not behave linearly in a log-log plot, can not be properly described by the Pareto-Levy m odel.

⁴ In nance, volatility is a relative measure of price movement during a given time period. It can be modeled by the standard deviation of stock price changes. E conophysicists usually use absolute returns to model the dynamics of volatility.

The twas carried out using data available in the tails regions is (t) j> 0:035. Both tails are marked with vertical klines in gure 2b. Those regions were chosen simply by exam ining the set of points for which the corresponding log-log plot behaves linearly. P (S (t)) was then reduced to 79 and 93 events in its negative and positive tails respectively. Note that, as is showed in gure 4, and in order to deal with the unde ned logarithm ic scale for the left tail of P (S (t)), we have used S (t) in our analysis.

It was found, that for these regions, the tails of P (S (t)) decay following a power law model. A straight line provides a good to for them in a logarithmic plot. Both to are shown in gure 4.




Fig. 4. Linear tted tails in a log-log plot of the cumulative distribution function P(S(t)) on S(t). Right in age positive tail. Left im age negative tail. Fitted parameters are shown.

Table 1 shows the estim ated parameters and the 95% condence intervals obtained from the lineal regression to for the negative and positive tails of P (S (t)).

5 D iscussion

R esults shown in table 1 are consistent with similar studies, where the Pareto-Levy model with 2.5 < < 4.0, has been found be useful for describe the behavior of extrem e variations of diverse nancial markets. Table 2 summarizes results of some of these studies.

High frequency studies of price variations, most of them performed for stock markets belonging to developed countries show that the distribution of returns follows a Pareto-Levy form with exponent converging to '3 as t decreases to time intervals of about one minute. For the case

of stock markets of emergent economies, it seems they may belong to a dierent universality class, some studies [36, 37] show that the return distributions from emergent markets have fatter tails than the observed in developed markets.

In sum m ary, it has been shown that the cumulative probability of daily extreme logarithm is changes of the M exican IPC index, can be approximated by the Pareto-Levy model, with exponents = $3.634\ 0.272$ and = $3.540\ 0.278$ for its positive and negative tails respectively. As a consequence of these values, we can a m that the stochastic process that governs the time series S (t), is well outside the Levy stable regime (0 < < 2).
