Collective dynamics in phospholipid bilayers investigated by inelastic neutron scattering: Exploring the dynamics of biological membraneswith neutrons

A bstract

We present the rst inelastic neutron scattering study of the short wavelength dynam ics in a phospholipid bilayer. We show that inelastic neutron scattering using a triple-axis spectrom eter at the high ux reactor of the ILL yields the necessary resolution and signal to determ ine the dynam ics of model membranes. The results can quantitatively be compared to recent Molecular Dynam ics simulations. Reectivity, in-plane correlations and the corresponding dynam ics can be measured simultaneously to gain a maximum amount of information. With this method, dispersion relations can be measured with a high energy resolution. Structure and dynamics in phospholipid bilayers, and the relation between them, can be studied on a molecular length scale.

M otions in biological membranes span a wide range of length and time scales [1]. Short wavelength density uctuations in the plane of the bilayer (as opposed to bilayer bending modes) are likely to play a key role in the transport of small molecules across the bilayer [2], but have received little experimental attention. While the structure of lipid bilayers has been the object of several studies in the last decades, dynamical properties even of simple model systems such as 1,2-dimyristoyl-sn-glycero-3-phoshatidylcholine (DMPC) remain largely unknown. A more quantitative understanding of short range molecular motions in a lipid bilayer is offundamental interest

in m em brane biophysics. Experim ental results can be linked to modern Molecular Dynamics (MD) simulations [3]. In this context, Chen et al. have recently presented a seminal measurement of the dispersion relation of the acyl chain uctuations in lipids [4] by inelastic X-ray scattering (IXS). As an important result, Chen et al. found a minimum in the dispersion relation at about $Q_0=1.4~{\rm A}^{-1}$, at the position of the static structure factor maximum S ($Q_{\rm xy}$). This soft mode was hypothetically linked to transport phenomena across the bilayer. Inelastic neutron scattering using a triple-axis spectrometer should over a much better resolution and avoid the danger of radiation damages




Fig. 1. A coessible (Q ,) range for a $\,$ xed energy of the scattered beam of E $_{\rm f}=10$ m eV . In the insert, a schematic of a triple-axis spectrom eter is shown.

in the sample, but has to date not been applied to study the dynamics of lipid bilayers. A further important advantage of INS over IXS is the fact that dierent parts of the bilayer can be probed by use of selective deuteration. We carried out the

rst inelastic neutron scattering experiments in model membranes employing the cold triple-axis spectrometer IN 12 at the high—ux reactor at the ILL. In this study we used fully deuterated chains DMPC—d54 (A vanti lipids, A labama) in D $_2$ O to minimize incoherent background. We report on experimental details and show examples of neutron direction and inelastic neutron scattering in deuterated DMPC bilayers.

From a solution of DMPC -d54 (deuterated 1,2-dim yristoyl-sn-glycero-3-phoshatidylcholine) in TFE/chloroform (1:1) with a concentration of 40 m g/ml, we prepared highly oriented membrane stacks on 2" silicon wafers (thickness 300 m) [5]. Ten of these wafers were stacked on top of and aligned with respect to each other to create a 'sandwich sample' consisting of several thousands of highly oriented lipid bilayers with a total mass of about 300 mg of deuterated DMPC. A luminum spacers between the substrates allow to let the heavy water vapor in between the wafers to hydrate the bilayers. In rocking scans we nd a mosaicity of the sandwich of !=0.6 deg.




Fig.2.Energy scan at Q = 1.0 A $^{\rm 1}$ and T = 30 $\,$ C.The insert shows the excitation of the DM PC-layers in m agni cation. Solid lines are guides to the eye.




Fig. 3.D ispersion relation in the uid phase of the lipid bilayer. Note the m in im um at the maximum of the static structure factor $S\left(Q_{Xy}\right)$ shown in Fig. 4.




Fig. 4. The inter-acyl-chain correlation peak (left) and reectivity (right). The insert schematically shows the orientation of the sample with respect to the incoming beam for the in-plane measurements. Solid lines are tsafter the Lorentzian-(chain-peak) and Gaussian-model (reectivity).

The insert in Fig. 1 shows a schematic of a tripleaxis spectrom eter. By varying the three axes of the instrument, the axes of rotation of the monochro-

m ator, the sam ple and the analyzer, it is possible to change the wavevectors k_i and k_f and the energies E_i and E_f of the incident and the scattered beam, respectively. The accessible (Q,) range for a xed energy of the scattered beam E f of 10 m eV is shown in Fig. 1. It is lim ited by the range of incident neutron energies o ered by the neutron quide as well as by mechanical restrictions of the spectrom eter. The instrumental energy resolution in this conguration is = 500 eV.By choosing smaller incident energies and energy transfers the energy resolution can be enhanced. By rotating the sam ple the scattering vector Q can be placed eitherwithin the plane of the membranes (Qxv) to measure interchain correlations or perpendicular to it (Q_z) to measure re ectivity (see insert in Fig. 4). The use of a triple-axis spectrom eter o ers the unique possibility to measure reectivity, the static structure factor $S(Q_{xy})$ in the plane of the m em branes and in plane dynam ics (S (Q $_{xy}$;)) on the sam e instrum ent in the sam e run. To controltem perature and the degree of hydration during the experim ent the sam plewaskept in a hum idity chamber. Inside the cham ber there was a heavy water reservoir, thermally isolated against the sample. By adjusting the tem perature of the cham ber and independently the tem perature of the reservoir using two H aake bath controllers, the hum idity inside can be controlled. C lose to the sample there were a hum idity sensor and a platinum resistor installed. IN 12 is equipped with a vertically focusing graphitem on ochromator and a vertically and horizontally curved graphite analyzer. The ux at the sample position is of the order of $5\,10^6\,$ n/(cm $^2\,$ s). For the inelastic m easurem ents the counting times were about veminutes per point. Figure 2 shows an energy-scan at $Q_{xy} = 1.0 \text{ A}^{-1}$ and T = 30 C, in the uid phase of the DMPC bilayer. The signal consists of a sharp central peak and a broad contribution, centered at = 0 m eV . The solid lines are guides to the eye. At = -5.5 m eV, the inelastic signal of the m em brane is observed in form of a pronounced peak with a width (FW HM) of about = 1 m eV . Figure 3 shows the corresponding dispersion relation in the uid L phase at T = 30 C as m easured by severalconstant-Q scans. The m easurem ents can quantitatively be compared to corresponding Molecular Dynamics simulations by Tarek et al.[3]. Figure 4

shows the corresponding inter-acyl-chain peak for tem peratures below and above the gel-liquid phase transition (phase transition tem perature T $_{\rm C}$ = 21.5 C) and the re-ectivity at T = 30 C.W hen heating from the more rigid gel-phase into the-uid phase, the inter-chain peak broadens drastically (decreasing correlation length $_{\rm xy}$) and the peak center shifts to smaller Q $_{\rm xy}$ -values (larger average next neighbor distance and smaller packing density). The re-ectivity shows we well-developed B ragg peaks giving information about the distance of the layers in z-direction. From the structure factors of the B ragg peaks, the z-pro-le of the bilayer can

be modelled. At T = 30 C we nd a next-neighbor distance of the acylchains of d_{xy} = 4.5 A and a correlation length of $_{xy}$ = 11 A . From the re ectivity there is a distance between the bilayers of d_z = 55 A . The combination of direction and inelastic measurements leads to a complete picture of structure and dynamics of modelmembranes on a molecular length scale. This will be especially useful in temperature dependent measurements in the range of the gel-liquid phase transition to study the development of structure and dynamics and the relation between them .
