Large N expansion for frustrated and doped quantum antiferrom agnets

A large N expansion technique, based on sym plectic (Sp (N)) sym metry, for flustrated m agnetic systems is studied. The phase diagram of a square lattice, spin S, quantum antiferrom agnetic system s is studied. The phase diagram of a square lattice, spin S, quantum antiferrom agnet with rst, second and third neighbor antiferrom agnetic coupling (the J_1 - J_2 - J_3 m odel) is determined in the large-N lim it and consequences of uctuations at nite N for the quantum disordered phases are discussed. In addition to phases with long range magnetic order, two classes of disordered phases are found: (i) states sim ilar to those in unfrustrated system s with commensurate, collinear spin correlations, con nem ent of spinons, and spin-Peierls or valence-bond-solid order controlled by the value of 2S (m od 4) or 2S (m od 2); (ii) states with incommensurate, coplanar spin correlations, and uncon ned bosonic spin-1=2 spinon excitations. The occurrence of \order from disorder" at large S is discussed. N either chirally ordered nor spin nem atic states are found. Initial results on superconductivity in the t J m odel at N = 1 and zero tem perature are also presented.

1. Introduction

Spurned by the discovery of high tem perature superconductivity [1], the last few years have seen intense activity in the subject of two-dimensional quantum antiferrom agnets. In particular, much attention has been focussed upon understanding the structure of quantum disordered phases of such antiferrom agnets [2] and their possible relationship to high tem – perature superconductivity [3]. Large N expansions [4] on unfrustrated antiferrom agnets found colum nar spin-Peierls order in the disordered state for half-integer spins [5, 6, 7]. \Chiral" [8] and \spin-nem atic" [9] states are among the new structures that have been proposed as ground states of frustrated quantum antiferrom agnets.

This paper presents details of a new system atic analytic technique for frustrated and doped antiferrom agnets (AFM s) which has been proposed recently [10]. The m ethod relies on a large N expansion based upon m odels with sym plectic sym m etry (Sp(N)). The m ethod is applied in this paper to two m odels:

(i) A square lattice AFM with rst, second and third neighbor antiferrom agnetic coupling – the J_1 - J_2 - J_3 m odel. This m odel has been studied elsewhere by numerical [11, 12], seriesexpansion [13], and mean-eld [14] m ethods; we will compare our results with these studies later. A particular strength of our approach is that it makes the connection between the structure of the known classically ordered phases and the quantum disordered phases especially clear. It will also clarify the appearance of \order-from -disorder" [15] from quantum uctuations for models which are classically disordered. W e will nd new quantum disordered phases which have uncon ned bosonic spin-1/2 spinon excitations.

(ii) The square lattice t $J \mod \mathbb{R}$ we will present initial results in the mean $\operatorname{eld} N = 1$ limit at T = 0. We is not superconducting ground states similar in structure to those of Ref [16].

We begin by motivating the use of a symplectic large N expansion for flustrated AFM s. P revious large N methods have been based on the SU(N) generalization of the SU(2) AFM [4, 6, 7] and have been restricted to unflustrated AFM swith a two sublattice structure (labeled A,B) for reasons we now explore. \Spins" are placed on sublattice A forming an irreducible representation of SU(N) while those on B form the conjugate representation. Thus e.g. totally symmetric representations on sublattice A can be can be formed [4] by placing n_b bosons created by b_i^y where = 1:::N and i 2 A; the b bosons transform under the fundamental representation of SU(N). The conjugate representation is placed on sublattice B by n_b bosons created by b_j^y for j 2 B; the b bosons transform under the representation conjugate to the fundamental. The use of conjugate representations ensures a natural pairing between directions in spin space on the two sublattices. The only possible coupling between sites on opposite sublattices which is invariant under SU(N) and bilinear in the spin operators is

(For SU (2) this reduces to the usual S_i § plus a constant). In the classical limit (n_b ! 1) this coupling will induce a N eel ground state

In a system with strong quantum uctuations, this coupling tries to maxim ize the number of valence bonds

between pairs of sites on opposite sublattices. The only bilinear coupling between sites on the same sublattice is the Yerrom agnetic' coupling

which dem ands that the spins on sites i and i^0 point in the sam e direction. R eversing the sign of this term will favor states in which the spins point in any two unequal directions; this is quite di erent from the antiferrom agnetic coupling which explicitly pairs directions in spin space. Interactions between sites on the sam e and opposite lattices are thus inequivalent and there is no natural way of introducing a dem ocratic antiferrom agnetic coupling between any two sites. Only for SU (2) do the ferrom agnetic and antiferrom agnetic couplings above becom e equivalent.

A proper description of a frustrated AFM therefore requires that all the spins transform under the same representation of a group, and that two spins can combine to form a singlet. For SU (2) we can write b_j " b_j (" $\circ =$ " \circ and ""# = 1); the boson annihilation operators on all the sites now have an upper index. Singlet bonds " $b_j^y b_j^y \circ$ can now be form ed between any two sites. This structure has a natural generalization to the sym plectic groups Sp(N) for all N. These are the groups of 2N 2N unitary matrices U such that

where

is the generalization of the "tensor (note Sp(1) = SU(2)). This tensor can be used to raise or lower indices on other tensors; all representations are therefore self-conjugate. \Spins" can be created on each site by n_b bosons b_i^y where = 1 ::: 2N. The b_i bosons transform as the fundam ental representation of Sp(N); the \spins" on the lattice therefore belong to the symmetric product of n_b fundam entals, which is also an irreducible representation. Valence bonds

can be form ed between any two sites; this operator is a singlet under Sp(N) because of (5). A n antiferrom agnetic coupling should maxim ize the number of such bonds between two sites; we will therefore consider models described by the following Hamiltonian

where i; j run over the sites of an arbitrary lattice, and J_{ij} are antiferrom agnetic exchange constants. We recall the constraint

which must be imposed at every site. For the group Sp(1) this generates states with spin $S = n_b=2$ at every site.

We now summarize the results obtained in our study of H_{AF} for the model with nearest (J_1) , second (J_2) and third (J_3) neighbor interactions on the square lattice. The large N limit was taken with the ratio $n_b=N$ xed; the results depend strongly on the value of $n_b=N$. The phases found (Figs 1, 2, 3, 4) can be separated into two distinct types:

1. Com m en surate, collinear phases

These are closely related to those found in unfrustrated SU (N) AFM s [6, 7]. For large values of $n_b=N$ these states have m agnetic long range order (LRO) with the spins polarized parallel or anti-parallel to each other. Upon reducing $n_b=N$ a transition eventually occurs to a corresponding short range ordered (SRO) phase, with a nite spin-correlation length. A ll the SRO phases are described at long distances and long times by the following e ective action when the correlation length is not too sm all:

where is the M atsubara time, c is the spin-wave velocity, $\sim = c$, and runs over x; y; \sim . Spatial anisotropy can be also be present but has been neglected for sim plicity. The action describes a complex eld z which transforms under the fundamental of Sp(N) and has a U (1) charge + 1; this eld is related to the lattice boson b, although the form of the relationship varies in di erent phases. The U (1) gauge eld A is related to the phases of certain link-variables, and the gauge symmetry is compact. In the SRO phase, the mass is nite and is proportional to the inverse spin-correlation length. The compact U (1) gauge eld leads to con nem ent of the z quanta and Berry phases of its instantons (m onopoles) [5] induce spin-Peierls order for special values of n_b [7]. The LRO phase is reached when vanishes and z quanta condense in the $k_0 = 0$ state [17]. To characterize the LRO phases by a gauge-invariant order param eter, we consider the expectation value of the spin' operators $s_a = z S_a z$ (S_a is a generator of Sp(N)) across the transition. In the SRO phase these vanish as a result of Sp (N) invariance. In the LRO phase, the order parameter manifold, M coll will be given by Sp(N) modulo the subgroup which leave the s_a invariant. Any orientation of the z condensate can be rotated by Sp(N) transform ations such that $hz = z^{-1}$. Now the s_a are invariant under the group Sp(N = 1) acting on components > 2. An additional factor of U (1) is obtained from the symmetry associated with rotations about the z' axis in the = 1;2 subspace under which $z^1 ! z^1 e^i$ and $z^2 ! z^2 e^i$. We have therefore

in direct analogy with U (N) = (U (1) U (N 1)) = CP^{N-1} for the SU (N) models [6, 18]; for N = 1 we recover CP^{-1} (the unit sphere, S^{2}). The transition from LRO to SRO is expected to be described by a non-linear sigm a (N L) model on M _{coll}. We note that ₂ (M _{coll}) = Z, the group of integers, so that topologically stable point defects in spacetime (hedgehogs) exist for all N when the spatial dimension d = 2, while ₁ = 0 so there are no line defects.

2. Incom m ensurate phases

Frustration induces phases with LRO and SRO in incommensurate helical spin con gurations. All of the phases found favor planar arrangement of spins and there is no \chiral" order. In regions not too far from a commensurate phase these states are described at long distances and long times by the following elective action:

The new feature is the presence of a charge 2 two-component scalar $\sim = (x; y)$ related to lattice link elds which induce incommensurate order. The coupling between the z and \sim is the simplest one consistent with global Sp(N) symmetry and is U (1) gauge invariant due to the antisymm etry of J (a coupling with no gradients of the form $\sim J z z$ vanishes identically). The potential V (~) is induced by short wavelength uctuations; in the incom mensurate phases V (~) will have minim a at a non-zero value of ~ leading to a Higgs phase with ~ 60. All of phases found in this paper have at least two gauge inequivalent minima related to each other by a square lattice symmetry; this leads to a two-fold degeneracy which can only be lifted by explicitly breaking the square lattice symmetry in H_{AF} . The minima are also such that h xi and h vi can simultaneously be made real in a suitable gauge. In such a gauge we see from Eqn (12) that the minim a of the dispersion of the z quanta are at wavevectors $k_0 = g(h_x i; h_y i) = 2$. For nite this leads to incommensurate SRO. The z quanta have unit charge and will therefore be uncon ned [19] in this Higgs phase: these SRO phases therefore possess uncon ned bosonic spinons which transform under the fundamental of Sp(N) [20] for all values of the on-site $spin' n_b$. In models which have the two-fold degeneracy lifted by small explicit symmetry breaking terms in H_{AF} these results appear to contradict the 'fractional quantization principle' of Laughlin [21]. As ! 0, the z

quanta will condense at k_0 leading to incom m ensurate LRO . The order-param eter m an ifold is now

because the U (1) invariance about the Σ' axis has now been reduced to Z_2 as the spins are no longer collinear. This generalizes the result for N = 1, SO (3) = SU (2)= Z_2 pointed out previously [22, 23]. For $M_{noncoll}$, $_2 = 0$ but $_1 = Z_2$, so there are line defects in spacetime (vortex worldlines) for d = 2 in this case. Instantons and vortices are suppressed in the Higgs phase, so their Berry phases are not expected to lead to spin-Peierls order. However the Berry phases could induce additional interm ediate phases between the Higgs and con nem ent phases: this will be brie y discussed later.

The sym plectic groups also have interesting applications to doped AFM s as described e.g. by a t J m odel. In such a m odel, the hopping term transfers spin from site to site and so resembles the ferrom agnetic coupling (4). Thus in SU (N) m odels with conjugate representations on neighboring sites there is no simple SU (N)-invariant hopping term for N > 2; if instead one choses all sites with the same representation, hopping can be included but not antiferrom agnetic exchange. Our sym plectic approach allows inclusion of both exchange and hopping for all N. In particular, using ferm ions with Sp(N) indices for spins and bosons for holes, the large N lim it justi as the decoupling of R ef [16] and produces superconductivity; phase separation into an insulating AFM and hole-rich superconductor is also present. D etails of this analysis at N = 1 and zero temperature are presented in Section 4.

The outline of the rest of this paper is as follows. In Section 2 we introduce the general form alism of the Sp(N) large N lim it for frustrated AFMs. Section 3 presents detailed results on the J_1 - J_2 - J_3 m odel. Finally Section 4 discusses initial results on the t-J m odel.

2. Frustrated Antiferrom agnets

We begin by setting up the general fram ework for the large-N expansion of antiferrom agnets with H am iltonian H_{AF} (Eqn (8)). The large-N limit is taken with $n_b=N$ xed to an arbitrary value. Depending upon the values of the J_{ij} and $of n_b=N$, the ground state $of H_{AF}$ m ay either break global Sp(N) symmetry and possess magnetic long-range-order (LRO) or be Sp(N) invariant with only short-range magnetic order (SRO). The structure of the large-N limit is very similar to the SU(N) case, and has been discussed extensively before [4, 7] for the SRO states. We will therefore present details mainly in the LRO phases. The large N limit for these states is most conveniently taken by adapting the method of Brezin and Zinn-Justin [24]. We begin by introducing the param etrization

We have introduced a natural double-index notation (m;) with m = 1:::N and =";#. The index m = 2;:::N. The x eld has been introduced to allow for a non-zero condensate h_{i}^{m} $i = {}^{p} \frac{m}{N} {}_{i}^{m} x_{i}; we will only consider m odels in which the condensate in the$ LRO phase can be transformed by a uniform global Sp(N) rotation into this form. We insert $(14) into <math>H_{AF}$, decouple the quartic term s by Hubbard-Stratanovich elds Q_{ij}, and enforce the constraints by the Largrange multipliers i. This yields

The large N limit is obtained by integrating over the 2(N = 1) b elds. The resulting e ective action, expressed in terms of the Q_{ij} , i and x_i elds, will have a prefactor of N (and some terms of order 1 which are sub-dom inant) and is therefore well approximated by its saddle-point value. The Q; ;x elds are expected to be time-independent at the saddle-point

and this is implicitly assumed in the following. The functional integral over the b requires knowledge of the eigenmodes of H_{MF} . This can be done along standard lines: we rst solve the eigenvalue equation

for the N_s (= number of sites in the system) positive eigenvalues ! and the corresponding eigenvectors (U_i ; V_j). The bosonic eigenoperators ^m

will diagonalize H $_{\rm M\ F}$. The inverse relation is

Consistency of these relations in poses certain orthogonality requirements on (U; V). It can be shown using Eqn (16) that these can always be satised. Finally the ground state energy, E_{MF} of H_{MF} is shown to be

In the last term we have emphasized that the ! depend upon Q; . Finding the ground state of H_{AF} in the large N limit is now reduced to the problem of minimizing E_{MF} with respect to the independent variables Q_{ij} , x_i with the i chosen such that the constraints

are always satised. It is instructive to examine the equations obtained by demanding stationarity of E_{MF} w.r.t. x_i :

This equation has two possible solutions: (i) $x_i = 0$: this gives the SRO phases (ii) $x_i \in 0$: comparing Eqn (21) with Eqn (16) we see that this condition is equivalent to demanding that Eqn (16) possess at least one zero eigenvalue. For nite n_b , this will only occur in the lim it $N_s ! 1$, and implies the existence of gapless excitations. These are the Goldstone modes associated with the Sp(N) symmetry breaking.

We now examine the large $n_b=N$ limit of H_{MF} ; it is easy to show that Q_{ij} i $n_b=N$ while x_i $n_b=N$. From Eqn (19) we observe that the sum over ! can be neglected and for large $n_b=N$, E_{MF} reduces to

The minimization of E_{MF}^{c} w.r.t. Q_{ij} can now be easily carried out and the problem reduces to that of nding the classical ground state of H_{AF} . Thus the large $n_{b}=N$ limit of the present large N equations is equivalent to the classical limit which involves n_{b} ! 1 at xed N. The fact that these two limits commute gives us further condence on the usefulness of the present large N procedure.

Finally we indicate how this form alism can be used to evaluate the spin-sti ness of the LRO phases in the large N limit. One takes values of x_i which minimize E_{MF} and performs a slowly varying rotation:

where n is the direction in spin-space about which the rotation has been perform ed, ~ are the Paulim atrices, and \tilde{k} is a small wavevector. We insert this value of x_i in E_{MF} , rem inim ize w.r.t. the Q_{ij} while maintaining the constraints and determ ine the change in energy E_{MF} for small \tilde{k} . We expect in general

The co-e cient is the spin-stiness tensor of the LRO phase about the direction n.

3. The $J_1 \neg J_2 \neg J_3$ M odel

W enow apply the form alism developed in the previous section to a frustrated antiferrom agnet on the square lattice with rst (J_1) , second (J_2) and third (J_3) neighbor interactions. This model has been examined by numerical [11, 12], series [13] and mean-eld [14] methods in the literature; their results will be compared with ours in section 3D. We begin by presenting the results of the N = 1 mean eld theory (section 3A). The elective actions controlling the long-wavelength, long-time uctuations at nite N will be considered in section 3B. Berry phases and the spin-Peierls order they induce will be disussed in section 3C.

3.A Mean Field Theory

The energy E_{MF} for this model was minimized over all elds Q_{ij} and $_i$ which were periodic with a p = p = 2 unit cell. All of the global minima found in fact turned out to have a periodicity with one site per unit cell: we will therefore restrict our analysis to this simpler limit. In addition, full wavevector-dependent stability matrices involving quadratic uctuations of E_{MF} on the manifold specified by Eqn (20) were evaluated at representative points, and all eigenvalues found to be positive. This gives us reasonable condence that the states described below are in fact the global minima of E_{MF} .

W ith one site per unit cell, the link variational parameters are the nearest neighbor elds $Q_{1x}; Q_{1y}$, the diagonal 2nd neighbor elds $Q_{2y+x}; Q_{2y}$ and the 3rd neighbor elds $Q_{3x}; Q_{3y}$. The bosonic eigenmodes can be calculated exactly and we not the eigenenergies:

The wavevector k extends over the rst Brilbuin zone of the square lattice.

Our results for $J_3 = 0$ are summarized in Fig 1. We begin by discussing the structure of the ground state at N = 1. We and 3 distinct types of phases:

1. (;)

These states have $Q_{1,x} = Q_{1,y} \in 0$, $Q_{2,y+x} = Q_{2,y-x} = Q_{3,x} = Q_{3,y} = 0$ and are the analogs of the states found in SU (N) system s. Inserting these values into Eqn (25) we see that $!_{k}$ has its minim a at (=2; =2): this implies that the spin-spin correlation function, which involves the product of two bosonic pair correlation functions [4], will have a peak at (;). We have a state with $x_{i} \in 0$ (LRO) for N = $n_{b} < 2.5$ and the corresponding SRO state for N = $n_{b} > 2.5$. The boundary between LRO and SRO is independent of $J_{2}=J_{1}$, but this is surely an artifact of the large N lim it. Finite N uctuations should be stronger as $J_{2}=J_{1}$ increases, causing the boundary to bend a little dow nwards to the right. W hile properties of these states can be calculated num erically for all values of $J_{2}=J_{1}$ and N = n_{b} , we tabulate a few analytic results for the LRO phase in an expansion in powers of N = n_{b} . The ground state energy is

where $I_1 = 0.84205$ is obtained from an integral over the Brillouin zone. The spin-sti ness for spin rotations about an axis perpendicular to the N eelaxis is found to be

The (0;) states have $Q_{1\mu} = 0$, $Q_{1\mu} \in 0$, $Q_{2\mu+x} = Q_{2\mu-x} \in 0$, and $Q_{3\mu} = Q_{3\mu} = 0$ and occur with LRO and SRO. The degenerate (;0) state is obtained with the mapping x \$ y. For $J_2=J_1 > 1=2$, the classical limit, has independent Neel order on each of the A and B sublattices; quantum uctuations, which are automatically included in the present approach, cause the Neel order parameters to align (\order from disorder") leading to the LRO states. To understand the nature of the transition between LRO at (;) to LRO at (;0) or (0;) we need the energy and sti ness of the latter states for small N = n_b. We nd

where I_3 is a Brilbuin zone integral whose value depends upon $J_2=J_1$; we will only need its value at $J_2=J_1 = 0.5$: $I_3 = 0.88241$. The sti ness of the (0;) state is soft at sm all $n_b=N$ for wavevectors in the x-direction:

where I_4 ; I_5 are B rilbuin zone integrals dependent upon $J_2=J_1$. A gain we will only need their values at $J_2=J_1 = 0.5$ which are $I_4 = 1.28576$ and $I_5 = 0.32767$. C om paring Eqns (26) and (28) we see that the energies of the (;)-LRO and (0;)-LRO states become equal at

Thus both sti nesses are positive and indicate that the transition between the states is rst order. Note that in both sti nesses the leading N $(n_b=N)^2$ term is absent; these sti nesses thus vanish classically and have appeared directly as a result of quantum uctuations another example of \order from disorder". These results contradict arguments in Ref. [25] that another 'spin liquid' phase exists at arbitrarily small N = n_b near $J_2=J_1 = 0.5$. While we agree that quantum uctuations are very in portant in a 'fan' emanating from $J_2=J_1 = 0.5$, N = $n_b = 0$, we have found that these uctuations just reinforce the classical order. At larger values of N = n_b we have a continuous (at N = 1) transition to the (0;)-SRO or (;0)-SRO state. The transition between this state and (;)-SRO remains rst-order.

3. D ecoupled"

For $J_2=J_1$ and $N=n_b$ both large, we have a \decoupled" state with $Q_{2N+x} = Q_{2N-x} \in 0$ and $Q_1 = Q_3 = 0$. In this case Q_p is non-zero only for sites on the same sublattice. The two sublattices have Neel type SRO which will be coupled by nite N uctuations. The N = 1 state does not break any lattice symmetry.

We now turn to $J_3 \in O$ (Figs 2, 3, 4), where we nd a new class of phases:

4. Incom m ensurate phases

It is known that for nite J_3 , the classical magnet has phases with incommensurate helical (coplanar) order [13]. Our phase diagram for a small value of $N = n_b$ ($N = n_b = 1$, Fig 2a) is similar to the classical one. All of the LRO phases undergo continuous transitions to SRO with the same spatial distribution of the Q_p and the accompanying broken rotational symmetry of the lattice. These SRO phases are shown in Fig 2b. The two new classes of phases which did not appear at $J_3 = 0$ are: (i) (q;) phases with $Q_{1,x} \notin Q_{1,y} \notin 0$, $Q_{2,x+y} = Q_{2,y} \times \oplus 0$, $Q_{3,x} \notin 0$ and $Q_{3,y} = 0$; the degenerate (;q) helix is obtained

by the mapping x \$ y. (ii) (q;q) phases with $Q_{1x} = Q_{1y} \in 0, Q_{2x+y} \in 0, Q_{2y} = 0, Q_{3x} = Q_{3y} \in 0$; this is degenerate with (q; q) phases [26]. The wavevector q varies smoothly from 0 to and is determined by doubling the wavevector at which ! k has a minimum; it is continuous across second-order phase boundaries (F ig 2a). In contrast to the classical limit [13], for N = n_b nite it requires a nite J₃ to induce helical order; the rst order transition from (;) to (; 0) order persists for small J as shown in the inset of F ig 2a. This suggests that quantum uctuations induce an elective ferror agnetic J₃ in them odel with bare J₃ = 0; a nite bare antiferror agnetic J₃ is required to compensate for this.

The broken discrete symmetries in states with SRO at (0;) and (q;) are identical: both are two-fold degenerate due to a breaking of the x \qquad y symmetry. The states are only distinguished by a non-zero value of Q₃ in the (q;) phase and the accompanying incommensurate correlations in the spin-spin correlation functions. However Q₃ is gaugedependent and so somewhat unphysical as an order parameter. In the absence of any further uctuation-driven lattice symmetry breaking (see below), the transition between SRO at (0;) and (q;) is an example of a disorder line [27]; these are lines at which incommensurate correlations rst turn on.

Fig 3 shows the transition from LRO to SRO as a function of $N = n_b$ for $J_3 = 0.35J_1$. Similar transitions also appear in Fig 4 which has $J_3 = J_2=2$. There are several notable features of these two phase diagram s:

(i) An interm ediate state in which Sp(N) sym metry is only partially restored (spin-nem atic [9]) does not appear in the large N lim it. We expect the transition from (q;q)-LRO to (q;q)-SRO to be described by a N L model on the manifold M _{noncoll}. A d = 1+ expansion of a sim ilar N L model [28] for N = 1 has been recently carried out and does not show any tendency towards such ordering. (ii) The Q_p variables can all be chosen real in all the phases, indicating the absence of \chiral" [8] order.

(iii) The commensurate states squeeze out the incommensurate phases as $N = n_b$ increases in both phase diagrams. We expect that this suppression of incommensurate order by quantum uctuations is a general feature of frustrated AFM s.

3.B Fluctuations - long wavelength e ective actions

This section will exam ine the form of the elds Q_p . We will focus mainly on the SRO phases in the region close to the transition to the LRO phases.

We begin by examining the (;)-SRO phase; this phase has already been examined in considerable detail in Ref [7] for the SU (N) AFM; here we adapt the results to the Sp(N) AFM. As noted above, this phase has the mean eld values $Q_{1xx} = Q_{1y} = Q_1$, and $!_k$ has minima at G, with G = (=2; =2). Close to the LRO phases, uctuations of the b will be strong at G. We therefore parametrize

where ' are assumed to have slow spatial variations. The most important component of the uctuations of the Q_{ij} are those of their phases. In particular, as noted in R ef [7], the mean-eld theory has an unbroken gauge symmetry; the transformation

From Eqn (38), it is clear that the the elds turn out to have mass $+ 4J_1Q_1$, while the z elds have a mass $4J_1Q_1$ which vanishes at the transition to the LRO phase. The elds can therefore be safely integrated out, and L yields the following elds extin action, valid at distances much larger than the lattice spacing:

Here $c = {}^{p} \overline{8}J_{1}Q_{1}a$ is the spin-wave velocity, = $({}^{2} 16J_{1}^{2}Q_{1}^{2})^{1=2}$ is the gap towards spinon excitations, and $A_{\sim} = A_{\sim} = c$; this action is of the form (10) quoted in the introduction. Thus, in its nalform, the long-wavelength theory consists of a massive z scalar (spinon) coupled to a compact U (1) gauge eld.

We now exam ine the changes in the above actions as one moves from the (;)-SRO phase into the (q;q)-SRO phase (F ig 2b) (a very sim ilar analysis can be performed at the boundary between the (;)-SRO and the (;q)-SRO phases). This transition is characterized by a continuous turning on of non-zero values of $Q_{iji+\hat{y}+\hat{x}}$, $Q_{iji+2\hat{x}}$ and $Q_{iji+2\hat{y}}$. It is easy to see from Eqn (34) that these elds transform as scalars of charge 2 i under gauge transform ation associated with A . Performing a gradient expansion upon the bosonic elds coupled to these scalars we nd that the Lagrangian L of the (;)-SRO phase gets modi ed to

Here $\sim = (\sim_{A} + \sim_{B}) = (2J_{1}Q_{1}a)$ is a scalar of charge 2; term s higher order in \sim have been dropped. We have also added a phenom enological potential V () which is generated by short wavelength uctuations of the b quanta. This action is of the general form (12), and as noted earlier, is the simplest one consistent with the requirements of U (1)-gauge and global Sp(N) invariance. In a phase with $\sim \frac{1}{6}$ 0 and real, we see from Eqn (41) that them in imum of the dispersion of the z quanta is at a wavevector $k_0 = (h_x i; h_y i)=2$: this will lead to

incom m ensurate order. The action (41) thus dem onstrates clearly the intim ate connection between the H iggs phenom enon and the appearance of incom m ensurate correlations.

We now turn to the (0;)-SRO phase; we will nd that its properties are quite similar to the (;)-SRO phase. We recall that this phase has the mean-eld values $Q_{2y+x} = Q_{2y-x} = Q_2, Q_{1y} = Q_1$ and $Q_{1y} = 0$. The excitation energies $!_k$ now have minima at G with G = (0; =2). We therefore parametrize the b elds as in Eqn (33), but using the new value of G. This phase also has an unbroken U (1) gauge symmetry; the main di erence is in the staggering pattern of the charges of the b quanta. W ith the choice of the constants $_i = 1(1)$ for r_{iy} even (odd) in Eqn (34) it is easily veried that all mean-eld expectations hQ $_{ij}$ irem ain invariant. The phases of the link elds are parametrized as in Eqn (35) in terms of a vector potential A but with the new $_i$; the diagonal link elds have the parametrization

The remaining analysis is essentially identical to that for the (;)-SRO phase and we obtain the same nallelective action S _{eff} (Eqn (39)) with an additional spatial anisotropy. The connection between the z quanta and the lattice bosons and between A and the phases of the link elds are now of course different.

The transition from (0;)-SRO to (q;)-SRO follows the treatment above of the transition from (;)-SRO to (q;q)-SRO; the nalaction for the incommensurate phase has the same form as Eqn (41).

3.C Berry Phases

For the unfrustrated SU (N) magnets, Berry phases associated with instanton tunneling events had particularly strong consequences in the SRO phase [5, 7]. Very similar e ects occur in the commensurate SRO phases of the J_1 - J_2 - J_3 model. We consider the various phases in tum:

1. (;)

This phase is essentially identical to the SU (N) case [7]. The instantons have Berry phases $n_{b~s} = 2$ where $_{s} = 0;1;2;3$ on dual lattice points with (even, even), (even, odd), (odd, odd), (odd, , even) ∞ - ordinates. Condensation of the instantons leads to spin-Peierls order of column (shown in Fig 1) or line type (not shown) for $n_{b} = 1;3 \pmod{4}$ and 2 respectively, or a featureless VBS state [29] for $n_{b} = 0 \pmod{4}$, throughout the (;) SRO phase. The b quanta are con ned by the compact U (1) gauge force, with a con nem ent length scale determ ined by the instanton density [30].

2. D = coupled

We can apply the analysis of subsection 3.C 1 to each sublattice separately, giving e.g. for $n_b = 1 \pmod{4}$ the type of spin-Peierls correlations shown in Fig 1. There is a total of 4 = 16 states for this case but coupling between the sublattices will reduce this to 8 states, all of one of the two types shown. The state with the dimers' parallel to one another has more possibilities for resonance using the J_1 bonds and is likely to be the ground state. For $n_b = 2 \pmod{4}$, there will be 2 = 2 = 2 states, and for $n_b = 0 \pmod{4}$, just one.

As in the other collinear phases, this state possesses instantons which are the rem nants of hedgehogs in the LRO phase. A natural location for these instantons is at the center of the horizontal links which have $Q_{1,x} = 0$; the spins at the ends of these links are ferror agnetically aligned and are most susceptible to large deform ations. The Berry phase for a conguration of well separated instanton charges m_s at co-ordinates R_s can be calculated as before [7, 5]

where $_{s}(r_{i})$ is an angle which winds by 2 as r_{i} m oves around R_{s} , the sum over i extends over all the sites of the lattice and $_{i}$ is the staggering associated with the (0;) phase i.e. $_{i} = 1(1)$ for r_{iy} even (odd). The sum over i can be evaluated in a manner similar to Ref [5]. Consider rst an isolated instanton of unit charge at R_{s} ; rew rite the sum mation in (43) as one over vertical links of the square lattice:

The symmetry of the mean-eld (0;) state with one instanton now requires that the contribution of the links be odd under relection across the horizontal line running through R_s. The majority of the links will cancel against their relection partners, the only exceptions being the links which intersect the cut in the angle eld $_{s}(r_{i})$; these will yield an additional contribution of i n_{b} . We expect that these symmetry considerations will also be valid for a conguration of well separated instantons. Combining the contributions of all the instantons we obtain nally

where $[R_{sx}]$ is the integer part of R_x . In the SRO phase the instantons interact with a C oulom bic 1=R potential; the instanton plasm a can therefore be m apped onto a dual sine-G ordon m odel [7] in which the instanton B erry phases appear as frustrating phase-shifts in the argum ents of the cosine term [7]. This m odel can be analyzed in a m anner which closely parallels R ef [7]. The B erry phases lead to condensation of the instanton charges and to spin-Peierls order of the type shown in F ig 1 for n_b odd, and a VBS state for n_b even. C on bined with the choice (0;) or (;0) this gives degeneracies 2;4;2;4 for $n_b = 0;1;2;3 \pmod{4}$.

4. Incom m ensurate P hases

A s the action (41) m akes clear, these phases require an additional charge 2 eld \sim for their description. In the SRO phases, the z quanta can be integrated out and we are left with a lattice gauge theory of a compact U (1) gauge eld and a charge 2 scalar. The scalar elds can form vortices with ux quantum : instantons can change this ux by 2, so only a Z_2 quantum number is topologically stable [31], in agreement with the analysis of the LRO phase. If the vortices proliferate it will be necessary to consider B erry phases associated with them and the instantons to understand the SRO phase. The following phases can occur in such a lattice gauge theory [19]:

(i) A Higgs phase in which the vortices and instantons are suppressed; Berry phase e ects are therefore unin portant and this phase will be insensitive to the precise value of n_b . The b quanta carry charge 1 and are uncon ned [19]: these are spinons transform ing under the fundam ental of Sp(N). No such excitations were found in the commensurate phases. G auge excitations have a gap controlled by the magnitude of the Higgs eld \sim^{D} . The incommensuration is also controlled by \sim^{D} , as has been noted earlier. There is no breaking of lattice symmetries beyond those found at N = 1. However with periodic boundary conditions the ground state has an additional factor of 4 degeneracy for all n_b : the additional states are obtained by changing the sign of all Q_p elds cut by a bop wrapped around the system [31]. This phase is expected to survive in our phase diagram at nite N.

(ii) A con nem ent phase with proliferation of vortices and instantons, con nem ent of spinons, and a gap towards gauge excitations controlled by the instanton density [30]. A plausible scenario is that this phase in fact coincides with the (;)-SRO phase and possesses spin-Peierls order driven by the Berry phases of instantons.

(iii) Additional intermediate phases driven by the Berry phases of the instantons and

vortices this possibility is under investigation.

3 D C om parison with num erical and series results

M any num erical [11] and series analyses [13] have appeared on the model with $J_3 = 0$ for the spin-1/2 SU (2) modelie. N = 1, n_b = 1 in the notation of this paper. They nd (;)-LRO at small $J_2=J_1$, (;0)-LRO at large $J_2=J_1$ and an intermediate SRO phase around $J_2=J_1 = 1=2$. This is in agreement (see Fig 1) with our prediction in section 3A.1 that the phase boundary between (;)-LRO and (;)-SRO bends downwards at nite N with increasing $J_2=J_1$. Analyses of this intermediate phase at $J_2=J_1$ [11, 13] shows clear evidence of columnar spin-Peierls ordering [7], also in agreement with the results of Ref [7] and section 3C.1. An additional intermediate phase with (0;)-SRO has not been ruled out.

It would clearly be interesting to nd the new incommensurate SRO phases with unconned spinons of this paper in numerical work on models with N = 1, $n_b = 1$. Our results suggest that such phases will only occur in models with a nite J_3 . A numerical analysis of the J_1 - J_2 - J_3 model along the line $J_3 = 0.5J_2$ has recently been performed [12]. For comparison, we display the large N results for these models in Fig 4. As in Fig 4, these investigators [12] nd correlations at (;) at small J_2 = J_1 and at (0;) at large J_2 = J_1 . Their results at intermediate J_2 = J_1 are inconclusive but suggestive of a (;q) phase. A system atic analysis to resolve this issue and to distinguish SRO from LRO would be useful.

4. The t-J M odel

This section will extend our results to a limited class of doped AFM s. These are described by the t-J models in which electrons hop with matrix element t, have a nearest-neighbor antiferrom agnetic exchange J, and have restrictions on their occupation number at each site due to the strong C oulom b interactions. Ideally one would like to dope A FM s which have spins in the representations exam ined above, i.e. transform ing under the sym m etric product of n_b fundam entals of Sp(N), and take the large N lim it with n_b =N constant. Param eters can then be chosen to obtain the experim entally observed [2]N celLRO state in the undoped lim it. These m odels require the introduction of bosons b carrying Sp(N) spin, and spinless ferm ions to represent the holes [26]. The Pauli exclusion principle now restricts the density of ferm ions to be order 1 and it appears that a sin ple large-N lim it does not exist.

We exam ine here the doping of AFM swhich have spins transform ing under the antisym – m etric product of m fundam entals of Sp(N) (this representation is not irreducible); the large N lim it will be taken with m = N constant. Such spins are most conveniently described by introducing ferm ions f transform ing under the fundam ental of Sp(N). The holes are now represented by spinless bosons b. The physical electron' is therefore

for every site i. W e will focus exclusively on the case in which the states are half lled at zero doping: m = N. This approach is an adaptation of the large N limits of R ef [32, 33] for SU (N) t-J m odels. Unlike the SU (N) case, the states on each site do not form an irreducible representation of Sp (N) at zero doping. Two ferm ions can combine to form on-site singlets $J = f_i^y f_i^y$. There is, however, no energy gained out of form ing such states; they in fact reduce the ability of the site to form energetically favorable singlet bonds with other sites.




Figure 1: G round states of H for $J_3 = 0$ as a function of $J_2=J_1$ and $N=n_b$ ($n_b = 2S$ for Sp(1) SU(2)). Thick (thin) lines denote rst (second) order transitions at N = 1. Phases are identialed by the wavevectors at which they have magnetic long-range-order (LRO) or short-range-order (SRO). The links with $Q_p \notin 0$ in each SRO phase are shown. The large $N=n_b$, large $J_2=J_1$ phase has the two sublattices decoupled at N = 1; each sublattice has Neel-type SRO. Spin-Peierls order at nite N for odd n_b is illustrated by the thick, thin and dotted lines. The (;)-SRO and the \decoupled" states have line-type [7] spin-Peierls order for $n_b = 2 \pmod{4}$ and are VBS for $n_b = 0 \pmod{4}$. The (0;)-SRO state is a VBS for all even n_b .

For undoped AFMs with exchange interactions of the type (8), the large N limit can be taken following the SU (N) case. For weak frustration [34] the ground states are fully dimerized into pairs of sites forming singlet bonds. (Note that the bosonic large N theories of Section 3 also give only dimerized ground states in the limit of large $N = n_b$ for n_b odd: see Figs 1, 3, 4.) Neel-type states which are important for N = 1 are not found. However at large dopings, the present large-N o ers a natural way of describing m etallic states with a Ferm i surface satisfying Luttinger's theorem, the existence of which appears to be suggested by some experiments on the high-T_c materials [35]. Thus the following calculation, while probably not experimentally relevant at small doping, might capture the correct physics at moderate and large dopings.

W e will consider the following H am iltonian

The last two terms enforce the local constraint (47) and x the average hole density at N . Here we will focus exclusively on the N = 1 limit at zero temperature. This requires a complete condensation of the b bosons $h_{p,i} = {p \over N} {b_i}$ and introduction of the link-eld

which performs the Hubbard-Stratanovich decomposition of the exchange interaction. We note that this decoupling is very similar to that performed in Refs [16]; in the present calculation however it is uniquely enforced by the large N limit. As in Ref [16], at T = 0, our solutions have $b_i \notin 0$ (for $\notin 0$) and $_{ij} \notin 0$ which describe a superconducting state. We have examined mean-eld equations numerically with two sites per unit cell (with both the 2 1 and $p = \frac{p}{2}$ unit cells) and determined the global ground states over thism anifold. The results are summarized in Fig 5. A large part of the phase diagram in fact turns out

to have a unit cell of just one site. In this case $b_i = p_{i,j+\hat{x}}$, $a_{i,j+\hat{y}}$, $b_{i,j+\hat{y}}$ and the quasi-particle energy spectrum k_i is

We nd 4 dierent types of superconducting states which are described below. With the exception of the rst phase which has coexisting spin-Peierls order, all phases are combination of extended s (s) and d wave pairing with no on-site pairing.

(i) C oexistence of spin-Peierls order and superconductivity: This phase occurs for sm all tor sm all and has a 2 1 unit cell with the spatial distribution of the $_{ij}$ shown in Fig 5. All three $_{1}$; $_{2}$; $_{3}$ cannot be made real in any gauge so this phase also breaks time-reversal invariance. Att = 0 and arbitrary, or = 0 and tarbitrary, we have $_{1} \in 0$, $_{2} = _{3} = 0$: the system is now a fully dimerized insulator. The quasi-particle spectrum is found to have a gap over the entire B rillouin zone. This is the only phase which has a unit cell larger than one site.

(ii) s + id-wave superconductor: O ccurs around t=J 1 and 0:5 and has $_x = e^i _y$ where the phase varies sm oothly with t=J and . Such a state has been considered previously by K otliar [36]. The quasi-particle spectrum is fully gapped and time-reversal symmetry is broken.

(iii) d-wave superconductor: This phase occurs form oderate and large t=J at sm all and has x = y and has been considered previously by K otliar and Liu [37]. The quasi-particle gap vanishes at 4 isolated points (k^0 ; k^0) in the B rilluoin zone.

(iv) s -wave superconductor: Finally for large we obtain an extended s-wave solution with no on-site pairing which has x = y. There is again a fully gapped excitation spectrum; for large t =J, the gap vanishes as t exp(ct =J) where c is a constant of order unity.

F inally we address the issue of the stability of the phases discussed above towards phase

separation. A realistic model of the high- T_c materials should also include the long-range C oulomb interactions between the electrons and between the rare-earth ions and the electrons. These interactions will reduce any tendency towards phase separation. It is nevertheless interesting to exam ine this issue for H_{tJ} alone. The results of a M axwell construction on the energy-versus-doping curve are shown in Fig 5. The region below the dotted line is susceptible to separation into an insulating antiferrom agnet with = 0 and a hole-rich phase with on the dotted line. The boundary towards phase separation approaches = 0 as t=J ! 1 , in agreem ent with R ef [38]. However at sm all values of t=J, in particular at t = 0, we nd no phase separation, unlike Em ery et. al. [38]. The absence of phase separation at t = 0 in the present calculation is due to the extra stability acquired at large N by fully dimerized solutions with every site less than half-lied.

5. Conclusions




Figure 2: As in Fig 1 but as a function of $J_2=J_1$ and $J_3=J_1$ for (a) $N=n_b = 1$ and (b) $N=n_b = 5$. The inset in (a) shows the region at the tip of the arrow magnied by 20: a direct rst-order transition from (;)-LRO to (0;)-LRO occurs up to $J_3=J_1 = 0.005$.




Figure 3: As in Fig 1 but for $J_3=J_1 = 0.35$.




Figure 4: As in Fig 1 but for $J_3=J_2 = 0.5$.

This paper has presented details on the application of a new large N expansion based on the sym plectic groups Sp(N) which was introduced recently [10]. These groups naturally generalize to all values of N the physics of SU(2) = Sp(1) antiferrom agnetism : the pairing of spins with opposite directions in spin space. They lead to a particularly appealing treatm ent of frustrated antiferrom agnets with all antiferrom agnetic exchange interactions treated dem ocratically. The large N lim it was taken by placing spins on each site which transform as n_b sym m etric products on the fundam ental of Sp(N), and xing $n_b=N$ at an arbitrary value $(n_b = 2S \text{ for } SU(2))$. For large $n_b=N$ the ground states become identical to the classical solutions and possess magnetic long range order (LRO). Upon reducing $n_b=N$ all the LRO states under continuous transition to short range ordered (SRO) states whose properties are closely connected to the LRO states. In particular for the square lattice m odel with rest, second, and third neighbor interactions (Figs 1, 2, 3, 4) we found two distinct classes of states:

(i) LRO states with commensurate, collinear order led at smaller values of $n_b=N$ to SRO states with a gap to all excitations, spinons conned by a compact U (1) gauge force, and spin-Peierls or valence-bond-solid order controlled by the value of n_b (m od 4).

(ii) LRO states with incommensurate, coplanar order led at smaller values of $n_b = N$ to SRO states with a gap to all excitations, uncon ned spinons and no spin-Peierls order. A charge

2 scalar in a H iggsphase was responsible for liberating the spinons [19]. These incommensurate SRO states appear to contradict the 'fractional quantization principle' of Laughlin [21]. This principle asserts that spin-1/2 excitations of a non-degenerate 'spin-liquid' ground state must interact with a gauge force which endows them with fractional statistics. The SRO states found in this paper have a two-fold degeneracy but this can easily be lifted by adding sm all explicit symmetry breaking terms to H_{AF} (this can be done for the (g;)-SRO phase by modifying J_3 on just the x-directed links, and for the (g;q)-SRO phase by changing J_2 on the links in the (1;1) direction). The modiled model now has a non-degenerate ground state, no gapless excitations, and uncon ned spin-1/2 spinon excitations with bosonic statistics, contradicting R ef [21].

A dditional interm ediate phases between the Higgs and con nem ent SRO phases are possible and are presently under investigation. No chirally ordered [8] or spin-nem atic [9] states were found.

An initial discussion of the application of the sym plectic groups to doped antiferrom agnets was also presented. In this case they allow a natural in plem entation of both antiferrom agnetic exchange and hole hopping term s, and emphasize the natural connection between antiferrom agnetism and singlet superconductive pairing [3]. In particular a study of the




Figure 5: Ground state of the t $J \mod H_{tJ}$ at N = 1 as a function of t=J and the hole concentration . All phases except on the lines t = 0 and = 0 are superconducting. The region below the dotted line is susceptible to separation into an insulating antiferrom agnet with = 0 and a hole-rich phase with on the dotted line. The boundary towards phase separation approaches = 0 as t=J ! 1

T = 0, N = 1 limit of a t J model with spins represented by fermions and holes by spinless bosons yields superconducting ground states (Fig 5) in much the same manner as Ref [16]. Extension of these results to nite temperature and nite N is clearly of great interest and is currently in progress.
