On the relation between the Hartree-Fock and Kohn-Sham approaches

Abstract

We show that the Hartree-Fock (HF) results cannot be reproduced within the fram ework of Kohn-Sham (KS) theory because the single-particle densities of nite systems obtained within the HF calculations are not v-representable, i.e., do not correspond to any ground state of a N non-interacting electron systems in a local external potential. For this reason, the KS theory, which nds a minimum on a di erent subset of all densities, can overestim ate the ground state energy, as com pared to the HF result. The discrepancy between the two approaches provides no grounds to assume that either the KS theory or the density functional theory su ers from internal contradictions.

The Hartree-Fock m ethod (HF), rst proposed in the pioneering works of Hartree and Fock [1,2] is known to be successful in calculating properties of electron systems, in particular, the ground state properties of atoms. Based on a variational principle, the HF m ethod estimates the ground state energy E of an electron system from above, i.e., $E_{HF} = E$, where E_{HF} is the ground state energy calculated within the HF m ethod. If the ground state wave function of N electrons is approximated by a single N -electron Slater determinant, the HF solution delivers the minimum value E_{HF} on the set of all such determinants. A green ent, or otherwise, with the HF results is often used to estimate the success of other approximate computational schemes.

The D ensity Functional Theory (D FT) exploits the one-to-one correspondence between the singleparticle electron density and an external potential acting upon the system and relies on the existence of a universal functional F [(r)] which can be minimized in order to nd the ground state energy [3]. The K ohn-Sham (KS) theory goes further in reducing the problem of calculating ground state properties of a many-electron system in a local external single-particle potential to solving H artreelike one-electron equations [3,4]. Successful solution of these equations allows to predict, at least in principle, the atom ic, m olecular, cluster and solid bodies binding energies, phonon spectra, activation barriers etc., see e.g. [5].

It is natural, therefore, to ask whether the HF ground state energy can be successfully reproduced in the K ohn-Sham approach. We note ist that a universal density functional $F_{\rm HF}$ [] can be defined with the help of the constrained-search technique [6]. Had the explicit form of $F_{\rm HF}$ [] been available, the HF and the DFT approach would have yielded the same results for the ground state energy, $E_{\rm HF} = E_{\rm DHF}$, and the electron density, $_{\rm HF}$ (r) = $_{\rm DHF}$ (r), [6]. Here, $E_{\rm DHF}$ and $_{\rm DHF}$ (r) are the exact DFT Hartree-Fock energy and density respectively, while $_{\rm HF}$ (r) is the HF density. Unfortunately, the correspondence theorem [3,6] establishes the existence of the functional only in principle, and provides no unique practical recipe for its construction. Rather, for practical calculations one has to resort to the KS approach. Exhaustive calculations [7{9] of the ground state energies of different atoms show that, if the KS approach is used, the resulting energy $E_{\rm KSHF}$ usually exceeds the energy $E_{\rm HF}$ obtained by the HF m ethod,

Recently, there have been suggestions that this disagreem ent may point to intrinsic aws in both the DFT and the KS theories. One might suspect, therefore, that an exact local exchange potential does not exist for ground states of typical atoms (see [8,9] and references therein). We will, how ever, argue that the discrepancy (1) between the HF and KS is due to the di erent domains on which the respective functionals are de ned. More speci cally, we will show that while a KS density is v-representative, a HF density is not, i.e., it cannot be obtained as the ground state density of any N non-interacting electrons in a local potential. As a result, the KS method sim ply delivers a minimum on a di erent class of electron densities, and its disagreem ent with the HF approach does not indicate the existence of any internal contradictions either in KS or DFT approach.

The purpose of this Letter is to show that HF results cannot be reproduced within the fram ework of KS theory because the single-particle densities of nite N electron systems obtained within the HF calculations are not v-representable. This means that the HF densities cannot be obtained as the ground state density of any N non-interacting electrons in a local potential. Thus, the discrepancy between the two approaches, which manifests itself in the inequality (1), provides no grounds to assume that either the KS theory or the DFT su ers from internal contradictions. We begin our study with considering the HF ground state energy which is given by the equation

We use an atom ic system of units: e = m = h = 1, where e and m are electron charge and mass, respectively. Here N is the total number of electrons, n_i are the occupation numbers: $n_i = 1$ if the corresponding single-particle level is occupied, otherwise $n_i = 0$. For an atom one has v(r) = Z = r, where Z is the nuclear charge. The exchange energy E_x can be represented as follows

and $_0(r_1;r_2;!)$ is the linear response function, which is of the form

with $!_{ik}$ de ned as $!_{ik} = "_k$ "_i, "_k and functions $_k(r_1)$ being respectively the one-particle energies and wave functions of the HF equations; and is the in nitely small number, ! 0. Varying Eq. (2) with respect to the single-particle wave functions $_i(r)$, one obtains the HF system of equations:

These equations di er from an ordinary Schrodinger equation in two essential aspects: they are nonlinear in \prod_{i}^{HF} (r) and the second term under the sum on the left hand side of Eq. (5) that represents the so-called Fock's potential is non-local.

The asymptotic behavior in r of $_{i}^{HF}$ (r), contrary to the case of an ordinary one-particle Schrödinger equation, is not determined by E_{i}^{HF} and does not have the form

On the contrary, it was shown in [10] that at r ! 1 the function ${}_{i}^{HF}$ (r) is not determined by E_{i}^{HF} but behaves as

where E_F^{HF} is the energy of the so-called Ferm i-level (with wave function F_F^{HF} (r)), which is the smallest binding energy of the occupied single-particle levels among all E_i in the considered system, and

and Y $_{\rm Im}$ (r=r) is the Ith order spherical polynom ial. The uniform behavior of the occupied levels given by Eq. (7) is a consequence of the long range nature of the non-local Fock potential. The uniform behavior (7) leads to a number of very speci c features of the ground state wave function, which, as we will see, cannot occur in the KS equations and m akes it in possible for the KS equations (see Eq. (13)) to reproduce the HF density. That is, it m akes the HF densities be non-v-representable.

Consider next the HF calculations based on the constrained-search formulation of DFT which employs the HF density functional F_{HF} [][6]. The functional F_{HF} [] is obtained by m inimizing the expectation value F_{HF} [] = ([] $\hat{f}\hat{f}$ j []) over all single-electron Slater determ inants consistent with a xed density (r). The Ham iltonian \hat{H} is of the form

From the manner in which the functional F_{HF} [] is constructed it is clear that the resulting ground state energy E_{DHF} equals that obtained in the HF method, E_{HF} ,

Obviously, $_{DHF}(r) = _{HF}(r)$, where $_{HF}(r)$ is the HF density obtained upon solving Eq. (5), while the determ inant HF , which yields the m in imum value, is composed of the eigenfunctions of Eq. (5) [6].

To give proof of the non-v representability of the HF densities, we assume for a moment that $_{\rm H\,F}$ (r) is non-interacting v-representable i.e., that it can be represented as the ground state density of N non-interacting electrons described by the Schrodinger equation with some local potential v_L (r). Equivalently, we assume that the functional $F_{\rm H\,F}$ [] is de ned in the domain of v-representable densities. As a result, the HF functional $F_{\rm H\,F}$ [] can be represented as $F_{\rm H\,F}$ [] F_x [] with F_x [] being a functional de ned in the domain of v-representable densities,

The second term in Eq. (11) being the Hartree term is obviously a functional of the density. The KS kinetic energy functional T_k [] is known to be dened in the domain of v-representable densities [4,7] and so is the fourth terms in Eq. (11). Thus, the exchange energy E_x given by Eq. (3) is also to be a functional E_x [], dened on the v-representable densities, as has been shown in [11], with the help of the representation (3). It has also been demonstrated in [11] that the variational derivative of E_x [] exists and can be evaluated explicitly to produce the KS exchange potential [11]

W e can then proceed to obtain the eigenvalues " $_i$ and the wave functions $_i$ (r) in Eqs. (4) and (11), by solving the KS single-particle equations

and compute the density (r) as

We note that due to the constrained-search technique [6] the minimum of the functional F_x [] is given by

where KS is a single N -electron Slater determ inant which delivers the lowest energy expectation value of \hat{H} given by Eq. (9). This determ inant is composed of the single-particle wave functions i(r)which are the solutions of one particle equations (13). Thus, we are led to the conclusion that the determ in ant HF has to coincide with the determ in ant ${}_{KS}$. Then the HF wave functions ${}^{HF}_{i}$ and the eigenvalues E_i^{HF} given by Eq. (5) must be equal to the wave-functions i and the eigenvalues "i given by Eq. (13). However, it is seen from Eq. (7) that all single-particle HF functions have the sam e asymptotic behavior determ ined by the sm allest orbital energy [10], even though the eigenvalues E_{i}^{HF} are not, in general, degenerate. On the other hand, eigenfunctions of Eq. (13) m ay exhibit such behavior only if the eigenvalues " $_i$ are degenerate as it follows from Eq. (6). As a result, we arrived at contradiction. This contradiction is resolved once we recognize that at least some of the HF densities are not non-interacting v-representable. Note that examples of non-v-representable densities were given in Ref. [13]. O byiously, a one-to-one correspondence between non-local potentials and local ones does not exist [14]. Therefore, if the explicit form the functionals F^{HF} [] and T_k [] was known, we would not have been able to obtain the HF ground state within the KS theory because they are de ned on the di erent subsets of densities. For exam ple, it is in possible to reproduce the HF singleparticle eigenvalues E_{i}^{HF} within the KS theory [15]. In other words, the two approximate methods have di erent dom ains of applicability and are not am enable to a direct com parison. Consequently, the result (1) cannot be used to prove that the KS method or DFT is in any way de cient, as was suggested in Refs. [8,9].

A few remarks are in order here. A single N -electron Slater determ inant coinciding with $_{KS}$ can be obtained in the optimized elective potential method with the local exchange potential V_{OPM} [12]. Because of one-to-one correspondence that exists between the wave function, the density and the local single-particle potential [3,6], V_{OPM} must coincide with V_x given by Eq. (12), $V_x(r) = V_{OPM}(r)$ as has been demonstrated in [11]. Therefore, the ground state energy E_{OEP} of a many-electron system calculated in OPM has to be equal to the corresponding energy E_{KSHF} calculated with the functional F_x [], $E_{KSHF} = E_{OEP}$. It is now tempting to assume that all three energies agree, i.e., that $E_{HF} = E_{KSHF} = E_{OEP}$ [8,9]. But it is not the case since the HF densities are not v-representable. This fact is in agreement with numerical calculations showing that $E_{HF} < E_{KSHF}$ [7[9]. One should also mention one special case where the HF and KS theories give the same answer. For a He atom, the HF potential acting on the occupied states is local and the HF density is v-representable, so that, $E_{OEP} = E_{KSHF} = E_{DHF} = E_{HF}$. This observation is con rm ed by numerical calculations [8]. For all other atom s, the HF potentials are non-local, and the HF densities are not v-representable. O by iously, in that case, one has $E_{OEP} = E_{KSHF} > E_{DHF} = E_{HF}$ in accordance with the num erical calculations [8].

In summary, by clarifying the relationship between the non-local exchange HF potential and the local exchange KS potential, we have shown that the Hartree Fock method cannot be reproduced within the framework of Kohn-Sham theory because the single-particle densities of nite systems obtained in Hartree Fock calculations are not v-representable. We have demonstrated that the fact that the KS calculations of nite electron systems lead to higher ground state energies cannot be used to infer the existence of inconsistencies in either KS or DFT theory. Most of the speci c features of the HF m ethod result from the non-local nature of the HF potential. For this reason, they provide no grounds to criticize the Kohn-Sham theory which deals with local single-particle potentials and v-representable densities. To conclude, it is worth m entioning that at present there is no com pelling evidence to believe the HF m ethod to be superior to the KS approach. Among the drawbacks of the HF theory is the well-known fact that the HF non-local single-particle potential acting on the unoccupied states falls o exponentially. As a result, the HF potential can only support very few unoccupied energy levels, which leads to di culties in treating the excited states. By contrast, the KS theory does not su er from the drawbacks inherent in the HF method. Thus, a further study is needed to clarify which type of behavior actually occurs in atom s with a large num ber of electrons and whether the failure to agree with the HF results can, indeed, be considered a fault of the KS theory.
