N onlinear theory of solitary waves associated with longitudinal particle motion in lattices: Application to longitudinal grain oscillations in a dust crystal

The nonlinear aspects of longitudinal motion of interacting point masses in a lattice are revisited, with emphasis on the paradigm of charged dust grains in a dusty plasm a (DP) crystal. Dierent types of localized excitations, predicted by nonlinear wave theories, are reviewed and conditions for their occurrence (and characteristics) in DP crystals are discussed. Making use of a general formulation, allowing for an arbitrary (e.g. the Debye electrostatic or else) analytic potential form (r) and arbitrarily long site-to-site range of interactions, it is shown that dust-crystals support nonlinear kink-shaped localized excitations propagating at velocities above the characteristic DP lattice sound speed v_0 . Both compressive and rarefactive kink-type excitations are predicted, depending on the physical parameter values, which represent pulse- (shock-)like coherent structures for the dust grain relative displacement. Furtherm ore, the existence of breather-type localized oscillations, envelope-m odulated wavepackets and shocks is established. The relation to previous results on atom ic chains as well as to experimental results on strongly-coupled dust layers in gas discharge plasm as is discussed.

I. IN TRODUCTION

A wide variety of linear electrostatic waves are known to propagate in plasm as [1, 2]. It is now established that the inherent nonlinearity of electrostatic dispersive media gives birth to remarkable new phenomena, in particular related to the form ation and stable propagation of long-lived nonlinear structures, when a balance between nonlinearity and dispersion is possible [3, 4]. Since about a decade ago, plasm a wave theories have received a new boost after the prediction (and subsequent experimental con mation) of the existence of new oscillatory modes, associated with charged dust-grain motion in dust-contam inated plasm as, as well as the possibility for an important modi cation of existing modes due to the presence of charged dust grains [5, 6]. A unique new feature associated to these dusty (or com plex) plasmas (DP) is the existence of new stronglycoupled charged matter con gurations, held responsible for a plethora of new phenom ena e.g. phase transitions, crystallization, melting etc., and possibly even leading to the form ation of dust-layers (DP crystals) when the inter-grain potential energy far exceeds the average dust

kinetic energy; a link has thus been established between plasm a physics and solid state physics [7]. These dust B ravais-type quasi-lattices, which are typically form ed in the sheath region in low {tem perature dusty plasm a discharges, and rem ain suspended above the negative electrode due to a balance between the electric and gravity forces [8, 9, 10, 11], are known to support harm onic excitations (acoustic modes) in both longitudinal and transverse-shear (horizontal-plane) directions, as well as optical-mode-like oscillations in the vertical (o -plane) direction [12, 13, 14, 15, 16, 17, 18, 19].

The longitudinal dust-lattice waves (LD LW) are rem iniscent of waves (phonons') propagating in atom ic chains, which are long known to be dom inated by nonlinear phenom ena, due to the intrinsic nonlinearities of inter-atom ic interaction mechanisms and/or on-site substrate potentials [20, 21, 22, 23, 24]. These phenom ena have been associated with a wealth of phenomena, e.g. dislocations in crystals, energy localization, charge and inform ation transport in bio-m olecules and DNA strands, coherent signal transm ission in electric lines, optical pulse propagation and m any m ore [25, 26, 27, 28, 29]. Even though certain well-known nonlinear mechanisms, e.g. shock form ation, electrostatic pulse propagation and instabilities, have been thoroughly investigated in weaklycoupled (gas-like) dusty plasm as [6, 30, 32], the theoretical investigation of the relevance of such phenom ena with waves in DP crystals is still in a pre-m ature stage; apart from the pioneering works of M elands [12], who rst derived a Korteweg-DeVries (KdV) equation [31] associated with longitudinal dust-lattice oscillations, Shukla [19], who predicted the form ation of dust cavitons due to lattice dynam ical coupling to surrounding ions, and

the investigation of related nonlinear am plitude m odulation e ects by Am in et al. [33] a little later, not much has been done in the direction of a system atic elucidation of the relevance of dust-lattice waves being described by the known m odel nonlinear wave equations. It should, how ever, be stressed that some recent attempts to trace the signature of nonlinearity in experiments [34, 35, 36] have triggered an e ort to interpret these results in terms of coherent structure propagation [35, 36, 37, 38], essentially along the physical ideas suggested in R ef. [12].

In this paper, we aim at reviewing the procedure em ployed in the derivation of a nonlinear evolution equation for longitudinal dust grain motion in DP lattices, and discussing the characteristics of the solutions. Emphasis is made on the methodology, in a quite exhaustive manner, in close relation with previous results on atom ic chains, yet always focusing on the particular features of DP crystals; we will discuss, in particular:

- the physical assumptions underlying the continuum approximation;

-the choise of truncation scheme, when departing from the discrete lattice picture;

- the long-range electrostatic interactions, di erentiating DP crystals from ordinary classical atom ic chains (spring m odels);

- the physical relation between di erent solutions obtained.

Some of the results presented here are closely related to well-known previous results, yet enriched with a new analytical set of coe cients allowing for any assumed range of site-to-site interactions and any analytical form of the interaction potential. The present study is, therefore, valid in both short and long-D ebye length DP cases, and also aim s at providing a general 'recipe' which allow sone, for instance, to assume a modi ed (possibly non-D ebyetype) potential form and obtain the corresponding set of form ulae in a straightforw and manner. In speci c, we have in m ind the modi cation of the inter-grain interactions due to ion ow in the sheath region surrounding the dust layer, which may even lead to the crystal being destabilized, according to recent studies from minciples [39, 40].

M ost of the results presented here are general and apply, in principle, to a su ciently general class of chains of classical agents (point masses) coupled via arbitrary (and possibly long-range) interaction laws. Nevertheless, our specic aim is to establish a rst link between existing nonlinear theories and the description of longitudinal dust-lattice oscillatory grain motion in a DP crystal. At a rst step, our description cannot help being 'academ ic', and som ew hat abstract: an ideal one{ dim ensionalDP crystal is considered, i.e. a single, unidimensional, in nite-sized, dust-layer of identical (in size, charge and mass) dust grains situated at spatially periodic sites (at equilibrium). E ects associated with crystal asymmetries, defects, dust charging, ion-drag, dust m ass variation and multiple dust-layer coupling, are left for further consideration [41]. Transverse (o -plane) m otion, in particular, will be addressed in a future work.

A. Equation of m otion

Let us consider a layer of charged dust grains (m assM , charge Q , both assumed constant for simplicity) forming a B ravais lattice, of lattice constant r_0 . The H am iltonian of such a chain reads

where r_n is the position vector of the n th grain; U_{nm} (r_{nm}) Q (x) is a binary interaction potential function related to the electrostatic potential (x) around the m th grain, and $r_{nm} = jr_n - r_m j$ is the distance between the n th and m th grains. We shall lim it ourselves to considering the longitudinal (\hat{x}) m otion of the n th dust grain, which obeys

where E (x) = @ (x)=@x is the electric eld; the usual ad hoc damping term is introduced in the left-hand-side (lhs), involving the damping rate , to account for the dust grain collisions with neutrals. Note that a one-dimensional (1D) DP layer is considered here, but the generalization to a two-dimensional (2D) grid is straightforward. At a rst step, we have om itted the external force term F_{ext} , often introduced to account for the initial lager excitation and/or the parabolic con nement which ensures horizontal lattice equilibrium in experiments [35]. The analogous form ulae for non-electrostatic, e.g. spring{like coupling interactions are readily obtained upon som e trivialm odi cations in the notation.

The additive structure of the contribution of each site to the potential interaction force in the right-hand-side (rhs) of Eq. (1) allows us to express the electric eld in (1) as:

where l denotes the degree of vicinity, i.e. l = 1 accounts for the nearest-neighbour interactions (NNI) and l = 2 accounts for distant- (second or farther) neighbour

interactions (D N I). The sum mation upper limit N naturally depends on the model and the interaction mechanism; even though N traditionally' equals either 1 or 2 in most studies of atom ic chains, one should consider higher values for long-range-interactions e.g. C oulom b or D ebye (screened) electrostatic interactions (the latter case is addressed below, in detail). In the last step, we have Taylor-developed the interaction potential (r) around the equilibrium inter-grain distance $lr_0 = jn$ m j₀ (between 1 th order neighbours), viz.

where l^0 denotes the degree (power) of nonlinearity involved in each contribution: $l^0=1$ is the linear interaction term, $l^0=2$ stands for the quadratic nonlinearity, and so forth. Obviously, $x_n=x_n \quad x_n^{(0)}$ denotes the displacement of the n the grain from equilibrium, which now obeys

W e have distinguished the linear/nonlinear contributions of the rst neighbors (1st/3rd lines) from the corresponding longer neighbor terms (2nd/4th lines, respectively).

K exping all upper sum mation limits at in nity, the last discrete di erence equation (3) is exactly equivalent to the complete equation (1). However, the form er needs to be truncated to a speci c order in $1;1^0$, depending on the desired level of sophistication, for reasons of tractability.

B. Continuum approximation.

W e shall now adopt the standard continuum approxim ation often employed in solid state physics [7], trying to be very system atic and keeping track of any inevitable term truncation. W e will assume that only small displacem ent variations occur between neighboring sites, i.e.

where the subscript in u_x denotes di erentiation with respect to x, i.e. $u_{xx} = 0^2 u = 0 x^2$ and so on. We see that only even order derivatives contribute to the linear part; this is rather expected, since the model (for = 0) is conservative, whereas odd-order derivatives m ight introduce a dissipative e ect, e.g. via a Burgers-like (u_{xx}) additional term in the K dV Eq. below [42, 43, 44]. The de nition of the coe cients c $_{2m}$ (m = 1;2;:::) is obvious; the rst term reads

and so on. Notice that $v_1^2 = v_0^2 = 12$ for NN I, i.e. if (and only if) one stops the summation at $l_{max} = N = 1$, like Eq. (26) in Ref. [12] [and unlike Eq. (5) in Ref. [38], whose 2nd term in the rhs is rather not correct, for 16 1 i.e. DN I]. See that the 'relative weight' of any given 2m th contribution as compared to the previous one is roughly (2m 2) \models (2m) !, e.g. 4 \models 6! = 1=30 for m = 3, which somehow justi es higher (than, say, m = 2) order contributions often neglected in the past; nevertheless, this argum ent should rigorously not be taken for granted, as a given function u(x;t) and/or potential (x), may present higher num erical values of higher-order derivatives, balancing this num erical e ect; clearly, any truncation in an in nite series inevitably implies loss of inform ation.

W e m ay now treat the quadratic nonlinearity contribution in (3) (the last two lines for $l^0 = 2$) in the same m anner. M aking use of Eqs. (4) and (5), and also of the identity a^2 $\dot{B} = (a + b)(a - b)$, one obtains

H igher order nonlinearities in Eq. (3) (the last two lines therein for 1^0 4), related to ffh- (or higher-) order derivatives of the interaction potential , will deliberately be neglected in the following, since they are rather not likely to a ect the dynamics of sm all grain displacements. It should be pointed out that, rigorously speaking, there is no a priori criterion of whether some truncation of the above in nite sum s is preferable to another; som e ad hoc truncation schemes, proposed in the past, should only be judged upon by careful numerical com parison of the relevant contributions { e.g. in Eqs. (6), (9), (11) above { and/or, nally, a comparison of the analytical results derived to experim ental ones.

K exping the rst few contributions in the above sum s, one obtains the continuum analog of the discrete equation of m otion

de ned by Eqs. (7), (8), (10) and (12), respectively, should be evaluated for a given potential function by truncating, if inevitable, all sum m ations therein to a given order l_{max} . Note that, quite surprisingly, the in nite neighbour contributions m ay be exactly sum m ed up, in the case of D ebye (screened) electrostatic interactions, as we shall show below. Let us point out that Eq. (13) is general; the only assumption made is the continuum approximation. Also, should one prefer to improve the above truncation scheme, e.g. by including more nonlinear term s, one m ay readily go back to the above form u lae and simply keep one or more extra term (s); in any case, one can nd the exact form of all (retained and truncated) coe cients above. On the other hand, Eq. (13) generalizes the previous known results for monoatom ic lattices in that it holds for an arbitrary degree of intersite vicinity (range of interactions).

Let us point out that the above de nitions of the coe cients in Eq. (13) are inspired by the Debye{Huckel (Yukawa) potential form (whose odd/even derivatives are negative/positive; see below), in which case they are dened in such a way that all of v_0^2 , v_1^2 , p_0 and q_0 take positive values. Nevertheless, keep in m ind that the sign of these coe cients for a di erent potential function is, in principle, not prescribed; indeed, analytical and num erical studies of the nature of the inter-grain interactions from st principles suggest that the presence of ion ow, for instance, may result in a structural change in the form of , leading to lattice oscillation instability and presum ably crystal melting [45]; see e.g. Refs. [39, 40]. However, our physical problem loses its meaning once this happens; therefore, we will assume, as a working hypothesis in the following, that c_2 and c_4 bear positive values (so that v_0 , v_1 are real) - as a requirem ent for the stability of the lattice - and that, in principle (yet not necessarily), the same holds for p_0 and q_0 .

We observe that, upon setting = 0, $q_0 = 0$, $r_0 = a$ and l = 1 (NN I), which imply that $v_1^2 = v_0^2 a^2=12$ and $p_0 = Q a^3 \ ^{(0)}(a)=M$ (a) $a^3=M$ in Eq. (13), one recoversexactly Eq. (26) in Ref. [12] [also see the denition in Eq. (16) therein]; also cf. Ref. [33]. Equations (5) { (7) in Ref. [38] are also recovered.

In the following, we will drop the dam ping term [second term in the right-hand-side of Eq. (13)], which is purely

M ost interestingly, the sum m ations (in 1) in the above de nitions of coe cients $c_{m,m}$, above, converge and m ay exactly be computed in the D ebye-Huckel (Yukawa) potential case: D (r) = Q e^{r= D} =r, for any given num - ber N of neighboring site vicinity: N = 1 for the nearest neighbor interactions (NN I), N = 2 for the second-neighbor interactions (SN I) and even N equal to in nity, for an in nite chain. The details of the calculation are given in the Appendix, so only the nal result will be given here, for later use in this text. Note the de nition of the lattice parameter = $r_0 = D$, to be extensively used in the following; in fact, is roughly of the order of (or slightly above) unity in laboratory experiments.

A num erical investigation shows that the num erical value of the frequency in the region near r_0 $_{\rm D}$ (i.e. 1) is thus increased by a factor of 1:5 or higher, roughly, com pared to the NNI expression above (see Fig. 1), and so does the characteristic second-order dispersion velocity v_0^2 = $!_{\rm L\,;0}$ r_0 = $!_{\rm L\,;0}$ $_{\rm D}$ (see Fig. 2). A sim ilar ect is w itnessed for the characteristic velocity v_1 , related to the fourth-order dispersion

U pon sim ple inspection of F igs. 4 and 5, one deduces that q_0 takes practically double the value of p_0 everywhere, and thus draw s the conclusion that q_0 should rather not be om itted in Eq. (13) (cf. e.g. Refs. [12, 30, 35, 38]), for the case of the D ebye potential.

III. LINEAR OSCILLATIONS

Let us rst consider the linear regime in longitudinal grain oscillations. For the sake of rigor, one may revert to the discrete form ula (3) and consider its linearized form by simply neglecting the two last (double) sums therein. Inserting the ansatz $x_n = \exp i(nk_B + t)$, where ! is the phonon frequency and k = 2 = (respectively,) is the wavenum ber (wavelength), one immediately obtains the general dispersion relation

O ne m ay readily verify that the standard 1D acoustic wave dispersion relation ! v_0 k is obtained in the sm all k (long wavelength) lim it: check by setting sin (lkr₀=2) lkr₀=2 (and recalling the general de nition of v_0 above). O fcourse, taking this lim it sim ply am ounts to linearizing the continuum equation of motion derived above (and keeping the lowest contribution in k). As pointed out

before (see e.g. Ref. [18]), one thus recovers the dustacoustic wave dispersion relation obtained in the strongcoupling dusty plasm a regime (upon de ning the density $n_d as r_g^3$, which may nevertheless appear som show heuristic in this 1D m odel).

Notice that the form of the dispersion relation, in principle, depends on the value of N . However, in the case of the Debye interactions, i.e. explicitly substituting $d^2_{\ D}$ (x)=dx² into (22), one obtains

A numerical investigation, e.g. for = 1 (see Fig. 6), suggests that the dispersion curve quickly sum s up to a limit curve, even for not so high values of N (practically for N = 2 already). The values of the frequency reduce with increasing , as suggested by the exponential term . We see that the dispersion curve possesses a maximum at $k = = r_0 = = (\ _D$) for any value of and N .

The dispersion curves of dust-lattice waves have been investigated by both experiments (see e.g. Refs. [46, 47]) and ab initio numerical simulations [48]. In should nevertheless be acknow ledged that the results of these studies do not absolutely con m the dispersion curves obtained above, which suggests, as poined out in Ref. [46], that one-dimensional crystalm odels may be inappropriate for real dust crystals.

IV. THE KORTEW EG { DE VRIES (KDV) EQUATION

In order to take into account weak nonlinearities, a procedure which is often adopted at a rst step consists in keeping only the rst nonlinear contribution in Eq. (13) (by cancelling the last term in the rhs, i.e. setting $q_D = 0$) and then considering excitations moving at a velocity close to the characteristic velocity v_0 . W e have introduced the parameters (= +1 = 1), denoting the sign of po, which m ay change the form of the solutions (see below); as discussed above, it is equal to s = +1for the Debye-type interactions. It should be noted that this procedure is identical to the one initially adapted for dust-lattice-waves in [12] and then followed in Ref. [30, 35, 38] (for s = +1) as may readily be checked, yet the new aspect here lies in the generalized de nitions of the physical parameters above. A lso notice that positiveoriented (\hat{x}) propagation was considered; adopting the above procedure in backward (x) propagation is trivial, yet it should be carried out by re-iterating the analytical procedure and not by plainly considering v ! v: the K dV equation is not symmetric with respect to this transform ation (also see that the velocity v appears under a square root in the form ulae).

As a m athem atical entity, the K dV Equation has been extensively studied [3, 27, 49, 50, 51, 52, 53, 54, 55], so only necessary details will be summarized here. It is known to possess a rich variety of solutions, including periodic (non-harmonic) solutions (cnoidalwaves, involving elliptic integrals) [54]. For vanishing boundary conditions, Eq. (25) can be shown (see e.g. in Refs. [27, 55]) to possess one-ormore (N) soliton localized solutions w_N (;) which bear all the well-known soliton properties: namely, they propagate at a constant prole, thanks to an exact balance between dispersive and nonlinear e ects, and survive collisions between one another. The simplest (one-) soliton solution has the pulsed-shaped form

where x_0 is an arbitrary constant, denoting the initial soliton position, and v is the velocity of propagation; in

principle, v m ay take any realvalue even though its range m ay be physically limited, as in our case, where v has been assumed close to v_0 ; this constraint will be relaxed below. A qualitative result to be retained from the soliton solution in (27) is the velocity dependence of both soliton amplitude $w_{1,m}$ and width L_0 , viz.

We see that $w_{1,m} L_0^2 = \text{constant}$, implying that narrower/wider solitons are taller/shorter and propagate faster/slower. These qualitative aspects of dust-lattice solitons have recently been con m ed by dust-crystal experim ents [35]. Notice that the solutions of (25) satisfy an in nite set of conservation laws [3, 55]; in particular, the solitons $w_{\,\rm N}\,$ carry a constant $\,h$ ass' Mwd (which_R is negative for a negative pulse), in om entum ' $(w_x^2 = 2 + u^3)d$, and so Ρ $w^2 d$, energy P forth (integration is understood over the entire x axis) [52, 55]. See that the forem entioned am plitude {width dependence of the 1-soliton solution (27) is heuristically deduced from the soliton In ass' conservation law (im plying conservation of the surface under the bell-shaped curved in Fig. 7): taller excitations have to be thinner and vice versa.

Inverting back to our initial reference frame, one obtains, for the spatial displacement variable u(x;t), the kink/antikink (for s = 1 = +1) solitary wave form

in posing Supersonic' propagation $(v > v_0)$ for stability, in agreement with experimental results in dust crystals [35]. Notice that faster solitons will be narrow er, and thus more probable to Yeel' the lattice discreteness, contrary to the continuum assumption above; therefore, one may impose the phenomenological criterion: L r_0 , amounting to the condition $v=v_0$ $1 + 2v_1^2=v_0^2$ [1:17 for the Debye NNI case; see (14) above], in order for the above (continuum) solution to be sustained in the (discrete) chain. Nevertheless, supersonic wave stable propagation has been numerically veried at a wide range of velocity values in atom ic chains [23, 57], where Eqs. (13) and (25) arise via a procedure similar to the one outlined above; also see Ref. [58] for a recent experiment in crystalline solids. Finally, note that v_0 in real DP crystals bears values as low as a few tens of mm /sec [34, 35].

R em arkably, Eq. (25) is exactly solved via the Inverse Scattering Transform [53, 55, 56], for any given initial condition u(;0), which is generally seen to break-up into a number of (say N, depending on u(;0) [56]) solitons plus a tail of background oscillations. These considerations, including, in particular, the two-soliton solution w_2 of Eq. (25), which represents two distinct hum psm oving at di erent velocities and colliding during propagation without changing shape, have been postulated to be of relevance in the interpretation of recent dusty plasm a discharge experiments [35, 38].

The wide reputation of the K dV Equation (25) is mostly due to the exhaustive know ledge of its analytical properties [3, 27, 51, 52, 53, 54, 55], in addition to its om ni-presence in a variety of physical contexts, not excluding the physics of ordinary (ideal, i.e. electron{ ion) plasm as [3, 4] and, m ore recently, dusty plasm as [6, 30]. How ever, in the above dusty-plasm a-crystal context, it has been derived under speci c assumptions (low discreteness and low nonlinearity e ects; also, a propagation velocity v v₀) which m ay be questionable, in a realDP crystal. Even if the rst one is virtually in possible to cope w ith, analytically, the latter ones m ay be som ehow relaxed via a di erent approach, to be outlined below.

V. HIGHER-ORDER KORTEW EG {DEVRIES (EKDV) EQUATIONS

In order to derive a K dV equation from the continuum equation of motion (13), we have neglected the coe – cient q, which is related to the cubic nonlinearity of the interaction potential. Nevertheless, a simple numerical investigation shows that this term is not small, and may, in certain cases, even dom inate over the quadratic term p, as in the D ebye potential case (see the discussion above). Therefore, one is tempted to nd out how the dynam ics is modiled if this term is taken into account.

A. The Extended K ortew eg { de V ries (EK dV) E quation

Repeating the procedure which led to Eq. (25), in the previous section, yet now keeping the fourth order derivative coe cient $q \in 0$ in Eq. (13), one obtains the EK dV Equation

where all coe cients are given in (26) except $\hat{a} = q_0 = (2v_0)$; recall that a, b are positive by de nition. We shall see below that $p_0; q_0 > 0$ for D ebye interactions (yet

not necessarily, in general), so that the nonlinearity coe cients, i.e. sa (for s = +1) and â, bear negative and positive (respectively) values in this (Yukawa crystal) case.

The EK dV Eq. (29) was thoroughly studied in a classical series of papers by W adati [21], who derived it for nonlinear lattices, then obtained its travelling-wave and, separately, periodic (cnoidalwave) solutions and, nally, exhaustively studied its m athem atical properties. B oth compressional and rarefactive solitons (say, w_2 ; , to be distinguished from the K dV solution w_1) were found to solve Eq. (29) (for either signs of s); adapted to our notation here [59], they are of the form

For s = +1= -1, the rst expression represents a propagating localized compression/rarefaction, while the second denotes a (larger, see comment below; cf. Fig. 8) rarefaction/compression, respectively. Notice that, for $q_0 = a = 0$, the rst expression recovers the K dV result obtained previously (since v=C then recovers the K dV soliton width $w_{1,m}$), while the second results in a divergent (physically unacceptable) solution [21]. and j = 1;2. As expected, for any given s (= 1), the two di erent kink/antikink solutions obtained for di erent j (= 1 or 2) are not symmetric; cf. Figure 8. Notice that the maximum value now also depends on W₂^(j) (j = 1;2).

In conclusion, the Extended K dV equation provides a m ore complete description of the nonlinear dynam ics of the lattice, compared to the KdV equation. In particular, the EKdV compressive (rarefactive) pulse soliton obtained for s = +1 (s = 1), i.e. $p_0 > 0$ ($p_0 < 0$) is slightly smaller than its KdV counterpart (see Fig. 8), but the EK dV also predicts the possibility for a rarefactive (compressive) soliton, in either case, to form and propagate in the same lattice. In the particular case of Debye crystals, the net new result to be retained is the prediction of the existence of a rarefactive new excitation, in addition to the rarefactive one, observed in experim ents. N evertheless, theoretical studies on m olecular chains seem to suggest that the additional shock-like localized m ode predicted by the EK dV equation will not be as stable as its (K dV (related) counterpart. This prediction should, therefore, be con med num erically (and experim entally) before being taken for granted.

B. The M odi ed K ortew eg { de V ries (M K dV) Equation

Note, for the sake of rigor, that upon setting $p_0 = 0$ in Eq.(29) above, one obtains a modi ed K dV (M K dV)

equation (with only a cubic nonlinearity term). The MKdV equation shares all the qualitative properties of the KDV Eq. and is, in fact, related to it via a M iura transform ation [55]. It has two (both negative and positive, for each value of s) pulse soliton solutions which follow immediately from the preceding solutions (30) and (31) of the EK dV equation, upon setting $p_0 = 0$. The remarkable additional aspect of the MKdV equation is that it also bears slowly oscillating solutions, named breathers, obtained just as rigorously via the inverse scattering method [22, 60]. These solutions (whose wavelength is comparable to their localized width, hence the breathing' in pression and the nam e) share the rem arkable properties of solitons; in particular, they are seen to survive collisions between them selves and with pulse solitons [22]. Their analytic form can be readily found in Refs. [22] (see x4.1 therein) and [60] and will not be reproduced here, since their condition of existence, q_0 (cf. Ref. [22]) is rather not satis ed in namely p_0 the case of D ebye-interacting dust grains. Note how ever that breather-like excitations m ay exist in a DP crystal, as one may see via a di erent (perturbative) analysis of the nonlinearm odulation of the amplitude of longitudinal lattice waves. This is considered in separate work [61].

R em em ber that the K dV {type equations in the preceding Section were obtained from the equation of m otion (13) in an approximative manner, assuming near{sonic propagation and neglecting high{order time derivatives. Those results are therefore expected to hold for velocity values only slightly above v_0 . We shall now see how these assumptions can be relaxed by directly relying on the initial (nonlinear) equation.

Let us consider Eq. (13) again (for = 0). Upon setting $p_0 = 2p$, q = 3q, $v_1^2 r_0^2 = h > 0$, and integrating once, with respect to x, one exactly obtains, for $w = u_x$, the generalized Boussinesq (GBq) Equation

It possesses well-known localized solutions, whose derivation is straightforward and need not be reproduced here. The exact expressions obtained from (37) for the relative displacement w (x;t) and the longitudinal displacement u (x;t) are exhaustively presented and discussed in Refs. [22, 23]. The analytic kink/antikink-type localized solutions for u (x;t) read

Recall that, for Debye interactions, h;q > 0 and $p = p_0 < 0$ (see above), prescribing the 'supersonic' (v > v_0) propagation of the solutions; the same was true of the K dV solitons obtained above. Notice, how ever, that the expressions obtained here for the longitudinal displacement u represent both rarefactive and compressive lattice excitations even for $p_0 > 0$ (see Table I in [23], for $p = p_0 < 0$); remember that this feature was absent in the K dV equation (25), where $p_0 > 0$ i.e. s = +1 always led to a compressive solution in (28). In fact, this is also true of the B q equation, which is obtained for $q_0 = 0$, i.e. neglecting the last term in the continuum equation of motion (13). The exact solution then reads

which, for positive h and p_0 , prescribes only compressive supersonic kinks, pretty m uch like the solution u_1 derived from the K dV theory above (cf. Table I in [23], for $h_0 > 0, p < 0$ and q = 0).

C losing this section, one may wish to compare the GBq and Bq solutions (38) and (40), to the hom ologous EK dV { and K dV {related solutions (35) and (28), respectively, obtained previously: one may readily check that the form er ones tend to the latter two as v tends to v_0 [to see this, one may set $v^2 = (v + v_0)(v^2 = v_0)$ $2v_0 (v^2 = v_0)$; recall that $h = v_1^2 r_0^2$]. Nevertheless, this velocity range restriction is relaxed in the Boussinesq{ related description.

VII. EXCITATIONS IN REAL DP CRYSTALS

It is now quite tempting to observe and compare the predictions furnished by the above nonlinear models in a DP crystal in terms of excitation features, e.g. dimensions and form. For instance, one may substitute the expressions for the model's physical parameters (i.e. $!_0$, v_0 , v_1 , p_0 and q_0) derived in xIIC into the denitions in the latter three sections, in order to derive a nal form for localized excitations in a real DP crystal, in terms of the propagation velocity v, the lattice parameter and, generally, the sign s (= +1 for D ebye interactions). The interest in this procedure is evident, since one may seek

feedback (e.g. parameter values, excitation behaviour) from experiments and then investigate the validity of the above models by adjusting them to realDP crystal values.

The nalexpressions for $u_j(x;t)$ [j = 1;2;3, cf. (28), (35) and (38), respectively] are somewhat lengthy and need not be reported here (since they are straightforward to derive). We may nevertheless summarize some interesting numerical results.

The soliton width L_1 , as de ned in (28), now becomes $L_1 = v_0^2 = p_0 u_{1,m}$: we see that the product of the displacement u kink's width and maximum value remains constant (regulated by the cubic interaction potential non-linearity), viz. $u_{1,m} L_1 = 1 = p_0$, unlike the K dV pulse soliton for the relative displacement $w = u_x$ which is characterized by $w_{1,m} L_1^2 = \text{cst.}$ Both the kink maximum value $u_{1,m}$ and width L_1 depend on the velocity v; as a matter of fact, faster kink excitations will be taller and narrow er - see F ig. 9 - since now

Recall that the M ach num ber $M = v = v_0$ is always larger than unity. Furtherm ore, the magnitude of the excitation seems to decrease with ; see Fig.9a: nevertheless, very high values (near $u=r_0 = 1$) observed for low and high v are rather not to be trusted, since they contradict the continuum approximation $u = r_0$.

Finally, one may compare the solutions obtained from the above theories, for a typical value of , say 1.25, according with real experim ental values. The KdV {, EKdV { and Boussinesq{related kink excitations, i.e. u_1 , u2 and u3, are depicted in Figs. 10 { 12, for three di erent values of M , 1:1, 1:25 and 2. W e see that the EK dV and Bqm odels allow for both compressive and rarefactive structures, while the K dV description predicts a localized compression, which is quite sensitive to velocity changes. As expected (cf. the discussion above), both the EKdV { and Bq{related compressive excitations are sim ilar in magnitude to the KdV {related anti-kink for near{sonic velocity (i.e. near M 1). Nevertheless, we see that the KdV {related antikink becomes taller and narrower as velocity increases, and substantially di erentiates itself from its EKdV { and Bq{analogues. One may wonder whether or not the KdV picture (more fam iliar since w idely studied) is adequate for the m odeling of a realDP crystal, and also whether the rarefactive excitations predicted by other theories can indeed be sustained in the crystal. These questions may be answered by appropriate experiments and, possibly, also be investigated by num erical simulations. From a purely theoretical point of view, the Boussinesq { based description appears to be more rigorous (recall that the KdV was derived in some approximation) and valid in a more extended region than both the KdV and Extended-KdV theories.

The above analytical solutions have been derived in the continuum limit, i.e. for $L >> r_0$, where L is the typical spatial dimension (width) of the solitary excitation. One m ay therefore de ne the discreteness param eter $g = r_0 = L$, and require a posteriori that g 1.From the expressions derived for the Bq equation above, one (√2 v_0^2)¹⁼²= v_1 , so this requirement easily sees that g is indeed ful lled for propagation velocities v vo.However, for higher values of v, the (narrower) soliton will be subject to a variety of e ects e.g. shape distortion, wave radiation etc., due to the intrinsic lattice discreteness. These e ects have been investigated in solid state physics [62, 63] and may be considered with respect to DP crystals at a later stage. Let us brie y point out that narrow kink-shaped lattice excitations have been num erically shown to propagate with no considerable loss of energy, in a quite generalm onoatom ic lattice m odel [62].

A lso worth mentioning is the work of Rosenau [65] who derived an in proved version of the Boussinesq equation (the I-Bq Eq.) in a quasi-continuum limit. The I-Bq equation, which bears the general structure of (37) upon replacing h u_{xxxx} therein by h u_{xxtt} (yet with di erent coe cient de nitions), is not integrable and bears solitary wave solutions which do not collide elastically; nevertheless, it was num erically shown to be more stable than the Bq equation, and was argued to model discrete lattice dynam ics more e ciently, upon comparison of theoretical predictions to exact num erical results [63]. Further exam ination of such e ects may be carried out in dust-lattices, once our feedback from experim ents has su ciently determ ined the relevance of the issue in real DP crystals, i.e. typical excitation width, dynam ics etc.

It should be underlined that the possibility for the existence of breather solitons, anticipated above, establishes a link between complex plasm a 'solid state' m odeling and the fram ework of discreteness-related localized excitations (discrete breathers [66], intrinsic localized m odes [67]), which have recently received increasing interest am ong researchers in the nonlinear dynam ics community. These localized m odes, which are due to coupling anharm onicity and are stabilized by lattice discreteness, have been shown to exist in frequency regions forbidden to ordinary lattice waves and account for energy localization in highly discrete real crystals, where continuum theories fail. The relevance of this fram ework to dust crystals appears to be an interesting open area for investigation.

IX. ENVELOPE EXCITATIONSAND SHOCKS { OPEN ISSUES

As a nal interesting issue involved in the nonlinear dynam ics of longitudinal lattice oscillations, let us mention the nonlinear modulation of the amplitude of dustlattice waves, a well-known mechanism related to harmonic generation and, possibly, the modulational instability of waves propagating in lattices, eventually leading to modulated wave packet energy localization via the form ation of envelope solitons [29]. This fram ework, which was recently also investigated with respect to low frequency (dust-acoustic, dust-ion acoustic) electrostatic waves in dusty plasm as [32], has been partly analyzed, on the basis of the M elands [12] m odel in R ef. [33]. The authors relied on a truncated Boussinesq equation, in the form of (37) for q = 0, and succeeded in predicting the occurrence of modulational instability in LDL waves in DP crystals and the form ation of envelope structures. Nevertheless, the nonlinearity coe cient q om itted therein seems to compete with p in (37) (notice the different signs) and is rather expected to a ect signi cantly the wave's stability pro le. It should be stressed that these localized envelope excitations result from a physicalmechanism which is intrinsically dierent from the one related to the sm all{am plitude excitations described in this paper; see the discussion in Ref. [68]. An extended study of this modulation nonlinear mechanism is in row and will be reported elsewhere, for clarity and conciseness.

As a nalcomment, we may speculate on the role of damping, herewith ignored, on the dynamics of dustlattice waves. It is known that weak dam ping m ay balance nonlinearity, leading to the form ation of shock wave fronts, as predicted in Refs. [30, 43] and con rm ed by num erical simulations [44]. Furtherm ore, it was recently shown that the same mechanism may result in the formation of large-amplitude wide-shaped solitary waves, which may later break into a (gradually dam ped) train of solitons or a wavepacket depending on physical param eters [42]. We see that friction, yet weak, may play a predom inant role in the life and death of localized excitations; this e ect de nitely deserves paying close attention with respect to waves propagating in dust crystals. A gain, one would expect phenom enological theories followed by appropriately designed experiments to elucidate the friction mechanisms inherent in longitudinal dust-lattice wave propagation, in view of a more com plete description than the one provided by the conservative m odel adopted here.

X. CONCLUSIONS

This work was devoted to an investigation of the relevance of existing model nonlinear theories to the dynam ics of longitudinal oscillations in anharm onic chains, with emphasis on dust-lattice excitations in (stronglycoupled) complex plasm a crystals. Taking into account an arbitrary interaction potential and long-range interactions, we have rigorously shown that both compressive and rarefactive kink-shaped (shock-like) excitations may form and propagate in the lattice, depending basically on the mechanism of interaction between grains located at each site. These excitations are electively modeled by either K dV - or Boussinesq-type equations, whose analytic form was presented and whose qualitative and quantitative di erences were discussed. In any case, the theory predicts coherent wave propagation above the lattice's 'sound' speed, in agreem ent with previous theoreticalworks and experimental observations (in both atom ic and dust-lattices). It may be appropriate to mention that subsonic soliton propagation in monoatom ic chains was also numerically considered and shown to be feasible in the past [62]. Let us point out that the model used here to pass from a discrete description to the continuum (long-wavelength) limit is quite generic, so possible modi cation via re ned nonlinear equations may readily be obtained from it, for future consideration.

Furtherm ore, we have discussed the possibility of the form ation of breatherm odes and envelope excitations, as a consequence of m odulated wave packet instability, anticipating their link to discrete nonlinear theories of localized m odes, left for future consideration; despite their analytical com plexity, these m odels m ay, in principle, be of relevance in dust crystals due to the nite dimensions of the chain and its intrinsic spatial discreteness. Finally, the possible role played by dissipation m echanism s

has been brie y discussed.

The present study relies on, and aim s at extending, previous theories on both anharm onic atom ic chains and dusty plasm a crystals. We hope to have succeeded in reviewing the form er (extending them to the case of longrange electrostatic interactions) and generalizing the latter (which are still in an early stage). Hopefully, our predictionsm ay be con rm ed by appropriately set-up experim ents, with the am bition of throwing som e light in the relatively new and challenging eld of strongly-coupled com plex plasm as and dust-lattice dynam ics.



Sim ilar to Figs. 11 and 12, for $M = v=v_0 = 2$.
















