Tem perature dependent change in the sym m etry of the order param eter in an electron-doped high-tem perature superconductor

We present specic heat measurements which show an unexpected phase transition from d-wave symmetry to s-wave symmetry as the temperature is reduced in electron-doped $Pr_{2-x}Ce_xCuO_4$ (PCCO), in both optimal and over-doped single crystals. The eld dependence of electronic specic c heat (C_{el}) is linear at T = 2K, consistent with s-wave symmetry, and non-linear, consistent with d-wave symmetry, at T 3K. This behavior is most consistent with a phase transition in the symmetry of the order parameter as the temperature is changed. Such a phase transition could be an explanation for the previous controversial results of diment experiments, performed at diment temperatures in the electron-doped cuprates.

Particle-hole symmetry is an important ingredient of any theory attempting to explain the mechanism of high tem perature superconductivity. Despite its fundam ental in portance, this issue has not been resolved yet, i.e. there is no consensus as to whether the electron-doped (n-type) and hole-doped (p-type) cuprates are essentially the same or very di erent. The symmetry of the order param eter is one of the important param eters to com pare the n-type cuprates to the p-type fam ily. Unlike the p-type cuprates, which are now generally considered to have d-wave symmetry [1,2], the pairing (gap) symm etry of the n-type cuprates continues to rem ain controversial, despite the enorm ous in provem ent in the sam ple quality and experim ental techniques since their discovery over 10 years ago. In addition to experim ents that support an s-wave symmetry [3] or a d-wave symmetry [4[8], there are a few experim ents that suggest a transition from d-wave symmetry to s-wave symmetry as the doping is increased [9,10].

Speci c heat has traditionally been used to study the superconducting (SC) gap since it is a direct measurement of the density of states (DOS). The diculty of detecting the small T^2 -type temperature dependence (5% of the phonon speci c heat at 4 K in YBCO [12]) expected at zero eld from a d-wave superconductor [11] makes eld dependence studies the preferred method of studying the gap symmetry. In a simple isotropic s-wave superconductor, the speci c heat is linear in magnetic

eld for elds larger than H_1 (H > H_{cl}) [13]. For a d-wave superconductor, C_{el} has a H -type eld dependence in the low temperature (T << T_c) and intermediate eld regime (H_{cl} << H << H_{c2}) [14].

In our case measuring the eld dependence of C_{el} is particularly advantageous since our PCCO crystals do not have electronic or nuclear Schottky contributions (see Fig. 1) in the temperature (T > 2K) and eld (H < 10T) range of our measurements. The eld independent addenda leaves C_{el} the only eld dependent part of in our speci c heat measurements. Therefore, our eld dependent data was acquired at a constant temperature while the magnetic eld is ramped up (zero eld cooled) or down. No hysteresis has been observed in our speci c heat between increasing and decreasing eld.

W e m easured the heat capacity of $Pr_2 \times Ce_x CuO_4$ (PCCO) single crystals grown by the directional solidi cation technique with cerium dopings of x = 0.150 0.005 and 0.165 0.005. The non-superconducitng as-grown crystals are annealed at 900 °C (in an inert atm osphere of owing argon gas) in order to attain superconductivity. The cerium concentration of the crystals was determined using W DX to an accuracy of 0:005. The experim ents were perform ed in a Quantum Design PPMS with a modi ed sample holder using therm al relaxation calorim etry [15]. Au-7% Cu wires (1-3 mildiam eter) are used as a weak link to connect the holder to the thermalbath. The therm om eters were calibrated at di erent magnetic elds in order to take into account their small m agnetoresistance. Our setup was tested by m easuring a 3 m q high purity copper sam ple, and a 3.2 m q N b sam ple, and our measurements were within 5% of the standard values.

Fig. 1 shows temperature dependence data on an optimally-doped PCCO crystal with $T_c=22$ 2 K and m ass of 32 mg in several magnetic elds (H//c-axis). The absence of any Schottky upturn at low temperatures show s that the sample is free of any measurablem agnetic in purities. The speci c heat in this case can be represented as $C = [(0) + (H)]T + T^3$, where (0) is the coe cient of the zero eld residual heat capacity, (H) is the coe cient of the eld dependent C_{el} , and is the coe cient of the phonon speci c heat. The gap symmmetry is investigated by studying (H). For H H_{c2},

(H) = $_n$, where $_n$ is the Sommerfeld constant. The (0) term is also found in hole-doped cuprates, and there are several proposals to explain its origin [L6{18]. By making a linear to the C/T vs T² data shown in the inset of Fig. 1 (is kept constant for the two elds), we nd (0)=2.1 0.2 m J/m oleK², $_n$ =5.3 0.2 m J/m oleK², and = 0.23 0.02 m J/m oleK⁴, which results in a D ebye temperature $_D$ = 390 15 K.

The D ebye tem perature is the same (within the accuracy of our m easurem ents) in all the crystals we studied,

and the value of (0) changes between 1.4-2.2 mJ/m oleK 2 in the di erent optim ally-doped crystals we studied. The $_n$ for di erent optim ally-doped crystals depends on the annealing time (oxygen content) and we have observed a variation between 4.0-5.3 mJ/m oleK 2 . The upper critical eld H_{c2} determ ined from speci cheat measurements also depends on the annealing time. Fig. 1 shows that the upper critical eld for this sample is H_{c2} < 8T since there is no di erence in the speci c heat data between 8T and 10T. The H_{c2} of the di erent optim ally-doped sam ples changed between 5.0-7.0 (0.5T) depending on the annealing time of the crystals.

Fig. 2 shows the eld dependence of an optimallydoped crystal ($T_c = 23$ 3K, mass= 3.4 mg). Only the eld dependent part of $C_{\rm el}$ is shown in Fig.2 since the zero- eld speci c heat, which includes the phonon contribution (T³) and the zero eld residual heat capacity ((0)T), is subtracted out. The eld dependence is clearly non-linear at T 3K. How ever, a dram atic change in the eld dependence is observed when the tem perature is reduced to 2K, where a linear eld dependence dom inates up to about 3T.Fig. 2-B shows that the change in the eld dependence of Cel between 4.5K and 2K is accompanied by a suppression of the electronic speci c heat. This suggests that the density of electronic states is suppressed, or possibly a gap is opened at the Ferm i level, since the electronic speci c heat is ameasure of DOS.

This change in the eld dependence of C_{el} from linear at T = 2K to non-linear at higher temperatures has been observed on four optimally-cerium doped crystals with di erent oxygen concentration. In addition to the optimally-cerium doped crystals, crystals of higher cerium doping also show a similar eld dependence. Fig. 3-A shows the eld dependence of speci c heat for an over-doped crystal (x= 0.165 0.005, T_c=15 1.5K, mass= 2.2 mg). The trend from linear to non-linear eld dependence as the temperature is increased is also evident in this crystal. In addition, Fig. 3-B shows that there is a small suppression of C_{el} , and hence electronic DOS, as the temperature is reduced from 3K to 2K.

There are several possible scenarios to explain such an unusual change in the eld dependence of C_{el} : a phase transition in the sym metry of the order parameter from d-wave at high tem peratures (T 3K) to s-wave at lower tem peratures(T 2K); an anisotropic s-wave gap which has a minimum around 3K; or a vortex-vortex interaction e ect which results in a non-linear eld dependence in an s-wave superconductor at T 3K. Now we will discuss each of these scenarios in more detail.

Vortices can interact with each other via quasiparticle (QP) transfer between their cores. At high magnetic elds (large number of vortices) or high temperatures (larger vortex-core size) the quasiparticle wavefunctions in the core of one vortex overlap with the quasiparticle wavefunctions in neighboring vortices, and hence inter-vortex quasiparticle transfer becomes possible. These inter-vortex QP transfers result in a shrinking of the vortex cores [19]. The calculations of Ichioka et al. [20], which took into account these vortex-lattice e ects, showed that C_{e1} / H^{0:67} at T=0.5T_c. Calculations of M iranovic et al. [21] at lower temperatures, where less overlap between vortex-cores reduces these effects and the size of the vortex-core is approximately constant for H < 0.5H_{c2}, showed that C_{e1} / H for H < 0.5H_{c2} at T=0.1T c.

These ideas were experimentally supported by the non-linear eld dependence of C_{e1} observed in some swave superconductors, e.g. V₃Si [2], NbSe₂ [23], and CeRu₂ [24]. Despite some complications that were discovered after the original work, a vortex-lattice transform ation in V₃Si [25] and anisotropic gap in NbSe₂ [26], the fundamental mechanism of vortex-core shrinking due to vortex-vortex interaction is still consistent with the non-linear eld dependence observed in these materials [25].

The change in the eld dependence of C_{el} in PCCO is in qualitative agreem ent with these theories for an swave superconductor. However, in PCCO the change in the eld dependence occurs over a very narrow tem perature range C_{el} / H^{0.5} at T 0.2T_c and C_{el} / H at T $0.1T_c$) compared to the gradual and slower change based on vortex-lattice e ects predicted in Ref. [20,21] for a conventional s-w ave superconductor (C_{el} / $H^{0:67}$ at $T = 0.5T_{c}$ and C_{el} / H at $T = 0.1T_{c}$). Hence, it is very unlikely that the non-linear eld dependence we observe in PCCO is due to a vortex lattice e ect. Regardless of the source of the non-linear eld dependence at higher tem peratures, the linear eld dependence that we observe at T = 2K, which is very similar to what is predicted by Ref. [21] for s-w ave superconductors, shows that the sym m etry of the order param eter is s-w ave at this tem perature.

Another possible explanation for our data is an anisotropic s-wave gap. How ever, it is di cult to di erentiate between an anisotropic s-wave superconductor and a d-wave superconductor using them odynam ic properties because what is usually measured experimentally is QP excitation energy $E_k = \frac{1}{k} + j_k f$, where k is the single particle energy relative to the Ferm i level and k is the SC gap. In particular, measurements on YN i_2B_2C , a highly anisotropic s-wave superconductor, have shown $C_{el} / H^{0.5}$ very similar to d-wave superconductors [27].

For an anisotropic gap the eld dependence could be linear or non-linear depending on whether the energy of the QP excitations is below or above the SC gap m inim um ($_{m in}$). If we consider our data in Fig. 2, $_{m in}$ 3kg (0.26 meV), since C_{el} is linear in H below T = 3K, and non-linear at higher tem peratures. How ever, there is a problem with this picture. In an anisotropic s-wave gap the magnetic eld should have a sim ilar e ect on the QP excitation spectrum as the tem perature. The QP's are excited due to a magnetic eld H by an energy E_H $_{0}$ $H = H_{c2}$ [28], where $_{0}$ is the gap m axim um ($_{0}$ 4m eV for PCCO [9]). At T = 3K in Fig. 2, the eld

dependence is non-linear even at elds as low as 0.1 T. Yet at T = 2K the eld dependence remains linear up to 3T.D ue to the similar elects of magnetic eld and temperature on the QP excitation spectrum in an anisotropic s-wave gap, for T = 2K we would expect the eld dependence to become non-linear at much low er elds than 3T (H < 1T). Since this is not what we observe in our data, we believe that the change from linear eld dependence to non-linear eld dependence to an anisotropic s-wave gap.

Finally we consider a phase transition in the symmetry of the order parameter from s-wave (T 2K) to d-wave (T 3K). This interpretation is particularly attractive since it has the potential of reconciling the results of many con icting experiments. The SQUID, ARPES, and R am an [5{7] m easurements that suggested d-wave symmetry in electron-doped cuprates are almost exclusively performed above 4.2K. On the other hand penetration depth (0.4K-R ef. [3]) and point contact tunnelling spectroscopy (1.8K-R ef. [9]), are performed at T < 2K and they are consistent with s-wave symmetry. The only inconsistent experiment with this picture is a penetration depth experiment with this picture is a penetration depth experiment which suggested d-wave symmetry down to T = 0.4K (R ef. [4]).

The above qualitative picture of a phase transition is also consistent with quantitative analysis both at $\frac{4}{5}$ $\frac{5K}{H}$ and 2K. The C_{el} of a d-wave superconductor has a $\frac{1}{H}$ - type eld dependence given by [29]:

$$C_{el} = A^{p} \frac{H}{H} = {}_{n}T \frac{8}{-} \frac{1^{-2}}{H} \frac{H}{H_{c2} = a^{2}} \frac{1^{-2}}{c}$$

This equation is valid at T T_c and H_{c1} H H _{c2}. Fig. 2-B shows a d-wave t given by Eq.(1) to the 4.5 K data and a linear t to 2K data. In calculating A, the coe cient of the H $^{1=2}$ term , $_{n}$ = 4.2 m J/m ole K 2 , H $_{\rm C2}$ = 7T , and a=0.7 were used. The _n and H_{c2} are determined from our speci cheat measurem ents. U sing these param eters a reasonably good to four data to $(H) = A H^{1=2}$ is obtained at T = 4.5K (Fig. 2-B). An s-wave superconductor on the other hand has a linear eld dependence: $C_{el} = nTH = H_{c2}$ (T), where is a geometrical constant of order 1. Using $_{n} = 4.2 \text{ mJ/mole K}^{2}$ and $H_{c2} = 7 \text{ T}$ at T = 2 K we nd the theoretical $C_{el} = 1.2 H$. A linear t to our data yields $C_{el} = 2.0H$. A comparison with data results in = 1.7, which is a reasonable value for .

Such a phase transition should also be observed in the tem perature dependence of the speci c heat. We estimate the magnitude of this feature to be approximately 5% of the total heat capacity around 3K (the suppression in Fig.2-b is approximately 5% of the total heat capacity), and expect it to be spread over a tem perature range of 1-2K. We were not able to resolve this transition in the tem perature dependence of the speci c heat because of our limited resolution (5%), how ever more sensitive m easurements using ac heat capacity are in progress.

The data on the over-doped crystal (shown in Fig. 3) is also consistent with swave theory at $T = 2K \cdot U s$ -

ing H $_{\rm c2}$ = 3.6 T, $_{\rm n}$ =2.8 mJ/mole K 2 (determ ined as for the optim ally-doped crystal), an s-wave estimate of 1.6 is obtained for the slope at T=2K.A linear t to the data yields 2.2 mJ/mole K T.This results in =1.4 for the over-doped crystal, which is again a reasonable value for . The low H $_{\rm c2}$ (H $_{\rm c2}$ =2.90.2T at T=3K) makes a comparison with d-wave theory di cult since the condition H $_{\rm c1}$ H $_{\rm C2}$ is only satis ed in a very narrow

eld range. How ever, the trend from linear to non-linear eld dependence as the tem perature is increased suggests that the x=0.165 crystalbehaves sim ilarly to the x=0.150 crystals.

The phase transition suggested by our data is compatible with a theoretical model proposed by K hodel et al. [30] which suggests a phase transition in the gap symmetry (from nodal to fully-gapped) in n-type cuprates based on the location of the Ferm i surface "hot-spots". The consistent picture form ed by thism odel and our data im plies that the hot spots and hence the antiferrom agnetic spin uctuations are an important ingredient of superconductivity in the n-type cuprates.

In conclusion, the results of our speci c heat ${\tt m}$ easurements can be sum ${\tt m}$ arized as:

a dram atic change is observed in the magnetic eld dependence of the electronic speci c heat in a very narrow temperature range; non-linear at T 3K and linear at T = 2K.

there is a suppression of DOS, consistent with opening of a gap at the Ferm i surface, as the eld dependence changes from non-linear to linear.

In light of these observations we conclude that the sym – metry of the order parameter in the n-type cuprates is not a simple d-wave symmetry as in the p-type compounds. In particular the s-wave symmetry observed at T = 2K is a denite evidence for this dimension. The change in the

eld dependence of C_{e1} is most consistent with a phase transition in the symmetry of the order parameter from d-wave to s-wave. Such a phase transition in the symmetry of the order parameter can explain most of the prior conicting symmetry experiments, since almost all experiments that suggest d-wave symmetry are performed at T $_{\rm c}$ 4K, and those that suggest s-wave symmetry are performed at T $_{\rm c}$ 2K.




FIG.1. Tem perature dependence of speci c heat for an optim ally-doped crystal, Pr_{1:85}C e_{0:15}C uO₄ (T_c= 22 2K), at different m agnetic elds (H=c-axis). The saturation of the speci c heat, i.e. eld-independent, at 8T suggests that H_{c2} 8T. The inset shows C/T vs T² for 0T and 10T m agnetic elds from which (0), n, and are extracted.




FIG.2. A Field dependent part of the electronic specic cheat (C (H)-C (O)) for an optim ally-doped PCCO crystal (T_c=23 3K) between 2-4.5K. At 2K the eld dependence is linear consistent with a fully-gapped order parameter. At slightly higher temperatures the eld dependence changes from linear to non-linear. B -The eld dependent specic cheat is divided by temperature to show the suppression in the specic cheat, and hence DOS. The curved line is a d-wave t to 4.5K, and the dashed line is an s-wave t to 2K data.




FIG. 3. A - Field dependence of specic heat for an over-doped PCCO crystal (T_c =15 1.5K). The eld dependence of the specic heat is similar to the optimally-doped crystals, i.e. linear at 2K and non-linear at higher temperatures. B - The eld dependent specic heat is divided by tem - perature to show the suppression in the specic heat, and hence DOS, similar to the optimally-doped crystal.
