## Evolutionary D ynam ics and the P hase Structure of the M inority G am e

We show that a simple evolutionary scheme, when applied to the minority game (MG), changes the phase structure of the game. In this scheme each agent evolves individually whenever his wealth reaches the specied bankruptcy level, in contrast to the evolutionary schemes used in the previous works. We show that evolution greatly suppresses herding behavior, and it leads to better overall perform ance of the agents. Similar to the standard non-evolutionary MG, the dependence of the standard deviation on the number of agents N and the memory length m can be characterized by a universal curve. We suggest a Crowd-Anticrowd theory for understanding the elect of evolution in the MG.

## I. IN TRODUCTION

C om plex adaptive systems consist of agents using adaptive strategies to compete for limited resources. As changes in the global environment are induced by the agents them selves, it is important to study dynamics of such systems. The minority game (MG), proposed by Challet and Zhang[1], is a prototypical agent-based model that can be analyzed using the tools of statistical mechanics. The game captures some essential features of complex adaptive systems in which agents with limited information and rationality compete for limited resources. A key question in the study of agent-based models is, how evolution changes the behaviors of the agents.

There have been a few studies on the e ect of evolution in the minority game. In the context of a sim ple evolutionary minority game, Johnson et al. found that the agents universally self-segregate into two opposing extrem e groups [3]. Hod and Nakar, on the other hand, claim ed that clustering of cautious agents em erges in a \tough environm ent" where the penalty for losing is greater than the reward for winning [4]. Chen et al. [5, 6] derived a general form alism to understand the dynam ical mechanism for the transition from segregation to clustering. They found that the e ective rate of evolution plays an important role in determining the resulting steadystate population distribution. These studies have focused mainly on population distribution. Liet al. [7], on the other hand, studied how evolution can help to improve the overall perform ance of the agents in the original MG. Starting from the adaptive M G proposed by Challet and Zhang [1], Liet al. introduced an evolutionary scheme in which all poorly perform ing agents evolve synchronously = 10;000 steps. Agents are ranked by their at. everv gains, and those ranked at the bottom p percent (p=10%, 20%, 30%, 40%, etc) are forced to change their strategies at these pre-specied steps. In order to make the evolution process sm ooth, not all the agents ranked at the bottom will change their strategies, but only 50% of those (chosen random ly) have to do so. Those who are chosen to evolve replace the current strategies with new random ly picked ones. They reported that with evolution the perform ance is signi cantly better; but the phase structure, characterized by the so called Savit curve [8], rem ains sim ilar to that of the original non-evolutionary M G .A later study [9] based on a variant of the evolutionary scheme used in Ref. [7] led to a sim ilar conclusion, but with better overall perform ance of the agents.

W hen dealing with m odels of heterogeneous agent population, it m akes sense to use an evolutionary scheme in which agents evolve individually, instead of synchronously at speci ed times. In this paper we adopt the simple scheme used in the EMG [3], in which an agent becomes bankrupted and is replaced whenever its accumulated wealth is below a given threshold. W ith this simple scheme we found that herding behavior has disappeared when the memory length (m) is sm all, and the Savit curve obtained is signi cantly di erent from that of the original MG.

## II. NUMERICAL RESULTS

Let us rst brie y describe the m inority gam e m odel. The gam e concerns a population of N (odd num ber) heterogeneous agents with limited capabilities, who repeatedly compete to be in the minority group. After each round the winners gain a point and the bærs bæ a point. Each agent holds S strategies. Each strategy is a lookup table listing the strategy's prediction of the m inority group given the record of the most recent m minority groups. There are total  $2^{2^m}$  number of possible strategies, so the larger the value of m, the greater the processing power of the agents. V irtual points are accumulated for each of the strategies the agent has, and he uses the most successful strategy available to him. To include the e ect of evolution we assign wealth w to each agent; w will increase/decrease by one when the agent wins/loses. The agent will be replaced if his wealth is below a threshd (d > 0); the new agent chooses his S strategies old random ly and his wealth is initialized to zero. The distribution of strategies gradually evolves as the gam e goes




FIG.1:  $^{2}=N$  vs  $2^{m}=N$  for the MG with and without evolution. d = 256 is used for the evolutionary MG. The results are obtained by averaging over eight independent runs

on.

We have done extensive simulations with N 51;101;201;401; m = 1;2;;10; S = 1;2; and d =4;16;64;256;1024;4096. The num ber of tim e steps used is set to be  $T_0 = 800000$   $2^{m-2} + 10000d$ ; we have checked that this choice of the time step is su cient for obtaining steady-state properties of the model. In our simulations we monitor , which is the standard deviation of the num ber of agents belonging to one of the groups. The sm aller the value of , the larger a typical m in ority group and the better the overall perform ance of the agents will be. The sm allest value of is = 0.5, which m eans that the di erence between the numbers in the minority and m a prity groups is one. The overall perform ance of the agents is at the optim alwhen = 0.5. At the other extrem e, when the agents m ake their choices random ly as in the random choice game (RCG), we have  $^{2}=N = 0.25$ . In alm ost all our simulations, particularly for sm all m , evolution reduces signi cantly. This is illustrated in Fig.1, which shows  $^{2}=N$  vs  $2^{m}=N$  for the MG with and without evolution. The results are based on averages over eight independent runs, which are enough for obtaining accurate averages for the evolutionary M G, as the di erences am ong di erent runs are quite sm all. For sm allm evolution leads to a dram atic reduction in as herding behavior of the agents is greatly suppressed. The results for dierent N fall to a universal curve. For large m the gam e still approaches the lim it corresponding to the

random choice gam e and the e ect of evolution is sm all.




FIG.2: <sup>2</sup>=N vs  $2^{m}$ =N for the evolutionary MG.d = 64 is used. The results are obtained by averaging over eight independent runs

We have also studied the model with the award-tone ratio (as de ned in Ref. [4]) R  $\in$  1. In this case the winners get R points while the losers lose a point. We found that, for each N, there is an optimal value of  $R = R_c(N) > 1$  that gives rise to the smallest value of . For  $R > R_c(N)$  the average wealth is ever increasing and there is no steady state. Fig.2 shows <sup>2</sup>=N vs 2<sup>m</sup> =N for R > 1 as compared to the case R = 1. It is clear from

the gure that can be further reduced when R > 1. W e also found that, for m = 1 or 2, the optim al value of = 0.5 can in fact be achieved.

## III. A CROW D -ANTICROW D THEORY FOR THE EVOLUTIONARY M G

We now consider a Crowd-Anticrowd theory [10] to understand the e ect of evolution in the minority game. Our discussion below follows Ref. [10]. For simplicity we only consider S = 1 and use a reduced strategy space (RSS). Numerically the di erences between the cases with S = 1 and S = 2 are small. RSS is a subset of strategies, which span the full strategy space (FSS). Consider, for example, an RSS for m = 2, consisting of the following eight strategies:

Here 1 indicate the prediction of a strategy given one of the four possible histories. Any two strategies in fU ,

Ug are either uncorrelated (with the Hamming distance




FIG.3: H istogram for the number of appearances of all possible histories. N = 101, S = 2, m = 6, and d = 256. For com – parison the corresponding histogram for the non-evolutionary MG is also plotted

 $2^m$  =2) or anti-correlated (with the largest H am ming distance  $2^m$ ). For a given m there are total 2P (P =  $2^m$ ) strategies with P pairs of anti-correlated strategies (other pairs are uncorrelated) in RSS.For each strategy G in RSS there is a corresponding anti-correlated strategy G. It is believed that the essential features of the gam e are kept when RSS is used instead of the FSS [2].

Let us evaluate  $2 = (n_{+} (t) N = 2)^{2} > t = (n_{+} (t) n (t))^{2} > = 4$ , where  $n_{+}$  and n are the num bers of agents making the choices + 1 and 1 respectively. The average is over time step t. In RSS

where (t) denotes the current history,  $a_{g}^{(t)} = 1$  is the response of strategy G to the history bit-string (t), and  $n_{G}$  is the number of agents using strategy G at time t. We have

In our simulation we found that the system visits all possible histories equally. This is illustrated in Fig. 3, which shows a histogram of the number of visits for each m-bit history. In order to compare with the non-evolutionary MG, we use S = 2 in the gure; the result for S = 1 is essentially the same. As we can see from the gure, the system does not visit all possible histories equally in the non-evolutionary MG.

For the evolutionary MG we can thus replace an average over time by an average over all possible histories. Now the double sum can be broken down into three parts, based on the correlation between the strategies. Given <  $a_G a_G > t = 1$ , <  $a_G a_G > t = 1$ , and

In the above derivation we have tacitly assumed that  $fn_G g$  change very slow ly so the averages over  $fa_G g$  can be done while holding  $fn_G g$  constant. This is in the spirit of adiabatic approximation; it is valid because the evolution rate is low (as long as d is not too small).

Let  $n_{\rm P}$  be the number of pairs of agents holding anticorrelated strategies and  $n_{\rm S}$  be the number of agents holding unpaired strategies. Only the agents holding unpaired strategies contribute to  $\,$ ; the gam e behaves essentially as an RCG with  $n_{\rm S}$  number of agents. Thus we have  $^2$  = 0.25n\_{\rm S}, or

where  $s = n_s = N$ . Note that  $2n_P + n_s = N$ ,  $n_P$  can be written as  $n_P = N$  (1 s)=2. To determ ine s we need to consider the evolutionary dynam ics of the gam e. At the steady state we have the follow ing balance equation

where  $r_{\rm P}$  and  $r_{\rm S}$  are the bankruptcy rate for the paired agents (pair breaking rate) and the bankruptcy rate for the unpaired agents respectively;  $p\,(m\,;N\,)$  is the probability that a new pair is form ed when a bankrupted agent is replaced. One can estim ate  $p\,(m\,;N\,)$  as

It is somewhat di cult to estimate r  $_P$  and  $r_S$ . It can be argued that  $r_P$  =r\_S does not sensitively depend on m and N . The equation for s is then

where  $z = 2^m = N$ . The solution s is a function of z. Thus, when we plot  $^2=N$  vs  $z = 2^m = N$ , the curves fall to a universal curve. Since p(x) is a monotonically decreasing function of x, the universal curve s(z) obtained from the above equation will be a monotonically increasing function of z. In the limit  $z \mid 1$  we have  $p(s=z) \mid 0$ ; this leads to  $s \mid 1$  or  $^2=N = 0.25$ . Thus  $z \mid 1$  is the RCG limit. For R > 1,  $r_P = r_S$  decreases; this leads to sm aller values for s and . All these are in agreement with the simulation results. Thus the C row d-Anticrowd picture provides a qualitative understanding of the evolutionary M  $\ensuremath{\mathsf{G}}$  .

In conclusion, we have show n that, when a simple evolutionary scheme is applied to a heterogeneous population of agents, herding behavior in the MG is greatly suppressed. The dependence of the standard deviation on the number of agents N and the memory length m

can be characterized by a universal curve. In addition, we demonstrated that a C row d-Anticrow d theory can be used to understand qualitatively the e ect of evolution in the MG.
