Theory of the Three-G roup Evolutionary M inority G am e

Based on the adiabatic theory for the evolutionary minority gam e (EMG) that we proposed earlier[1], we perform a detail analysis of the EMG limited to three groups of agents. We derive a form ula for the critical point of the transition from segregation (into opposing groups) to clustering (towards cautious behaviors). Particular to the three-group EMG, the strategy switching in the <code>\extrem e"</code> group does not occur at every losing step and is strongly intermittent. This leads to an correction to the critical value of the num ber of agents at the transition, N_c. Our expression for N_c is in agreem ent with the results obtained from our num erical simulations.

I. IN TRODUCTION

There have been growing interests in study of complex adaptive system s using agent-based modeling. Complex adaptive system s are ubiquitous in social, economics, and biological sciences; they consist of agents using adaptive strategies to complete for limited resources. A schanges in the global environment are induced by the agents them – selves, it is important to study dynamics of such system s. Even though agent-based models are simple, the outcomes may not be at all obvious because the agents typically use adaptive rather than optimizing strategies.

The M inority G ame, proposed by Challet and Zhang [2, 3], is a prototypical agent-based m odel that can be analyzed using the tools of statistical mechanics. The gam e captures som e essential features of com plex adaptive systems in which the agents with limited information and rationality compete for limited resources. The key question in the study of agent-based models is, how evolution changes the behaviors of the agents. In the context of a simple evolutionary minority game (EMG), Johnson and cow orkers found that the agents universally self-segregate into two opposing extrem e groups.[4] Hod and Nakar, on the other hand, claim ed that a clustering of cautious agents em erges in a \tough environm ent" where the penalty for losing is greater than the reward for winning.[7] We have derived a general form alism to understand the dynam ical mechanism for the transition from segregation to clustering.[1] Our theory is based on an adiabatic approximation, in which short-time uctuations are integrated out to obtain a steady state population distribution. We found that the e ective rate of evolution plays an important role in determ ining the resulting steady-state population distribution. Frequent strategy switching leads to large market ine ciency that favors clustering of cautious agents. The theory is illustrated with a detail statistical mechanical analysis of the EMG limited to three groups of agents: two opposing groups and one cautious group; it agrees very well

with the num erical simulations of the original EMG, but deviates from the num erical results of the three-group EMG. In this paper we perform a further analysis of the three-group EMG. We show that with an interm ittency correction, which is particular to the three-group EMG, the num erical results can be explained.

II. PHENOMENOLOGY OF THE EVOLUTIONARY M INORITY GAME

We rst brie y describe the EMG model. There are N agents. At each round they choose to enter room 0 or room 1. At the end of each round the agents in the room with fewer agents (in the minority) win a point; while the agents in the room with more agents lose a point. The winning room numbers (0 or 1) are recorded. The agents' decisions are based on the same record (a bit-string of length m) of the most recent winning room num bers. G iven the current m -bit string, the common basic strategy is simply to choose the winning room num berafter the most recent pattern of the sam em -bit string in the historical record. To use the basic strategy is thus to follow the trend. In the EMG each agent is assigned a probability p: he will adopt the basic strategy with probability p and adopt the opposite of the basic strategy with probability 1 p. The agents with p = 0 or 1 are \extrem e" players, while the agents with p = 1=2 are cautious players. The gam e and its outcom es evolve as the less successful agents, de ned as the ones with the accumulated wealth less than d (d < 0), change their p values. In the original EMG model, the new p value is chosen random ly in the interval of width p centered around its original p value. H is wealth is reset to zero and the gam e continues.

Johnson and coworkers showed that the agents selfsegregate into two opposing extrem e groups with p = 0and p = 1.[4, 5, 6] Thus, in order to succeed in a competitive society the agent m ust take extrem e positions. This behavior can be explained by the market in pact of the agents' own actions which largely penalizes the cautious agents.[6] H ow ever, H od and N akar later found that the above conclusion is only robust when the reward-to- ne ratio R 1. W hen R < 1 there is tendency for the agents to cluster towards cautious behaviors and the distribution of the p value, P (p), may evolve to an inverted-U shape with the peak at the middle. We show that the transition from segregation to clustering in fact depends on all three parameters, N, R, and d. We derived a general expression [1] for the critical value N_c = $\frac{jij}{A(1-R)}$, where A is a constant of the order one. This was verieed by our extensive simulations of the EMG for a wide range of the parameter values.[1] W hen R ! 1 the clustering only occurs for either very large N or very small jdj. At R = 1 the clustering disappears and the segregation to extrem e behaviors becomes robust.

III. DESCRIPTION OF THE GENERAL AD IABATIC THEORY FOR THE EM G

We now brie y describe our theory, illustrated with the three-group EMG model, in which p takes only one of the three possible values 0; 1=2, and 1. The agents in group 0 (with p = 0) make the opposite decision to the agents in group 1 (with p = 1). We denote the group with p = 1=2 group m; this is the group of cautious agents.

We begin by evaluating the average wealth reduction for the agents in each of the three groups, given the num – ber of agents N₀; N_m; N₁ in group 0, m, and 1 respectively. By comparing the average wealth reduction in the extrem e groups and in the cautious group, we can determ ine the transition from clustering to segregation. Let n be the num ber of agents in group m m aking the same decision (decision A) as those in group 0. When N_m 1, the distribution of n can be approxim ated by a G aussian distribution P (n) = $\frac{p-1}{2}$ means exp((n N_m =2)² = (2 $\frac{2}{m}$)); where m = $\frac{p}{N_m}$ =2. By averaging over n, we obtain the average change of wealth for the agents in group 0,

where $N_d = N_1$ N_0 ; erf(x) is the error function $p^2 - \frac{R_x}{0} e^{t^2} dt$. Sim ilarly the average change of wealth for the agents in group 1 is given by,

The average change of wealth of the agents in the extrem e groups (group 0 and 1) is given by $w_e = (N_0 w_0 + N_1) = (N_0 + N_1)$, or

The second term in w_e is due to the uctuations of N_d; it is always negative. The larger the uctuation in N_d, the less e cient the market becomes. This term can be interpreted as the cost due to market ine ciency.

Largemarket ine ciency on average penalizes the players taking \extreme" positions.

The average wealth reduction for the agents in group $m\,$ can be evaluated sim ilarly by averaging over n ,

The rst term in w_m is the same as that in w_e . The second term can be interpreted as the market impact.[6] A large market impact (self-interaction) penalizes the cautious players; their own decisions increase their chances of being in the majority and hence increase their chances of losing. The relative magnitudes of the second terms in w_e and w_m determ ine whether clustering or segregation dom inates.

To further evaluate w_e and w_m , we need to average over the distribution of N_d. Let N denote the change in N_d in one time step. As argued in Ref. [1], the steady state probability distribution Q (N_d) for N_d should satisfy

where $W = \frac{1}{2} \begin{bmatrix} 1 & \text{erf}(N_d = (2^{p} \overline{2}_m)) \end{bmatrix}$. This equation can be solved to give the distribution $Q(N_d)$. A fler averaging N_d over $Q(N_d)$, we obtain

Here $_{d} = \frac{q}{\frac{p}{2}} \frac{p}{m} \frac{1}{N}$. At the critical point, $N_{0} = N_{1} = N_{m} = N = 3$, and $w_{e} = w_{m}$. It is easy to verify that this occurs when

Note that N is the number of extrem e agents switching their strategies per time step. On average N = $2N_0 = (j1j = ((1 R)=2)) = N_0 (1 R) = j1j$ thus the crossover value for N is $N_c = d^2 = A (1 R) f$. As shown in Ref. [1] the derivation can be generalized to a general EMG involving m ore than three groups of agents.

IV. GAP DISTRIBUTION AND INTERMITTENCY CORRECTION

W hile the expression $N_c = d^2 = A (1 R)^{\dagger}$ describes very well the transition in the original EMG with a continuous distribution of p, it does not describe the R dependence of N_c correctly for the transition in the threegroup EMG. This is due to the following particular feature of the three-group EMG. The strategy switching of




FIG.1: Schem atic illustration of the wealth distributions of group 0, m, and 1. There are gaps in the distributions for the extrem e group 0 and 1

the agents in the \extrem e" groups does not occur at every being step and is rather interm ittent. A boss at the current round, for example, will not make the agents in the extrem e groups to switch strategy if they have won in the previous two rounds. This gives rise to a gap between the lowest value of the wealth in an extrem e group and the strategy-switching threshold at d, as schem atically illustrated in Figure 1.

W hen the wealth distribution of the losing extreme group has > 1, N_d does not change, because no sw itching occurs in or out of the extreme groups. Only the cases with < 1 a ect the distribution of N_d. Thus we need to use the e ective number of extreme agents sw itching their strategies per time step, averaged only over the cases with < 1. This e ective rate of sw itching is given by $N = N = z = N_0 (1 \ R) = (zjd)$, where z is the probability that < 1. The e ect of interm ittency of the strategy sw itching can be taken into account by using this e ective N[°].

To obtain the interm ittency correction to the expression of N_c, we need to standard the probability z. Let P () be the probability distribution of . Since there are always new agents with wealth 0 coming from group m at each step, cannot be greater than jdj. Thus P (jdj) = 0. Since there are roughly equal numbers of winning and losing steps, P () should satisfy

For jdj $1 \text{ we can approxim ate the above equation using the following di erential equation (this is adequate as P () is rather sm oothly varying as a function of).$




FIG. 2: The critical value N vs $jd_c j$ for R = 0:6;0:7;0:8;0:9;0:95, and 0:975

The critical value N_c is determined from the relation N_c , $\frac{P_{\rm N_c}}{N_c}$; this gives rise to

The num erical values of N $_{\rm c}$ vs jdj from our extensive simulations are plotted in Figure 2.0 ne notable feature is that N $_{\rm c}$ is proportional to d², but is independent of R for su ciently large values of jdj. This can be explained using the above expression of N_c . For jdj(1 R) 1 and 1, z can be approxim ated by z 1 R.This 1 R gives rise to N_c d for jdj 1=(1 R). From the gure, we can see the crossover to the N $_{\rm c}$ ở behavior occurs roughly at d = 2 = (1 R), in agreem ent with the theory. This unique feature of the three-group EMG model is completely due to the existence of a gap in the wealth distribution of the extrem e groups. For the original EMG m odel, there is no such gap, and N $_{
m c}$ $d^2 = (1 R)^2$ holds very well.

V. CONCLUSION

In conclusion, we have derived an interm ittency correction to the critical value N $_{\rm c}$ for the three-group EM G .

O ur estimates of N_c agree well with the numerical results. We have identieed the key dierence between the three-group EMG and the original EMG with a continuous distribution of the p values: the existence of a gap in the wealth distribution of the extrem e groups in the three-group EMG. This key dierence leads to a qualitative correction to the expression for N_c. The general framework of the adiabatic approximation, however, is equally valid for studying the transition in both the original EMG and the three-group EMG.
