Functional Characterization of Generalized Langevin Equations

Abstract

We present an exact functional form alism to deal with linear Langevin equations with arbitrary memory kernels and driven by any noise structure characterized through its characteristic functional. No others hypothesis are assumed over the noise, neither the uctuation dissipation theorem. We found that the characteristic functional of the linear process can be expressed in terms of noise's functional and the G reen function of the determ inistic (memory-like) dissipative dynamics. This object allow us to get a procedure to calculate all the K olm ogorov hierarchy of the non-M arkov process. A s examples we have characterized through the 1-tim e probability a noiseinduced interplay between the dissipative dynam ics and the structure of di erent noises. C onditions that lead to non-G aussian statistics and distributions with long tails are analyzed. The introduction of arbitrary uctuations in fractional Langevin equations have also been pointed out.

Noise is a basic ingredient of m any types of m odel in physics, m athem atics, economy, as well as in engineering. Besides that in each area of research the uctuations have very di erent origins, in m any cases the evolution equation governing the system of interest can be approximated by a suitable stochastic di erential equation.

In general the driving forces may be any source of uctuations and the system can be characterized by a given potential. The most popular of those stochastic di erential equations are the one driven by white Gaussian uctuations, therefore the problem can immediately be reduced to the well known Fokker-P lanck dynamics¹³. If the uctuations are not Gaussian we are faced with a problem that is hard to solve, but among the di erent types of uctuations the so call dichotom ic noise is a good candidate to study, because in general for any potential some conclusions can be draw n⁴⁸. If the uctuations are di erent from the Gaussian ones or the dichotom ic noise, in general it is not possible to solve the problem for any potential.

In m any situations the technical complications of the model can be diminished by studying the system in a linear approximation, i.e., around the xed points of the dissipative dynamics. This approximation leads to the study of linear stochastic dimential equations with arbitrary noises. Besides the simplicity of this kind of equations they were the subject of numerous theoretical investigation^{9 {25}, and also they provide non-trivial models for the study of many diment mechanism of relaxation in physics, biology and another research areas.

From the previous considerations, it is clear that the usefulness of a linear Langevin equation arises from the possibility of working with di erent kind of noise structures. Therefore, one is faced with the characterization, in general, of non-M arkov processes. These processes can only be completely characterized through the whole Kolm ogorov hierarchy of the stochastic process², i.e.: the know ledge of any n joint probability, or equivalently any n tim e m om ent and/or cum ulant.

In Ref.^{26;27}, by using a functional technique, we have been able to characterize arbitrary linear Langevin equations with local dissipation, giving therefore a procedure to calculate the whole K olm ogorov hierarchy of the process and any n time moment. Using this previous experience, in this paper we are going to generalize our functional technique to tack le the more general situation where the dissipative term is non-local in time and the noise is also arbitrary; this is what we call a Generalized Langevin Equation, i.e., a linear Langevin equation with arbitrary memory and driven by any noise structure

where (t), the uctuation term (i.e., the external noise) is characterized by its associated functional, and (t) is an arbitrary memory kernel.

This type of generalized Langevin equation arises quite natural (considering G aussian uctuations) in the context of the Zwanzig-M ori projector operator technique^{28,29}; in this case the uctuation-dissipation theorem is required^{30,31}, which imposes that (t) = h (t+) ()i=kT. Therefore the dissipative m em ory must be consistent with the structure of the correlation of the G aussian uctuations³⁰. N evertheless, if the system is far away from equilibrium, the uctuation-dissipation theorem is not full led and in general the G aussian assumption is not a good candidate to describe the uctuations of the system. Therefore, in a general situation, both the kernel and the noise properties must be considered independent elements whose interplay will determ ine the full stochastic dynam ics of the process u (t). A long the paper we will be interested in characterizing this noise-induced interplay by assuming di erent kind of noises and memory kernels, both in the transient as in the long-time regime.

The paper is organized as follows. In section II, after a short review of the functional m ethod, we obtain the characteristic functional for a vectorial Langevin equation with m em - ory. In section III we apply this result to di erent situations. First we analyze the case of stable noises; after this step, we analyze the stochastic dynam ics induced by an exponential m em ory kemel in a process driven by two di erent uctuating structures: radioactive

and Poisson noises. Then the interplay between the kernel and the noise properties is emphasized. The necessary noise's properties that guarantee a stationary distribution with a long-tailare presented. As an example we introduce the Abelnoise that induces this asymptotic behavior. The characterization of a fractional Langevin equation with arbitrary noise is also presented. The interplay between the fractional property of the dimensional operator and the Levy noise is analyzed. In section IV we give the conclusions.

II.FUNCTIONAL CHARACTER IZATION OF ARBITRARY LINEAR LANGEVIN EQUATIONS

A. The characteristic functionalm ethod

In our previous papers, we have presented a complete characterization of Langevin equations with local dissipation by m eans of the characteristic functional of the stochastic process u(t) [t 2 (0; 1)]

Here k (t) is a test function, and h i means an average over the stochastic realizations of u (t) belonging to a given support. The know ledge of the characteristic functional allows a full characterization of the process. In fact, from this functional it is possible to calculate the whole K olm ogorov hierarchy, and of course any n time moment and/or cum ulant. This follows by dening the n characteristic function $G_u^{(n)}$ (fk_j;t_jg_{j=1}) as

We have show $ed^{26;27}$ that in order to obtain the characteristic functional of u (t), it is only necessary to know the characteristic functional of the noise (t)

N o any other hypothesis were assumed over the noise. This general form alism allows us to dealw ith arbitrary non-M arkovian evolution processes, where there is not a clear underlying Fokker-P lanck dynamics.

In what follows we will generalize our functional characterization for the case of a Langevin dynam ics that includes m em ory e ects, Eq. (1.1). We remark that not any condition as therm al equilibrium, G aussian noises, or any other, is imposed on the stochastic evolution of the processes u (t).

B. The multivariable linear case with dissipative memory

A general case that covers m any m odels of evolution, is the vectorial linear stochastic equation

Here, u (t) represent a d dimensional stochastic process $fu_i(t)g_{i=1}^d$, with $u_i 2$ (1;+1). The memory kernel (t) is an d d matrix with arbitrary kernel functions. The d dimensional vector noise (t) is characterized through its characteristic functional

From this equation it is possible to identify the matrix (t) with the G reen function of Eq. (2.8). Notice that the vector hu (t) i_0 corresponds to the average value of the process u (t) for the case in which the average of the noise is null, i.e., h (t)i = 0.

A fler introducing the solution Eq. (2.12) into Eq. (2.10), and reordering the tim e integrals ${}^{R}_{t} {}_{0} dt^{0} {}^{R}_{t^{0}} dt^{0} = {}^{R}_{t} {}_{0} dt^{0} {}^{R}_{t} dt^{0} (t^{0} t^{0}), \text{ where (t) is the step function, we arrive to a closed expression for the characteristic functional of u (t) in terms of the functional of the vector noise. The expression Eq. (2.16) gives us the desired exact functional G_u (k (t)]) as the product of two functional. The stone corresponds to the determ inistic evolution, or equivalently to the averaged process when the noises have null averages. On the other hand, the second term comes from the noise characteristic functional, i.e., the stochastic evolution.

Finally, the n time characteristic function $G_u^{(n)}$ (fk_j;t_jg_{j=1}ⁿ) can immediately be evaluated from the characteristic functional of the noise. The unidimensional case, Eq. (2.2), is easily generalized to the vectorial case as

Eq. (2.21) gives, in a simple way, the n characteristic function of the process u (t) by evaluating the characteristic functional of the noise with the function y (t). This last function is dened in terms of the G reen function (t) of the problem. At this point, it is in portant to remark that our formalism is valid independently of the assumed form for the dissipative G reen function evolution. Thus, this function may present a monotonous or oscillating decay (taking positive and negative values), and in general any one consistent with the corresponding kernel. In Appendix A we show a particular 2 dimensional stochastic process $fu_i(t)g_{i=1}^2$ where each component $u_i(t)$ represents the position and the velocity of a memory dam ped harm onic oscillator in presence of an arbitrary noise structure.

III.EXAM PLES

Here we are going to analyze, and characterize with our functionalm ethod, m any am azing situations that arise by choosing di erent noise structures and a non-local dissipative kernel.

A . Local D issipation

From now on, we will restrict to a unid in ensional case. By assuming a Dirac correlated kernel

W ith this solution, it is possible to recapture all the results obtained in $Ref.^{26}$.

Stable probability distributions play an important role in the theory of sum s of random variables. This fact follows from the generalized central lim it theorem valid for Levy distributions and the asymptotic power-law decay^{32;33}. Here we are going to apply our functional form alism with the use of stable noises.

1. Gaussian noise

A zero-m ean Gaussian noise (); with an arbitrary correlation function $(_2;_1) = h(_2)(_1)i$; is characterized by the functional²

2. Levy noise

A nother example that share sim ilar conclusions than using the Gaussian noise, is the Levy noise. The characteristic functional of this noise reads 21

Therefore, memory-like linear Langevin equations driven by stable noises give rise to new stable stochastic processes whose correlations properties are de ned in terms of the G reen function (t) of the dissipative dynamics. Note that this result is valid independently of the particular form of the G reen function.

C . Interplay between non-local friction and noise structure

In general, around a xed point, the linearized dynamics of a dissipative system | depending on the parameters of the problem | m ay presents a relaxation behavior with quite di erent characteristics: let us say, a monotonous or a time-oscillating decay. Here we are going to study the relaxation and the uctuations of the process u (t) by analyzing the interplay between these mentioned dissipative behaviors and di erent noise structures.

The di erent behaviors of the dissipative dynam ics can be modeled through a non-local exponential memory friction

A s desired, the dissipative G reen function, Eq.(3.11), has a regime where it decays oscillating in time. But on the other hand there is a possibility, for $< \frac{1}{2}^2$ where (t) decays in a monotonous way. Note that the local case (non-memory dissipation), Eq. (3.1), is reobtained considering the limit: ! 1 and ! 1; with = ! (nite).

Now we are going to present some results using the G reen function Eq. (3.11) in connection with two di erent structures for the uctuating term, i.e., a radioactive noise and a Poisson white-noise. W e will show that the interplay between the determ inistic G reen function and the structure of the noise play a crucial role to determ ine the relaxation and in general any statistical dynam ical property of the stochastic process u (t): 0 n the other hand, a m em ory kernel with a power-law decay will be studied in the context of fractional derivatives in the sub-section E.

1. Radioactive decay noise

The radioactive noise is non-white and Markovian. Its 1 time and conditional probability evolve controlled by the master equation

Thus, the realizations of this noise start with some initial value $_0$ and at random times decrease by nite unit steps until the process reaches the zero value. The constant denes the probability per unit of time for such discrete steps (decay). The characteristic functional reads²

This noise clearly does not reach a stationary regime. Using this noise, the 1 time characteristic function of the process u (t) results

This noise leads to very striking dynamical behaviors for the driven process u(t). In the following gures we have plotted, at di erent times, the corresponding exact probability distribution P (u;t). In order to get this object we have anti-transformed Eq. (3.15) by using a fast Fourier algorithm. In Fig. 1, the parameters for the memory kernel were chosen as = 0:1, = 1. Thus, the Green function decays without oscillations (see inset). The noise decay rate is = 1 and its initial value was chosen to be $_0 = 2$. At time t = 1 (full line), we see that the probability distribution is highly irregular and also has a Dirac contribution (indicated symbolically with the vertical line). This singular behavior arises from the particular realization (t) in which the noise has not yet su er any decay.

In Fig. 2 we show the case in which the G reen function is oscillatory in time (see inset). The parameters are = 0.1, = 0.2, and for the noise we choose = 1 and $_0 = 10$. Here, in contrast to the previous gure, we have increased the initial intensity of the noise, which imply that the D irac contribution decay in a very fast way. On the other hand, this higher initial value imply that the \discrete" decay of the corresponding noise realizations do not change appreciably the noise intensity. In consequence, at all time the distribution P (u;t) results smooth. As in the previous example, all realization of the process u (t) are

attracted by the stable point u = 0. Nevertheless, here the transient behavior rejects the oscillatory behavior of the G reen function. In fact, we note that at successive times, the center of m ass of the distribution P (u;t) approximately follows the dissipative dynamics of the G reen function oscillating around the origin u = 0 (see times: t = 1 continuous line, t = 5 dotted line, t = 15 dashed line, t = 25 dot-dashed line). In addition, we note that the width of the distribution grows approximately up to t = 5. In fact, at this time most of the noise realizations have decayed to a null value. For later times, the distribution is mainly governed by the dissipative dynamics of u(t). Therefore, its width decreases up to reaching a D irac form in the stationary state.

We remark that for this noise the stationary distribution P (u) is always determ inate by the xed point of the dissipative dynam ics. This characteristic is due to the vanishing noise's amplitude at the long time regime. In the next example we show a case where the noise properties participate, in a crucial way, both in the transient as in the stationary properties of the process u (t).

2. Shot noise

The stochastic realizations of the shot noise are dened by a sequence of pulses (t), each one arriving at random independent times t_i . The characteristic functional of the noise^{2;26;27} (t), in the intervalt 2 [0;1], is

This functional characterizes a noise with a null average, whose realizations consists in the random arriving of D irac pulses with amplitude A. Note that in the limit A ! 0, ! 1 with $A^2 = D = 2$, this symmetrical white shot-noise converges to a G aussian white noise, i.e., Eq. (3.4) with (2; 1) = D (2).

U sing Eq. (3.20), the 1 time characteristic function of the process u (t) is given by

A swe will show below, this expression leads to a rich variety of possible stochastic dynam ical behavior for the process u (t); both, in the transient as in the stationary state, the di erent behaviors arise from the competence between the di erent characteristic time scales of the G reen function Eq. (3.11)] and those of the noise. In the monotonous regime, $< {}^2=4$, the decay of () can be characterized by the rate = . For $> {}^2=4$, when w₀ > =2, the oscillatory behavior of () is characterized by the damping rate =2 and the frequency w₀. On the other hand, the noise is characterized the rate and the amplitude A. The analysis of the behavior of P (u;t) on these parameters can be simplied by de ning the rescaled process u⁰(t) = u(t)=A, whose evolution can be written as

Here, we have de ned the dimensionless time $^{\circ}$ = tand parameter $^{\circ}$ = $^{\circ}$. Furtherm ore, the dimensionless symmetric Poisson noise $^{\circ}(^{\circ})$ is only characterized by the dimensionless rate $^{\circ}$ = = . Thus, the full dynamical properties of the process u (t) are controlled by the parameters $^{\circ}$ and $^{\circ}$.

In the next qures we have obtained num erically P (u;t) from fast Fourier transform of Eq. (321). In Fig. 3 the parameters of the kernel are = 02, = 1, and for the noise we used A = 1, = 7.5. For these values, the frequency w_0 in Eq. (3.12) is complex. Therefore, the G reen function (t) decays monotonously in time (see inset). At short times, t = 0.5[Fig. 3 (a)], the probability distribution presents a series of peaks, each ones separated by a distance A = 1. This property is a direct consequence of the nature of the shot-noise, where D irac pulse produces a shift of magnitude A in the driven process u (t). In each arriving this short time regime the e ect of the dissipative dynam ics is negligible. At later times, the dissipative contribution becom es appreciable; its e ects is to attract all the realization of u (t) to the xed point u = 0. This action, added to the shift e ect of the arriving pulses, produces an increasing of the width of all the peaks of the distribution; then any value of u becomes (approximately) probable. This e ect is clearly seen in Fig. 3 (b) [t = 1:65]. Note that the distribution retained the \sharpy" structure of peaks. This erasing e ect is even increased with time; see Fig. 3 (c) (time t = 2). At later times, all the signature of the peaks have disappeared and the distribution goes asymptotically to a Gaussian distribution; see Fig. 3(d) [times t = 2.5 (dotted line) and t = 20 (full line)].

In general, an asymptotic G aussian stationary distribution is always expected when the rate of the arriving D irac pulses is greater than the characteristic decay rate of the G reen function. W hen the decay of (t) is monotonous, this condition can be expressed through the inequality $^{\circ} > ^{\circ}$, which is clearly satis ed in the previous gure. W hen this relation is not satis es, deviations from a G aussian distribution must arise both in the transient as in the stationary distribution. W e show this e ect in the next gures.

In Fig. 4, the parameters of the G reen function (see inset) are the same than in the previous gure, [= 02, = 1], and for the noise we have used A = 1, = 0:1. As in the previous case, the behavior of P (u;t) arises from the competence between the shift e ect of the arriving pulses and the dissipative dynam ics of u (t). For example, at short times [Fig. 4(a), t = 2:5] the probability shows a set of maximal located at A with tails pointing in the direction to the origin. These tails are mainly originated by the dissipative

dynam ics that attracts all realizations to the stable point u = 0. On the other hand, here the occupation around u = 0 comes from the shift e ect produced by two arriving pulses with dierent signs. In contrast to the previous example, at later times [Fig. 4(b), t = 5] the evolution of the distribution P (u;t) is mainly governed by the dissipative dynam ics and the structure of peaks is retained during all the evolution, Fig. 4(c) t = 10, and Fig. 4(d) t = 100, where the stationary state is practically reached. Note that in this stationary state, the non-G aussian characteristics are present in u = 0 and in u = A.

We note that during all the transient dynamics, there exist a -D irac contribution (indicated with the vertical lines) centered at the origin, u = 0. This term is originated by the noise realization in which not any pulse has arrived up to time t. Therefore, it is exponentially damped with a rate 2, i.e., it can be written as exp (2 t) (u). At each of the chosen times, the weight of the D irac term are respectively: 0:606, 0:368, 0:135 and 2 10 ⁹. Notice that in the stationary state, the D irac contribution is always completely washed out. We remark that, independently of the values of the parameters, this D irac contribution is always present. Nevertheless, note that in the case of Fig. 3, it is rapidly attenuated and its contribution is insigni cant in the time scale of that plot.

In the two previous gures we have assumed a monotonous decreasing G reen function. In general the interplay between an asymmetric Poisson noise, Eq. (3.19), and an oscillatory G reen function is similar to that founded in the case of the R adioactive noise. In the case of a symmetric noise, Eq. (3.21), due to the symmetry of the problem, the transient dynamics is approximately similar to that founded for a monotonous decay. Thus, the more relevant aspect to analyze is the corresponding stationary distribution.

In Fig. 5 we study the properties of the stationary distribution P (u) for di erent values of the parameter of the G reen function and the noise. In Fig. 5 (a) the parameters corresponding to the G reen function (see inset) are = 2, = 1; while for the Poisson noise we have taken = 0.3 (dotted line), = 0.4 (dashed line) and = 0.8 (continuous line); in all cases taking $A = \frac{p}{0.4}$. In consequence, the elective amplitude of the noise A^2 is constant in the three graphs. D ue to this selection the tails of the distributions coincide, indicating that all

the distributions are asymptotically, for large ju j G aussian. This property will be analyzed analytically in the next-subsection.

As in the case of the non-oscillating G reen function, Figs. 3 and 4, here we expect a G aussian stationary distribution when the average waiting time between two arriving pulses is shorter than the characteristic relaxation time of the G reen function. In this case, the oscillatory decay of the G reen function is characterized by the rate =2. Thus, we estimate that for $^{\circ} > 1=2$ a G aussian statistics arises. This prediction agree very well with the plots shown in Fig. 5(a). Nevertheless, note that this inequality does not depend on the frequency of the G reen function oscillations. In the next gure, we will check the validity of this prediction.

In Fig. 5(b) we show the stationary distribution P (u) by maintaining the noise parameters and changing the values of the parameters of the G reen function. The noise parameters were chosen as = 0.25, A = 1 and for the G reen function = 1, = 0.15 (full line), = 0.6 (dashed line), and = 50 (dotted line). In the inset we show the corresponding G reen function for each values. Consistently with our previous analysis, we can methat independently of the value of the characteristic frequency of the G reen function, the stationary distribution P (u) is non G aussian for $^{\circ} < 1=2$. Furthermore, we note that by increasing the frequency of the G reen function, the fast oscillations of (t) completely drop-out the non-G aussian peaks located at A, remaining only one peak centered at u = 0. On the other hand, with the chosen values of the noise parameters, a G aussian distribution only arise for a non-oscillating G reen function.

Finally, we want to remark that the criteria for obtaining a stationary G aussian distribution $^{\circ}$ > $^{\circ}$, valid when the decay of the G reen function is monotonous, and $^{\circ}$ > 1=2 valid for an oscillatory decay, change their validity in a smooth way around the value $^{\circ}$ = 1=4, which corresponds to the point in which the G reen function modify its characteristic decay.

D. Long-tail stationary distributions

Here we are interested in characterizing the stationary distribution of the stochastic process u (t); of great in portance is to know whether there will be or not a long-tail in the distribution. In order to make a general analysis, here we assume that the structure of the noise is such that we can write the 1 time characteristic function in the form

This form ulae characterizes the stationary distribution of the stochastic process u(t), if it exists, as a series expansion in the Fourier component k.

From Eq. (3.25) it is simple to see that even when the stochastic transient can be non-Gaussian (depending on the driving noise) in the large asymptotic scaling ju j! 1, the Fourier transform of the stationary distribution goes like

where A_0 ; B_0 are constants given in terms of the dissipative memory and the structure of the noises; then at large scale the behavior is not anom alous. The analysis with a non-white

noise is similar and the general conclusion is not changed. So in order to understand the occurrence of anom alies or long-tails in the stationary distribution of the process u(t) we have to consider driving noises that break the hypothesis Eq. (3.25). This case is achieved by structures like the one from the Levy noise, see Eq. (3.7), or its associated one-side power-law noise shown in appendix B.

In the previous sub-section we have shown that the Poisson noise, Eq. (3.19), can give rise, during the transient and in the stationary state, to strongly non-G aussian distributions for the process u (t). Nevertheless, this noise can not give rise to long-tail stationary distributions. As a matter of fact, the characterization of the stationary state induced by this shot noise follows straightforward using Eq. (3.24). From Eq. (3.19) its follows

Now it is interesting to remark about the non-analytic structure of $G_u^{st}(k)$, perhaps pre-announcing an anom alous behavior in the stationary distribution of the process u(t). Nevertheless, it should be noted that in the large scale limit k ! 0 this non-analytic structure cancel out, leading therefore to an expansion like Eq. (3.26), which in ply the absence of any long-tail distributions. This is not what happens if the driving noise has a long-tail structure as the one we are going to show below.

Abelnoise

In close connection with a Poisson noise with a random density of arriving pulses, in appendix B we have de ned the characteristic functional of A belnoise (t). The functional of this noise reads [t 2 (0;1)]

From this result it is simple to see that the (one-side stable) directed random walk behaves like P (u;t) (at) $/u^{1+}$; as was expected; see appendix B.

In presence of a non-local dissipation and in the case $> \frac{1}{2}^2$, due to the fact that the G reen function Eq.(3.11) changes its sign oscillating in time, a power-law behavior is obtained in a quite unusual way during the transient, i.e., the long-tail changes its support from a positive to a negative dom ain and so on as the time goes on. On the other hand, in the stationary regime we get

In Fig. 6 we show this amazing behavior for the noise parameters a = 3, $= \frac{1}{2}$, $K_{1=2}(x) = \frac{p}{-2x} \exp(-x)$. In this case we have used for the G reen function (see inset) the parameters values = 0.85 and = 0.2. At time t = 3.5 Fig. 6(a)] we can see that there is a long-tail in the positive dom ain, but also a sort of exponential decay appears in the negative dom ain as a result of the interplay between the oscillating G reen function and the Abel noise. At later time t = 5 Fig. 6(b)] it is possible to see that the long-tail has changed its support, showing also an exponential decay but now in the positive dom ain. At time t = 50 Fig. 6(c)] the stationary distribution is alm ost reached with the expected long-tail in the positive dom ain. In these gures we have also tted (with dashed lines) the corresponding long-tails with the asymptotic behavior

To end this sub-section let us call the attention that by subtracting two statistically independent A bel noises, it is also possible to obtain the n time characteristic function of a symmetric process u (t), see appendix B.

E.Fractional derivative evolutions

A nother example that can be characterized with the present functional technique is the case of fractional Langevin equations with dissipation. There exist m any di erent way of introducing this kind of equations. Here we will consider the evolution

From Eq. (3.37) it is evident that our functional approach allows us to introduce any kind of statistics to drive the fractional stochastic evolution.

Competition between fractional derivative and Levy noise

Here we are interested in analyzing the competence between the statistic of Levy noise and the dynam ical e ects introduced by a fractional derivative structure. In order to get a simpler analysis, here we will assume zero dissipation, i.e., = 0. In this case, the previous evolution reduce to

This expression is only well de ned if (1) < 1. Note the restriction on the parameters f; g. This result contrasts with that of a driving G aussian white noise, where the restriction is 2 $(\frac{1}{2};1]$. Thus, in the case of Levy noise, sm aller values of the parameter

2 (0;1] are allowed at the expenses of diminishing the value of 2 (0;2] (i.e., large Levy-step excursions).

Finally, we want to remark that Eq. (3.42) driven by Gaussian uctuations, can be mapped with an elective medium approximation in the context of disordered system $s^{3;36}$. Note that from our functional approach, it is easy to calculate any correlation functions and more complicated objects than the propagator of the system; this is something that is hard to obtain in the context of self-consistent approximations³⁷.

IV.SUMMARY AND CONCLUSIONS

We have completely characterized generalized linear Langevin equations when the usual uctuation-dissipation theorem does not apply. Our central result is an exact expression for the characteristic functional of the process u(t), for a general d dimensional correlated process (in appendix A we present a 2 dimensional example) where the memory and the noise are arbitrary. In this way we have been able to give a closed expression to get the whole K olm ogorov hierarchy, i.e., to calculate any n joint probability and any n time correlation function or cumulant.

We have applied our form alism to many di erent noise structures, and in this way we have shown the noise-induced interplay between the elects of the dissipative memory and the structure of the driving noises. Particular emphasis have been put in analyzing the 1 time probability distribution P (u;t) and its stationary state; we have shown that the transient toward the stationary state strongly depends on the interplay between the dissipation and the noise structure. As example we have analyzed the case of an exponential mem ory function in presence of di erent stochastic driving forces; for exam ple, radioactive noise and Poisson noise. A loo we have discussed whether or not, at large scale, a non-G aussian distribution appears and when these distributions have long-tails. In order to get this class of stationary distributions we have introduced, for the st time, the Abel noise in connection with the occurrence of one-side power-law distributions (see appendix B). We remark that this noise structure can be useful when studying models where molecular di usion is an important ingredient to be considered. In this context, the relaxation analysis of a generalized Langevin particle considering memory dissipation and injection of energy by microscopic random contributions characterized by a symmetric power-law, can be also carried out by using the present functional form alism. As a matter of fact, asymptotically when the Abel noise is symmetric the conclusions, for < 2, are in agreement with the structure of the Levy noise.

O f particular relevance is the use of our form alism to study fractional Langevin equations driven by arbitrary noise structures. We have analyzed the competence between the noise statistic and the fractional derivative operator. As examples we have compared Levy and G aussian noises and their interplay with the fractional calculus. We remark that the possibility of introducing arbitrary noise statistics in fractional Langevin equations is an interesting step forward to broad the possible applications of these equations²³.

To end this work let us com m ent that the present functional approach can also be applied to the so called delayed Langevin equations. In that case the associated G reen function (t) turns to be the crucial ingredient to study di erent m odels of delayed Langevin equations driven by arbitrary noises. Results along this line will be presented elsewhere.

This second order di erential equation also arises when modeling a rigid rotator^{26;6}. The marginal statistic description of this equation can be obtained from Eq. (A 11) after taking $k_v(t) = 0$. Quantities like hoos[x(t)]i or hsin [x(t)]i follow in mediately from the real and in aginary part of the characteristic functional, and more complex stochastic objects can also be calculated analytically. In general, any order di erential stochastic equation can be analyzed with our functional form alism after introducing additional stochastic process corresponding to the di erent derivatives of the original process.

A belwas probably the st to give an application of fractional calculus³⁸. He used derivatives of arbitrary order to solve the isochrone problem in classical mechanics, and the

From this expression it is simple to see that

where G ([z(t)]) is the functional of the Poisson noise (A = 1) evaluated in the test function $z(t) = \frac{R_1}{t} k(t^0) dt^0$. This means that the M arkov process n(t) controlled by Eq. (B8), with a probability rate , is equivalent to solve a linear Langevin equation driven by a Poisson noise (t) with a uniform density of arriving pulses . Thus we can write the associated stochastic di erential equation

$$\frac{\mathrm{dn}}{\mathrm{dt}} = (t): \tag{B14}$$

Now, we will assume that the rate in Eq. (B8) is a random variable with a distribution P (). This assumption arises naturally in the context of disordered systems. Therefore, the nalfunctional can be obtained from Eq. (B12) as

This integral can be done for m any di erent distributions P (); in particular if we use the Abel distribution Eq. (B2), we get

$$Z_{1} = \frac{s}{Z_{1}} + \frac{s}{Z$$

where we have used that $R_e \begin{bmatrix} R_1 \\ 0 \end{bmatrix}$ (e^{iz(t)} 1) dt 0. This result ends the interpretation of the Abel noise as the noisy term appearing in Eq. (B14), in close connection with the solution of a directed random walk model with a random (power-law distributed) transition rate .

Note that the cumulants of the Abel noise are not self-averaging with respect to the cumulants of the Poisson noise and the average over P (). For example using the Poisson functional, see Eq. (3.19) with A = 1 [or Eq. (B12)], it is simple to show that its second cumulant is hh (t₁) (t₂)ii = (t₁ t₂). Then the average of the correlation of the Poisson noise reads

result that is di erent from the calculation of the correlation of the Abelnoise, see Eq. (B7).

Consider now the subtraction of two Abel noises $c_{ib}(t)$ statistical independent: (t) = $^{c}(t)$ $^{b}(t)$. In this case, we can write the characteristic functional of the process (t) in the form

$$G ([k(t)]) = \exp i k(t) ^{c}(t) ^{b}(t) dt$$

where each functional is given by Eq. (B5). From the properties of the Basset function we can write this formula in a compact form, using the Kelvin functions, to handle this in a more friendly way. Also from this expression, it is simple to see that the rstmoment of the symmetric Abelnoise (t) is null, etc.

Note that our functional technique also allows us to calculate more complicated objects in disordered systems; for example, we can calculate the non-trivial two-particles density $P(u_1;t_1;u_2;t_2)$, etc.










