Insight into Resonant Activation in Discrete Systems

The resonant activation phenomenon (RAP) in a discrete system is studied using the master equation formalism. We show that the RAP corresponds to a non-monotonic behavior of the frequency dependent rst passage time probability density function (pdf). An analytical expression for the resonant frequency is introduced, which, together with numerical results, helps understand the RAP behavior in the space spanned by the transition rates for the case of rejecting and absorbing boundary conditions. The limited range of system parameters for which the RAP occurs is discussed. We show that a minimum and a maximum in the mean inst passage time (MFPT) can be obtained when both boundaries are absorbing. Relationships to some biological system s are suggested.

1. IN TRODUCTION

Noise induced escape of a particle from a potential well has been a fundam ental way for describing various processes in biology, chem istry, and physics, since the sem inal work of Kramers [1]. More recently, it has been suggested that for som e system s the potential itself uctuates in time. A few examples are: the transport of ions and bio-polym ers through m em brane channels [2]-[4], enzym atic kinetics [5], and the rebinding of ligand-protein com plexes [6, 7]. The basic form ulation of noise induced escape from a uctuating environment is obtained by making the potential term of the stochastic di erential equation (e.g. a white noise overdam ped Langevin equation) change with a frequency between two states. Doering and G adoua showed that for a uctuating system, the MFPT, , from a re ecting boundary to an absorbing boundary, may show a minimum as a function of [8]. The occurrence of a minimum in () was termed the resonant activation phenom enon (RAP). This has been followed by an extensive theoretical work to understand the nature of the RAP [9]-[16], along with experim ental e orts to nd system s displaying RAP [2, 17]. The theoretical works have been mainly focused on checking the e ect of di erent potentials on the RAP.

In this paper we study the discrete case RAP using coupled master equations (M E). We show that the RAP is only one of the properties that stem from the nonm onotonic behavior of the frequency dependent rst passage times (FPT) pdf, F (t), and which are related to frequency dependent m inim a in the rst and higher moments of F (t). We introduce an analytical expression for the dependence of the frequency that m inim izes () on the system transitions rates. We show that the RAP is obtained only when certain conditions in posed on the transition rates are full led. A nalyzing these conditions we come up with an instructive understanding regarding the nature of the RAP. In addition, a novel behavior of the M FPT is obtained when changing the reboundary into an absorbing one: the $\cos x$ is tence of a minimum and a maximum in ().

2. THEORETICAL FRAM EW ORK

We describe the escape from a system that uctuates between two con gurations A and B, using the coupled ME:




Figure 1: Schem atic illustration of the exit problem in a uctuating environment for n = 2. For an invariant system $a_{1;0} = a_{2;1} = a_f$, $a_{1;2} = a_b$, and $b_{1;0} = b_{2;1} = b_f$, $b_{1;2} = b_b$. For the particular invariant birth-death system $a_b = 0$, and $b_f = 0$.

 \dot{F}_{A} (t) (\dot{F}_{B} (t)) is an n-dimensional column vector, whose j element is the pdf to occupy site j of the A (B) conguration at time t. The transition between each site j in one conguration and its counterpart in the second conguration occurs with a ipping frequency, see Fig. 1. I is the unit matrix of n dimensions introduced in Eq. (1) to indicate the congurational coupling. Movement along each of the congurations, A and B, is governed by the square n-dimensional tridiagonal propagation matrices A and B, respectively, whose elements are the transition rates (Fig. 1). The choice of the matrices A and B corresponds to an equivalent choice of potential proles and boundary conditions in the continuum case. In what follows we set a rejecting boundary at site j= n, and an

absorbing boundary, as a trap, at site j=0, unless otherwise indicated. Fig. 1 shows a schematic illustration of the coupled system for n = 2.

The FPT pdf is de ned by F (t) = Q(1)S (t))=@t, where S (t) is the survival probability; namely, the probability of not reaching the site j=0 until time t. S (t) is obtained by sum m ing the elem ents of the vector that solves Eq. (1), S (t) = $U_{2n} E e^{D t} E^{-1} P_{2n}$ (0). Here U_{2n} is the summation row vector of 2n dimensions, P $_{2n}$ (0) is the initial condition column vector, $[P_{2n}(0)]_{i}$ = $(x_{j}P_{A;0} + x_{n;j}P_{B;0})$, where x is the initial site, and the process starts in the A (B) con guration with probability $P_{A:0}$ ($P_{B:0}$). Unless otherwise speci ed, we use x=n as a starting site, and $P_{\rm A\,;0} = P_{\rm B\,;0} = 1 {=} 2$, as suggested from the single con gurational ipping frequency. The de nite negative real part eigenvalues matrix D is obtained through the similarity transformation: $D = E^{-1}HE$, where H is the matrix given on the right hand side of Eq. (1), and E and E 1 are the eigenvectors matrix, and its inverse, of H .

3. RESULTS AND DISCUSSION

We start by computing F (t) for an invariant birthdeath system. By an invariant system we mean that the transition rates are independent of the site index, j; namely, m_{j;j} =+ 1 = m_{f=b} for con guration M , where m_{f=b} represents $a_{f=b}$ and $b_{f=b}$ transition rates, and M stands for A and B. A birth-death system means that the movement in each con guration occurs only in one direction, i.e. $a_b=b_f=0$. C learly, the term birth-death indicates that the particle [when simulating Eq. (1)] can move only towards its "death" (the trap) when it is subjected to the dynamics of the A con guration, and in this sense, when ipping to the B con guration occurs it is "born" (or "resurrected"). Therefore, for the birth-death system, the uctuations are between a con guration, and a con-

guration acting as a "valley", the death conguration. Note that a single-rate (namely, $a_f = b_b$) invariant birthdeath system is similar to the system studied by D oering and G adoua [8], where the derivatives of the two linear potentials are sign opposite and equal in the absolute values.




Figure 2: F (t) as a function of t and on a log-log plot (natural log), for a single rate invariant birth-death system with n= 10, and $a_f = b_o = 1$. Also shown is F (t) projections.

Fig. 2 shows F (t) for a single-rate invariant birthdeath system and n=10. At short to interm ediate times, F (t) displays a peak that shifts towards larger times with . This peak represents the exiting of the initial population of con guration A, $_{x,j}P_{A,0}$, for small, and the overall initial condition for large . At longer times and intermediate , a minimum in F (t) appears as a function of that represents the fastest exit mainly of the initial B population. A coordingly, the minimum in the M FPT () is a consequence of the shape of F (t), and is therefore rejusted in higher moments of F (t) as well.

To study the RAP we start by computing the MFPT. In general, the sth moment of F(t) is obtained by inverting matrix H: $s = 0 t^{s}F(t)dt = 1 t^{s}U_{2n}(t) t^{s}P_{2n}(0)$. Using the projection operator techniques for H $^{-1}$ blocks [18], reads

where $C_A = [A B (A + B)]^1$, $C_B = [B A (A + B)]^1$, and $[P_n(0)]_j = x_{j}$. From Eq. (2) one can calculate () for the limiting cases ! 0 and ! 1. For

() by the infinite grades . It is the incomplex congrutations, A and B, $= (_{A} + _{B})=2$, where $_{M} = UM^{-1}P_{n}(0)$ is the MFPT of congrutation M. For ! 1, is the MFPT of an averaged fully coupled system, namely, $= U_{n}(\frac{A+B}{2})^{-1}P_{n}(0)$. These are the expected limiting behaviors of the MFPT [8]-[12], [15, 16]. RAP is expected for intermediate ipping frequencies.

To obtain an analytical expression for the frequency that minimizes (), $_{m \text{ in}}$, we search for an extrem um point (a minimum) of the function (), for an invariant system and n=2. We nd $_{m \text{ in}}$ to be a sum of two terms:

where the notations on the right hand side of Eq. 3 m ean that each of the term smust be non negative to contribute to m in, and

W e note that the sm allest system that exhibits the RAP requires a three site system, which is a speci c case of the system shown in Fig. 1, with, for example, $b_{1,2} = b_{2,1}$! 1. However, in what follows we consider system s with nite transition rates.

For the birth-death system Eq. (3) reduces to:

The simple form of Eq. (6) provides an insight into the nature of the RAP. It immediately implies the requirement $a_f=b_b < 2$ for RAP to occur. For b_b a_f , $m_{in} = (A)^{-1}$, where A is the rst moment, s=1, of F (t) for a death system, $A = (n)_s = a_f^s$, where $(n)_s = (n + s - 1) \models (n - 1)!$. This optimal frequency means that $x_{ij}P_{A,j0}$ has exited the interval, on average, while the

rst con gurational transition occurred, and the same holds for $_{x,j}P_{B,0}$, for the second con gurational transition. Because the probability (particles) can exit the intervalonly when it is subject to the A con guration dynamics, a situation where the A con guration is empty but not the B con guration, means a "waste" of time with regards to fastest interval exiting. This is the case for < min. For > min, not all $_{x,j}P_{A,0}$ exited the interval, while the rst con gurational transition occurred, meaning that another cycle of ipping is required to exit the system. This leads again to a "waste" of time with regards of fastest interval exiting. At $= (A)^{-1}$, only one con gurational change occurs, and costs the minimal time for exiting the interval.

The special feature that $a_f = b_b < 2$ is needed for RAP suggests that the rate along the birth conguration must be, at least, as fast as those along the death conguration for the RAP to be obtained. For an invariant birth-death system to show the RAP, the ratio $a_f = b_b$ must full $a_f = b_b$. Scaling the time, $\mathfrak{e} = tb_b$, leads to dimensionless rates $a_f = b_b$ and $= b_b$.

W e em phasize that even for the sim ple invariant birthdeath system that ful lls the dem and that the B con guration rate is much larger than of con guration A rates, the relation $m_{in} = (A)^{1} m_{ij}$ might not be satis ed. To see that we calculate m_{in} for a general birth-death system and n=2 (see Fig. 2):

which for $p_{\overline{a_{1;0}a_{2;1}}=b_{1;2}}$! 0, reduces to $m_{in} = p_{\overline{a_{1;0}a_{2;1}}=2}$, where $(A)^{1} = a_{1;0}a_{2;1} = (a_{1;0} + a_{2;1})$. Moreover, when $a_{1;0}^{-1} = a_{2;1}^{-1}$, $(A)^{-1} = a_{2;1}^{-1}$, m_{in}^{-1} is unchanged, and is much larger than $(A)^{-1}$, in plying that more than one con gurational change occurs at the optimal ipping frequency. Reverse substitution $= m_{in}$ and = $(A)^{1}$ into (), results in (= m in) 2= $a_{2,1}$ and $\frac{(= m in)}{(= (A)^{-1})}$ 0.8. Note that for both values of , () is independent of $b_{1,2}$ to be compared with (! 1) $\frac{b_{1,2}}{a_{1;0}a_{2;1}}$. m in has, therefore, a general functional form that not necessarily coincides with the M FPT of the faster conguration.

Going beyond the birth-death system, we rst consider a case for which B = A. From Eqs.(3)-(5) we have, for n=2, m in < 0 for any positive . From numerical calculation we nd that for n > 2 there is no real positive m in. Both the analytical and the numerical results im - ply that a system for which A and B commute does not exhibit the RAP.

The next case to be checked for the occurrence of the RAP is obtained by setting, $a_f = b_b = k$. U sing e = kt, the system transition rates are dimensionless, measured in units of k. This procedure leads to the reduced Eqs.(4-5):

where $u = a_b = k$ and $v = b_f = k$. Fig. 4a shows m in = k as a function of v for u = 1 = 2. m in; 1 = k displays a maximum at $v_m ax$, which is easily recovered from Eq. (8). For $v = v_m ax$, m in; 1 = k increases, which rejects the increase in the relative ability of the B con guration to "help" the fastest exiting of con guration A. On the other hand, the decrease in m in; 1 = k for $v = v_m ax$, in plies that the B con guration m ovem ent towards the absorbing end be-




Figure 3: $\min_{A} = b_{b}$ as a function of n and the ratio $a_{f} = b_{b}$. W hen $a_{f} = b_{b} > 3$ the RAP does not exist, for any n.




Figure 4: a: $\min_{i=1} = k$ for $a_f = b_0 = k$, and u = 1=2, as a function of v.b: $\min_{i=1} = k$ as a function of 0 $u; v < 1.c: \min_{i=1} = k$ for u = 1 as a function of v.d: $\min_{i=1} = k$ for u = 5 as a function of v.

com es fast enough "to stand on its own" for the accom plishment of this task. A resonant-free zone occurs in the $_{\rm B}$, and is followed by a short resoregion where Anant region, where both con gurations are trap oriented, namely, u < 1 and v > 1. Fig. 4b shows that in the range u < 1 m in;1=k is non-m onotonic. Fig. 4c shows for 0 u=1 the only non-zero $\min_{i=1} = k > 0$ which diverges as when v! 1, because for these system parameters 1 $B = A \cdot For u > 1 and v$ 1, m in =k has two asym ptotic lines, which de ne a resonant-free region. This happens when B A. For u v > 1, m in =k v=2. These two features are dem onstrated in Fig. 4d.

The above analysis is of importance since the coupled ME with n=2 can be used to model the kinetics of a conform ationally changing enzyme. Such extended M ichaelis-M enten m odels are appropriate for describing experim ents perform ed on a single molecule level [5]. If we assume that there are two enzyme conform ations, a speci c stage of the enzym atic activity can be described by Fig. 1. From Eqs. (8) and (9), and more generally Eqs. (4) and (5), a relationship between the reaction rates and the conform ational ipping frequency can be established for an optim al enzym atic activity. In addition, changes in the ipping rate value near the resonant frequency, which can be achieved for example by binding of other m olecules to the enzyme, provide a simple and e cient mechanism for regulating the enzymatic activity, which is a well known issue in biology [19].




Figure 5: a: A log-log-log plot (natural log) of ()= (! 1) as a function of a_b and $_A$, for two absorbing ends in an invariant system, with $a_f = 3.5$, $b_f = 0.175$, $b_b = 1$, n = 7, and x = 4. b: Pro le of the left gure for $a_b = 0.25$ exposes a global minimum and a globalm aximum in ()= (! 1).

Finally, we study a system for which both ends are absorbing; namely, the rejecting boundary is replaced by an absorbing one, and the escape process starts at the middle site (n=7, and x=4). The coupled invariant congurations are taken to have an opposite bias, i.e. the transition rates of the B conguration are $l_{\rm P}=0.175$, $b_{\rm D}=1$, which give rise to a left side bias as dened in Fig. 1, whereas in the A con guration q = 3:5, and $a_b < a_f$ give rise to a right side bias. A globalm inimum and a globalm aximum in ()= (! 1) can occur (Fig. 5b). Them inimum and maximum appearat the neighborhood of the points $m_{in B} = 1$, and $m_{ax A} = 1$, respectively. This behavior is sensitive to the value of a_b (Fig. 5a). For a_b ! 0 the global extrem um points reduce to local extrem um points. When a_b ! a_f , ()= (! 1) is a m onotonically increasing function of A.

We note that these boundary conditions for a uctuating system have been used to describe the translocation of a single stranded DNA through a conformationally changing nanopore [4]. For this case no resonance occurred because of the physical conditions that im posed the relation B = A. However, for systems that are described by matrices A and B that do not commute and for two absorbing ends, a change in in the vicinity of the extrem al points, leads to a drastic change in the average time during which the system is occupied, and, therefore, emphasizes the importance of the frequency of uctuation as a control parameter.

4. CONCLUSIONS

To conclude, in this paper we revisited the resonant activation phenom enon. We studied the origin of the RAP and the requirements under which this phenom enon can be observed. We showed that for a single rate invariant birth-death system the RAP is a consequence of a general phenom enon, which is a non-monotonic behavior of F(t) along the frequency axis for large time. We characterized the conditions for which an invariant birth-death system exhibits the RAP, and broaden these conditions by examining more general systems. Relationship between the RAP and biological activity was suggested. In addition, we introduced a new property of the MFPT, the coexistence of a minimum and a maximum in the ipping frequency dependent MFPT, ().
