# Insight into $R$ esonant A ctivation in D iscrete System $s$

#### Abstract

The resonant activation phenom enon (RAP) in a discrete system is studied using the master equation form alism. W e show that the RAP corresponds to a non-m onotonic behavior of the frequency dependent rst passage tim e probability density function (pdf). An analytical expression for the resonant frequency is introduced, which, together with num erical results, helps understand the RAP behavior in the space spanned by the transition rates for the case of re ecting and absorbing boundary conditions. The lim ited range of system param eters forwhich the RAP occurs is discussed. $W$ e show that a $m$ in $\dot{m} u m$ and a $m$ axim um in the $m$ ean rst passage time (MFPT) can be obtained when both boundaries are absorbing. R elationships to som e biological system s are suggested.

## 1. $\mathbb{I N} T R O D U C T I O N$

N oise induced escape of a particle from a potentialw ell has been a fundam ental way for describing various proœesses in biology, chem istry, and physics, since the sem inal work of $K$ ram ers $[\underline{[1]}]$. $M$ ore recently, it has been suggested that for som e-system sthe potential itself uctuates in tim e. A few exam ples are: the transport of ions and bio-polym ers through $m$ em brane channels $\left[\underline{L}_{1}^{\prime}\right]\left[-\left[L_{1}^{1}\right]\right.$, enzym atic kinetics $\left[\frac{1}{1}\right]$, and the rebinding of ligand-protein com plexes $\left[\begin{array}{ll}{\left[\frac{1}{1}, ~\right.} \\ \hline\end{array}\right.$ escape from a uctuating environm ent is obtained by $m$ aking the potential term of the stochastic di erential equation (e.g. a white noise overdam ped Langevin equation) change w ith a frequency between two states. D oering and G adoua showed that for a uctuating system, theMFPT, , from a re ecting boundary to an absorbing boundary, $m$ ay show a $m$ inim um as a function of [ipl. $T$ he occurrence of a $m$ inim um in () was term ed the resonant activation phenom enon (RAP). This has been follow ed by an extensive theoretical w ork to understand the nature of the RAP [d] [1] $]$, along w th experim ental $e$ orts to nd system $s$ displaying RAP oreticalw orks have been $m$ ainly focused on checking the $e$ ect of di erent potentials on the RAP.

In this paper we study the discrete case RAP using coupled $m$ aster equations (ME).W e show that the RAP is only one of the properties that stem from the nonm onotonic behavior of the frequency dependent rst passage tim es (FPT) pdf, F (t), and which are related to frequency dependent $m$ in im $a$ in the rst and higher $m o-$ $m$ ents of $F$ ( $t$ ). We introduce an analytical expression for the dependence of the frequency that $m$ in im izes ( ) on the system transitions rates. W e show that the RAP is obtained only when certain conditions im posed on the transition rates are ful lled. A nalyzing these conditions we com e up with an instructive understanding regarding the nature of the RAP. In addition, a novelbehavior of the MFPT is obtained when changing the re ecting
boundary into an absorbing one: the coexistence of a $m$ inim um and a $m$ axim um in ().

## 2. THEORETICALFRAMEWORK

W e describe the escape from a system that uctuates between two con gurations A and B, using the coupled ME:
$P^{\prime}{ }_{A}(t)\left(P^{\prime} \quad(t)\right)$ is an $n$-dim ensional collum $n$ vector, whose $j$ elem ent is the pdf to occupy site $j$ of the $A(B)$ con guration at timet. The transition betw een each site $j$ in one con guration and its counterpart in the second con guration occursw ith a ipping frequency, see Fig. 1. I is the unit $m$ atrix of $n$ dim ensions introduced in Eq. (1) to indicate the con gurational coupling. M ovem ent along each of the con gurations, $A$ and $B$, is govemed by the square $n$-dim ensional tridiagonal propagation $m$ atrices A and B, respectively, whose elem ents are the transition rates ( $F$ ig. 1). The choige of the $m$ atrioes $A$ and $B$ corresponds to an equivalent choice of potential pro les and boundary conditions in the continuum case. In what follow s we set a re ecting boundary at site $j=n$, and an

absorbing boundary, as a trap, at site $j=0$, unless otherw ise indicated. $F$ ig. 1 show $s$ a schem atic illustration of the coupled system for $n=2$.

The FPT pdf is de ned by $F(t)=@(1 \quad S(t))=@ t$, where $S(t)$ is the survivalprobability; nam ely, the probability of not reaching the site $j=0$ until timet. $S$ ( $t$ ) is obtained by sum $m$ ing, the elem ents of the vector that solvesEq. (1), S (t) = $\dot{U}_{2 n}^{1} E e^{D} E^{1}{ }^{1} \stackrel{!}{P}_{2 n}(0)$. Here $\dot{U}_{2 n}^{1}$ is the summ ation row vector of 2 n dim ensions, $\mathrm{P}_{2 \mathrm{n}} \mathrm{m}^{2}(0)$ is the initial condition column vector, $\left[\mathrm{P}^{\prime} 2 \mathrm{n}(0)\right]_{j}=$ $\left(x_{i j} \mathrm{P}_{\mathrm{A} ; 0}+\mathrm{x}+\mathrm{n} ; \mathrm{j} \mathrm{P}_{\mathrm{B}} ; 0\right)$, where x is the in itialsite, and the process starts in the $A(B)$ con guration $w$ ith probability $P_{A ; 0}\left(P_{B ; 0}\right)$. Unless otherw ise speci ed, we use $x=n$ as a starting site, and $P_{A ; 0}=P_{B ; 0}=1=2$, as suggested from the single con gurational ipping frequency. The de nite negative real part eigenvalues $m$ atrix $D$ is obtained through the sim ilarity transform ation: $D=E{ }^{1} \mathrm{HE}$, $w$ here $H$ is the $m$ atrix given on the right hand side of Eq. (1), and $E$ and $E{ }^{1}$ are the eigenvectorsm atrix, and its inverse, of H .

## 3. RESULTSAND D ISCUSSION

We start by com puting $F$ ( $t$ ) for an invariant birthdeath system. By an invariant system we mean that the transition rates are independent of the site index, $j ;$ nam ely, $m_{j ; j}=+1=m_{f=b}$ forcon guration $M$, where $m_{f=b}$ represents $\mathrm{a}_{\mathrm{f}=\mathrm{b}}$ and $\mathrm{b}_{\mathrm{f}=\mathrm{b}}$ transition rates, and M stands for A and B. A birth-death system $m$ eans that the $m$ ove$m$ ent in each con guration occurs only in one direction, i.e. $\mathrm{a}_{\mathrm{b}}=\mathrm{b}_{\mathrm{f}}=0$. C learly, the term birth-death indicates that the particle [when simulating Eq. (1)] can m ove only tow ards its "death" (the trap) when it is sub jected to the dynam ics of the A con guration, and in this sense, when ipping to the $B$ con guration occurs it is "bom" (or "resurrected"). Therefore, for the birth-death system, the uctuations are betw een a con guration which acts as a "barrier", the birth con guration, and a con-
guration acting as a "valley", the death con guration. $N$ ote that a single-rate (nam ely, $a_{f}=b_{0}$ ) invariant birthdeath system is sim ilar to the system studied by D oering and $G$ adoua $\left[\frac{[8}{[1]}\right]$, where the derivatives of the tw o linear potentials are sign opposite and equal in the absolute values.

Fig. 2 shows $F$ (t) for a single-rate invariant birthdeath system and $n=10$. At short to interm ediate tim es, F (t) displays a peak that shifts tow ards larger tim es with . This peak represents the exiting of the initial population of con guration $A, x ; j \mathrm{P}_{\mathrm{A} ; 0}$, for sm all, and the overall initial condition for large. At longer tim es and interm ediate, a m inim um in $F$ ( $t$ ) appears as a function of that represents the fastest exit $m$ ainly of the initial B population. A ccordingly, the $m$ inim $u m$ in the MFPT () is a consequence of the shape of $F$ ( $t$ ), and is therefore re ected in higher $m$ om ents of $F$ ( $t$ ) as well.

To study the RAP we start by computing the MFPT. In general, the $s^{\text {th }} m$ oment $R_{1}^{f} F(t)$ is $o b-$ tained by inverting $m$ atrix $H: \quad s=c_{1} t^{s} F(t) d t=$ $s!U^{!} 2 n(H)^{s} P^{!} 2 n(0)$. U sing the projection operator techniques for $\mathrm{H}^{1}$ blocks $\left[\underline{[1 G}_{\underline{1}}^{\mathbf{1}}\right]$, reads

( ) for the lim iting cases ! 0 and ! 1 . For
! 0 , is the average of the MFPT of the uncoupled con, gurations, $A$ and $B,=(A+B)=2$, where $M=U^{\prime} M{ }^{1} \mathrm{P}_{\mathrm{n}}(0)$ is the MFPT of con guration M. For ! 1 , is the MFPT, of an averaged fully coupled system, nam ely, $=U_{n}\left(\frac{A+B}{2}\right){ }^{1} \mathrm{P}_{\mathrm{n}}(0)$. These are the expected lim iting behavions of the M FPT [id] $\left[\begin{array}{c}12\end{array}\right],\left[\begin{array}{ll}1,16 \\ 1\end{array}\right]$. R A P is expected for interm ediate ipping frequencies.

To obtain an analytical expression for the frequency that $m$ inim izes ( ), $m$ in, we search for an extrem um point (a m inim um ) of the function ( ), for an invariant system and $n=2$. We $n d m$ in to be a sum oftwo term $s$ :

where the notations on the right hand side ofE q. 3 m ean that each of the term sm ust be non negative to contribute to m in, and

$W$ e note that the sm allest system that exhibits the RAP requires a three site system, which is a speci c case of the system shown in F ig. 1, w ith, for exam ple, $\mathrm{b}_{1 ; 2}=$ $b_{2 ; 1}!1$. H ow ever, in what follow s we consider system s w th nite transition rates.

For the birth-death system Eq. (3) reduces to:

The simple form of Eq. (6) provides an insight into the nature of the RAP. It im m ediately im plies the requirem ent $a_{f}=b_{b}<2$ for RAP to occur. For $b_{b} a_{f}$, $m$ in $=(A)^{1}$, where $A$ is the rst $m$ oment, $S=1$, of F (t) for a death system, ${ }_{A}^{s}=(n)_{s}=a_{f}^{s}$, where $(n)_{s}=$ $\left(\begin{array}{ll}n+s & 1\end{array}\right)!\left(\begin{array}{ll}n & 1\end{array}\right)!$. This optim al frequency $m$ eans that ${ }_{x ; j} \mathrm{P}_{\mathrm{A}}$;0 has exited the interval, on average, while the rst con gurational transition occurred, and the same holds for ${ }_{x ; j} P_{B ; 0}$, for the second con gurational transition. Because the probability (particles) can exit the intervalonly when it is sub ject to the A con guration dynam ics, a situation where the A con guration is em pty but not the $B$ con guration, $m$ eans a "waste" of time w ith regards to fastest interval exiting. T his is the case for $<m$ in . For $>m$ in, notall $x_{; j} \mathrm{P}_{\mathrm{A} ; 0}$ exited the interval, while the rst con gurationaltransition occurred, $m$ eaning that another cycle of ipping is required to exit the system. This leads again to a "waste" of tim e w ith regards of fastest interval exiting. At $=(\text { A })^{1}$, only one con gurationalchange occurs, and costs the $m$ inim al tim e for exiting the interval.
$T$ he special feature that $a_{f}=b_{0}<2$ is needed for R AP suggests that the rate along the birth con guration $m$ ust be, at least, as fast as those along the death con guration for the RAP to be obtained. For an invariant birthdeath system to show the RAP, the ratio $a_{f}=b_{0} m$ ust ful $l$ $\mathrm{a}_{\mathrm{f}}=\mathrm{b}_{\mathrm{o}} \quad 3$ asym ptotically, which is dem onstrated in F ig. 3. N ote that Fig. 3 spans both degrees of freedom of the invariant birth-death case, the size $n$, and the ratio $\mathrm{a}_{\mathrm{f}}=\mathrm{b}_{\mathrm{b}}$. Scaling the tim $\mathrm{e}, \mathrm{E}=\mathrm{tb}_{\mathrm{b}}$, leads to dim ensionless rates $\mathrm{a}_{\mathrm{f}}=\mathrm{b}_{\mathrm{b}}$ and $=\mathrm{b}_{\mathrm{b}}$.

W e em phasize that even for the sim ple invariant birthdeath system that fiul lls the dem and that the B con $g$ uration rate is m uch larger than ofcon guration A rates, the relation $m$ in $=(\mathrm{A})^{1} \mathrm{~m}$ ight not be satis ed. To see that we calculate $m$ in for a generalbirth-death system and $\mathrm{n}=2$ (see Fig. 2) :

Which for ${ }^{\mathrm{P}} \overline{\mathrm{a}_{1 ; 0} \mathrm{a}_{2 ; 1}}=\mathrm{b}_{1 ; 2}$ ! 0 , reduces to m in $=$ $\mathrm{P} \overline{\mathrm{a}_{1 ; 0} \mathrm{a}_{2 ; 1}}=2$, where $(\mathrm{A})^{1}=a_{1 ; 0} \mathrm{a}_{2 ; 1}=\left(\mathrm{a}_{1 ; 0}+\mathrm{a}_{2 ; 1}\right)$. M oreover, when $a_{1 ; 0} \quad a_{2 ; 1},\left({ }_{A}\right)^{1} \quad a_{2 ; 1}, m$ in is unchanged, and is much larger than ( $\left.{ }_{\mathrm{A}}\right)^{1}$, im plying that $m$ ore than one con gurational change occurs at the optim al ipping frequency. Reverse substitution $=\mathrm{m}$ in
and $=\left(A_{A}\right)^{1}$ into () , results in $(=\mathrm{m}$ in $) \quad 2=a_{2 ; 1}$ and $\frac{(=\mathrm{m} \text { in })}{\left(=(\mathrm{A})^{1}\right)} \quad 0: 8$. N ote that for both values of
, ( ) is independent of $\mathrm{b}_{1 ; 2}$ to be compared $w$ ith ( ! 1) $\frac{\mathrm{b}_{1 ; 2}}{\mathrm{a}_{1 ; 0} \mathrm{a}_{2 ; 1}}$. m in has, therefore, a general functional form that not necessarily coincides $w$ th the MFPT of the faster con guration.

G oing beyond the birth-death system, we rst consider a case for which $B=A$. From Eqs. (3)-(5) we have, for $\mathrm{n}=2$, m in $<0$ for any positive. From num erical calculation we nd that for $n>2$ there is no real positive $m$ in. B oth the analytical and the num erical results im ply that a system forwhich A and B commute does not exhibit the RAP.

The next case to be checked for the occurrence of the RAP is obtained by setting, $a_{f}=b_{b}=k . U \operatorname{sing} E=k t$, the system transition rates are dim ensionless, $m$ easured in units of k . This procedure leads to the reduced Eqs.(45) :

$w$ here $u=a_{b}=k$ and $v=b_{f}=k$. $F$ ig. 4a show $s m$ in $=k$ as a function of $v$ for $u=1=2$. $m$ in $; 1=k$ displays a $m$ axim um at $\mathrm{V}_{\mathrm{m}}$ ax, which is easily recovered from Eq. (8). For v Vnax, $m$ in; $=k$ increases, which re ects the increase in the relative ability of the B con guration to "help" the fastest exiting ofcon guration A. On the other hand, the decrease in $m$ in $; 1=k$ for $v \quad y_{m x}$, implies that the $B$ con guration $m$ ovem ent towards the absorbing end be-

com es fast enough "to stand on its own" for the accom plishm ent ofthis task. A resonant-free zone occurs in the region where A B, and is followed by a short resonant region, where both con gurations are trap oriented, nam ely, $u<1$ and $v>1$. Fig. 4b show $s$ that in the range $0 \mathrm{u}<1 \mathrm{~m}$ in ;1 $=\mathrm{k}$ is non m onotonic. F ig. 4c show s for $u=1$ the only non-zero $m$ in; $=\mathrm{k}>0$ which diverges as $\frac{1}{1 \mathrm{v}}$ when v ! 1 , because for these system param eters $\mathrm{B}=\mathrm{A}$. For $u>1$ and $v \quad 1, \mathrm{~m}$ in $=\mathrm{k}$ has tw 0 asym ptotic lines, which de ne a resonant-free region. This happens when B A. For $u \quad v>1, m$ in $=k \quad v=2$. These two features are dem onstrated in Fig .4 d .

The above analysis is of im portance since the coupled ME w ith $n=2$ can be used to $m$ odel the kinetics of a conform ationally changing enzym e. Such extended $M$ ichaelis $M$ enten $m$ odels are appropriate for describing experim ents perform ed on a single $m$ olecule level [5]. If we assum e that there are two enzym e conform ations, a speci c stage of the enzym atic activity can be described by Fig. 1. From Eqs. (8) and (9), and m ore generally Eqs. (4) and (5), a relationship between the reaction rates and the conform ational ipping frequency can be established for an optim al enzym atic activity. In addition, changes in the ipping rate value near the resonant frequency, which can be achieved for exam ple by binding of other $m$ olecules to the enzym e, provide a sim ple and e cient $m$ echanism for regulating the enzym atic activity, which is a well known issue in biology [19].

Finally, we study a system for which both ends are absorbing; nam ely, the re ecting boundary is replaced by an absorbing one, and the escape process starts at the $m$ iddle site ( $n=7$, and $x=4$ ). The coupled invariant con gurations are taken to have an opposite bias, i. e. the transition rates of the $B$ con guration are $\varphi=0: 175$, $\mathrm{b}_{\mathrm{b}}=1$, which give rise to a left side bias as de ned in F ig.

1, whereas in the A con guration $a_{6}=3: 5$, and $a_{b}<a_{f}$ give rise to a right side bias. A global $m$ inim um and a globalm axim um in ( $)=(!1)$ can occur ( $F$ ig. 5b). Them inim um and $m$ axim um appearat the neighborhood of the points $m$ in $B=1$, and $m$ ax $A=1$, respectively. $T$ his behavior is sensitive to the value of $a_{b}$ ( $F$ ig. 5a). For $a_{b}$ ! 0 the global extrem um points reduce to local extrem um points. $W$ hen $a_{b}!a_{f}, \quad()=(!1)$ is a $m$ onotonically increasing function of $A$.

W e note that these boundary conditions for a uctuating system have been used to describe the translocation of a single stranded DNA through a conform ationally changing nanopore $\left[\begin{array}{l}{[i]} \\ ]\end{array}\right.$. For this case no resonance occurred because of the physical conditions that im posed the relation $B=A . H$ ow ever, for system $s$ that are described by $m$ atrices A and B that do not com $m$ ute and for two absorbing ends, a change in in the vicinity of the extrem al points, leads to a drastic change in the average tim e during which the system is occupied, and, therefore, em phasizes the im portance of the frequency of uctuation as a control param eter.

## 4. C O N C LU S IO N S

To conclude, in this paper we revisited the resonant activation phenom enon. W e studied the origin of the RAP and the requirem ents under which this phenom enon can be observed. W e showed that for a single rate invariant birth-death system the RAP is a consequence of a general phenom enon, which is a non-m onotonic behavior off ( $t$ ) along the frequency axis for large tim e. W e characterized the conditions for which an invariant birth-death system exhibits the RAP, and broaden these conditions by exam ining $m$ ore generalsystem $s$. R elationship betw een the RAP and biological activity w as suggested. In addition, we introduced a new property of the MFPT, the coexistence of a $m$ inim um and a $m$ axim um in the ipping frequency dependent MFPT, ().
