# G eom etric structure of coexisting phases found in the $B$ inam -M iddleton-Levine tra cm odel

#### Abstract

$T$ he $B$ inam M iddleton-Levine tra cm odel is perhaps the sim plest system exhibiting phase transitions and self-organization. M oreover, it is an underpinning to extensive $m$ odem studies of tra $c$ ow . The general belief is that the system exhibits a sharp phase transition from freely ow ing to fiully jam $m$ ed, as a function of in itial density of cars. H ow ever we discover interm ediate stable phases, where jam s and freely ow ing tra c coexist. T he geom etric structure of such phases is highly regular, w ith bands of free ow ing tra cintersecting at jam $m$ ed $w$ avefronts that propagate sm oothly through the space. Instead of a phase transition as a function of density, we see bifurcation points, where interm ediate phases begin coexisting w ith the m ore conventionally known phases. W e show that the regular geom etric structure is in part a consequence of the nite size and aspect ratio of the underlying lattice, and that for certain aspect ratios the asym ptotic interm ediate phase is on a short periodic lim it cycle (the exact $m$ icroscopic con guration recurs each tim esteps, where is $s m$ all com pared to the system size). A side from describing these interm ediate states, which previously were overlooked, we derive sim ple equations to describe the geom etric constraints, and predict their asym ptotic velocities.

## I. INTRODUCTION

M odeling vehicular and Intemet tra $c$, thereby gaining an understanding of congestion pattems and jam $m$ ing phenom ena, is an extrem ely relevant problem, w th obvious practical ram i cations. O ne popular approach is the use of sim ple discrete cellular autom ata (CA) m odels, which capture aspects of the dynam ics of discrete vehicles or packets. O ne of the $m$ ost cited exam ples of such a CA model is the B iham, M iddleton, and Levine m odel (BM L) of tw o-dim ensional tra $c$ ow [l] 1. At the tim e of this writing, $R$ ef. [f] has received over two-hundred citations in the scienti c literature, and it serves as a theoretical underpinning for the physicists' approach to $m$ odeling tra $c$. $N$ ote that using techniques from physics to $m$ odel tra $c$ has been a fruitful research area for $m$ ore than $a$ decade, and

$T$ he BM L m odeldescribes tw o species of $\backslash \operatorname{cars}^{\prime \prime} m^{-1}$ oving on a tw o-dim ensionalsquare lattioe, w th periodic boundary conditions. The $m$ odel is extrem ely sim ple, yet the behaviors it displays, extraordinarily com plex. The system show s what appears to be a phase transition from having all cars freely moving at all tim e steps, to com plete gridlock, where no car can ever $m$ ove again. In addition, in all the phases, the system becom es filly correlated, form ing a range of interesting stable selforganized pattems. It is perhaps the sim plest $m$ odel where one can study both phase transitions and self organization. This $m$ odel has recently becom e increasingly of interest to the com binatorial m athem atics com $m$ unity, as it continues to elude rigorous theoretical analysis [G].

W e im plem ent the BM L m odeland experim entally study its behaviors. W e discover stable interm ediate states that have never been reported before for the BM L m odel, w ith highly structured geom etric pattems of wave fronts of jam sm oving through otherw ise freely ow ing tra $c$. We show the geom etry of these pattems arise due to the nite size and periodic boundary conditions of the underlying lattice. We also show that the aspect ratio of the lattice im poses geom etric constraints which restrict the pattems, and derive sim ple equations describing these geom etric constraints which allow us to calculate the asym ptotic velocities. For certain aspect ratios we can prove that the interm ediate con gurations end up on a short periodic lim it cycle| the exact $m$ icroscopic con gurations recur each
tim esteps (where is sm all com pared to the system size)| hence these states are stable for all tim e. For the other aspect ratios, we show the interm ediate states are at least $m$ etastable, lasting as long as we could sim ulate them. By establishing the existence of these interm ediate states, we show that the conventionalbeliefs about this m odel need to be reexam ined. C ontrary to the evidence published elsew here, only on sm aller spaces do we see evidence for a sharp transition from freely ow ing to fully jam $m$ ed con gurations as a function of the initialdensity of cars, . Instead we

observe bifurcations as a function of , where di erent phases can begin to coexist. T he bifurcation points, the range of the w indow s for phase coexistence, and the num ber of coexisting phases, depend on the size and the aspect ratio of the underlying lattice. C onsidering the am ount of ongoing work on this m odel, and its use in large scale, com plex sim ulations of tra $c$, we believe it is im portant to understand these new observations.
 we describe our sim ulations and em pirical results. Section "IVI' contains a discussion of the kinetic pathw ays, geom etric constraints, and derivation of the velocities for the intermiate states. $F$ inally, in Sec. $V$ open questions and areas for further inquiry.

## II. THE BMLMODEL

C onsider two species of particles (i.e., \cars"), east-bound and north-bound (which we also interchangeably call \red" and \blue" respectively), which populate a two-dim ensional square lattice with periodic boundary conditions. Each lattice site can be in one of three states: em pty, occupied by an east-bound car, or occupied by a north-bound car. The cars are in itially distributed uniform ly at random along the lattice sites, with spatial density, (usually taken to be the same for both north and east-bound cars). The discrete time dynam ics has two phases. On even steps, all east-bound cars synchronously attem pt to advance one lattice site tow ards the east. If the site eastw ard of a car is currently em pty, it advances. O therw ise, it rem ains stationary (even if the eastw ard site is to becom e em pty during the current tim e step). On odd tim e steps, the north-bound cars follow the analogous dynam ics, only attem pting to advance to the north-bound site. The dynam ics is fully determ inistic. T he only random ness is in the initial condition. Furtherm ore, the dynam ics conserves cars, and does not allow for an east-bound car to change its row, nor for a north-bound car to change its colum $n$. So on a L L lattice, there are 2 L conservation law s .

If initialized w ith a low enough density of cars, the system eventually self-organizes into a con guration where all cars can $m$ ove at each time step (each car has asym ptotic velocity equal to unity). A typical such con guration is show $n$ in $F$ ig. ${ }_{1} 1 \overline{1}(\mathrm{a})$. If in itialized at slightly higher density, the cars are blocked by other cars, until eventually all cars end up participating in one large global jam, where no car can m ove (asym ptotic velocity equal to zero). A typical global jam is shown in Fig. 'II'(b). The transition betw een the tw o behaviors has been thought of as shanp, show ing characteristics of a rst order phase transition. In itialized at much higher densities, sm all jam s begin sim ultaneously throughout the lattice and $m$ erge alm ost im $m$ ediately $w$ ith other sm all jam $s$, leaving all carsblocked (w ith allvelocities equal to zero). In this high density phase, the system has no tim e to self organize, and instead of one global jam, we observe a collection ofsm all random jam s . This latter type of jam has been com pared to tra c in a large city during \rush hour": a carm ight escape one jam, only to quickly join the tail of the next. W e expect that for an in nite size system, the fully jam $m$ ed state resem bles this random type of jam.
M ost of the understanding of the BM L m odel has com e from num erical sim ulations $T$ heoretical analysis has been lim ted to $m$ ean eld approaches $\overline{1} 1$ hydrodynam ic equations and form ulate an equivalent discrete $m$ odel[ $[1]$. T here are generalbeliefs about this $m$ odel, that the transition is rst order and that the critical density, $c$, decreases $w$ ith increasing system size, possibly
reaching the value ${ }_{c}=0$ as the system size approaches in nite[ill ${ }^{[1]}$. The BM $L$ m odel has been sim ulated extensively, but there are inconsistencies in the literature and lack of detail of num erical im plem entations (such as the size of the ensem ble being averaged over). D etails of num erical studies have been published only for sm all system s, on the order of $=1050[7$


D espite extensive num erical sim ulation, the existence of stable interm ediate phases (w ith $0<v<1$ ) has not been explicitly reported previously. Fukui and Ishibashitid do show evidence of the existence of an interm ediate phase in one plot. T hey note that for interm ediate values of,$v \backslash$ uctuates around a certain value for a long tim $e^{\prime \prime}$. T he value show $n$ in their plot is extrem ely close to the values we observe (plotted in Sec. 'ITI). A side from this com $m$ ent, they do not pursue the issue further. A careful study by $T$ orok and $K$ ertesz [1] $]_{1}^{1}$ ] contains precise details of their num erical sim ulations. They are study ing a variant ofBM L w ith faster convergence tim es (called the green wavem odel). Since it is not possible to theoretically predict the convergence tim e, they estim ate it, and apply the follow ing, very reasonable, em pirical heuristic. If a realization has not reached a state, with v 0 or v 1 , within an allotted tim e (taken to be 5 tim es the estim ated convergence tim e), that realization is discarded. W e can only assum e som e of the studies of the BM L m odelm ay have used a sim ilar criteria of discarding \non-converged" states. N ote that for continuum m odels, interm ediate phases of jam $m$ ed wavefronts $m$ oving through otherw ise freely ow ing tra chave been reported. See for instance $R$ ef. [18].
 dilute lim it (! 0), and show that di erent results are obtained for an \entangled" torus versus a conventional one. $T$ hey raise interesting questions about how to get at the bulk properties using only nite size sim ulations, but do not quantify nor pursue the e ects further. C hau, $W$ an, and $Y$ an 1 boundary conditions ( BCs ) ( m eaning, particles $m$ oving o the right (top) edge reappear at som e random ly selected site on the left (bottom) edge). They claim v>0 whenever < 1 , and hence dism iss such system sas being \not very interesting". They also note that the velocity and critical density depend sensitively on the choige of BC s, but they also do not pursue the e ects further.

## III. SIM ULATION RESULTS

$W$ e im plem ent the BM L m odel on square lattioes of nite size $L \quad L$, for a range of sizes and varying aspect ratios. For square aspect ratios (i.e., $L=L^{0}$ ), the lengths studied range from $L=64$ to $L=512 . W$ e also study rectangu lar aspect ratios w here the $w$ idth, $L$, is an integerm ultiple of the height, $L{ }^{0}$, and where $L$ and $L^{0}$ are relatively prime. On each lattice, we im plem ent a range of densities, studying at least ten realizations for each density. A 11 sim ulations are im plem ented on a special purpose cellular autom ata m achine, the CAM 8[1]. T he CAM 8 perform s approxim ately one-billion site updates per second, com parable to a m odem high-perform ance desktop com puter. T he $m$ ain advantage of the CAM 8 is that it allows for excellent visualization of the system, with no overhead in the rendering, giving us live video output of the dynam ics of the system. A s discussed in Sec. 'īV-1, visualizing the kinetic pathw ay gives crucial insight into the form ation of the interm ediate states.
$T$ he $m$ ain subtlety involved $w$ ith sim ulating this $m$ odel is determ ining the convergence time (i.e., the time is takes to reach the asym ptotic behavior). A ll realizations were sim ulated until converged ( $\mathrm{v}=0, \mathrm{v}=1$, or the periodic lim it cycle was reached) or for tim es out to at least $t=210^{6}$ tim e steps. O fthe realizations that had not yet converged, $m$ any were sim ulated for orders ofm agnitude beyond. We nd this a reasonable com prom ise, since the com pute pow er to sim ulate all sam ples to tim es greater than $10^{8}$ is beyond our current capacity. Throughout the rem ainder of the $m$ anuscript, we refer interchangeably to the east-bound cars as $\backslash$ red" and the north $-b$ ound as $\backslash \mathrm{blue}$ ".

## A. Square aspect ratios

For sm all size system s we actually observe the predicted behavior of a sharp transition from freely ow ing to total gridlock. Figure (2la) is for an $L \quad L$ system with $L=64$. It is a plot of the nal average velocity observed for each realization, $v$, versus the density for that particular realization. N ote we are plotting the average velocity for each individual realization, not an average over all realizations intialized with the sam $e$ (hence error bars are on the order of the size of the plotting sym bol used). Surprisingly, when we im plem ent system swith L > 64, we observe a bifurcation where tw o phases start to coexist, as we go from low to interm ediate values of . The second phase that em erges has average velocity $v \quad 2=3$, as show $n$ in $F$ ig. (Zַ). In addition, these interm ediate states have a very well de ned geom etry, of bands of red stripes with slope one-half, criss-crossing bands ofblue stripes w ith slope two. An exam ple of the geom etry is show $n$ in $F$ ig. ( $\overline{\mathrm{G}})$. Jam m ed wavefronts are located at the intersections of the bands, and, as the system $s$ evolves in $\operatorname{tim} e, m$ ove as solid structures uniform ly dow $n$ tow ards the southw est with unit velocity.

$P$ articles are freed from the head of each jam, but a like num ber of new jam $m$ ed particles aggregate at the tail. As discussed in detail below, the underlying lattioe im poses constraints on the allow ed topologies of the con gurations. In Sec. 'I'V', we derive a sim ple form ulation of the constraints.

A $l l$ realizations contributing to $F$ ig. (1) w ere sim ulated to at least $t=210^{6}$ full updates of the entire space, w ith various realizations sim ulated for $t>10^{8}$. W e do occasionally observe a realization persist in the $v \quad 2=3$ state for orders ofm agnitude, then suddenly jum $p$ to either $v=0$ orv $=1$, $w$ th the latterbeing $m$ ore com $m$ on. Regardless, the interm ediate state is at least $m$ etastable, persisting for longer than we could sim ulate $m$ ost realizations. Furtherm ore it is \universal" in the sense that the value of $v \quad 2=3$ is independent of system size and density, and all system sthat do not go to $\mathrm{v}=0$ or $\mathrm{v}=1$ go to the sam e interm ediate state (i.e., sam e geom etric structure and approxim ate value of $v$ ). The reason we do not average over the individual realizations, is that it would obscure the behavior. Instead of displaying the three distinct quantized states, averaging w ould produce a deceitfully sm oothly decaying curve.

From our data, it is di cult to determ ine the exact bifurcation point where the phases begin to coexist, and the point where they cease to. W e attem pted to identify the factors that distinguished realizationswhich converge to $\mathrm{v}=0$ from those, w th the sam e density, that converge to $\mathrm{v} \quad 2=3$. W e rst investigated connections to anisotropy, such as an im balance betw een the total num ber of red versus blue particles. But we found no correlation. The probability a realization would jam or go to the interm ediate state is independent of this asym $m$ etry. W e also looked at a m ore ne-grained $m$ easure: the line density of red particles versus the blue. A gain we found no correlation betw een this asym $m$ etry and the likelihood of jam $m$ ing.

In Sec. 'IV'I we discuss the kinetic m echanism observed, which gives rise to the interleaved band structure exhibited by the interm ediate states. A s m entioned above, the jam interface m oves ballistically, w ith unit speed, tow ards the southw est. The width of the jam interface can uctuate. It seem $s$ for the $L=64$ system, the uctuations are large enough that eventually the head of one jam $m$ eets the tail of the previous, continuing until eventually one global jam form s . K inetic m echanism s aside, it could be that the convergence tim es for $\mathrm{L}=64$ are short enough that the interm ediate state cannot be considered $m$ etastable. $F$ ig. ( $\overline{4} \underline{I}^{1}$ ) show $s$ the $m$ edian convergence tim es observed for the

system s w ith square aspect ratios. N ote that the a value of $t=2 \quad 10^{6}$ really m eans $\mathrm{t}>210^{6}$.

## B . R ectangular aspect ratios

W e also im plem ent the BM L m odel on system s with varying rectangular aspect ratios. In particular we study lattioes where the tw o lattice lengths are subsequent $F$ ibonacci num bers. $F$ igure ( 5 show $n$ in $F$ ig. $(\bar{Z})$ ), for a system $w$ ith $L=89$ and $L^{0}=55$. N ote we see the sam e interm ediate velocity of $v \quad 2=3$, but we also see the em ergence of one $m$ ore possible phase $w$ th $v \quad 2=5$. A ll the con gurations $w$ th $v \quad 2=3$ resem ble the one show $n$ in $F$ ig. (Stb), w ith one red band w rapping around the $\hat{x}$-axis, and three blue bands. The jam points are at

the intersections of the bands. N ote the crisp, regular geom etry. Figure ( $\overline{\mathrm{B}} \mathrm{b}$ ) is for an equivalent, but larger, system w ith the sam e Fibonnaci aspect ratio but with $L=377$ and $L^{0}=233$. This gure $m$ ore clearly ilhustrates the highly ordered geom etry. It also includes the de nitions of several of the param eters used in the analysis in the subsequent sections. A 11 realizations w ith $v \quad 2=5$ resem ble the one shown in $F$ ig. ( $15 \mathrm{~F}, \mathrm{c})$, w ith one red band and approxim ately tw 0 blue bands (though the latter are not so clearly de ned).

O ne of the $m$ ost striking di erences when com paring these rectangular aspect ratios to the square, is that for the rectangular, the interm ediate con gurations are exactly periodic $w$ ith a short recurrence tim e: the exact m icroscopic con guration of particles repeats every updates. We observe system $s$ of size $L=89$ and $L^{0}=55$, settling into the periodic behavior typically in a time less than $t$ 100;000 updates, with a period on the order of 6000 updates. $F$ igure ' $\bar{G}$ is a plot illustrating such typical behavior. A nother striking di erence, is that not one realization

has jam $m$ ed fully ( $v=0$ ), despite the fact that the largest density sim ulated is $=0: 45$. N ote that for the square aspect ratios, the bifurcation point where the phases cease to coexist is at $0: 40$. A nother striking di erence is the lack of disorder for the relatively prim e system $s w$ ith rectangular aspect ratios. In $F$ ig. (laka) there are isolated particles (\dislocations") moving in the area betw een the bands. H ow ever for the rectangular case, all the particles $m$ anage to join the ordered bands.

## IV. GEOMETRICCONSDERATIONS

A. K inetic pathw ays

By watching the dynam icalevolution of the system, starting from the initialcon guration, the m echanism by which the interm ediate phases form can be observed. O ften one global jam initially begins to form, yet the head of the jam just fails to $m$ eet up $w$ th the tail, leaving a few lattice sites of distance betw een them. P articles shed from the head as soon as allow ed by the local environm ent (since all particles move whenever possible), leaving w ith a well de ned order. See Ref. [2d], for video im ages of the dynam ical evolution.

To understand the pattem form ed by the shedding, consider rst one row of a solid isolated block of red particles. Since the particles only advance provided the site they wish to occupy is em pty, a particle would leave the head of the jam only every other tim estep. H ow ever, we can now consider a diagonal interface form ed by a triangular block of red particles in contact with a triangular block of blue particles. See Fig. (7 $\bar{\prime}$ ) . N ote red (eastbound) particles are represented by $\backslash x$ " and blue (northbound) particles by $\backslash \circ$ ". E ach subsequent tim e step illustrated corresponds to one com plete update of the space (i.e., one north-step follow ed by one east-step). Recall, all particles of the sam e species update synchronously. Step 1: N o \o's" are able to move. But, during the east-phase of the tim estep, the rst $\backslash \mathrm{x}$ " $m$ oves away from the jam, opening up a space. Step 2: The rst $\backslash o$ " advances. This blocks all other $\backslash x$ 's" in the original row, yet opens up a space for an $\backslash x "$, one site from the original $\backslash x "$ along the southw est diagonal, to advance. $T$ he original $\backslash x "$ to $m$ ove, also continues advancing. Step 3: That rst $\backslash o "$ continues advancing and opens up a space for an $\backslash x$ " in the original row to advance| two tim e steps delayed from the rst $\backslash x$ " to $m$ ove in that row. The lo" below this original \o" is currently blocked. H ow ever an \o" one site from the original along the southw est diagonal is now free to advance. N ote this $\backslash o "$ blocks the $\backslash x$ " in its new ly occupied row from advancing, yet opens up a space for the $\backslash x$ " one row southw ard to advance. H ence a pattem em erges: a red particle sheds from with in the sam e row only every third tim estep, yet from a site further southw est every tim estep, yielding red bands of density $r=1=3$ $w$ ith slope $s_{r}=1=2$. Likew ise for the blue particles, a blue particle sheds from $w$ ithin the sam ecolum $n$ only every third tim estep, yet from a successive site along the southw est every tim estep, yielding blue bands of density $b=1=3$ $w$ ith slope $s_{b}=2$. The jam s occur at the intersections of the bands, and the interface of a jam has slope s. Typically, $s=1$. In $F$ ig. ( 7 (1) ) one can see the order beginning to em erge.
$M$ ore ilhum inating is to view a closeup near the jam $m$ ed regions. $F$ ig. $(\bar{q})$ is a zoom ed in view of the region near one

In this region there are altemating diagonal stripes of blue, red, and em pty. $T$ he stripes have \phase locked"| on the next update the blue stripes $m$ ove into the em pty stripe regions, leaving room for the red stripes to m ove on the subsequent update, and so on . H ence the system has organized itself into the highest density packing that still allow $s$ all particles to $m$ ove $w$ ith $v=1$.

## B. $W$ inding num ber

Since the system lives on a torus, the bands m ust wrap seam lessly around it. N oting these facts, we can develop a $m$ athem atical expression for the num ber of red bands, $!_{r}$ and the num ber of blue, $!_{b}$, (referred to respectively as the \w inding" num ber for red and blue), that $m$ ust be present. Essentially, we can calculate the length of the regions of slope $-1=2$, slope-s, and slope-2 that $m$ ust be present for the bands to w rap around the torus. (T he slopes are respectively those of the red band, the interface, and the blue band). C onsider an $L \quad L^{0}$ lattice, and a red band starting in the low er left hand comer. M oving out along the $\hat{x}$-direction, there are $k$ sites $w$ ith slope- $1=2$ and $\mathrm{k}^{0}$ sites w ith slope-s. Sim ilarly for a blue band starting in the low er left hand comer, there are $m$ sites $w$ ith slope- 2 and $\mathrm{m}^{0}$ sites $w$ ith slope-s. T he constraints are:

where, due to the lattice, $f k ; k^{0} ; m ; m{ }^{0} g$ are positive integers, and $f!_{r} ;!{ }_{\mathrm{b}} \mathrm{g}$ are either positive integers or equal to $1=\mathrm{g}$, where $g$ is a positive integer (e.g., for the con guration shownin $F$ ig. (3p), $!_{r}=1=2$ ). The nal equation, Eq. (5) , expresses that the length of the jam interface $m$ ust be the sam efor the red and blue cars. C om bining this system (of ve equations in seven unknow ns), we can solve som e com bination of variables in term $s$ of the others. Solving rst for $k^{0}$ :

U sing this, we can solve for $!_{b}$ in term $S$ of $!_{r}, S, L$, and $L^{0}$, and obtain:

$K$ now ing that the interface slopes 1 , we can tabulate the allow ed values of $!_{r}$ and $!_{b}$ in term sof the aspect ratio of the space, $L=L^{0}$. The allow ed values for various aspect ratios are listed in Table in . N ote, the value $!_{r}=1=2 \mathrm{~m}$ eans the red band has only reached height $\mathrm{I}^{0}=2$ in traversing distance $L$ (as in $F$ ig. (了ైa) ) . We im plem ent system $s w$ ith the various aspect ratios show in Table ${ }_{i}^{1} 1$, and $n d$ the experim ental con gurations observed all $m$ atch the predicted
 em pirically the values of $!_{r}$ and $!_{b}$, and using Eq. ( $\underline{1}_{1}$ ) can predict the value of $s$. Recall $!_{r}$ and $!_{b} m$ ust be integers. $T$ he system seem $s$ fo tune the value of $s$ to allow $s$ this. For instance, if $L$ and $L^{0}$ are successive $F$ ibonacci num bers (i.e., $\mathrm{L}=\mathrm{L}^{0}=(1+\overline{5})=2$ ), a rearrangem ent of Eq . (TTi) predicts $\mathrm{s}=1: 17$, which m atches our em pirical observations. $N$ ote in F ig. ( $\overline{\mathrm{s}} \mathrm{b}$ ) , the upper jam has sm all glitches where $s>1$.

> C. A verage velocity
 label on the gure the lengths $\mathrm{a}, \mathrm{b}, \mathrm{c}$, and d , denoting respectively the w idth of the red band, the blue band, the blue jam and the red jam. W e de ne two discontinuous functions which will sim plify notation later on:

Recall is the overall particle density (red plus blue). Em pirically we determ ined that a $=\frac{b}{}=1=3$, which is a
 of the \typical" geom etry, we can solve for the velocity of the interm ediate state. U nfortunately, we have to consider the square and rectangular aspect ratios independently, and do not have one equation that describes all cases. T he assum ptions described above are valid for the rectangular aspect ratios, but fail to capture the fiull behavior of the square ones.

## 1. Rectangular aspect ratios, type I:

C on gurations such as the one show $n$ in $F$ ig. ( $\bar{W}_{1}$ ) have a regular, highly structured, geom etry that is w ell described by the form alism in Sec. 'IV B1. We nd that the values of $\mathrm{k}^{0}$ predicted by Eq. ${ }^{\mathbf{G}} \mathrm{G}$ exactly m atch those obtained experim entally. Typically there are $n_{j}$ jam $s$, w ith the particles equally divided am ongst them. The interface $w$ idth per jam is $k_{i}^{0}=k^{0}=n_{k}$, where $n_{k}$ is the total num ber of jam $s$ one red band is involved in, as it w raps once around the $\hat{x}$-axis. See Fig. (Bुa), for exam ple, where $n_{k} \quad 2$, and $n_{j}=3$.
$T$ he structure of the jam $s$ and the relevant geom etric factors are show $n$ in F ig. "1 1 d (a). The jam s form trapezoidal shapes of $w i d t h$. From simple geom etric considerations, we can show that $=l_{i}^{0} \sin (\quad) \quad k_{i}^{0}$. The jam width per line, $d$, and per colum $n, c$ is

For the data plotted in Fig. $\underline{1}_{1}^{1}, L^{0}$ and $L$ are tw o successive $F$ ibonacci num bers, hence $L=L^{0}=\left(1+{ }^{\mathrm{P}} \overline{5}\right)=2 \quad \mathrm{~F}$. In agreem ent $w$ ith expected values show $n$ in Table $l_{1}^{l}!_{r}=1_{\text {。 }}$ (thus ${ }_{r}\left(!_{r}\right)=1$ ), and $!_{b}=3$ (thus $\quad b\left(!_{b}\right)=3$ ). For this geom etry, $n_{j}=n_{k}=2$. Plugging in these values into Eq.1G,

$N$ ote, this is independent of and independent of $L$ and $L^{0}$. This predicted value for $v_{r 1}$ is included in the plot of the experim entally determ ined velocities, shown in $F$ ig. $\bar{W}_{1}$. N ote the calculated value slightly underestim ates the num ber of particles involved in the jam (hence slightly overestim ates $\mathrm{v}_{\mathrm{r} 1}$ ).

## 2. Rectangular aspect ratios, type II:

A $s m$ entioned, rectangular lattioes are well described by the form alism in Sec. 'IV1. W e observe the \rich" jam described above, but also a second type of \depleted" jam (not enough particles). Em pirically, all observations of th is type have $s \quad 2=3$, and one large jam. See for instance $F$ ig. ( ${ }_{5} \mathrm{c}$ c). The per row and per colum $n$ width of the jam $s$ are the $m$ axim um, $d_{m}$ ax and $c_{m}$ ax respectively, since $k^{0}$ is greater than the num ber of particles available in a row or colum $n$. A jam interface of length $k^{0}$ and slope $s$ ( $w$ ith $s>1$ ) involves $k^{0}$ colum ns, but only $s^{0}{ }^{0}$ row $s$. H ence the total num ber of particles involved in the jam s:

W e include this predicted value in the plot of F ig. $\overline{\text { I'IT }}$. $N$ ote the agreem ent $w$ ith the experim ental data.

## 3. Square aspect ratios:

The typicalgeom etry of an interm ediate state for a square lattice is show $n$ in $F$ ig. (żaa). T he interfaces and especially the edges of the bands are disordered and jagged. The slope assum ptions only hold approxim ately: $\mathrm{s}_{\mathrm{r}} \quad 1=2$ and sb 2. Furthem ore, there are several particles $m$ oving freely in the low density regions, unlike for the rectangular
lattices, where all particles eventually order into the bands and jam s. A lso unlike for the rectangular lattioes (see for instance $F$ ig. ( $\overline{\sin } \mathrm{i})$ )), the red and blue bands cross through each other w thout the pronounced shifting upw ards.

W e cannot use the form alism developed above in Sec.'IV. Bor this situation, since that form alism is based solely on geom etric constraints of $w$ inding seam lessly around the lattice. A con guration on a square lattice $w$ ith $s_{r}=1=2$, $\mathrm{s}_{\mathrm{b}}=2, \mathrm{~s}=1$, w ould have $\mathrm{w}_{\mathrm{r}}=1=2$. P lugging into Eqn. (iG) we nd the required length of the overall interface, $\mathrm{k}^{0}=0$. Instead, em pirically we nd the blue jam $s$ form a trapezoidal shape of approxim ate length $b$ and height $a=4$. Likew ise the red jam s form a trapezoid of approxim ate length $a$ and width b=4. E ach jam has this shape and there are $n_{j}=3$ jam $s$ altogether (i.e., three distinct intersections of the bands). The num ber of particles involved in jam $s, J$ is:

$T$ his predicted value $v_{s}$ is included in the plots of $F$ ig. $\overline{1}$ 는. It captures the features of the experim ental data, including the slight decrease in $v_{s} w$ ith increasing.
V. D ISCUSSION

The BM L tra c model is a sim ple model of a jam ming transition $w$ ith self organization. In our study, instead of agreem ent $w$ th conventionalbeliefs, we nd stable interm ediate con gurations $w$ ith phase coexistence of jam $m$ ed and free- ow ing tra c. Such con gurations have not been previously reported in the literature, despite the extensive am ount of past work on the BM L m odel. Furthem ore, these interm ediate con gurations have interesting geom etric and topologicalproperties, w ith di erent behaviors resulting as a consequence ofdi erent aspect ratios of the underlying lattioe. W e develop a form alism, based on geom etric constraints im posed by the lattice, to predict the asym ptotic velocities of the coexisting phases. $V$ isualizing the kinetic pathw ays of the evolving con gurations was a key elem ent in uncovering the existence of the interm ediate phases and, $m$ oreover, their periodic nature on lattioes w ith relatively prim e aspect ratios. The observations described in this m anuscript open up a range of new questions about the BM L m odel.

As mentioned, instead of a phase transition as a function of density, we observe a bifurcation point where the interm ediate states rst begin appearing, and a second bifurcation point, where they com pletely cease to appear. Perhaps $m$ ore interesting than predicting the asym ptotic velocities, would be to calculate the locations of the bifiurcation points. From our experim entaldata, the exact location of the bifurcation points are di cult to determ ine, and $m$ oreover, also depend on the aspect ratio of the underlying lattice.

It is possible that there is a shanp phase transition. H ow ever, in such a case, the density would not be the appropriate order param eter. P erhaps a m ore appropriate order param eter would be an interaction energy betw een north-bound and east-bound particles. N ote that when in the free- ow ing state, the north and east particles have $m$ oved onto non-interacting lattices. It $m$ ay be possible that one can de ne an initial energy based on the overlap or interaction betw een two lattioes, and use that as an order param eter.

A com plication which $m$ akes theoretical treatm ent of the BM L m odel di cult, is that it is not strictly m onotonic. A dding particles to a con guration that is known to jam (i.e., increasing ), can actually change the sequence of particle interactions and result in that con guration going to free- ow ing instead of jam m ing. Furtherm ore, it is known that certain discrete $m$ odels $w$ th the sam e property as BML| nam ely that the random ness is in the in itial condition, yet the dynam ics fully determ inistic| can be notoriously di cult to deal with analytically. Exam ples include bootstrap percolation [21] and the Lorentz lattice gas[22]. We modi ed the BM L m odel to include a sm all probabillity for particles to ip speciestypes at each update. O ur prelim inary studies, adding this sm all am ount of random ness to the dynam ics, suggest that the $m$ odel $w$ ith random ness has extrem ely di erent geom etric properties than the original BM L m odel. In addition, for the $m$ odel $w$ ith random ness, $w e$ did not observe the interm ediate con gurations described herein.
