Superconducting P roperties under M agnetic F ield in N $a_{0:35}$ C oO $_2$ 1:3H $_2$ O Single C rystal

We report the in-plane resistivity and m agnetic susceptibility of the layered cobalt oxide N $a_{0:35}$ C OO $_2$ $1.3H_2O$ single crystal. The tem perature dependence of the resistivity shows m etablic behavior from room tem perature to the superconducting transition tem perature T_c of 4.5~K. Sharp resistive transition, zero resistivity and almost perfect superconducting volume fraction below T_c indicate the good quality and the bulk superconductivity of the single crystal. The upper critical eld H $_{c2}$ and the coherence length are obtained from the resistive transitions in m agnetic eld parallel to the c-axis and the ab-plane. The anisotropy of , $_{ab}/_{c}$ = 12 nm/1.3 nm $^\prime$ 92, suggests that this m aterial is considered to be an anisotropic three dimensional superconductor. In the eld parallel to the ab-plane, H $_{c2}$ seem s to be suppressed to the value of P auli param agnetic lim it. It m ay indicate the spin singlet superconductivity in the cobalt oxide.

The superconductivity in the layered cobalt oxide $Na_{0:35}CoO_2$ 1:340 found by Takada et al¹⁾ has attracted m uch attention. In particular, unconventional superconductivity has been expected in this com pound because of the unique crystal structure in the C oO 2 layer although the superconducting transition tem perature T_c ' 5 K is one order of magnitude smaller than that in H igh- T_c copper oxide superconductors. The C oO 2 layer is form ed by the hexagonal arrangem ent of the Co ions, which is in contrast to the tetragonalarrangem ent of the Cuions in the copper oxides. A de ciency of the sodium atom leads to dope 0.65 holes into the layer of the insulating low spin (S = 0) state of Co^{+3} . This hole doping results in 0.35 electrons doped in the triangular lattice consisting of $S = 1=2 \text{ of } C \text{ o}^{+4}$. Such triangular magnetic lattice is regarded as having magnetic frustration and one may expect that unconventional superconductivity is realized on the basis of such frustration. Then just after nding the superconductivity in the present m aterial, m any theoretical proposals of possible unconventional superconductivity have been presented.2(5) The experin ental investigation on the superconductivity, how ever, has not progressed so much because of di culty of getting the single crystal. It is highly desirable to obtain the basic superconducting parameters in magnetice eld, for example, the upper critical eld H_{c2} , the coherence length , and those an isotropy. These basic material param eters must be important to understand NMR and NQR results reported so $far_{t}^{6,7)}$ which should give crucial inform ation about the pairing sym m etry and the gap anisotropy.

In this letter, the basic superconducting parameters such as H_{c2} , , and those anisotropy of the superconducting cobalt oxide are reported on the basis of the resistivity measurements in the single crystal.

Single crystals of Na_{0:7}CoO₂ used in this study was

grown by oating zone method. The deintercalation of N a and hydration process to obtain the superconductivity is similar way reported by Takada et al.¹⁾ The detail of the sam ple preparation and the characterization will be published elsewhere.⁸⁾ The superconducting crystals were obtained as $Na_{0:35}CoO_2$ 1:3HO. The typical size of the single crystal is 1 0.6 0.02 mm^3 . The inplane resistivity wasm easured by standard dc four probe method. In order to make the electrical contact to the sample, the gold wires (10 m) were attached with silver paste which dried for 30 m inutes at a few C $\,$. The sam ples were xed to the single-axis rotatable holder for resistivity measurements in magnetic elds and cooled quickly below ice point because of avoiding the partial dehydration from the sample.We paid attention to handle the samples in cold condition. For instance, the samples were placed on the alum inum plate cooled by ice during the preparation of the electrical contact under microscope. The magnetic susceptibility was measured with a SQUID magnetometer (Quantum Design MPMS-XL5).




Fig. 1. Tem perature dependence of the in-plane resistivity of $Na_{0:35}CoO_2 1:3H_2O$ single crystal. Filled circle indicates the data point at 290 K. In order to cool the sam ple as rapidly as possible, no data between 250 and 290 K is available. Inset shows the magnetic susceptibility in H = 50000 O e parallel to the c-axis. The sam ple space is purged by helium gas at room tem perature three (upper curve) and sixty tim es (low er curve).

Figure 1 shows the tem perature dependence of the inplane resistivity of the single crystal sample in the cooling process. The absolute value of the in-plane resistivity is somewhat larger than the reported value^{9,10)} of 1 { 2 m on at room temperature. The present resistivity may have an ambiguity because of the irregular shape and easily cleaved nature of the layered crystal.⁸⁾ The data between 250 K and 290 K is lacked due to the quick cooling from room temperature. The resistivity shows m onotonic decrease from 290 K down to T_c . The quality of the single crystal seems to be good considering large residual resistivity ration (290 K)/ (5 K) ' 38. The superconducting transition appears following such m etallic tem perature dependence of the resistivity. Such m etallic behavior in the single crystal sample is dierent from the previous report by Jin et al,⁹ but is sim ilar to another report by Chou et al.¹⁰⁾ although both groups use single

crystals. The form er results have shown a large resistance anom aly around 50 K. The origin of the di erence is not known at present, but the metallic behavior in the inplane resistivity observed by C hou et al. and us seem s to be intrinsic nature because no anom aly in magnetic susceptibility mentioned latter and speci c heat has been reported at the tem perature.⁹⁾

The tem perature dependence of the magnetic susceptibility in another single crystal from the same batch is shown in the inset. A round 45 K, an anom aly appears as a cusp of , which has been reported in the single crystal sample by Chou et al.¹⁰⁾ but has not been observed in the powder sam ple.^{7,9,11)} The origin of the anomaly is likely to be the residual oxygen on the surface or in the intercalated water because the large number of purging the sample space of the magnetom eter by helium gas at room tem perature strongly suppresses the anom aly. The Curie-Weiss like enhancement of at low tem perature is reduced also by such su cient gas exchange. The difference of the Curie-W eiss like enhancem ent by purging appears only below the tem perature of the cusp anom aly. Therefore the anomaly of around 45 K and some part of the Curie-Weiss like enhancement of can be considered to come from the extrinsic origin which is probably due to the residual oxygen. It is noted, how ever, that the Curie-W eiss like enhancem ent becom es rem aining even after su cient num ber of purging. It suggests that som e part of the enhancem ent is free from the residual oxygen and may result from a magnetic uctuation origin.




Fig. 2. Temperature dependence of (a) the in-plane resistivity and (b) the magnetic susceptibility in H = $1.0 \,\mathrm{e}$ in the same single crystal of N a_{0:35} C oO₂ $1.3 \,\mathrm{H}_{2}$ O.V_{M eissner} denotes the full volume of the superconductivity.

Figure 2 dem onstrates the superconducting transition observed by the in-plane resistivity (upper gure) in zero m agnetic eld and the magnetic susceptibility in H = 1O e parallel to the c-axis. Both the resistivity and the m agnetic susceptibility were measured on the same sam – ple. The sam ple after measuring resistivity was transferred to the magnetom eter in keeping the tem perature

cold below ice point as rapidly as possible. The resistive transition starts at about 4.5 K. It shows zero resistivity at 3.9 K, which is smaller than the present experim entalaccuracy, 10 3 of the norm alresistivity value at 5 K . There are small structures seen in the transition curve. It may be due to distribution of T_c inside the crystal which may be caused by the partial dehydration at room tem perature. The magnetic susceptibility which is corrected by the dem agnetization factor using a ellipsoidal approximation decreases below about 4.5 K. The magnitude of the shielding signal in zero magnetic eld cooling (ZFC) indicates alm ost 70 { 80 % of the superconducting fraction to the full volume $V_{M eissner}$ of the crystal although the value has uncertainty coming from the am biguity of the dem agnetization factor of the planer shape of the sam ple. The sharp transition and alm ost full superconducting volum e fraction dem onstrate that the sam ple used here shows the bulk superconductivity and has good enough quality for evaluating the intrinsic superconducting param eters.




Fig. 3. Temperature dependence of the in-plane resistivity under magnetic elds parallel to (a) the c-axis and (b) the ab-plane of $Na_{0.35}CoO_2$ 1:3H₂O single crystal. The inset shows the magnetic eld direction dependence of the resistivity at T = 3.5 K and in H = 1 T. The magnetic eld direction is denoted by the angle tilted from the c-axis to the ab-plane.

Figures 3(a) and 3(b) show the temperature dependence of the in-plane resistivity under magnetic elds parallel to the c-axis and ab-plane, respectively. In order to align the magnetic eld exactly parallel to the ab-plane, the magnetic eld direction dependence of the resistivity is measured. The resistivity takes its minimum in the eld parallel to the ab-plane which is shown in the inset of Fig. 3(b). The in-plane current is always perpendicular to the magnetic eld. The resistivity minimum should show sharp cusp behavior¹²⁾ in the case of the large an isotropy expected from the large $C \circ O_2$ layer spacing expanded by the hydration. The shape of the m in im um, how ever, looks to be rounded. It is not clear at present that the reason of the round shape of the minin um is whether the anisotropy is not so large intrinsi-

cally or some experimental artifacts such as the large m isalignment in setting the sample to single-axis rotator and the possible slight bending in the crystal used. But we notice the gradual decrease of the resistivity can be seen already in the region of 30 degree from the parallel direction. It may indicate that the intrinsic anisotropy is not so large because the artifact origin is not e ective in such angle region.

The resistive transition becomes broad in both magnetic eld directions. Then the certain value of H_{c2} is di cult to be determined from the resistive transition. Here we de ne some characteristic points in the resistive transition curves by using several criteria of the resistivity value. The criteria are 0.9_n , 0.5_n , 0.1_n , and 0.001_n , where $_n$ is the norm al resistivity extrapolated from higher temperature region. In the temperature region above 1.5 K, the temperature dependence of the norm al resistivity is expected to show a T-linear dependence from the data in 2 T (H k c-axis) and 8 T (H k abplane).

Figures 4 (a) and 4 (b) show the magnetic eld -tem -




Fig. 4. Magnetic eld – tem perature 4(B) has and deagram of Na_{0:35}CoO₂ 1:3H₂O in the eld parallel to (a) the c-axis and (b) the ab-plane. The led circle, open triangle, led triangle and open circle denote the points de ned by the resistivity level of 0.9 n, 0.5 n, 0.1 n and 0.001 n, respectively. The dotted and solid curves are guides for eyes. The dashed lines show the initial slope of H_{c2} de ned by = n = 0.9 criterion. H $_{c2}^{WHH}$ (0) and H_p are the upper critical eld estim ated by W HH and the Pauli param agnetic lim it, respectively.

perature phase diagram on the resistive characteristic transition points in the magnetic eld parallel to the caxis and ab-plane, respectively. The led circles, open triangles, lled triangles, and open circles denote the points de ned by the several resistivity criteria of 0.9_{n} , 0.5 n, 0.1 n, and 0.001 n, respectively. The dotted and solid curves corresponding to 0.9 _n and 0.001 _n are guides for eyes. Here we use the resistive criteria 0.9 n and 0.001_n for the upper critical eld H_{c2} and the irreversibility eld H_{irr} in conventional way although such criteria are not sound exactly correct for them odynam ic transitions. The initial slope of H $_{\rm c2}$ (T) at T $_{\rm c}$ shown as the dashed lines are 0:53 and 4:7 T/K in the eld parallel to the c-axis and ab-plane. Theses values of the slope are in agreem ent with the previous reports.^{8,10)} From these initial slopes, the Ginzburg -Landau coherence length can be calculated by using the relation dH $_{c2}^{i}$ =dT j_{c} = $(1=T_c)$ ($_0=2$ $_{jk}$), where

 $_0$ = hc=2e = 2:07 10¹¹ T cm² and i, j, and k are cyclic permutations of the directions. Here we assume the isotropic in the ab-plane, that is i = j = ab and $_{k} = _{c}$. Following the equations the coherence lengths are calculated to be $_{\rm ab}$ ' 12 nm and $_{\rm c}$ ' 1.3 nm . It is noted that the interlayer coherence length _c is longer than the interlayer spacing, about 0.98 nm, of the $C \circ O_2$ layers.¹⁾ A coordingly the anisotropy calculated from is about 92, which may be a lower lim it value of the anisotropy considering the experim ental uncertainty described before. This moderate size of the anisotropy is alm ost comparable to that of the pyridine intercalated transition m etal dicalcogenides (20), ¹³⁾ organics ($10)^{14)}$ and Sr_2RuO_4 ($20)^{12)}$ and is larger than that of the alkali intercalated nitrides (4).15) In comparison with the High-T_c copper oxides, the anisotropy of the present cobalt oxide is located between the value of $Y B_2 C u_3 O_7$ and the La-based cuprates.¹⁶⁾ O nem ay expect larger anisotropy than the observed value because of expanding largely the interlayer spacing between the CoO₂ layers by intercalation of H₂O molecules. But it is much sm aller than that of the Bibased cuprates. The reason m ay be due to longer interlayer coherence length

than the interlayer spacing of the $C \circ O_2$ layers.

The upper critical eld at T = 0 K can be W ertham er-Helfand-Hohenberg estim ated from (WHH) form $u la^{17}$ by using the initial slope, $H_{C2}^{W H H}(0) =$ 0:693 (dH $_{c2}$ = dT \dot{T}_{c}) T_c. The calculated values of H $_{c2}^{W~H~H}$ (0) are about 1.7 T and 15 T in the eld parallel to the c-axis and ab-plane, respectively. In the magnetic eld parallel to the c-axis, the H_{c2}^{c} (T) line looks likely to be pointing to H_{c2}^{WHH} (0). On one hand, $H_{c2}^{ab}(T)$ is strongly suppressed from $H_{c2}^{WHH}(0)$ in the low tem perature region. This suppression m ay arise from the singlet pair breaking by Zeeman e ect, that is so-called C logston-C handrasekhar lim $it^{18,19)}$ or P auli param agnetic lim it. The value of Pauli param agnetic lim it is simply described as $H_P = 1.84T_c$. A coording to $T_c = 4.5 \text{ K}$, H_P ' 8.3 T. As can be seen in Fig. 4(b), the actual H_{c2}^{ab} (T) line seems to be suppressed from H_{c2}^{WHH} (0) to H_{P} . Such suppression by Zeeman e ect may suggest the spin singlet superconductivity in the present cobalt oxide superconductor.

There is large discrepancy on H $_{\rm c2}$ value between the recent report¹¹⁾ in the powder sample and the present results. The magnetization measurements in the powder sample have been used to estimate H $_{\rm c2}$ and the lower critical eld H_{c1} by Sakurai et al.¹¹⁾ They reported huge H $_{\rm c2}^{\rm W~H~H}$ (0) = 61 T evaluated from the initial slope dH $_{\rm c2}$ =dT $\dot{f}_{\rm c}$ = {19.3 T/K at T_c. These value of H $_{\rm c2}^{\rm W~H~H}$ (0) and the initial slope are about four times larger than our results in magnetic elds parallel to the ab-plane. The

In conclusion, we show the upper critical eld and its anisotropy evaluated from the resistivity measurements on the single crystal sample of the layered cobalt oxide $Na_{0:35}CoO_2$ 13HO. The magnitude of the anisotropy and the coherence length in the interlayer direction indicate that this superconductor is classi ed to the anisotropic three dimensional one. The suppression of the upper critical eld to the Pauli limiting value may suggest the spin singlet pairing of the superconductivity of this compound. In order to con rm the present results, lower temperature experiments on the phase diagram must be important because several unconventional features, such as multi superconducting phases, are expected in the unconventional superconductor having a triplet pairing.
