# The trion: tw o electrons plus one hole versus one electron plus one exciton

#### Abstract

We rst show that, for problem s dealing with trions, it is totally hopeless to use the standard $m$ any-body description in term $s$ of electrons and holes and its associated Feynm an diagram s. We then show how, by using the description of a trion as an electron interacting with an exciton, we can obtain the trion absorption through far sim pler diagram $s, w$ ritten $w$ ith electrons and excitons. T hese diagram $s$ are quite novelbecause, for excitions being not exact bosons, we cannot use standard procedures designed to deal $w$ th interacting true ferm ions or true bosons. A new $m$ any-body form alism is necessary to establish the valid ly of these electron-exciton diagram sand to derive their speci crules. It relies on the \com m utation technique" we recently developed to treat interacting close-to-bosons. This technique generates a scattering associated to direct C oulom b processes betw een electrons and excitions and a dim ensionless \scattering" associated to electron exchange inside the electronexciton pairs | this \scattering" being the original part of our many-body theory. It tums out that, although exchange is crucial to di erentiate singlet from triplet trions, th is \scattering" enters the absonption explicitly when the photocreated electron and the initial electron have the sam e spin | i. e., when triplet trions are the only ones created | but not when the two spins are di erent, although triplet trions are also created in this case. The physical reason for this rather surprising result w ill be given.

## 1 Introduction

W hile the physics ofexcitons and electron-hole plasm a has been a sub ject of great interest in the 60's and 70's, the physics of trions [1,2], i. e., excitons bound to an electron or a hole, developed recently only: The exciton being a neutral ob ject, its possible binding to a carrier is indeed quite weak com pared to the binding of an electron to a hole. H ow ever, due to the developm ent of nanostructure technology, it is now possible to experim entally study these trions because, all binding energies being enhanced by the reduction of di$m$ ensionality, trions, not seen in bulk sam ples, can appear as line well below the exciton line in the absorption spectra ofdoped sem ioonductor quantum wells (see for instance ref. [3-9]).

From a theoretical point of view [10-19], the study of these trions still faces major di culties: (i) Being the eigenstates of two electrons and one hole \{ or two holes and one electron \{ in C oulom b interaction, their energies and wave functions are not analytically known, the corresponding three-body H am iltonian having no analytical solution; (ii) because these trions are bound states, there is no way to reach them from a (nite) perturbative approach; (iii) while $m$ any-body procedures have been developed in the 60's to treat interactions between ferm ions (or bosons), we will show that these $m$ any-body procedures are com pletely inappropriate to approach the bound states resulting from the exact sum $m$ ation of all C oulomb processes between $m$ ore than two ferm ions, as in the trion case.

W ith respect to this last point, a good idea can be to bind one electron to the hole in order for the trion to appear as a two-body system : one electron interacting w ith one exciton [18]. H ow ever, since the electrons are indistinguishable, the electron which is bound to the hole to $m$ ake the exciton, is a priori arbitrary. M oreover | and physically linked to this arbitrariness | the exciton is not an exact boson so that standard $m$ anybody procedures, designed to treat interactions betw een exact ferm ions or exact bosons, cannot be used for this interacting electron-exciton system .

In spite of these obvious problem $s$, the description of a trion as an electron interacting w ith an exciton, is physically appealing because it allow s to im m ediately see that, as the exciton is neutral, its attraction is very weak, so that the trion binding has to be much weaker than the exciton binding. It is thus worth to nd a way to cope w ith the di culties
this electron-exciton (e-X ) description raises.
In order to use it, we rst have to identify a quantity corresponding to the electronexciton C oulom b interaction, although, due to the com posite nature of the exciton, there is no way to extract such an interaction from the Coulom b potentialbetween individual carriers. In addition, we m ust nd a way to take care of the electron indistinguishability when constructing the exciton. This indistinguishability som ehow adds novel exchange \scatterings" to the som ew hat norm al electron-exciton C oulomb scatterings, with speci c rules which have to be determ ined and which are the novel part of the diagram s corresponding to electrons interacting $w$ ith excitons.

This paper in fact deals w ith the sim plest possible problem on trions, nam ely the absonption of one photon in the presence of one carrier. T he photon creating one electronhole (e-h) pair, wew ill rst consider it in the fram ew ork of a tw o electron-one hole system, and show that the corresponding response function, w rilten with standard electron and hole diagram $s$, is so com plicated that there is no hope to identify and sum up the processes responsible for the trion bound states.

W e will then show that this response function appears extrem ely sim ply if we bind one electron to the hole and have this exciton scattered by its interactions with the additional electron. T he spin conservation of the sem iconductor-photon interaction leads to di erentiate absorption in which the photocreated electron and the initialelectron have di erent spins, from absorption in which the two spins are identical. We w ill show that electron exchange enters the photon absonption explicitly in this last case only, i. e., when triplet trions are the only ones created, in spite of the fact that triplet trions can also be created w hen the tw o electrons have di erent spins. W e w ill establish the rules for these electron-exciton diagram $s$, using our com m utation technique for an exciton interacting w th electrons [18]. It allow s to calculate the response function to a photon eld at any order in the electron-exciton interaction, while form ally keeping the com posite nature of the exciton, i. e., the fact that the exciton can be m ade w ith any of the tw o electrons.

This rst paper allows to establish the problem of one exciton interacting with one electron on a $m$ basis, in order to possibly face a m uch harder one, nam ely one exciton interacting w ith N electrons, as for the photon absonption in the presence of a Ferm isea [11,14]. Such an absonption has been considered long ago by C om bescot and N ozieres [20].

In this work, the spin degree of freedom of the electrons has been dropped from the rst line aswellas the electron-electron (e-e) repulsion. W hile the rst sim pli cation physically corresponds to have one kind of spin only in the problem | as for a photon absorbed by a quantum well having a ( $+1=2$ ) polarized Ferm isea so that ( $S_{z}=1$ ) triplet trions are the only ones possibly form ed | , the second simpli cation is dram atic: O nce it is $m$ ade, the trion physics is irretrievably lost. Indeed, the e-e repulsion partly com pensates the eh attraction, $m$ aking the trion binding energy much weaker than the excition one, whatever the electron spins.

Let us stress that this cruciale ect of the e-e interaction cannot be included through a na ve screening of the e-h attraction, as suggested by $H$ aw rylak in his 2D extension [11] of C om bescot-N ozieres's work. Indeed, such a screening in the sam e way reduces the e-h attraction responsible for the exciton binding, so that the trion binding energy this procedure generates, is weak but equal to the exciton one, not sm aller as it should. This screening procedure in fact generates one electron energy level, not two, this level being possibly occupied by two electrons if their spins are di erent. This procedure thus $m$ isses the whole physics of the trion, with an electron very weakly bound, com pared to the other.

In order to nd a trion with a binding energy $m$ uch weaker than the exciton one, we m ust inchude the e-e interaction independently from any eh process, not just through a screening of this eh attraction. The trouble is that, w thin the $m$ any-body procedures at hand up to now, there is no hope to add this e-e repulsion to the set of already com plicated processes which, sum $m$ ed up to all orders, give rise to the so called $\backslash$ Ferm iedge singularities". In this paper, we explicitly show that the Feynm an diagram S , w ritten w th electrons and holes, are already inappropriate to describe the three-body problem corresponding to just one trion. A new $m$ any-body form alism is thus highly necessary if we want to properly describe the trion absorption change w ith doping observed experim entally. Its presentation is in fact the underlying punpose of this work, with a particular attention paid to the interplay between the som ew hat nom al e-X direct C oulom.b scattering and the farm ore subtle electron exchange inside the e-X pair.

The paper is organized as follow $s$ :
In section 2, we brie y recall the usualprocedure to calculate photon absonption and we
try to calculate it in the case of trion form ation, using the standard $m$ any-body procedure which leads to expand it through the well known electron-hole Feynm an diagram s . We show that, even in the sim plest case of a photon creating an electron $w$ ith a spin di erent from the spin of the initial electron, the sum $m$ ation of these diagram $s w$ ith all possible C oulom b processes between two electrons and one hole, is totally hopeless.

In section 3, we reconsider our description of a trion as an electron interacting w ith an exciton. The derivations given here of som e im portant results on this description in term sofe-X pairs, arem ore direct than the som ew hat pedestrian ones we gave in previous works [17,18]: O nce a result is m athem atically established and physically understood, it becom es easy to nd \straightforw ard " derivations and enlightening links...

In section 4, we calculate the trion response function in term sof these interacting e-X pairs. $W$ e show that it appears as a sum ofe-X ladder diagram $S, w$ th possibly one | but no m ore than one | electron exchange between eand $X$, if $\mid$ and only if $\mid$ the spins of the photocreated electron and the initialelectron are the sam e. T his can be surprising at rst since, at each e-X scattering, the exciton can a priori be constructed with any of the two electrons, whatever their spins are.

## 2 The trion as tw o electrons plus one hole

A quite direct way to reach the trion is to look at the photon absonption when the sem ioonductor has one electron already present in the sam ple. Let us rst brie y recall how photon absorption is usually calculated and how it appears in the case of exciton form ation, since its com parison w th trion is quite enlightening.

### 2.1 Standard procedure to calculate photon absorption

The linear absonption of a photon eld is given by the Ferm igolden rule,

as easy to show by inserting the closure relation for the $\hat{H}$ eigenstates, $F$ i, in front of W ${ }^{\text {Y }}$.
$\hat{H}$ is the $H$ am iltonian of the uncoupled $m$ atter-photon system, $\hat{H}=H+!_{p}{ }^{y}$, with H being the $m$ atter $H$ am iltonian and ${ }^{y}$ the creation operator of ( ${ }_{p} ; Q_{p}$ ) photons. The coupling $W$ ${ }^{\mathrm{y}}$ betw een the photon eld and the $m$ atter physically corresponds to annihilate one photon while creating one electron-hole pair, $W^{\mathrm{y}}=\mathrm{U}^{\mathrm{Y}}$. For circularly polarized photons ( ) absorbed in quantum wells, $m$ om entum conservation allows to write $U^{y}$ in term s of free electrons and holes as

### 2.2 Photon absorption with exciton form ation, using electronhole diagram s

For + photons absorbed in an em pty quantum well, the response function given in eq. (2.4) reads, due to eq. (2.3),

### 2.3 P hoton absorption w ith trion form ation, using electron-hole diagram s

For the X trion to be form ed, the sem ioonductor in itial state $m$ ust have one electron. If $k_{i}$ and $s_{i}$ are its $m$ om entum and spin, this initial state reads $\ddot{\mu} i=a_{k_{i} ; s_{i}}^{Y} j \dot{j},^{\prime} w$ th $E_{i}={ }_{k_{i}}^{(e)}$. W e then note that, while the photon polarization is unim portant when the sem iconductor is em pty, it is cnucial when it already has electrons: Indeed, in a quantum well, if the spins of the photocreated electron and the initialelectrons are di erent, the hole can only recombine w ith the photocreated electron, while it can recombine with any of them if their spins are identical. C onsequently, the response functions di er if the electron spins are identical or not. Let us start w th the sim plest case.

### 2.3.1 Photocreated electron with sp in di erent from the in itial one

This happens when $a+$ photon is absorbed in a quantum well having a $s_{i}=+1=2$ electron. The zero order term of the response function appears, using eqs. (2.3,2.4), as

W e readily nd that $S_{\%}^{(0)}$ reduces to the exciton zero order response function $S_{x}^{(0)}$, so that it corresponds to the diagram of $g$. (1a). If we now tum to the rst order term, it is given by
where $V$ is the C oulomb potential given in eq. (2.8). As this C oulomb potential only contains $q \in 0$ excitations, the above $m$ atrix elem ent di ers from 0 for $p^{0}=p+q$ only: This rst order term is thus equal to $S_{x}^{(1)}$ and corresponds to the ladder diagram of $g$. (1b).

The higher order term s are not as sim ple: W hen m ore than one C oulom b excitation take place, in addition to processes in which the photocreated electron is scattered several tim es by the hole, other processes involving the initial electron becom e possible: In
addition to the exciton ladder diagram $s$ show $n$ in $g$. (1c) at second order in $V$ and in $g$. (1d) at third order, we also have the 4 diagram s of $g$. (2) at second order in $V$ and the 20 diagram s of $g$. (3) at third order. N ote that, since the ( $+1=2$ ) electron band has one electron only, these diagram s have one conduction-hole line only, w ithout any possible scattering, i.e., one electron line only going backw ard, from left to right.

A s the X trion corresponds to the bound state of two electrons and one hole resulting from their C oulom b interaction, it is necessary to take the C oulom b potentialexactly into account i.e., to include it at all orders, to possibly generate the bound state poles in the response function. In view of the third order processes shown in $g$. (3), it is obviously hopeless to w rite down the diagram s corresponding to all possible C oulom b interactions at any order in $V$ and to sum them up to get the trion.

### 2.3.2 P hotocreated electron w ith spin identical to the in itial one

T he situation is w orse when the photocreated electron has the spin of the initialelectron, because the hole can now recom bine w th any of the two electrons. $W$ hile the zero order term, given in eq. (2.14), w th $a_{k_{1} \text {; }}^{y}$ replaced by $a_{k_{i} ;}^{y}$, stays essentially unchanged, $p$ being just di erent from $k_{i} \quad e_{\mathrm{p}}$, new diagram $\mathrm{s} w$ ith exchange processes betw een the two electrons appear at higher orders. From eq. (2.15) w ith $a_{k_{i} ;+}^{y}$ replaced by $a_{k_{i} ;}^{y}$, it is easy to see that, beside $p^{0}=p+q$ which gives the rst order ladder diagram of $g$. (1b), we can also have $p=p^{0}=k_{i} \quad q$ which gives the rst order exchange diagram show $n$ in $g$. (4a). In a sim ilar way, beside the second order direct diagram $s$ already contained in $S_{\xi}^{(2)}$, we also have the six diagram sof $g$. (4b) which result from exchange processes between the photocreated electron and the initialelectron; and so on...

C onsequently, the response function for photocreated and initial electron having the sam e spin, is even $m$ ore com plicated than the one for di erent spins: $T$ his leads us to conclude that the representation of a trion as tw o electrons plus one hole, and its associated standard electron-hole Feynm an diagram $s$, are com pletely inappropriate.

We are now going to show that the description of a trion as an electron interacting w ith an exciton is farbetter. For that, let us rst recall the $m$ ain steps of the $m$ any-body procedure on which it is based and which allow s an exact treatm ent of the tridky part of this description, nam ely the electron indistinguishability. This procedure ultim ately leads
to represent the trion through novel electron-exciton diagram $s$, w ith quite speci c rules for the new \scattering" com ing from pure exchange, i. e., exchange w thout C oulomb, not easy to guess at rst.

## 3 The trion as one electron plus one exciton

By considering the trion as an electron interacting w ith an exciton, we tend to put the trion and the exciton on equal footing | w ith the hole of the exciton just replaced by an exciton. $T$ his is actually quitem isleading because, due to the electron indistinguishability, the trion is de nitely farm ore subtle than the exciton. In order to grasp the deep di erences which exist between them, it appears to us useful to rst recall a few well known results on exciton. In doing so, we will settle som e im portant notations, also useful for trion.

### 3.1 A few results on exciton

### 3.1.1 $F$ irst quantization

The exciton can be seen as a two-body ob ject, $m$ ade of one electron ( $m e ; r_{e}$ ) and one hole $\left(m_{h} ; r_{h}\right)$. Ifwe extract its center ofm ass, characterized by

### 3.1.2 Second quantization

In second quantization, the sem ioonductor H am iltonian (which has the sam e form whatever the num ber of electrons and holes), is given by eqs. (2.7-8). ### 3.2 Trion in rst quantization

The trion is a threebody object (two electrons and one hole) or (tw o holes and one electron). To sim plify the notations, we will here consider the tw o-electron-one-hole case only.

A rst di culty with trions, com pared to excitons, arises from the spin variables. They are unim portant for excitons if we neglect \electron-hole exchange", i. e., valenceconduction Coulombexcitations, their energies being then degenerate with respect to ( $s ; m$ ). On the opposite, the spin variables are crucial for trions because they di erenciate their possible states through the parity of the onbital part of the $w$ ave functions $w$ ith respect to the electron positions. Indeed, this parity is directly linked to the trion total electronic spin: A s singlet states are odd while triplet states are even, their associate onbitalw ave functions m ust be even and odd respectively, due to the sym m etry principle for the whole wave function of ferm ions.

A nother di culty, less obvious at rst, com es from the appropriate variables to describe the trion. The center ofm ass $\left(M_{T} ; R_{T}\right)$ is surely one of these appropriate variables. For two electrons ( $m_{e} ; r_{e} \boldsymbol{i} r_{e^{0}}$ ) and one hole $\left(m_{h} ; r_{h}\right)$, it reads

A though som ew hat $m$ ore com plicated due to the im portance of spins for trions, these equations are the analogues of eq. (3.8) relating free e-h pairs to excitons.

### 3.4 M any-body e ects betw een electrons and excitons

In usualm any-body problem $s$, the H am iltonian splits as $\mathrm{H}=\mathrm{H}_{0}+\mathrm{V}$, so that the m anybody e ects result from eq. (2.5) and its iteration (2.6). In the case ofm any-body e ects w ith excitons, such a separation of the H am iltonian is not possible, due to the com posite nature of the exciton. Attem pts have been $m$ ade to produce a potential $V_{x} x$ between excitons by bosonizing them. H ow ever, quite recently, we have shown that these procedures, although rather sophisticated, fail to give the correct answ er to physical quantities such as the exciton lifetim e and the exciton-exciton scattering rate [25], whatever the $X-X$ scattering used in $V_{x x}$ is. $W$ e have also show $n$ that they fail to give the correct nonlinear susceptibilities [26], because they $m$ iss purely Pauli many-body e ects, i. e., scattering processes which exist in the absence of any C oulom b interaction. This is why we will not here use the bosonization procedures to describe the interaction of one electron w ith one exciton.

Let us stress that the sum $m$ ation of e-X ladder processes has rst been established from a quite form al procedure designed to treat electrons interacting with excitons. It can a priori be used in any other problem dealing w ith electrons and excitons, not just in the case of one electron plus one exciton, i. e., one trion. It is how ever clear that we can also use it in this simple problem too, for which a form ulation in rst quantization through the trion $H$ am iltonian $H_{T}\left(R_{T} ; r ; u\right)$ is sim ple enough to be ofpracticaluse. This rst quantization form ulation of the onetrion problem actually provides enlightening foreshortenings to som e results on e-X pairs. In m ore com plicated situations how ever, second quantization along w ith the form alde nitions of the direct C oulom b and exchange scatterings between electrons and excitons it allow $S$, are the only possible way to treat problem s dealing $w$ th one hole and $m$ ore than tw o electrons. T he tw o aspects of the sam e results are how ever of interest for the understanding of the trion physics.

## 4 P hoton absorption using electron-exciton diagram s

In section 2, we have derived the photon absonption using eh diagram s in the case of exciton form ation and in the case of trion form ation. W e have show $n$ that these standard Feynm an diagrams are in fact totally inappropriate for trions. In section 3, we have derived all the tools necessary to propose a new diagram matic procedure for photon absonption in term s of excitons, while taking into account the fact that the exciton can also be $m$ ade $w$ th any of the electrons present in the sam ple, through the exchange \scatterings" generated by the \com mutation technique" .

This new formulation of photon absonption is in fact quite natural: Indeed, the sem ioonductor-photon interaction, given in eq. (2.3) in term s of free electrons and free holes, can also be w ritten in term sofexcitons. From eq. (3.8) and the fact that ${ }^{\mathrm{P}} \mathrm{h}_{\mathrm{hp} j \mathrm{j}=}=$ $0 i=1$, we readily get

(iii) These diagram s have a unique conduction-hole line, going from left to right: Since the initial state has one electron ( $\mathrm{k}_{\mathrm{i}} ; \mathrm{S}_{\mathrm{i}}$ ) only, the corresponding initial $\backslash F e r m i$ sea" can have one hole only, w ith a well de ned $m$ om entum, nam ely $k_{i}$, so that this hole cannot scatter. W ith such an essentially em pty \Ferm isea", the conduction electron ( $\mathrm{s}_{\mathrm{i}}$ ) has, on the opposite, plenty of sites to scatter.

W hile physically appealing at rst, this concept tums out to be technically useless: Indeed, the sum ofe-X ladder processes can be sum $m$ ed up easily in term $s$ of singlet and triplet trionswhen | and only when | all $q_{n}$ 's are included. On the opposite, the sum of ladder processes restricted to $q_{n} \in 0$ as the ones appearing in $T\left(!{ }_{p} ; Q_{p} ; k_{i}\right)$ is not know $n$. C onsequently, although physically nice at rst, eq. (4.29) which would lead to w rite the response function as

Ifwe now take a m athem atical point ofview, we hardly see how the one-body operator $\check{h}_{x}$ can be transform ed into a two-body operator, for the j ;pi (or jr;pi) states to appear in the response function as they should, in view of eq. (423). By com paring eqs. (4.23) and (4.30), we note that the matrix elem ents between jr $=0$ i states of (! p
 does not tell anything about the operators them selves.

### 4.3.8 C onclusion

The response function, in the case of a photocreated electron $w$ ith spin di erent from the initial one, is very sim ilar to the response function of an exciton: It just contains e-X ladder processes. It is how ever of im portance to stress that, while, in the exciton case, there is no way to cut these ladder diagram s into pieces, in the trion case, the exciton | which plays the role of the hole in the exciton ladder processes | can possibly retum into $a\left(n ; Q_{p}\right)$ state after a set of scatterings. This $m$ akes the corresponding diagram topologically separable. These tw o types ofdiagram shave how ever to be included in order to nd all term s appearing in the response function (see gs. (7d) and (7e)). A nother im portant point is the fact that no additional diagram resulting from possible electron exchanges exists, although, at any stage, the exciton can a priori be m ade either $w$ ith the photocreated electron or w ith the initialelectron. T his is basically due to the fact that, in a quantum well, when the electron spins are di erent, the hole can only recom bine w ith the photocreated electron; so that the num ber of exchanges which can take place before recom bination, has to be even. Since two exchanges reduce to an identity according to eq. (323), two exchanges are basically the sam e as no exchange at all.

A last com $m$ ent: For $m$ ost people, \trion" in fact $m$ eans \ground state trion". Such trion corresponds to singlet state, i. e., state in which the two electrons have di erent spins, so that it corresponds to the e-X ladder diagram s described in this paragraph. The real challenging di culty with trions seen as interacting e-X pairs, in fact arises when the two electrons have the sam e spin, i. e., when the hole can recom bine with any of the tw o electrons, so that electron exchanges have to explicitly enter the problem. Let us end this work by considering these triplet trions, although they are not the interesting ones in m ost experim ents.

### 4.4 P hotocreated electron w ith sp in identical to the in itial one

The consequences of the possible electron exchanges in form ing the excition can appear quite di cult to handle at rst. This is probably why trions have not been treated as a set of interacting e-X pairs up to now. Let us show how our com mutation technique allow s to take care of this electron exchange in a sim ple and transparent way.

From a rapid look at eq. (4.22), we see that the response function $S_{f}$ for di erent
electron spins reads in term $s$ of trion states $j$ siwith both $S=0$ and $S=1$. This is reasonable since, with j+ i electrons, we can form singlet and triplet trions. On the opposite, if the two electrons have the sam e spin, j+ + i for exam ple, we can only form ( $S=1$ ) trions, so that only ( $S=1$ ) trions should enter the response function. Since A $a_{p} ; p(a ; K)$ appearing when $1=(a \quad H)$ acts on $e-X$ pairs, read in term sofboth $(S=0)$ and ( $S=1$ ) trions, the exchange processes, which take place when the tw o electron spins are identical, have to $w$ thdraw the $(S=0)$ trion contributions from the nal result. Let us see how they do it.

If we go back to eq. (4.9), we nd that the scalar product of e-X states which enters $S ; s_{i}$, has tw o term $s$ instead of one when the electron spins are the sam e (see eq. (3.33)). Beside the ${ }_{1}={ }^{0}$ and $p_{1}=p_{i}$ term, we also have an exchange term, so that eq. (4.9) now leads to

It thus contains contributions from triplet trions only, as expected. Let us note that, due to this restriction, $S=$ cannot be w ritten in a com pact form in term $s$ of the trion relative $m$ otion $H$ am iltonian $h_{T}$, as for $S_{\xi}$ in eq. (423).

### 4.4.2 Expansion in e-X diagram $s$

W e now com eback to eq. (4.31) and use the expression of $A{ }_{0} p_{p} ;(a ; K)$ in term sofe-X scaterings given in eq. (3.55). Beside the set of direct ladder diagram s leading to $S_{\text {\% }}$ and which come from the rst term ofeq. (4.31), there are additional exchange diagram $s$ com ing from the second term. It is of interest to note that these exchanges appear through the $L o_{p_{i} ; 1 p_{1}}$ factorwhich takes place \at the end" of a set of direct e-X scatterings, just
before the exciton recombination, as A ${ }_{1 p_{1}} ; p_{i}\left(\mathrm{a}_{\mathrm{i}} ; \mathrm{K}_{\mathrm{i}}\right)$ contains direct C oulom b scatterings only. From eq. (4.31) we thus see that, in the case of a photocreated electron having the sam e spin as the initial electron, the response function in fact reads

It is of im portance to note that, when the photocreated electron has a spin di erent from the initial one, the rst order term of the response function $S_{f}$ is zero: The exciton-
 rst order e-X scatterings can exist when the tw o spins are identical, because the possible
electron exchanges appearing in the dressed exciton-photon vertex do not im pose $p^{0}=p_{i}$ anym ore. The rst order term of $\hat{S}^{(1)}$ in fact corresponds to the diagram of $g$. (10b), since it is easy to show that, for $q_{1} \in 0$,

U sing the sam e procedure, we can show that the second order term sof $\hat{S}$ in e-X C oulom b processes correspond to the diagram of $g$. (10c) plus the one of $g$. (10d). Indeed, here again, the e-X scatterings appearing in $A o_{p_{i} ; p_{i}}\left(a_{i} ; K_{i}\right)$ impose $\left.q_{n} G_{1}\right\}$ (w ith $\left.q_{0} 0\right): T$ his leads to $q_{1} \in q_{2} \quad q_{1}$, so that we can have both, $q_{2} \in 0$ and $q_{2}=0$. Since the standard rules for calculating diagram s only lead to processes in which the carriers of the Ferm i sea are excited, the diagram of $g$. (10c) takes into account $q_{2} \in$ excitations only. T he $\mathrm{q}_{2}=0$ ones which would be m issing, have to be included separately through the diagram of g. (10d).

If we now tum to the third order term s of $\hat{S}$, they correspond to the diagram s of $g s$. ( $10 \mathrm{e}, 10 £, 10 \mathrm{~g}$ ) . A nd so on ...

This thus shows that the additional exchange diagram s which take place when the photocreated electron and the initialelectron have the sam espin, and which are of crucial im portance to $w$ ithdraw the singlet contributions appearing in $S_{f}$, correspond to a set of lopen" ladder diagram swhich have the follow ing characteristics:
(i) They all have one conduction-hole line only, going from left to right, w ithout any hole scattering since the initial \Ferm isea" still contains one electron only.
(ii) They all have an exciton possibly scattered by direct e-X processes w thout any exchange w ith the other electron, although the tw o electrons have the sam e spin.
(iii) The fact that the exciton can be $m$ ade $w$ ith the initial electron or the photocreated electron appears in this case, once and for all, in the renorm alized exciton-photon
interaction ${ }_{\hat{p}_{i} ; \text { ip }}$, because the photocreated deep hole can now recombine $w$ ith any of the two electrons. These diagram s thus start with a bare exciton-photon vertex and end with a dressed one $\hat{p}_{p_{i} ; ~}$.

The reader can be puzzled by the apparent dissym etry of this new set of diagram $s$, w th the exchange at the end, and not at the beginning. It is actually possible to show that the result does not depend on the position of this exchange.
(iv) Since the scattered excition can be in a $\left(n ; Q_{p}\right)$ state, while the standard nules for diagram s lead to processes in which the initial \Ferm isea" | here the initialelectron | is excited, we must add to the connected \open" ladder diagram $s$, diagram $s$ w ith an \open" part separated from a ladder part, as in g. (10d,10f,10g).

### 4.5 V olum e dependence

From the expressions of the response functions $S_{f}$ and $S=$ in term softrions given in eqs. (4.22) and (4.33), we see that the trion oscillator strength reads sim ply in term s of the
 \good" trion variables $r$ and $u$, de ned in eqs. (3.2) and (3.10). W e also see that, when the photon polarization is such that only ( $\mathrm{S}=1$ ) trions can be form ed, the oscillator strength of these ( $S=1$ ) trions have an additional factor of 2 , com pared to the case in which both ( $S=0$ ) and ( $S=1$ ) trions can be created.

From the expression $j f$ fr $=0 ; p_{i j}$ if of the trion oscillator strength obtained in eq. (4 22), it is easy [19] to com pare its size for bound state (eeh), partially dissociated state $(e+e h)$ and totally dissociated state $(e+e+h)$.

In the case of a bound trion, hr; uji has an extension over $r$ of the order of $a_{x}$ and an extension over $u$ of the order of $a_{T}$, w th $a_{T}$ m uch larger than $a_{X}$ since the trion binding energy is much weaker than the exciton binding energy. In 2D, dim ensional argum ents then lead to $h r=0 ; u=0 j i \quad\left(z_{T} a_{T}\right)^{1}$. From the spatial extension $a_{T}$ of $\mathrm{hr}=0$; $u j$ i, we then nd, again from dim ensional argum ents, that, for $\mathrm{p} \quad \mathrm{a}_{\mathrm{T}}{ }^{1}$,
 $\left(L^{2}=\right)$. This leads to a bound trion oscillator strength j $j\left(a_{T}=a_{x}\right)^{2}$, independent from the sam ple volum e.

If we now consider a partially dissociated trion, hr; ujinow has an extension $a_{x}$
over $r$ but $L$ over $u$, so that $h r=0 ; u=0 j i \quad(\underset{a}{ }=)^{1}$. For $p$ small, we then have $\mathrm{hr}=0 ; \mathrm{pj}$ i $1=$ ॠ, so that the partially disssociated trions have an oscillator strength $j{ }_{j} L^{2}=a_{x}^{2}$, which is the one of a free exciton.

Finally, for a totally dissociated trion, hr; $u j i$ has an extension $L$ over $r$ and $L$ over $u$, so that $h r=0 ; u=0 j i \quad L^{2}$. Forsm all $p$, this gives $h r=0 ; p j i \quad 1=L$, which leads to a sam ple volum e independent oscillator strength $j \rho$ equal to the one of the exciton di usive states, i. e., free carriers. This oscillator strength is how ever sm aller than the bound trion one, since the trion extension $a_{T}$ is som ew hat larger than the exciton extension $a_{x}$.

W e thus conclude that the partially dissociated trion has essentially the sam e oscillator strength as the exciton, while the bound trion oscillator strength is $\mathrm{a}_{\mathrm{T}}^{2}=\mathrm{L}^{2}$ sm aller. It is thus vanishingly sm all in the large sam ple lim 五, i. e., the lim 辻 of solid state physics. This is after all not surprising: If we take a large sam ple and if we add just one electron, we cannot expect any sizeable change in the photon absonption spectrum! From a technical point of view, if we consider the volum e dependence of the diagram s representing the response function, we nd that the dom inant one corresp onds to the bare exciton diagram, given in $g .(7 a)$, so that in the large L lim it, the trion diagram s reduce to this unique diagram.

T hese quite sim ple argum ents lead us to conclude that, when a line is seen, w ell.below the excition line, in the photon absonption spectrum of a doped sem ioonductor, it cannot be the line of a (clean) trion because its oscillator strength would be a sam ple volume (or a coherence volum e) sm aller than the exciton one. It is m ost probably a trion having $m$ any-body e ects with the $(\mathbb{N} 1$ ) other electrons of the sem iconductor, or better a photocreated exciton dressed by the N electrons already present in the sam ple. This quite di cult $m$ any-body problem will be adressed in a further work, using the tools we have established in sections 3 and 4 of the present paper, which allow to treat excitons interacting w ith electrons through electron-exciton diagram s.

## 5 C onclusion

In order to solve the sim plest problem on trion, nam ely the photon absonption in the presence of one electron, we have rst shown that the standard Feynm an diagram s , which read in term s of free electrons and free holes, are totally inappropriate: A s the trion is a bound state, C oulom b processes have to be included at all orders. W hile these C oulom b processes can be handled exactly between the two carriers of an excition, it is totally hopeless to draw and sum them all, in the case of three carriers.

W e propose to reduce this three body problem to a two-body problem by considering the trion as an electron interacting with an exciton. A though physically appealing, this approach however faces the problem of the electron indistinguishability, i. e., the fact that the exciton can a priori be $m$ ade $w$ ith any of the two electrons. O ur com mutation technique, designed to dealw th this problem in an exact way, allows to overcom e th is di culty.

W e nd that when the photocreated electron has a spin di erent from the initialelectron spin | which is for exam ple what happens ifwe want to photocreate a ground state trion |, we can forget about these possible electron exchanges: T he response function to the photon eld just corresponds to a set of e-X ladder diagram s between e-X pairs ( $; p ; K$ ), w ith $K$ being the center of $m$ ass $m$ om entum of the pair $\mid$ constant in these ladder processes $\mid, p$ the relative $m$ otion $m$ om entum of the $e-X$ pair and characterizing the exciton relative $m$ otion level. The e-X interaction vertex $C \underset{p_{p} ; p}{\operatorname{dir}_{0}}$ of these novel diagram s corresponds to direct C oulom b processes between the electron and the exciton, the \in" exciton and the \out" exciton ${ }^{0}$ being $m$ ade $w$ ith the sam e electron. $C \underset{p_{p} ; p}{\mathrm{dir}_{0}}$ reads in term $s$ of the Fourier transform $\mathrm{w}_{\mathrm{q}}(\mathrm{r})$ of the C oulom b potentialw ( $\mathrm{r} ; \mathrm{u}$ ) between the electron $e^{0}$ and the exciton $m$ ade of (e; $h$ ).

The possible electron exchanges are only im portant when the spins of the tw o electrons are identical, i.e., when only triplet trions ( $\mathrm{S}_{\mathrm{z}}=1$ ) are photocreated. It is then possible to inchude these exchanges through a dressed exciton-photon interaction. They thus play a role, once and for all, when the hole recom bines, so that we are again left w ith direct e-X ladder processes only, except that they are now \open".

The physical reason for a so trivialconsequence of the possible electron exchange lies in the fact that tw o exchanges reduce to an identity; so that, etther we end with no exchange
at all | as when the photocreated hole can recom bine w th the photocreated electron only, which is what happens when the two electron spins are di erent |, or we end with zero and one exchange | as when the hole can recom bine with either the photocreated electron or the initial electron, which is what happens when the two electrons have the sam e spin.

In section 3 ofthis paper, we have also collected all im portant results on trions derived in our previous works | plus som e unpublished ones. This \background on trion", which leads to this novel $m$ any-body procedure in term $s$ of electrons and excitons, will be of great help to study the interaction oftrion w ith carriers in doped sem ioonductors: Indeed, the existing literature on this very di cult $m$ any-body problem, which relies on standard electron-hole procedure | the only one known up to now $\mid$, is quite unsatisfactory, as we outlined in ref. [19].
