# Local Geom etry of the Ferm isurface and Quantum $O$ scillations in the Linear $R$ esponse of $M$ etals

#### Abstract

In this paper we present a theoretical analysis of the e ect of anom alies of the Ferm i surface (FS) curvature on oscillations in the electron density of states (DOS) in strong magnetic elds. It is shown that the oscillations could be signi cantly weakened when the FS curvature takes on zero or extrem ely large values or diverges in the vicinities of som e extrem al cross-sections. This leads to a characteristic dependence of the oscillations $m$ agnitude on the direction of the $m$ agnetic eld which is studied. The results of these general studies are em ployed to analyze the e ects of the FS curvature anom alies on the quantum oscillations in the velocity of sound waves travelling in $m$ etals.

## 1. IN TRODUCTION

Experim ental data conceming quantum oscillations in various observables in $m$ etals under strong $m$ agnetic elds were repeatedly used in studies of their electron characteristics $\left.{ }_{\underline{1}}^{11}\right]$. It is know $n$ that the electron response of a m etal to an extemal disturbance depends on the geom etry of the FS. The Ferm i surfaces of $m$ etals are m ostly com plex in shape and this can essentially in $u$ ence observables. A t present those phenom ena which are determ ined by the $m$ ain geom etric characteristics of the FS's, i.e. their connectivity, are well studied. H ow ever those e ects which appear due to som e ne geom etrical features of the FSs such as nearly cylindricalsegm ents or points of attening have not been investigated in detail so far. M eanw hile these elem ents in the FS geom etry can noticeably a ect the electron response ofm etal.

W hen the FS includes points and/or lines where its curvature tums zero, this it leads to an enhancem ent of the contribution from the neighborhood of these points/lines to the electron density of states (DOS) on the FS.U sually this enhanced contribution is sm all com pared to them ain term in the DOS which originates from the rem aining $m$ a jor part of the FS. T herefore it cannot produce noticeable changes in the response of the $m$ etal when all segm ents of the FS contribute to the response functions essentially equally. H ow ever, som e e ects (including those originating from quantum oscillations in the electron D O S) are determ ined with sm all \e ective" segm ents of the FS. The contribution to the D OS from the vicinities of the points and lines of zero curvature can be congruent to the contribution of an le ective" segm ent. In other w ords, when the curvature of the surface becom es zero at som e part on an le ective" segm ent of the FS, it can give a sensible enhancem ent ofe cient electrons and, in consequence, a pronounced change in the response of the $m$ etal to the disturbance.

It has been shown that when the FS includes points
or lines where at least one of the principal radii of curvature becom es in nitely large, then changes $m$ ay be observed in the frequency and tem perature dependences of
 the frequency dependence of the surface im pedance of a conventionalm etal under anom alous skin e ect $\overline{\underline{1} 1, ~} \overline{1} \overline{1} \overline{1}$. Likew ise, the attening points at the FS m ay give rise to som e anom alies in the $m$ agnetoacoustic response of a two-dim ensional electron gas, as show $n$ in the papers


In the present work we concentrate on quantum oscillations in observables in $m$ etals which originate from the D O S oscillations in strong magnetic elds. The oscillating term in the DOS is form ed by the neighborhoods of the FS cross-sections w ith extrem al areas. U sually, the latter are narrow strips on the FS. Therefore the FS curvature anom alies at these strips $m$ ay signi cantly a ect their contributions to the DOS quantum oscillations. C onsequently, the e ect of the FS local geom etry can be revealed in oscillations of various observables in $m$ etalls, such as $m$ agnetization, $m$ agnetic susceptibility, resistivity, sound velocity and attenuation. Q ualitative anom alies of the de-H aas-van A lphen oscillations associated with cylindrical pieces of the FSs were con-
 that nearly cylindrical pieces inserted in the FS could cause noticeable softening of som e acoustic $m$ odes near the peaks of the DOS quantum oscillations (see Refs. [14, 1251]).

A long w ith the points and lines of zero curvature there can exist points and lines, where the FS curvature diverges. A sim ple illustration is a kink line on a surface where the electron velocity is discontinuous. If the FS inserts such lines, then the e ective belts could be $m$ issed for appropriate directions of propagation of electrom agnetic or sound waves, which brings anom alies in highfrequency properties of the $m$ etal. It is shown $[1][1]$ that under these conditions electrom agnetic waves of
som e special kind can propagate in $m$ etals. The lines of a singular (in nite) curvature can be arranged on edges of narrow lenses or needle-shaped cavities, which are ele$m$ ents of the F Ss of som e m etals. H ow ever, it could happen that the FS curvature diverges at som e points w here the velocity of electrons varies continuously as discussed below.

A characteristic feature of quantum oscillations attributed to the extrem alcross sections of anom alous curvature is a clearly $m$ anifested dependence of their am plitude on the direction of an extemalm agnetic eld B. $T$ he e ect could be revealed only for certain directions, when the e ective cross-section runs along that part of the FS where the curvature tums zero or diverges. $W$ hen them agnetic eld is tilted aw ay from such direction by an angle the e ective cross section slips from the \anom alous" segm ent of the FS. This brings sensible changes in the oscillations $m$ agnitude. $T$ his is typical for all effects arising due to localpeculiarities in the FS geom etry. For instance, angular dependence of the am plitudes of m agnetoacoustic com $m$ ensurability oscillations in a twodim ensional electron system was discussed in $R$ ef $\left.[1] \overline{1}_{1}^{-1}\right]$. In the present work we analyze angular dependencies of quantum oscillationsm agnitudes for di erent kinds of local anom alies of the FS curvature. The results could be em ployed to analyze $m$ anifestations of the FS local geom etry in quantum oscillations of various characteristics in $m$ etals. A $s$ an exam ple, we brie $y$ consider the e ect of the FS curvature anom alies on quantum oscillations in the velocity of an ultrasonic wave propagating in a $m$ etal. To avoid further prolixities in this work, other applications are not included. T hese applications are to be discussed elsew here.

## 2. THEMODEL

The concept of a zero curvature line (nearly cylindrical cross-section) on the FS does not require further explanation. On the contrary, the concept of the line where the FS curvature diverges needs clari cation. Before introducing the FS m odel used in the follow ing analysis, we present a sim ple illustration to clear this concept.

It is know $n$ that $F$ Ss of cadm ium and zinc (both $m$ etals have a hcp crystalline structure) include an axially sym $m$ etric electron lens. The lens is located at the center of third $B$ rillouin zone, w ith its axis running along the [0001] direction. W e can roughly reproduce this lens using the $H$ arrison $m$ ethod of construction of free electron FSs. A ssum ing that $\backslash z^{\prime \prime}$ axis of the coordinate system is directed along the axis of sym $m$ etry, we arrive at the follow ing energy m om entum relation for electrons associated w th the lens:

Here, $p_{\text {? }}$ and $p_{z}$ are the electron quasim om entum com ponents across and along the sym $m$ etry axis, respectively: $m$ is the electron e ective $m$ ass; $x=p_{z}=p_{m}$ where $p_{m}$ is the $m$ axim um value of the quasim om entum along the "z" axis; and $G=(0 ; 0 ; G)$ is the corresponding reciprocal lattioe vector.

The lens described with (1) has a kink line running along its edge. H ow ever, this curvature anom aly appears ow ing to our free electron approxim ation. In actualm etals we can expect it to be sm oothed by m eans of crystalline elds. To better reproduce the shape of the lens near the edge we start from the standard asym ptotic for the sign function which is valid for $\dot{x} j<1$; nam ely:

To proceed we use the approxim ation sgn (x) $f(x ; 1)$ : Substituting this approxim ation into (1) we see that now the velocity of the electrons belonging to the lens varies continuously, and its longitudinal com ponent reduces to zero at the central cross-section ( $p_{z}=0$ ). K eeping only the greatest term s , we can w rite the follow ing expression for the cross-sectionalarea near the centralcross-section:

H ere, $\mathrm{A}_{\text {ex }}$ is the central cross-sectional area, $\mathrm{b}^{2}$ is a di$m$ ensionless positive constant, and $k=\frac{1}{2}(1+1=1)$ : The lens curvature near the central cross-section could be approxim ated as follow s:

Since $k<1$; the curvature tends to in nity when $p_{z}$ tends to zero although these is no break in the longitudinalvelocity at $\mathrm{p}_{\mathrm{z}}=0$, as show n in the Fig .1 . Thism eans that the central cross-section of ourFS is not a kink line, and the e ective strip still exists here. H ow ever, there could be a considerable decrease in the num ber of electrons associated w ith the vicinity of this cross-section. It can in uence som eproperties of the $m$ etalincluding quantum oscillations. A ctually, there exists a piece of experim entalevidence for the curvature anom aly at the edge of the electron lens in cadm ium. A resonance feature at the cyclotron frequency w as observed in the surface im pedance derivative when the $m$ agnetic eld was directed along the [0001] axis [1] ${ }^{2}$ ]. This resonance originates from the contribution of the electrons associated w the the edge of the lens, and it could be explained assum ing that the lens curvature diverges there [19].

In further calculations we use a simple model of a closed sim ply connected and axially sym $m$ etric $F$ S which has a unique extrem al cross section for any direction of the extemalm agnetic eld. Such FS could be described w th the energy-m om entum relation:

$W$ hen $\mathrm{k}=1$; Eq.(5) corresponds to the ellipsoidalF. . In this case $m_{?} ; m_{j j}$ are the principal values of the e ective $m$ ass tensor. A s previously, the cross-sectional area of the FS near its central cross-section is described w ith the expression (3), where $b^{2}=1$ : It follow from (4) that at
$=0$ (the m agnetic eld is directed along the sym m etry axis), the chosen FS is nearly cylindrical in the vicinity of the centralcross-section when $k>1$ :H ow ever, for $1=2<$ $k<1$ the FS curvature diverges here. Suppose that the $m$ agnetic eld $B$ deviates from the sym $m$ etry axis by the angle : Then the expression for the cross-sectional area changes. A fter som e straightforw ard calculations we arrive at the result:

$H$ ere, $\mathrm{a}^{2} ; \mathrm{b}^{2}$ and $\mathrm{A}_{\text {ex }}$ are functions of the angle betw een the $m$ agnetic eld and the FS sym $m$ etry axis, $a^{2}(0)=0$; and it increases whereas enhances. W hen the angle takes on a certain value $0 ; a^{2}()$ becom es greater than $\mathrm{b}^{2}()$; and stays likew ise when further increases.
3. THE EFFECTOFTHE FERMISURFACE CURVATUREANOMALIES ON THEQUANTUM

OSCILLATIONS IN THE ELECTRON IC DENSITYOFSTATES

For FSS w ith a single extrem al cross-section the electron DOS is given by:

Here, f is the Ferm idistribution function for quasiparticles w ith energies E ; $g$ is the value of the electron DOS in the absence of the $m$ agnetic eld, and the oscillating function is described by the expression

In further analysis we assume that the num ber of Landau levels under the FS is large, and the param eter ${ }^{2}=2=h \quad$ ( is the chem ical potential of electrons) takes values much larger than unity. So, we can derive asym ptotic expressions for the integrals (10), (11) using the stationary phase $m$ ethod.
$T$ he principalterm $s$ in the expansions of these integrals in powers of the sm allparam eter ${ }^{1}$ are easily obtained in two lim titing cases: $a^{2} \quad b^{2}$ and $a^{2} \quad b^{2}: T$ he rst inequally is satis ed for sm all values of the angle betw een the $m$ agnetic eld and sym $m$ etry axis, when the extrem al cross-section of the FS nearly coincides w th the line of anom alous curvature. T he asym ptotic expression for the oscillating function has the form

In the opposite $\lim$ it $\mathrm{a}^{2} \quad \mathrm{~b}^{2}$; which corresponds to su ciently large values of the angle, the principalterm in the expansion of in powers of ${ }^{1}$ equals:

So, in this case, the function describes ordinary oscillations of the electron density of states in a quantizing $m$ agnetic eld.

It is well known that amplitudes of quantum oscillations depend on tem perature. O rdinary quantum oscillations of the electron D O S described by the Eq. (13) have the amplitude of the order of $\quad 1=2 \quad 1=2$ : The am plitude of the oscillations related to the \anom alous" cross-section given by (12) m ay be estim ated as
$1=\mathrm{k} \quad(12 \mathrm{k})=2 \mathrm{k}$ : C om paring these estim ates, we see that the am plitude ofoscillations associated w ith the extrem al cros-section of zero/diverging curvature signi cantly differs from that of the usualquantum oscillations. The contribution from a nearly cylindrical cross-section can considerably exceed in am plitude contributions from usual cross-sections. A swell, the am plitude ofD O S oscillations originating from a cross-section where the FS curvature diverges is sm aller than that of the ordinary oscillations. A lso, the ne geom etricalstructure of the FS near the extrem al cross-sections $m$ ay bring changes in the tem perature dependence of the oscillations am plitude. A s show n in the Fig. 2, the closer is the vicinity of an extrem al cross-section to a cylinder, the m ore pronounced is the decrease in the oscillation am plitude while the tem perature rises. O scillations associated with a cross-section where the FS curvature diverges, exhibit w eaker tem perature dependence com pared to ordinary quantum oscillations.

N ow we analyze the am plitude of oscillations w ith in the interm ediate range where $\mathrm{a}^{2}$ and $\mathrm{b}^{2}$ have the sam e order of $m$ agnitude. We present the integrals (10) and (11) as expansions in powers of the param eter w ( $\mathrm{w}=$ $\left.r^{2} a^{2}=\left(r^{2} b^{2}\right)^{1=k}\right)$ : In particular, the expression for $U_{r}$ in the case $w<1$ has the form

Expansions for $W_{r}$ could be obtained from (14) and (15) by replacing cosines $w$ th sines of the sam e argum ents.
$T$ he results of com putation ofthe oscillation am plitude $Y\left(Y=\overline{U^{2}+W^{2}}\right)$ as a function of $w$; are presented in the Fig. 2. C alculations were carried out assum ing that

1: A ccordingly, only the rst term was kept in the sum over $r$ included in (12). The dependence of $Y$ on $w$ calculated for $\mathrm{k}=2$ and $\mathrm{k}=4$ is show n in the left panel. In this case the central cross section of the FS for $=0$ is quasi-cylindrical. The oscillations am plitude takes on the largest value when $=0$ and decreases m onotonically as w increases. Both curves are asym ptotically approaching the straight line $Y=1=$ when $w 1$ :As expected, the am plitude variation is $\mathrm{m} u \mathrm{uch}^{\text {b }}$ better pronounced for the curve 2. This curve is plotted for the larger value of the param eter $k$ when the FS is closer to a cylinder near its central cross-section. In the right panel the behavior of the am pitude of quantum oscillations of the D OS upon a variation of the angle is shown under the assum ption that the FS curvature diverges at the central cross-section at $=0: T$ he curves presented here are plotted for $\mathrm{k}=3=4$ and $\mathrm{k}=5=8$ : The second value of $k$ corresponds to a stronger anom aly in the FS curvature at the extrem alcross-section. Fork $=5=8$; the oscillation am plitude increasesm onotonically $w$ ith $w$ and tends to the value 1= : For a less pronounced anom aly in the curvature $(k=3=4)$; the dependence of $Y$ on $w$ is nonm onotonic. H ow ever, in this case the decrease in the value of $Y$ forsm allvalues ofw is replaced by its increase when w takes on greater values.

N ow, we rem ark that two param eters characterizing the FS local geom etry were used in the present work, and they both could be easily evaluated provided that we possess relevant experim entaldata. The angle 0 describing the width of the FS strip where the curvature anom alies are revealed is a directly $m$ easurable quantity, and the shape param eter $k$ introduced in the Eqs. (3)

and (5) could be estim ated basing on the variation in the oscillations $m$ agnitude betw een its m axim $\mathrm{um} / \mathrm{m}$ inim um $(=0)$ and plateau ( $\quad 0$ ) values. The magnitudes of oscillations described by Eqs. (12),(13) have the order of $\quad 1=k \quad(1=2 k)^{1}$; and $\quad 1 \quad 1=2$; respectively. 4. AN APPLICATION:QUANTUM

OSCILLATIONS IN THE ULTRASOUND VELOCITY

To m ake the presented results m ore speci c we apply our analysis to study the e ects of the FS localgeom etry on the quantum oscillations of the velocity of ultrasound waves travelling in a m etal. W hen an ultrasound wave propagates in a m etal the crystalline lattioe is periodically deform ed. It gives rise to electric eldswhich in uence the electrons. Besides, the periodical deform ations of the lattice cause changes in the electronic spectrum. H ere, we om it these deform ation corrections to sim plify further analysis.

The em ergence of the electric eld accom panying the lattice deform ation, leads to a redistribution of the electron density $N$ : T he localchange in the electronic density N (r) equals:

W e use these equations to express the potential ${ }^{\prime}(\mathrm{r})$ in term s of the lattice displacem ent vector. A s a result we derive the expression for the electron force $F(r)$ acting upon the lattice under its displacem ent by the vector $u(r)$. For a longitudinalultrasound $w$ ave travelling along the magnetic eld B we obtain:

$H$ ere, $\mathrm{b}_{0}$ is unit vector directed along the eld $B$ : $M$ ore thorough analysis taking into account deform ation corrections to the electron energies does not bring qualitative changes in the expression (19). We arrive at the $m$ odi ed expression for the force $F$ ( $r$ ) sim ply m ultiplying (19) by a dim ensionless factor of the order of unity which could be treated as a constant.

Starting from (19) we obtain the well know n result for the oscillating correction $s$ to the sound velocity s:

$w$ here is the $m$ etal density and the sum $m$ ation is carried out over allextrem al cross-sections on the FS corresponding to the given direction of the $m$ agnetic eld. So, the above angular dependences of $m$ agnitudes of quantum oscillations arising due to the local geom etry of the FS could be revealed in oscillations of the velocity of ultrasound waves propagating in $m$ etals.

## 5. C ONCLUSION

In sum $m$ ary, we showed that when the FS of a m etal inserts lines where its curvature tums zero or reveals discontinuity, this can signi cantly a ect both am plitude and phase of electron DOS oscillations in strong (quantizing) magnetic elds. The e ect arises due to increase/decrease of the relative num ber of electrons associated w ith the neighborhoods of these lines. It reveals itself at certain directions of the $m$ agnetic eld, and disappears when the m agnetic eld is tilted aw ay from such direction. T his results in angular dependence of the D O S oscillation am plitudes. T he latter could be observed in experim ents on quantum oscillations in various characteristics of a $m$ etal such as $m$ agnetization, $m$ agnetic susceptibility and resisitivity, for all these oscillations arise due to the DOS quantum oscillations. Q uantum oscillations in the sound velocity discussed in this work is a m ere exam ple of the e ect of the FS curvature local anom alies on observables.

The most obvious $m$ aterials where we can expect the FS curvature anom alies to be $m$ anifested include layered structures w ith $m$ etallic-type conductivity (e.g.
(BEDT TTF $\mathrm{MM} \mathrm{H}_{\mathrm{H}}(\mathrm{SCN})_{4}$ group oforganicm etals). Ferm i surfaces of these $m$ aterials are sets of rippled
cylinders, isolated or connected by links $\left.{ }_{2}^{2} \overline{0}_{1}^{\prime}\right]$. The angular dependence of the $m$ agnetic oscillations $m$ agnitude resembling that shown in the $F$ ig. 3 is well known for such $m$ aterials. The appearance of this e ect show $s$ that the quasi-two-dim ensional FSs of som e organic m etals include segm ents $w$ ith zero curvature. The e ect was
rst analyzed in $\left[\overline{1}_{1}^{1}\right]$, and further discussed in som e later works (see e.g. $\left.\underline{R}^{2} \underline{1}^{1}\right]$ ).

Local geom etry of the FSs of usualm etals also can be displayed in the angular dependences of $m$ agnitudes of quantum oscllations. For instance, there is an experi$m$ ental evidence that \necks" connecting quasispherical pieces of the FS of copper include nearly cylindricalbelts [1] ]. W hen the $m$ agnetic eld is directed along the axis Of a \neck" (for instance, along the [111] direction in the quasim om enta space), the extrem al cross section of the \neck" could be expected to run along the nearly cylindrical strip where the FS curvature tums zero. It is also likely that the FS of gold possesses the sam e geom etrical features for it closely resembles that of copper. As for possible divergences of the FS curvature, experim ents of [18ㄴ․ give grounds to con jecture that such anom alies could be found on the FSs of cadm ium and zink. It is possible that the curvature is anom alously large at the edge of the electron lens which is the part of the FSs in both $m$ etals. For all above listed substances we can expect the e ect to be revealed at reasonably low tem peratures ( 1 K ) and reasonably strong $m$ agnetic elds (1 10T); giving additionalinform ation on the FSs ne geom etrical characteristics.
