LocalGeometry of the Ferm i Surface and Quantum Oscillations in the Linear Response of Metals

In this paper we present a theoretical analysis of the e ect of anom alies of the Ferm i surface (FS) curvature on oscillations in the electron density of states (DOS) in strong magnetic elds. It is shown that the oscillations could be signi cantly weakened when the FS curvature takes on zero or extrem ely large values or diverges in the vicinities of som e extrem al cross-sections. This leads to a characteristic dependence of the oscillations magnitude on the direction of the magnetic eld which is studied. The results of these general studies are employed to analyze the elds of the FS curvature anom alies on the quantum oscillations in the velocity of sound waves travelling in metals.

1. IN TRODUCTION

Experimental data concerning quantum oscillations in various observables in metals under strong magnetic elds were repeatedly used in studies of their electron characteristics [1]. It is known that the electron response of a metal to an external disturbance depends on the geometry of the FS. The Ferm i surfaces of metals are mostly complex in shape and this can essentially in uence observables. At present those phenom ena which are determined by the main geometric characteristics of the FS's, i.e. their connectivity, are well studied. However those elects which appear due to some ne geometrical features of the FSs such as nearly cylindrical segments or points of attening have not been investigated in detail so far. Meanwhile these elements in the FS geometry can noticeably a ect the electron response of metal.

W hen the FS includes points and/or lines where its curvature turns zero, this it leads to an enhancement of the contribution from the neighborhood of these points/lines to the electron density of states (DOS) on the FS.U sually this enhanced contribution is sm all com pared to the main term in the DOS which originates from the remaining major part of the FS. Therefore it cannot produce noticeable changes in the response of the m etal when all segments of the FS contribute to the response functions essentially equally. However, som e e ects (including those originating from quantum oscillations in the electron DOS) are determ ined with small \e ective" segments of the FS. The contribution to the DOS from the vicinities of the points and lines of zero curvature can be congruent to the contribution of an \e ective" segm ent. In other words, when the curvature of the surface becom es zero at som e part on an \e ective" segment of the FS, it can give a sensible enhancem ent of e cient electrons and, in consequence, a pronounced change in the response of the metal to the disturbance.

It has been shown that when the FS includes points

or lines where at least one of the principal radii of curvature becom es in nitely large, then changes may be observed in the frequency and tem perature dependences of sound dispersion and absorption [2, 3, 4, 5, 6], and in the frequency dependence of the surface impedance of a conventional metal under anom alous skin e ect [7, 8]. Likewise, the attening points at the FS may give rise to some anom alies in the magnetoaccoustic response of a two-dimensional electron gas, as shown in the papers [9, 10].

In the present work we concentrate on quantum oscillations in observables in metals which originate from the DOS oscillations in strong magnetic elds. The oscillating term in the DOS is formed by the neighborhoods of the FS cross-sections with extrem al areas. U sually, the latter are narrow strips on the FS. Therefore the FS curvature anom alies at these strips m ay signi cantly a ect their contributions to the DOS quantum oscillations. Consequently, the e ect of the FS local geom etry can be revealed in oscillations of various observables in m etalls, such as m agnetization, m agnetic susceptibility, resistivity, sound velocity and attenuation. Qualitative anom alies of the de-H aas-van Alphen oscillations associated with cylindrical pieces of the FSs were considered before in Refs. [11, 12, 13]. Also, it was shown that nearly cylindrical pieces inserted in the FS could cause noticeable softening of som e acoustic modes near the peaks of the DOS quantum oscillations (see Refs. [14, 15]).

A long with the points and lines of zero curvature there can exist points and lines, where the FS curvature diverges. A simple illustration is a kink line on a surface where the electron velocity is discontinuous. If the FS inserts such lines, then the electron belts could be missed for appropriate directions of propagation of electrom agnetic or sound waves, which brings anom alies in highfrequency properties of the metal. It is shown [16, 17] that under these conditions electrom agnetic waves of som e special kind can propagate in m etals. The lines of a singular (in nite) curvature can be arranged on edges of narrow lenses or needle-shaped cavities, which are elem ents of the FSs of som e m etals. How ever, it could happen that the FS curvature diverges at som e points w here the velocity of electrons varies continuously as discussed below.

A characteristic feature of quantum oscillations attributed to the extrem alcross sections of anom alous curvature is a clearly manifested dependence of their am plitude on the direction of an external magnetic eld B. The e ect could be revealed only for certain directions, when the e ective cross-section runs along that part of the FS where the curvature turns zero or diverges. When the magnetic eld is tilted away from such direction by an angle the e ective cross section slips from the \anom abus" segment of the FS. This brings sensible changes in the oscillations magnitude. This is typical for all effects arising due to local peculiarities in the FS geom etry. For instance, angular dependence of the amplitudes of m agnetoacoustic com m ensurability oscillations in a twodimensional electron system was discussed in Ref [10]. In the present work we analyze angular dependencies of quantum oscillations magnitudes for di erent kinds of local anom alies of the FS curvature. The results could be employed to analyze manifestations of the FS local geom etry in quantum oscillations of various characteristics in metals. As an example, we brie y consider the e ect of the FS curvature anom alies on quantum oscillations in the velocity of an ultrasonic wave propagating in a metal. To avoid further prolixities in this work, other applications are not included. These applications are to be discussed elsew here.

2. THE MODEL

The concept of a zero curvature line (nearly cylindrical cross-section) on the FS does not require further explanation. On the contrary, the concept of the line where the FS curvature diverges needs clari cation. Before introducing the FS model used in the following analysis, we present a simple illustration to clear this concept.

It is known that FSs of cadm ium and zinc (both m etals have a hop crystalline structure) include an axially sym – m etric electron lens. The lens is located at the center of third B rillouin zone, with its axis running along the [0001] direction. We can roughly reproduce this lens using the H arrison m ethod of construction of free electron FSs. A ssum ing that $\z"$ axis of the coordinate system is directed along the axis of sym m etry, we arrive at the follow ing energy-m om entum relation for electrons associated with the lens:

Here, $p_{?}$ and p_{z} are the electron quasimom entum components across and along the symmetry axis, respectively: m is the electron electron electron mass; $x = p_{z}=p_{m}$ where p_{m} is the maximum value of the quasimom entum along the "z" axis; and G = (0;0;G) is the corresponding reciprocal lattice vector.

The lens described with (1) has a kink line running along its edge. However, this curvature anom aly appears owing to our free electron approximation. In actual etals we can expect it to be smoothed by means of crystalline elds. To better reproduce the shape of the lens near the edge we start from the standard asymptotic for the sign function which is valid for jxj < 1; namely:

To proceed we use the approximation sgn(x) = f(x;l): Substituting this approximation into (1) we see that now the velocity of the electrons belonging to the lens varies continuously, and its longitudinal component reduces to zero at the central cross-section ($p_z = 0$). K eeping only the greatest term s, we can write the following expression for the cross-sectional area near the central cross-section:

Here, A_{ex} is the central cross-sectional area, b^2 is a dimensionless positive constant, and $k = \frac{1}{2} (1 + 1 = 1)$: The lens curvature near the central cross-section could be approxim ated as follow s:




FIG.1: Curvature anomalies at axially symmetric Fermi surface. Top panels: Plots of v_z versus p_z (left panel) and K versus p_z (right panel) in the vicinity of the extremal cross-section at $p_z=0$ where the FS curvature K diverges. The curves are plotted according to Eqs.(4) and (5) for m $_?=m_{\rm jj};\ k=3=4;5=6;1$ from the top to the bottom. Bottom panels: Plots of v_z versus p_z (left panel) and K versus p_z (right panel) in the vicinity of the nearly cylindrical cross-section at $p_z=0$: The curves are plotted for m $_?=m_{\rm jj};\ k=1;9=8;4=3$ from the top to the bottom .

Since k < 1; the curvature tends to in nity when p_z tends to zero although these is no break in the longitudinal velocity at $p_z = 0$, as shown in the Fig. 1. This means that the central cross-section of our FS is not a kink line, and the e ective strip still exists here. How ever, there could be a considerable decrease in the number of electrons associated with the vicinity of this cross-section. It can in uence som e properties of the metal including quantum oscillations. A ctually, there exists a piece of experim entalevidence for the curvature anom aly at the edge of the electron lens in cadm ium . A resonance feature at the cyclotron frequency was observed in the surface in pedance derivative when the magnetic eld was directed along the [0001] axis [18]. This resonance originates from the contribution of the electrons associated with the edge of the lens, and it could be explained assuming that the lens curvature diverges there [19].

In further calculations we use a simple model of a closed simply connected and axially symmetric FS which has a unique extrem alcross section for any direction of the external magnetic eld. Such FS could be described with the energy-momentum relation:

W hen k = 1; Eq.(5) corresponds to the ellipsoidal FS. In this case m_?; m_{jj} are the principal values of the e ective m ass tensor. As previously, the cross-sectional area of the FS near its central cross-section is described with the expression (3), where $b^2 = 1$: It follows from (4) that at

= 0 (the magnetic eld is directed along the symmetry axis), the chosen FS is nearly cylindrical in the vicinity of the central cross-section when k > 1: How ever, for 1=2 < k < 1 the FS curvature diverges here. Suppose that the magnetic eld B deviates from the symmetry axis by the angle : Then the expression for the cross-sectional area changes. A fler som e straightforw and calculations we arrive at the result:

Here, $a^2;b^2$ and A_{ex} are functions of the angle between the magnetic eld and the FS symmetry axis, $a^2(0) = 0;$ and it increases whereas enhances. When the angle takes on a certain value $_0; a^2()$ becomes greater than $b^2();$ and stays likewise when further increases.

3. THE EFFECT OF THE FERM ISURFACE CURVATURE ANOMALIES ON THE QUANTUM OSCILLATIONS IN THE ELECTRONIC DENSITY OF STATES

For FSs with a single extrem all cross-section the electron DOS is given by:

Here, f is the Fermi distribution function for quasiparticles with energies E; g is the value of the electron DOS in the absence of the magnetic eld, and the oscillating function is described by the expression

In further analysis we assume that the number of Landau levels under the FS is large, and the parameter $^2 = 2 = h$ (is the chem ical potential of electrons) takes values much larger than unity. So, we can derive asymptotic expressions for the integrals (10), (11) using the stationary phase method.

The principal term s in the expansions of these integrals in powers of the small parameter 1 are easily obtained in two limiting cases: $a^2 b^2$ and $a^2 b^2$: The rst inequality is satisted for small values of the angle between the magnetic eld and symmetry axis, when the extremal cross-section of the FS nearly coincides with the line of anom alous curvature. The asymptotic expression for the oscillating function has the form




FIG.2: E ect of the FS curvature on the tem perature dependence of quantum oscillation amplitudes at moderately low tem peratures (1): Left panel: nearly cylindrical cross-sections; k = 4;2;1 from the top to the bottom. R ight panel: cross-sections where the FS curvature diverges; k = 1;3=4;5=8 from the top to the bottom. Curves are plotted assuming m_{ij} = m₂; $^{2} = 10^{3}$:

In the opposite limit $a^2 b^2$; which corresponds to su ciently large values of the angle, the principal term in the expansion of in powers of ¹ equals:

So, in this case, the function describes ordinary oscillations of the electron density of states in a quantizing magnetic eld.

It is well known that am plitudes of quantum oscillations depend on temperature. Ordinary quantum oscillations of the electron DOS described by the Eq. (13) have the am plitude of the order of 1=2 1=2: The am plitude of the oscillations related to the \anom alous" cross-section given by (12) may be estimated as

 $^{1=k}\ (1\ 2k)^{=2k}$: C om paring these estim ates, we see that the amplitude of oscillations associated with the extrem al cros-section of zero/diverging curvature signi cantly differs from that of the usual quantum oscillations. The contribution from a nearly cylindrical cross-section can considerably exceed in amplitude contributions from usual cross-sections. A swell, the amplitude of DOS oscillations originating from a cross-section where the FS curvature diverges is smaller than that of the ordinary oscillations. Also, the negeometrical structure of the FS near the extrem alcross-sections m ay bring changes in the tem perature dependence of the oscillations amplitude. As shown in the Fig. 2, the closer is the vicinity of an extremal cross-section to a cylinder, the more pronounced is the decrease in the oscillation amplitude while the temperature rises. O scillations associated with a cross-section where the FS curvature diverges, exhibit weaker tem perature dependence com pared to ordinary quantum oscillations.

Now we analyze the amplitude of oscillations within the intermediate range where a^2 and b^2 have the same order of magnitude. We present the integrals (10) and (11) as expansions in powers of the parameter w (w = $r^2 a^2 = (r^2 b^2)^{1=k}$): In particular, the expression for U_r in the case w < 1 has the form

Expansions for W $_{\rm r}$ could be obtained from (14) and (15) by replacing cosines with sines of the same arguments.

The results of computation of the oscillation amplitude Y (Y = $U^2 + W^2$) as a function of w; are presented in the Fig. 2. Calculations were carried out assuming that

1: A coordingly, only the rst term was kept in the sum over rincluded in (12). The dependence of Y on w calculated for k = 2 and k = 4 is shown in the left panel. In this case the central cross section of the FS for = 0is quasi-cylindrical. The oscillations am plitude takes on the largest value when = 0 and decreases monotonically as w increases. Both curves are asymptotically approaching the straight line Y = 1 = w hen w 1:As expected, the amplitude variation is much better pronounced for the curve 2. This curve is plotted for the larger value of the parameter k when the FS is closer to a cylinder near its central cross-section. In the right panel the behavior of the ampitude of quantum oscillations of the DOS upon a variation of the angle is show n under the assumption that the FS curvature diverges at the central cross-section at = 0: The curves presented here are plotted for k = 3=4 and k = 5=8: The second value of k corresponds to a stronger anom aly in the FS curvature at the extrem alcross-section. For k = 5=8; the oscillation amplitude increases monotonically with w and tends to the value 1= : For a less pronounced anom aly in the curvature (k = 3=4); the dependence of Y on w is nonmonotonic. However, in this case the decrease in the value of Y for sm all values of w is replaced by its increase when w takes on greater values.

Now, we remark that two parameters characterizing the FS local geometry were used in the present work, and they both could be easily evaluated provided that we possess relevant experimental data. The angle $_0$ describing the width of the FS strip where the curvature anom alies are revealed is a directly measurable quantity, and the shape parameter k introduced in the Eqs. (3)




FIG.3: The amplitude of the electron DOS quantum oscillations as a function of the magnetic eld orientation. Left panel: k = 2 (curve 1), k = 4 (curve 2). Right panel: k = 3=4 (curve 1), k = 5=8 (curve 2). The curves are plotted for ${}^2 = 10^3$:

4. AN APPLICATION : QUANTUM OSCILLATIONS IN THE ULTRASOUND VELOCITY

To make the presented results more speci c we apply our analysis to study the e ects of the FS boalgeom etry on the quantum oscillations of the velocity of ultrasound waves travelling in a metal. When an ultrasound wave propagates in a metal the crystalline lattice is periodically deform ed. It gives rise to electric elds which in uence the electrons. Besides, the periodical deform ations of the lattice cause changes in the electronic spectrum. Here, we om it these deform ation corrections to simplify further analysis.

The emergence of the electric eld accompanying the lattice deformation, leads to a redistribution of the electron density N : The local change in the electronic density N (r) equals:

The relation (17) has to be complemented by the condition of electrical neutrality of the system :

W e use these equations to express the potential' (r) in terms of the lattice displacement vector. As a result we derive the expression for the electron force F (r) acting upon the lattice under its displacement by the vector u(r). For a longitudinal ultrasound wave travelling along the magnetic eld B we obtain:

Here, b_0 is unit vector directed along the eld B: M ore thorough analysis taking into account deformation corrections to the electron energies does not bring qualitative changes in the expression (19). We arrive at the m odi ed expression for the force F (r) simply multiplying (19) by a dimensionless factor of the order of unity which could be treated as a constant.

Starting from (19) we obtain the well known result for the oscillating correction s to the sound velocity s:

where is the metal density and the sum mation is carried out over all extrem al cross-sections on the FS corresponding to the given direction of the magnetic eld. So, the above angular dependences of magnitudes of quantum oscillations arising due to the local geometry of the FS could be revealed in oscillations of the velocity of ultrasound waves propagating in metals.

5. CONCLUSION

In summary, we showed that when the FS of a metal inserts lines where its curvature turns zero or reveals discontinuity, this can signi cantly a ect both amplitude and phase of electron DOS oscillations in strong (quantizing) magnetic elds. The e ect arises due to increase/decrease of the relative num ber of electrons associated with the neighborhoods of these lines. It reveals itself at certain directions of the magnetic eld, and disappears when the magnetic eld is tilted away from such direction. This results in angular dependence of the DOS oscillation amplitudes. The latter could be observed in experiments on quantum oscillations in various characteristics of a m etal such as m agnetization, m agnetic susceptibility and resisitivity, for all these oscillations arise due to the DOS quantum oscillations. Quantum oscillations in the sound velocity discussed in this work is a mere example of the e ect of the FS curvature local anom alies on observables.

The most obvious materials where we can expect the FS curvature anomalies to be manifested include layered structures with metallic-type conductivity (e.g.

(BEDT TTF M Hg(SCN)₄ group of organicm etals). Ferm i surfaces of these materials are sets of rippled cylinders, isolated or connected by links [20]. The angular dependence of the magnetic oscillations magnitude resembling that shown in the Fig. 3 is well known for such materials. The appearance of this e ect shows that the quasi-two-dimensional FSs of some organic metals include segments with zero curvature. The e ect was rst analyzed in [21], and further discussed in some later works (see e.g. [20]).

Localgeom etry of the FSs of usual metals also can be displayed in the angular dependences of magnitudes of quantum oscillations. For instance, there is an experim ental evidence that \necks" connecting quasispherical pieces of the FS of copper include nearly cylindrical belts [1]. W hen the magnetic eld is directed along the axis of a \neck" (for instance, along the [111] direction in the quasim om enta space), the extrem al cross section of the \neck" could be expected to run along the nearly cylindrical strip where the FS curvature turns zero. It is also likely that the FS of gold possesses the sam e geom etrical features for it closely resembles that of copper. As for possible divergences of the FS curvature, experiments of [18] give grounds to conjecture that such anom alies could be found on the FSs of cadmium and zink. It is possible that the curvature is anom alously large at the edge of the electron lens which is the part of the FSs in both metals. For all above listed substances we can expect the e ect to be revealed at reasonably low tem peratures (1K) and reasonably strong magnetic elds (1 10T); giving additional information on the FSs ne geometrical characteristics.
