Approximation schemes for the dynamics of diluted spin models: the Ising ferrom agnet on a Bethe lattice

A bstract

We discuss analytical approximation schemes for the dynamics of diluted spin models. The original dynamics of the complete set of degrees of freedom is replaced by a hierarchy of equations including an increasing number of global observables, which can be closed approximately at dimensional dynamics of the hierarchy. We illustrate this method on the simple example of the Ising ferrom agnet on a Bethe lattice, investigating the more and more accurate predictions for the nite-time behavior. We also investigate the critical region around the phase transition, and the behavior of two-time correlation functions. We nally underline the close relationship between this approach and the dynamical replica theory under the assumption of replica symmetry.

1 Introduction

The last few years have seen a considerable increase in the research activity concerning diluted and disordered spin m odels. This recent interest is mainly driven by two very di erent, but technically closely related m otivations.

The rst one aim s at understanding common fundamental features of glassy systems, or more generally of out-of-equilibrium problems. Besides various other approaches [1, 2], the study of disordered spin models has led to important insights and given rise to the use of general concepts like, e.g., replica symmetry breaking on the static side β], or elective temperatures on the dynamic one [4, 5]. Most of these studies were performed on mean-eld models, and the validity of these concepts for nite-dimensional systems is still under discussion. For spin models, mean-eld has long been another name for fully-connected, i.e. models where each degree of freedom interacts with each other. More recently, a lot of e ort was invested in the study of diluted models [6, 7, 8, 9, 10, 11, 12]. These are still mean-eld like in the sense that they do not have an underlying geometric structure, and are thus analytically easier to treat than nite-dimensional problem s. At the same time, they have nite connectivity: each degree of freedom interacts only with a nite num ber of neighbors, and the concept of a local environment is well-de ned. This allows, e.g., to

introduce m icroscopically m otivated interactions. D iluted m odels can therefore be considered as an interm ediate step between the fully-connected and the nite-dimensional case.

A second major motivation for the study of diluted spin models arises from their close connection with a very interesting class of combinatorial optimization problems [13], including famous problems like satis ability of Boolean formulas and graph coloring for instance. These problems show phase transitions in the statistical properties of their solutions as well as in the dynamical behavior of algorithms [14, 15, 16], and have thus been extensively studied using tools and concepts originally devised for statistical mechanics purpose [17, 18, 19, 20, 21, 22].

D espite the large interest in diluted m odels, m any basic questions are still open. W hereas the m ain technical obstacles in analyzing the static behavior are solved by now, and the equilibrium properties of these m odels are quite well-understood, the know ledge on the dynam ical side [23, 24, 25, 26] is still relatively poor. Here we reinvestigate some approximative m ethods recently introduced for analyzing the behavior of stochastic local search optim ization algorithms [27, 28]. W e apply and generalize these ideas to a purely physical model, in order to better understand the assumptions behind the approximations m ade, and to assess their quality. W e concentrate on a very simple system, namely a ferrom agnetic Ising model de ned on a diluted network of xed connectivity, or B ethe lattice. This example allows to easily present, test and understand approximate methods which should be useful to treat more interesting, glassy problems. In fact the non-equilibrium avor of this work comes from the study of transient relaxation from an arbitrary initial con guration to thermal equilibrium, and not from the absence of thermal equilibrium as in the case of glassy systems, or from the lack of detailed balance as in previous investigations of algorithm s.

The paper is organized as follows. A fler this general introduction, the model and its equilibrium behavior are presented in Sec. 2. In Sec. 3 the dynam ical rules of the model are presented, and a hierarchical approximation scheme is developed. The rst three approximations are compared to numerical simulations in Sec. 4, and they are further exploited analytically to describe the critical behavior in Sec. 5. Sec. 6 is dedicated to an extension of the previous approximations to the analysis of two-time quantities. In Sec. 7 we unveil the relation of our approach to the dynam ical replica theory proposed by Coolen and Sherrington [29, 30]. Finally, the results are summarized in the last section, and possible future directions of research are presented.

2 The model and its equilibrium behavior

W e consider a ferrom agnetic Ising m odel on a Bethe lattice, given by its H am iltonian

depending on the microscopic con guration ~= ($_1$;:::; $_N$) of the N Ising variables $_i = 1$; i= 1; :::; N. The couplings J_{ij} take the value + 1 whenever two spin $_i$ and $_j$ are connected, and zero otherwise. C on pared to the usual form we have shifted the H am iltonian by its ground state value, and divided it by two. In this way, the H am iltonian sim ply counts the num ber of unsatis ed edges, i.e. the num ber of edges carrying anti-parallel spins on their extrem ities. It can thus be rewritten as

The reason why we choose this slightly modiled form will become clear below, it allows a simpler presentation of the dynamical equations.

As already said above, we consider this Ising model on a Bethe lattice. In accordance with the recent use in statistical mechanics [7], we de ne these as random regular graphs, i.e. all vertices have the same degree (number of neighboring sites) [31, 32]. These graphs are locally tree-like. In contrast to C ayley trees they have no boundary, all vertices have exactly K neighbors and are thus equivalent. The graph therefore contains loops for any K > 1. These are, how ever, of length

O ($\ln N$), i.e. they become long in the therm odynam ic $\lim it N ! 1$ (with K kept constant). Note that the random ness of these graphs appears only through these loops. On nite length scales they appear hom ogeneous due to their constant vertex degree.

Before investigating the non-equilibrium dynamics of this model, we shortly review its static behavior which can be easily solved using the Bethe-Peierls iterative approach [33, 7]. For doing so, we assume for a moment that our model is de ned on a tree, the long loops will be taken into account later as self-consistency conditions.

Consider a given bond (i; j), i.e. $J_{ij} = 1$. Let us denote Z_{ijj} ($_i$) the partition function of the subtree rooted in i, with (i; j) deleted, and with a xed value of spin $_i$. These partition functions can be easily computed iteratively,

where denotes the inverse tem perature. De ning the cavity eld

we obtain the iterative equations

At this point, we take into account the fact that the model is not de ned on a tree, but that all vertices have the same vertex degree and are thus equivalent. We are therefore looking for a self-consistent hom ogeneous solution of Eq. (5) with $h = h_{ij}$ for all bonds (i; j),

This equation has the obvious param agnetic solution h = 0. In fact, at high temperature this solution is the only one. There appears, however, a ferrom agnetic phase transition at the critical inverse temperature $_{c} = \ln (K = (K \ 2))$. For lower temperatures, the trivial solution is thermodynamically unstable, and two equivalent ferrom agnetic solutions h describe the equilibrium behavior of the model.

Here and in the following, without any loss of generality, we concentrate only on non-negative h. Once its value is known, we can immediately compute the Bethe free-energy density (total free-energy divided by N),

O ther interesting observables are the energy density

which equals $\frac{K}{2}$ (1 + e)¹ in the param agnetic phase, and the magnetization

which becomes positive for positive cavity eldsh. Note that the magnetization m depends on the cavity eld h via the true" e ective eld K h= (K 1) which incorporates the contributions of all K neighbors of a spin, cf. Eqs. (5,6).

To explain some steps of the dynamical approach, we also need the probability p (u) that a random ly selected vertex has spin value and belongs to exactly u unsatis ed edges, i.e. u out of his K neighbors have spin . This quantity is given at equilibrium by

with N_v being a norm alization constant enforcing $P_{u; p}(u) = 1$. This can be rewritten in terms of the energy density and the magnetization as

Similar expressions can be easily derived for the probability $p_{1/2}(u_1;u_2)$ that a random ly selected edge has a rst (resp. second) end vertex of spin $_1$ (resp. $_2$), and this vertex belongs to u_1 (resp. u_2) unsatis ed edges,

where N $_{\rm e}\,$ is again determ ined by norm alization.

3 Dynamical approximation schemes

3.1 De nitions

We will study the following local stochastic dynamics of the model: in each algorithmic step T ! T + 1, a site is chosen at random, i 2 f1; :::; N g. This site is characterized by its spin i and the number $u_i(\sim) = \int_j J_{ij}$; of its unsatise d incident edges. The spin is ipped to i with probability W ($u_i(\sim)$;). We denote the new conguration, with spin i ipped, by $F_i \sim$.

O byiously all edges incident to site i which were unsatis ed become satis ed, and vice versa. Hence the variation of the energy if the spin is ipped equals $E = K = 2u_i$. In order to reach them alequilibrium at inverse temperature in the long-time limit, we impose the detailed balance condition under the form

The two best-known possibilities falling in this category are the M etropolis rate,

W e will keep, how ever, a general form for W in our analytical treatment, only assuming Eq. (13) to be valid. In the therm odynamic limit, this discrete process acquires a continuous form by

dening the time as t = T = N, and stepwise di erences of extensive observables translate into time derivatives of the corresponding observable densities (extensive observables divided by N).

The dynam ics of the system, or more precisely of the probabilities P(~;t) that a microscopic conguration ~ is found at time t, can be completely described by the master equation

It is, however, far too complicated to solve these $2^{\mathbb{N}}$ coupled equations directly. We are therefore going to present several approximative characterizations of the dynam ics of them odel. They all rely on the same idea: instead of following the evolution of the full distribution P (~;t) of microscopic con gurations, we turn to a simplied description, in terms of a nite number of macroscopic observables. The dynamic evolution of these cannot be expected to be closed, as we have lost information with respect to the microscopic description. It depends in general on a larger number of macroscopic carefully a closure hypothesis at any level of this hierarchy, we are led to improvingly precise predictions.

In the next three subsections the set three levels of this hierarchy are presented, together with the corresponding closure assumptions. The evaluation of their accuracy is deferred until Sec. 4, where we compare them with numerical simulations.

3.2 The binom ial approxim ation

The simplest implementation of this idea consists in keeping track of the energy density e(t) and of the magnetization per spin m (t) only.

It is rather natural to include the energy in our set of observables. Indeed, the system is evolving towards equilibrium with respect to the G ibbs measure, in other words, at long times all the microscopic congurations with equilibrium energy are equiprobable. Including the magnetization is also necessary for a ferrom agnetic system, where the low temperature phase is characterized by a non zero value of the magnetization. In a more general setting, the minimal set of observables is given by the energy of the system and a complete set of order parameters which allow for the exact description of the equilibrium distribution.

At each time-step, the chosen spin has value and u unsatised edges around it with a certain probability p (u;t). If the ip is accepted, i.e. with probability W (u;), the total energy changes by an amount of K 2u (unsatised edges become satised, and vice versa), and the variation of the total magnetization is 2. We thus obtain in the therm odynamic limit:

A lthough exact, these equations are not of direct use because they involve p(u;t), a dynam ical quantity not present in our original description via fe(t);m(t)g. We thus have to express approximately p(u;t) in terms of e and m in order to close the set of equations. The random ly selected variable has spin with probability (1 + m(t))=2. In the absence of further informations, we can only assume that each of the K incident edges is unsatisticated with the same probability (t). This yields the approximate binom ial expression

can be determ ined by the following consistency condition. All unsatistic ed edges connect antiparallel spins. The energy must then be the same if expressed as the number of + spins around spins, or the other way around.

This expression has the same form as the equilibrium equation (11), but with e(t) and m (t) being dynamical variables, which can dier from their equilibrium values.

Equations (17), (18) and (21) can be condensed into

A few expected properties of these equations can be checked im m ediately:

 F_m (e;m = 0;) = 0 for all e and . If the system is strictly unmagnetized, the dynamics does not break this symmetry in the thermodynamic limit. In the low temperature phase, there is of course an instability with respect to magnetization uctuations (which are present in any nite system), as we shall show in Sec. 5.

 $F_e(e_p; m = 0;) = 0$ where $e_p = \frac{K}{2}(1 + e)^{-1}$ is the param agnetic energy density at inverse tem perature . To prove this, one can note that in that case

U sing the detailed balance condition on W and the change of variables u 7 K u in one of the sum s de ning F_e , one thus shows that the param agnetic state is a xed point of the dynam ics.

 $F_e(e_f;m_f;) = F_m(e_f;m_f;) = 0$ for > c, where m_f and e_f are the magnetization and the energy density of the ferrom agnetic phase. Indeed, relation (24) is still valid, as can be seen from (10), and the proof follows the same line as in the paramagnetic case: the ferrom agnetic state, when present, is also a xed point of the dynamics.

3.3 Independent-neighbor approxim ation

In the last section, we have described the dynam ics of our ferrom agnetic m odel by m apping it to two coupled di erential equations for the energy and the m agnetization. In order to approxim ately close these equations we had to assume a speci c binom ial form for the quantities p (u;t) which is exactly valid only in therm al equilibrium, but not for interm ediate times. It seems therefore natural to extend the set of considered observables, and to look for dynam ical equations forp (u;t) itself. Note that on regular graphs, these quantities still form a nite set of observables. This would not be the case for a graph with unbounded uctuations of the connectivities.

To form ulate the dynam ical equations, we have to take into account di erent contributions to the variation of p (u;t) during a time-step:

The rst type of contribution is due to the ipped spin itself, i.e. is ipped to . All incident edges change from satis ed to unsatis ed and vice versa, i.e. we have u \$ K u.

The second type comes from the neighbors of the ipped spin. For these vertices, remains obviously unchanged, but u is increased or decreased by one depending on whether the connecting edge was satis ed or not before the ip.

Including the corresponding loss and gain term s, we nd the following exact equations,

where p(uj; v!; t) is the conditional probability that a vertex of spin belongs exactly to u unsatis ed edges, under the condition that this vertex is reached via an edge coming from a vertex with spin ~ and with v unsatis ed bonds. This probability can be computed from the joint probability p_{-} (v;u;t) of two adjacent vertices which, in the equilibrium context, was already introduced at the end of Sec. 2:

As in the previous subsection, these exact equations do not close. The time evolution of the probabilities p(u;t) is given in term softhe correlations between neighboring vertices, $p_{-}(u;u;t)$. We can, however, close the equations at least approximately by considering neighbors as independent [28],

i.e. the conditional probability does not depend on the properties of the initial vertex, but only on the fact that we reach the new vertex via a satis ed or an unsatis ed edge. In the last equation we have used the short-hand notation h i = p(u;t). Note that this does not describe an average since, for instance, hli equals the fraction of spins with value , and norm alization holds only for h i + h i.

Under this approximation, Eq. (25) closes in p (u;t) and becomes

An important observation is that Eq. (27) becomes exact for the equilibrium distributions (10) and (12). Therefore the true therm al equilibrium is a xed point of the closed dynamical equations. For intermediate times, however, there will be deviations from Eq. (28). Since the description via p (u;t) is, however, more detailed than the one of the binomial approximation, we expect deviations to be less important. A thorough comparison with M onte-C arb simulations will be given in Sec. 4.

These equations are ordinary di erential equations and can thus be solved numerically by standard methods. One has, however, to be careful with the choice of initial conditions. In fact, not every normalized p (u) corresponds to microscopic con gurations ($_1$;:::; $_N$). A necessary

and su cient consistency condition is given by the fact that each unsatis ed edge connects two antiparallel spins, see the discussion before Eq. (20). Therefore

must hold for arbitrary time t. Restricting the allowed initial conditions to all p (u;t) fullling this condition, consistency is preserved by the dynam ical evolution (28). This in fact guarantees that the only stationary points of the dynam ics are the solutions of the equilibrium study of Sec. 2. In the high-temperature phase, the param agnetic solution attracts the dynam ics, while the low-temperature phase allows for three stationary points. The two ferrom agnetic ones are stable, whereas the param agnetic solution is unstable with respect to any spin- ip asymmetry (p (u;t_0) \in p (u;t_0)) in the initial condition.

3.4 Inclusion of neighbor correlations

In order to further re ne the description of the non-equilibrium behavior of the model, we may \iterate" the step which led us from the binom ial to the independent-neighbor approximation. The exact equations for the evolution of the single-site quantity p(u;t) depend on the joint distribution $p_{-}(a;u;t)$ for neighboring sites. Formulating an equation for the time evolution of the latter quantity, which again includes a nite set of functions, we nd an equation including three-spin correlations. Approximately, these can be expressed in terms of the two-spin distribution, and the dynamical equations close. In the formulation of the equations we have to include the e ects of the ipped spin itself, and of its rst and second neighbors. We only give the resulting equations, where the time dependence is not stated explicitly to lighten notations:

where $(u_1 \ u_2)$ m eans that the complete expression on the right-hand side of the equation with u_1 and u_2 interchanged has to be added. In the following, these equations will be denoted shortly as link approximation. As in the case of the single-site quantities, they have to be solved numerically. The p (u) can be recovered from the pair distribution in two distinct ways:

These two procedures must yield the same value of p (u). This consistency condition ensures, in analogy to Eq. (29) for the previous approximation scheme, that the only stationary points are those given by the static approach.

In principle, one could go on like this, i.e. equations for higher-order correlations can be written down exactly. They will depend on even higher correlations, and an in nite hierarchy of exact equations arises. This hierarchy can be cut approximately at any arbitrary level by factorizing higher correlations. Since the number of order parameters used to describe the dynamics increases with each level, and the observables of lower levels are contained via consistency conditions, the description is expected to become more and more precise. On the other hand, the equations become more and more complex, as is already clear when one compares them for the three rst levels of the approximation hierarchy. Instead of continuing further in this way, we compare now the results of the rst three approximation levels with M onte C arlo simulations. As we shall see, already these approximations give an astonishing coincidence with numerical data.

4 Comparison with num erics

The approximation schemes presented in the last section do not possess any intrinsic criterion to measure their quality. We therefore have performed numerical simulations for large graphs in order to check all three schemes.

To do so, we have not generated large random regular graphs $(N = 3 \ 16)$ of various connectivities, according to the algorithm of [32]. Then we have perform ed M onte C arb simulations of the ferror agnetic Ising m odel de ned on this graph. In these simulations, we have used as well G lauber as M etropolis dynamics, cf. Sec. 3.1. In the following presentation we concentrate, however, solely on the M etropolis case. The results for G lauber dynamics di er quantitatively, but the coincidence between num erical and analytical results has the sam e quality. To suppress nite-size uctuations, which become important for large times close to the critical point, we have averaged num erical data for up to 200 independent runs on independently generated graphs.

In general, we have initialized the system in the following way: all spins are assigned random by and independently a value, with a certain bias in order to impose some initial magnetization on the system. Note that this conguration is not an equilibrium conguration for any arbitrary temperature. Then we have measured the relaxational dynamics from this non-equilibrium conguration to them all equilibrium, and recorded in particular the time evolution of the energy density e(t) and of the global magnetization m(t).




Figure 1: Energy density as a function of time. The three approximations (dashed line = binomial, dash-dotted = independent neighbor, full = link approximation) are compared to numerical simulations (symbols, N = 3 10; K = 3, averaged over 200 runs, error bars are smaller than the symbol size) for inverse temperatures = 1.0; h 3; 12 (top to bottom), with critical value $_{\rm c}$ = h 3. In the initial condition all spins were drawn independently, with average magnetization 0.1. In the main plot, the independent neighbor approximation is not shown because, on the scale of the gure, it is very close to the link approximation. The shoulder in the curve for = 12 is located close to the paramagnetic energy value, the relaxation to the ferrom agnetic state appears on a longer time scale. The inset enlarges the region of largest deviation between the di erent approximations for $_{\rm c}$. O by bously, the more involved schemes lead to better approximations, the di erence between the link approximation and the numerical data is hardly visible.




Figure 2: M agnetization as a function of time. The parameters and symbols are the same as in Fig. 1. Again, the coincidence of the link approximation with the numerical data is excellent for the full time interval.

As a result, as represented in Figs. 1 and 2, we have found the following behavior: for very short and very long time, all three approximation schemes are in extremely good coincidence with numerical data. This is even true close to the critical temperature, all three schemes reproduce with high precision the critical slowing down, i.e. the diverging longest time scale in the system. Exactly at the critical point, all three approximation schemes show the correct algebraic relaxation towards equilibrium. So even the simplest approximation, which can be analyzed in large detail, see the next section, allows for a precise estimate of the relaxational dynamics close to equilibrium.

As shown in the insets of Figs. 1 and 2, considerable deviations between numerical data and analytical predictions appear only for interm ediate times. As to be expected, these deviations become smaller form ore detailed approximations. In the link-approximation, these deviations are hardly visible for all times, even at the critical point.

In addition, we have observed an increasing precision of all three approximations for growing K. We expect therefore, that the binomial approximation becomes exact in the large K limit [27].

5 Critical behavior

In this section we investigate in m ore detail the predictions of our approximations in the critical region of temperatures separating the paramagnetic and the ferrom agnetic phase. For the sake of simplicity, we concentrate on the static levels of approximations, for which more detailed computations can be done explicitly.

As we have seen before, all the presented dynam ical approximations have xed points corresponding to param agnetic and ferrom agnetic equilibrium. One has to study now the nature of the dynam ical ows in the space of projected order param eters. At high tem peratures, the only xed point is the param agnetic one, and it is obvious on physical grounds that it will be stable. In the low tem perature phase, this xed point will become unstable and the two ferrom agnetic ones will attract the dynam ics.

Quite generally, if the projected evolution is described by an n-component vector q(t) of observables, the system's evolution is given by n equations $q_i = F_i(q)$. Fixed points correspond to $F_i(q_0) = 0.8i$. They are locally stable if and only if all eigenvalues of the n n matrix M are negative, where M is de ned by its entries $M_{ij} = (@F_i) = (@q_j)$, evaluated at the xed point under consideration. In this case, the asymptotic relaxation of a uctuation towards equilibrium is given by the largest eigenvalue m_{ax} (sm allest in absolute value), and the longest relaxation-time scale of the m odel reads

Approaching the critical point, this eigenvalue tends to zero. The system slows down until the relaxation time eventually diverges at $_{\rm c}$. Right at the critical point, uctuations decay only algebraically with time.

5.1 Relaxation time and critical slowing down in the binom ial approximation

In the sim plest case of the binom ial approxim ation, the space of parameters is only two-dimensional, the state of the system being characterized by its magnetization and energy. Following the notations of Sec. 32, we denote the matrix M by

This matrix takes a particularly simple form when computed at the paramagnetic xed point. Indeed, the symmetry of the system undermagnetization reversal causes the non-diagonal elements to vanish, and one can directly read the eigenvalues of M in the diagonal entries,

It is obvious from these expressions that M $_{ee}$ is negative at all tem peratures, and that M $_{mm}$ changes its sign at the critical tem perature $_{c} = \ln (K = (K 2))$. At low tem perature, the paramagnetic xed point becomes unstable against uctuations of the magnetization, as expected on physical grounds.

From the above expression of M $_{m\,m}$ one obtains the divergence of the relaxation time of the system when approaching the critical temperature from above,

In the low tem perature phase, at the ferrom agnetic xed point (we consider only the one with positive magnetization for simplicity), the four elements are dimensional terms. Both eigenvalues of M are negative, implying the stability of the ferrom agnetic phase. As their expressions at general temperature is not very illuminating, we concentrate on the $! \frac{+}{c}$ limit, for which one nds the following scaling of the matrix elements:

5.2 Relaxation time and critical slowing down in the independentneighbor approximation

The analysis becomes more involved in the independent-neighbor approximation. As said above, we have to compute the 2(K + 1) = 2(K + 1) matrix

The relaxation times equal m inus the inverse eigenvalues of this matrix. One has, however, to be careful since not all eigenvectors correspond to physically allowed deviations of p (u;t) from its equilibrium value. As already discussed in Sec. 3.3, the values of p (u) are restricted by norm alization and by the consistency condition (29). The corresponding eigenvectors, one being proportional to p (u) itself, the other one to the deviation p (u)=0 h according to a deviation of

the eld h away from its self-consistent cavity value, correspond to zero eigenvalues of M , and have to be excluded.

The most e cient way to achieve this is to explicitly require normalization and consistency by, e.g., expressing p (K;t) through the other values p (u;t) with u < K. From normalization and consistency we immediately nd

The matrix M becomes thereby reduced to a 2K -dimensional matrix M with entries $(u_{1,2} = 0; ...; K = 1)$

B esides the excluded unphysical eigenvectors, this matrix has the same eigenvalues and eigenvectors as M $\,$.

Unfortunately, we were not able to nd a general expression for the smallest eigenvalue of M⁻ for arbitrary temperature, and thus of the longest relaxation time of the system. For small values of K, the latter can, however, easily be evaluated using a standard computer-algebra system . We nd, in complete accordance with the binom ial approximation, that the longest relaxation time scale diverges like $_{p} = A_{K} (_{c})^{-1}$ if the critical point is reached from the paramagnetic side, and like $_{f} = \frac{1}{2}A_{K} (_{c})^{-1}$ coming from lower temperature. We thus nd the same critical exponent and the same universal amplitude ratio 1=2. Only the prefactors are slightly modi ed, with a di erence of about 1-2% only between the estimates of the binom ial and of the independent-neighbor approximations. The values for M etropolis dynamics are recorded in the table below.




Figure 3: M etropolis relaxation time for K = 3 in the param agnetic (top) and the ferrom agnetic (bottom) phase. We have plotted the results of the binom ial (dashed line) and the independentneighbor (full line) approximations as extracted from the exact eigenvalues of the matrices M. The dotted line gives the asymptotic algebraic divergence in the param agnetic phase. The symbols are extracted from numerical simulations (N = 3 10, 20 samples).

In Fig. 3, the results of both approximations are compared to numerical data. The results of the independent neighbor approximation are slightly higher than the binomial ones. In perfect agreement with this observation, also the numerical data are found to systematically deviate towards slightly higher relaxation times. Note, however, that the extraction of the relaxation time in the ferrom agnetic phase is slightly subtle: the time interval between the pre-asymptotic and the uctuation-dominated dynamics is rather short even for large systems ($N = 3 = 10^{\circ}$, averaged over 20 sam ples).

5.3 A lgebraic relaxation at criticality

At the critical point $_{\rm c}$, the longest time scale diverges, and the observables of the system decay only algebraically towards their equilibrium values. W ithin the binom ial approximation, the dynamical exponents for energy and m agnetization decay as well as their prefactors can be determined analytically.

The equilibrium at the critical point is given by a non-magnetized state of energy density $e_c = \frac{K}{4} \frac{(K-2)}{(K-1)}$. If the initial condition has vanishing magnetization, the energy relaxes exponentially

towards e_c . However, if the evolution starts from an initial condition of arbitrarily small, but non-zero magnetization, the dynamical evolution shows a power-law dependence in time.

Let us denote the excess-energy density by $\hat{e} = e_c$, and expand the evolution equations around their xed point (e_c ;m = 0). Exploiting the spin- ip symmetry m m and the fact that $\hat{e}_m F_m$ vanishes at the critical tem perature, we obtain for the lowest orders

Seen that the lhs of the rst equation is of 0 (t z_e^{-1}), the asymptotically larger 0 (t z_e^{-1})-term on the rhs has to be compensated by the second contribution with 0 (t z_m^{-1}). This results in $z_e^{-1} = 2z_m^{-1}$. The lhs of the second equation is of 0 (t z_m^{-1}), whereas the two dom inant terms on its rhs are of 0 (t z_e^{-1}) = 0 (t z_m^{-1}). Comparing the order of these terms we consequently nd

Note that there are two solutions $m_0 = \frac{p_m_0^2}{m_0^2}$, depending of the sign of the magnetization in the initial condition. The quality of the agreem ent between these predictions and num erical simulations (not show n) is comparable to the one of previous subsection.

6 Two-time correlations

We brie y sketch in this section an extension of the previously introduced approximations to the study of two-time quantities, more precisely of the global auto-correlation function of the spins,

These will be, in the therm odynam ic limit, sharply peaked around its average value (with respect to the possible histories of the microscopic dynamics). We suppose in the following t_2 t_1 to simplify the notations. To compute this function, we shall consider t_2 as the evolution time and project the dynamics onto a global observable which retains a trace of the microscopic con guration at the earlier time t_1 . More precisely, let us call $q_{1/2}$ (uu; us; su; t_1 ; t_2) the fractions of sites whose spin equals t_1 at time t_1 and t_2 at time t_2 , and which have around them

uu edges which are unsatis ed at both tim es,

us which are unsatis ed at tim e t_2 and satis ed at tim e t_2 ,

su which are satis ed at time t_2 and unsatis ed at time t_2 ,

and ss K uu us su which are satis ed at both times.

W e introduce the notation

which is again not a norm alized average for a given value of $_1$ and $_2$, but only when the sum is taken over all indices, $hli_{++} + hli_{+-} + hli_{+-} + hli_{--} = 1$. The two-time correlation of the spins can be obtained from q, and reads in this short-hand notation:




Figure 4: Two-time correlations C ($t_1 + ;t_1$) as a function of , for K = 3. Solid lines: numerical integration of the di erential equations, see the text for details. Sym bols: M onte C arb sim ulations. Left: = 1, $t_1 = 0$. Numerical simulations averaged on 200 sam ples of size N = 10^7 . Right: = 12, $t_1 = 0$ (bottom), 30 (m iddle), 150 (top). Numerical simulations averaged on 200 sam ples of size N = $3 \, 10^6$, error bars are sm aller than the sym bol size.

An evolution equation with respect to t_2 for $q_{1/2}$ (uu; us; su; t_1 ; t_2) can be closed using factorization approximations similar to those used in Sec.3.3, here we only state the result:

where we suppressed the explicit time dependence of q in the right-hand side to lighten notations.

O ne can easily exploit these equations to compute the two-time correlation C (t_2 ; t_1) for a given initial conguration at t = 0. The rst task is to determ ine p ($u_i t_1$) by a numerical integration of the equations (28) between t = 0 and $t = t_1$. Using then the boundary condition (59) and the evolution equations (60), one obtains q and nally C through (56). We confront in Fig. 4 the results of such a procedure with M onte C arbo numerical experiments, which are in satisfying agreem ent with each other.

7 Connection with dynam ical replica theory

7.1 Basic assumptions of dynamical replica theory

In this section, we are going to show the equivalence of our approximations to the dynamical replica theory (DRT) [29, 30] under the assumption of replica symmetry. To do so, we will derive

the closure equations we used in Sec. 3 starting from the assumptions of the dynamical replica approach.

Sim ilar to our approach, DRT aim s at an approxim ate description of the non-equilibrium dynam ics of disordered system s by m eans of projecting the dynam ics onto an array q of n observables, and by approxim ately closing the corresponding equations. The m ethod becom es exact if the follow ing two properties are fulled:

- (i) The observables in q have self-averaging properties along the dynam ics, i.e. they follow their average trajectories with probability one in the therm odynam ic lim it.
- (ii) At each time, all microscopic congurations ~ = ($_1$; ...; $_N$) having the same values of all observables in q are equi-probable.

The rst assumption is not expected to pose serious problems if, e.g., densities or fractions of vertices with certain characteristics are considered. The second assumption, on the other hand, is much more crucial: it is obviously true in them alequilibrium if the energy density is included in q. Indeed the probability distribution of microscopic con gurations is then given by the Boltzm ann-G ibbs distribution, i.e. it depends on the actual con guration only via one observable, the energy. There is, however, no reason why this should hold far from equilibrium. In fact, as discussed before, we have observed that the inclusion of more and more sophisticated observables gives a better and better description of the dynamics of the system .

At variance with the original DRT, where replicas are introduced to average over the disorder of the Sherrington-K inkpatrick m odel [34], we are going to use the cavity m ethod [7]. The latter is m ore e cient to average over the quenched disorder of diluted system s, in our case represented by the random regular graph on which the Ising m odel is de ned. Even if this average is alm ost trivial in the case of a random regular graph, where the disorder enters only via large bops, i.e. via self-consistency conditions, this m ethod can be easily extended to uctuating connectivities or random interaction strengths.

7.2 The binom ial approxim ation

Let us start the discussion with the binom ialapproxim ation, i.e. with the case where the dynam ics is completely approxim ated by the behavior of the energy and the magnetization densities. The two assumptions of DRT stated above result in the following approximation,

Instead of working directly in this generalized m icro-canonical fram ework, we use a generalized canonical approach introducing conjugate parameters for the energy, i.e. a form al inverse tem perature (e;m), and for the m agnetization, i.e. a form alexternal eld (e;m). We thus replace Eq. (61) by

Note that the form altem perature (e;m) is different from the physical temperature, as long as the system is not equilibrated. Both conjugate parameters have to be adjusted such that the average values of the energy and magnetization density assume the desired values e(t) and m(t). In the therm odynamic limit, the measure becomes sharply concentrated around these values.

U sing these weights for the m icroscopic con gurations, we have to prove that Eq. (21) holds, i.e. that the two assumptions of DRT lead to the same closure of our approximate dynamical equations. This can be easily obtained using the Bethe-Peierls approach sketched in Sec. 2, the only modi cation is due to the additional external eld. The analysis follows, how ever, exactly the same steps, and it leads in particular to the desired binomial closure assumption.

7.3 The independent-neighbor approxim ation

The case of the independent neighbor approximation is only slightly more involved. We have to show that the assumption that all congurations with the same p(u) are equiprobable leads to the desired factorization of the joint distribution of neighbors, and thus to the dynamical equations of Sec. 3.3. More precisely, we demonstrate that, under the above-stated assumption, the conditional probability of nding a vertex with u_2 unsatisted edges, following a ! edge from a vertex with u_1 antiparallel neighbors, equals

As in the the previous section, we can circum vent the explicite microcanonical calculation by going to a generalized canonical ensemble by introducing form allowerse temperatures (u) for every pair (;u). These form altemperatures have to be adjusted in order to constrain the p(u) to the desired values. Out of equilibrium, they are not directly related to the physical temperature .

W e consequently have to determ ine the partition function

P roceeding in close analogy with Sec. 2, we introduce partial partition functions Z_{ijj} ($_i;u_{ijj}$) for the subtrees rooted in vertex i, with edges (i; j) removed. The values of $_i$ and u_{ijj} are xed, where u_{ijj} denotes the number of unsatised edges including vertex i but not j. D enoting the set of all neighbors of i in the subtree by V_{ijj} , the partition function can be calculated by an iterative procedure:

Introducing generalized cavity elds as $h_{ijj}(;u) = \ln fZ_{ijj}(;u) = Z_{ijj}(1;K)$ 1)g, and boking for a hom ogeneous solution $h_{ijj}(;u) = h(;u)$ for all edges (i; j), we obtain the following 2K 1 self-consistency equations:




Figure 5: On the left, an example for a subgraph contributing to p_+ (2;3) is given. W ithin the cavity calculation, the in uence of the exterior part is replaced by the corresponding cavity elds h(+;1) and h(;2), cf. Eq. (70).

Note that, by plugging Eq. (67) into (68), these equations can easily be reduced to only three self-consistent equations for f(+;+), f(+;) and f(;), whereas f(;+) = 1 by de nition. Once these quantities are known, we can immediately determ ine the distribution

As already said, the form altern peratures have to be adjusted in such a way that all p (u) take the desired values.

In order to show that the independent-neighbor approximation holds in this ensemble, we have to calculate the joint distribution $p_{1;2}(u_1;u_2)$ for neighboring vertices. As an example we are analyzing the case $_1 = +1$, $_2 = 1$, the other combinations work out analogously, see Fig. 5 for an illustration:

For the conditional probability given in Eq. (63) we thus nd

$$p(u_2 j+;u_1 !) = \frac{p p_1 (u_1;u_2)}{u_2 p_1 (u_1;u_2)} / u_2 p (u_2)$$

which is exactly the independent neighbor approximation applied to close the dynamical equations in Sec. 3.3.

This derivation can be easily generalized for the link approximation scheme. We thus conclude that the presented approach is equivalent to DRT under the assumption of replica symmetry. On the other hand, focusing on nite-connectivity models makes this approach more elegant and intuitively understandable, compared to fully connected models for which the analogous equations are much more involved [30].

8 Conclusions and outlook

To sum marize, we have studied the dynam ics of the Ising ferrom agnet on a Bethe lattice. This simple and, from the point of view of statics, well-analyzed model serves as an ideal testing ground

for a series of dynam ical approximation schemes rst introduced in the context of the analysis of stochastic local search optimization algorithms. In particular, we have obtained a detailed characterization of the critical behavior of this mean-eld model.

W hereas the presented approximation schemes work very well in this simple case, there remain crucial open questions in the dynamic of disordered diluted systems, where the disorder can be present either in uctuating vertex degrees or in random ly chosen interactions strengths.

A rst interesting application of our approach would therefore be the study of disordered ferrom agnets in their G ri th phase [35, 36]. This phase is characterized by an anomally slow relaxation behavior even in the high-tem perature param agnetic regime, which results from the existence of large regions of higher than average coupling strength.

An even more challenging problem appears if fustration is included into the model, i.e. if we turn to systems displaying a low-temperature spin-glass phase. Here the connection of our approach with DRT becomes important and opens the way for the inclusion of replica symmetry breaking e ects. A challenging task in this direction would be to reproduce with such a dynam ical approach the subtle phenomena of cooling schedule dependence investigated numerically in [37].

Finally, we want to mention as a future direction of research the re-ned analysis of stochastic local search algorithms which solve (or approximate) optimization problems like 3-satiability or graph coloring. This includes, e.g., the analysis of the in-uence of greedy heuristic steps, which was out of range before [38].
