## Short-Term M em ory in OrthogonalNeuralN etworks

W e study the ability of linear recurrent networks obeying discrete time dynam ics to store long tem poral sequences that are retrievable from the instantaneous state of the network. We calculate this tem poral mem ory capacity for both distributed shift register and random orthogonal connectivity matrices. We show that the mem ory capacity of these networks scales with system size.

The brain holds inform ation in short-term memory for use in prospective action. It is thought that persistent ring patterns in cortical networks subserve such working memory and several mechanisms have been proposed [1]. In some, a stimulus, such as a spoken word or a picture activates a pattern of neuronal activity that persists for several seconds because it corresponds to an isolated stable xed point of the dynamics [2]. However, working memory offen involves memorization of graded signals, such as stimulus location in 2D space or the eye's gaze, which are hard to associate with discrete attractors. Recent models propose that short-term memory is associated with low dimensional continuous manifolds of attractors. B oth network [3] and single cell mechanisms [4] have been in plicated in generating these manifolds.

M ore recently it was suggested that a generic recurrent network can store arbitrary tem poral inputs in its transient responses, even though these responses do not correspond to attractors, and that working memory operates by reconstructing input history from the network's current state [5, 6]. This proposal has been investigated num erically for som e recurrent networks but its theoretical underpinnings are unexplored. For instance, how does a network's storage capacity for tem poralm em ory scale with system size? W hat network architectures are suitable? How do noise and structural perturbations affect memory? Such issues have important implications for general dynamical systems. To what extent can the history of perturbations on a dissipative system be reconstructed from its current state? How does the transient m em ory of a dynam ical system depend on its num ber of degrees of freedom and the amount of noise? In this paper we develop theoretical understanding of the capacity of linear recurrent networks to store tem poral signals.

M odel: W e consider here the discrete tim e m odelproposed by Jaeger [6]. A tim e dependent scalar signal, s(n), is m em orized by a linear recurrent network with N neurons obeying the discrete tim e dynam ics:

x (n) gives the network state at time n, v is a unit norm




FIG.1: A rchitecture of the short-term memory network. A single input unit, s, feeds into an N unit recurrent network. Each of an array of readout units reconstructs the input at a given past time.

constant vector of connections from the input source, W is the matrix of recurrent connections which need not be symmetric, and z(n) is a noise vector. To ensure dynam ical stability, we require < 1, where is the norm squared of W 's largest eigenvalue. The goal is to extract the scalar history of the signal, fs (m) in ng, from the current network state x (n). This is achieved using a layer of linear readout neurons, the state of which at time n is given by  $y_k(n) = u_k^T x(n); k = 0; 1; 2; ..., see Fig. 1. u_k$ is a constant vector of output connections from the recurrent network to the k-th readout neuron. It is chosen to m in in ize m can square deviations hjy<sub>k</sub> (n) s (n k)<sup>2</sup> ji<sub>n</sub> so that  $y_k$  (n) is close to s (n k), where h::: denotes a time average. The resultant optimal output weight is  $u_k = C^{-1} p_k$  where  $C = x (n) x^T$  (n) <sub>n</sub> is the covariance matrix of x, and  $p_k = hs(n k)x(n)i$ ; The ability to embed signals in the network may depend on their statistics. Here we characterize the signal ensem ble by  $hs(n)i_n = 0$  and  $hs(n)s(n + k)i_n = k_{i,0}$ . The noise vectors have zero m ean, hz (n)  $i_n = 0$  and variance  $hz_i(n)z_i(n+k)^T i_n = k_{ij}$ . W ith the above signal and

noise statistics,  $p_k = W^k v$ , and

where the scaled noise covariance is C  $_n$  =  $\mathop{}^{P}_{\phantom{P}k}W^{-k}W^{-kT}$  .

M em ory function: W e de ne the system 's m em ory function as the overlap between the past input and its reconstructed value, m  $(k) = hs(n \quad k)y_k(n)i_n$ . W ith the above statistics,

 $m(k) = 1 \text{ corresponds to perfect reconstruction, } y_k(n) = s(n k), whereasm(k) = 0 \text{ indicates nomemory of s}(n k). For an arbitrary, stable connection matrix W,$ 

This sum rule provides a useful indication of the network's short term m em ory. For zero noise, the area under the memory function is exactly N, implying that all N degrees of freedom are useful for storage. Storage capacity decreases with strength of noise. System perform ance also relates to the shape of m (k). Since 0 m (k) 1, it follows that the length of signal that can be exactly reproduced is also bounded. To characterize the length of time over which a signal can be retrieved with reasonable accuracy, we de ne the tem poral capacity  $k_c$  as the minimum value of k such that m (k) <  $\frac{1}{2}$ . We focus particularly on the conditions under which the system 's capacity is extensive, namely  $k_{\text{C}}$  \_ N as N  $\ !$  1 . For given noise, we de ne<sup>opt</sup> as the value of at which capacity achieves its maximum ,  $k_c^{opt}$  .

D istributed Shift R egister (D SR ) N etwork: A straightforward candidate for a short-term memory system is a delay line, or a shift register network, which corresponds to a one-dimensional network with W  $_{ij} = \sum_{i,j+1}^{n} 1$ , and  $v_i = \sum_{i,j+1}^{n} 0$  ne drawback of this system is its extrem e sensitivity to removal of a single neuron. A more robust, distributed architecture of the shift register operation is a fully connected network with

where  $v^{(k)}$  is an arbitrary set of N orthonormal vectors. Note that W  $v^{(k)} = {\stackrel{p}{-}v^{(k+1)}}$  for k = N 1 and W  $v^{N} = 0$ , implying that W  $^{N} = 0$  [7]. In this network the covariance matrix is

where e = = (1). The memory function is given by




FIG.2: M em ory capacities of D SR and O rthogonal networks for  $= 10^{4}$  and N = 400 at various values of . For the O rthogonal network, the circles show simulation results and the solid lines show predictions of the Annealed A pproxim ation, which begins to break down for very near 1. W hile the m em ory of the D SR im proves with increasing , the capacity of the orthogonal network peaks at <sup>opt</sup> = 0:98.

and m (k) = 0 for k N. In zero noise, x (n) =  $P_{k=0}^{N-1} k^{s-2} s(n-k) v^{(k+1)}$ . Thus the network embeds each of the previous N signal values in a distinct orthogonal direction v<sup>(k)</sup> for k up to N 1. An important question in both this and the follow ing models is how the value of a ects the system performance. In the absence of noise the present model retrieves perfectly the most recent N inputs for all values of , as implied by Eq. 7. How ever, the required readout weights  $u_k = k^{s-2} v^{(k+1)}$  for the retrieval of these m em ories increase with decreasing , limiting the choice of to values close to 1.

N on-zero noise contributes to x (n), polluting the signalbut leaving xed the directions along which tem poral signals are embedded. W hen > 0, m (k) < 1 for all k. The capacity  $k_c$  is greater than 0 for all < 1. It increases with decreasing and saturates to  $k_c = N$  at zero noise. For xed noise, increasing increases signal-to-noise ratio and hence m (k) increases, see Fig.2. Thus  $^{\text{opt}} = 1$  for all values of noise > 0.

R andom O rthogonal N etwork: W e next ask whether broader classes of connection matrices can also store long tem poral signals. A plausible extension of the above m odel is to a network with W =  ${}^{P}$  O where O is an N N orthogonalmatrix (i.e., OO<sup>T</sup> = 1) and < 1. Similar to the DSR m odel, W performs a rotation followed by a shrinking with factor  ${}^{P}$ . However W  ${}^{k}v$  and W  ${}^{k+1}v$  are not necessarily orthogonal, in contrast to the DSR. M oreover while W  ${}^{N}$  = 0 for the DSR, orthogonal W is full rank. Consequently, inputs from times earlier than N can interfere with current inputs. For any choice of 0 and v the covariance m atrix is

However the system behavior can depend upon the particularO and v.W e therefore considerO drawn from the G aussian Orthogonal Ensemble (GOE) and input connections v from a G aussian distribution with  $v^T v = 1$ . W e evaluate m (k) =  $hp_k^T C^{-1} p_k i$  where the average is over these ensembles and captures the typical behavior for N large. Exact analytical evaluation of m (k) is com plex and requires accounting for statistical correlations between powers of random orthogonal matrices. In the following we solve the problem under the \Annealed Approximation" (AA), in which W and v are not quenched in time but drawn random by at each time step. Under this approximation,

To see this, rst note that in the annealed scenario  $p_k = v^{(k)}$  where  $v^{(k)}$  is an in nite set of independent random normalized vectors. Hence,

where  $C_0 = C_k v^{(k)} v^{(k)T}$  is independent of the random variable  $v^{(k)}$ . Expanding in powers of k and averaging over  $v^{(k)}$  yields Eq. (9) for the memory function where

The last equality holds for large N because TrC  $^{1}$  TrC  $_{0}^{1}$  s  $^{k}$  v  $^{(k)T}$  C  $_{0}^{2}$  v  $^{(k)}$ , which is only of order 1 due to the normalization of v  $^{(k)}$ . Eq. (10) for q is obtained from the sum rule Eq. (4) by substituting C  $_{n} = (1 )^{1}$  I. Though the annealed approximation neglects quenched correlations, it agrees suprisingly well with the num erical solution of the quenched system for all values except for ! 1, seen in the exam ples of Fig. 2 for  $= 10^{4}$ .

To analyze the network's behavior, we rst consider the limits (1)=N, =N ! 0 for N ! 1. In this case, the sum of (k) is nite so Eq. (10) gives  $q = 1=^{n}$ ; and thus Eq. (9) reduces to




FIG. 3: Capacity per neuron as a function of = N (1), at = 0.04, showing non-monotonic dependence. Points from simulations on di erently sized system s fallon essentially the same curve, con m ing that in this regime capacity is extensive. The inset shows the dependence of  $k_{\rm C}$  =N on scaled noise for  $^{\rm opt}$  both in the AA and from simulation.

Capacity is nonzero for ~ < 1; in which case  $k_c = \log(~) = \log(~) = \log(~)$ . Here  $^{opt}(~)$  is less than unity and decreases with increasing noise because it results from a balance between signal suppression on one hand and am – pli cation of error input by the factor  $(1 ~)^1$  on the other. For small , maximizing  $k_c$  with respect to yields  $^{opt}$  1 e and  $k(~^{opt})$  1= e. For ! 1,  $^{opt}$ ! 0 and  $k_c$ ! 0. Equation (13) is exact in the limit of large N if and are kept xed.

In order to yield extensive capacity, and 1 must decrease inversely with N, so that 1 = = N and = = N with and nite. To see that in this case  $k_c$  scales with system size N, we write  $q = \exp($ ). Capacity  $k_c = N$  is extensive for = O(1) and  $k_c = 0$  for < 0, see Eq. (9). The sum rule Eq. (10) determines the value of . In the present regime the sum can be approximated by an integral, yielding

Solving for yields a nonmonotic function of (see Fig. 3) which attains its maximum at <sup>opt</sup>. For < <sup>opt</sup>, decreases with decreasing and < 0 for smaller than the critical value  $= \log(2) + \ldots$  For large noise, 1, <sup>opt</sup> increases with noise level as <sup>opt</sup> ie., е, as in the nite capacity limit. However, at low noise levels  $^{\rm opt}$  does not approach 0 (as predicted by the nite capacity limit) but increases with decreasing as opt  $\frac{1}{2}\log(1)$  . This is because for su ciently small. su ciently close to 1, strong long-time interferand ence prevents faithful reconstruction even of recent inputs. Therefore, <sup>opt</sup> < 1 even in the ! 0 lim it. Additionally, choosing close to opt reduces retrieval error for values of  $k < k_{C}$ . This behavior is demonstrated in Fig. 2. As in the DSR model, the choice of should be bounded not only by capacity lim its but also by the


m agnitudes of the output weights which increase with roughly as  $jju_k jj$  k=2 = exp(k=N) at zero noise.

The Annealed Approxim ation: An interesting issue is the range of validity of the annealed approxim ation. As indicated above, nite capacity results should be exact in the large N lim it with xed noise and suppression coe cient. In this lim it, at any given time only a small num ber of directions in x space contribute to the current state and since 0 is random, the correlations am ong them are negligible. On the other hand, when and 1 are proportional to 1=N, the num ber of unsuppressed m odes is of order N and hence the com bined e ect of their correlations become im portant. Breakdown of the AA occurs when memory of early times begins to decrease due to strong long-time interference. Our simulations indicate N (1 that this occurs for ). 10, as seen for small

in Figs. 2 and 3. Derivation of a full quenched theory requires appropriate handling of the intricate correlations among high powers of random orthogonalm atrices.

R obustness: Our results show that system s with the DSR or orthogonal architectures are tolerant to stochastic noise in their network dynamics up to noise am plitudes signi cantly larger than 1=N . An important issue is the sensitivity of the network to structural noise. We have tested num erically the robustness of the orthogonal recurrent network to neuron deletion. We nd that this perturbation does not a ect drastically the capacity of the system provided that the output weights are retrained after the neurons' rem oval, in contrast to the simple delay line. If the output weights are not retrained, how ever, capacity drops substantially. Therefore for this to be a viable model of working-memory, the system would need to relearn weights uk su ciently quickly upon neuron loss [6]. Note also that these results in ply that W need not be exactly orthogonal since neuron rem oval is also a perturbation away from orthogonality.

R andom G aussian M atrices: In this work we have assumed rather special network architectures. On the other hand, there are claims that any generic (stable) connection matrix W can robustly store long temporal signals [5, 6]; if substantiated this is indeed a powerful result. The theoretical study of more generic ensembles is di cult. However, our simulations of fully connected Gaussian random matrices indicate that their capacity is not extensive. If = 0 and is su ciently small then it is likely that m(k) = 1 for  $k \in N$  and zero for larger N, as is the case in the models studied here. This is because for small , interference from long past times is negligible and hence the sum -rule Eq.4 in plies the above square form form (k). However, this capacity is unusable in large system s because it requires exponentially large output weights (re ecting the near singularity of the correlation matrix C). Taking close to 1 so that C is well conditioned, results in strong uctuations in m (k)






FIG. 4: Numerical calculation of the memory function of G aussian random matrices for = 0.01, = 0.999 and different sizes. Results are averages over 50 realizations of the connectivity matrix. Exploring di erent values of we nd that up to the above mentioned value the memory im proves with increasing . Increasing beyond this value results in irregular and highly variable m (k).

not contribute to give extensive capacity, as indicated in Fig. 4. We are currently developing a fuller understanding of the short-term memory properties of generic connectivity matrices.
