Low-frequency incom m ensurate m agnetic response in strongly correlated systems

It is shown that in the t-J m odel of Cu-O planes at low frequencies the dynam ic spin structure factor is peaked at incom mensurate wave vectors $(\frac{1}{2} \quad ; \frac{1}{2})$, $(\frac{1}{2}; \frac{1}{2} \quad)$. The incom mensurability is connected with the momentum dependencies of the magnon frequency and damping near the antiferrom agnetic wave vector. The behavior of the incom mensurate peaks is similar to that observed in La2 $_{x}$ (Ba,Sr) $_{x}$ CuO $_{4+y}$ and YBa $_{2}$ Cu $_{3}$ O $_{7-y}$: for hole concentrations 0.02 < x < 0.12 we not that is nearly proportional to x, while for x > 0.12 it tends to saturation. The incommensurability disappears with increasing temperature. Generally the incommensurate magnetic response is not accompanied by an inhomogeneity of the carrier density.

One of the most interesting features of the inelastic neutron scattering in lanthanum cuprates is that for hole concentrations x < 0.04 the spin uctuation scattering rem ains com m ensurate: it is peaked at the antiferrom agnetic wave vector Q = $(\frac{1}{2}; \frac{1}{2})$ in the reciprocal lattice units 2 = a with the lattice period a. However, for larger x and low energy transfers the spin uctuations become incommensuratewith scattering peaks shifted to the four sym m etric positions $(\frac{1}{2})$ $\frac{1}{2}$) and $(\frac{1}{2};\frac{1}{2})$) [1]. For x < 0.12 the incom m ensurability parameter is approxim ately equal to x and varies nearly linearly with the tem perature of the superconducting transition T_c [2]. For larger x the param eter saturates near the value The incomm ensurate response was observed both below and above T_c [3]. There are no clear experim ental indications that in La_{2 x}Sr_xCuO₄ the dynam ic magnetic incom m ensurability is connected with lattice distortions. However, for x 0:12 when the static incommensurability is observed for tem peratures T < T $_{\rm c}$ a rem arkable softening of longitudinal sound waves and soft optical phonons were observed [4]. This softening is a manifestation of the incipient structural transition from the low-tem perature orthorhom bic to the low-tem perature tetragonal phase and the appearance of the static incom mensurability is connected with the pinning of the dynam ic incommensurate spin correlations by this lattice instability [4].

The experimental data suggest that the magnetic incommensurability emerges due to doped holes. Several approaches have been used to clarify the underlying mechanism. As possible candidates the Fermi surface nesting [5], mean-eld spiral [6] and stripe [7] phases, and phenomenological marginal Fermiliquid [8] were considered. In works based on the Fermi surface nesting the dierence in the low-frequency magnetic response in La2 $_{\rm x} {\rm Sr}_{\rm x} {\rm CuO}_4$ and YBa2Cu3O7 $_{\rm y}$ was attributed to the dierence in their Fermi surfaces calculated in the meaneld approximation. However, recently the incommensurability which is analogous to that observed in lan-

thanum cuprates was also detected in YB a_2 C u_3 O $_7$ $_v$ [9]. This result indicates that the low-frequency incommensurate m agnetic response m ay be a com m on property of cuprates. This is especially interesting because the overall magnetic response of these two classes of crystals differs essentially. As known, in YBa2Cu3O7 v and some other high T_c cuprates the resonance peak is observed [10] at som ew hat larger frequencies! = 20 40 m eV than the frequencies of incommensurate response, while no such peak was detected in lanthanum cuprates [11]. In works based on the stripe mechanism the magnetic incom m ensurability is connected with the appearance of the charge density wave. In neutron scattering such a wave is observed only in the low-temperature tetragonal or the low-tem perature less-orthorhom bic phases where the wave is stabilized by the corrugated pattern of the in-plane lattice potential [12]. Am ong lanthanum cuprates La_{2 x}Ba_xCuO₄ and La_{2 v x}Nd_vSr_xCuO₄ have these phases. In La $_2$ $_x$ Sr $_x$ CuO $_4$ in the low-tem perature orthorhom bic phase no indications of the charge density wave were observed in neutron scattering [13].

In this letterwedem on strate that the low-frequency incom m ensurate response can be interpreted based on the t-J m odelofCu-O planes. We use the general form of the spin spectral function B (k!) obtained [14] in M ori's projection operator technique. This approach allows us to take proper account of strong electron correlations inherent in cuprates. In calculating the magnon damping the known shape of the spin-polaron band [15] which form s the Ferm i surface at low x was used. The mechanism of the appearance of the incommensurability is the following: at low frequencies B (k!) is reduced to the quotient of the magnon damping (k) and the fourth power of the magnon frequency !k. Near Q this frequency is an increasing function of ik Qi. Thus, B (k!) will be peaked at incommensuratemomenta if (k) is also an increasing function of jk Q j. This takes place indeed because the magnon damping connected with the decay into an electron-hole pair is approxim ately proportional to S = $\frac{P}{k^0}$ [1 n_F (" $_{k+k^0}$)] n_F (" $_{k^0}$) where n_F (!) = [exp(!=T)+1] 1 , " $_k$ is the hole dispersion and the chem ical potential. Due to the approximate periodicity of " $_k$ with the period Q (connected with the short-range antiferrom agnetic order) S = 0 for k = Q and grows with growing $_k$ Q $_k$.

The spin spectral function, connected with the retarded spin G reen's function D (k!) = $hhs_k^z \dot{j}s_k^z$ ii by the relation B (k!) = 1 Im D (k!), reads [14]

where s_k^z is the z-component of the spin $\frac{1}{2}$ operator describing localized Cu spins, $f=4JC_1(\ _k-1)$ with $_k=\frac{1}{4}$ a exp(ika), a are four vectors connecting nearest neighbor sites in the square lattice of the 2D t-J model, J is its exchange parameter, $C_1=2hs_n^zs_{n+a}^z$ is the spin correlation on the neighbor sites n and n+a with the statistical averaging denoted by the angular brackets. In the normal state the magnon frequency and the damping are given by the relations

If the m agnons near Q are not overdam ped, the dominant feature of the spectral function (1) is the maximum near ! = !Q = 4J (2 $\frac{t}{r_1}\frac{j}{r_1}\frac{j}{r_1}$. This maximum, the resonance peak, is observed in YBa2Cu3O $_{7-y}$ and some other high T_c cuprates [10]. Notice that its frequency ! = 20 40 meV is close to the frequency of the spin gap !Q [14, 18]. In lanthanum cuprates the magnons near Q are apparently overdam ped even in the underdoped region and due to the small superconducting gap the resonance peak was not observed in the superconducting




FIG. 1: The B rillouin zone of the square lattice. Solid curves are two of four ellipses form ing the Ferm i surface of the band (6) at small x. D ashed lines are the Ferm i surface contours shifted by (k Q). Regions of k_1 and $k+k_1$ contributing to the damping (7) are shaded.

state either [11, 18]. In this case the frequency dependence of the spectral function is determ ined by (k!) rather than the resonance denom inator in Eq. (1). In lanthanum cuprates the incommensurate response is observed for frequencies of the order of several millielectronvolts. For such frequencies Eq. (1) can be essentially simplied,

As seen from Eq. (2), $!_k$ $[!_Q^2 + c^2 (k Q)^2]^{1-2}$ near Q and therefore in Eq. (4) $!_k^4$ decreases rapidly with increasing k Q j. In this case for the function B (k!) to be peaked at incommensurate momenta near Q the numerator of the fraction (4), the magnon damping, has to be a growing function of k Q j.

To make sure that the damping may really have such a behavior let us consider the case of low hole concentrations when in Eq. (3) the hole and spin spectral functions can be approximated as [16]

where $=\frac{1}{2}(1+x)$ and the dispersion of the spin-polaron band [15, 16]

The approximate formula (6) reproduces the main known features of the spin-polaron band [15]. In particular, it has minima at (=2; =2). The bottom of the band, 2.5t, and its width, 0.4t = 2J, are set to be close to the values obtained in spin-wave and exact diagonalization calculations for J=0.2t. This parameter ratio is close




FIG. 2: The dynam ic structure factor vs.wave vector along the edge (solid line) and the diagonal (dashed line) of the Brillouin zone for x=0.06, T=0.01t, and !=0.004t.

to that observed in hole-doped cuprates [19]. Also the shape of the band (6) and its Ferm i surface are similar to those observed in oxychlorides and in La $_2$ $_{\rm x} {\rm Sr}_{\rm x} {\rm CuO}_4$ at light and moderate doping [16, 20]. For low x the Ferm i surface of the band (6) consists of four ellipses centered at (=2; =2). Two of them are shown in Fig. 1. Substituting Eq. (5) in Eq. (3) and taking into account that for k Q and small! the region around Q m akes the main contribution in the sum mation over k $_2$ we nd

K ey elem ents for the validity of the above conclusion are the spin spectral function in Eq. (3) which is strongly peaked near Q and an approximate periodicity of the hole dispersion with the period Q. Due to the doubling of the elem entary cell in antiferrom agnetically ordered crystals both these conditions have to be fulled in lightly and moderately doped cuprates which are characterized by the short-range antiferrom agnetic ordering. A small damping of hole states is also necessary (the incommensurability was suppressed in the self-consistent calculations [16] due to a sizeable hole damping introduced for stabilizing the iteration procedure).

W e used Eqs. (3) $\{$ (6) and parameters , C $_1$, and obtained self-consistently [16] for calculating the dynamic




FIG. 3: (a) The dynam ic structure factor vs. wave vector along the edge for x=0.015 (solid line), 0.06 (dashed line), and 0.12 (dotted line). For all curves T=0.01t and !=0.004t. Inset: the structure factor measured [2, 21] in La_{2 x} Sr_x CuO₄ for x=0.03, T=2 K, !=0 (led squares and solid line), x=0.06, T=25 K, !=2 m eV (triangles and dashed line), and x=0.12, T=31 K, !=2 m eV (open squares and dotted line). Fitted curves in the inset are from [2, 21]. (b) The incommensurability parameter vs. x for T=0.01t and t=0.004t. Inset: experimental data [2] for La_{2 x} Sr_x CuO₄. Connecting lines are a guide to the eye.

structure factor S (k!). We considered lattices up to 120 120 sites with the parameters J=0.2t. Figure 2 dem onstrates the dynam ic structure factor calculated along edge and diagonal of the Brillouin zone near Q. The parameters chosen are close to those used in experiments: for $t=0.5~{\rm eV}$, $T=58~{\rm K}$ and $!=2~{\rm m\,eV}$. In agreement with experimental observations [1, 2, 3] peaks along the edge are more intensive than those along the diagonal.

Figure 3 shows the concentration dependence of the peak position along the edge. Starting from x 0.02 there appears the incommensurability { instead of one peak at Q four peaks are observed at $(\frac{1}{2};\frac{1}{2})$) and $(\frac{1}{2};\frac{1}{2})$. For x < 0.12 the incommensurability parameter grows nearly linearly with growing x and tends to saturation for x > 0.12. As seen from the insets in Fig. 3, this behavior is similar to the experimental observations except that in experiment the incommensurability arises




FIG. 4: The dynam ic structure factor vs.wave vector along the edge for x=0.04, !=0.004t and T=0.01t (solid line), 0.02t (dashed line), and 0.04t (dotted line). Inset: the structure factor in La_{1:93} Sr_{0:07}CuO₄ m easured [22] for !=4 m eV, T=23 K (led squares and solid line), T=100 K (triangles and dashed line), and for !=8 m eV, T=293 K (open squares and dotted line). Fitted curves in the inset are from [22].

at x 0.04 and the parameter is approximately 1.5 times larger. In our calculations its concentration dependence is mainly determined by the variation of the spin-gap parameter in ! $_k$ in Eq. (4). For x < 0.12 this parameter grows with x and saturates at x 0.12 [16].

The tem perature variation of the peaks is shown in Fig. 4. With growing tem perature decreases and nally the incommensurability disappears. As seen in the inset of Fig. 4, the analogous behavior of the dynamic structure factor is observed experimentally [9, 22]. Notice that using Eq. (5) we neglected completely the damping in the hole spectral function. As mentioned, this damping decreases or even suppresses the incommensurability. The thermal growth of the damping hastens the decrease of the incommensurability with temperature.

It should be emphasized that at least in the case when magnons near Q are not overdamped the low-frequency incommensurability in B (k!) in uences only weakly the hole spectral functions. The solution of the self-energy equations [16] for the t-J model indicates that in these conditions the density of holes remains homogeneous as it is apparently observed in the low-temperature orthorhombic phase in La $_{2}$ xSr_xCuO $_{4}$ [13].

In sum m ary, it was shown that for hole concentrations x > 0.02 the low-frequency magnetic response of the two-dimensional t-J model is incommensurate. The incommensurability is the consequence of the local minimum in the momentum dependence of the magnon damping. The minimum is located at the antiferromagnetic wave vector $Q = (\frac{1}{2}; \frac{1}{2})$ in the reciprocal lattice units and is connected with the growth of the phase space for the magnon damping into the electron-hole pair with dis-

tance of the wave vector k from Q. For such behavior the spin spectral function has to be strongly peaked near Q and the hole dispersion has to be approximately periodic with the period Q. Both these conditions are full-

lled in crystals with short-range antiferrom agnetic order to which lightly and m oderately doped cuprates belong. In agreem ent with experim ent for x $^<$ 0:12 the incom - m ensurability grows nearly proportional to x and tends to saturation for x > 0:12. This dependence is connected with the concentration dependence of the spin gap at Q . Also in agreement with experiment the incommensurability decreases with increasing temperature. In the considered mechanism the magnetic incommensurability is not accompanied by the inhomogeneity of the carrier density.
