# Edwards Wilkinson surface over a spherical substrate: 1=f noise in the height uctuations

#### A bstract

We study the steady state uctuations of an Edwards-W ilkinson type surface with the substrate taken to be a sphere. We show that the height uctuations on circles at a given latitude has the elective action of a perfect G aussian 1=f noise, just as in the case of xed radius circles on an in nite planar substrate. The elective surface tension, which is the overall coel cient of the action, does not depend on the latitude angle of the circles.

## 1 Introduction

It was long ago that the voltage uctuations of a current-carrying resistor was observed to have a power spectrum nearly proportional to the inverse of the frequency [1]. Since then it has been realized that this so called 1=f noise can be detected in a large variety of phenom ena. Examples range from the velocity uctuations of m oving interfaces [2], the num ber of stocks traded daily [3] to the spectra of speech and m usic [4]. Because of this apparent universality, the suggestion emerged that there m ight be a generic underlying m echanism. The problem has been extensively studied from a large num ber of view points, but a general description has not emerged so far.

A ntalet al. have recently found [5] a new aspect of the 1=f noise. N am ely, they proved that them ean square uctuations (also called roughness) of periodic signals with G aussian 1=f power spectra are distributed according to one of the extrem e value probability distributions, the F isher-T ippet-G um bel (FTG) distribution [6][7]. This means that if we can nd physical system s where G aussian 1=f noise is present and periodic boundary conditions are realized, then FTG statistics naturally em erges in a measurement, thus again suggesting a possible reason for the generality. The periodic boundary conditions are of course strange restrictions when we look for a physical realization. One example was given in [5] for a system which meets the above requirements. If we consider a d = 2 E dwards-W ilkinson (EW) surface on an in nite planar substrate, and draw a circle on it with a given radius R, then the probability of a height conguration is given by the elective action of the desired G aussian 1=f noise.

Here we consider the generalization of the above example to spherical substrates. A motivation for investigating this problem comes from the increasing am ount of accessible data on the cosm ic m icrow ave background (CMB) radiaton's anisotropy. Recently CMB measurements of the Wilkinson Microwave Anisotropy Probe rst year sky survey gave a detailed sky map on the tem perature uctuations of the radiation [8]. These uctuations are believed to be Gaussian, and their angular power spectrum is an essential detail in the cosm ological models. The statistics of the present data are still not perfect, and one could in prove the reliability of conclusions by investigating the uctuations on objects of various shapes. Here we investigate the case of circles on the sphere and we assume that the EW uctuations provide a simple model of the tem perature anisotropy. If we could prove that the uctuations on circles of this spherical substrate have the same properties as in the planar case, then a com parison between the probability distribution of the measured data and the FTG distribution would tell us about the appropriateness of our assumption. W e could also look at the decay of two point correlations of the data set, which is in fact a more direct way of checking the EW model assumption. However, we believe that the use of the distribution function m ight give an e ective alternative m ethod, since here we have not only an exponent, but a universal scaling function to compare.

In our paper we present the derivation of the probability density functional of a height con guration over the equator of the sphere. We conclude that the elective action is equal to that of the G aussian 1=f noise, exactly as in the case of the planar substrate in [5]. Then we generalize our result to arbitrary circles with latitude angle  $\#_0$ .

#### 2 Themodel

In EW model the probability P [h]  $e^{S [h]}$  of a height conguration h (#;') de ned on the 2-sphere  $S_2$  can be given through the free-eld e ective action

where is the elective surface tension. In order to get the probability that h takes the value of some  $xed \ h_0$  on the equator we have to integrate over eld values at other points:

where Z is a norm alization coe cient, and equals with the same integral without restriction on the equator. The functional integration is carried out on continuous functions.

## 3 Calculation of the e ective action

W e use the same trick as in [9] in order to get rid of the functional integration. Namely, we introduce the "classical" solution  $h_c$ , and the new variable  $\tilde{h} = h_c$ . Since the action is quadratic in the eld we can write it in the following form :

The "classical" solution  $h_c$  is the function that solves the Laplace equation on the northern and southern hem isphere, respectively, and on the equator satis es the same boundary condition as the integration variable in (2):

Changing the integration variable h to h we have:

Since the new boundary condition is  $\hbar \frac{1}{2}$ ;  $\prime = 0$ , the integral is now independent of  $h_0$  so it can be absorped into Z.

In the "classical" action we can perform an integration by parts:

where we changed to variables  $x = \cos \#$  and ' for convenience.

In order to  $nd h_c(\mathbf{x};')$  we have to solve two D irichlet-problem s on the two hem ispheres with a common boundary condition at the equator. It is tempting to determ ine the continuous and so squared integrable solution to (4) as an expansion to spherical harm onics, which are eigenvectors of the Laplacian. This way the e ect of the Laplacian on the expansion could easily be computed by changing the order of the sum and the Laplace operator. However, the latter step is not always correct, the Laplacian not being a bounded operator. We can convince ourselves that in the present case changing the order of the in nite sum and the Laplacian yields erroneous result. Instead, we use an expansion for which this step is allowed.

In spherical polar coordinates the Laplace equation reads

Putting the usual Ansatz  $h_c^n(x; \prime) = Q^n(x)e^{in'}$  into (7) we obtain a second order equation for  $Q^n$ . For  $n \in 0$  we give the general solution of this equation as the sum of the linearly independent solution of the following two equations of rst order:

The general solutions of (7) are

By prescribing regularity at the poles, only one term remains for each n:

where we introduced the notation

W e are ready to give the solution of the two D irichlet problem s (4):

$$h_{c}(z;') = p \frac{1}{2} \int_{n=1}^{X^{i}} \hat{h}_{0}(n) e^{in'} z^{j_{1}j_{i}}; \qquad (12)$$

where  $\hat{h}_0$  (n) denote the Fourier coe cients of  $h_0$ . If  $n^2 \hat{f}_0$  (n)  $\hat{f} < 1$  then n = 1

Since

$$\frac{\partial h_c}{\partial x} = \frac{\operatorname{sgn} x}{(1 + jx)^p 1 x^2} \frac{\partial h_c}{\partial z}; \qquad (14)$$

the e ective action can be given in the following form :

$$S[h_{c}] = \int_{0}^{\mathbb{Z}^{2}} d' h_{0}(') \lim_{z \neq 1} z \frac{\partial h_{c}}{\partial z}(z; ') = 2 \int_{n=1}^{\mathbb{X}^{2}} n \hat{f}_{0}(n) \hat{f}:$$

where the last equality was obtained by using  $\hat{h}_0$  ( n) =  $\hat{h}_0$  (n) .

Thus we have arrived at our main result: the action describing the probability density of the height con gurations on the equator is exactly the same as the one characterizing G aussian 1=f noise.

#### 3.1 Generalization to arbitrary circles

In case the boundary values are prescribed not on the equator but for instance on the circle at latitude angle  $0<~\#_0<~$  , we introduce sim ilar variables as before:

where  $x_0 = \cos \#_0$ . The solutions of the two D irichlet problem s are

$$h_{c}(z; \prime) = p \frac{1}{2} \int_{n=1}^{X^{1}} \hat{h}_{0}(n) e^{in \prime} \frac{z}{z_{0}} ; \qquad (17)$$

where  $h_c^+$  ( $h_c$ ) is de ned for #  $\#_0$  (#  $\#_0$ ).

The integration in S  $[h_{\rm c}]$  is carried out along the circle at latitude angle  $\#_0$ , where the derivatives of the solutions are not continuous:

## 4 Final rem arks

The question naturally arises whether boundary conditions prescribed on objects di erent from circles yield the e ective action of the Gaussian 1=f noise. A possible way of nding such objects is to apply conform al transform ations to the solution obtained in case of circles. These transform ations leave Laplace equation invariant but the boundary curves where the solutions on the two regions of the sphere are jointed m ight take m ore general shape. Because of the large variety of conform al transform ations, nding the ones that result in the action of Gaussian 1=f noise requires m ore detailed analysis.

It would be worth perform ing the calculation on other surfaces, for instance on a negative curvature surface besides the plane and the sphere. Furtherm ore, the generalization to surfaces of non-trivial topology would be interesting as well.
