Evidence of two e ects in the size segregation process in a dry granular media

In a half-lled rotating drum, the size segregation of particles of equal density builds a ring pattern of the large particles, whose location continuously varies from the periphery to the center depending on the size ratio between particles [I hom as, Phys. Rev. E 62, 1 (2000) 961-974]. For sm all size ratios (typically< 5): large beads are at the surface of the ow, as usually observed; for high size ratios (typically>15): large beads are close to the bottom in a reversing position. The existence of circles with an interm ediate radius shows that the segregation at an interm ediate level within a ow is possible. In this paper, we experimentally study the segregation of particles of di erent densities and sizes in a half-lled rotating drum and other devices (chute ow, pile). In the drum, the location of the segregated ring continuously varies from the periphery to the center and is very sensitive to both the size (from 1 to 33) and density (from 0.36 to 4.8) ratios. The densest large beads segregate on a circle close to the center, the lightest large beads on a circle close to the periphery. Consequently, we found that for any tracer, its excess of mass, due to only a size excess, a density excess, or both, leads to a deep inside segregation of the tracer. There is a push-away process that m akes heavy beads of any type go dow nw ards, while the excess of size is already known to push large beads tow ands the surface, by a dynam ical sieving process. Each segregation at an interm ediate ring corresponds to a balance between these mass and geom etrical e ects. The segregation level in the ow is determ ined by the ratio of the intensities of both e ects.

I. IN TRODUCTION

W hen a granular m atter com posed of several types of particles is put into motion, a demixing of the di erent particles occurs. This segregation appears whenever there are di erences in size, density, shape, roughness... For example, in a mixture of large and small beads of the same matter, the large beads are often found at the surface of the bed after the granularm atter has been put into motion [1] or vibrated [2], or at the periphery of a half-led rotating drum [3, 4, 5]. Segregation of beads of di erent sizes has been interpreted as a dynam ical sieving during the ow which makes the small particles go down and, consequently, the large ones end up at the surface. This process com es from the size di erence and is actually a geom etricale ect. How ever, this interpretation is incomplete because it does not take into account the fact that large beads m ay push aw ay their neighbors to go downwards [6, 7], and can get buried into the bed.

In a previous paper [6], we investigated the balance between the two e ects in plied in the size segregation, named the geometrical and mass e ects: the geometrical sieving pushes the large beads to the free surface, while the mass e ect pushes the large (and heavy) beads to the bottom. This balance produces surprising rings of segre-




FIG. 1: Ring of segregation of 1.5-mm large tracer beads (G lass) in a bed of 90-m sm all G lass beads, in a quasi 2D (2 dimensions) drum. The radial location of tracers is precisely de ned (note that the upper bead is still in the owing layer). The position is very sensitive to the value of the size ratio [6] and of the density ratio [this paper]. The variation of the ring radius is a powerful means to study the geometrical e ect of segregation by making an equivalence with the variation of position induced by a change of density.

gation Fig. 1]. In three experim ental devices (ow in an inclined channel, form ation of a heap, half-lled rotating drum) a m ixture of large and sm all G lass beads has

been sheared during the ow. For a sm all fraction of large beads (typically 3%), the segregated positions of the large beads continuously evolve from the surface to the bottom when increasing the size ratio, giving the up, interm ediate and reverse segregations. Typically, for size ratios between 1 and 5, large beads are visible at the surface, and for size ratios above 15, they are close to the bottom . This evolution is masked when using a large fraction of large beads (for example 50%). We concluded that, for sm all size ratios, the geom etrical sieving is dom inant while for larger ratios, the mass e ect is dom inant. But, for interm ediate size ratios, the large beads are found at an interm ediate level inside the bed: the 2 e ects exactly counterbalance at this level, whose location depends on the value of the size ratio. In a rotating drum, this interm ediate segregation produces rings of segregated tracers [Fig.1] whose location can be accurately measured, and is very sensitive to the size ratio between the beads. The position of the ring is then closely related to the relative intensities of the geometrical and mass segregation effects. In most previous studies, it is only possible to know if segregated particles are at the surface or at the bottom of the ow, i.e. there are only two possible patterns of segregation (or three when counting also the hom ogeneous state). But contrary to these classical patterns, the evolution of the position of the ring is continuous: there is an in nite number of patterns. Consequently, it is possible to continuously quantify the relative intensity of the segregation e ects by measuring the ring radius.

The aim s of the present study are (1) to con m that, in the size segregation of beads of equal density, a m ass e ect is responsible of the reverse and interm ediate positions of large beads [6] and (2) to obtain data to quantitatively separate the two e ects, geom etrical and m ass, both im plied in the size segregation of beads of equal density. For that reason, we vary the m ass e ect independently of the geom etrical e ect, by changing the tracers density. W e then investigate the segregation of beads of di erent densities, for each size ratio.

Experimentally, the segregation due to a density difference has been less studied than the size segregation, one reason being the di culty in varying the density. Som e studies focus on phenom ena happening during the shaking of a mixture [8, 9] or follow the trajectories of tracers during the vibration [10, 11]. The previous experim ental studies involving a granular matter sheared into a slow frictional motion, report that for equivalent sizes, the dense particles are found at the bottom of the bed (or center of the drum), and the light particles at the surface (or periphery of the drum) [12, 13, 14]. But they concern large density ratios (from 3 to 7). Num erical studies [13, 14, 15, 16, 17] use a continuous range of density. Some results are close to a ring segregation and show a continuous evolution of the segregated tracer location versus the m ass ratio [17]. W hen using particles of di erent sizes and densities, the two di erences act in addition or in competition, leading to up, down or no seqregation [18, 19]. For example, a di erence of size (ratio

3) can dom inate a sm all di erence of density (ratio 1.5): large dense particles are on surface [20]. Experim entally [19, 21] or num erically [18], adjusting densities and sizes can lead to a hom ogeneous bed, interpreted as a global balance between density and size e ects. But these studies concern only the segregation state (hom ogeneous or not) of the whole granularm atter because they use sim ilar fractions of large and sm all particles, contrary to the segregation pattern in rings which gives both the segregation intensity (ranging from hom ogeneous to totally segregated) and the location of the segregated m inority particles.

The present study concerns two sets of experiments where particles are submitted to a frictional shearm otion during the ow (no vibration, no collisional ow).

In the rst part, we precisely measured the ring seqregation pattern in a half-lled rotating drum . The segregation process is mainly considered as a one-particle process as shown by [3, 4], and results of all identical tracers regrouping at the same preferential level. A few large tracer beads of di erent densities (density ratios from 0.36 to 4.8) have been placed in a bed of sm all G lass beads whose size varies (size ratios from 1 to 33). Sm all tracers volum e fractions (0.16% to 3%) are used; consequently, there is no percolation process, even for large size ratios. Large beads are considered as tracers, but are num erous enough to allow statistics (10 to 50 beads). W e are aw are of the fact that interactions between large beads modify the process at larger fractions [6] even if m ost features are still qualitatively valid, but we do not want to treat that point here. The aim is to relate the ring position to the forces that are exerted on each tracer for the tracer to reach a particular equilibrium level in the ow. In that way, we can study the forces responsible for the segregation, knowing (1) the location where they balance, and (2) how this varies with size and density ratios.

In the second part, three experimental devices have been used to show that the reverse and intermediate segregations are not only characteristic of the drum device: formation of a pile, half-lled rotating quasi 2D disc, ow along a slope. The general behavior of the segregation (up-inside-hom ogeneous) has been determined as a function of both density (ratios from 0.5 to 3.2) and size ratios (ratios from 0.2 to 10). Finally, the link between the two parts is made through values of tracer rings.

II. EXPERIMENTS IN A ROTATING DRUM

The drum is half-led and turns around its axis, placed horizontally. The slow frictional owing layer is located on the free surface. The remainder of the beads rotates in a solid way with the drum. An initially hom ogeneous mixture of two types of beads is obtained by placing the tracers by hand between successive thin layers of G lass beads, the drum axis being vertical during the lling. Two demixing processes take place in a drum : radial [3, 4, 6] and axial segregations [22, 23, 24]. The axial segregation is the longer one to appear, and we avoid it by stopping the rotation after a few revolutions.

We follow the behavior of the m inority component (tracers, indexed 2) in a bed of the majority component (sm all G lass beads, indexed 1). A m ixture is characterized by diameter $d_2=d_1$ and density $_2=_1$ ratios. This study is limited to the case of large tracers ($d_2=d_1>1$).




FIG. 2: Each radial position r_i in the rotating solid part corresponds to a Vertical' (perpendicular to the free surface) location z_i in the owing layer.

We interpret the radial segregation as resulting from a segregation process happening within the owing layer. The three patterns in the drum (tracers at the periphery, on a ring, at the center) are respectively due to the three locations of the segregation in the ow (tracers at the surface, at an interm ediate level, at the bottom). The segregation is quanti ed by m easuring the distances r_i from the center of tracers to the center of the drum [Fig. 2]. Two parameters are used:

(1) the spreading of the r_i distribution, related to the segregation intensity and measured by the standard deviation of the r_i distribution. W hen it is low, the intensity is strong, and the segregation pattern is well focused. W hen it is large, the segregation is weak and tracers are widely spread over the bed.

(2) r the average of r_i , de ned as the ring radius. r=R indicates the mean location of the segregated tracers whether the segregation is strong or weak (R is the drum radius). Each radius r_i corresponds to a Vertical' level z_i in the owing layer [Fig. 2] [25]. Roughly r_i = 0 comes from tracers whose center is at the bottom of the ow, and r_i = R from tracers whose center is at the free surface (half-em bedded). The link could be done by the shape of the interface between static and owing zones, which can be approximated by a parabolic function when the free surface is plane [26, 27]. But, we observed that beads whose centers are above the free surface present larger r_i than beads just half-em bedded, although a simple intersection linking z_i and r_i would give a saturation to

the maxim al value for all these beads. We assume that a tracer m ay stop when its bottom touches the interface between owing layer and static zones: ri would then be sm aller than the radius corresponding to the intersection between z_i and the interface. This remark is based on qualitative observations, and we do not have data for a $z_i - r_i$ link. M oreover, tracers have a nite size and $r_i = R$ maximum is equal to 1 $d_2=2R$ (0.938 for 3-mm tracers), when the tracer touches the periphery. Due to the ow thickness, $r_i=R$ m in imum is not equal to 0 either. As the densest tracers are never visible during the ow, we assume that the ow thickness is at least d_2 . We do not take into account the beads located at less than 1.5d₂ from the free surface, because they could be touching the owing layer when the rotation stops. $r_i=R$ is then superior to $1:5d_2=R$ (0.18 for 3-m m tracers).

A. Experim ental device

The drum is 42 mm long and 48.5 mm in diameter, m ade of G lass with Steel caps, and half-lled with a mixture of sm allG lass beads and large tracer beads (Table I). The variation of the density ratio is obtained by changing the tracer density, the variation of the size ratio by changing the size of the sm all G lass beads. Tracers, usually 3 mm in diameter, represent from 0.16% to 3% of the beads volum e and do not interact enough for their position to be a ected [6]. Lead and G lass tracers are nearly spherical with the dimensions of each tracer comprised in the given range (Table I) and there is no noticeable shape e ect on the segregation. Sm allG lass beads are very-well sorted, having less than 10% of relative size spreading [6], and whose diam eters range from 90 m icrons to 4 m m : 90; 150; 180; 200; 212; 250; 300; 355; 400; 425; 500; 600; 710; 850; 1000; 1500; 2000; 2500; 3000; 4000 m. The G lass density is 2.5 g/cm³, measured with a picnom eter from 2.46 to 2.54 with no system atic variation with the size. Som e experim ents using sm all Zirblast beads (500 m, 3.85 g/cm^3) for the bed have also been done.


The hum idity in the laboratory room is held at 50-55% and special care is given to experiments involving the smallest beads to minimize electrostatic and hum idity cohesive e ects [28]. But electrostatic e ects are strong when using Te on beads which attract small G lass beads.

Rotation speeds correspond to a continuous ow and to a plane free surface: around 0.085 s^1 (from 0.04 to 0.1 s^1) and up to 0.15 s^1 in few cases [Figs.6,8,13,14]. Experiments with a bed made of the largest G lass beads (resp. 2-2.5-3-4 mm) have been system atically done with higher speeds to obtain a continuous ow (resp. 0.1-0.12- $0.13-0.2 \text{ s}^1$). There is no di erence between rotation obtained by a motor and by manually rolling the dnum, which is the case for a third of the experiments, with no system atic order compared to size or density ratios.

A fler 3 to 6 revolutions, we carefully dip the drum into water. We can open it without disturbing the spatial distribution of the beads. For the largest bed beads, the

drum is frozen before openning it. Several cross-sections are carefully made perpendicular to the drum axis, to measure the radial position $r_{\rm i}$ of each tracer [Fig.2]. We noticed that tracers touching the caps have a slightly di erent mean location from tracers inside the bed, and rem oved them for the measurements.

B. Circles of segregation

A fier segregation, the large beads are found on a ring whose radius varies with the mixture characteristics [Fig. 3]. A fier 1 revolution, the ring radius is constant when the drum continues to turn [6], corresponding to the stable segregation pattern obtained after one passage in the owing layer [29]. We then rotate 3 turns for most of our experiments. In a 2D drum [5], the convergence towards the stable pattern is less rapid and also shows an increase of the convergence time to the nal segregated state at high rotation speeds. As our measurements of convergence were done in experiments at 'low speed', for the highest speeds the drum is rotated 6 turns, rather than 3, to take into account a possible increase of the convergence time.




FIG. 4: Mean locations of 3-mm Polypropylene beads in a bed of sm all G lass beads: () 50 beads (corresponding to 3% volume fraction), () 17 beads (1%). For Figs. 4-15, 19-21 standard deviations of the r_i distributions are represented as errors bars. A llbeads touching the periphery corresponds to $r=R=r=R_{max}$. Lines provided to illustrate data trends: [30] for Figs. 4-15, [34] for Figs 19-20. Here, $r=R_{max}=0.938$. Density ratio is 0.36.

Figures 4 to 15 represent the radius of the segregation ring versus the beads diam eter ratio, for growing tracer densities. Lines are provided to highlight data trends [30]. Each mean radius r is associated to an 'error bar' which is the standard deviation of the r_i distribution.

1. Intensity of the segregation

Roughly, for each experiment, excepting when $d_2=d_1 6 2$, the standard deviations of the r_i distributions [Figs. 4-15] are small: there is a well-de ned segregation pattern. We call it a strong segregation process. In that case, r, the average of the r_i distribution, is equal, or

very close, to the position where one tracer would preferentially be. In other words, the mean value, r is equal to the maximum of the r_i distribution [Fig.16].

For the sm allest size ratios, and especially for $d_2=d_1=1$, the standard deviations are large: the segregation pattern is not well-de ned and the beads are spread [Fig. 17]. W e qualify the segregation process as weak. r can be signi cantly di erent from the maximum probability value, when the distribution is non symmetrical [Fig. 16].

Here, we discuss what inform ation could be deduced on the segregation e ects, coming from observations made on the focus of the segregation pattern. Tracers have been driven to their nal position due to some forces exerted on them . We could separate them into forces due to the size di erence (geom etrical force), due to the m ass or density di erence (buoyancy, weight), due to a shape di erence, etc. The sum of all these forces determines the nallocation. Two cases have to be distinguished to interpret the focus of the segregation pattern. (1) W hen beads are at the top or at the bottom, the total force resulting of all segregation e ects is not equal to zero. It is in balance with an iceberg e ect near the free surface (the weight of the emerging part of the tracer), or with the e ect of the static bed at the bottom of the ow (oor e ect). The focus of the pattern depends on the intensity of the total segregation force. (2) W hen beads are at an interm ediate level, the segregation e ects balance at that level, and the total segregation force is equal to zero at that level. In that case, the dependency of the total force with the position z determ ines the focus of the pattern. W hen the total segregation force strongly depends on z, the pattern is well-focused around the balance level.




FIG.5: Mean locations of 3-mm Polyamide beads in a bed of sm all G lass beads: () 50 beads (3%). See caption Fig.4. $r=R_{m\ ax}=0.938$. Density ratio is 0.45.

In both cases, the intensity of the force or of its z-derivative has to be compared with the uctuations of the tracer trajectories. We expect that the amplitude of the uctuations depends on d_2/d_1 , and on the ow thickness in number of sm all beads, related to $d_1=R$. F luctuations are also enhanced when tracers interact.




FIG.6: M ean locations of 3-m m Polyacetal beads in a bed of sm all G lass beads: () 50 beads (3%), () 17 beads (1%). See caption Fig. 4. $r=R_{max}=0.938$. Experiment with size ratio 3.5 has been done at 0.15 s¹. Density ratio is 0.56.




FIG.7: Mean locations of 3-mm Te on beads in a bed of smallG lass beads: () 50 beads (3%), () 17 beads (1%). See caption Fig.4. r=Rm $_{\rm max}$ = 0.938. There are strong electrostatic e ects for size ratio 20. D ensity ratio is 0.86.

Roughly, results show three tendencies: the focus is very strong for tracers at the periphery, strong for high size ratios and weak for sm all size ratios. Very strong focus when tracers saturate at the periphery indicates that a non zero total segregation force is an e cient e ect of segregation. This is not observed when tracers saturate at the center because it is masked by the interaction between tracers which creates uctuations. The use of a larger am ount of tracers (3% instead of 0.6%) [Fig. 11] increases the standard deviations when r tends to 0.




FIG.8: M ean locations of 3-m m G lass beads in a bed of sm all G lass beads: () 50 beads (3%), () 17 beads (1%), () theoretical hom ogeneous point ($d_2/d_1=1$; r=R = 0.71). See caption F ig. 4. r=R_{m ax} = 0.938. C om pared to F ig.14 presented in [6], some results have been added, and some have been slightly corrected by rem oving the tracers touching the caps when it was possible. Standard deviations are larger than for other m aterials due to the less precise hand of the experimenter at that time. The experiment with size ratio 7 (3%) and the upper result for size ratio 6 have been done at larger speeds, resp. 0.11 and 0.13 s¹. D ensity ratio is 1.




FIG.9: M ean locations of A lum inum beads in a bed of sm all G lass beads. 3.97-m m tracers: () 23 beads (3%) and () 15 beads (2%); 2.5-m m tracers: () 20 beads (0.65%). See caption Fig.4. $r=R_{m\ ax}=0.918$ for large tracers, and to 0.948 for sm all tracers. The line takes into account both sets of data. D ensity ratio is 1.08.




FIG.10: M ean locations of Si_8N_4 beads in a bed of sm all G lass beads: () 10 beads (0.7%) of 3.175 mm, () 10 beads (0.6%) of 3 mm (only for size ratio 1), () avalanches regime for size ratio 1.06. See caption F ig. 4. $r=R_{max}=0.934$. Each experiment has been done twice, except for size ratios 12.7 (once) and 1 (3 times). Density ratio is 1.26.




FIG.11: M ean locations of $3-m m \ A \ b O_3$ beads in a bed of sm all G lass beads: () 50 beads (3%), () 10 beads (0.6%). See caption Fig.4. r=R_{m ax} = 0.938. The line for 0.6% is used in Fig. 18. D ensity ratio is 1.56.

Several causes can explain the weak segregation at sm all diam eter ratios. It could be due to a decrease of the segregation force or its z-derivative, or due to the enhancem ent of the uctuations of trajectories. Fluctuations enhancem ent could be characteristic of sm all size ratios or could come from the fact that excessively large beads m ay have been used in the device. In fact, in our experiments, sm all diam eter ratios are obtained by increasing the size of the sm all beads, which leads to beds




FIG.12: M ean locations of 3-mm T itane beads in a bed of sm all G lass beads: () 10 beads (0.6%). See caption Fig. 4. D ensity ratio is 1.8.




FIG.13: M ean locations of $2\text{-m} \text{ m} \text{ ZrO}_2$ beads in a bed of sm all G lass beads: () 25 beads (0.45%). See caption F ig. 4. Experiments with 1.3 and 2 size ratios have been done at 0.15 s¹. Density ratio is 2.4.

com posed of relatively large beads (4 to 1 mm) compared to the drum diam eter (48.5 mm). The owing layer is then only 12 to 48 beads long, which may not be enough to ensure a segregation process fully developed. Moreover, at low tracers fractions, the ow thickness is im posed by the sm allbeads size [27]: for such a geom etry, the ow thickness is around 6 beads for 1-mm beads, and 1-2 beads for 3-mm beads. Such layersm ight not be considered as a continuous owing material, but as a rolling layer of beads. In that case, trajectories of tracers and beads of the bed should be very chaotic and uctuations are probably as large as the ow thickness.




FIG.14: M ean locations of Steelbeads in a bed of sm allG lass beads: (and solid line (used in Fig.18)) 10 beads of 3 mm (0.6%), (4 and dashed line) 15 beads of 2.5 mm (0.47%), (and dotted line) 72 beads of 1 mm (0.16%). See caption Fig. 4. For 2.5-mm beads, experiments with size ratios 8.3 and 11.8 have been done at a larger speed (0.15 s¹) and () corresponds to avalanches regime. Density ratio is 3.1.




FIG.15: Mean locations of 3-mm Lead beads in a bed of small G lass beads: () 10 beads (0.6%). See caption Fig.4. Density ratio is 4.8.

To di erentiate between the two possibilities explaining possible enhanced uctuations, we compare 3 (resp. 2) sets of experiments with Steel (resp. A lum inum) tracers of di erent sizes [Figs. 14, 9]. For the smallest tracers, we found that the increase of standard deviations at small size ratios still exists, although it concerns smaller sizes for the bed beads and thicker/longer ows measured in bed bead diameters. Moreover, in other devices (Sec. III), som e mixtures with a small size ratio look




FIG.16: Histogram s of locations of 3-m m Te on beads in a bed of G lass beads. Both mean values r=R are similar but correspond (left) or not (right) to the most probable value.




FIG.17:3-mm Si_3N_4 tracers in a bed of 3-mm G lass beads.

hom ogeneous, whatever is the size of the bed particles compared to the ow thickness. These two points prove that the weak segregation is not due to the use of excessively large beads for the bed, compared to the dnum size. In conclusion, the segregation pattern is focused at large size ratios, and is not well-de ned for sm all size ratios, because of the variations of either the segregation force or the trajectory uctuations. This point is independent of the value of the density ratio.

C onsequently, density and size ratios do not play an equivalent role in determ ining the focus of the pattern. C onsidering tracers at interm ediate location, we deduce that the segregation force due to a density ratio weakly depends on z (large standard deviations for $d_2=d_1=1$). But, the data do not give deductions about the gradient of the segregation force coming from the geometrical e ect: small values of the standard deviations can be due to small trajectories uctuations or to a strong z-dependency of the geometrical force. O ther arguments based on r=R data (end of Sec. IIB 3) show that there is a z-gradient of the geometrical force.

W e also would like to point out a possible statistical e ect due to spread asymmetric patterns [Fig.16], which could in uence the interpretation of mean locations r=R in terms of balance level. A lthough r=R values for the weak segregations ($d_2=d_1<1.5$) vary regularly with the density ratio [Fig.19] and are consistent with values obtained for larger size ratios [Figs. 4-15], r=R could be signi cantly di erent from the maximal probability of r_i . A ssum ing two preferential positions, the top for light tracers and the bottom for dense tracers, the variation of r=R with the density ratio could be just a consequence of a variable spreading of the distribution: the closer to 1 the density ratio is, the wider the distribution could be. The available set of data is not statistically large enough to di erentiate between a variation of the preferential bcation and those of the spreading of the distribution.

In conclusion, we keep in m ind that rst values of the r=R vs d₂=d₁ curves m ay have to be shifted to 1 (resp. 0) for m aterials lighter (resp. denser) than G lass to obtain the curves of the preferential locations (balance levels). We also know that the r=R curves are almost equal to those of the preferential locations when standard deviations are sm all, which is the case of m ost experiments.

2. Location of the tracers for each m aterial

In these experiments, we vary the size of the small beads and the density of the tracers. We also change the density of the small beads, to check that the ring position depends on the density ratio rather than on density (Sec. IIB 3). Tracers location has been shown to depend on the size ratio rather than on the sizes [6]. Consequently, we will use density and size ratios as the parameters controlling the ring position.

For each material, r=R presents the same evolution with $d_2 = d_1$: (1) a rapid increase, then (2) a long decrease Figs. 4-15]. The increasing part is restricted to small size ratios, roughly < 2, giving a maximum for r=R corresponding to size ratios between 1.5 and 2. W e will see (Sec. III) that indications of this complex variation of r=R vs $d_2=d_1$, are found in other experimental devices. (1) The increase corresponds to the classical upsegregation of large beads, intensively studied by the granular com munity. The 'up-character' is stronger when the size ratio increases. W hen $d_2 = d_1$ passes from 1 to 2, r=R increases, and reaches the saturation value for low densities: all tracers touch the drum periphery. For larger densities, the maxium radius also occurs for size ratio close to 2, but the ring is buried inside the drum . (2) The long decrease corresponds to tracers getting larger, and consequently heavier. They progressively sink into the bed by a push-away process. This new phenom enon has been nam ed interm ediate and reverse segregations by the authors [6]. It happens even for tracers less dense than the G lass beads of the bed. For the dense m aterials, the ring radius tends to saturate to its m inimum value related to the ow thickness.




FIG. 18: Curves of mean locations r=R of large tracers of di erent densities plunged in a bed of sm allG lass beads (from Figs. 4-15). Density ratio $_{2=1}$ is written on each curve.

The evolutions are similar to those of the location of a large G lass tracer in a bed of small G lass beads, corresponding to $_{2}=_{1}=1$ ([6] and Fig. 8). The theoretical point for $d_{2}/d_{1}=1$, i.e. the hom ogeneous media, would correspond to r=R=2/3 in a half-led drum, but because we remove all tracers which are closer to the

free surface than 0.18R, a numerical calculation gives r=R=0.71 for hom ogeneity. C om pared to those of G lass tracers, the r=R curves are shifted to the top for lighter m aterials, or to the bottom for denser materials (note on Lead in [32]) [Fig. 18]: both evolutions with $d_2=d_1$ and $_2=_1$ are continuous. The continuity could appear surprising and we could have expected tracers denser (resp. lighter) than G lass at the bottom (resp. at the top) of the ow. The balance at interm ediate level is not explained by buoyancy variations either (Sec. IIB 3). B oth density and size ratios take a role in the selection of the tracer location, as already found [33].

From each r=R curve, we want to deduce the evolution of the preferential level, where all segregation forces balance. Both variables are linked when standard deviations are sm all $(d_2=d_1>2)$ but could be di erent for large standard deviations $(d_2=d_1<2)$.

-For materials lighter than G lass ($_{2}=_{1}<1$), the most probable value of the r_{i} distribution could be the periphery for $d_{2}=d_{1}$. 2. This suggests that the r=R increase could be a consequence of an asymmetric spreading of the r_{i} distribution and not of a variation of the preferential location. In that hypothesis, the preferential location would be constant up to $d_{2}=d_{1}$ 2, then decreases in the same way as r=R.

- For denser materials ($_{2}=_{1}>1$), the expected most probable value is close to the center of the drum, which would enhance the increasing part of the curve. Consequently, asymmetry of histograms is not the reason for the r=R increase. The evolution of the preferential level really follows a complex curve, increasing then decreasing, similarly to those of r=R.

O ne consequence of this com plex variation is that two m ixtures having di erent $d_2=d_1$ can show the sam e m ean segregation pattern (sam e r=R), even if com posed of the sam e m aterials. Two sizes of tracers will then be found at the sam e place in a bed of an otherm aterial beads (for exam ple Si₂N₄ beads with 1.4 and 3 size ratios in sm all G lass beads [Fig. 10]). This gives possibilities of m ixing between two m inority species, with the sam e or with di erent densities, inside a third m a prity component.

3. In uence of the bead density on the tracer location

Tracers denser or lighter than G lass generally reach an interm ediate level. For a given size ratio, the denser the tracer is, the deeper is its position [F igs. 4-15]. We can continuously vary its position keeping the geometry constant (sam $d_2=d_1$, sam e geometrical ect) [F igs. 19, 20].




FIG.19: Tracersm ean locations for size ratios: () 1 (and few ratios com prised in 0.992–1.015), () 1.2 (1.25–1.33), (N) 1.5 (1.52–1.67), () 2 (1.98–2.11). See caption Fig.4. The dashed step line is one possible curve for the preferential location for $d_2=d_1=1$ (see Sec. IIB 1).




FIG.20: Tracers m ean locations for size ratios: () 2 (and few ratios comprised in 1.98-2.11), () 3 (2.94-3.175), () 4.23 (4-4.47), (4) 6 (6-6.67), (N) 7.5 (7.5-8.33), () 10 (9.92-10.58), () 20 (19.85-21.17) (averaged data when there are several experiments). See caption Fig. 4.

W hen increasing $_{2}=_{1}$, a large bead passes from the surface to the bottom. This sinking appears earlier for large size ratios than for small ones because large tracers are already heavy [Fig. 20]. But for size ratios 1 to 2 [Fig. 19], the sinking is delayed when $d_2=d_1$ is large. It corresponds to the sharp increase of the r=R vs $d_2=d_1$ curves [Figs. 4-15]. For $d_2=d_1=1$, we could have expected r=R m axim um for all lighter tracers than Glass, and r=R minimum for all denser tracers (step line in Fig. 19). But this is not what it is observed experimentally [this study] and numerically [17]. r=R varies continuously, and suggests that a pure di erence of density leads to a balance at an interm ediate level in the ow. Quantitatively, our curve decreases more rapidly and goes further down than the 2D simulations [17], probably because of a reduced ability for the tracer to move down in 2D. Nevertheless, we have to take into account statistical e ects (Sec. IIB 1) to

determ ine the curve of the preferential location, which is probably between the step line and the r=R curve [Fig. 19]. Further investigations have been planned to determ ine if the balance at an interm ediate level due to a pure di erence of density experim entally happens or not.

Additional experiments involving a bed of small Zirblast beads instead of small G lass beads have been done. Zirblast beads are 500 m in diameter and 3.85 g/cm^3 in density, mainly composed of ZrO_2 (67%) and SiO_2 (30%). Each experiment has been done at 0.085 s^1 , with 10 tracers. Tracers are 3-mm beads made of Te on, G lass, Si_3N_4 , A $\frac{1}{2}\text{O}_3$, T itane, Z ircone, Steel (7.91 g/cm³) and Lead (Table I). The positions of tracers for experiments done with small G lass and those done with small Z irblast beads plot very well on the same curve [F ig. 21]. We deduce that r=R depends on the density ratio rather than on the density.

The density di erence of the material is not the only reason for a large bead to be buried in the owing layer. It could not explain the fact that large G lass beads or large beads made of lighter materials can be buried [Fig. 7]. These observations prove that there is a mass e ect involved in the segregation process: the large tracers are heavy enough to push away their sm all neighbors and to go down. Thinking in terms of Fluid M echanics, the mass e ect can be interpreted by the fact that a G lass tracer is denser than a bed of sm all G lass beads containing at least 27% of void. Consequently, the density of the tracer has to be compared to the one of a sm all bead for $d_2 = d_1 = 1$, or to the density of the bed for $d_2=d_1$ 1. This interpretation implies that tracers lighter than the bed are always visible in surface, their partial sinking being due to an iceberg e ect Fig. 18].




FIG.21: M ean locations of 3-m m tracers: (4) in 2.5-g/cm³ G lass beads (data from Fig. 20), () in 3.85-g/cm³ Z irblast beads. In both cases, size ratio is 6. See caption Fig. 4.

Each tracer is a ected by the mass and the geom etrical e ects and its position is determ ined by the addition of these e ects. By varying the density ratio between the beads, only the mass e ect changes. But, by varying the size ratio, both e ects (geom etrical and mass) change. W hen increasing the tracer size, the mass e ect tends to be dom inant explaining that larger tracers get buried deeper. We represent each e ect by a force exerted on the tracer; the mass e ect by the sum of the weight and the buoyancy, the geom etrical e ect by the result of the actions of the smallbeads on the tracer (except the buoyancy). In that point of view, the mass e ect depends on density and size ratios, the geom etrical e ect only on the size ratio. The balance is obtained where the sum of the forces is equal to zero.

Considering a tracer at an interm ediate level within the ow, the mass and the geometricale ects exerted on it balance: it shows no vertical relative motion. If the balance is obtained at that particular level z_i , it means that, at least, one of the two e ects depends on the vertical coordinate z within the ow. Hereafter, we discuss the possible dependencies of the two e ects with z.

Because the focus of the pattern is weak for $d_2/d_1=1$, we do not expect that the mass e ect strongly depends on z. N evertheless, the mass e ect includes the buoyancy which varies with z due to the variation of compacity inside the ow. Only a few studies present data on vertical gradient of compacity in the owing layer of a drum [35, 36, 37, 38], but they concern 2D or quasi-2D experimental devices. Excepting the rst layer of beads in which the compacity drops to zero, 2D compacity ranges from 0.4 to 0.8. From 3D numerical simulations of a drum owing layer, an estimate of the maximal compacity variation is from 0.4 to 0.6 [39]. Consequently, the maximal range of buoyancy is gV [0.4-0.6] 2.5 g/cm³ in sm all G lass beads, where g is the gravity, and V the volum e of the tracer.

The question is to estim ate if this range of buoyancy is

large enough to explain that tracers having di erent densities reach equilibrium at di erent levels inside the sam e

ow . W e lim it the calculus to tracers totally embedded, but not touching the bottom of the ow: their density varies from 2.15 to 6 g/cm^3 (Sec. IIB 2), leading to a range of weights of gV [2.15-6] g/cm³, approxim ately 10 tim es bigger than the range of buoyancy. A lthough there is a large uncertainty on the compacity, the variations of buoyancy are too sm all to balance the range of tracer weights. We can not explain our results by involving only a mass e ect variation with z. M oreover, we found tracers of the same size and of dierent materials located at interm ediate levels, i.e. with mass and geometrical e ects in balance, although they induce very di erent values of the mass e ect (very di erent weight, sim ilar buoyancy). This implies that they are submitted to very di erent values of the geom etrical e ect. Because they have the same size, these di erent values are due to the fact that they are located at di erent levels. W e conclude that the geom etrical e ect strongly depends on z, while the mass e ect varies weakly with z.

The data also show that the density di erences prevail for large and sm all density ratios [F igs.19,20]. Very light tracers ($_2/_1$.0.5) are always at the surface regardless of size and very dense tracers ($_2/_1$ &4) are always at the bottom . For those extrem e density ratios, the preferential location of a tracer is not in uenced by the value of its diam eter. In these cases, there is no balance between the two e ects: them asse ect always dom inates for very dense beads, or is acting upwards for very light beads, as the geom etrical e ect does. While for all interm ediate density ratios, the size ratio has an in uence: the whole pair (d₂=d₁, $_2$ = 1) determ ines the position of the bead.

4. A few more remarks

Two sets of experiments have been done with Si_3N_4 tracers [Fig. 10]. Both r=R, each calculated on the ten r_i data, are similar, which is not surprising in view of the small standard deviations of each set. The two sets show the good reproducibility of the results.

Experiments with the 3 Steel tracers (1, 2.5 and 3 mm) [Fig.14], and those with the 2 A lum inum tracers (2.5 and 4 mm) [Fig.9] show that the size ratio is the relevant parameter when tracers are at intermediate level, as already found with G lass tracers [6]. Small e ects due to the tracer size might appear when they are near center or periphery, as the A lum inum biggest tracers up-shift close to the center of the drum.

We do not notice any in uence of the rotation speed, random ly distributed between 0.04 to 0.1 s¹. It is probably because the ow thickness is weakly dependent of the rotation speed [31] for that range of drum and beads sizes (geometrically, increasing the ow thickness slightly increases r=R, signi cantly only for sm all r=R). Both sets with $\operatorname{Si}_{2}\operatorname{N}_{4}$ tracers have been done at speeds around 0.085 s¹ and 0.15 s¹, showing no di erence, and no system atic relative order between the two sets [Fig. 10]. Some of the experiments with the largest Sm all' G lass beads (2-3 mm), usually done at high speeds, have also been done at 0.085 s¹ at which the ow is in the avalanches regime [Figs. 10, 14]. Tracers positions are more spread but r=R are very close to those at higher speed, when averaged on several experiments.

The in uence of the volum e fraction of large tracers on their nal location has been previously tested on G lass tracers [6]: interactions between tracers shift the segregated locations towards the surface. The interpretation involves the reduction of the push-away process due to the presence of other large (and heavy) tracers in the bed. The shift is combined with a spreading of the positions: for $d_2=d_1$ such that a few tracers segregate at a deep interm ediate level, a nearly hom ogeneous m ixture is experim entally obtained by increasing the fraction of tracers. Consequently, two behaviors are expected when increasing the fraction of tracers in a mixture of beads of di erent densities and sizes: (1) for very large or dense large tracers the m ixture tends to be m ore hom ogeneous; (2) for light large tracers, the mixture still segregates with large beads on the surface. These 2 evolutions are com patible with the results of num erical simulations [18] obtained on 50-50% mixtures, showing segregation for light large beads and hom ogeneousm ixing for dense large beads. In the same way, the value of r=R at low fraction can be used to estimate the segregation state of a mixture at high fractions. For example, in a 3D drum, 50% of large 'tracers' with a size ratio 3, and a density ratio 1.5, which would lead to r=R=0.7 in our device, segregate at the surface [20]. In a 2D drum, a m ixture with size ratio 1.14 (resp. 1.42), density ratio 0.82 (resp. 1.53) and thus r=R=0.83 (resp. 0.75) in our device, stays hom ogeneous at 50%, while a mixture with size ratio 1.14 (resp. 1.18), density ratio 1.53 (resp. 0.69), and r=R=0.6 (resp. 0.9), gives down (resp. up) segregation of large particles [19].

In our experiments, we keep the volume fraction low (from 0.16 to 3%) and quantify its e ect in $A l_2 O_3$ experiments (3% and 0.6%) [Fig. 11] and on a few other data Figs. 4, 6-9]. Results show that there is almost no in uence of the fraction in this small range. Nevertheless, when tracers are close to the center (r=R lower than 0.4), the value of r=R is slightly larger when using more tracers Fig. 11]. A similar e ect might be seen on Fig. 9, again for r=R getting close to the center. The shift is sm all, but strong enough to m ake two 'parallel' curves with di erent tracers fractions cross each other when getting to small r=R values (high size ratios in $Si_{3}N_{4}-0.7$ % and Ab03-3% data Figs. 10, 11]). The r=R up-shift com es with an increase of the standard deviations. It probably happens because too m any tracers can not be all grouped in the center. M oreover, the interaction between tracers enhances the trajectories uctuations. It

could prevent them from reaching the deeper point of the owing layer because tracers roll on each other (one being in the ow, one in the solid rotating part). For that reason, only few tracers have been used in the case of Steel and Lead [Figs. 14, 15]. For an obstruction reason too, we expected r=R slightly smaller for larger fractions, when all beads are close to the periphery. But, this dow nshift would appear for higher di erences of fraction due to the larger volum e available at the periphery than at the center, and we have not observed it. In conclusion, for sm all fractions (< 3%), r=R variations with the fraction are negligible, except when tracers are all grouped at the center.

III. DIAGRAM OF SURFACE SEGREGATION




FIG.22: Experimental devices for: (a) ows in a channel, (b) rotating a half-lled quasi 2D disc, (c) building a pile.

The complex shape of the r=R vs $d_2=d_1$ curves indicates that the same mean position can be reached for two diameter ratios, even with tracers of the same density (Sec. IIB 2). To determ ine if that feature only happens in the drum device, or if it might be due the ows only a few beads thick, we work with 3 other experimental devices in which the ow thickness varies: a channel, a half-lled quasi 2D disc (no bulk observations), and build-up of a pile Fig. 22]. We explore the possibility for di erent tracers to be at the same level in the ow.

For practical reasons, we choose as a criterion the presence or absence of tracers at the surface. \V isible" corresponds to tracers being over the surface or partially embedded in the small particles. \Hidden" corresponds to tracers buried inside the bed, whatever their position, intermediate or at the bottom. On the limit separating \visible" and \hidden" states, the mixture looks as if there is no segregation: tracers do not appear to be preferentially at one location, neither inside, nor at the surface. But, we do not distinguish between real hom ogeneous m ixtures and a bad-focused segregation at a level close to the surface, called ho apparent segregation'. It is sometimes possible to dierentiate the 2 cases by a cross-section of the deposit, but most of the time, experiments are not accurate enough. From channel experim ents done with large and sm all G lass beads [6], the lim it occurs for size ratio around 4.2, which corresponds to tracers at r=R=0.8 in the 3D drum. Taking into account the uncertainties, this is not far from r=R=0.71

In the following sections, we draw in $(_{2}=_{1}; d_{2}=d_{1})$ coordinates the two elds (hidden, visible). Then, we examine if the shape of the limit between the elds explains that di erent tracers of the same density can segregate at the same level.

A. Experim ental devices

In these experim ents, m ixtures are com posed of tracer particles indexed 2 in a bed of particles indexed 1. Volume fractions are 2% for disc and piles, 10% for channel. Most of beads used previously are not adapted here, for size (disc) or available quantity (piles, channel) reasons. Large and small particles are either beads (preferentially used) or angular particles (Table II). Angularity of particles is probably one reason for the lim it not to be sharp (Sec. IIIA 3). D iam eters are sizes or mean sizes of ranges, de ned by a sieving interval (Table II). There is no systematic use of one type of particles to play the role of tracers, or bed. The initial m ixture hom ogeneity is obtained by putting successive thin layers of both components in the starting box of the channel, in the funnel, or by putting tracers by hand all over the 2D drum . Som e additional experiments with a initially demixed state, in both possible con gurations, show: no major di erence for the channel, a slightly longer convergence time to the same nal state for the drum, a strong m odi cation of the results for piles. The in uence of the initial hom openeity mainly depends on the possibility of globalm ixing during the ow.

1. Rotation in a quasi 2D half- lled disc

The drum is 3.5 mm thick, 81 mm in diameter, made of clear plastic [Fig. 1]. The system is close to be 2D for largest tracers, but is 3D with walls e ects for small particles. The disc is half-lled and its axis horizontal. Rotation is obtained with a motor at 2 speeds: 0.033 s^{-1} corresponding to successive avalanches and one speed between 0.8 and 0.16 s¹ chosen to obtain a continuous ow and a plane free surface. We observe through the walls what species is present at the surface of the owing layer. One limitation is the formation of plugs when tracer size is close to the drum thickness [6]. Strong electrostatic e ects happen, especially with small Diakon and W ood Nut particles. Consequently, results are not accurate and we focus on the general behavior. The criterion \being visible on the surface during the ow " gives 2 identical sets of results for the 2 di erent speeds: the segregation




FIG.23: Surface segregation in the disc: tracers () at the surface of the ow, () totally embedded or at the bottom, () mainly embedded but still visible at the surface or homogeneous. In Figs.23-27, diam eter and density ratios are for tracers to bed particles. Two symbols added m eans that there is no clear determ ination between these cases or that two experiments have been done. The same lim it is drawn on Figs.23, 24, 25, 27.

process in a continuous ow or in a single avalanche is the same. We thus only draw 1 point which represents the type of segregation for each couple ($_2=_1$, $d_2=d_1$) [Fig. 23, discussed in Sec. IIIB].

2. Formation of a pile

The heap form ed beneath a funnel exhibits features of segregation [6, 40, 41]. Here, they fully result from processes taking place in the ow along the pile slope: dynam ical sieving, rolling of large beads on a relatively smooth surface [42, 43] and push-away process [6]. No segregation happens in the funnel [44] because the m ixture slips along the walls, contrary to [45]. The particles at the surface of the owing phase go further than the others and accumulate in a ring at the pile base. Consequently, an up-segregation of tracers in the ow produces a basal ring of tracers, contrary to an interm ediate level segregation for which tracers stop on the pile sides, and to a bottom segregation for which tracers stop near the sum mit (pictures in [6]). The funnel contains 250 to 850 g of a hom ogeneous m ixture and is placed at 12 cm above a rough plane. Fluxes range between 10 and 30 g/s depending on particles used. One lim itation is the occurrence of blocking of the funnel for $d_2 > 5 \text{ mm}$. The ow is continuous along the pile slope in the rst stage, then proceeds as axisym m etric avalanches when the pile gets bigger. The owing layer is thin, and vanishes to zero along the slope when the pile gets bigger, allowing the possibility to see buried particles. Because buried trac-




FIG.24: Surface segregation in piles: tracers () making a bottom ring on the pile, () embedded at the top of the pile, () piles looking hom ogeneous. See caption Fig.23.

ers are visible, the chosen criterion is the form ation of a basalring of tracers. It gives the up (ring) and inside (no ring) segregation elds [Fig. 24, discussed in Sec. IIIB].

3. Flow along a slope




FIG. 25: Surface segregation in the channel: tracers () cover the surface, () are embedded in the deposit or at the bottom, () are both inside and at the surface (hom ogeneous). See caption Fig. 23.

Chute ows have been already studied for mixtures of di erent size or/and density particles [1, 6, 16, 46, 47]. We choose to study frictional ows, and avoid collisional ows. The chute is a 1 m long, 6 cm wide channel inclined with an angle of about 27 for beads (26.5-30), and up to 33.5 for angular particles, chosen to produce frictional ows [Fig.22]. The bottom ism ade rough by gluing G lass beads or angular fragm ents on it, whose size is those of the bed particles. The starting box is lled with 1 kg of a hom ogeneous m ixture, then opened, producing a thick ow with a ux of about 400 g/s. The ow stops where the channel is horizontal. Observations of the ow and of the internal structure of the deposit show that the deposit results of a strong deform ation of the ow. How ever, the surface of the ow stays on the surface of the deposit: there is little doubt in diagnosing the location of a species above or under the surface of the ow by looking only at the deposit. We took as criterion whether the tracers are visible or not at the surface deposit [Fig. 25, discussed in Sec. IIIB].




FIG. 26: Channel experiments for various angularity contrasts: () tracers at the surface, () tracers buried in the deposit, () hom ogeneity, (+ and dashed line) expected homogeneity for particles of the same shape [21]. See caption Fig. 23. When angular and spherical particles of the same size' and density are mixed, there is an up-segregation of angular particles. The use of more angular particles as tracers (resp. as bed particles) seem s to shift down (resp. up) the size ratio for which the mixture remains hom ogeneous (indicated by arrows). SiC are tracers: $_{2}=_{1}=1.28$ (right); 1 (left).

The particle shape in uences the segregation pattern and the ratio values corresponding to the lim it [Fig. 25]. The relative sizes in the 3 axes of particles allow to estim ate their angularity: typically a factor 1-2 between sm aller and larger sizes for Sand, a factor 2-3 for SiC, Sugar and W ood fragments, a factor 5 for G lass fragments. W hen mixed, all these particles give several angularity contrasts [Fig. 26]. First, we found that for \equal sized" particles (same sizving interval) angular particles segregate at the surface (G lass fragments and beads () for size ratio 1). These results seem in ac-

cordance with shaking simulations of elongated particles [48] which show di erent segregations depending on the elongation. Second, when tracers are more angular than bed particles (SiC or G lass fragm ents in beads), the homogeneous state seems to be obtained for smaller size ratios than expected [21]. For G lass, the shift in size ratio extends roughly from 1 to 0.7: G lass fragm ents behave as beads approximately 1.4 bigger. When tracers are less angular (SiC tracers in G lass fragm ents), the hom ogeneous state seem s to appear for greater tracers than expected. These deviations suggest that the more angular particles are pushed tow and the surface, although the gap between the experiments is too large to conclude, except for size and density ratios 1. It is in accordance with the 4 () under (resp. 3 () above) the bottom lim it [Fig. 25] corresponding to tracers m ore (resp. less) angular than bed particles. But, for particles whose 3 dimensions are close, the elect of shape is small explaining why data regroup in two distinct zones Figs. 23-25].

B. Recursive lim it between the elds of segregation

O n each set of results, two distinct dom ains can be dened in ($_{2}=_{1}$; $d_{2}=d_{1}$) coordinates [Figs. 23-25] showing that the segregation pattern is a function of size and density ratios rather than diam eter and density. The results of the 3 systems are very similar: the same dashed limit is plotted on the 3 graphs. The segregation process does not depend on the geometry inducing the frictional ow.

The top part of the lim it has been chosen as a comprom ise using all sets of data. The bottom part is the line $_{2}=_{1}=d_{2}=d_{1}$ obtained by [21] for hom ogeneousm ixtures at low tracer fractions. We notice that processes happening when shaking or shearing a granular medium are di erent: our 3 identical sets of results are di erent from those of a vertically shaken box [8].

On each graph, the lim it passes between the two seqregation types, or where there is no observed segregation (marked as hom ogeneous). The lim it shape is recursive, i.e. it is not a curve of a single-valued function from $[_2 = _1]$ to $[d_2 = d_1]$; the area of visible tracers () is surrounded by those of buried tracers (). Consequently, a line 2 = 1 = constant can cross twice the limit, depending on the $_2=_1$ value. For these ratios, sm all and very large tracers are under the surface, and medium size tracers are on the surface. Consequently, the mean position of a growing tracer evolves up then down, in an analogous way of the r=R curves [Figs. 4-15]. This im plies that the same level can be reached by two tracers of the same density, with di erent diam eters. W e deduce that the shape of the r=R vs d_2 = d_1 curves [Figs. 4-15] is not due to the use of excessively large beads constituting the bed in the 3D drum (Sec. IIB 2). For $_{2}=_{1}\& 1.8$ (1.6-2.2), tracers are alwayshidden. In the 3D drum, these density ratios correspond to tracers which never go higher than r=R=0.7(between 0.84-0.6) whatever their sizes are. It im plies that positions visible in surface correspond to approxim ately r=R > 0.7 (strictly r=R > 0.84) and that the level of the lim it m ight be r=R=0.7 in the drum .




FIG. 27: Curves linking mixtures in which tracers segregate at the same r=R in the 3D drum (r=R values in the inset). See caption Fig. 23. Symbols are values taken from the ts [30] of r=R vs d_2/d_1 , lines are just guides for eyes. Iso-r=R 0.7 and 0.8 are close to the limit (thick dashed curve) between segregation elds of pile/disc/channel experiments.

V ice-versa, the r=R vs d_2/d_1 curves [Figs. 4-15] suggests that not only the level of the limit but all levels in the ow have a recursive shape when represented in ($_{2}=_{1}$; $d_{2}=d_{1}$) coordinates. The intersections of the r=R vs ($_{2}=_{1}$, $d_{2}=d_{1}$) surface (Sec. II) by planes r=R = constant have e ectively recursive shapes [Fig. 27]. M oreover, the limit de ned from disc-pile-channel data, is close to curves r=R = 0.7 and 0.8: it corresponds roughly to one iso-location, and it is close to r=R = 0.71 which represents the hom ogeneity (Sec. IIB 2).

M oreover, the 3D drum experiments show that the isoposition curves are not symmetrical in terms of ægregation intensity: each low erpart, close to line $_2=_1=d_2=d_1$, corresponds to large standard deviations, and each upper part to small standard deviations. This fact is compatible with cross-sections of the channel deposit, which look rather hom ogeneous on the low erpart of the limit, and rather ægregated at an intermediate level close to the surface for the upper part. These observations are only visual, but seem to con imit that large size ratios enhance the focus of the ægregation pattern, whereas both size and density ratio determine the mean position of tracers.

IV. CONCLUSIONS

W e found that large tracers segregate either at the bottom , at the surface or, in m ost cases, at an interm ediate

level in the ow. This creates well-de ned ring patterns of tracers in a half-lled rotating dnum. Reversing between surface and bottom segregation is also observed in chute ow and pile building where the granular matter is subject to a frictional ow.

In the drum device, the radius of the ring varies continuously with both the density and the size ratios between tracers and beads of the bed. A di erence of size has an equivalent e ect on the tracer segregated position than a di erence of density. C om pared to the size segregation of beads of the same density, the progressive sinking of large tracers when increasing the size ratio is enhanced (resp. delayed) for denser (resp. lighter) tracers.

These facts are interpreted by the existence of two segregation processes a ecting the tracers: a geom etricale ect (dynam ical sieving process) and a mass e ect (push-away process). The push-away e ect makes heavy beads go towards the bottom of the ow. The geom etricale ect drives large beads towards the free surface. We could have expected that the density di erence between the beads is responsible for one e ect, and that the size di erence is responsible for the other one. But, a size di erence is responsible for the other one. But, a size on etrical and mass), while a density di erence in plies only the mass e ect. When tracers segregate on a ring, the two e ects exactly balance at a well-de ned vertical levelinside the ow. This level is the equilibrium location for these tracers. The segregation of the tracers appears consequently to the regrouping of all the identical tracers at the same equilibrium location.

In the size segregation between beads of the sam e density, the geom etrical e ect is dom inant at sm all size ratios (large beads segregate at the surface, as usually observed); the mass e ect is dom inant at very large size ratios (large beads segregate at the bottom); geom etrical and mass e ects balance for interm ediate ratios (large beads segregate at an interm ediate level). The variation of the relative intensities of both e ects explains the continuous progressive reversing of the position of large tracers when increasing the size ratio.

Because the balance happens at one particular level when a ring form s, at least one of the two segregation effects depends on the vertical coordinate in the ow. The evolution of the ring pattern gives two types of inform ation: (1) the focus of the pattern determ ines the intensity of the segregation process. It is observed to be strong for high size ratios, weak for sm all size ratios, whatever the density ratio is. (2) The variation of the radius of the ring shows that di erent m ass e ects can be in balance with geom etrical e ects due to the same size ratio, but acting at di erent levels in the ow. D ata on focus and radius allow to conclude that the geom etrical e ect de-

pends strongly on the size ratio, as expected, but also on the vertical location in the ow. W hile the mass e ect depends mostly on the size and density ratios.

Consequently, the two e ects (m ass and geom etrical) implied in the size segregation of beads of equal density can be separated when using the whole set of data acquired on the locations of segregated beads of di erent densities and sizes: (1) Considering two tracers of di erent sizes and densities at the sam e location, the di erence of geom etrical e ect due to the size di erence is exactly balanced by the di erence of mass e ect. (2) Considering two tracers of the same size, at two di erent locations, which is possible if they have dierent densities, the di erence of geom etrical force due to the variation of the location is exactly balanced by the di erence of m ass effect. By modeling the mass e ect, the geometrical e ect can be calculated in function of both location and size ratio. This is currently under developm ent in a model of the geom etricale ect responsible for the segregation [49].
