The linear Ising model and its analytic continuation, random walk

A generalization of G auss's principle is used to derive the error laws corresponding to Types II and V II distributions in Pearson's classi cation scheme. Student's r-pdf (Type II) governs the distribution of the internal energy of a uniform, linear chain, Ising model, while analytic continuation of the uniform exchange energy converts it into a Student t-density (Type V II) for the position of a random walk in a single spatial dimension. Higher dimensional spaces, corresponding to larger degrees of freedom and generalizations to multidimensional Student r-and t-densities, are obtained by considering independent and identically distributed random variables, having rotationally invariant densities, whose entropies are additive and generating functions are multiplicative.

A relation between the Ising problem and random walks has been conjectured a number of times over the years [1]. Rather than one of technique, we shall show in this letter that the two are inter convertible through analytic continuation of the uniform exchange energy which transforms a probability density function (pdf) of nite range into one of in nite range. Speci cally, a Student rpdf [2], of lim ited range, which governs the distribution of the internal energy of a linear, uniform Ising chain, is transform ed into Student's t-pdf, of unlim ited range, for the position of a random walker along an in nite linear chain, through analytic continuation of the uniform exchange energy between spins. These two fam ilies of distributions will be derived as error laws from a generalization of G auss's principle, which will serve in uniting these two seem ing unrelated phenom ena.

G auss's principle asserts that if the probability of an error, given the true value, is a function of the error alone, and the log-likelihood function is maximum when the true value coincides with the mean of the observed values, then the law of error must be norm al $[\beta]$. How – ever, many other error law sexist, such as the beta pdf, in which the probability of an error is not a function of the error alone $[\beta, pp. 165]$. Moreover, other error law s tend to the norm al law only in the asymptotic limit, where the num ber of observations increases without limit. Student's r- and t-pdfs fall into this category.

A law of error for determ ining the probability of deviations from a location parameter is given in the form :

The method of maximum likelihood switches the roles of variate, x, and parameter, , thereby converting the probability (1) into a likelihood function. Maximum likelihood is determined from a solution of

is them ost probable value of the quantity m easured, then the norm allaw follow sby integration of the log-likelihood equation. The log-likelihood equation is form ed by setting deviations from (2) proportional to deviations from (3), where the constant of proportionality is conveniently taken as the second derivative of an, at least, twice differentiable continuous function [4]. The norm allaw corresponds to the case of a negative unit weight

Integrating and using the integration function to complete the square yields the norm al pdf. For any other constant weight, we would get the weighted average β , pp. 214]

v ith P $_{i=1}^{n}$ i = 1, rather than the arithm etic m ean, (3). Actually, (4) must be true for whatever i is chosen. Hence, it must be independent of i, and, at most, can be a function of the location parameter . Except for the norm al law, where is a negative constant, the Poisson ¹, the binom ial, and negative, binolaw, where =m ial law s, where = [(1)]¹, respectively, other error laws cannot be derived from the conventional form of Gauss's principle [5]. One example is Student's t-pdf, even though it tends to the norm allow as the num ber of degrees of freedom increases without lim it. The t-pdf is nearly norm alat the centerbut it has fatter tails than the norm alpdf because higher order m om ents do not exist. A nother example is Student's r-pdf, notw ith standing the fact that all the moments of the distribution exist.

W e [5] have identi ed the weights, $_{i}$, as the second derivatives of the entropy. The weights we will consider here [3, pp. 210{211},

will lead to Pearson distributions of Types II (negative sign) and VII (positive sign). We assume that the information regarding the values of the location, , and scaling, s, parameters depend on [3, p. 379]

In the case of Type II distributions a single integration of gives the 'equation of state'

where we will soon appreciate as the intensive variable conjugate to the extensive variable u. In essence, (6) contains the statem ent of the second law of therm odynam ics

Introducing the equation of state (6) into (7) gives

Setting = J=T, where J is the uniform exchange energy between spins, and T the absolute temperature in energy units where Boltzm ann's constant is unity, u in (6) is identified as the ratio of the internal energy per unit spin to the exchange energy, and (8) is the zero-eld entropy reduction per spin of the uniform, linear chain, Ising model [6]. Since there are 2^{m} con gurations, the maximum entropy per spin is S (0) = log 2.

For m spins (7) will be m times as large. Viewed as the Legendre transform

The Legendre transform (9) is asymptotically equivalent to the Laplace transform

in the limit as m ! 1. The function, u = S(u), has a minimum on [1;0] at the interior point (6). Employing Laplace's method, the integral (12) can be evaluated by developing the exponent in a Taylor series to second order about the minimum (6), and using the fact that m is so large that the value of the resulting G aussian integral is barely changed when the low er limit of integration is set equal to $1 \cdot W$ e then obtain

for the expression of the generating function of m spins. Consequently, (10) and (11) are logarithm ically equivalent.

The entropy reduction determ ines the univariate pdf through Boltzm ann's principle [9]:

Consider a uniform distribution of mass inside a hypersphere of m-dimensions with unit radius. The energies $U_1; \ldots; U_m$ of m spins are supposed to be independent and identically distributed (iid), and, in addition, they have rotationally invariant densities. Such a hypersphere will be spanned by the coordinates, $u_1; \ldots; u_m$. The Euclidean distance from the origin to any point

The multidim ensional pdf, (15), shows that we are essentially dealing with a beta pdf

de ned over [1;+1], rather than over [1;0]. In fact, the entropy reduction, (7) can be written as an entropy of m ixing

The distribution of mass inside a spherical layer whose radius varies from (1) to 1, with an in nitesimal quantity is [8, p. 191]

where the constants have been absorbed into the new de nition of K. This is the same pdf as (15), except that m has been reduced by a factor of 2. A change of variable, $u = \cos$, converts it into

For a sphere, m = 3, and it is well-known that two points on its surface subtend an angle between and + d, at the center of the sphere, if and only if the second point falls in a ring of area 2 sin d. This occurs with probability 2 sin d =4 = $\frac{1}{2}$ sin d [10].

The approach to the norm alpdf can be viewed in the following terms. As m increases, jumps to the left and right will tend to equalize, like heads and tails, so that the distribution will tend to concentrate around the origin. To avoid this, and derive the shape of the asymptotic distribution, we introduce the scaling u ! $u = \frac{1}{m}$ [8, p. 59] so that 1 $u^2 = m^{-\frac{1}{2}(m-1)}$! $e^{-\frac{1}{2}u^2}$. The norm ald istribution is obtained in the limit without having to invoke any assumptions regarding the central limit theorem .

The form of the pdf (15) agrees with that found from the log-likelihood equation for the centering parameter [3, p. 210]

of a Type II kw. A part from the norm ing constant, the likelihood function is seen to be the product of pdfs of the form (15).

Analytic continuation of the exchange energy, (i.e., J ! iJ) converts the therm all equation of state (6) into¹

where ! i, and u ! iu in (6) ². W hat was an inverse temperature has now become an angle, . Such a process simulates a symmetric walk on an in nite 1-dimensional lattice, where what was the dimensionless internal energy per unit spin, u, is now the position of the walker along the chain. Since the interval for is $\left[\frac{1}{2};\frac{1}{2}\right]$, the walker can wander o to 1.

O n account of the properties of concavity and convexity, the equation of state (17) is the negative derivative of the entropy and the positive derivative of the logarithm of the generating function, respectively. D i erentiating a second time shows that we are dealing with a Type V II distribution, whose weight is given by $_{+}$ in (5). Integrating (17) gives the entropy reduction

The characteristic function of a random walk model with equal a priori probabilities of a jump to the left or to the right is \cos^3 . This symmetric Bernoullian

¹ Feller [11] gives a 2-dim ensional example where the random equation of state, (17), for u has the density (22) with m = 2. It consists of a light source at the origin on a wall and a rotating m irror whose axis of rotation is at a unit distance from the wall. The angle of rotation is distributed uniform ly between $\frac{1}{2}$ and $\frac{1}{2}$, according to (17), and u represents the distance between the light source and the point where the rected ray intersects the wall. The C auchy pdf represents the distribution of the inten-

sity of light along lines of constant v, the axis orthogonal to u in the u;v-plane. The convolution property of the C auchy pdf, according to Feller, is a statem ent of Hughen's principle which states that intensity of light is the same for a source located at the origin along the line v = 1, as it would be if the source were distributed along this line and the intensity were measured along v = 2. M oreover, if we make n measurements, the average, $(U_1 + U_2 + :::+ U_n) = n$, has exactly the same pdf as that of a single measurement, so that nothing is gained by making repeated measurements.

² A similar transformation leads from aperiodic to periodic behavior in Newton's reiteration scheme. An approximate root x_n of the equation g(x) = 0 has $x_{n+1} = x_n \quad g(x_n) = g^0(x_n)$ as its next approximation. For $g(x) = x^2$ 1, this reads $x_{n+1} = \frac{1}{2}(x_n + 1 = x_n)$. Setting $x_n = \coth_n$ gives $_{n+1} = 2_n$, without any trace of periodicity. However, by making x purely imaginary, x = iy, the iterative scheme $y_{n+1} = \frac{1}{2}(y_n - 1 = y_n)$ has the solution $y = \cot(\#)$, which demands that $\#_{n+1} = 2\#_n$ mod 1. Now, initial aperiodic behavior can lead to preperiodic orbits by an appropriate choice of a rational number for $\#_n$, instead of to a xed point [12].

³ The generating function exists for all real in all cases where the pdfhas a nite range, and in the case of the norm al law [3, p. 87]. In cases where the integral exists, the logarithm of the generating function will be equal in m agnitude and opposite in sign to the logarithm of the characteristic function.

distribution has mass $+\frac{1}{2}$ at sites +1 and 1. Since the jumps are iid, the characteristic function of m jumps is simply \cos^m . The inverse Fourier transform

gives the pdf, which in the large m-lim it, transform s into the norm alpdf. The approach to the norm alpdf can be obtained from Boltzm ann's principle, (13).

W ith the entropy reduction given by (18), the pdf for a single jum p of length u is given by Boltzm ann's principle, (13):

The form of the pdf (22) is, again, supported by the log-likelihood equation for the centering parameter [3, p. 210]

for the likelihood function of a Type V II law. To within a constant factor, the likelihood function is a product of pdfs of the form (22).

The pdf (22) is a generalization of the 1-dimensional Student t-pdf with m degrees of freedom to an m-dimensional distribution having the same number of degrees of freedom [8, p. 194]. In the limit as m! 1, (22) transforms into the norm alpdf,

and the scaling u ! u = m has been introduced. Student's t-distribution (22) can, therefore, rightly be considered the last stop before norm ality for large, but nite, m.

We have derived Student's t-pdf from Boltzm ann's principle, (13), where the entropy (18) is independent of the number of degrees of freedom. As a consequence of their statistical independence, the entropy is additive. For m idd random variables, or degrees of freedom, the total entropy is m times as great as the entropy of a single variate, while the joint pdf is the product of functions, and this can only be true if there is a logarithm ic relation between the two. If this were not the case, it would be im possible to talk about the entropy of a single constituent of the system, or the probability of a single event. Consequently, any putative expression for the entropy which is de ned in term s of the degrees of freedom of the system [14] must be considered not as an entropy, but, rather, as an interpolation formula between two bona de expressions of the entropy. A prototype is the Renyi entropy, which is an interpolation formula connecting the Boltzm ann-Hartley and the Gibbs-Shannon entropies as a param eter ranges over its perm itted values (i.e., those that preserve the property of Schur-concavity [15]).

⁴ The distinction between (22) and the C auchy distribution in <^m is the following. For m = 2, the probability that a vector in a random ly chosen direction with a length R will be greater than r is $Pr(R > r) = (1 + r^2)^{\frac{1}{2}}$ [11, p. 71]. The extreme observations that m 1 will be greater than r while the remaining one will lie in the range dr will have a density proportional to $r(1 + r^2)^{\frac{1}{2}(m+1)}$. The change of variable, $r = {}^{p}\overline{x}$ will convert it into a beta density of the second kind, proportional to $(1 + x)^{(\frac{1}{2}m+1)}$. Likewise, the property of extrem e observations for $Pr(R > r) = (1 - r^2)^{\frac{1}{2}}$ will lead to a beta density of the rst kind, which is closely allied to order statistics. For extrem e observations of largest value, B oltzm ann's principle (13) m ust be modil ed in such a way that the logarithm of the tail of the distribution is proportional to the entropy reduction [13].
