Probing the superconducting gap symmetry of PrR u_4Sb_{12} : A

com parison with P rO s_4Sb_{12}

Abstract

We report m easurements of the magnetic penetration depth in single crystals of $PrRu_4Sb_{12}$ down to 0.1 K.Both and super uid density _s exhibit an exponential behavior for $T < 0.5T_c$, with parameters (0)/k_BT_c = 1.9 and (0) = 2900 A. The value of (0) is consistent with the speci cheat jump value of $C = T_c = 1.87$ m easured elsewhere, while the value of (0) is consistent with the measured value of the electronic heat-capacity coe cient . Our data are consistent with PrRu₄Sb₁₂ being a moderate-coupling, fully-gapped superconductor. We suggest experiments to study how the nature of the superconducting state evolves with increasing Ru substitution for 0 s. The recent discovery^{1,2} of the H eavy Ferm ion (HF) skuttenudite superconductor (SC) P rO s₄Sb₁₂ has attracted much interest due to its di erences with the other HFSC. M easurements of dc magnetic susceptibility, speci c heat, electrical resistivity and inelastic neutron scattering showed that the ninefold degenerate J = 4 H und's rule multiplet of Pr is split by the cubic crystal electric eld, such that its ground state is a nonmagnetic $_3$ doublet, separated from the rst excited state $_5$ by 10 K. Hence its HF behavior, and consequently the origin of its superconductivity, m ight be attributed to the interaction between the electric quadrupolar m on ents of Pr³⁺ and the conduction electrons. It is thus a candidate for the rst superconductor mediated by quadrupolar uctuations, i.e. by neither electron-phonon nor, as with other HFSC, magnetic interactions.

Surprisingly, replacement of 0 s by Ru, i.e. in $PrRu_4Sb_{12}$, yields a superconductor with T_c 125 K with signicantly dierent properties. From the slope of the upper critical eld near T_c, ({dH $_{c2}$ /dT)_{T_c} = 2.4 kO e/K and using the procedure in Ref. 1, we get the e ec- $20m_{e}$. This contrasts with the value m $/m_{e} = 45$ for tive m ass of the heavy electrons m PrOs₄Sb₁₂, showing that while PrOs₄Sb₁₂ is clearly a heavy-ferm ion material, PrRu₄Sb₁₂ is at most, a marginal HF. Various experimental results suggest that these two materials have di erent order-param eter sym m etry. Firstly, there is an absence of a Hebel-Slichter peak in the nuclear quadrupole resonance (NQR) data⁴ for $PrOs_4Sb_{12}$, while a distinct coherence peak was seen⁵ in the Sb-NQR $1/T_1$ data for $PrRu_4Sb_{12}$. Secondly, the low-tem perature power-law behavior seen in speci c heat and penetration depth⁶, and the angular variation of therm alconductivity⁷, suggest the presence of nodes in the order parameter of PrO s_4 Sb₁₂. Speci cally, Refs. 6 and 7 reveal the presence of point nodes on the Ferm i surface (FS). For $PrRu_4Sb_{12}$, however, an exponential decrease in $1/T_1$ is observed below the Hebel-Slichter peak⁵ and was twith an isotropic gap of magnitude $(0) = 1.5k_{\rm B}T_{\rm c}$, where (0) is the magnitude of the zero-tem perature superconducting gap. Thirdly, muon spin rotation (SR) experim ents on PrO s₄Sb₁₂ reveal the spontaneous appearance of static internalm agnetic elds below T_c, providing evidence that the superconducting state is a time-reversal-symmetrybreaking (TRSB) state⁸. Such experiments have not been performed on $PrRu_4Sb_{12}$.

In this paper, we present high-precision measurements of penetration depth (T) of $PrRu_4Sb_{12}$ at temperatures down to 0.1 K using the same experimental conditions⁶ as for $PrOs_4Sb_{12}$. Both (T) and super uid density _s(T) exhibit exponential behavior at low temperatures, suggesting the presence of an isotropic superconducting gap on the FS.D ata

are best t by the parameters $(0)/k_B T_c = 1.9$ and (0) = 2900 A, and thus suggest that $P rR u_4 Sb_{12}$ is a moderate-coupling, fully-gapped superconductor. The values of $(0)/k_B T_c$ and (0) are consistent with values³ derived from the speci c-heat jump $C = T_c = 1.87$, and the linear speci c-heat coe cient .

D etails of sam ple grow th and characterization are described in Ref. 3. The observation of the de Haas-van Alphen (dHvA) e ect from the same batch of sam ples⁹, and the large residual resistivity ratio (RRR 76), relect the high quality of the sam ples. M easurements were performed utilizing a 21-M Hz tunnel diode oscillator¹⁰ with a noise level of 2 parts in 10^9 and low drift. The magnitude of the ac eld was estimated to be less than 40 m 0 e. The cryostat was surrounded by a bilayer M um etal shield that reduced the dc eld to less than 1 m 0 e. The sam ple was mounted, using a small amount of GE varnish, on a single crystal sapphire rod. The other end of the rod was therm ally connected to the mixing chamber of an 0 x ford K elvinox 25 dilution refrigerator. The sam ple tem perature is monitored using a calibrated RuO₂ resistor at low tem peratures (T _{base} to 1.8 K).

The deviation $(T) = (T) \{ (0.1 \text{ K}) \text{ is proportional to the change in resonant} frequency <math>f(T)$ of the oscillator, with the proportionality factor G dependent on sample and coil geometries. We determ ine G for a pure Al single crystal by tting the Al data to extrem e nonlocal expressions and then adjust for relative sample dimensions¹¹. Testing this approach on a single crystal of Pb, we found good agreement with conventional BCS expressions. The value of G obtained this way has an uncertainty of 10% because our sample, with approximate dimensions 0.7 $0.5 \quad 0.25 \text{ mm}^3$, has a rectangular, rather than square, basal area¹².

Figure 1 () shows (T) for PrRu $_4$ Sb₁₂ as a function of temperature in the lowtemperature region. The inset shows (T) for the entire temperature range. The value of T_c, taken to be the mid-point of the transition, is 1.25 K. The data points atten out below 0.22 K (0.18T_c), in plying activated behavior in this temperature range. Contrasting this, we superpose data for PrO s₄Sb₁₂ on the same gure (), which show varying strongly (T²) with temperature, indicative of low-lying excitations⁶. We t the PrRu₄Sb₁₂ data to the BCS low-temperature expression in the clean and local limit, from T_{base} (0.1 K 0.08 T_c) to 0.65 K (0.5T_c), using the expression

with the proportionality constant and (0) as parameters. The best t (solid line in Fig. 1) is obtained when (0) = $2.4 \text{ K} = 1.9 \text{k}_{\text{B}} \text{ T}_{\text{c}}$. This value is larger than the BCS weak-coupling value of $1.76 \text{k}_{\text{B}} \text{ T}_{\text{c}}$, suggesting that $P \text{ rR } u_4 \text{ Sb}_{12}$ is in the moderate-coupling regime. To check the validity of this value of (0) we make use of the strong-coupling equations^{13,14}

where each represents the correction factor to the corresponding weak-coupling BCS value. If we take $(0)=1.9k_BT_c$, then Eq. (2) gives the characteristic (equivalent Einstein) frequency !₀ 17 K and Eq. (3) gives $C = T_c = 1.9$. This value of $C = T_c$ agrees excellently with the measured value (1.87) in Ref. 3, giving further evidence that $PrRu_4Sb_{12}$ is indeed a moderate-coupling superconductor.

To extract the super uid density $_{\rm s}$ from our data, we need to know (0). For a type-II superconductor, (0) can be obtained from 15

where $_0=2.06\ 10^9\ G\ A^2$ is the ux quantum, $H_{c2}(0)$ is the upper critical eld at T=0, $_{sc}(0)=k_BT_c$, and is the electronic speci c heat coe cient. Using $(dH_{c2}=dT)_{T_c}=2.4\ kOe/K$ from Ref. 3 and the expression $H_{c2}(0)=0.693(dH_{c2}/dT)_{T_c}T_c$, we obtain $H_{c2}(0)=2.16\ kOe$. The superconducting coherence length $_0$ can be estimated from the relation $H_{c2}(0)=_0=2$ $_0^2$, yielding $_0$ 400 A. The value = 59 m J/m ol K² is also obtained from Ref. 3. We calculate (0) using two methods: (1) Taking $_{sc}=1.9$, or (2) taking $_{sc}=1.76\ along\ with\ strong-coupling\ corrections\ (Eqs. 2 and 4)$. Both methods yield (0) 3200 A. This puts $PrRu_4Sb_{12}$ in the local limit. Furthermore, from dH vA data⁹, we estimate the mean free path 1 1300 A, in plying that the sam ple is close to the clean limit. To calculate $_s$ for an isotropic s-wave superconductor in the clean and local limits we use the expression $_{T}$

where $f = [\exp(E/k_B T) + 1]^1$ is the Ferm i function, and $E = [P^2 + (T)^2]^{1-2}$ is the quasiparticle energy. The tem perature-dependence of (T) can be obtained by using¹⁵

where $_{sc}$ is the only variable parameter, $T_c = 1.25$ K, a = 2/3, and the speci c heat jump C = C $C = T_c = 1.87$ is an experimentally obtained value³.

Fig. 2 shows the experimental () and calculated (solid and dotted lines) values of $_{\rm s}$ as a function of temperature. The best t from 0.1 K to 0.95 K (0.8T_c) is obtained when (0)=2900 A and (0)=1.9k_BT_c (solid line). This value of (0) is 10% lower than the earlier-calculated value of 3200 A, but is acceptable because of the uncertainty in obtaining the calibration factor G. The value of (0) once again agrees with the speci c-heat jump C = T_c obtained in Ref. 3 via Eqs. (2) and (3), though it disagrees with the weak-coupling value of $1.5k_B T_c$ in Ref. 5. The dotted line in Fig. 2, calculated using the weak-coupling parameters (0)= $1.76k_B T_c$ and C = T_c=1.43, clearly does not t the data. Our superuid data once again suggest that $PrRu_4Sb_{12}$ is a moderate-coupling superconductor with a superconducting gap on the entire FS.

It is apparent in Fig.2 that the data deviate from local BCS expression above 0.95 K.W e also noticed a small hump in near 1.1 K shown in Fig.1, which shows up as a curvature change in $_{\rm s}$ in Fig.2. These features may be due to inhom ogeneities and/or in purity e ects in the sample, because the T_c's of these single crystals vary¹⁶ between 1 K and 1.3 K.

It is puzzling that the substitution of Ru for Os (same column in the periodic table) causes $PrRu_4Sb_{12}$ to di er in so many respects from $PrOqSb_{12}$. Further, evidence for gap anisotropy in the latter compound is contradicted by SR measurements¹⁷ (suggesting either s or p-wave pairing, with (0)=2.1k_BT_c), scanning tunneling spectroscopy¹⁸, and NQR measurements⁴ (with (0)=2.6k_BT_c). If both $PrRu_4Sb_{12}$ and $PrOqS_4Sb_{12}$ have isotropic gaps, then they are unique, especially the latter, among HFSC, suggesting the possibility of (a) an important di erence in superconducting properties between HFSC with magnetic and non-magnetic f-ion ground states, and (b) a correlation between pairing symmetry (isotropic ornodalgap) and mechanism (quadrupolar orm agnetic uctuations) of superconductivity¹⁷.

Recently, Frederick et al. perform ed X-ray powder di raction, magnetic susceptibility and electrical resistivity measurements¹⁹ on single crystals of $Pr(Os_{1 x} Ru_{x})_{4}Sb_{12}$. They found that (1) the lattice constant a decreases approximately linearly with increasing Ru concentration, (2) the splitting between the ground and rst excited state increases monotonically with x, with the ts consistent with a $_3$ doublet ground state for all values of x, although reasonable ts can be obtained for a $_1$ ground state for x near 0 and 1, and (3) T_c decreases nearly linearly with substituent concentration away from x= 0 and x= 1, but exhibits a deep m inimum (0.75 K) at x = 0.6. The smooth evolution of a and T_c with x, and the presence of superconductivity for all values of x, m ay suggest that both PrOs₄Sb₁₂ and PrRu₄Sb₁₂ possess the same order-parameter symmetry. The m inimum in T_c at x = 0.6 could simply mark the shift from quadrupolar-mediated heavy fermion superconductivity to phonon-mediated BCS superconductivity. On the other hand, one still has to contend with measurements^{6,7,8,20} that indicate point-node gap structure, TRSB and double superconducting transitions in PrOs₄Sb₁₂. If so, the minimum in T_c could be a consequence of competing order-parameter symmetries with a possible quantum critical point between them. It is also interesting to notice in Ref. 19 that the step-like structure seen in ac susceptibility data in the x= 0 sample, i.e. PrOs₄Sb₁₂, indicative of an intrinsic second superconducting transition, is not seen for all other values of x.

To further elucidate the relationship between PrOs₄Sb₁₂ and PrRu₄Sb₁₂, work is underway looking at the changes in penetration depth on Pr(Os_{1 x} Ru_x)₄Sb₁₂ for a range of values of x. We want to know at which value of x (paying close attention to the value x = 0.6), if any, does the isotropic superconducting gap evolve into a nodal one. Moreover, we want to know whether the second superconducting transition²⁰ seen in PrOs₄Sb₁₂ can also be seen in sam ples where 0 < x = 1. If we do not see the second superconducting transition in the other sam ples, then it is possible that the superconductivity in the two superconducting phases of PrOs₄Sb₁₂ respond di erently to impurities (Ru substituents) | one is completely destroyed by even tiny amounts of in purities, while the other persists (though weakened) all the way to PrRu₄Sb₁₂. It m ight be useful also if the impurity introduced is of an element that would not produce an isostructural superconducting com pound.

In conclusion, we report m easurements of the magnetic penetration depth in single crystals of $PrRu_4Sb_{12}$ down to 0.1 K using a tunnel-diode based, self-inductive technique at 21 M Hz. Both and _s exhibit an exponential behavior for $T < 0.5T_c$, with parameters (0)/ $k_BT_c = 1.9$ and (0) = 2900 A. The value of (0) is consistent with the speci c-heat jump value of $C = T_c = 1.87$ m easured elsewhere³, while the value of (0) is consistent with the measured value³ of the electronic heat-capacity coe cient , and (0). Our data are

consistent with $P rR u_4 Sb_{12}$ being a moderate-coupling, fully-gapped superconductor. We also suggest further experiments that can be done to study how the nature of the superconducting state evolves with R u substitution, to further elucidate the relationship among HF behavior, superconducting gap structure, and the presence of TRSB in the superconducting state.
