Local G eom etry of the Ferm i Surface and the Cyclotron R esonance in M etals in a N orm al M agnetic Field

In this paper we present a detailed theoretical analysis of the cyclotron resonance in m etals in the m agnetic eld directed along a norm alto the surface of a sam ple. We show that this resonance occurs due to localgeom etry of the Ferm isurface of a m etal. When the Ferm isurface (FS) includes segments where its curvature turns zero, this could give rise to resonance features in the frequency/m agnetic eld dependence of the surface in pedance or its derivative with respect to the eld. O therw ise the resonance is scarcely detectable unlike the well-known cyclotron resonance in a parallel m agnetic eld. The proposed theory agrees with experimental results concerning both convenient and organic m etals.

H igh-frequency properties of m etals in the presence of an external magnetic eld were repeatedly analyzed in detail. It is well known that a periodical motion of conduction electrons in the magnetic eld can cause a resonance with the electric eld of an incident electrom aqnetic wave. This resonance occurs when the cyclotron frequency of electrons coincides with the frequency of the electrom agnetic eld ! : There are two geom etries providing the resonance features in the surface in pedance to be displayed. At rst, strong resonance arises when the magnetic eld is directed nearly in parallel with the surface of a metal. The conduction electrons spiral around the magnetic eld and at each revolution some of them return to the skin layer where they gain energy from the electrom agnetic wave. A nother opportunity for the resonance appears when the magnetic eld is perpendicular to the surface. In this case some conduction electrons remain within the skin layer for a long time absorbing the energy. As a rule, the cyclotron resonance in a normalmagnetic eld is not manifested in good metals. The usual explanation is that the skin layer in m etals is very thin at high frequencies. Therefore the percentage of conduction electrons moving within the skin layer in parallel with the metal surface is too small to provide a distinquishable resonance feature at ! = in either the surface im pedance of the metal or the absorbed power. This was supported with thorough calculations carried out assuming the FS of a metal to be a smooth surface of a nonzero curvature (see e.g. [1]). Nevertheless, the cyclotron resonance in the norm alm agnetic eld was observed in potassium [2], cadmium and zinc [3, 4]. No detailed theory has yet been given for these old experin ents. Qualitative explanation of the experiments on

potassium was o ered basing on the assumption that the FS of this metal includes some cylindrical segments [5] (this assumption agrees with the results concerning the FS shape in potassium which follow from the charge density wave theory [6, 7, 8], and was con med in experiments of [9, 10]). Here, we adopt and further develop this approach.

The purpose of the present work is to show that the cyclotron resonance in the norm alm agnetic eld could appear in m etals when their Ferm i surfaces (FS) possess som e special local geom etrical characteristics such as local attenings, nearly cylindrical segments, fracture lines and som e others. The point of the present analysis is the e ect of the FS local geom etry on the frequency dependence of the surface im pedance. W e prove that when the FS of a metal has lines of zero curvature they a ect the anom alous skin e ect characteristics. As a result, the cyclotron resonance in the norm alm agnetic eld could be manifested in conventional metals in the same way as in layered organic metals. Cyclotron resonance in the norm al eld was observed in the experim ents [11, 12] on the quasi-two-dim ensional organic metals and there are grounds to believe that the e ect sensibly depends on the local geometry of the FSs of these substances [13]. W e also analyze possible manifestations of local attening on the FS in the surface in pedance. This enables us to sem iquantitatively describe resonance features resem bling those observed in cadmium and zinc [3, 4]. The outline of the remainder of this paper is as follows. In Section II, we analyze the e ects of the FS local geom etry on the electric conductivity tensor. In Section III, the surface in pedance is calculated, and it is shown that local anom alies of the FS curvature could give rise to various resonance features in the frequency dependence of the impedance near ! = : Finally, we discuss our results in Section IV.

II. ELECTRON CONDUCTIVITY

In further analysis we consider a sem i-in nite metal which lls the half-space z < 0: We assume that the external magnetic eld B is directed along the normal to the surface of metal. The response of the conduction electrons to an electrom agnetic disturbance of the frequency ! and the wave vector q (the latter is supposed to be parallel to "z" axis) could be expressed in terms of the electron conductivity components.

For a m etalw ith a closed Ferm isurface the latter could be w ritten as follows [14]:

Here, v; are the electron velocity components; p_z is the longitudinal component of electron quasim om entum; m_2 (p_z) is the electron cyclotron m ass, and is the electrons scattering time. The angular variable = t is related to the time t of electron motion along the cyclotron path. For a m etalw ith a com plex m any-sheet FS (for example, cadm ium or zinc), integration with respect to p_z in Eq.(1) is carried out within the limits determ ined by the form of each sheet, and summation is carried out over all sheets of the Ferm i surface. To analyze the cyclotron resonance we need an appropriate asym ptotic expression for the conductivity com ponents at large q when $u = !=qv_F$ is small compared to unity (v_F is the Ferm i velocity). Then we change variables in Eq.(1) and pass to integration over velocities space. To carry out the integration we divide the FS in segments supposing that electron quasimomentum components are single-valued functions of the velocity magnitude v and angles ;' determining the position of the velocity vector in spherical system of coordinates over each segment. This change of integration variables gives the result:

The sum m ation over "j" is carried out over allFS segments. When u << 1 the main contributions to the conductivity components (3) comes from narrow e ective strips on the FS where $v_z = 0$ (= =2): The principal terms in the expansion of the electrical conductivity tensor components in powers of $!=qv_F$ are independent of the magnetic eld. For $^0_{xx}$; we obtain the familiar relation:

A gain, sum m ation over j is carried out over the e ective strips on the FS, and K_j (=2;') is the Gaussian curvature at the corresponding points on the e ective j-th strip. The principal term in the asymptotic expression for the component $_{yy}$ is described by a similar form ula, where the numerator in the integrand in each term is replaced by $\sin^2 '$: For a metal with everywhere nite nonzero curvature of the FS the rst correction to the principal term in the expansion for $_{xx}$ has the form

The last term in (6) takes into account contributions from those parts of the FS which do not contain e ective lines. Integration with respect to and ' in each term of the sum s over r and j is carried out within the lim its set by the shape and size of the corresponding segment of the Ferm i surface. It follows from (6) that the quantity v_0 in the expression (5) has the dimensions of velocity, while its value for a one-sheet FS is of the order of Ferm i velocity of electrons. The rst correction to the main approximation of the electrical conductivity component vy is described by a similar expression.

In general, we can present the conductivity in the form :

 $_{1xx}$ could be found from Eq.(6). The conductivity approximation based on the expansion similar to Eq.(7) was employed in the earlier paper [13] concerning organic m etals. However, it is appropriate in general case provided that the FS curvature is nite and takes on nonzero values over the whole elective part of the FS.

Now, we start to analyze the e ect of the FS local geometry on the electron conductivity. First we assume that the FS curvature turns zero at a whole e ective line. We suppose that the curvature anom aly is attributed to the radius of curvature which is directed perpendicularly to the elective line. This means that the FS includes a nearly cylindrical segment whose curvature could be approxim ated as follow s:

where < 0; and the function W (;') accepts nonzero values.

The conductivity may be sensibly a ected due the presence of the nearly cylindrical belts on the FS. The reason is that the FS curvature at an elective cross-section is closely related to a width of the associated strip, that is, to the number of electrons which belong to the strip. The number of conduction electrons belonging to nearly cylindrical strips (< 0) could be significantly greater than for "norm al" elective strips, and this enhances the contribution from such strips to the conductivity. As a result a special term emerges in the asymptotic expression for the conductivity at large q:

To avoid tedious calculations we employ a model of axially symmetric FS in computation of this term. A ssuming that them agnetic eld is directed along the symmetry axis, both velocity magnitude and FS curvature do not depend on the angle ': This enables us to carry out integration with respect to ' and in the general expression (3). The conductivity tensor is diagonalized in circular components (!;q) = $_{xx}$ (!;q) i $_{yx}$ (!;q): U sing the approximation (8) for the curvature (the factor W (;') is now reduced to W ()); we get the following expressions for the additional term s $_a$:

Here, = 1 = ! + i = !; is a dimensionless parameter whose value is determined with the relative number

of the conduction electrons concentrated at the "anom alous" e ective cross-section. The term $_a$ (!;q) could predom inate, assuming that the parameter takes on values of the order of unity. O therwise, this term corresponds to the rst correction to the main approximation for the conductivity. We remark that Eq.(9) gives a general expression for the contribution to the transverse conductivity originating from a nearly cylindrical elective strip at any axially symmetric FS. Unlike resembling results of the earlier work [13] this expression is not associated with a particular form of the energy-momentum relation near the elective line.

Now, we turn to analysis of possible e ect of the FS local attening on the electron conductivity. For certainty we assume that the attening point is located at = =2; ' = 0: The contribution to _{xx} from the e ective strip passing through this point can be presented as the sum of two terms. The rst term has the same order of magnitude as the correction (5) and is given by

Like the quantity v_0 in the expression (5), v_a also has the dimensions of velocity. The second term, which contains the contribution to the conductivity from the locally at region can be represented in the form

W hen the singularity in the denom inator of Eq.(12) is well pronounced (the FS is nearly at in the vicinity of the corresponding point) this term could predom inate over the "usual" rst correction to the conductivity given by Eqs.(5),(10) as well as this occurs when the FS includes a nearly cylindrical elective strip.$

To bring more certainty into further analysis we adopt the following energy-momentum relation:




FIG. 1: Local attening of the lens described with Eq.(18) near the points ($p_z;0;0$): The curves representing the proles of the lens cross-sections at $p_z = 0$ are plotted for s = 0;0:2;0:4;0:5 (from the inner to the outer curve).

The corresponding FS is a lens whose radius and thickness are p_1 and p_2 , respectively; f ($p_x = p_2$) is an even function of p_x which increases monotonically for $p_x > 0$; provided that f(0) = 0; f(1) = 1: For l = 1 and $f(p_x=p_2) = (p_x=p_2)^2$; the energy-momentum relation (13) describes an ellipsoidal FS. In this case m_1 and m_2 are the principal values of the e ective mass tensor. The lens could be a part of a multiply connected FS.For example, electron lenses are included in the FSs of cadm ium and zinc. It is worth to mention that the cyclotron resonance in a norm alm agnetic eld was observed in both m etals.

The Gaussian curvature at any point of the lens corresponding to (13) is given by the expression

For the l > 1; the Gaussian curvature K ($p_x; p_y; p_z$) vanishes at the points $(p_2;0;0)$ coinciding with the vertices of the lens. This is illustrated in the Fig. 1. In view of axial symmetry of the lens, the curvatures of both principal cross-sections turn zero at these points, so the vertices are the points of attening of the FS.As usual, we assume the magnetic eld to be directed along the "z" axis, so, the attening points at the vertices of the lens belong to an e ective strip.

W hile carrying out integration in (12), we can use an approximate expression for the curvature of the lens in the vicinity of the attening region:

and (x) is the gamma function. The expansion of yyas well as expansions for nondiagonal conductivity com ponents, do not contain any such term since in this case the electron velocity component vy vanishes at the points of attening of the Ferm i surface.

C lose resemblance of the results (9) and (16) gives an evidence that locally attened and nearly cylindrical segments of the FSs a ect the high-frequency conductivity in a similar way. In both cases an additional term appears in the expression for conductivity, whose frequency dependence is special. In the next Section we show that these "anom alous" term s could sensibly in uence the frequency dependence of the surface in pedance giving rise to various resonance features at ! = :

III. SURFACE IM PEDANCE

W e calculate the surface im pedance of a sem i-in nite m etal in the presence of a norm alm agnetic eld. Calculations are carried out under the anom alous skin e ect conditions, when the electron m ean free path 1 is greater than the skin depth : We choose these conditions for they are favorable for observations of resonance features at cyclotron frequency. W e assum e a specular re ection of electrons from the m etal surface to predom inate, which is typical at anom abus skin e ect. W e start our calculations within the model of axially symmetric FS, so the surface in pedance tensor is diagonalized in circular com ponents. W e have:

At the anom abus skin e ect the surface impedance can be expanded in the inverse powers of the anom aly parameter. The main terms in this expansion originate from the addend Z_1 : These terms can be readily found by expanding the integrand in Eq.(20) in powers of the parameter given by:

To arrive at the result (24) we used three rst terms s in the expansion of $\overline{}$ in powers of the small parameter u and we kept the terms of the order of $(t=)^2$ in the expression for : Taking into account next terms in the expansion of $\overline{}$ in powers of u or keeping next terms in the expansion of we obtain that corresponding integrals diverge. Therefore we cannot expand the correction Z_1 in the inverse powers of the anom aly parameter and we leave it in the form :




FIG.2: Contours used for calculation of the quantities (a) Z_1 and (b) Z_2 :

Eqs.(24) { (26) include the parameter t_0 which has been introduced arbitrarily. As should be expected, however, we have $dZ = dt_0 = 0$. So, the impedance does not depedend of t_0 . Therefore, we can select a speci c value of the parameter t_0 (assuming that t_0) and then derive various equivalent form s of Eqs.(24) { (26).

Now, we perform analytic continuation of the integrands in Eqs.(25) and (26) to the rst quadrant of the complex plane. To calculate the term Z_1 we use a path shown in the Fig. 2a. The path includes segments of real and imaginary axes and a circular arc of the radius t_0 : To calculate Z_2 we choose the path shown in the Fig. 2b.

W e put $t_0 = ;$ and after som e straightforw and calculations we arrive at the result:

where the values of the dimensionless constants g; b and d are determined with the FS shape. For a spherical FS our result (27) agrees with the similar result derived earlier [1].




FIG.3: Magnetic eld dependence of the realpart of the surface in pedance near the cyclotron resonance assuming that the FS is axially symmetric at an elective cross-section for = 0.8; (left panel) and = 0.01 (right panel). The curves are plotted for $! = 10; ^3 = 10^4; = 0.8; 0.7; 0.6; 0.4$ (from the top to the bottom).

The result does not reveal resonance at the cyclotron frequency, since not a single term in the expression (27) for Z exhibits a resonance behavior at ! = : This proves that the cyclotron resonance in a norm alm agnetic elds cannot occur in m etals whose FSs possess nite and nonzero curvature, and em phasizes the part played by anom alies in the FS curvature in the appearance of the e ect. W e analyze the latter below.

We rst consider the case when the elective crosssections of the FS include one of a zero curvature. It can be the only nearly cylindrical cross-section if it is the central one. O therwise, the e ective cross-sections are combined in pairs which are symmetrically arranged with respect to a plane $p_z = 0$. The contribution of the nearly cylindrical cross-sections to the surface in pedance depends on the relative number of the electrons associated with them . W hen a considerable part of conduction electrons is concentrated at the nearly cylindrical e ective segments of the FS (1); then the anom alous contribution to the conductivity _a is the principal term in the expansion of the conductivity in powers of u; and it strongly contributes to the surface in pedance. As a result the principal term of the impedance in the case of anom alous skin e ect is given by

This expression shows a very special dependence of the surface impedance on the magnetic eld. Near the cy-

cbtron frequency the real and in aginary parts of the component Z swiftly rise. The increase in R (B) is no smaller in order than R (0) at the same frequency. In strong magnetic edds (! <<) the value of R (B) rises proportionally to (=!) = (+3) as shown in the Fig. 3 (see the left panel). When the parameter takes on values close to zero, R (B) almost levels o at strong magnetic edds whereas in the limit ! 1 R (B) =!:

No experimental observations of such impedance behavior have been reported. The reason is that we hardly can expect the parameter to take on values of the order of unity in real metals. We must rather expect that the relative number of electrons associated with the nearly cylindrical cross-section is small <<1. Then the principal term in the surface impedance expansion in inverse powers of the anom aly parameter remains the same, as given by Eq. (27). However, we obtain additional higher-order terms corresponding to the contribution of the anom alous elective cross-section. The main approximation for the correction originating from a nearly cylindrical elective strip equals:

A comparison of Eqs. (32) and (27) show sthistheterm Z_a is the largest am ong all corrections added to the principal term in the surface in pedance approximation. This correction describes resonance features at the cyclotron frequency in both realand in aginary parts of the im pedance com ponent Z (Fig. 3, right panel). The shape of the peak in the real part of the impedance resembles that recorded on potassium [2]. The peak height depends on the value of the parameter : For 10²;! 10, and 3 10⁴ the resonance amplitude in ReZ is approxin ately 10 2 of the principal term which agrees with the experiments of [2] on potassium, as well as with experim ents on organic m etals [11, 12].

In the previous section we showed that the "anom alous" contribution to the conductivity also could appear when an e ective strip on the FS includes a locally attened segment (see (16)). The occurence of such term in the conductivity can in uence the surface in pedance and cause resonance at the cyclotron frequency. A ssum ing the electrons to be specularly re ected we can write the follow ing expressions for the surface in pedance com ponents:

The results show that attening points on an elective strip of the FS could bring an additional term in the expression for impedance, in the same way as in the case when one of the elective strips on th FS is nearly cylindrical. The emergence of this contribution to the surface impedance (the last term in (34)) is associated with a broadening of the strip of elective electrons due to the presence of attening points on it.

The extent to which the locally at regions of the FS a ect the surface in pedance is determ ined by the relative number of the electrons associated with the attened regions and the param eter s characterizing the degree of attening of the FS in the vicinity of the attening point. If s considerably di ers from zero and s is not too sm all, this contribution m ay turn out to be signi cant and lead to the appearence of noticeable resonance type singularities in the frequency/eld dependencies of the surface impedance M hen s > 1=2; the resonance peak could be observed in the impedance itself, while for a less pronounced attening of the FS (0 < s < 1=2) the resonance singularity is manifested only in the eld and frequency dependencies of the derivative of im pedance. The experimental results obtained in Refs. [3, 4] for Cd and Zn indicate that in all probability, the latter of the above possibilities is realized in these metals. In other words, the attening of the FS at vertices of the electron lens is moderate (0 < s < 1=2): However, the rst possibility (s > 1=2) cannot be ruled out either, since a strong attening of the FS could be accompanied with a relatively sm all value of the parameter : In this case, the resonance singularity of the surface in pedance may not be revealed whereas the stronger singularity in the derivative of the impedance for the same is exhibited quite clearly. The derivative of the real part of the contribution to the impedance from a locally at region has the form :

W hile deriving this form ula (36), we have taken into account only the term with n = 1 in the sum over n in the expression for the resonance term in (34), since this result describes the eld dependence of dR =dB in the region of magnetic eld corresponding to the closeness of and !: The contribution from the harm onics of cyclotron resonance can be taken into account by considering other terms in the sum over n in (34). Finally, the quantity in the expression for is de ned as follow s:

The resonance nature of the dependence of dR = dBis manifested under the condition of smallness of the im aginary part of : A part from the obvious condition ! >> 1; the inequality j (=2;0) j<< ! must also be satis ed in order to keep the value of the above quantity low. If the FS attening points are located at the vertices of an electron lens, the electron velocity vector slightly varies during its motion along the part of the cyclotron orbit passing through the at region of the lens. Therefore, the quantity (=2;0) can be expected to be sm all here. How ever, if the magnetic eld is tilted away so that the point with coordinates = =2; ' = 0 on the Ferm i surface no longer coincides with the attening point, the value of (=2;0) m ay increase considerably, and the resonance can no longer be revealed. This is one of the reasons behind the weakening of the resonance as the magnetic eld deviates from the direction corresponding to the maximum amplitude of the resonance




FIG. 4: Plots of the function Y_s () versus magnetic eld for moderate (left panel) and strong (right panel) attening of the FS near the vertices of the lens (18). Curves are plotted assuming that (=2;0) = 0; ! = 10 for s = 0.25; 0:375 (left panel, dashed line and solid line, respectively) and s = 0.625; 0:75 (right panel, dashed line and solid line, respectively).




FIG.5: Resonance features in the magnetic eld dependence of dR =dB recorded in experiments of $[\beta, 4]$ on cadmium (a) and zinc (b). Curve 1 is plotted for B jj[1120] whereas curve 2 corresponds to the case when the angle between B and [1120] equal 8° (a). A m pli cation at the recording of the curve 2 com pared to that of the curve 1 is 10 :1.

observed in the experiments of [3]. Similar e ect is well known for quasitwo dimensional metals as discussed in [34, 35, 36].

Figure 4 displays the eld dependence of the function Y_s() for certain values of the parameter s: A comparison with Fig. 5, which contains the recording for dR = dBobtained in R efs. [3, 4] shows that the shape of the resonance lines described by (36) is in fairly good agreem ent with the experim ental results. The variation of the am plitude and shape of the resonance lines with decreasing s resembles the variation of the experimental resonance lines upon an increase in the angle between the magnetic eld and the axis $[11\overline{2}0]$: The latter rests in the plane perpendicular to the sym metry axis of the electron lens included in the FSs of cadm ium and zinc. The above sim ilarity is due to the fact that as the magnetic eld deviates from the axis [1120]; the e ective cross-section of the electron lens no longer passes through the attening points at the vertices of the lens but still rem ains quite close to them for small angles of deviation. So, it can be assumed that if the angle does not exceed a certain critical value o characterizing the size of the attening region on the FS, the parameters decreases with increasing ; but rem ains nonzero. The value s = 0 corresponds to angles $_{0}$; when the cyclotron orbit of e ective electrons no longer passes through the locally at region on the FS.

IV . D ISC U SSIO N

It is known that the local geometry of the FS could a ect high-frequency properties of m etals. W hen the effective belts on the FS are nearly cylindrical in shape or include attened segments, this brings changes in observables. These changes could be revealed for thing directions of propagation of an external disturbance. As a result, specic angular dependences are to be manifested in the observables. The e ect of the local geom etry on frequency and angular dependences of the dispersion and attenuation of ultrasound waves, and the surface impedance of a metal was predicted and analyzed before within some simple models of the FS [18, 19, 20, 21, 22, 23, 24, 25, 26]. The present analysis shows that local geometry of the FS also could give rise to the cyclotron resonance in the norm alm agnetic eld in good m etals.

A simple explanation of the e ect is that the contributions from attened or nearly cylindrical ægm ents of the FS to the electron density of states could be ænsibly greater than those from the rest of the surface. Therefore the number of e ective electrons moving inside the skin layer is increased which provides favorable conditions to the resonance to be manifested.

W e can show that even slight distortion of the original Ferm isphere caused by the crystalline elds brings along curvature anom alies. A dopting the nearly-free electrons approach we arrive at the energy-m om entum relation for conduction electrons:

where m is the e ective mass; k = g p; g = hG = 2; G is a reciprocal lattice wave vector; V is the Fourier com – ponent of the potential energy of electron in the lattice eld which corresponds to the vector G : W ithin the nearly-free-electron m odel the energy V is assumed to be small com pared to the Ferm i energy of electrons E_F ; so we introduce a small parameter = $V = E_F$:

The corresponding FS represents, roughly speaking, a sphere with "knobs" located at those segments which are close to the boundaries of the Brillouine zone. In ection lines of zero curvature pass along the boundary between knobs and the main body of the FS. A FS segment including a knob and its vicinity is axially symmetric, and the symmetry axis is directed along the corresponding reciprocal lattice vector. In further analysis we single out such FS segment to consider it separately. For certainty we choose the coordinate system whose "x" axis is directed along the reciprocal lattice vector. W ithin the chosen segment the FS curvature is described with the expression:

where $p_{\rm F}$ is the radius of the original Ferm isphere. Now, we can expand the variable $p_{\rm x}$ in powers of ($p_{\rm P}$ $p_{\rm P\,0}$) near the zero curvature line. Taking into account that $d^2p_{\rm x}=dp_{\rm P}^2$ turns zero at points belonging to the in ection line, and keeping the lowest-order terms in the expansion, we obtain:

This sem iquantitative analysis shows that the form of the energy-m om entum relation (13) could be reasonably justi ed within a nearly free electron approximation. In realm etals the attening of som e FS seem ents could be manifested even more. In ection lines as well as points of attening exist on the FSs of the most of the metals, therefore we can expect cyclotron resonance in a normalmagnetic eld to be manifested there for suitable magnetic eld directions. There is an experim ental evidence that "necks" connecting quasispherical pieces of the FS of copper include nearly cylindrical belts [27]. W hen the magnetic eld is directed along the axis of a "neck" (for instance, along the [111] direction in the quasim om enta space), the extrem al cross section of the "neck" could be expected to run along the nearly cylindrical strip where the FS curvature turns zero. It is also likely that the FS of gold possesses the sam e geom etrical features for it closely resembles that of copper. As was already m entioned the cyclotron resonance in the norm al eld was observed in organic metals of the (BEDT { $TTF)_2MHq(SCN)_4$ group and some other layered conductors. The FSs of these materials are supposed to be a set of weakly rippled cylinders (isolated or connected by links) [28, 29, 30, 31, 32, 33, 34, 35, 36] whose axes are perpendicular to the layers. U sually, the pro les of the cylinders are described adopting the tight-binding approximation for the electrons energy-momentum relation. W ithin this model the FS curvature is nite and nonzero at the e ective cross-sections assuming that the magnetic eld is directed along the axes of the cylinders. However, experimental results of [11, 12] do not agree with this model very well. Our approach was successfully used to analyze the e ects of various pro les of the cylinders on high-frequency properties of the layered conductors. A lso it was successfully applied to describe special features of quantum oscillations in the elastic constants in these materials [37], as well as in conventional metals [38].

Finally, this work presents novel results concerning the e ect of local anom alies of the FS curvature in the initiation of the cyclotron resonance in conventional metals in a norm alm agnetic eld. We show that this phenom enon could occur in 3D metals provided that their FSs include nearly cylindrical strips or attened segments, and we give a theoretical explanation to the existing experimental evidence of the works [2, 3, 4]. The presented results resemble those obtained for quasi-2D organicm etals which proves that the considered e ect has the same nature and origin in both kinds of materials. The results are based on thorough theoretical analysis and give further understanding of high-frequency properties of metals.
