# Local Geom etry of the Ferm isurface and the Cyclotron $R$ esonance in $M$ etals in a N orm alM agnetic Field

#### Abstract

In this paper we present a detailed theoretical analysis of the cyclotron resonance in $m$ etals in the $m$ agnetic eld directed along a norm alto the surface of a sam ple. W e show that th is resonance occurs due to localgeom etry of the Ferm isurface ofa m etal. W hen the Ferm isurface ( $F$ S ) includes segm ents where its curvature tums zero, this could give rise to resonance features in the frequency/m agnetic eld dependence of the surface im pedance or its derivative with respect to the eld. O therw ise the resonance is scarcely detectable unlike the well-known cyclotron resonance in a parallel magnetic eld. T he proposed theory agrees w ith experim ental results conceming both conven ient and organ ic $m$ etals.

## I. IN TRODUCTION

H igh-frequency properties ofm etals in the presence of an extemalmagnetic eld were repeatedly analyzed in detail. It is well know $n$ that a periodicalm otion of conduction electrons in the $m$ agnetic eld can cause a resonance w ith the electric eld of an incident electrom agnetic w ave. T h is resonance occursw hen the cyclotron frequency ofelectrons coincides w ith the frequency of the electrom agnetic eld !: T here are tw o geom etries providing the resonance features in the surface im pedance to be displayed. At rst, strong resonance arises when the $m$ agnetic eld is directed nearly in parallelw the the surface of a $m$ etal. The conduction electrons spiral around the $m$ agnetic eld and at each revolution som ef them retum to the skin layer where they gain energy from the electrom agnetic w ave. A nother opportunity for the resonance appears $w$ hen the $m$ agnetic eld is penpendicular to the surface. In this case som e conduction electrons rem ain within the skin layer for a long tim e absorbing the energy. A s a rule, the cyclotron resonance in a norm alm agnetic eld is not m anifested in good m etals. T he usual explanation is that the skin layer in $m$ etals is very thin at high frequencies. Therefore the percentage ofconduction electrons $m$ oving $w$ ithin the skin layer in parallel w th the $m$ etal surface is too $s m$ all to provide a distinquishable resonance feature at ! = in either the surface im pedance of the $m$ etal or the absorbed power. This was supported w th thorough calculations carried out assum ing the FS of a m etal to be a sm ooth surface of a nonzero curvature (see e.g [1]1]). N evertheless, the cyclotron resonance in the norm alm agnetic eld was ob-
 detailed theory has yet been given for these old experim ents. Q ualitative explanation of the experim ents on
potassium waso ered basing on the assum ption that the FS of this $m$ etal includes som e cylindrical segm ents [1] (this assum ption agrees w ith the results conceming the FS shape in potassium which follow from the charge den-
 in ents of $[\underline{10}, 1][1])$. Here, we adopt and further develop this approach.

The purpose of the present work is to show that the cyclotron resonance in the norm alm agnetic eld could appear in $m$ etals when their Ferm i surfaces (FS) possess som e special local geom etrical characteristics such as local attenings, nearly cylindrical segm ents, fracture lines and som e others. The point of the present analysis is the e ect of the FS local geom etry on the frequency dependence of the surface im pedance. $W$ e prove that when the FS of a m etal has lines of zero curvature they a ect the anom alous skin e ect characteristics. As a result, the cyclotron resonance in the norm alm agnetic eld could be $m$ anifested in conventional $m$ etals in the sam $e$ way as in layered organic $m$ etals. C yclotron resonance in the norm al eld was observed in the experim ents 11 the quasi-tw o-dim ensional organic $m$ etals and there are grounds to believe that the e ect sensibly depends on the local geom etry of the FSs of these substances [1] [1]. W e also analyze possible $m$ anifestations of local attening on the FS in the surface im pedance. This enables us to sem iquantitatively describe resonance features resem -
 outline of the rem ainder of this paper is as follow s. In Section II, we analyze the e ects of the FS local geom etry on the electric conductivity tensor. In Section III, the surface im pedance is calculated, and it is show $n$ that local anom alies of the FS curvature could give rise to various resonance features in the frequency dependence of the im pedance near ! = : Finally, we discuss our results in Section IV.

## II. ELECTRON CONDUCTIVITY

In further analysis we consider a sem i-in nite $m$ etal which lls the half-space $z<0$ : We assum e that the extemalm agnetic eld $B$ is directed along the norm al to the surface ofm etal. The response of the conduction electrons to an electrom agnetic disturbance of the frequency ! and the wave vector $q$ (the latter is supposed to be parallel to "z" axis) could be expressed in term s of the electron conductivity com ponents.

For a m etalw th a closed Ferm isurface the latter could be w ritten as follow s [14']:

Here, $v$; are the electron velocity com ponents; $p_{z}$ is the longitudinal com ponent of electron quasim om entum ; $m$ ? $\left(p_{z}\right)$ is the electron cyclotron $m$ ass, and is the electrons scattering time. The angular variable $=t$ is related to the time $t$ of electron $m$ otion along the cyclotron path. For a m etalw th a com plex m any-sheet FS (for exam ple, cadm ium or zinc), integration with respect to $\mathrm{p}_{\mathrm{z}}$ in Eq.(1) is carried out within the lim its deter$m$ ined by the form of each sheet, and sum $m$ ation is carried out over all sheets of the Ferm i surface. To analyze the cyclotron resonance we need an appropriate asym ptotic expression for the conductivity com ponents at large q when $\mathrm{u}=!=\mathrm{qv}_{\mathrm{F}}$ is small compared to unity ( $\mathrm{v}_{\mathrm{F}}$ is the Ferm i velocity). At $u \ll 1$ the correction ( ) is nearly proportional to and we can write the relation:

Then we change variables in Eq. (1) and pass to integration over velocities space. To carry out the integration we divide the FS in segm ents supposing that electron quasim om entum com ponents are single-valued functions of the velocity $m$ agnitude $v$ and angles $;^{\prime}$ determ ining the position of the velocity vector in spherical system of coordinates over each segm ent. This change of integration variables gives the result:

A gain, sum $m$ ation over $j$ is carried out over the e ective strips on the FS, and $K_{j}\left(=2 ;^{\prime}\right)$ is the G aussian curvature at the corresponding points on the e ective $j$-th strip. The last term in (6) takes into account contributions from those parts of the FS which do not contain e ective lines. Integration $w$ th respect to and' in each term of the sum s over $r$ and $j$ is carried out $w$ ithin the lim its set by the shape and size of the corresponding segm ent of the Ferm i surface. It follow s from (6) that the quantity
$\mathrm{V}_{0}$ in the expression (5) has the dim ensions of velocity, while its value for a one-sheet FS is of the order ofFerm i velocity of electrons. The rst correction to the m ain approxim ation of the electrical conductivity com ponent yy is described by a sim ilar expression.
In general, we can present the conductivity in the form :

Here, the coe cients $n x x$ are continuous functions of ! and : For instance, the expression for the coe cient
1xx could be found from Eq.(6). The conductivity approxim ation based on the expansion sim ilar to Eq.(7) w as em ployed in the earlier paper [1] ] conceming organic m etals. H ow ever, it is appropriate in general case provided that the FS curvature is nite and takes on nonzero values over the whole e ective part of the FS.

Now, we start to analyze the e ect of the FS local geom etry on the electron conductivity. First we assum e that the FS curvature tums zero at a whole e ective line. W e suppose that the curvature anom aly is attributed to the radius of curvature which is directed perpendicularly to the e ective line. This $m$ eans that the FS includes a nearly cylindrical segm ent whose curvature could be approxim ated as follow s:

where $<0$; and the function $W$ ( $;^{\prime}$ ) accepts nonzero values.

The conductivity may be sensibly a ected due the presence of the nearly cylindricalbelts on the FS .T he reason is that the FS curvature at an e ective cross-section is closely related to a width of the associated strip, that is, to the num ber of e ective electrons which belong to the strip. The num ber of conduction electrons belonging to nearly cylindrical strips ( < 0) could be significantly greater than for "norm al" e ective strips, and this enhances the contribution from such strips to the conductivity. A s a result a special term em erges in the asym ptotic expression for the conductivity at large q:

To avoid tedious calculations we em ploy a m odelofaxially sym $m$ etric FS in com putation of this term. A ssum ing that them agnetic eld is directed along the sym $m$ etry axis, both velocity $m$ agnitude and FS curvature do not depend on the angle ': This enables us to carry out integration w ith respect to ' and in the generalexpression (3). Here, $=1=!+i=!$; is a dim ensionless param eter whose value is determ ined w ith the relative num ber
of the conduction electrons concentrated at the "anom alous" e ective cross-section. The term a (! ;q) could predom inate, assum ing that the param eter takes on values of the order of unity. O therw ise, this term corresponds to the rst correction to the $m$ ain approxim ation for the conductivity. W e rem ark that Eq.(9) gives a generalexpression for the contribution to the transverse conductivity originating from a nearly cylindricale ective strip at any axially sym $m$ etric FS. Unlike resem bling results of the earlier work [ 1 [1] $w$ th a particular form of the energy-m om entum relation near the e ective line.

N ow, we tum to analysis of possible e ect of the FS local attening on the electron conductivity. For certainty we assum e that the attening point is located at

To bring $m$ ore certainty into further analysis we adopt the follow ing energy-m om entum relation:

The corresponding FS is a lens whose radius and thickness are $p_{1}$ and $p_{2}$, respectively; $f\left(p_{x}=p_{2}\right)$ is an even function of $p_{x}$ which increases $m$ onotonically for $p_{x}>0$; provided that $\mathrm{f}(0)=0 ; \mathrm{f}(1)=1$ : For $1=1$ and $f\left(p_{x}=p_{2}\right)=\left(p_{x}=p_{2}\right)^{2}$; the energy-m om entum relation (13) describes an ellipsoidalF. S. In this case $m_{1}$ and $m_{2}$ are the principal values of the e ective $m$ ass tensor. The lens could be a part of a m ultiply connected FS. For exam ple, electron lenses are included in the F Ss of cadm ium and zinc. It is worth to $m$ ention that the cyclotron resonance in a norm alm agnetic eld was observed in both $m$ etals.

The G aussian curvature at any point of the lens corresponding to (13) is given by the expression

For the $l>1$; the $G$ aussian curvature $K\left(p_{x} ; p_{y} ; p_{z}\right)$ vanishes at the points ( $\left.p_{2} ; 0 ; 0\right)$ coinciding $w$ th the vertioes of the lens. $T$ his is illustrated in the $F i g$. 1. In view of axial symmetry of the lens, the curvatures of both principal cross-sections tum zero at these points, so the vertioes are the points of attening of the FS. As usual, we assum e the magnetic eld to be directed along the "z" axis, so, the attening points at the vertioes of the lens belong to an e ective strip.

W hile carrying out integration in (12), we can use an approxim ate expression for the curvature of the lens in the vicinity of the attening region:

and $(x)$ is the gamma function. The expansion of $y y$ as well as expansions for nondiagonal conductivity com ponents, do not contain any such term since in this case the electron velocity com ponent $\mathrm{v}_{\mathrm{y}}$ vanishes at the points of attening of the Fem isurface.

C lose resem blance of the results (9) and (16) gives an evidence that locally attened and nearly cylindricalseg$m$ ents of the FSs a ect the high-frequency conductivity in a sim ilar way. In both cases an additional term appears in the expression for conductivity, whose frequency dependence is special. In the next Section we show that these "anom alous" term scould sensibly in uence the frequency dependence of the surface im pedance giving rise to various resonance features at! = :

## III. SURFACE IM PEDANCE

W e calculate the surface im pedance of a sem i-in nite $m$ etal in the presence of a norm alm agnetic eld. Calculations are carried out under the anom alous skin e ect conditions, when the electron $m$ ean free path $l$ is greater than the skin depth : W e choose these conditions for they are favorable for observations of resonance features at cyclotron frequency. W e assum e a specular re ection ofelectrons from the $m$ etalsurface to predom inate, which is typical at anom alous skin e ect. W e start our calculations $w$ ithin the $m$ odel of axially sym $m$ etric $F S$, so the surface im pedance tensor is diagonalized in circular com ponents. $W$ e have:

The result does not reveal resonance at the cyclotron frequency, since not a single term in the expression (27) for Z exhibits a resonance behavior at! $=$ : This proves that the cyclotron resonance in a norm alm agnetic elds cannot occur in m etals w hose F Ss possess nite and nonzero curvature, and em phasizes the part played by anom alies in the FS curvature in the appearance of the e ect. W e analyze the latter below .

W e rst consider the case when the e ective crosssections of the FS include one of a zero curvature. It can be the only nearly cylindrical cross-section if it is the central one. O therw ise, the e ective cross-sections are com bined in pairs which are sym m etrically arranged $w$ th respect to a plane $p_{z}=0$. The contribution of the nearly cylindricalcross-sections to the surface im pedance depends on the relative num ber of the e ective electrons associated w th them. W hen a considerable part of conduction electrons is concentrated at the nearly cylindrical e ective segm ents of the FS ( 1); then the anom alous contribution to the conductivity $a$ is the principalterm in the expansion of the conductivity in powers of $u$; and it strongly contributes to the surface im pedance. As a result the principal term of the im pedance in the case of anom alous skin e ect is given by

This expression show s a very special dependence of the surface im pedance on the $m$ agnetic eld. N ear the cy-
clotron frequency the real and im aginary parts of the component $Z$ sw iftly rise. The increase in $R(B)$ is no sm aller in order than $R(0)$ at the sam e frequency. In strong $m$ agnetic elds (! $\ll$ ) the value of $R(B)$ rises proportionally to $(=!)=(+3)$ as shown in the $F i g .3$ (see the left panel). W hen the param eter takes on values close to zero, R (B) alm ost levels o at strong magnetic eldswhereas in the lim it ! $1 \mathrm{R}(\mathrm{B}) \quad=$ !:

N o experim ental observations of such im pedance behavior have been reported. T he reason is that we hardly can expect the param eter to take on values of the order of unity in real m etals. W e must rather expect that the relative num ber ofelectrons associated $w$ ith the nearly cylindricalcross-section is sm all $\ll 1$. Then the principalterm in the surface im pedance expansion in inverse pow ers of the anom aly param eter rem ains the sam e, as given by Eq. (27). H ow ever, we obtain additional higher-order term s corresponding to the contribution of the anom alous e ective cross-section. T hem ain approxi$m$ ation for the correction originating from a nearly cylindricale ective strip equals:

A com parison ofEqs. (32) and (27) show sthis the term $\mathrm{Za}_{\mathrm{a}}$ is the largest am ong all corrections added to the principal term in the surface im pedance approxim ation. This correction describes resonance features at the cyclotron frequency in both realand im aginary parts of the im pedance com ponent Z (Fig. 3, right panel). T he shape of the peak in the real part of the im pedance resembles that recorded on potassium [2, [2]. T he peak height depends on the value of the param eter : For $10^{2}$; ! 10, and ${ }^{3} 10^{4}$ the resonance am plitude in ReZ is approxim ately $10{ }^{2}$ of the principal term which agrees w ith the experim ents of $\left[\frac{1}{[21]}\right.$ ] on potassium, as well as w ith experi$m$ ents on organic $m$ etals $\left[11_{1}^{\prime}, 12\right]$ in

In the previous section we showed that the "anom alous" contribution to the conductivity also could appear when an e ective strip on the FS includes a locally attened segm ent (see (16)). T he occurence of such term in the conductivity can in uence the surface im pedance and cause resonance at the cyclotron frequency. $T$ he results show that attening points on an e ective strip of the FS could bring an additionalterm in the expression for im pedance, in the sam eway as in the case when one of the e ective strips on th FS is nearly cylindrical. The em ergence of this contribution to the surface im pedance (the last term in (34)) is associated with a broadening of the strip of e ective electrons due to the presence of attening points on it.

The extent to which the locally at regions of the FS a ect the surface im pedance is determ ined by the relative num ber of the e ective electrons associated w ith the attened regions and the param eter s characterizing the degree of attening of the FS in the vicinity of the attening point. Ifs considerably di ers from zero and $s$ is not too sm all, th is contribution $m$ ay tum out to be signi cant and lead to the appearence of notioeable resonance type singularities in the frequency/ eld dependencies of the surface im pedance.W hen $s>1=2$; the resonance peak could be observed in the im pedance itself, while for a less pronounced attening of the FS $(0<s<1=2)$ the resonance singularity is $m$ anifested only in the eld and frequency dependencies of the derivative of im pedance. $T$ he experim ental results obtained in Refs. [1] and Zn indicate that in all probability, the latter of the above possibilities is realized in these $m$ etals. In other words, the attening of the FS at vertices of the electron lens is m oderate ( $0<\mathrm{s}<1=2$ ): H ow ever, the rst possibility ( $s>1=2$ ) cannot be ruled out either, since a strong attening of the FS could be accom panied w ith a relatively sm all value of the param eter : In this case, the resonance singularity of the surface im pedance $m$ ay not be revealed whereas the stronger singularity in the derivative of the im pedance for the same is exhibited quite clearly. The derivative of the real part of the contribution to the im pedance from a locally at region has the form :

The resonance nature of the dependence of $d R=d B$ is $m$ anifested under the condition of smallness of the im aginary part of : A part from the obvious condition ! >>1; the inequality $j(=2 ; 0)^{-j} \ll$ ! must also be satis ed in order to keep the value of the above quantity low. If the FS attening points are located at the vertioes of an electron lens, the e ective electron velocity vector slightly varies during its $m$ otion along the part of the cyclotron orbit passing through the at region of the lens. $T$ herefore, the quantity $(=2 ; 0)$ can be expected to be sm all here. H ow ever, if the $m$ agnetic eld is tilted aw ay so that the point $w$ ith coordinates $==2$; $^{\prime}=0$ on the Fem i surface no longer coincides w th the attening point, the value of $(=2 ; 0) \mathrm{m}$ ay increase considerably, and the resonance can no longer be revealed. This is one of the reasons behind the weakening of the resonance as the $m$ agnetic eld deviates from the direction corresponding to the maxim um amplitude of the resonance

IV.D ISCUSSIO N

It is known that the local geom etry of the FS could a ect high-frequency properties ofm etals. W hen the effective belts on the FS are nearly cylindrical in shape or include attened segm ents, this brings changes in observables. These changes could be revealed for tting directions of propagation of an extemal disturbance. A s a result, speci c angular dependences are to be $m$ anifested in the observables. The e ect of the local geom etry on frequency and angular dependences of the dispersion and attenuation of ultrasound waves, and the surface im pedance of a m etal was predicted and analyzed before w thin som e simple m odels of the FS
 show s that local geom etry of the FS also could give rise to the cyclotron resonance in the norm alm agnetic eld in good m etals.

A simple explanation of the e ect is that the contributions from attened or nearly cylindrical segm ents of the FS to the electron density of states could be sensibly greater than those from the rest of the surface. Therefore the num ber of e ective electrons $m$ oving inside the skin layer is increased which provides favorable conditions to the resonance to be $m$ anifested.

W e can show that even slight distortion of the original Ferm isphere caused by the crystalline elds brings along curvature anom alies. A dopting the nearly-free-electrons approach we arrive at the energy m om entum relation for
conduction electrons:

The corresponding FS represents, roughly speaking, a sphere w ith "knobs" located at those segm ents which are close to the boundaries of the B rillouine zone. In ection lines of zero curvature pass along the boundary betw een knobs and the $m$ ain body of the FS. A FS segm ent including a knob and its vicinity is axially sym $m$ etric, and the symmetry axis is directed along the corresponding reciprocal lattioe vector. In further analysis we single out such FS segm ent to consider it separately. For certainty we choose the coordinate system whose "x" axis is directed along the reciprocal lattice vector. W ithin the chosen segm ent the FS curvature is described w th the expression:

$T$ his sem iquantitative analysis show $s$ that the form of the energy-m om entum relation (13) could be reasonably justi ed within a nearly free electron approxim ation. In realm etals the attening of som E FS segm ents could be $m$ anifested even $m$ ore. In ection lines as well as points of attening exist on the FSs of the $m$ ost of the $m$ etals, therefore we can expect cyclotron resonance in a norm al m agnetic eld to be m anifested there for suitable m agnetic eld directions. There is an experim ental evidence that "necks" connecting quasispherical pieces of the FS of copper include nearly cylindrical belts [2] ${ }_{2}^{2}$ _1]. $W$ hen the $m$ agnetic eld is directed along the axis of a "neck" (for instance, along the [111] direction in the quasim om enta space), the extrem al cross section of the "neck" could be expected to run along the nearly cylindrical strip where the FS curvature tums zero. It is also likely that the FS of gold possesses the sam e geom etrical features for it closely resembles that of copper. A s w as already $m$ entioned the cyclotron resonance in the nom al eld was observed in organic metals of the ( BEDT \{ $\mathrm{TTF})_{2} \mathrm{MHg}(\mathrm{SCN})_{4}$ group and some other layered conductors. The FSs of these $m$ aterials are supposed to be a set of weakly rippled cylinders (isolated or connected
 are penpendicular to the layers. U sually, the pro les of the cylinders are described adopting the tight-binding approxim ation for the electrons energy -m om entum relation. W ithin this model the FS curvature is nite and nonzero at the e ective cross-sections assum ing that the m agnetic eld is directed along the axes of the cylinders. H ow ever, experim ental results of [1] 1 w ith this m odel very well. O ur approach w as succesfiully used to analyze the e ects of various pro les of the cylinders on high-frequency properties of the layered conductors. A lso it w as successfully applied to describe special features of quantum oscillations in the elastic constants in these $m$ aterials $[3]=1,1$ as well as in conventionalm etals [32

F inally, this w ork presents novel results conceming the e ect of local anom alies of the FS curvature in the in itiation of the cyclotron resonance in conventionalm etals in a norm alm agnetic eld. W e show that this phenom enon could occur in 3D m etals provided that their F Ss include nearly cylindrical strips or attened segm ents, and we give a theoretical explanation to the existing experim ental evidence of the works sults resem ble those obtained for quasi-2D organicm etals which proves that the considered e ect has the sam e nature and origin in both kinds ofm aterials. T he results are based on thorough theoretical analysis and give further understanding of high-frequency properties ofm etals.
