Local G eom etry of the Ferm i Surface and M agnetoacoustic R esponce of Two-D im ensional E lectron System s in Strong M agnetic Fields

A sem iclassical theory for magnetotrasport in a quantum Hall system near lling factor = 1-2 based on the Composite Ferm ions physical picture is used to analyze the elect of local attening of the Composite Ferm ion Ferm i surface (CF-FS) upon magnetoacoustic oscillations. We report on calculations of the velocity shift and attenuation of a surface acoustic wave (SAW) which travels above the two-dimensional electron system, and we show that local geometry of the CF-FS could give rise to noticeable changes in the magnitude and phase of the oscillations. We predict these changes to be revealed in experiments, and to be used in further studies of the shape and symmetries of the CF-FS. Main conclusions reported here could be applied to analyze magnetotransport in quantum Hall system s at higher lling factors = 3-2; 5-2 provided the Ferm i-liquid-like state of the system.

IN TRODUCTION AND BACKGROUND

A two-dimensional electron gas (2DEG) in a strong magnetic eld reveals rich and complex physics. Near half lling of the lowest Landau level (= 1=2) the ground state of such a system is shown to be a com – pressible Ferm i-liquid-like state of Composite Ferm ions (CF) [1]. These quasiparticles are distributed inside the Composite Ferm ion Ferm i Surface (CF-FS). A sim ilar physical picture could be adopted to describe the 2DEG at half lling of the next Landau level (= 3=2): Experim ental evidences of the CF Ferm i sea at = 1=2;3=2were repeatedly obtained during the recent decade [2].

For higher lling factors close to = N + 1=2 where N 3 is an integer, the exchange interaction would lead to an instability towards charge density wave form ation in the relevant Landau levels. The ground state of the 2DEG for these lling factors corresponds to a charge density wave (CDW) and has a striped structure [3, 4, 5, 6]. It could be described as a sequence of one dimensional stripes alternating between the adjacent lling factors N and N + 1. This gives rise to a strikingly anisotropic transport properties of the 2DEG at half lling of higher Landau levels [7, 8] which were revealed in experiments [9, 10, 11].

The quantum Hall state at = 5=2 is perhaps the m ost enigm atic due to its position in the magnetic eld spectrum between the high Landau level N 3 stripe phases and the low Landau level (N 1) Ferm i-liquid like states. Theoretical studies of this state started from the model of paired CFs [12]. Depending on the interaction strength within the system, the 2DEG at = 5=2 could reveal a striped state, a Ferm i(liquid, or the paired state [13]. Num erical simulations presented in [13] give grounds to believe that at = 5=2 the CF Ferm i liquid undergoes condensation to the paired state at low tem – perature lim it. A lso, there could be a transition from the

Ferm i{ liquid to the striped phase when in-plane m agnetic eld is applied. Recently, an experim entalevidence of the CF-FS at = 5=2 was obtained [14].

So, both theory and experiment give grounds to believe that physical picture of CFs which form a Fermi sea could be successfully employed to describe the 2DEG states at half lling of the low est Landau levels (N 2). However, the geometry of the CF-FS was not analyzed up to present. It is usually assumed that the CF Ferm i liquid is isotropic, and the CF-FS is a circle in the two-dimensional quasimomenta space. This is an obvious oversim pli cation. Real sam ples com m only used in studies of the quantum Halle ect have 2DEGs deposited in GaAs/AGaAs heterostructures. Therefore the crystalline eld of the host sem iconductor could signi cantly in uence the CF-FS geometry distorting the original Ferm i circle [15]. Another sourse of the CF-FS anisotropy, especially for higher lling factors (= 3=2;5=2), is the interaction in the electron system . The developm ent of highly an isotropic charge-density wave form ations (striped phases) at high lling factors including 5=2; gives us strong argum ents to expect these interactions to work as an extra crystalline eld at the Ferm iliquid state of the 2DEG at = 3=2;5=2. As a result the CF-FS shape could be further modi ed.

Theory of magnetotransport in metals showes that the FS localgeom etry noticeably a ects the electron response of the metal to an external perturbation [16]. The change in the response occurs under the nonlocal regime of propagation of the disturbance when the mean free path of electrons 1 is large compared to the wavelength of the disturbance : The reason is that in this nonlocal regime only those electrons whose motion is somehow consistent with the propagating perturbation can strongly absorb its energy. These "e cient" electrons are concentrated on sm all "e ective" segments of the FS.

W hen the FS includes attened segments it leads to

an enhancem ent of the contribution from these segments to the electron density of states (DOS) on the FS.Usually this enhanced contribution is small compared to the main term of the DOS which originates from all the remaining parts of the FS. Therefore it cannot produce noticeable changes in the response of the metal under the local regime of propagation of the disturbance (1 < <)when all segments of the FS contribute to the response functions essentially equally. However the contribution to the DOS from the attened section can be congruent to the contribution of a small "e ective" segment of the FS. In otherwordswhen the curvature of the FS becomes zero at some points on an "e ective" part of the FS it can give a signi cant enhancem ent of e cient electrons and, in consequence, a noticeable change in the response of the metal to the disturbance.

D ue to the same reasons we can expect local geom etrical features of the CF-FS to give signi cant e ects on the 2DEG response to an external disturbance. A swell as for convenient m etals, these e ects are to be revealed within a nonlocal regime (1 >): It was shown before that the local attening of the CF-FS could give rise to a strong anisotropy in the response of a 2DEG to a surface acoustic wave (SAW) [17]. Such anom aly was observed in experiments on m odulated 2DEG near = 1=2 [18].

Here, we analyze the in uence of the CF-FS local geom etry on so called geom etric resonances which were repeatedly observed in 2DEGs in strong magnetic eld [2], as well as in convenient metals [19]. These oscillations could be revealed within a nonlocal regime, and they appear due to periodical reproduction of the most favorable conditions for the resonance absorption of the energy of the external disturbance by quasiparticles at stationary points on the cyclotron orbit where they move along the wave front of the disturbance. W hen the external disturbance is associated with an acoustic wave these geom etric resonances are also called m agnetoacoustic oscillations [19]. In the following analysis we mostly consider magnetoacoustic oscillations in the 2DEG at = 1=2state, and we describe this state within the framework of Halperin, Lee and Read (HLR) theory [1]. However, we believe that the main results of the present analysis could be applied to study m agnetotransport in 2DEGs at higher lling factors (3=2;5=2) provided that the system is at a Ferm i-liquid-like state.

MAIN EQUATIONS

D ue to the piezoelectric properties of G aAS, the velocity shift (s=s) and the attenuation rate () for the SAW propagating along the x axis across the surface of a heterostructure containing 2DEG, take the form [20]:

Here q;! = sq are the SAW wave vector and frequency, respectively, is the piezoelectric coupling constant, m = "s=2; " is an electric dielectric constant of the background and xx is the component of the electron conductivity tensor.

A coording to HLR theory, the electron resistivity tensor at = 1=2 is given by:

where ^{CF} is the CF resistivity tensor, and the contribution ^{CS} originates from the Chem{Sim ons formulation of the theory. This tensor contains only o diagonal elements CS = CS = 4 h=e²:

The CF resistivity tensor ^{CF} could be calculated as the inverse for the CF conductivity ~ (^{CF} = ~ ¹): We carry out our analysis in a regime where $_{xx yy} << \frac{2}{xy}$; therefore the relevant component of the electron conductivity could be written in the form :

The CFs are supposed to experience not actual but reduced magnetic eld $B_{eff} = B$ $B_{1=2}$ where $B_{1=2}$ corresponds to one half lling of the lowest Landau level. Their motion could be described within a sem iclassical approximation based on the Boltzm ann's transport equation. Following standard methods [21] we obtain:

Here, m ; are the CF cyclotron mass and their cyclotron frequency at the eld $B_{\rm eff}$; is the CF scattering time, and $v_n\,$ (q) are the Fourier transforms of the CF velocity components:

The variable included in these expressions is the angular coordinate of the CF cyclotron orbit.

The most favorable conditions for magnetoacoustic oscillations to be revealed occur at moderately strong effective magnetic eld when ql >> >> 1:U nder these conditions the main contributions to the integrals over in the expressions (6),(7) come from the neighborhoods of stationary points at CF cyclotron orbits. So, the expressions for v_n (q) could be rewritten as:

Here, 2R is the diam eter of the CF cyclotron orbit in the direction of propagation of the SAW, X (qR) is a dim ensionless quantity, and V (qR) has dimensions of velocity. Both X (qR) and V (qR) are power functions of qR with the same exponent. As we show below, the value of the exponent is determined with the local geometry of sm all e ective segments of the CF-FS which correspond to the vicinities of the stationary points. When these segments are attened, this leads to signi cant changes in them agnitude of the magnetoacoustic oscillations.

THE CF-FSM ODEL

W ithin the commonly used isotropic model of CF Ferm i liquid at p = 1=2 the CF+FS is a circle, and its radius p_F equals 4 N h^2 where "N" is the electron density. To develop more realistic model of the CF+FS we include a periodic static electric eld applied along the "y" direction which provides CFs with the potential energy of magnitude U_g (g is the wave vector of the electric eld). The above electric eld could originate from interactions with electrons of low er Landau levels at = 3=2;5=2 and from the crystalline eld of the host sem iconductor. The latter is especially important at = 1=2: The point is that wherever it com es from , this eld distorts the CF-FS, including form ation of local anom alies of the CF+FS curvature.

A ssume for simplicity that the electric modulation is weak ($U_g << E_F$; where E_F is the CFs Ferm i energy). Then we can use the nearly-free-electron model to derive




FIG.1: The shape of the CF-FS in the nearly-free-electron approximation (solid line), and the CF-FS described with the Eq. (14) (dashed line). Point S_1 and S_2 are associated with the stationary points at the CF cyclotron orbit when the SAW wave vector q points in the p_x direction.

the energy-momentum relation for the CFs. W hen the modulation period is small enough hg > $2p_F$ we obtain:

Here $p_y = p_y$ hg=2; m is the CF e ective mass; U_g is the magnitude of the quasiparticle potential energy in the periodic electric eld. Calculating the FS curvature:

with $v = \frac{q}{v_x^2 + v_y^2}$ one can nd it tending to zero when p_x tends to $p_F (U_q = E_F)^{1=2}$ (See Fig.1).

In the vicinities of the corresponding points on the FS the quasiparticles velocities are nearly parallel to the the y direction. Near these zero curvature points we can derive an asymptotic expression for energy-momentum relation (10). Introducing $(p_{x_0}; p_{y_0})$ by $p_{x_0} = p_F$, $p_{y_0} = p_F - 1 - \frac{1}{2} \frac{1}{2}^2$, where $= \frac{P}{U_g = E_F}$, we can expand the variable p_y in powers of $(p_x - p_{x_0})$; and keep the lowest order terms in the expansion. We obtain:

Near p_{x0} , where $(\dot{p}_x p_{x_0} j < {}^2p_F)$ the rst term on the right side of Eq.(12) is small compared to the second one and can be om itted. So we have:

The "nearly free" particle model can be used when 2 is very small. For larger U_g the local attening of the CF-FS can be more signi cant. To analyze the contribution to the conductivity from these attened parts we generalize the expression for E (p) and de ne our dispersion as:

where p_0 is a constant with the dimensions of momentum, m_i are the elective masses, and is a dimensionless parameter which determ ines the shape of the CF {FS. .When > 2 the CF { $\frac{FS}{p_2}$ boks like an ellipse attened near the vertices (0; $m_2 = m_1 p_0$). Near these points the curvature is:

and, K ! 0 at p_x ! 0. The CF-FS will be the atter at $p_x = 0$, the larger is the parameter . A separate investigation is required to establish how depends on U_g : Here we postulate Eq.(14) as a natural generalization of Eq.(13).

W hen $p_F > hg$ we have to consider the CF {FS as consisting of several branches belonging to several "bands" or Brillouin zones. The modulating potential wave vector g in this case determ ines the size of the "unit cell". However with this condition we also may expect some branches of the CF {FS to be attened. W ithin an appropriate geom etry of an experim ent these attened segments of the CF-FS become the e ective parts of the FS.Consequently, the response of the CF system to the SAW could undergo signi cant changes. Prior to start the analysis of these changes we rem ark that our model of the deform ed CF-FS (14) could be easily generalized and accom odated to more com plicated geometry of electric eld which determ ines the CF-FS shape and symmetries. However, even the simple model (14) captures the essential physics, enabling to include local attenings of the CF-FS into consideration. Therefore we adopt this m odel in the further analysis.

RESULTS AND DISCUSSION

W hen the SAW propagates along the "x" direction the vertices $S_1; S_2$ of the attened ellipse (14) correspond to the stationary points on the CF cyclotron orbits (see Fig.

1). The enhanced DOS of quasiparticles in their vicinities in uences the features of the magnetoacoustic oscillations. Using the stationary-phase method we obtain the following asymptotics for the functions X (qR) and V (qR):

C om parison of our expressions (19) (21) with the results for a Ferm i circle showes that the local attening of the CF-FS near the points which correspond to the stationary points of the CFs cyclotron orbit enhances the m agnitude of the m agnetoacoustic oscillations of the CF conductivities. A similar e ect was studied before for conventionalm etals [23]. The e ect originates from the enhancem ent of the quasiparticle DOS at attened segm ents of the FS.

The above considered enhancement of magnetoacoustic geom etric oscillations could be manifested only when the stationary points on the CF cyclotron orbit correspond to the points located at attened segments of the CF-FS. Therefore the e ect has to be very sensitive to variations in the direction of the SAW propagation. Suppose that the SAW travels at some angle with respect to the sym m etry axis of the CF-FS as it is shown in Fig. 1. Then the stationary points slip from the attened pieces and fall into "norm al" segments of the FS whose curvature takes on nonzero values. Due to the low er D O S of quasiparticles at these "norm al" CF-FS segments, the number of e cient CFs which can participate in the absoption of the SAW energy decreases when the angle increases. This results in the noticeable reduction of the oscillations.

Assuming a nonzero value for the angle $\ ;$ we can present Fourier transform softhe CF velocity components in the form :

Expansions for the function W (qR;) could be ontained from (29),(30) by replacing cosines by sines of the same angles.




FIG. 2: Angular dependence of the amplitude of magnetoacoustic oscillations. The curves are plotted for qR = 10; $m_1 = m_2$; = 4 (curve 1); = 6 (curve 2); and = 8 (curve 3).

W hen ! 0 we arrive at our form er asymptotic expressions for the CF velocity components (16). W hile increases, the functions S (qR;) and W (qR;) dim inish and approach the value ($m_1=4m_2qR$)¹⁼² which is a typical estimate for an elliptical CF-FS as ! 90°: Angular dependence of the amplitude factor of magnetoa-coustic oscillations F²(qR;) = S²(qR;) + W²(qR;) is presented in the Fig. 2. We see in this gure that the e ect of local attening of the CF-FS on the oscillations amplitude remains distinguishable even for moderate attenings (= 4):

D i erences in m agnitudes of geom etric oscillations of the CF conductivity components are manifested in the electron conductivity. Substituting our results for ~ into (4) we have:

and we see that both am plitude and phase of the geom etric oscillations in the electron conductivity di er from those for the CF Ferm i circle. The same could be applied to magnetoacoustic oscillations described with the expressions (1),(2). W hen the e ective parts of the CF-FS are attened, the amplitude of the magnetoacoustic oscillations drops. We also conclude that varying the direction of propagation of the SAW we can observe angular dependence of the oscillations amplitude. The latter originates from the angular dependence of the CF conductivities discussed before. We have grounds to expect it to be revealed in experiments.

Finally, we belive that Ferm i-liquid state of a 2D EG in quantum H all regime at = 1=2;3=2;5=2 is anisotropic and exhibits an anisotropic CF-FS. The CF-FS geometry relects symmetries of the crystalline elds of the host semiconductor. For higher lling factors = 3=2;5=2 it also could show elects of interactions in the electron system. It was already found that screening due to polarization of remote Landau levels plays an essential role for the preferred orientation of the stripes induced by an in-plane magnetic eld at = 5=2 [24]. Therefore, we may conjecture that at weaker in-plane elds when Ferm i-liquid like state of the 2D EG still exits, these polarization elects could give extra anisotropies to the C fFS.

Anisotropic CF-FSs usually include som e attened segm ents. E ven a naive m odel (10) based on the nearly-freeelectron approach, dem onstrates that local attening of the CF-FS appears as a result of a weak deform ation of the latter with an electric modulation. In general, local attenings are initiated with electric elds acting within a 2DEG like crystalline elds in usualmetals. A coordingly, locations of the attened segments conform with the symm etries of the CF-FS and could reveal these sym m etries. The results of the present analysis show that magnetoacoustic oscillations in the velocity shift and attenuation of the SAW travelling in piezoelectric G aA s/A IG aA sheterostructures above the 2DEG, could be used as a toolto discover local attenings at the CF-FS when the 2DEG is in the quantum Hall regime at Ferm i-liquid like state. This could give a new know ledge of the shape and sym m etries of the CF-FS and, consequently, a better understanding of the magnetotransport in quantum Hall system snearhalf lling of low est Landau levels. It would be especially interesting to compare symmetries of the CF-FS at the Ferm i-liquid like state of the 2DEG at = 5=2with the characteristic symmetries of the striped state of the system at the same lling factor. It is possible that such comparison would give some unusual results providing a new insight in the nature of transition from the Ferm i-liquid to the striped phase of the 2D electron system .
