Charge and Statistics of Quasiholes in Pfa an States of Composite Fermion Excitations

## Abstract

The charge of quasiparticles in P fa an states of composite ferm ion excitations (the presence of which is indicated by recent experiments) is found. At the lling fraction of the P fa an state = p=q (of the lowest Landau level) the charge is e=(2q). As in the case of the P fa an state of electrons the statistics of N  $_{qh}$  quasiholes in the P fa an state corresponds to the spinor representation of U (1) SO (2N  $_{qh}$ ) (the continuous extension of the braid group). Here U (1) is given by the phase factor  $e^{i(\frac{1}{8}+\frac{1}{4m})}$  with m = 1+ , { the exclusion statistics parameter of Jain quasiparticles. The possiblity of Read-Rezayi states of Jain quasiparticles is also discussed.

Recently, the non-Laughlin and non-Jain states were observed in the fractional quantum Halle ect [1]. They can be interpreted as condensed states of composite ferm ion excitations [2,3]. Even-denominator states (i. e. at lling fractions with an even denominator) can be seen as P fa an states of Jain quasiparticles. Odd-denominator states correspond to the condensed states of composite ferm ion excitations which can either be Laughlin [4] (or Jain) states or condensed states of dierent origin. One possibility (as competing to Laughlin-Jain states) is the class of states proposed by Read and Rezayi [5] for electron states in higher Landau levels (Read-Rezayi states result from clustering of a number of particles, the P fa an state is the state of pairs of particles [6]). The other proposed states for the origin of odd-denominator states are Halperin paired states [749].

The composite ferm ion approach predicts the so-called Jain states at lling fractions of the form  $=\frac{n_0}{2p_0n_0+0}$  (where  $2p_0$  { the Chem-Sim ons composite ferm ion parameter being an even number,  $n_0$  { the number of excive shells lled, 0 { the sign of the excive eld with respect to the external magnetic eld). The excive eld is found when the mean Chem-Sim ons composite ferm ion eld is added to the external magnetic eld. Let us introduce the condensed states of composite ferm ion excitations (following [2]) which appear at the lling fraction of the form:

$$e^{1} = 2p_0 + \frac{0}{n_0 + 1} \tag{1}$$

where  $_1$  is the fraction in which the  $(n_0+1)$ -th e ective shell is partially led. All recently observed states [1] can be described within (1) (e.g.  $_{\rm e}=4$ =11, with  $p_0=1$ ,  $n_0=1$ ,  $_0=1$ ,  $_1=1$ =3). The states 4=13, 5=17, correspond to the  $_0=1$  case (the elective eld is opposite to the external magnetic eld). The state 7=11 can either be seen as the  $_0=1$  state (with  $n_0=2$ ) or as the 4=11 state of holes conjugated to electrons. The partial llings of interest (as observed in the experiment) are  $_1=1$ =3, 2=3, and 1=5. Even-denominator states correspond to  $_1=1$ =2. In this paper we are also going to refer to Read-Rezayi states defined at lling fractions (in the fermion representation of fractional statistics particles):

(k = 2 for the P fa an, for k = 1 the Laughlin 1=3 state is found). All observed hierarchical states would correspond to even-k Read-Rezayi states, i. e.  $_1$  = 1=2 (the P fa an k = 2),  $_1$  = 2=3 (or by the particle-hole conjugation  $_1$  = 1=3) { k = 4,  $_1$  = 4=5 (by the particle-hole conjugation  $_1$  = 1=5) { k = 8 (which corresponds to the = 6=17 state). In the last case it seems that the Laughlin 1=5 state should rather be preferred over the Read-Rezayi clusters of 8 quasiparticles. Assuming the possibility of Read-Rezayi states the question arises why only these three values of k would be of interest. If one would have the k = 4 Read-Rezayi state, why a k = 3 state would not appear. Even worse, why the k = 8 state if there would be no k = 5;6;7 states. (The case of k = 6 would correspond to the  $_1$  = 1=4 P fa an state via particle-hole conjugation, if observed). The simple test for Read-Rezayi states would be for example the observation of the  $_1$  = 3=7 state of composite ferm ion excitations (it is the rest Jain state which can not be represented as a Read-Rezayi state). However, we should stress that the P fa an state of composite ferm ion excitations is seen as the best candidate for recently discovered even-denom inator hierarchical states 3=8 and 3=10.

It is worth to notice that the observed 3=8 state corresponds to the half-lling of Laughlin quasielectron shell (Laughlin quasielectrons of the 1=3 state). However, the 3=10 state corresponds to the 1=4 lling of the Laughlin quasihole shell. It is perhaps better to see the 3=10 state as the half-lled quasielectron shell, but seen within the opposite elective eld picture (or, equivalently, to the half-lled quasihole level of quasiholes of the 2=7 state). Within the composite fermion picture then, both states (3=8 and 3=10) correspond to a half-lling of the rest excited electrons in the rest excited and a state of electrons is proposed for the end are occupied by electrons of opposite spins). Also, the Read-Rezayi states are proposed for electrons in the rest excited (or higher) Landau level. Hence, it is interesting to consider also Read-Rezayi states of quasiparticles as natural candidates (competing with the picture of Laughlin or Jain states of quasiparticles). Maybe, except for the end of the state (the 1=5 state of quasielectrons, or the 4=5 state of conjugated)

holes { the Read-Rezayi state for k = 8 { 8 holes make a cluster { as discussed above}.

At present in the case of odd-denom inator states the rst guess aims at Laughlin or Jain states of quasiparticles [2,3]. One possible competing mechanism of incompressibility may be due to clustering of quasiparticles as discussed by Read and Rezayi (in the case of electrons) [5]. Laughlin (or Jain) states of Jain quasiparticles are not seen in numerical studies (e. g. in spherical systems [10]) but the studies are far from being conclusive (the number of quasiparticles is very low when exact diagonalization of electrons is considered, usually 3-4 quasiparticles [2,10]). The approximate numerical methods for higher numbers of quasiparticles are also proposed [2,11,12,9] but their accuracy seems to be discult to estimate.

There are examples in numerical studies (on a sphere) which support the P fa an states of composite ferm ion excitations (which should correspond to the 3=8 states), e. g. the states with the L = 0 ground state:  $N_e = 14 \ 2S = 33 \ (2S_{qe} = 9, N_{qe} = 6) \ [11], N_e = 12 \ 2S = 29 \ (2S_{qe} = 9, N_{qe} = 4) \ [2,12] \ (N_e electrons are in the angular momentum shell S, N_{qe} quasielectrons are in the ective shell <math>S_{qe}$ ). The former can be seen as the P fa an state of quasielectrons ( $2S_{qe} = 2N_{qe} = 3$ ) [13], the latter is related by the particle-hole conjugation (in the quasielectron shell). There are also approximate results for a higher number of quasiparticles pointing at a P fa an state (e.g. for  $N_{qe} = 10, 2S_{qe} = 17$  in [9]).

We are going to de neithe charge of quasiparticles in P fa an (and R ead-R ezayi) states of composite ferm ion excitations. Note that as Jain quasiparticles are anyons they can be seen in the ferm ion (or boson) representation (with the appropriate Chem-Sim onseeld included). We use the strong-pairing (strong-clustering) limit which is valid if charge of excitations is considered [13,5,8]. The (non-Abelian) statistics of quasiholes in P fa an states corresponds to the spinor representation of U (1) SO ( $2N_{\rm qh}$ ) ( $N_{\rm qh}$  { a number of quasiholes) of the dimension  $2^{N_{\rm qh}-1}$ . In the present case one can consider P fa an states of Jain quasiparticles in the boson representation. It means we rest consider the P fa an state of bosons, and next we introduce the Chem-Sim onseeld appropriate for the fractional statistics. Such operation a ects only the U (1) term of the representation (Fradkin et al. [14] discussed the similar

case where the P fa an ferm ion state is found within the boson representation of ferm ions). The P fa an state (in the plane,  $z_i = x_i + iy_i$ ) is de ned as:

a<sub>0</sub> is the magnetic length, m is odd for bosons, and is even for ferm ions (at the respective lling fraction 1=m). One can notice that m appears only in the Laughlin-like part of the wave function (3). For four quasiholes in the P fa an state the braiding matrix is [14]

(in the spinor representation). We note that the second term in the phase factor  $(\frac{1}{4m})$  can be found in the strong-pairing lim it [13,15,16]. Hence, the value of quasihole charge is  $\frac{1}{4m}Q_c$  where  $Q_c$  is the charge of pairs of particles, for  $Q_c = 2e$  one gets the charge  $\frac{e}{2m}$ . The P fa an state of anyons (Jain quasiparticles) corresponds to a nonintegerm [13] (which describes the statistics), and we de nem = 1+ where is the exclusion statistics parameter of anyons [17] (in the magnetic eld, at the elective lling 1=2, in the ferm ion representation,

We discuss below the strong-pairing (strong-clustering) lim it. Let us consider the lling fraction of the form

 $_1$  is the lling fraction of composite ferm ion excitations in the elective  $n_0 = 2$  shell. We assume Read-Rezayi states of quasielectrons (for the P fa an k = 2), hence [5]

The total ux entering the system is

One gets N  $_{\rm e}=\frac{1+}{1}$  N  $_{\rm qe}$ , Q  $_{\rm qe}=$  e=q $_{\rm p}$  (quasielectrons partially 11 the rst excited e ective shell), q $_{\rm p}$  is the denominator of the parent state [18]. Since k quasielectrons make a cluster one gets N  $_{\rm c}=\frac{N}{k}$  (the number of clusters), Q  $_{\rm c}=$  kQ  $_{\rm qe}$ , and

In the case of N  $_{\rm c}$  anyons in the Laughlin state [17] (of charge Q  $_{\rm c}$  and the statistics = = (  $_{\rm str}^{\rm qh}$ )  $^{\rm 1}$  (m od 2))

with quasihole excitations of the exclusion statistics  $^{qh}_{str}$ , and the quasihole charge Q =  $^{qh}_{str}Q_c$ . We assume that k-clusters condense at a Laughlin state, then the excitations charge Q is (if absolute values of charges are considered)

For k even the lling fraction can be  $\sin pli$  ed (the numerator and the denominator in  $_{e}$  may be divided by two). Hence, the charge of excitations equals = q for k odd and = (2q) for k even. The same conclusion can be reached at the lling fraction of the form:

where holes conjugated to quasielectrons are considered (Jain quasiholes of the state  $_{\rm e}^{\ 1}$  =  $2p_0+\frac{_0}{^2}$ ). In that case

The charge of quasiparticles in fractional quantum Hall systems can be detected, e.g. in "shot-noise" experiments [19{22].

The statistics of excitations in the strong-pairing  $\lim$  it can also be determined. Let us consider the P fa an, i. e. k=2, then

gh str is the exclusion statistics parameter of quasiholes in the strong-pairing lim it. Let us assume that  $_{qe} = m$  1, then  $m = _{qe} + 1 = \frac{2(_0 + 3p_0)}{_0 + 2p_0}$  [17]. Then

$$_{\text{str}}^{\text{qh}} = \frac{1}{4m} : \tag{20}$$

The same relation can be found for Jain quasiholes in (14). The result (20) is the one which appears in the expression for the statistics of excitations in the P fa an state (4). The state 3=8 corresponds to the P fa an state of  $_{qe}=5=3$  quasielectrons [17]. Then the phase factor in (4) is

$$\frac{1}{8} + \frac{3}{32}$$

When one considers the P fa an state of the conjugated quasiholes (of the 2=5 state,  $_{\rm qh}$  = 3=5) one gets  $_{8}$  +  $_{5}$  . Note, however, that both cases correspond to opposite change in the external magnetic eld (e.g. quasihole-like, quasielectron-like excitations). At = 3=10 we have  $_{\rm qe}$  = 7=3 [17], so that the phase factor is =8 + (3=40) (or if one starts from = 2=7,  $_{\rm qh}$  = 3=7, then one gets the phase =8 + (7=40)).

In conclusion we found the charge of quasiparticles in condensed states of composite ferm ion excitations seen as the P fa an and R ead-R ezayi states. In the standard hierarchy (e.g. the Haldane hierarchy [18] or the hierarchy of composite ferm ion excitations [2]) the charge is always eq where q is the denominator of the lling fraction ( = p=q; p, q are coprime). However, for P fa an or Read-Rezayi states (where k particles make a cluster, k = 2 for the P fa an) one gets e=q for k odd and e=(2q) for k even (e. g. for the P fa an state). Then, the charge of excitations in the proposed P fa an states 3=8 and 3=10 should be e=16 and e=20, respectively. This provides also the possible identication of Read-Rezayi states of Jain quasiparticles (for even k) in charge-detecting experiments (e. g. in "shot-noise" experiments). For example the charge of excitations at  $_{\rm e} = 5 = 13$  (and = 4=11) should be =26 ( =22 for  $_{\rm e}$  = 4=11) if one deals with Read-Rezayi states of quasiparticles. Hence, for all observed states it should be possible to identify P fa an and k-even Read-Rezayi states by future charge-detecting experiments. The Pfa an state can be further tested by detecting (if possible) the non-abelian statistics of excitations. The non-A belian statistics of quasiholes in P fa an states of Jain quasiparticles is given as the spinor representation of U (1) SO (2N ah) (the continuous extension of the braid group) with U (1) given by  $e^{i(\frac{\pi}{8} + \frac{\pi}{4m})}$  where  $m = 1 + \frac{\pi}{4m}$ , { the exclusion statistics of Jain quasiparticles (at the e ective lling fraction 1=2 in the ferm ion representation). Let us note that also excitations in Read-Rezayi states of Jain quasiparticles (if observed) would obey non-abelian statistics.
