The phase diagram of the simplest approximation to Double-Exchange systems, the bosonic Double-Exchange model with antiferrom agnetic super-exchange coupling, is fully worked out by means of M onte C arlo simulations, large-N expansions and Variational M ean-Field calculations. We nd a rich phase diagram, with no rst-order phase transitions. The most surprising nding is the existence of a segment like ordered phase at low temperature for intermediate AFM coupling which cannot be detected in neutron-scattering experiments. This is signaled by a maximum (a cusp) in the speci c heat. Below the phase-transition, only short-range ordering would be found in neutron-scattering. R esearchers looking for a Q uantum C ritical Point in manganites should be wary of this possibility. Finite-Size Scaling estimates of critical exponents are presented, although large scaling corrections are present in the reachable lattice sizes.

I. IN TRODUCTION

There are at least two motivations for studying the spin-only version of the Double-Exchange (DE) models. On the one hand one, has its relationship with the Colossal M agnetorresistance e ect (CMR).^{1,2,3} On the other hand, in this problem some puzzles arise⁴ with the Universality H ypothesis,⁵ that deserve a detailed study. Let us start addressing the rst aspect.

CMR has renewed the interest in Double-Exchange (DE) systems.⁶ The typical CMR manganites are $La_{1 x} A E_{x} M n_{1 y} O_{3}$; where A E = Ca, Sr in the range 0.2 < x < 0.5. It is believed that the relevant degrees of freedom¹ are the localized $S = 3=2 M n^{3+}$ core spins, and the e_{α} holes. The M n³⁺ ions form a single cubic lattice and, besides the DE mechanism, interact through an antiferrom agnetic (AFM) superexchange coupling. The relatively high spin of the M n³⁺ core suggests to treat them as classical spins, ~i. Although phonons are believed to be crucial for the CMR e ect_{r}^{7} m anganites display a very rich magnetic phase diagram which can be addressed neglecting lattice e ects.⁸ In spite of these simplications, and of the introduction of powerful new tools,^{9,10,11} the num erical study of the DE m odel in large lattices beyond M ean Field Approxim ation is out of reach for present day computers. Yet, nite-size e ects in these system s are unusually large.⁸ T he need to obtain reliable predictions has m ade people to further simplify m odels, replacing e_a holes by an e ective interaction among the localized S = $3=2 \text{ M n}^{3+}$ core spins. Indeed, a simple calculation⁶ shows that the kinetic energy of the electrons depends on the relative orientation of neighboring

q_ $M n^{3+}$ core spins as $1 + \tilde{i}$. This substitution of a simpler spin-only problem in place of the very dicult electronic problem lies at the heart of several theoreticalanalyses (see e.g. de Gennes in Ref. 6) and num erical simulations.¹² In spite of this, up to our know ledge there is only one detailed previous study¹³ of the phasediagram of the bosonic DE model. That study predicted the existence of a disordered (PM) phase at very low tem peratures for interm ediate super-exchange coupling. This is very remindful of the presence of a Quantum -Critical Point¹⁴ which is believed to be of importance for the CMR phenom enon,¹⁵ and has been predicted to occur in m anganites by som e m odel calculations.¹⁶ The experim ental characterization of this Quantum Critical Point is a wedge of param agnetic (PM) phase, maybe $glassy_1^{17}$ that at zero tem perature becom es a single point separating two ordered phases.¹⁵ The glassy wedge would be created by disorder, 15 and would be separated from the Param agnetic state at high-tem perature scale T . M aybe the most surprising result of the here presented analysis is that this glassy wedge could not be PM or glassy at all, but ordered in a segment-like way 18,19,20 (as in liquid crystals). This ordering will be referred to in the following as RP^2 (real projective space). As we shall show, the RP² phase cannot be detected in neutronscattering experiments (although a short-range ordering will be present). Nevertheless, the phase-transition can be studied experimentally using the speci-cheat, that should present a maximum (furtherm ore, a cusp) at the critical tem perature. Indeed, the therm al critical exponent is predicted⁴ to be = 0.78(2) which implies = 0:34, and hence the cusp behavior follows. An-

= 0:34, and hence the cusp behavior ionows. Another bonus of our simpli ed model is that it allows us to study qualitatively (see subsection IV C) the funny interplay between ferrom agnetism, antiferrom agnetism, temperature and applied magnetic eld in low-doped La_{1 x} Sr_xM nO $_3$.^{21,22,23,24}

Let us now address Universality. A common wisdom is that the critical properties of a system are given by its dimensionality and the local properties (i.e. near the identity element) of the coset space G=H, where G is the sym m etry group of the H am iltonian (the sym m etry of the high tem perature phase) and H is the rem aining symmetry group of the broken phase (low temperature). So, system swith locally isom orphic G=H belong to the same Universality Class. This seems to be true in perturbation theory, where the observables are computed by doing series expansions around the identity element of G=H . In this picture, a phase transition of a vector model, with 0 (3) global symmetry and with an 0 (2) low temperature phase symmetry, in three dimensions must belong to the O (3)/O(2) scheme of symmetry breaking (classicalH eisenberg m odel). In addition, if H = 0 (1) = Z_2 is the remaining symmetry, the corresponding scheme should $be^{25} O(4)/O(3)$ which is locally isomorphic to O(3)/O(1).

Hence, it is interesting to check if the global properties of the coset space G=H are relevant or not to the phase transition. The common wisdom has been challenged in the past by the so-called chiral models.²⁶ However, the situation is still hotly debated: som e authors believe that the chiral transitions are weakly rst-order,²⁷ while others claim²⁸ that the Chiral Universality Class exists, im plying the relevance of the global properties of G=H . O n the other hand, we do not have any doubt about the second order nature of the PM $-\!\!R\,P^2$ transition. A detailed study of the critical exponents was recently published⁴ in Letter form . In the present work, we perform a detailed Monte Carlo, Mean Field and large-N study of the phase diagram . A thorough study is perform ed of the RP^2 phase. We shall con m that the pattern of symmetry breaking is 0(3)/0(2), implying a violation of Universality for which we do not have any plausible explanation.

The layout of the rest of this paper is as follow s. In section II we de ne the model, study the phase diagram at zero tem perature, and de ne the order param eters and observables measured in the Monte Carlo simulations. The Mean-Field calculation is explained in section III, where we also report the results of the Large-N analysis. In section IV we present our M onte Carlo results. W e start determining the global phase diagram in subsection IV A. The RP^2 phase is investigated in more detail in subsection IV B, while the e ects of a magnetic eld on conductivity close to a ferrom agnetic-antiferrom agnetic transition is considered in subsection IV C. We present our conclusions in section V.W e complement the paper with two appendices. Appendix A contains the details about the large-N calculation. In Appendix B the reader will nd the Mean-Field phase diagram as obtained from the fourth-order expansion of the Free-Energy.

II. THE MODEL

A. The Ham iltonian

We de ne a system of spins $f_i^{-}g$ living in a three dimensional cubic lattice of size L (and volum e V = L³) with periodic boundary conditions. The spins are three-component real unit vectors. We consider the Ham iltonian

where the sum is extended to all pairs of nearest neighbors and we consider only J < 0. Notice that we will measure temperature in units of the double exchange constant. The cubic lattice is bipartite, therefore we shall call the lattice site i even or odd according to the parity of the sum of its coordinates, $x_i + y_i + z_i$.

 ${\tt W}$ e will consider the system at a tem perature ${\tt T}$, the partition function being

where the integration measure is the standard measure on the unit sphere.

B. Phase diagram at zero tem perature

As usual, the study of the phase diagram begins with an understanding of the ordered phases at zero tem perature. We can write in a compact way our original Ham iltonian:

and clearly y 2 [1;1]. In the lim it of zero tem perature, the only con gurations which contribute to the partition function are those which provide a maximum of V (y). If, as con med by the M onte C arb simulations, the spin texture itself is bipartite, the value of y will be uniform through the lattice. Thus, a simple computation yields that the maxim a of V (y) are at the following values of y (denoted by y_{max})

It is clear that $y_{m ax} = 1$ corresponds to a ferrom agnetic state and that in the J ! 1 lim it we reach an antiferrom agnetic one ($y_{m ax} = 1$). The interm ediate values of y_{max} correspond to a ferrim agnet if $0 < y_{max} < 1$ and to an anti-ferrim agnet when $1 < y_{max} < 0$. The physical picture is as follows: the spins in the, say, even sublattice are all parallel along (for instance) the Z-axis. On the other hand the odd spins lie on a cone form ing an angle (cos = y_{max}) with the Z-axis.

The corresponding free energy is just

Hence we have the following phase transitions:

- 1. Ferrom agnetic-ferrim agnetic at $J = 1 = \frac{p}{8}$. It is easy to check that df=dJ is continuous at $J = 1 = \frac{p}{8}$ but $d^2 f = dJ^2$ is discontinuous. Hence, according to the standard E then fest classic cation, we have a second order phase transition.
- 2. Ferrin agnetic antiferrin agnetic at J = 1=2, where the free-energy is C^1 . At this special point $y_{m ax}$ changes from positive to negative. The fact that $y_{m ax} = 0$ in plies that one can reverse every single spin independently of the others w ithout changing the energy (m ore pedantically, one nds a dynam ically generated Z_2 gauge symmetry⁴).
- 3. The limiting value $y_{m ax} = 1$ that corresponds to an antiferrom agnet rather than an antiferrim agnet is reached only at J = 1.

The transition 2 (Ferrim agnet-antiferrim agnet) needs further discussion. We can expand the Ham iltonian around the minimum y = 0, and we obtain

Thus, close to J = 0.5 and T = 0 one has, neglecting constant term s,

which corresponds to an anti-ferrom agnetic RP^2 -theory. The minimum energy con guration satis es y = 0. Hence, we obtain that the ferrim agnet-antiferrim agnet transition occurs at zero tem perature via a RP^2 state at a single point. We shall see that at nite tem perature the RP^2 phase occupies a region (rather than a single point) of the phase diagram.

From the previous analysis at zero tem perature, one expects to nd the following phases at nite tem perature:

PM : the usual disordered state, where all the sym - m etries of the m odel are preserved.

FM : a standard ferrom agnetic ordering, i.e., the spin uctuates around (0;0;1).

AFM: a standard anti-ferrom agnetic ordering. Even (odd) spins uctuate around $\sim^{e} = (0;0;1)$ ($\sim^{\circ} = (0;0;1)$).

FI: The ordering consists on even spins uctuating around the Z axis and odd spins uctuating around the cone of angle < =2 with axis Z.

AFI: This ordering is similar to the previous one, with > =2.

 RP^2 : Here the ordering is the nite T version of the one found analytically in J = 0.5; T = 0, i.e., even spins uctuating around the Z axis, with random sense, and odd spins uctuating around the cone with random sense.

C. Order Param eters

In m odels with antiferrom agnetic couplings, one m ight expect an even-odd structure of the ordered phases. Therefore, from the local eld f_i^g , we de ne the standard m agnetization as the Fourier transform at m om entum 0, and the staggered m agnetization as the Fourier transform at m om entum (;;):

D. Correlation Length

For an antiferrom agneticm odel, not only the usual susceptibility, also the staggered susceptibility can diverge. Thus, in the Brillouin zone, one needs to monitor the behavior of the G reen functions close to the origin as well as close to (;;). Since in critical-phenom ena studies one usually considers only the behavior around zero momentum, we have found it convenient to de ne four G reen functions in terms of four elds in momentum space

Here diverges as $\pm j$, t being the reduced tem perature. The anom abus dimension, , will depend on the considered eld.

In a nite lattice, to estimate the correlation length one uses the propagator at zero momentum and at the minimum non-zero momentum compatible with boundary conditions. Dening $F = \hat{G} (2 = L;0;0)$ and noting that $= \hat{G} (0)$, one has²⁹

III. MEAN FIELD CALCULATION

W hen several phases compete, it is quite tricky to calculate the phase diagram in M ean-Field approximation (the T = 0 calculation has shown that we should face this problem !). Since one can nd di erent ordered phases at low temperatures within di erent M ean-Field schemes, it is necessary to decide which phase shall be the most stable one. We consider that the cleanest way of performing such a calculation is to use the variational form ulation of the M ean-Field approximation (see for example R ef. 30), with a variational family large enough to take into account all the phases found in the phase diagram. In this way, all the phases compete on the same e grounds and one has an objective criterion to decide which phase is to be found in a given region of the phase-diagram.

O ne needs to compare the actual system with a sim – pli ed model where all degrees of freedom are statistically independent. The method is derived from the inequality 30

Here, H₀ is a trial H am iltonian depending on some param eters (the mean ekbs) and the average h:::i₀ means average with the Boltzmann weight corresponding to H₀. The right-hand side of the inequality (33) is minimized with respect to the free parameters in H₀, then used as our best estimate of the Free-energy. Thus the task is to generalize the standard Curie-W eiss ansatz, H₀ = h $_{i}$ $_{i}^{z}$, ($_{i}^{z}$ is the component of the local spin $_{i}^{r}$ along the Z-axis), to cover all the expected orderings.

In our case, we must use the simplest possible variational fam ily that perm its to have di erent orderings in the even and odd sublattices:

We now need to parametrize the local potentials with the help of the mean elds, that will be our minimizing parameters. One easily sees that keeping only the linear term ($V_{e;o}$ (z) = $h_{e;o}$ ²) will not reproduce the ferrim agnetic or antiferrim agnetic phases, since at very low temperatures and non vanishing mean-elds, $h_{e;o}$, the spins would always be (anti)aligned with the Z axis. If one keeps also the quadratic term, $V_{e;o}$ (z) = $h_{e;o}$ ² + $_{e;o}$ (z)², the situation improves significantly. The minimum of $V_{e;o}$ can now be 1 $_{min}^{z}$ 1 which implies that at low temperature spins would lie on the cone of angle , $\cos = _{min}^{z}$. Therefore, we will choose as our variational family

In the above expression, $\sim_{e;o}$ is a generic spin belonging to the even (odd) sublattice. The problem is that, even if

 $\sim_{\rm e}$ and $\sim_{\rm o}$ are statistically independent, the calculation of the mean-value of the square root in Eq. (50) cannot be straightforwardly factorized in an even and an odd contribution. In order to achieve this factorization, we shall use the series expansions introduced by de G ennes.³¹ O ne rst use an expansion in Legendre P olynom ials:

Thus, the mean-values are factorized into even and odd contributions. Due to the rotational sym metry along the Z axis, only the m = 0 term s in Eq. (52) are non vanishing. Thus we obtain,

Fortunately, if one wants to calculate the free-energy as a series expansion in the Mean-Fields, h, h_s , and s, at a given order only a nite number of terms in Eq. (50) contribute, due to the orthogonality properties of the Legendre Polynom ials. This expansion allows to discuss the continuous phase transitions from the PM phase (where $h = h_s = s = 0$ is the absolute minimum of the free-energy), to ordered phases. Indeed, calculating (per unit volum e) to second order one gets:

This is a quadratic form in h, h_s, and _s. If the above quadratic form is positive de nite, the PM phase is a (bcal) m inim um of the free energy. The other way around, when one of the eigenvalues of the quadratic form is negative, the PM phase is unstable with respect to some ordered phase, depending on the M ean-Field that should grow in order to m inim ize the free-energy. Notice also that the eigenvalue corresponding to ² is always positive. Thus, even if there are four eigenvalues, we obtain three lines of continuous phase transitions, where




FIG.1: Phase diagram as obtained from the second order series expansion of the free-energy (55). The param agnetic phase is unstable for temperatures below the full-lines (the instability being toward the FM, AFM or RP^2 phases, as indicated in the plot). The dashed lines indicate the places where some of the eigenvalues of the quadratic form in (55) vanish, but they do not correspond to phase transitions.

Therefore the PM phase, stable at high-tem perature, meets two transition lines of opposite slope, and an horizontal line that separates it from the RP2 phase (see Fig.1).




FIG.2: Phase diagram of the model. Circles correspond to M onte Carlo estimates. Full lines correspond to the M ean-Field transition temperatures divided by 2.3. The dashed vertical and horizontal lines show the direction of the Ferrenberg-Swendsen extrapolation in the points which are the subject of detailed study reported. We label $t_0:::t_5$ each one of the m ore carefully studied transitions.

For tem peratures below the full lines in Fig. 1, one needs to discuss the stability of a minimum of the freeenergy dierent from $h = h_s = s = 0$. To locate that m inim um , and to discuss its stability, one needs to extend the series expansion in (55) at least to fourthorder in h, h_s, and s. This can be done (see Appendix B), but it is not particularly illum inating since the series expansion for is not fastly convergent. We have rather turned to a num ericalm ethod. G iven a particular value of the Mean-Fields, h, h_s, , s, we have calculated by means of a Gauss-Legendre integration of all the term s in Eq. (44). To do this, we have divided the interval [1;1] in twelve subintervals and we have done a twelfth order G auss-Legendre integration in each of them . The series of Eq. (50) has been evaluated to order 50. Being able to calculate , the m in im ization has been done using a conjugate gradient method. The resulting phase diagram is shown together with the results of the M onte C arlo calculation in Fig. 2. Notice that, as usual, the M ean-F ield calculation overestim ates the criticaltem peratures by a large factor (about 2.3 in this case). However, considering this rescaling of the tem peratures, the obtained phase-diagram is in remarkable agreem ent with the num erical one. We have con med that all the

transitions are second order except the ferrom agnetic-RP2 which is rst order (nevertheless, this transition line is an artifact of the M ean-Field solution: in the M onte C arb phase-diagram it seems to collapse to a tetracritical point). The second order nature of the transitions can be checked by computing the appropriate order param eter at a given value of T and J, then noticing that it vanishes at the transition line with M ean-Field exponents $M / JT T_c J^{=2}$ or $/ JJ J_c J^{=2}$).

Since M ean-Field overestim ates critical tem peratures, it is interesting to compare the previous results with the ones of another approximation (large N) that usually underestimates them . We have calculated the position of the PM-FM and PM-AFM phase-transition in the large N approximations (see Appendix A):

The critical temperature is underestim ated by roughly the same factor that the M ean Field approxim ation overestim ates it (see below). To extend further this calculations would require to study non translationally invariant saddle-points, which is rather complex.

IV. MONTE CARLO SIMULATION

The model (1) can be investigated using a standard M onte C arlo m ethod. W e shall here describe som e technical points, the results being discussed in the following subsections.

The single M onte Carlo (M C) step consists of a fulllattice M etropolis lattice sweep. Som e of the simulations have been done at extremely low temperatures, thus the m ethod of choice would have been a heat-bath algorithm, but its implementation in this model is rather complex. Fortunately, one can e ectively falsify a heat-bath algorithm by means of a multi-hit M etropolis method, proposing per each hit as spin update a random spin on the unit sphere. Luckily enough, to achieve a 50% acceptance the number of needed hits is quite modest except for the lowest temperatures that represent a negligible fraction of the total CPU time devoted to the problem. The pseudo-random number generator was the Congruential+ Parisi-Rapuano (see e.g. Ref. 32).

To extract critical exponents and critical tem peratures, we have used the quotient m ethods: 18,33 for a pair of lattices of sizes L and 2L we choose the tem perature where the correlation-lengths in units of the lattice-size coincide (2 $_{\rm L}$ = $_{\rm 2L}$). Up to scaling corrections, the m atching tem perature is the critical point. Let now 0 be a generic observable diverging at the critical point like $\pm j^{\times \circ}$. Then, one has (up to scaling corrections):

where is the critical exponent for the correlation length itself. For extracting we have used the temperature derivative of the correlation-length, $x_{\theta_T} = 1 + ...$ To full the m atching condition 2 $_L = _{2L}$ one often needs to extrapolate from the simulation temperature to a nearby one. This has been done using a rew eighting m ethod (see e.g. R ef. 34).

A. Phase Diagram

Ata rst stage, the phase diagram (see Fig. 2) has been explored by performing hysteresis cycles with L from 6 to 24. The energy and relevant order parameters have been used to locate phase transitions. Once a rough diagram has been established, we have simulated in lattices L = 6;12, and have re ned the transition point calculating the correlation lengths associated to the relevant order parameter and computing the point where =L is L independent. The phase diagram obtained can be seen in Fig. 2. We have studied in greater detail the phase transitions at the points t_0 , \ldots , t_5 , depicted in Fig. 2. W e have simulated lattices L = 6;8;12;16;24;32;48 and 64, producing 20 m illion of MC full-lattice sweeps for the largest lattices in each transition. W e have discarded 5 10^5 M C steps for therm alization. In all cases this has been checked to be much larger that the integrated autocorrelation time. In addition, at the lowest tem peratures, we have compared di erent starting con gurations (random, FM, etc.), concluding that the results are startindependent.

Before discussing the results let us brie y comment what can one expect on universality grounds. Transi-

tion t_0 connects the param agnetic phase, where the full O (3) sym m etry-group is preserved, to a FM phase where the symmetry group is just the O (2) group corresponding to the global rotations around the global magnetization. Thus it is expected (and con med) to be in the Universality class of the O (3) Non Linear model (see table III). For all the other transitions the scheme of symmetry breaking is not so clear. The only obvious symmetry-breaking (for transitions t_2 and t_3) is the symmetry between the even and odd sublattice. This is a Z_2 sym m etry, thus one m ight expect the transition to be in the Ising Universality class. The symmetries of the RP^2 phase are intriguing and will be investigated in the following subsection. Let us only recall that the transition t_5 has been recently studied in great detail in R ef. 4, where it was found that

Perhaps not unexpectedly, the critical exponents were found to be compatible within errors with the one of the antiferrom agnetic RP^2 m odel.¹⁸




FIG.3: H istogram for $E_v=h^{\sim}{}_i~~_ji$ (for nearest neighbors i and j), in transition t_3 .

As for transitions t_0 , :::, t_4 , we have located quite accurately the critical parameters (see table I). We have focused in each case in the largest order parameter (see Eq. (22)). The PM-AFM transition should have the same critical behavior and we have not invested time in this study. We are reasonably condent in the continuous nature of all ve transitions. This stems from two facts. First, the energy histograms are not doublepeaked (see an example in Fig. 3). Yet, a much more re ned test comes from the (L-dependent) value of the

e ective exponents shown in table II. W ith the exception of transition t_0 , which as expected belongs to the U niversality C lass of the H eisenberg m odel in three dimensions, scaling-corrections are not even m onotonous in their evolution with the lattice size. A lthough an asymptotic value can not be guessed with reachable lattice sizes, at least one sees that, for the largest lattices, the exponent is reasonably far from the value 1=2 to be expected in weak rst order transitions.

B. Detailed study of the RP² phase

The RP² phase poses many questions, the rst one possibly being: is it truly a RP² phase? In other words, (as far as long-distance correlations are concerned) do the spins behave like segments rather than arrows? As we

will see below, the answer is positive: the spin ordering is truly invariant under spin reversal. Once this is established, one may worry about continuous symmetries. At the special point T = 0, J = 0.5, the spins in the (say) even sublattice are random ly aligned or anti-aligned with the (say) Z-axis. The spins in the odd sublattice are random ly placed on the XY-plane. This state has a remaining 0 (2) symmetry, corresponding to rotations around the Z-axis. The Z₂ symmetry corresponding to exchanging the roles of the even and odd sublattices is obviously broken. Hence one may wonder if, up to the critical tem perature which separates it from the param agnetic state, the RP^2 phase can be characterized as an O (2)-sym m etric phase with broken even-odd sym m etry. D oubts arise from the order-from -disorder interaction that favors the alignm ent^{18} (in the segment sense) of all the spins in the planar sublattice (the odd sublattice in the above discussion). This global alignment would imply a second phase transition separating the low tem perature 0 (2)-symmetric phase from a phase without any remaining rotational symmetry at higher tem perature. This second RP² phase would be separated from the param agnetic state where the full rotational symmetry, O(3), is maintained. This complex scenario would explain the exotic values of the critical exponents corresponding to the RP²-PM transitions. Universality argum ents²⁵ would then predict that the critical exponents would be the ones of the O (4) classical Non-Linear model, which are not very far from the ones actually

found⁴. On the other hand, in the simple scenario of a single O (2) symmetric \mathbb{RP}^2 phase, the expected critical exponents would be those of the classical H eisenberg model, in plain contradiction with our numerical results. Since the simple scenario seem s to be the realone, we are facing a failure of the Universality H ypothesis for which we do not have any plausible explanation.

To sum m arize, in the follow ing we shall address, in this

order, the three following questions:

- 1. Is the R P 2 phase truly segment-like?
- 2. Is the even-odd symmetry broken up to the tem perature separating the RP² phase from the Param agnetic state?
- 3. Is the low tem perature O (2) sym m etric RP² phase preserved up to the tem perature separating the RP² phase from the Param agnetic state?

1. Tensor versus vector ordering




FIG.4:Lattice size dependence of ${}_{s}^{T}$, T and ${}_{s}^{V}$ at di erent tem peratures, for J = 0.5.

W e have called R P² the phase in which the vectorm agnetization vanishes (for any momentum in the Brillouin zone), and the tensor magnetization is non-vanishing, both at momentum (0;0;0) (^T) and at momentum (;;)) ($_{s}^{T}$). In Fig. 4 (upper and middle part) we show, xing J = 0:5, that, for temperatures ranging from 0.001 to 0.05, there is a non vanishing therm odynamic limit for both quantities. For comparison, we show in the low erpart the vectorm agnetization at momentum (;;)) ($_{s}^{V}$), which goes to zero as $1 = L^{3}$. We have also measured the correlation-length in the vector channel. A lthough some short-range ordering is present, the correlation-length is not larger than 0:3 lattice spacing.




FIG. 5: Scatter-plot for 90 statistically independent con gurations for each lattice size (L = 6;8;12;30;60) at J = 0.55, T = 0.5. In the horizontal axis we plot the maximum over the Brillouin zone of the squared Fourier transform of the spin eld, and in the vertical axis the corresponding associated m omentum p = kpk. The horizontal position of legends scales as L ³ log L in agreement with the absence-of-order prediction.

To con m the absence of any other vectorial magnetization we have measured at J = 0.55; T = 0.5 (just in the middle of the RP² phase) all Fourier components of the vector eld \sim_i for 90 statistically independent congurations for each lattice size, and plotted in Fig. 5 the

corresponding m om entum versus the m axim um value of the Fourier component squared. In other words, we are searching for the m axim um (over the B rillouin zone) of the static structure factor (divided by L^3). We have chosen as lattice sizes L = 6;8;12;30;60 to allow for dierent periodicities of the would-be vector-ordered states. If no vectorial ordering is present, the last quantity should go to zero as $1=L^3$, up to logarithm ic corrections that arise from the fact that we are computing the m axim um of a set of 0 (L^3) elements. The absence of ordering is clear from Fig. 5.

2. Even-Odd sym metry

To analyze the even-odd symmetry, we measure the tensor correlation di erence at second neighbors between even and odd lattices. The norm alized total di erence for a given con guration can be written as

where the sum s extend over even (odd) second neighbor pairs. The non-vanishing of the di erence in the therm odynam ic lim it signals even-odd sym m etry breaking. N otice that the sublattice energy di erence can be dened locally, and it plays the role of a local eld. Another interesting observable is the dim ensionless quantity associated to the energy di erence




FIG. 6: Dierence of the tensor second neighbors energies between sublattices, for T = 0.05.




FIG.7: Histogram of $_{\rm E}$ for J = 0:5, T = 0:05.

Fig. 6 shows the tensor energy di erence as a function of tem perature for several lattice sizes. A clear therm odynam ic lim it can be observed for T < 0.05. At T = 0.05 the asym ptotic behavior can be elucidated by a direct study of the tensor energy di erence histogram s. A L = 96 lattice is necessary to clearly resolve the two peak structure of the histogram (see Fig. 7), corresponding to an even-odd symmetry breaking. Notice that L = 96 is the largest lattice used, which makes it in possible to study the therm odynam ic lim it of that quantity for T larger than 0.05 and less than $T_c = 0.0559$. We can conclude that, within the computational resources employed, no evidence exists for a therm odynam ic lim it with unbroken even-odd symmetry.

Although no thermodynamic limit can be reached beyond T = 0.05, more information can be obtained through a nite size analysis. The closer we get to T = 0.05, the harder it becomes to nd a two peak




FIG.8: D isplacement of the critical temperature, de ned as the point where $_{\rm E}$ takes a xed value, as a function of size. Fits suggest that there is no even-odd symmetry restoration at a temperature less than the RP²-PM one.

structure in the histogram . A correlation length could be de ned in the even-odd symmetry breaking channel which grows as the possible critical point between the RP^2 phase with broken even-odd symmetry and a hypothetical RP^2 phase with restored even-odd symmetry is approached. The functional form of the growth of the correlation length m ight give indication of the existence of such phase transition. A direct way to carry out that study is to de ne the correlation length as the lattice-size itself, when the histogram has a central valley at half the peak hight. The result shows a grow th of the correlation length as T increases compatible with a divergence just at T_c, though with rather peculiar exponents. But the m easurem ent of that correlation length is very noisy. A much more precise way to study the possible presence of a transition previous to T_c is to de ne as apparent critical point the T value at which $_{\rm E}$ takes a xed value. Fig. 8 shows the results. A though the possibility of an evenodd sym m etry recovery transition previous to T_{c} cannot be discarded, results are compatible with a divergence just at T_c. The gures show a t to a power law (xing the critical point to the value given in Eq. (58)). It is worth remarking that the exponent obtained is very large (2 or larger), which m ight point to a logarithm ic divergence. Thus, all our results point to a single RP^2 phase with broken even-odd sym metries at all tem peratures.

3. 0 (2) Sym m etry

The chosen tool to study whether the O (2) symmetry of the T = 0 state is preserved at higher temperatures, has been the eigenvalue structure of the tensor M_s . The latter being traceless in plies that the vector

= ($_1$; $_2$; $_3$) must lie on the x + y + z = 0 plane. The whole information reduces, then, to a modulus (which is nothing but the observable $_s$), and an angle, which contains all the information of the eigenvalues on the sym – metry 0 (2). As any result must be symmetric under eigenvalue permutations and global inversion, we can restrict the angle to the interval between 0 and =6. More precisely, we consider the orthonorm albasis fu_x; u_yg for the plane given by




FIG. 9: H istogram s of the angle of the eigenvalue vector on the (1,1,1) plane for two tem peratures at J = 0.5. The dots correspond to param agnetic con gurations.

Fig. 9 shows histogram s of angles at several tem peratures and lattice sizes. Dotted lines correspond to com – pletely disordered con gurations. In case of the system being O (2)-symmetric (one large eigenvalue and two identical small eigenvalues), the distribution should be a delta at angle =6. For a system with broken O (2)symmetry but unbroken even-odd-symmetry, the eigenvalues are (a;0; a)-like, which would correspond to a D irac delta at angle 0. We notice that, for small lattices, the distribution points to complete disorder, but as the size grows an in ection point turns up at T = 0.04;0.045for L = 24;48 respectively, and as L goes on growing a peak arises at angles ever closer to the maximum. It might be said, that the behavior in L is always the same, except for a scale change.




FIG .10: M odulus of the di erence between the two sm aller eigenvalues of M $_{\rm s}$ as a function of T .

A nother interesting quantity is the di erence between the two small eigenvalues (), which should vanish in the presence of O (2) symmetry, so turning out to be an order parameter. Fig. 10 shows that quantity for several values of the temperature and lattice size. If we look at an intermediate size (L = 24 for instance) the appearance is that of a transition at T = 0.03 to a phase with broken O (2) symmetry. Yet, as L increases, the apparent transition m oves back approaching T_c evermore.




FIG.11: Scaling of for the analysis of a possible O (2) restoring transition. Data is fairly well tted assuming the transition occurs at T_c (Points next to T_c are not well tted because there the largest eigenvalue becomes zero and ceases to make sense). The tted values are = 0.5, = 1.8, $T_c = 0.0559$.

To check the consistency of the results with respect to the existence of a transition within the RP² phase we can perform a Finite Size Scaling study thing $L = as a function of (T T_0)L^{1=}$. Only $T_0 = T_c$ yields a reasonable t (see Fig.11). Notice that for T close to T_c the de nition of ceases to be meaningful, as a large eigenvalue exists no more since the RP² magnetization fades away, and no good t can be expected. However, for most T values (more precisely, for T < 0.05) the t is excellent, though the and values are admittedly




FIG.12: D isplacement of the critical tem perature, de ned as the point where takes a xed value, as a function of size. Fits suggest that there is no 0 (2) breaking transition, at a tem perature less than the RP^2 -PM transition tem perature.

rather unusual (= 0.5, = 1.8). The conclusion should be that there is no evidence for an O (2) breaking transition at any nite distance from T_c . A collapse of that transition over the RP²-PM transition m ight occur.

A more quantitative analysis can be made studying the displacement of the temperature at a xed value of . In Fig. 12 we plot the obtained measures together with ts to several functional forms: a power law with Tc xed to the value of Eq. (58), a three parameter power law, and a K osterlitz-Thouless-like divergence. The results point again to no breaking of the O (2) symmetry inside the RP^2 phase.




FIG.13: Hysteresis along t_2 . The transition occurs in the region where $\frac{V}{s}$ changes suddenly, and the gure shows a movement of T_c to higher values when h = 0.01 is switched on $(T_c (h = 0) = 0.0171)$.

C. Interplay between Ferrom agnetism, Antiferrom agnetism, Tem perature and an applied M agnetic Field in the low-doped $La_1 \ _x Sr_x M$ nO₃.

In a series of papers^{21,22,23,24} the interplay between FM, AFM, temperature and an applied magnetic eld in the low-doped $La_1 \times Sr_x M$ nO₃, mainly at x close to 1/8, has been studied. We would like to point out some properties of our FM -FI phase transition (point t_2 in this paper) which m ight help to understand phenom ena which, in those references, are related to the FM -CO (Charge O rdered) phase transition, not fully understood so far.

Roughly speaking, som e of the mentioned phenomena are:

- 1. Resistance increases as T decreases below T_{CO} (t₂ in our model). In our simplified model, this corresponds to the fact that, when crossing the FM \pm T I transition, odd and even spins cease to be aligned, which makes conductivity via DEM harder.
- 2. The Charge O rdered phase grows larger when an external magnetic eld is applied. In our case, we have run a simulation with non zero magnetic eld to see how the transition line moves.
- 3. In the CO phase, at xed temperature, the magnetization increases with an external magnetic eld, just as in a FM phase.

Let us now describe the physics of the FM -FI transition. Near the FM -FI transition, in the FM phase the ordering is symmetric with respect to the odd-even exchange and the eld uctuates at random around the totalm agnetization vector, the uctuations being larger than in the FI phase, as shown by measurements of speci cheats and susceptibilities made in both phases. More precisely, the magnetization increases as the temperature goes down from the FM to the FI phase, which can be explained by a diminution of uctuations. In fact, one would expect that the magnetization should be smaller in the FI phase, with xed odds and evens on an open cone around the odd direction, than in the FM phase, where the evens lie on a narrower cone, with a larger projection on the odd direction. Yet, the large uctuations in the FM phase destroy the even contribution to the magnetization. The FI vacuum consists then on the odd, practically frozen, sublattice, and the even sublattice, with spins on an open, but less uctuating cone.

Let us now look in the FM phase close to the FI transition, and switch on a weak magnetic eld in the Z direction. This will have the general e ect of collimating the spins. In more detail, odd spins shall freeze closer to the Z direction, which shall cause the even sublattice to freeze on the cone, with smaller uctuations. Paradoxically, the collimating e ect of the magnetic eld in the Z direction is to stabilize the cone, e ectively opening it, giving rise to a more FI-like ordering, i.e., the FI phase shall invade the FM phase, and the critical temperature shall rise. This phenom enon (see point 2) is accompanied by an increase in the magnetization at xed temperature in the FI phase (see point 3).

In order to check the correctness of the description, we have simulated in the neighborhood of the transition with h = 0.01, which does not alter the system properties, and have run a hysteresis cycle at J = 0.43 in L = 12;24 between T = 0.01 and T = 0.025 (i.e. along t_2). A good observable for the transition is $\frac{V}{s}$. The results at the two L values show that the nite size e ects are negligible in front of the change in T_c with h.

Fig.13 shows the result, which con rm s that the inclusion of a magnetic eld rises $T_{\rm c}$, causing the invasion of the FI ordering into regions which at h = 0 were FM .

V. CONCLUSIONS

We have studied a simple model for double exchange interactions which retains a good number of interesting properties. It exhibits a complex phase diagram with ferrom agnetic, ferrim agnetic phases, with their staggered counterparts, and a segment-ordered phase.

W e obtain quantitatively all phases with approximate calculations (M ean Field and 1=N expansions), which can be contrasted with exact M onte Carlo calculations. W ith M onte Carlo simulations we obtain, in addition to the precise positions of the transitions, information about their order. Our conclusion is that all transitions seem to be second order, although an accurate determination of the critical exponents is di cult and it is beyond the scope of this paper.

We have studied in detail the exotic RP^2 phase (segment-ordered), concluding that it is a single phase up to the resolution allowed by the lattice sizes used in the simulation. The presence of a RP^2 phase up to T = 0

is interesting from the experim ental point of view, since it can be confused with a PM or glassy phase and consequently with a Quantum Critical Point. We have shown that the structure factor (V, in g.5) remains bounded in the full B rillouin-zone . Therefore the R P 2 phase cannot be detected in neutron scattering experiments as a long-range ordering, although the phase transition will show up as a maximum (more precisely, a cusp) of the specic heat. A short-range ordering would of course always be present. Since the critical exponent is negative, the Harris criterion³⁹ in plies that our results are robust against disorder e ects. The RP² phase is characterized by a breakdown of the even-odd symmetry and a remaining O (2) symmetry, despite the fact that the m easured critical exponents for the RP² transition point to a total breakdown of the initial O (3) sym m etry. W e have also discussed the e ects of a magnetic eld on the ferrom agnetic-ferrin agnetic transition, and we have discussed its interplay with electrical conductivity.




FIG. 14: Mean-Field phase diagram as obtained from the num erical m in in ization of the free-energy (dashed lines) and from the m in in ization of the free-energy calculated to fourth order (full lines). The dotted lines are artifacts of the fourth-order approximation.

APPENDIX B:MEAN FIELD FOURTH ORDER ANALYSIS
