M ass-Enhanced Ferm i Liquid G round State in N a_{1:5}C o₂O ₄

M agnetic, transport, and speci c heat m easurements have been performed on layered m etallic oxide N $a_{1:5}$ C o_2 O_4 as a function of temperature T. Below a characteristic temperature T = 30 40 K, electrical resistivity shows a metallic conductivity with a T² behavior and magnetic susceptibility deviates from the Curie-W eiss behavior showing a broad peak at 14 K. The electronic speci c heat coe cient is 60 m J/m olK² at 2 K. No evidence for magnetic ordering is found. These behaviors suggest the formation of mass-enhanced Ferm i liquid ground state analogous to that in d-electron heavy ferm ion com pound LiV₂O₄.

There has been a great deal of interest in the physics of geom etrically fustrated spin system s, in which the long-range m agnetic order tends to be suppressed and novel types of phase transitions or ground states are expected. In particular, the recent discovery of the heavy ferm ion (HF) behavior in LiV_2O_4 has stimulated new interest in the geom etrically frustrated system s, where the HF behavior is demonstrated by the d-electrons on the spinelB lattice.¹ O ne of the most exciting scenario is the generation of the d-electron heavy ferm ions through the e ect coming from the geom etrical frustration which is possibly inherent due to the geom etry of V atoms and the negative W eiss tem perature of 40 K.¹

The low-T properties of $L_{1}V_{2}O_{4}$ are apparently of interm etallic dense K ondo system s, showing a fairly large electronic speci c heat coe cient 420 m J/m o \mathbb{K}^{2} ,¹,² a broad maximum of magnetic susceptibility,^{1,3} and a m etallic conductivity with a T² behavior below a coherence tem perature T = 20 30 K⁴. Indeed, the origin of the HF behavior has been considered from various angles, but a uniform understanding remains to be achieved. Urano et al. suggest the importance of the geometrical frustration,⁴ which is inferred from the occurrence of spin-glass order by the slight substitution for the Lior V sites.^{5,6,7} A recent inelastic neutron scattering study has revealed a feature of frustrated magnetism in LiV₂O₄. On the other hand, a broad maximum of 7 Li1=T₁(T) at 30 50 K and a constant (T_1T) ¹ at low T have been found, suggesting a dense K ondo picture.⁹ ⁷Li 1= T_1 (T) has also been interpreted from the view point of the ferrom agnetic instability predicted in the spin uctuation theory.¹⁰ From the theoretical side, various approaches have been introduced and several groups focus on the geom etrical frustration. 11,12,13

To gain m ore insight into this problem, the discovery of other examples of d-electron m aterial to exhibit HF behavior is of signicant importance. From this view point, it is interesting to note the low -T properties of the m etallic oxide $-Na_xCo_2O_4$ (1 x 1.5), which is well-known as a large therm oelectric m aterial.¹⁴ This compound has

been found to exhibit a large of 80 mJ/molK^2 at 2 K and a Curie-W eiss behavior of magnetic susceptibility with a W eiss tem perature 120 K showing no sign ofm agnetic order.^{15,16,17} N $a_x C o_2 O_4$ has a layered structure consisting of $C \circ O_2$ layers in which the $C \circ$ atom s form a two-dimensional regular triangular lattice with interlayers of N a atom s alternatively stacked along the c axis.¹⁸ In addition to the large value and the metallic conductivity, the absence of magnetic order and the arrangem ent of the magnetic ions sitting on a geometrically frustrated lattice are characteristic features in com m on with $L IV_2 O_4$. Also, the C15 Laves phase compound (Y_{0:95}Sc_{0:05})Mn₂, in which the arrangement of the Mn atom s is equivalent to B sites on spinel lattice, has been found to show no magnetic order and HF behavior with $= 150 \text{ m J/m o} \mathbb{K}^2 \cdot ^{19}$

In the present work, the intrinsic low-T properties of Na1:5C 020 4 have been investigated through the measurements of dc magnetic susceptibility (), electrical resistivity () and speci c heat (C). For the precise investigations, high purity specimens which were melted and grown in a oating-zone furnace were prepared. The crystal grow th was perform ed in a high pressure oxygen atmosphere of 0.5 1.0 MPa. The nalproducts were not single crystals but multiple crystals. All the peaks observed in the powder X-ray di raction were indexed as $-Na_xCo_2O_4$. The lattice constants were estimated to be a=2.84(5) A and c=10.85(2) A similar to those reported in the previous work.²⁰ The chem ical com position of $Na_xCo_2O_4$ was determined to be x 1.5 by inductively coupled plasm a analysis. dc m agnetic susceptibility was measured by a superconducting quantum interference device (SQUID) magnetom eter. Speci c heat was measured by a therm al relaxation method. E lectrical resistivity was measured using a standard four-probe technique.




FIG .1: P bts ofm agnetic susceptibility vs tem perature data for N $a_{1:5}C\,o_2\,O_4\,$ at H = 1 T .

Figure 1 shows the (T) data for the melt-grown crystal of N $a_{1:5}$ C o_2 O $_4$ in a magnetic eld of H = 1 T.A remarkable feature is a broad peak of (T) at 10 20 K, which is similar to that observed in LiV $_2$ O $_4$.¹ No indica-

tion of magnetic order above 2 K was found in our eldcooled and zero-eld-cooled (T) measurements. While for the sintered sample of $Na_{1:5}Co_2O_4$, the (T) curve has been reported to show a monotonic increase as decreasing temperature.¹⁷ This is probably because the low-T peak is masked by a Curie-like behavior of magnetic in purities or defects contained in the sintered sam ple. Also for $L_{1}V_{2}O_{4}$, a broad peak of (T) is often masked by a Curie-like behavior depending on the sam ple quality.³ The (T) curve for the melt-grown crystal was tted by the expression, $(T) = _0 + C = (T)$) for 50 T 300 K, yielding a Curie constant C = 0.369 emu/molK, a W eiss temperature = 139 K and a Tindependent susceptibility $_0 = 1.12 \ 10^4 \text{ emu/mol. For}$ $NaCo_2O_4$, Co ion has a mixed valence between Co^{3+} $(3d^6)$ and Co^{4+} $(3d^5)$ $(Co^{3+}/Co^{4+}=1)$, which are presum ably in the low spin state with S = 0 and S = 1/2, respectively. The value of C corresponds to an e ective magnetic moment $_{\rm e}$ 1.22 $_{\rm B}$ per Co site.




FIG.2: Plots of magnetic susceptibility vs temperature data for the melt-grown crystal of N $a_{1:5}$ C o_2 O $_4$ in various magnetic elds up to 7 T. The inset shows those for LiV $_2$ O $_4$.

Next, we show the (T) data for $Na_{1:5}Co_2O_4$ at various magnetic elds up to 7 T in Fig. 2. The inset of Fig. 2 shows the (T) data for LiV_2O_4 , which were collected using the specimen used in the previous work.⁷ In the

(T) curves both for N $a_{1:5}$ C o_2 O $_4$ and L \swarrow $_2$ O $_4$, a broad peak is observed at 10 20 K, and a low-T upturn seen at H = 0.1 T vanishes at H = 7 T. This is due to the saturation of the m om ents of the m agnetic im purities in the high magnetic eld, indicating that the intrinsic (T) behavior is observed at H = 7 T. A rem arkable feature is that the height and position of the peak commonly appear to be almost unchanged by the application of high magnetic eld. Moreover, the peak tem perature of (T) at $\rm H$ = 7 T for N $a_{1:5} C \, o_2 O_4$ is identi ed as $T_p - 14 \; K$, sim ilar to that for LW_2O_4 (T_p=15 16 K). The broad peak behavior in (T) is similarly observed in interm etallic dense K ondo system s, which are thought to becom e Pauliparam agnetic below the peak tem perature. The broad peak behavior, how ever, does not agree with S = 1/2 K ondo m odel predictions,³ since the behavior is \lim ited to the

For LiV_2O_4 , a m etallic behavior with (T)/T² has been observed below T = 20 30 K, indicating the formation of heavy-mass Fermi liquid (FL) below T ⁴. The results of the (T) measurements for them elt-grown crystal of N a_{1:5}C o₂O₄ are displayed in Fig. 3. (T) was measured along the cleaved (001) surface of the meltgrown crystal. The sam ple was not a single crystal but we think that the data roughly represent the in-plane resistivity due to the crystal orientation. In Fig. 3, the

(T) curve at am bient pressure decreases as the tem perature is lowered below 300 K and shows a higher rate of decrease below 30 40 K. The inset of Fig. 3 shows a plot of versus T² at low T, clearly indicating a T² behavior in (T). Thus, the (T) data suggest the FL behavior below T = 30 40 K. T was found to nearly correspond to the temperature below which the deviation from the Curie-W eiss behavior in (T) is apparent, as in LiV_2O_4 .⁴ W e obtain a coe cient of the T² term A=0.48 cm =K², which yields A= ² 1.3 10⁴ cm =K²=(m J=m ol K²)². The value of A= ² is fairly

larger than that for the K adowaki W oods relation, i.e., $A = {}^{2}$ 10 5 cm =K²= (m J=m ol K 2)², but the value would be reduced if we used a single crystal specimen for the (T) m easurement.

The (T) data in Fig. 3 is inconsistent with that measured using a single crystal specimen of N aC o_2O_4 prepared by NaC I- ux technique in the previous work,¹⁴ where (T) along the (001) plane decreases monotonously as decreasing temperature even at low T. The origin of the discrepancy is unclear but a similar discrepancy has also been observed between sintered samples,^{22,23} one of which shows a metallic behavior with a marked decrease in (T) below 40 K similar to (T) in Fig. 3 and is prepared by \rapid heat-up technique".²³ O ne may consider that the (T) data in Fig. 3 re ects not only in-plane re-

sistivity but also out-of-plane resistivity, which has been reported to show a maximum at 200 K.¹⁴ However, we note that (T) in Fig. 3 shows no tendency to make a maximum at 200 K and out-of-plane resistivity reported previously does not show a marked decrease below 40 K .14

Next, we investigate the behavior of C = T vs T for the $m elt-grown crystal of Na_{1.5}Co_2O_4$. The result is shown in Fig. 4, where C = T shows a gradual decrease with decreasing tem perature. The behavior is inconsistent with that for the sintered sample of N aC $o_2 O_4$ in the previous work, where C =T increases with decreasing tem perature below 5 K and reaches 80 m J/m olK² at 2 K.¹⁵ For a sintered sample, the contribution of the magnetic impurities, associated with the release of the magnetic entropy S = C = T dT at low T, could not be excluded. In Fig. 4, (2 K) (C=T at 2 K) for $Na_{1:5}Co_2O_4$ is estimated to be $60 \text{ m J/m o } \mathbb{K}^2$, which is three times larger than the value obtained from a recent band calculation.²⁴ The C = T T curve is qualitatively sim ilar to that for UG a_3 $(=43 \text{ mJ/molk}^2)^{25}$ Using $(2 \text{ K})=22 \text{ mJ/molt}^2$ and $(2 \text{ K}) = 60 \text{ m J/m o } \mathbb{K}^2$, we obtain a W ilson ratio \mathbb{R}_{W} 2.7. No indication of magnetic order was found for both sam -

ples in the m easurem ents for 2 T 100 K.

For LiV_2O_4 , (T) is the prediction for the S=1=2 Kondo model, yielding a Kondo temperature $T_{K} = 27.5 \text{ K} \cdot 1$ Assuming one spin (S = 1=2) per formula unit, the C=T T curve for the melt-grown crystal of $Na_{1:5}Co_2O_4$ was also reproduced by the prediction for an S = 1=2 K ondo m odel (Ref. 26) with $T_{K} = 140$ K at least in the limited temperature range 2 T 15 K. However, $T_{\rm K}$ is fairly higher than $T_{\rm p}$ ($14~{\rm K}$) for ~(T) and T(= 30 40 K) for (T), inconsistent with a dense K ondo picture. In the inset of Fig. 4, the C=T T curve for the melt-grown crystal of Na1:5C 0204 in a magnetic eld of H = 10 T, together with the zero-eld data, is show n. (2 K) for H = 10 T was estimated to be about 10% larger than that for zero eld. This is contrary to that expected in conventional dense K ondo system s, where the value of

tends to decrease with applied magnetic eld and the eld dependence is explained by the broadening of the

K ondo resonance with applied $eld_{\cdot}^{27,28}$ N $a_{1:5}$ C o_2O_4 is unlike dense K ondo system s.

It should be noted that, in both of $Na_{1:5}Co_2O_4$ and ${\rm L\,i\!V}_2{\rm O\,}_4,$ below T , the system shows FL behavior accom panied by a large mass enhancem ent and (T) deviates from the Curie-W eiss behavior showing a broad peak at 14 16 K. These behaviors suggest that the massenhanced FL ground states in these com pounds are analogous to each other. A Kondo lattice model has been proposed for $L \mathbb{N}_2 O_4$,²⁹ but is not adequate as a uni ed description for these compounds, because $Na_{1:5}Co_2O_4$ is unlike dense K ondo system s as m entioned above. M oreover, it is not obvious how the localized moments and it inerant carriers as in f-electron HF com pounds originate from the same 3d shell with the electron con guration 3d^{5:5} at low spin state. A common feature between $Na_{1:5}Co_2O_4$ and LiV_2O_4 is the geometry of magnetic ions possibly giving rise to the spin frustration. Furtherm ore, HF behavior has been found in $(Y_{0:95}Sc_{0:05})Mn_2$ (= 150 $m J/m o \mathbb{K}^2$) (Ref. 19) and $-M n (= 70 m J/m o \mathbb{K}^2)$,³⁰ both of which have magnetic ions sitting on a geometrically frustrated lattice and do not show any magnetic order. It is hard to imagine that the common structural feature possibly leading to the spin frustration in the mass-enhanced FL compounds noted above is accidental.


In summary, our measurements for the melt-grown


15 10 _T² (5 15 20 (K²) 0^L 100 200 300 Temperature (K) FIG.3: Tem perature dependence of electrical resistivity for

crystal of N $a_{1:5}$ C o_2O_4 have revealed a large value of 60 m J/m olK² at 2 K, a T² behavior of (T) and a characteristic broad peak behavior of (T) at 14 K, suggesting the form ation of m ass-enhanced FL analogous to that in LW₂O₄ below T = 30 40 K. A bænce of m agnetic order and m ass-enhanced FL behavior are com m on features am ong N $a_{1:5}$ C o_2O_4 , LW₂O₄, (Y $o_{1:95}$ S $c_{0:05}$)M n_2 and

-M n, all of which have a magnetic sublattice identical to that in geom etrically frustrated system s. To advance

tow ands further understanding for what happens in these system s, the theoretical explanation is desirable for the origin of the broad peak behavior in (T) and the role of the geom etrically frustrated lattice in the ground state.
