# Excitons dressed by a sea of excitons

#### Abstract

W e here consider an excition iem bedded in a sea of N identicalexcitons 0 . If the excitons are bosonized, a bosonic enhancem ent factor, proportional to $N$, is found for $i=0$. If the exciton com posite nature is kept, this enhancem ent not only exists for $i=0$, but also for any exciton having a center of $m$ ass $m$ om entum equal to the sea excition $m$ om entum . This physically com es from the fact that an exciton $w$ ith such a $m$ om entum can be transform ed into a sea exciton by \P auli scattering", i. e., carrier exchange $w$ ith the sea, $m$ aking this $i$ exciton not so $m$ uch di erent from a 0 exciton. This possible scattering, directly linked to the com posite nature of the excitons, is irretrievably lost when the excitons are bosonized. $T$ his work in fact deals w ith the quite tricky scalar products of N -exciton states. It actually constitutes a crucial piece of our new $m$ any-body theory for interacting com posite bosons, because all physical e ects involving these com posite bosons ultim ately end by calculating such scalar products. The \P auli diagram s" we here introduce to represent them, allow to visualize $m$ any-body e ects linked to carrier exchange in an easy way. They are conceptually di erent from Feynm an diagram s , because of the special feature of the $\backslash \mathrm{P}$ auli scatterings": These scatterings, which originate from the departure from boson statistics, do not have their equivalent in Feynm an diagram s , the com m utation rules for exact bosons (or ferm ions) being included in the rst line of the usualm any-body theories.


## 1 Introduction

W e are presently developing a new many-body theory [1-7] able to handle interactions betw een com posite bosons | like the sem ioonductor excitons. The developm ent of such a theory is in fact highly desirable, because, in the low density lim it, electron-hole pairs are known to form bound excitons, so that, in this lim 止, to $m$ anipulate excitons is surely a better idea than to $m$ anipulate free carriers. H ow ever, the interaction between excitons is not an easy concept due to carrier indistinguishability: Indeed, the excitons, being $m$ ade of two charged particles, of course interact through C oulom b interactions. H ow ever, this C oulom.b interaction can be ( $\left.V_{e e^{0}}+V_{h h^{0}} \quad V_{\text {eh }} 0 \quad V_{\text {eh }}\right)$ or ( $\left.V_{\text {ee }}{ }^{0}+V_{h h} 0 \quad V_{e h} \quad V_{\text {en }} 0\right)$ depending ifwe see the excitons as $(e ; h)$ and ( $e^{0} ; \mathrm{h}^{0}$ ) , or ( $e ; \mathrm{h}^{0}$ ) and ( $\left.e^{0} ; \mathrm{h}\right)$. In addition, excitons interact in a far m ore subtle $m$ anner through Pauli exclusion between their indistinguishable com ponents, in the absence of any Coulom b process. This \P auli interaction" is actually the novel and interesting part of our new $m$ any-body theory for com posite bosons. It basically com es from the departure from boson statistics, all previous theories, designed for true bosons or true ferm ions, having the corresponding com mutation rules set up in the rst line [8]. In our theory, the fact that the excitons are not exact bosons appears through \P auli scatterings" mnij between the \in" excitons ( $i ; j$ ) and the \out" excitons $(m ; n)$. Their link to boson departure is obvious from their de nition. Indeed, these P auli scatterings appear through $[2,3]$

$B_{i}^{y}$ being the i excition creation operator. It precisely reads in term sof the exciton wave function ${ }_{i}\left(r_{e} ; r_{h}\right)=h r_{e} ; r_{h} B_{i}^{Y} j \dot{j}$ as

The above expression $m$ akes clear the fact that $m$ nij just corresponds to a carrier exchange between two excitons (see g.la) w thout any Coulomb process, so that mnij is actually a dim ensionless \scattering". It is possible to show that for bound states, $m n i j$ is of the order of $\mathrm{V}_{\mathrm{X}}=\mathrm{V}$, w ith $\mathrm{V}_{\mathrm{x}}$ being the exciton volum e and V the sam ple volum e [6].

A $l l$ physical quantities involving excitons can be written as matrix elem ents of an Ham iltonian dependent operator $\mathrm{f}(\mathrm{H})$ between N -exciton states, with usually m ost of them in the ground state 0 . These $m$ atrix elem ents form ally read

They can be calculated by \pushing" $\mathrm{f}(\mathrm{H})$ to the right in order to end with $\mathrm{f}(\mathrm{H})$ jvi, which is just $f(0)$ jvi if the vacuum is taken as the energy origin. This push is done through a set of com $m$ utations. In the sim plest case, $f(H)=H$, we have

to end with $V_{i}{ }^{Y}$ jui which is just 0 due to eq. (6) applied to jvi.
Equations ( 6,7 ), along $w$ th eqs. ( 1,2 ), form the four key equations of our $m$ any-body theory for interacting com posite excitons. ${ }_{\mathrm{m}}^{\mathrm{m}} \mathrm{nij}$ is the second scattering of this theory. It transform $s$ the $(i ; j)$ excitons into ( $m ; n$ ) states, due to $C$ oulom b processes betw een them, as obvious from its explicit expression:

N ote that, in $\underset{\mathrm{m} \mathrm{nij}^{\mathrm{dij}}}{\mathrm{dir}}$, the \in" and \out" excitons are m ade w ith the sam e pairs, while, in
 bound states are of the order of $\mathrm{R}_{\mathrm{x}} \mathrm{V}_{\mathrm{X}}=\mathrm{V}$, w ith $\mathrm{R}_{\mathrm{x}}$ being the exciton Rydberg [6].

A nother $\mathrm{f}(\mathrm{H})$ of interest can be $1=(\mathrm{a} \quad \mathrm{H})$, w ith a possibly equal to (! +i) as in problem s involving photons. In order to push $1=\left(\begin{array}{ll}a & H\end{array}\right)$ to the right, we can use [4]

which follow s from eq. (5). In pushing $1=\left(\begin{array}{ll}a & H\end{array}\right)$ to the right, we generate C oulom b term $s$ through the $V_{i}^{y}$ part of eq. (9). D ue to dim ensional argum ents, these term $s$ ultim ately
 or just a di erence betw een excition energies, depending on the problem at hand.

A last $f(H)$ of interest is $e^{\text {if } t}$ which appears in problem $s$ involving tim e evolution. In order to push $e^{\text {iH } t}$ to the right, we can use [7]

Equations $(10,11)$ result from the integral representation of the exponential, nam ely

valid fort and positive, com bined with eq. (9). A gain additionalC oulom b term s appear in passing $e^{i H t}$ over $B_{i}^{y}$.

By com paring eqs. $(5,9,10)$, we see that, when we pass $f(H)$ over $B \frac{y}{i}$, we essentially replace it by $f\left(H+E_{i}\right)$, as if the i exciton was not interacting $w$ ith the other excitons, $w$ thin a C oulomb term which takes care of these interactions, $f\left(H+E_{i}\right)$ being in some sense the zero order contribution of $f(H)$.

O nce we have pushed all the H's up to jvi and generated very many C oulomb scatterings $\underset{m \text { mij }}{\operatorname{dij}}$, we end w ith scalar products of $N$ exciton states which look like eq. (4) w ith $\mathrm{f}(\mathrm{H})=1$. Then, we start to push the $B$ 's to the right according to eqs. $(1,2)$, to end $w$ th B jui which is just zero. This set of pushes now $m$ akes appearing the $P$ auli scatterings mnij.

In the case of $N=2$, eqs. $(1,2)$ readily give the scalar product of two-exciton states as [2]

For large $N$, the calculation of sim ilar scalar products is actually very tricky. $W$ e expect them to depend on $N$ and to contain $m$ any $m n_{i j}$ 's.

TheN dependence ofthese scalarproducts is in fact crucialbecause physicalquantities m ust ultim ately depend on $\quad=\mathrm{N} \mathrm{V}_{\mathrm{X}}=\mathrm{V}$, w ith $\mathrm{V}_{\mathrm{X}}=\mathrm{V}$ com ing either from Pauliscatterings or from Coulom.b scatterings | with possibly an additional factor $N$, if we look for som ething extensive. H ow ever, as the scalar products ofN -exciton states are not physical quantities, they can very well contain superextensive term $s$ in $N^{p} n$ which ultim ately
disappear from the nalexpressions of the physicalquantities. To handle these factors N properly | and their possible cancellations | is thus crucial.

In previous works [1,5], we have calculated the sim plest of these scalar products of N -exciton states, nam ely hv $-\mathrm{B}_{0}^{\mathrm{N}} \mathrm{B}_{0}^{\mathbb{Y N}}$ jvi. W e found it equal to N !, as for exact bosons, $m$ ultiplied by a corrective factor $\mathrm{F}_{\mathrm{N}}$ which com es from the fact that excitons are com posite bosons,

This $\mathrm{F}_{\mathrm{N}}$ factor is actually superextensive, since it behaves as $\mathrm{e}^{\mathrm{N} 0()}$ (see ref. [5]). In large enough samples, $N$ can be extrem ely large even for $s m a l l$, which $m$ akes $F_{N}$ exponentially sm all. In physicalquantities how ever, $\mathrm{F}_{\mathrm{N}}$ never appears alone, but through ratios like $F_{N}{ }_{p}=F_{N}$ which actually read as $1+O()$ forp $N$. This restores the expected dependence of these physical quantities.

The present paper in fact deals w ith determ ining the interplay between the possible factors $N$ and the various 's which appear in scalar products of $N$-exciton states. $T$ hese $P$ auli scatterings being the original part of our $m$ any-body theory for interacting com posite bosons, the understanding of this interplay is actually fiundam ental to $m$ aster m any-body e ects between excitons at any order in $\quad=\mathrm{N} \mathrm{V}_{\mathrm{X}}=\mathrm{V}$. This will in particular allow us to cleanly show the cancellation of superextensive term swhich can possibly appear in the interm ediate stages of the theory [7].

This paper can appear as som ew hat form al. It how ever constitutes one very im portant piece of this new $m$ any-body theory, because all physical e ects between $N$ interacting excitons ultim ately end with calculating such scalar products. P roblem s involving two excitons only [7] are in fact rather simple to solve because they only need the scalar product of two-exciton states given in eq. (13). The real challenging di culty which actually rem ains in order to handle $m$ any-body e ects between $N$ excitons at any order in, is to produce the equivalent of eq. (13) for large $N$.

In usualm any-body e ects, Feynm an diagram s [8] have been proved to be quite convenient to understand the physics of interacting ferm ions or bosons. W e can expect the introduction of diagram s to be also quite convenient to understand the physics of interacting com posite bosons. It is how ever clear that diagram s representing carrier exchange between $N$ excitons have to be conceptually new : In them, m ust enter the Pauli scat-
terings which take care of the departure from boson statistics. As the ferm ion or boson statistics is included in the rst lines of the usual many-body theories, the Pauli scatterings do not have their equivalent in Feynm an diagram s. A nother im portant part of the present paper is thus to present these new $\backslash$ Pauli diagram s " and to derive som e of their speci c rules. A s we will show, these P auli diagram s are in fact rather tridky because they can look rather di erently although they represent exactly the sam e quantity. To understand why these di erent diagram s are indeed equivalent, is actually crucial to $m$ aster these P auli diagram $s$. This is the sub ject of the last section of this paper. It goes through the introduction of \exchange skeletons" which are the basic quantities for carrier exchanges between $m$ ore than two excitons. Their appearance is physically reasonable because Pauli exclusion is N -body \at onœ", so that, when it plays a role, it in fact correlates all the carriers of the involved excitons through a unique process, even if this process can be decom posed into exchanges betw een two excitons only, as in the P auli scatterings mnij.

From a technical point of view, it is of course possible to caloulate the scalar products of $N$-exciton states, just through blind algebra based on eqs. $(1,2)$, and to get the right answer. H ow ever, in order to understand the appearance of the extra factors $N$ which go in front of the ones in $N \quad, N V_{X}=V=$ and which are crucial to ultim ately withdraw superextensive term $s$ from physical quantities, it is in fact convenient to introduce the concept of lexcitons dressed by a sea of excitons", because these extra factors N are physically linked to the underlying bosonic character of the excitons which is enhanced by the presence ofan exciton sea. W ew ill.show that these extra factors $N$ are linked to the topology of the diagram $m$ atic representation of these scalar products, which appears as \disconnected" when these extra N 's exist. This is after all not very astonishing because disconnected Feynm an diagram s are known to also generate superextensive term s .

Let us introduce the exciton idressed by a sea of N excitions 0 as

The denom inator $h v-\beta{ }_{0}^{N} B_{0}^{Y N}$ jvi is a norm alization factor which $m$ akes the operator in front of $B_{i}^{y}$ appearing as an identity in the absence of P auli interactions with the excition
sea. Indeed, we can check that the vacuum state, dressed in the sam e way as

is just jvi, as expected because no interaction can exist with the vacuum. On the opposite, subtle $P$ auli interactions take place betw een the exciton sea and an additional exciton i. As the dressed exciton i contains one m ore $B^{y}$ than the num ber of $B$ ' $s$, it is essentially a one-pair state. It can be w ritten either in term s of free electrons and holes, or better in term $s$ of one-exciton states. Since these states are the one-pair eigenstates of the sem ioonductor $H$ am iltonian $H$, they obey the closure relation $1={ }_{m}^{P} B_{m}^{y}$ jvihv $\mathcal{B}_{\mathrm{m}}$. So that $j_{i}{ }^{(N)}$ i can be written as

This decom position of $\left.j_{i}{ }_{i}^{N}\right)$ i on one-exiton states $m$ akes appearing the scalar product of $(\mathbb{N}+1)$-exciton states $w$ th $N$ of them in the exciton sea.

A s the physics which controls the extra factors N in these scalar products, is actually linked to the underlying bosonic character of the excitons, let us rst consider bosonexcitons in order to see how a sea of $N$ boson-excitions 0 a ects them.

## 2 B oson-excitons dressed by a sea ofexcitons

Instead of eq. (1), the commutation rule for boson-excitons is $\left.\mathbb{B}_{m} ; B_{i}^{y}\right]=m$ i, so that the deviation-from -boson operator $\mathrm{D}_{\mathrm{m}}$ i forboson-excitons is zero, as the P auliscatterings $m \mathrm{nij}$. From this boson commutator, we get by induction

$T$ he factor $N$ which appears in this equation is physically linked to the well know $n$ bosonic enhancem en [9]. Themem ory of such an e ect $m$ ust a priori exist for com posite bosons,
such as the excitons. However, subtle changes are expected due to their underlying ferm ionic character. Let us now see how this bosonic enhancem ent, obvious for bosonexcitons, does appear for exact excitons.

## 3 Exact excitons dressed by a sea of excitons

The com $m$ utation rule for exact excitons is given in eq. (1). By taking another com $m$ utation, we generate eq. (2) which de nes the P auli scattering mnij. From it, we easily get by induction

(W e can note that eq. (19) for bosons just follows from eq. (24), since the deviationfrom -boson operator $D_{m i}$ and the Pauliscattering $m n_{i j}$ are equal to zero in the case of boson-excitons) .

In order to grasp the bosonic enhancem ent for exact excitons, let us start $w$ th the \best case" for such an enhancem ent, nam ely an exciton 0 dressed by a sea of N excitons 0.

### 3.1 Exciton 0 dressed by N excitons 0

A ccording to eq. (17), this dressed exciton can be writen as

This ${ }_{\mathrm{N}}(\mathrm{m})$, which is just $\mathrm{F}_{\mathrm{N}+1}=\mathrm{F}_{\mathrm{N}}$, $1+\mathrm{O}()$ for $\mathrm{m}=0$, w ill appear to be a quite usefiul quantity in the follow ing. Its diagram $m$ atic representation is show $n$ in $g .2 a$ as well as its iteration ( $g .2 \mathrm{~b}$ ). Its solution is

$z^{(p)}(m ; 0)$ can be represented by a diagram $w$ ith ( $p+1$ ) lines, the low est one being ( $m$; 0 ), while the $p$ other lines are $(0 ; 0)$. These lines are connected by $p$ Pauli scatterings which are in zigzag, altematively right, left, right... (see g. 2 b ). For $p=1, \mathrm{z}^{(\mathrm{p})}(\mathrm{m} ; 0)$ is just $m 000$, while for $p=2$, it reads ${ }^{P}{ }_{n} m n 00$ oono and so on ...Fig. 2c also shows ${ }_{N}$ (i), easy to obtain from ${ }_{\mathrm{N}}(\mathrm{m})$ by noting that ${ }_{\mathrm{mnij}}=\mathrm{ijm}_{\mathrm{n}}$, so that ${ }_{\mathrm{N}}$ (i) is just obtained from ${ }_{\mathrm{N}}$ (i) by a sym m etry right-left: In ${ }_{\mathrm{N}}$ (i), the zigzag in fact appears as left, right, left,... Since we are ultim ately interested in possible extra factors $N$, it can be of interest to understand the appearance of $N$ ' $s$ in $n(m)$. If we forget about the com posite nature of the exciton, i. e., if we drop all carrier exchanges with the exciton sea, the electron and hole of the exciton 0 are tight for ever as for boson-excitons, so that we should have for $j 0_{0}^{(\mathbb{N})} i$ the sam e result as the one for boson-excitons, nam ely $j_{0}^{(N)} i^{\prime}(\mathbb{N}+1) B{ }_{0}^{y} j v i$. This leads to ${ }_{\mathrm{n}}(\mathrm{m})^{\prime} \mathrm{m}_{\mathrm{m}}$ at lowest order in . The com posite exciton 0 can however exchange its electron or its hole w ith one sea exciton to becom e an $m$ exciton. Since there are $N$ possible excitons in the sea for such an exchange, the rst order term in exchange scattering $m$ ust appear w ith a factor $N$. A nother exciton, am ong the $(\mathbb{N} \quad 1)$ left in the sea, can also participate to these carrier exchanges so that the second order term in P auli scattering $m$ ust appear w ith a $N \mathbb{N}$ 1) prefactor; and so on ...

From this iteration, we thus conclude that ${ }_{\mathrm{N}}(m)$ contains the sam e num ber of factors $N$ as the num ber of 's. Since, for 0 and $m$ being bound states, these 's are in $V_{X}=V$, while $F_{N}{ }_{p}=F_{N}$ reads as an expansion in (see ref. 5]), we thus nd that, in the large $N$ lim it, $\mathrm{n}(\mathrm{m})$ can be written as an expansion in , without any extra factor N in front. $T$ his thus show sthat $j_{0}^{\mathbb{N})}$ i contains the sam e bosonic enhancem ent factor $(\mathbb{N}+1)$ as the one of dressed boson-excitons $\left.j_{0}{ }^{\mathbb{N}}\right)$ i. Let us how ever stress that the relative weight of the $B_{0}^{y}$ jvi state in $j_{0}^{(N)}$ i, nam ely ${ }_{\mathrm{N}}(0)$, which is exactly 1 in the case ofboson-excitons, is som ew hat sm aller than 1 due to possible carrier exchanges w ith the exciton sea. From the teration of ${ }_{\mathrm{N}}(0)$, we nd that this weight reads ${ }_{\mathrm{N}}(0)=1 \quad\left(\mathrm{~F}_{\mathrm{N}} \mathrm{I}_{1}=\mathrm{F}_{\mathrm{N}}\right) \mathrm{N} \quad 0000+$ which is nothing but $\mathrm{F}_{\mathrm{N}+1}=\mathrm{F}_{\mathrm{N}}$ as can be directly seen from eq. (26).

To com pensate this decrease of the $B{ }_{0}^{\gamma}$ jivi state weight, $j_{0}^{(N)}{ }_{0}^{(1}$ has non-zero com ponents on the other exciton states $B_{m}^{Y} \xi_{0} j_{j i}$, in contrast $w$ ith the boson-exciton case. We can how ever note that, since ${ }_{\mathrm{N}}(\mathrm{m})=0$ for $Q_{\mathrm{m}} \not Q_{0}$, due to m om entum conservation in Pauli scatterings, the other exciton states making j $0_{0}^{(N)}$ im ust have the sam em om entum Qo as the one of the 0 excitons.

We thus conclude that one exciton 0 dressed by a sea of $N$ excitons 0 , exhibits the same enhancem ent factor ( $(\mathbb{N}+1$ ) as the one which appears for boson-excitons. This dressed exciton how ever has additional com ponents on other exciton states which have a $m$ om entum equal to the 0 exciton $m$ om entum $Q_{0}$.

The existence of such a bosonic enhancem ent for the excition 0 can appear as som ew hat norm albecause excitons are, after all, not so far from realbosons. W ew ill now show that a sim ilar enhancem ent, i. e., an additional prefactor $N$, also exists for excitons di erent from 0 but having a center ofm ass $m$ om entum equal to $Q_{0}$. Before show ing it from hard algebra, let us physically explain why this has to be expected: From the two possible ways to form two excitons out of two electron-hole pairs, we have shown that

$B{ }_{i \in \sigma_{0}}^{Y} B_{0}^{y}$ can thus be written as a sum of an exciton $m$ and an exciton $n w i t h Q_{m}+Q_{n}=$ $Q_{i}+Q_{0}$ due to $m$ om entum conservation included in the Pauli scatterings mnij. This shows that, for an exciton iw th $Q_{i}=Q_{0}, B{ }_{i f}^{y}{ }_{0} B_{0}^{y}$ has a non-zero contribution on $B{ }_{0}^{y 2}$, so that this i exciton, in the presence of other excitons 0 , is partly a 0 exciton. A bosonic enhancem ent has thus to exist for any exciton iw th $Q_{i}=Q_{0}$.

### 3.2 Exciton idressed by N excitons 0

Let us now consider an exciton with arbitrary i. W e will show that there are essentially two kinds of such excitons, the ones $w$ th $Q_{i}=Q_{0}$ and the ones $w$ th $Q_{i} \in Q_{0}$ : Since a $Q_{i}=Q_{0}$ exciton can be transform ed into an $i=0$ exciton by carrier exchange $w$ th the exciton sea, it is clear that the excitons with $Q_{i} \in Q_{0}$ are in fact the only ones de nitely di erent from 0 excitons; this is why they should be dressed di erently.

The excition i dressed by $N$ excitons 0 reads as eq. (17). From eq. (26), we already know that $A_{N}(0 ; i)$ is just $(\mathbb{N}+1)_{n}$ (i), so that we are left with determ ining the scalar product $A_{N}(m ; i)$ for $(m ; i) \in 0$.

There are $m$ any ways to calculate $A_{N}(m ; i)$ : $W$ e can for exam ple start $w$ ith $\left.B_{m} ; B_{i}^{y}\right]$ given in eq. (1), or with $\left.\mathbb{B}_{\mathrm{m}} ; \mathrm{B}_{0}^{\frac{\mathrm{NN}}{}}\right]$ given in eq. (23), or even $w$ th $\left.\mathbb{B}_{0}^{N} ; \mathrm{B}_{i}^{y}\right]$ given in eq. (24). W hile these last tw o com $m$ utators lead to calculations essentially equivalent, the rst one $m$ ay appear som ew hat better at rst, because it does not destroy the intrinsic ( $m$; i) sym $m$ etry of the $A_{N}\left(m\right.$;i) $m$ atrix elem ent. These various ways to calculate $A_{N}$ ( $m$;i) m ust of course end by giving exactly the sam e result. H ow ever, it tums out that the diagram $m$ atic representations of $A_{N}(m$; i) these various ways generate, look at rst rather di erent. W e will, in this section, present the calculation of $A_{N}(m$; i) which leads to the \nicest" diagram s, i. e., the ones which are the easiest to $m$ em orize. W e leave the discussion of the other diagram $m$ atic representations of $A_{N}(m$;i) and their equivalences for the last part of this work.

### 3.2.1 Recursion relation betw een $A_{N}\left(m\right.$;i) and $A_{N}$ ( $n$;i)

If we now tum to $\hat{A_{N}}(i ; m)$, there are a priori two ways to calculate it: E ther we use $\left.\mathbb{B}_{m} ; B_{0}^{Y \mathbb{N}}\right]$, or we use $\left.\mathbb{B}_{0}^{N} ; B_{i}^{Y}\right]$. The diagram $m$ atic representation of eq. (39) is shown in $g$. 4a. From it and the diagram sof g .2 c for ${ }_{\mathrm{N}}$ (i), we obtain the Pauli expansion of $\mathrm{l}_{\mathrm{N}}(\mathrm{m}$; i) shown in g .4 b . It is just the diagram $m$ atic representation of eq. (40). W e see that $\mathrm{l}_{\mathrm{N}}(\mathrm{m}$; i) is m ade of diagram swhich can be cut into two pieces. $W$ e also see that, while $a_{N}$ ( $m$;i) di ers from 0 for $Q_{m}=Q_{i}$ only, due to $m$ om entum conservation included in the Pauli scatterings, we must have $Q_{m}=Q_{i}=Q_{0}$ to have $Q_{N}(m ; i) 0$, since ${ }_{N}(m)$ is 0 for $Q_{m} Q_{0}$, as previously shown.

From the fact that we just need to have $Q_{m}=Q_{i}$ for $a_{N}(m ; i) 0$, while $\mathrm{l}_{\mathrm{N}}(\mathrm{m}$; i) 0 im poses $Q_{m}=Q_{i}=Q_{0}$, we are led to divide $A_{N}(m$;i) into a contribution which exists whatever the i exciton $m$ om entum is and a contribution which only exists when $Q_{i}$ is equal to the sea exciton $m$ om entum $Q_{0}$. The part of $A_{N}\left(m\right.$;i) which exists for any exciton $i$ is ${ }_{N}(m$;i). The diagram $m$ atic representation of its recursion relation (43) is shown in g . 5 a , as well as its iteration ( g . 5b). If, in it, we insert the diagram $m$ atic representation of $a_{N}(m$;i) given in $g .3 b$, we end w th the diagram $m$ atic representation of ${ }_{N}(m$;i) show $n$ in $g .5 c$. $N$ ote that we have
used $\mathrm{mnoi}=\mathrm{mnio}$ in order to get rid of the factor 2 appearing in $a_{N}(m ; i)$. U sing eq. (35) for $a_{N}(m$; i), it is easy to check that the solution of eq. (43) reads

From g.5c, we also see that ${ }_{\mathrm{N}}$ (m;i) contains asm any N 's as 's so that it ultim ately depends on $\mathbb{N}$; )'s through.

The part of $A_{N}(m$;i) which only exists when the $i$ and $m$ excitons have the sam $e$ $m$ om entum as the sea exciton one, is $N{ }_{\mathrm{n}}(\mathrm{m}$;i). The diagram $m$ atic representation of the recursion relation (44) for ${ }_{\mathrm{N}}$ is show n in g .6 a , aswellas its iteration ( g . 6b). U sing eq. (40) for $\mathrm{l}_{\mathrm{N}}(m$; i) and eq. (29), it is easy to check that the solution of the recursion relation (44) reads

W e also see that ${ }_{\mathrm{n}}\left(\mathrm{m}\right.$;i) contains as many N 's as 's so that ${ }_{\mathrm{n}}(\mathrm{m}$;i), like ${ }_{\mathrm{N}}(\mathrm{m} ; \mathrm{i})$, is an function.
c) $N$ dependence of $A_{N}(m$;i)

Ifwe now com eback to the expression (41) for $\mathrm{A}_{\mathrm{N}}\left(\mathrm{m}\right.$; i), we see that when ${ }_{\mathrm{N}}(\mathrm{m}$; i$)=$ 0 , i.e., when $Q_{m}=Q_{i} \in Q_{0}$, the $N$ 's in $A_{N}(m$;i) simply appear through products $N$. O n the opposite, $A_{N}\left(m\right.$;i) contains an extra prefactor $N$ when ${ }_{N}(m$;i) 0, i.e., when $Q_{m}=Q_{i}=Q_{0}: T h i s$ extra $N$ is the $m$ em ory of the bosonic enhancem ent found for the dressed exciton $i=0$. A s already explained above, this bosonic enhancem ent exists not only for the exciton $i=0$, but also for any exciton which can be transform ed into a 0 exciton by P auli scatterings w ith the sea excitons.

From a $m$ athem atical point of view, this extra $N$ is linked to the topology of the diagram s representing $A_{N}(m$;i). As in the case of the well known Feynm an diagram $s$ for which superextensive term s are linked to disconnected diagram $s$, we here see that an extra factor $N$ appears in the part of $A_{N}(m$;i) corresponding to diagram $s w h i c h$ are $m$ ade of two pieces.

To conchude, we can say that the procedure we have used to calculate $A_{N}$ (m ;i) led us to represent this scalar product by Pauli diagram swhich are actually quite sim ple: The part of $A_{N}\left(m\right.$;i) which exists for any $Q_{m}=Q_{i}$ is $m$ ade of all connected diagram $s$ w ith m at the left bottom and i at all possible places on the right, the exciton lines being connected by P auli scatterings put in zigzag right, left, right... (see g.5c). $\mathrm{A}_{\mathrm{N}}$ (m ;i) has an additional part when the $m$ and iexcitons have a $m$ om entum equal to the sea exciton $m$ om entum $Q_{0}$. This additional part is $m$ ade of all possible $P$ auli diagram $s$ which can be cut into two pieces, $m$ staying at the left bottom of one piece, while i stays at the right bottom of the other piece, the exciton lines being connected by P auli scatterings in zigzag right, left, right. . .for the $m$ piece, and left, right, left...for the i piece (see $g$. $6 c$ ). A s a direct consequence of the topology of these diconnected diagram $s$, an extra factor $N$ appears in this part of $A_{N}(m$; $)$. This factor $N$ is physically linked to the well know $n$ bosonic enhancem ent which, for com posite excitons, exists not only for an exciton identical to a sea exciton, but also for any exciton which can be transform ed into a sea excition by Pauli scatterings $w$ th the sea.

A though this result for the scalar product of $(\mathbb{N}+1$ )-exciton states, $w$ ith $N$ of them in the sam e state 0 , is nicely sim ple at any order in P auli interaction, it does not leave us com pletely happy. Indeed, while in the diagram $s$ which exist for $Q_{i}=Q_{m}=Q_{0}$, the $m$ and i indices play sim ilar roles, their roles in the diagram $s$ which exist even if $Q_{i} Q_{0}$
are dissym $m$ etric, which is not at all satisfactory. This dissym $m$ etry can be traced back to the way we calculated $A_{N}(m$;i). It is clear that equivalences between P auli diagram $s$ have to exist in order to restore the intrinsic $\left(m\right.$;i) $s y m m$ etry of $A_{N}(m$;i). In the last part of this work, we are going to discuss som e of these equivalences betw een P aulidiagram s.

H ow ever, the reader, not as picky as us, $m$ ay just drop this last part since, after all, the quite sim ple, although dissym $m$ etric, Pauli diagram s obtained above are enough to get the correct answer for $A_{N}(m$;i) at any order in the $P$ auli interactions.

## 4 Equivalence betw een $P$ auli diagram $s$

In order to have som e ideas about which kinds of $P$ auli diagram s can be equivalent, let us rst derive the other possible diagram $m$ atic representations of $A_{N}(m$;i). They use the recursion relations.betw een $A_{N}(m ; i)$ and $A_{N} 2(m ; j)$ or $A_{N} 2(n ; j)$, instead of $A_{N} 2(n ; i)$.

Letus rst consider ${ }^{-}{ }_{\mathrm{N}}\left(\mathrm{m}\right.$; i). As ${ }_{\mathrm{N}}\left(\mathrm{m}\right.$; i), it di ers from zero for $Q_{\mathrm{m}}=Q_{i}=Q_{0}$ only. Its recursion relation leads to expand it in term sofc's as shown in g.8. Ifwe now replace the c's by their expansion shown in $g .7$, we immediately nd that ${ }_{\mathrm{N}}{ }_{\mathrm{N}}(\mathrm{m}$; i) is represented by the sam e P auli diagram $s$ as the ones for ${ }_{N}(m ; i)$, so that ${ }_{N}{ }_{N}(m ; i)={ }_{N}(m ; i)$. This is after all not surprising because, in them, the roles played by $m$ and $i$ are sym $m$ etrical.

From this result, we im $m$ ediately conclude that the parts of $A_{N}(m$;i) which exist even if $Q_{i}=Q_{m} Q_{0}$ have also to be equal, i.e., we m ust have ${ }^{-}{ }_{N}(m ; i)={ }_{N}(m ; i)$. Let us now see how this ${ }_{\mathrm{N}}$ (m ;i) appears, using eq. (51).

Ifwe calculate $a_{N}(m ; i)$ not with $\left.\mathbb{D}_{m i} ; B_{0}^{V_{N}^{N}}\right]$ butw ith $\left.\mathbb{B}_{0}^{N} ; D_{m i}\right]$, we nd that $a_{N}(m$;i) can be represented, not only by the diagram s of g . 3 b , but also by those of g . 3c. T hese diagram s look very sim ilar, except that the crosses are now in zigzag left, right, left. . .Since these two sets of diagram s (3b) and (3c) represent the sam e $\mathrm{a}_{\mathrm{N}}$ ( m ; i), while they have to be valid for $\mathrm{N}=2 ; 3$; , the relative positions of the crosses have to be unim portant in these Pauli diagram s. We will com e back to this equivalence at the end of this part.

The iteration of the recursion relation for ${ }^{-}{ }_{\mathrm{N}}(\mathrm{m}$; $i)$ leads to the diagram s of g .9 a . If in them, we insert the diagram sof $g .3 c$ for $a_{N}(m ; i)$, we get the diagram s of $g .9 b$. They look like the ones for n ( $m$; i), except that inow stays at the right bottom while $m$ $m$ oves to all possible positions on the left, the zigzag for the $P$ auli scatterings being now left, right, left. . . If, in these diagram $s$, we now insert the diagram $m$ atic representation of $d_{N}(m ; i)$ shown in $9.10, w$ ith them part altematively below and above the ipart, we nd that ${ }_{{ }_{N}}(m ; i)$ is represented by exactly the sam e diagram $s$ as the ones for ${ }_{N}(m ; i)$, so that ${ }_{N}{ }_{N}(m ; i)={ }_{N}(m ; i)$. As a consequence, we m ust have $={ }_{N}(m ; i)={ }_{N}(m ; i)$.

Let us now consider the recursion relation between $=_{N}(m ; i)$ and ${ }_{N}{ }_{N} \quad(n ; j)$. The iteration of this recursion relation leads to the diagram s of g .12 a . If in it, we insert the diagram $m$ atic representation of $a_{N}(m ; i)$ show $n$ in $g .3 b$, we get the diagram $s$ of $g$. 12b. W e can note that it is not enough to use $0_{n 00}=$ nooo to transform the last third order diagram into the tw o last third order zigzag diagram $s$ left, right, left of ${ }_{\mathrm{N}}$ ( m ;i). At fourth order, the situation is even worse, the last fourth order P aulidiagram for ${ }^{=}{ }_{N}$ ( $m$;i)
being totally di erent from a zigzag diagram. They how ever have to represent the sam e quantity because ${ }_{N}(m ; i)={ }_{N}(m$;i) for any $N$.

Let us now identify the underlying reason for the equivalence ofP aulidiagram s like the ones of $g s .3 \mathrm{~b}$ and 3 c which represent the sam $e a_{N}(m$;i), or the ones of $g s .5 c, 9 b$ and 12 b which represent the part of the sam $e A_{N}\left(m\right.$;i) which exists even if $Q_{m}\left(=Q_{i}\right) Q_{0}$. This will help us to understand how these Pauli diagram s really work.

## 4.3 \Exchange skeletons"

A llthe P aulidiagram swe found in the preceding sections, are m ade of a certain num ber of exciton lines connected by Pauli scatterings betw een two excitons, put in various orders. It is clear that the value of these diagram s can depend on the \in" and \out" exciton states, i. e., the indioes which appear at the right and the left of these diagram s , but not on the interm ediate exciton states over which sum s are taken. Between these \in" and \out" excitons, a lot of carrier exchanges take place through the various P auliscatterings represented by crosses in the P aulidiagram s . It is actually reasonable to think that these Pauli diagram s have to ultim ately read in term s of \exchange skeletons" between the \in" and \out" excitons of these diagram s. For $\mathrm{N}=2 ; 3 ; 4 ; \ldots$ excitons, these \exchange skeletons" should appear as

and so on...T hese de nitions are actually transparent once we look at the diagram $m$ atic representations of these exchange skeletons shown in g. 13.

There are in fact various equivalent w ays to represent these exchange skeletons, as can be seen from g .14 in the case of three excitons. These equivalent representations sim ply say that the $i_{1}$ exciton has the sam e electron as the $m_{1}$ excition and the sam e hole as the
$m_{2}$ exciton, so that $i_{1}$ and $m_{1} m$ ust be connected by an electron line while $i_{1}$ and $m_{2} m$ ust be connected by a hole line.

A ll possible carrier exchanges between $N$ excitons can be expressed in term s of these exchange skeletons.

In the case oftw o excitons, the P auliscattering which appears in the P aulidiagram S , is just ${ }_{m n i j}=L^{(2)}\left(\mathrm{m} ; \mathrm{n} ; \mathrm{i}_{\mathrm{i}} \mathbf{j}\right)+\mathrm{L}^{(2)}\left(\mathrm{n} ; \mathrm{m} ; \mathrm{i}_{\mathrm{j}} \mathbf{j}\right)=2$ (see g. 1a). In ourm any-body theory for interacting com posite bosons, this m nij appears as com posed ofprocesses in which the indices $m$ and $n$ are exchanged. $T$ his is actually equivalent to say that the excitons exchange their electrons instead of their holes (see g.1b). W e can also note that, when the two indiges on one side are equal, like in mnoo, to exchange an electron or to exchange a hole is just the same (see gs. 1d and 1e).

For three excitons, we could think of a carrier exchange between the ( $i ; j ; k$ ) and $(m ; n ; p)$ excitons, di erent from the one corresponding to $L^{(3)}(m ; n ; p ; i ; j ; k)$. Let us, for exam ple, consider the onewhich would read like eq. (60), with ( $m_{1} ; \mathrm{m}_{2} ; \mathrm{m}_{3} ; \mathrm{i}_{1}$ ) respectively replaced by ( $m ; \mathrm{n} ; \mathrm{p} ; \mathrm{i}$ ), while $\mathrm{i}_{2}\left(\mathrm{r}_{\mathrm{e}_{3}} ; \mathrm{r}_{\mathrm{h}_{1}}\right) \mathrm{i}_{3}\left(\mathrm{r}_{\mathrm{e}_{2}} ; \mathrm{r}_{\mathrm{h}_{3}}\right)$ is replaced by ${ }_{j}\left(r_{e_{2}} ; r_{h_{3}}\right)_{k}\left(r_{e_{3}} ; r_{h_{1}}\right)$. This carrier exchange, shown in $g .15$, indeed reads as an exchange skeleton, being sim ply $L^{(3)}(m ; n ; p ; i ; k ; j)$.

A nd so on, for any other carrier exchange we could think of.

Let us now consider the various diagram swe have found in calculating $A_{N}(m$;i) and understand why they are indeed equivalent, in the light of these exchange skeletons.

### 4.4 P aulidiagram $s$ w ith one exciton only di erent from 0

$W$ e rst take the sim plest of these P auli diagram $s$, nam ely the zigzag diagram $z^{(p)}(m ; 0)$ entering $\mathrm{N}(\mathrm{m})$, shown in g .2 .0 n its left, this zigzag diagram has pexcitons 0 and one exciton $m$, while on its right, the ( $p+1$ ) excitons are all 0 excitons. A fter sum $m$ ation over the interm ediate exciton indioes, the nalexpression of this $P$ aulidiagram m ust read as an integral of ${ }_{\mathrm{m}}\left(\mathrm{r}_{\mathrm{e}_{1}} ; r_{\mathrm{h}_{1}}\right)_{0}\left(r_{\mathrm{e}_{2}} ; r_{\mathrm{h}_{2}}\right) \ldots{ }_{0}\left(r_{\mathrm{e}_{\mathrm{p}+1}} ; r_{\mathrm{h}_{\mathrm{p}+1}}\right) \mathrm{multiplied}$ by $(\mathrm{p}+1)$ wave functions 0 w th the $\left(r_{e_{i}} ; r_{\mathrm{h}_{1}}\right)$ 's mixed in such a way that the integral cannot be cut into two independent integrals (otherw ise the P aulidiagram would be topologically disconnected).

This is exactly what the exchange skeleton $L^{(p+1)}(m ; 0 \quad ; 0 ; 0 ; \quad ; 0)$ does.T he possible perm utations of the various $\left(r_{e} ; r_{h}\right)$ 's in the de nition of this $L^{(0+1)}$, actually show that the $m$ index in the diagram $m$ atic representation of this exchange skeleton can be in any possible place on the left. This is also true for the $m$ position in the $P$ aulidiagram $s w$ ith all the indices equal to 0 except one. M oreover, the relative position of the crosses in these diagram s are unim portant (see g.16). This is easy to show, just by \sliding" the carrier exchanges, as explicitly shown in the case of three excitons (see g.17). In this gure, we have also used the fact that the $P$ auli scatterings reduce to one diagram when the two indices on one side are equal (see gs. 1d and 1e). This possibility to \slide" the carrier exchange, $m$ athem atically com es from the fact that ${ }^{P}{ }_{q}{ }_{q}\left(r_{e} ; r_{h}\right){ }_{q}\left(r_{e} i^{\prime} r_{h_{0}}\right)$ is


### 4.5 P aulidiagram $s$ w ith one exciton on each side di erent from 0

There are essentially two kinds of such diagram $s$ : E ither the two excitons (m ;i) di erent from 0 have no com $m$ on carrier, or they have one. Let us start with this second case.

### 4.5.1 m and i have one com m on carrier

Two di erent exchange skeletons exist in this case, depending if the com $m$ on carrier is an electron or a hole. They are show $n$ in gs. 18a and 18b. By \sliding" the carrier exchanges as done in g .18 c , it is easy to identify the set ofP aulidiagram swhich correspond to the sum of these two exchange skeletons (see g.18d). This in particular show s the identity of the $P$ auli diagram s of $g$. 18 e which enter the two diagram $m$ atic representations of $a_{N}(m$;i) shown in gs. 3b and 3c.

### 4.5.2 m and ido not have a com m on carrier

In this case, the number of di erent exchange skeletons depends on the number of 0 excitons involved.

For two 0 excitons, there is one exchange skeleton only (see g.19). By \sliding" the carrier exchanges, we get the two equivalent Pauli diagram s shown in g. 19.

They can actually be deduced from one another just by sym $m$ etry up/down, which results from $\mathrm{mnij}=\mathrm{nmji}$.

For three 0 excitons, there are two possible exchange skeletons which are actually related by electron-hole exchange (see gs. 20a and 20b). By sliding the carrier exchanges, we get the two diagram s of g .20 c , so that, by combining these two exchange skeletons, we nd the two Pauli diagram s of g. 20d.

In the sam ew ay, for four 0 excitons, there are three possible exchange skeletons, tw o of them being related by electron-hole exchange (see gs. 21a,21b,21c). By sliding the carrier exchanges, it is again possible to nd the Pauli diagram s corresponding to these exchange skeletons as shown in g .21.
4.6 Equivalent representations of the diagram $s$ appearing in $A_{N}(m ; i)$

By expressing the various P auli diagram s entering the expansion of $A_{N}(m$;i) in term $s$ of these exchange skeletons, as shown in gs. (16-21), it is now possible to directly prove their equivalence.

Fig. 22 show s the set of transform ations which allow s to go from the last third order diagram s of $={ }_{N}\left(m\right.$;i) to the zigzag Pauli diagram sof ${ }_{N}(m$;i), w th $i$ at the two upper positions.

The transform ation of the last fourth order diagram for $=_{N}(m$;i) into the tw om issing zigzag diagram $s$ of ${ }_{\mathrm{n}}(\mathrm{m} ; i)$ is som ew hat $m$ ore subtle. For the interested reader, let us describe in details how this can be done. W e have reproduced in $g .23$, the last fourth order diagram of $=_{\mathrm{N}}(m ; i)$, as it appears in $g .12 \mathrm{~b} . \mathrm{W}$ e see that all P auli scatterings have two 0 indioes on one side, except npq0. A coording to gs. 1a,1b, this npq0 can be represented by the sum of an electron exchange plus a hole exchange between the ( $\mathrm{q} ; 0$ ) excitons. By continuity, we represent each of the other $P$ auli scatterings which have two 0 excitons on one side, either by g. 1d or by $g$. 1e, the choice between these two equivalent representationsbeing driven by avoiding the crossings ofelectron and hole lines. This leads to the two diagram s of gs. 23b and 23c: They just correspond to exchange the role played by the electrons and the holes.

W e now consider one of these two diagram s, nam ely the one of g. 23b. Let us call 0, $0^{0}, 0^{\infty}$ and $0^{\infty 0}$ the four identical 0 excitons on the right, in order to recognize them m ore easily when we will redraw this diagram. To help visualizing this redraw ing, we have also given nam es to the various carriers. It is then straightforw ard to check that the diagram of g .23 b corresponds to the sam ecarrier exchanges as the ones of g.23d. Since the diagram of g .23 c is the sam e as the one of g .23 b , w th the electrons replaced by holes, we conclude that tw ice the ugly diagram of g . 23 a is indeed equal to the two m issing zigzag diagram sof ${ }_{\mathrm{n}}(\mathrm{m}$;i) reproduced in the top of this gure.

## 5 C onclusion

In this paper, we have essentially calculated the scalar product of $(\mathbb{N}+1)$-exciton states w ith N of them in the sam e state 0 . This scalar product is far from trivial due to m anybody e ects induced by \P auli scatterings" which originate from the com posite nature of excitons. A s a result, these scalar products appear as expansions in $=N V_{X}=V$, where $\mathrm{V}_{\mathrm{x}}$ and V are the excition and sam ple volum es, w th possibly som e additional factors N .

In order to understand the physical origin of these additionalN's | which willulti$m$ ately di erentiate superextensive from regular term $s \mid$ we have introduced the concept of excition dressed by a sea of excitons,

In the absence ofP auli interaction betw een the exciton i and the sea of $N$ excitons 0 , the operator in front of $B_{i}^{Y}$ reduces to an identity. D ue to P auli interaction, contributions on other exciton states $B_{m}^{Y}$ fiji appear in $j_{i}^{(N)} i$, which originate from possible carrier exchanges between the iexciton and the sea. W em oreover nd that a bosonic enhancem ent, which gives rise to an extra factor $\mathrm{N}, \mid$ reasonable for the exciton $\mathrm{i}=0$, since after all, excitons are not so far from bosons | also exists when the i exciton can be transform ed by carrier exchanges into a sea exciton. This happens for any exciton i having the sam e center of $m$ ass $m$ om entum as the sea excition.

In order to understand the carrier exchanges between N excitons, whidh make the scalar products ofN exciton states so tricky, we have introduced \P auli diagram s" . T hey read in term s of P auli scatterings betwen two excitons. $W$ ith them, we have show $n$ how
to generate a diagram $m$ atic representation of the scalar products of $(\mathbb{N}+1)$-exciton states w th N of them in the sam e state 0 , at any order in Pauli interaction.
$T$ his diagram $m$ atic representation is actually not unique. A though the one we rst give, is nicely sim ple to $m$ em orize, $m$ ore com plicated ones, obtained from other procedures to calculate the sam e scalar product, are equally good in the sense that they lead to the sam e correct result.

In order to understand the equivalence betw een these various $P$ aulidiagram $s$, we have introduced \exchange skeletons" which correspond to carrier exchanges between more than two excitons. Their appearance in the scalar products of N -exciton states is actually quite reasonable because, even if we can calculate these scalar products in term s ofP auli scatterings between two excitons only, Pauli exclusion is originally N -body \at once": W hen a new exciton is added, its carriers $m$ ust be in states di erent from the ones of all the previous excitons. The Pauli scatterings between two excitons generated by our $m$ any-body theory for interacting com posite bosons, are actually quite convenient to calculate $m$ any-body e ects between excitons at any order in the interactions. It is how ever reasonable to nd that a set of such P auliscatterings, which in fact correspond to carrier exchanges betw een $m$ ore than tw oexcitons, nally read in term softhese lexchange skeletons".

The present work is restricted to scalar products of N -exciton states in which all of them, except one, are in the sam e 0 state. In physical e ects involying N excitons, of course enter m ore com plicated scalar products. Such scalar products will be presented in a forthcom ing publication. T he detailed study presented here, is how ever all the $m$ ore useful, because it allow s to identify the m ain characteristics of these scalar products, which are actually present in $m$ ore com plicated situations: A $s$ an exam ple, in the case of two dressed excitions ( $i ; j$ ), a bosonic enhancem ent is found not only for $Q_{i}$ or $Q_{j}$ equal to $Q_{0}$, but also for $Q_{i}+Q_{j}=2 Q_{0}$, because these ( $i ; j$ ) excitons can transform them selves into two 0 excitons by carrier exchanges. The corresponding processes are represented by topologically disconnected Pauli diagram s, and extra factors N appear as a signature of this topology.
