Stripe O rder and M agnetic Transitions in La_{2 x}Sr_xN iO 4

M agnetic order has been investigated in stripe-ordered $La_2 \times Sr_x NiO_4$ (x = 0.275;0.37;0.4) by d.c. m agnetization and by polarized- and unpolarized-neutron di raction. In the m agnetically ordered phase, all three compositions exhibit a m agnetic transition consistent with a spin reorientation in the ab plane. For x = 0.37, the spin axes rotate from an angle of 37.7 0.3 to the stripe direction at 71 K, to 52.3 0.2 at 2 K. The x = 0.275 and 0.4 com pounds were found to undergo a sim ilar spin reorientation. A spin reorientation has now been observed to occur for ve di erent doping levels in the range 0.275 x 0.5, suggesting that this spin transition is an intrinsic property of the stripe phase.

I. IN TRODUCTION

 $La_{2 \times} Sr_{x}CuO_{4}$ (LSCO) and $La_{2 \times} Sr_{x}NiO_{4}$ (LSNO) are isostructural, but it is well known that LSCO superconducts¹ when su ciently doped whereas LSNO does not. In LSNO the doped charges are known to localize in the form of charge stripes, i.e. periodically spaced lines of charges at 45 to the NiO bonds. A ntiferrom agnetic ordering of the Nispins between the charge stripes sets in at lower tem peratures.² The charge-stripes act as antiphase dom ain walls to the antiferrom agnetic background. The pattern of incom mensurate m agnetic

uctuations in LSC O^3 resembles the magnetic order seen in LSNO, and this has been attributed to the existence of dynamic stripes in LSCO. The uctuations in superconducting LSCO are centred on wavevectors parallel to the Cu-O bonds,⁴ but the uctuations in the nonsuperconducting state, 0.024 x 0.053, are centred on wavevectors at 45 to the Cu-O bonds.⁵ These parallels suggest that charge stripe correlations may play an important role in superconducting LSCO.⁶

Charge-stripe order has been studied in LSNO by neutron^{2,7,8,9,10,11} and x-ray^{12,13,14} di raction for doping levels in the range 0.135 x 0.5. As well as being static on the time scale probed by neutrons and x-rays, the charge stripes are found to be well correlated with correlation lengths in excess of 100A for certain levels of doping.^{2,13,14} T hese two properties make LSNO a good system for studying the basic properties of spin-charge stripes.

These studies have revealed many key facts about charge-stripe ordering including the variation of the stability of charge-ordering with doping. LSNO with x = 1/3 has stripe order that is particularly stable owing to a commensurability e ect that pins the charges to the lattice.^{2,9,15} F igure 1 (a) shows the commensurate charge-ordering that occurs for x = 1/3. A lthough this gure

show s the charge stripes only residing on the N i sites, recent tunnelling electron m icroscopy work has shown the charge stripes can also reside on the O sites.¹⁶ T he charge order is even m ore stable for x = 1=2, form ing a theckerboard' pattern in the N iO₂ layers at tem eratures below

450 K , which becomes slightly incommensurate below 180 K $\cdot^{10,17}$




FIG.1: (a) M odel for the stripe pattern ordering in the ab plane of ${\rm La}_{5=3}\,S\,r_{1=3}\,N$ iO $_4$. C incles represent holes residing on Ni^{3^+} sites, while the solid arrows represent the Ni^{2^+} spins. Dashed lines indicate the charge dom ain walls of the stripeorder. The occurence of purely Nicentred stripes may not be realized in practice, especially for $x \in 1=3$. The observed spin order in $La_{1:63}Sr_{0:37}N$ iO $_{4+}$ is sim ilar to that show n, but is actually incommensurate in the direction perpendicular to the stripes. The components of the ordered moment parallel $\binom{k}{k}$ and perpendicular $\binom{2}{2}$ to the stripe direction are show n, and denotes the angle between the spin axis and the stripe direction. (b) Diagram of the (h; h; l) plane in reciprocal space. Q $_{\rm 1}$ and Q $_{\rm 2}$ are the scattering vectors of two m agnetic Bragg peaks of the stripe order, chosen to be approxim ately parallel and perpendicular to the caxis. The particular positions shown in the diagram are those investigated for the case x = 0:37.

Lee et al.⁸ studied the magnetic order in LSNO crystals

with x = 0.275 and 1=3 with polarized neutrons in order to determ ine the direction of the ordered m om ent. They concluded that at T = 11 K the spins in the N i-O₂ layers are aligned at an angle to the stripe direction, where = 27 for x = 0.275 and 52.5 for x = 1=3. How ever, for the x = 1=3 they found a reorientation transition at $T_{\rm SR}$ ' 50 K such that on warming the spins rotate by an angle of = 12.5 towards the stripe direction. Freem an et al.¹¹ studied a sam ple with x = 1=2 and observed a similar spin reorientation transition: in this case at T = 2K = 78, $T_{\rm SR}$ ' 57 K, and = 27.

A lthough this much is known about the spin orientation in LSNO the trends have not yet been fully established, and the mechanism driving the spin reorientation is not understood. Our new study was undertaken to try to address these questions by studying doping levels other than 1=3 and 1=2.

We studied single crystals of La_{2 x} Sr_xN iD₄ grown by the oating-zone method,¹⁸ using the techniques of magnetom etry, (x = 0.275;0.37;0.4), polarized-neutron di raction (x = 0.37) and unpolarized-neutron di raction (x = 0.275;0.4). The charge and magnetic ordering tem peratures were found to be in good agreement with previous work on sam ples of sim ilar doping.^{2,10} The data reveal a spin reorientation sim ilar in size and orientation to that in La₅₌₃Sr₁₌₃N iD₄, but which is slower and occurs at lower tem peratures, 10K, for all three doping levels studied. These spin reorientations, unlike those in the x = 1=2 or 1=3 doped materials, all occur for incom-mensurate doping levels.

II. MAGNETIZATION MEASUREMENTS

M agnetization data were collected with a superconducting quantum interference device (SQUID) m agnetom eter (Q uantum D esign), with the eld applied parallel to the ab plane of the crystal. The crystals used for the m agnetization m easurem ents had typical dimensions 5 5 2 m m³. We carried out dc m easurem ents either by cooling the sample in an applied eld of 500 0 e parallel to the ab plane (FC), or by cooling in zero eld then m easuring while warming in a eld of 500 0 e (ZFC).

In gure 2 we show the variation of the FC and ZFC m agnetizations for x = 0.37. A subtle change of slope at 240 10 K, marks the charge-ordering tem perature, with a more pronounced gradient change at 160 10 K m arking the spin-ordering tem perature. We observe from these results that this material exhibits irreversible m agnetic behaviour, with a large FC {ZFC di erence below

50K and a much smaller di erence that persists to the charge-ordering temperature T_{CO} 240K with a slight widening around the magnetic ordering temperature, T_{SO} 180K. This is a typical feature for magnetization results on LSNO compounds that will be reported in detailelsewhere.¹⁹ O fm ost concern to the present work is the smallbut sharp drop in magnetization observed at T_{SR} 10K. The inset of gure 2 shows the eld de-

pendence of T_{SR} , which can be seen to decrease when increasing the applied eld.




FIG. 2: FC and ZFC magnetization data for La_{1:63}Sr_{0:37}NiO₄₊. A rrows indicate the charge-ordering temperature, $T_{\rm CO}$, spin-ordering temperature, $T_{\rm SO}$, and the spin-reorientation temperature, $T_{\rm SR}$, determined separately by neutron di raction. The inset shows the eld dependence of the onset temperature of the spin reorientation.




FIG .3: FC and ZFC m agnetization data for La $_2$ $_x$ Sr_xN iO $_{4+}$ x = 0.275 and 0.4.

Figure 3 shows the variation of FC and ZFC magnetizations for the x = 0.275 and x = 0.4. Like x = 0.37, both these materials are observed to have irreversible magnetic behaviour. The ZFC magnetization of the x = 0.275 crystalhas a rounded maximum at 10K.For x = 0.4 there is no maximum, but the increase in magnetization with decreasing temperature rst slows down and then begins to rise sharply below 5K. The increase below 5K could be due to a small amount of paramagnetic in purity in the crystal.

III. NEUTRON DIFFRACTION MEASUREMENTS

The polarized neutron experim ents were perform ed on the triple-axis spectrom eter IN 20 at the Institut Laue-Langevin. The energies of the incident and elastically scattered neutrons were selected by Bragg re ection from an array of Heusler alloy crystals. The data were obtained with initial and nal neutron wavevectors of 2.66A¹. A PG Iter was present between the sam – ple and the analyzer to suppress scattering of higherorder harm onics. The unpolarized neutron experiments were perform ed on the triple-axis spectrom eter R ITA –II at SINQ at the Paul Scherrer Institut. The energies of the incident and elastically scattered neutrons were selected by Bragg re ection from a PG crystal. The data

were obtained with initial and nal neutron wavevectors of 1.55 Å 1 , and a Be liter operating at 77 K was present between the sample and the analyzer to suppress scattering of higher-order harm onics.

For x = 0.275;0:37, single crystal rods of 7{8mm diam eter and 45mm in length were used, and for x = 0.4the crystal was a slab of dimensions 15 10 4mm³. In this work we describe the structural properties of LSN 0 with reference to a tetragonal unit cell, with unit cell parameters a 3:8A, c 12:7A. The samples were mounted with the [001] and [110] crystal directions in the horizontal scattering plane. Scans were performed in reciprocal space either parallel to the (h, h, 0) direction at constant 1, or parallel to the (0, 0, 1) direction at constant h.

We begin by discussing the polarized-neutron di raction results for x = 0.37. Initially, the neutron polarization P was arranged to be parallel to the scattering vector Q, by an adjustable guide eld of a few m T at the sample position. In this con guration a neutron's spin is ipped during an interaction with electronic m agnetic m om ents, but rem ains unchanged when scattered by a non-m agnetic process, e.g. a lattice distortion. Thus by m easuring the spin- ip (SF) and non-spin- ip (NSF) channels one can identify whether observed scattering is m agnetic or not in origin.

M agnetic orderB ragg peaks were observed at (h+1=2"=2, h + 1=2 "=2, l) positions for all integer l. This can be seen in gure 4(a), which shows the SF scattering for a scan parallel to (h; h; 0) for l = 5 at T = 2K. The peak positions corresponds to " = 0.3554 0.0002, consistent with previous m easurem ents.²

Figure 4 (b) show sthe NSF scattering for the same scan as Fig. 4 (a). The scan contains 2 weak peaks, one at




FIG.4: (a) The spin ip (SF) diraction channel for a scan parallel to (h; h; 0) for l = 5 for $La_{1:63} Sr_{0:37} N$ io 4 at T = 2 K. This peak corresponds to the magnetic order peak, and is centred at h = 0.678. (b) The non-spin ip diraction for the same scan. The arrow indicates the charge-order B ragg peak. The second peak is diraction from the magnetic order peak observed in the NSF channel due to the imperfect spin polarization of the neutron beam.

h = 0.6460.001 corresponding to charge ordering with an incommensurability of " = 0.3540.001, and the other at h = 0.678 corresponding to magnetic ordering. The latter appears in the NSF channel due to imperfect polarization of the neutron beam . W e searched for the charge order peak at other equivalent (0:646; 0:646; 1) positions, but only at l= 3 and 5 was there a m easurable peak. From the temperature dependence of the charge peak in Fig. 4(b) we found T_{CO} 230K.By perform ing scans parallel to (h; h; 0) we were able to obtain the in-plane charge-order correlation length perpendicular to the stripe direction of 70 6A. This compares with a correlation length of 49 5A along the caxis. These results show that the charge order is relatively three-dim ensional.




FIG. 5: Spin- ip (SF) and non-spin- ip (NSF) diraction from $La_{1:63}Sr_{0:37}N$ iO 4 at T = 2K. The scan is parallel to (0,0,1) and passes through the magnetic-order peak (0.6775, 0.6775,1). No correction has been made for the imperfect polarization of the neutron beam. The additional peaks in the NSF channel at 1 4.4 and 5.4 are due to diraction from the Alsam ple mount.

Figure 5 shows a scan parallel to (0; 0; 1) through the magnetic order peaks. The widths of the peaks in this scan relate to the correlation length along the c-axis, how every e observed that the correlation lengths for even and odd 1 di er by a factor 2. That is, for even 1 we obtain a correlation length of 53.2 1.4 A and for odd 1 we obtain a correlation length 108 2 A .W e perform ed scans parallel to (h; h; 0) on odd 1 peaks, for which we obtained an in-plane correlation length perpendicular to charge stripe direction of 112.6 1.1 A.

The intensities of the even and odd lm agnetic peaks were discussed in work on La₂N iO₄₊, by P.W ochner et al.²⁰ For a commensurate stripe spin-ordering, such as " = 1=3, the stripes stack in a body centred arrangement and only the odd lm agnetic peaks are observed, with the systematic absence of the l= even peaks. How ever, for incommensurate spin-ordering with the stripes either

pinned to the N iorO sites,¹⁶ perfect body-centred stacking cannot be achieved. The disorder thus created, along with the additional disorder introduced due to di ering C oulom b interactions between the ab layers, result in the presence of l = even peaks. Hence, l = odd peaks have a long correlation length as they come from the ideal long range body-centred stacking, whereas l = even peaks are a result of the disorder created on the sm aller length scale of the non-ideal stacking.

In gure 1(b) are shown the positions of two magnetic re ections $Q_1 = (0.3225, 0.3225, 3)$ and $Q_2 =$ (0.6775,0.6775,1). The vectors Q $_{\rm 1}$ and Q $_{\rm 2}$ are directed close to (0; 0; 1) and (h; h; 0), respectively. Since m agnetic neutron di raction is sensitive to spin components perpendicular to Q, the scattering at Q_1 arises mainly from the total in-plane spin moment, while that at Q_2 com es mainly from the spin components parallel to the stripe direction and along the c axis. Hence, we perform ed scansparallel to (h; h; 0) through Q₂ at di erent tem peratures to give a st indication as to whether there exists an in-plane spin reorientation like those observed for x = 1=3 and 1/2. Figure 6 (a) shows the tem perature dependence of the magnetic re ection Q_2 . The magnetic ordering transition can be seen to occur at T_{SO} ' 170K. On cooling below T_{SO} the intensity of Q ₂ can be seen to increase m onotonically until it reaches a m axim um at ' 20 K, then it is seen to decrease in intensity continuously to our base tem perature. This anom alous behaviour correlates well with the transition observed in the magnetization, Fig. 2, and indicates a spin reorientation below ' $20 \,\mathrm{K}$.




FIG.6: (a) The temperature dependence of the intensity of the magnetic Bragg peak at $Q_2 = (0.6775; 0.6775; 1)$ see gure 1 (b). (b) The temperature dependence of the angle between the spin axis and the stripe direction obtained from polarized-neutron analysis.

To fully analyze the direction of the spins over this temperature range we varied the direction of the neutron polarization P relative to the scattering vector Q, m easuring at the Q₁ and Q₂ positions. The method is described in Ref11, where the expressions used to obtain the spin direction are given. A correction for the slightly non-ideal perform ance of the polarization elements of the instrument was calculated from the ipping ratio of 18 1 m easured on the magnetic B ragg peaks.

Polarization analysis of both the Q₁ and the Q₂ B ragg peaks revealed that the moment lies in the ab plane to within 1 in the temperature range 2 71K. Having established this, we subsequently assumed the c-axis com – ponent to be zero and analyzed the polarization at Q₁ to determ ine the in-plane moment. From this analysis we determ ined that the spins rotated from an angle of 37.7

0.3 to the stripe direction at T = 71K to 52.3 0.2 at T = 2K, as shown in Fig. 6(b). The transition occurs mainly between 10 and 20K, but slowly develops from below 50K.




FIG. 7: The tem perature dependence of the intensity of the magnetic Bragg peak at $Q_2 = (0.645; 0.645; 0)$ for x = 0.275, and at $Q_2 = (0.685; 0.685; 1)$ for x = 0.4.

We performed unpolarized neutron di raction at equivalent Q₁ and Q₂ positions on the single crystals with x = 0.275 and x = 0.4, using the instrum ent R ITA – II at SINQ.We found a similar behaviour to the x = 0.37results just described. In particular, the tem perature dependence of the Q₂ = (0.645,0.645,0) m agnetic B ragg peak for x = 0.275, and of the $Q_2 = (0.685, 0.685, 1)$ m agnetic Bragg peak for x = 0.4, both have a maximum similar to that shown in Fig. 6 (a) for x = 0.37. By contrast, the intensities of the Q_1 Bragg peaks are almost constant below 20 K. The temperature dependence of the Q_2 intensity is shown on Fig. 7 for both x = 0.275 and x = 0.4. The drop in Q_2 intensity at low temperature in plies a spin reorientation in x = 0.4 and x = 0.275 similar in nature to that in x = 0.37.

U npolarized neutron di raction cannot accurately determ ine without a detailed analysis of the intensities of many di raction peaks, but we can estim ate from the drop in intensity of the Q $_2$ peak below $T_{\rm SR}$ $10\,\rm K$ and the value of for $T > T_{\rm SR}$, assuming the ordered m om ent remains in the ab plane and xed in magnitude in this temperature range. Taking = 27 above $T_{\rm SR}$ for $x = 0.275,^8$ and using = 38 for x = 0.4 (based on the observations for x = 0.37 at 71 K). We nd

10 15 for both x = 0.275 and x = 0.4, sim ilar to x = 0.37.

IV. DISCUSSION AND CONCLUSIONS




FIG.8: Variation of the spin reorientation tem perature, $T_{\rm SR}$, with doping level, x. The line is a guide to the eye indicating the possible trend.

There are di erences and sim ilarities between the spin reorientations reported here for x = 0.275, 0.37 and 0.4 and those that occur for x = 1/3,⁸ and x = 1=2.¹¹ In each case the spins rotate in the same sense, away from the stripe direction on cooling. The size of the reorientation in x = 0.37 (' 14.5) (and more approximately in x = 0.275 and 0.4) is sim ilar to that in x = 1/3 (' 13), but sm aller than in x = 1/2 (' 26). However, in x = 0.37;0.275 and 0.4 the spin reorientation

occurs at a much lower tem perature, T_{SR} ' 10K, com – pared with T_{SR} ' 50K for x = 1/3 and T_{SR} ' 57K for x = 1/2. Figure 8 sum marises the variation of T_{SR} with x that has so far been established for the doping range 0.275 x 0.5. The results indicate that if there is no commensurate charge ordering the spin reorientation occurs 10K, but if there is a commensurate charge ordering the spin reorientation occurs at 50K.

There is also evidence of a trend in the direction of the ordered m om ent. The base tem perature spin orientations are 53 for x = 1/3, 52 for x = 0.37, and 78 for x = 1/2, with charge ordering tem peratures of 240K, 230K,

480K respectively. We can add to this list an estim ate of 38 43 for x = 0.275, (charge ordering tem perature

200K) based on the angle of 27 at 11 K found by Lee et al.⁸, with an additional 10 15 due to the spin reorientation on cooling to 2K. Hence, there seems to be a correlation between the spin orientation angle and the charge-ordering temperature. Further measurements on samples with doping levels between x = 0.4 and 0.5 would be useful to con m this trend.

Up to now, spin reorientations in La_{2 x} Sr_xNiO₄ had only been observed in materials with especially stable charge order (x = 1=3 and 1/2). The existence of a spin reorientation in x = 1/2 has shown that a commensurate spin-stripe order is not required for a spin reorientation to occur.¹¹ The new results on x = 0.275, 0.37 and 0.4 presented here further show that not even commensurate doping is required. It is likely that LSNO at all doping levels in the range 0.275 x 0.5 undergo a spin reorientation, but that T_{SR} is larger at the commensurate doping compositions.
