## The stochastic dynam ics of nanoscale m echanical oscillators immersed in a viscous uid

The stochastic response of nanoscale oscillators of arbitrary geometry immersed in a viscous uid is studied. Using the uctuation-dissipation theorem it is shown that determ inistic calculations of the governing uid and solid equations can be used in a straightforward manner to directly calculate the stochastic response that would be measured in experiment. We use this approach to investigate the uid coupled motion of single and multiple cantilevers with experimentally motivated geometries.

Single molecule force spectroscopy using nanoscale cantilevers in mersed in uid is a tantalizing experimental possibility [1, 2]. The precise manner in which nanom echanical devices will be utilized for single-molecule force spectroscopy and sensing is currently under development [3, 4], however the detection system will rely upon the change in response of the cantilever due to the binding of target biomolecules. It is therefore important to build a baseline understanding of the motion of a uid loaded cantilever, or arrays of cantilevers, in the absence of active molecules. This is the focus of this Letter.

The dynam ics of the nanoscale structures considered are dominated by Brownian uctuations although the mechanical structures are still large compared to the molecular size of the uid molecules. The elastic response of a single cantilever immersed in uid has been investigated previously in the context of atom ic force m icroscopy (see for example [5, 6]). This theoretical approach, essentially two-dimensional in nature, modelled the cantilever as an in nite cylinder oscillating in an unbounded uid. This approach has been experimentally validated for long and slender micron-scale cantilevers [6]. However, the response of nanoscale cantilevers (very strong uidic dam ping) or short and wide cantilevers (where end e ects would be important) is not well understood. U sing the uctuation-dissipation theorem we show that determ in istic num erical simulations of the cantilever- uid system can be used to obtain experim entally relevant stochastic quantities such as the noise spectrum of the uctuations.

The uctuation-dissipation theorem allows for the calculation of the equilibrium uctuations using standard determ inistic num erical methods. This is possible because the same molecular processes are responsible for the dissipation and the uctuations. In the case under consideration here, predom inantly these are the collisions of the uid molecules with the cantilever, although dissipative processes within the elastic material of the cantilever could also be included. The uctuation-dissipation theorem comes in many forms. For the uid-damped motion of nanoscale cantilevers it is su cient to use a classical formulation. The most convenient form is the one originally discussed by Callen and G meene [7] (see also [8]). Consider a dynam – ical variable A. For the classical system of interest here this will be a function of the microscopic phase space variables consisting of 3N coordinates and conjugate momenta of the cantilever, where N is the number of particles in the cantilever. We investigate the situation where a force f (t) that couples to A is imposed. In this case the H am iltonian of the system is

and we bok at the linear response for very smallf. Then it can be shown for the special case of a step function force given by,

that in the linear response regime, the change in the average value of a second dynam ical quantity B (again any function of the 3N coordinates and momenta) from its equilibrium value in the absence of f is given by

where =  $(k_B T)^1$ ,  $k_B$  is Boltzm ann's constant, T is the absolute temperature, A = A  $hAi_0$ , B = B $hBi_0$  and the subscript zero on the average hi denotes the equilibrium average in the absence of the force f. Thus we can calculate a general equilibrium cross-correlation function in terms of the linear response as

There are no approximations involved in this result, except that of assuming classical mechanics and linear behavior. If in addition the dynamical variables are suf-

ciently macroscopic that the mean hB (t)i can be calculated using determ inistic, macroscopic equations, we have our desired result.

There are a number of advantages to a form ulation of the uctuation-dissipation theorem in time rather than frequency for our purposes. First, the full correlation function is given by a single (num erical) calculation, the response to removing a step force. The spectral properties can be obtained by Fourier transform. This is particularly advantageous for the low -quality factor (Q) situation characteristic of uid-dam ped nanoscale cantilevers, since the spectral response is very broad, and a large number of xed-frequency simulations would be needed to characterize this response. A second advantage is that no expansion in modes of the oscillator is needed. A though such an expansion is not too hard for a high-Q oscillator where the dissipation has negligible in uence on the mode shape, for small cantilevers in a uid, the coupling to the uid is large, and the motion of the uid com plex, so that a mode analysis would be quite di cult. Finally, the expression Eq. (4) allows us to calculate the correlation function and noise spectrum of precisely the quantity m easured in experiment, rstly by tailoring the applied force to couple to one physical variable m easured in the experiment (A), and then determining the e ect on the second physical variable (B). This idea has been exploited in the very high-Q situation of the oscillators used in gravitational wave detectors [9], although there it was convenient to form ulate the result in the frequency dom ain. In our case for example, if the displacem ent of the cantilever is measured through the strain of a piezoresistive layer near the pivot point [3, 4] of the cantilever, it is possible to tailor the force F to couple to this distortion, and so determ ine the \strain-strain" correlation function of one or more cantilevers.

O ur scheme consists of the following steps in a deterministic simulation: (i) apply the appropriate force f, constant in time, small enough so that the response remains linear, and tailored to couple to the variable of interest A, and allow the system to come to steady state; (ii) turn o the force at a time we labelt = 0; (iii) measure some dynamical variable B (t) (which might be the same as A to yield an autocorrelation function, or different) to yield the correlation function of the equilibrium uctuations via Eq. (4). Using the sophisticated num erical tools developed for such calculations, we can

nd accurate results for realistic experimental geometries that may be quite complex, for example the triangular cantilever design often used in commercial atom ic force microscopy, or the reduced stiness geometries currently under investigation for use as detectors of single biomolecules as shown if Fig. 1.

For simplicity, we illustrate our approach by noting the auto-and cross-correlation functions for the displacements  $x_i$  (t) of the tips of one or two nanoscale cantilevers with experimentally realistic geometries. To do this we calculate the deterministic response of the displacement of each tip, which we call X<sub>i</sub>(t) i = 1;2, after switching o at t = 0 a small force applied to the tip of the

rst cantilever,  $F_1$ , given by Eq. (2). For this case the equilibrium auto- and cross-correlation functions for the

uctuations  $x_1$  and  $x_2$  are precisely

The cosine Fourier transform of the auto and cross-correlation functions yield the noise spectrum G $_{11}$ () and G $_{12}$ (), respectively, which are the experimentally relevant quantities.

W e have perform ed three-dim ensional tim e-dependent num erical simulations of the determ inistic uid-solid coupled problem (algorithm described elsewhere [10, 11]). The uid motion is calculated using the incom pressible Navier-Stokes equations and the dynamics of the solid structures are computed from the standard equations of elasticity.

For long (l & 100 ) and slender (l >> w) cantilevers, the cantilever response can be well approximated as an in nitely long oscillating cylinder [5, 6]. We rst validate our num erical approach by investigating a cantilever in this regime. We emphasize that for the experimentally motivated nanoscale cantilevers of interest here an approximate theory is not available, yet our numerical approach remains valid providing a means to gain valuable insight.




FIG.2: Panel (a) the noise spectrum from simulation (solid line) and from theory (dashed line). For the theory calculation only the fundam entalm ode has been considered. Panel (b) is a schem atic of the m icron-scale cantilever used for validation: length l = 197, width w = 29 and height h = 2. The applied step force is  $F_1 = 26$  nN.

The micron-scale cantilever used for validation has the simple beam geometry as shown in Fig.2 (b) (see case c2 in [6]). For micron and nano-scale cantilevers immersed in uid, dissipation is dominated by the viscousm otion of the uid driven by the cantilever vibrations. This can be described by a Reynolds number based on the frequency of oscillation ! as  $R = !w^2=4$  where is the uid density and is the kinematic viscosity. For the cantilevers of interest here the Reynolds numbers are typically 0.01 . R . 1 indicating that this is in the low Reynolds number regime. Small corresponds to strong dissipation.

The noise spectrum , G $_{11}$  ( ), is calculated from the numerical results by taking the cosine Fourier transform

of the autocorrelations and is shown by the solid line in Fig.2(a). The two broad peaks can be identified with the

rst two modes of the cantilever. The noise spectrum is also calculated using the long cylinder analytic approximation and is shown by the dashed line. The analytical result for the fundam entalm ode of the noise spectrum is found in the following manner [5] (note that higher harmonics could be included if desired). In Fourier space the equation of motion for the cantilever displacement is

where  $\hat{F_{f}}$  is the force felt by the cantilever due to the uid,

 $\hat{F_B}$  is the uctuating (B rownian) force,  $m_e$  is the e ective mass [14] of a uid cylinder of radius w=2, m is the e ective mass of the cantilever, and (!) is the hydrodynamic function (for an in nitely long cylinder of diameter w oscillating in the x-direction) which contains both the

uid dam ping and uid loading components and is given by [12],

where K<sub>1</sub>, K<sub>0</sub> are Bessel functions and  $i = \frac{p_{-1}}{1}$ . From the uctuation-dissipation theorem the spectral density of the uctuating force, G<sub>FB</sub> (), can be related to the dissipation due to the uid and is given by

where ! = 2. Solving for the spectral density of the displacement uctuations,  $G_x$  (), from Eqs. (7), (8) and (10) yields,

A recent study of the uid coupled motion of two adjacent 1 beads illustrates the importance of understanding




FIG.3: Schem atic showing various cantilever con gurations. In all con gurations the step force  $F_1$  is released at t = 0 resulting in the cantilever motion referred to by  $X_1$  (t). The motion of the neighboring cantilever is,  $X_2$  (t), and is driven through the response of the uid. Panel (a) two cantilevers with ends facing, panel (b) side-by-side cantilevers and panel (c) cantilevers separated along the direction of the oscillations

the cross correlations in the uctuations for use in single m olecule force m easurements [13]. The uid disturbance caused by an oscillating cantilever is long range, producing motion of the other cantilevers through the viscous drag. As a result, the stochastic motion of multiple cantilevers will be correlated. How ever, the num erical approach developed here remains valid for multiple

uid-baded cantilevers of arbitrary geometry, and our approach can be used to quantify the response of multi-

ple cantilevers with the precise com plex geom etries used in experiment (as we show below) as well as to help develop a better analytical understanding of idealized geom etries. Various possible cantilever con gurations are shown in Fig. 3 (a)-(c); here we will present results for the end to end case and defer results for the other geom etries to a later paper.




FIG. 4: Absolute predictions of the auto- and crosscorrelation functions of the equilibrium uctuations of the cantilevers shown in Figs. 1 and 3. Panel (a) a schem atic of the step force boundary condition that is applied to the tip of the rst cantilever,  $F_1 = 75pN \cdot Panel$  (b) shows the autocorrelation and panel (c) the cross-correlation of the uctuations (5 separations are shown s = h; 2h; 3h; 4h; 5h where only s = h; 5h are labelled and the remaining curves lie between these values in sequential order).




FIG.5: Panel (a): The noise spectrum,  $G_{11}$  (). Panel (b): The noise spectrum,  $G_{12}$  (), as a function of cantilever separation, s, for two adjacent experim entally realistic cantilevers (see Fig.1). Five separations are shown s = h;2h;3h;4h;5hwhere only s = h;5h are labelled and the remaining curves lie between these values in sequential order.

W e use our approach to calculate the behavior of the experimentally motivated cantilever show n in Fig.1. Full three-dimensional simulations were performed for both one cantilever and two cantilevers facing end to end in uid as shown in Fig. 3(a). Through the uctuationdissipation theorem the simulations yield results for the cantilever autocorrelation function and the two cantilever cross-correlation function shown in Fig. 4 (b) and (c), respectively. The response of the driven cantilever (on the left) was not signi cantly a ected, for any of the separations investigated, by the presence of the adjacent passive cantilever on the right. The value of  $hx_1(0)x_1(0)i$  is 0:471nm<sup>2</sup> indicating that the de ection of the cantilever due to Brownian motion in an experiment would be 0:686nm or about 2:3% of the thickness of the cantilever. The cross-correlation of the Brownian uctuations of two cantilevers is small compared with the individual uctuations. The largest magnitude of the of the crosscorrelation is 0.012 nm<sup>2</sup> for s = h and 0.0029 nm<sup>2</sup> for s = 5h. The noise spectra for both the one and two cantilever uctuations, given by the cosine Fourier transform of the cross-correlation function, are shown in Fig. 5(a)

and (b). Notice that tuning the separation could be used to reduce the correlated noise in some chosen frequency band.

The variation in the cross-correlation behavior with cantilever separation as shown in Figure 4 (c) can be understood as an inertial e ect resulting from the nonzero Reynolds number of the uid ow, as follows. The ow around the cantilever can be separated into a potential component, which is long range and propagates instantaneously in the incom pressible uid approximation, and a vorticity containing component that propagates di usively with di usion constant given by the kinem atic viscosity. For step forcing, it takes a time  $v = s^2 = for$ the vorticity to reach distance s. For sm all cantilever separations the viscous component dom inates, for nearly all times, and results in the anticorrelated response of the adjacent cantilever in agreem ent with [13]. How ever, as s increases the am ount of time where the adjacent cantilever is only subject to the potential ow eld increases resulting in the initial correlated behavior.

In summary, a numerical approach to calculate the stochastic response of single and multiple nanocantilevers, of arbitrary geometry, immersed in a viscous

uid using determ inistic calculations has been developed, validated, and applied to an experim entally relevant cantilever geom etry. The m ethods described here are applicable to atom ic force m icroscopy in general and also to other nano-structure uid interaction problem swhich are of growing importance as NEMS technology advances.
