## A bstract


#### Abstract

We rst reobtain in a sim plerway the H aldane fractional statistics at them al equilibrium using an interpolation argum ent. W e then show that the $m$ ean occupation number for fractional statistics is invariant to a group of duality transform ations, a nonabelian subgroup of fractional linear group.


## 1 Introduction

In the two-dim ensional system s the particles are not constrained to obey the Ferm ior B ose statistics but they $m$ ay have fractional statistics; tw o well know n exem ples are o ered by the quasi-particles in the fractionalquantum $H$ alle ect and by anyons. P rom pted by this, H aldane [1] stated a generalized exclusion principle that allow s for interm ediate statistics, though his derivation of the particle occupation num ber does not involve the spatial dim ensionality and so, it seem $s$ to be valid for an arbitrary num ber of dim ensions. W u [2] discussed the them odynam ics of the fractional statistics particles (geons) in the idealgas approxim ation. Further developm ents on the them odynam ical aspects ofgeons can be found in [3], [4]. In an akin paper [5] to the present one, it w as show $n$ that the distribution funtion for geons en joys a duality property. Q uite recently, a num ber of authors [6], starting from an appropiate de nition for indistinguishability in the phase space, have obtained a nontrivial classical counterpart of H aldane's exclusion principle.
$T$ he purpose of this Letter is rst, to rederive, using a very sim ple interpolating argum ent, the occupation num ber distribution for geons at them al equilibrium. Then, based on this derivation, we show that the relation for the occupation num ber rem ains invariant under a certain num ber of dual transfor$m$ ations that organize in a group and we discuss the $m$ eaning of these dualities.

## 2 M odel

A very long tim e ago, when the black body radiation form ula was still under scrutiny, a sim ple argum ent based on intenpolation has been put forw ard in (7). $T$ he argum ent goes as follow $s$ : Let be " the $m$ ean energy for a radiation eld, averaged over time in a xed unit volum e. U sing the equality of tim e averages and phase spase averages one can write for the $m$ ean squares values $\overline{"^{2}}$ of the uctuating energy that

Em pirically, the $m$ ean square value gets contributions from low frequencies (the R ayleigh-Jeans part of the spectrum ), where the $m$ ean energy ${ }^{*}=k T$; therefore

It also gets contributions from high frequencies (the $W$ ien part of the spectrum ), where the $m$ ean energy ${ }^{*}=h \exp \frac{h}{k T}$; hence

W th the underlying assum ption that the two contributions act independently and are of equal weight, relation (1) reads as

It is $m$ ore convenient to use the dim ensionless variables $n=\frac{\pi}{\|}, \frac{h}{k T}=$ that lead to the di erentialequation:

The solution is

T his is, the P lanck law, here w th $=\overline{\mathrm{kT}}, \mathrm{m}$ erely an integration constant. $T$ his derivation em phasises the w ave-particle character of bosons.

H ow this reasoning can be extended for other statistics? $N$ ote that this type of interpolation w orks equally well for ferm ions. H ow ever, for ferm ions, as long as " < , the long wavelength (high tem perature) is negative:

and accordingly, relation (5) m ust be m odi ed to

W hen we take into account that $n$ 1, we obtain, as solution, the Ferm i distribution:

Introducing a genuine interpolation param eter $g$, i.e. a param eter ranging in the $[0 ; 1]$ interval, one can w rite in a single stroke, for both ferm ions and bosons:

w ith the solution

$N$ ote that this represents also, as a particular case, for $g=\frac{1}{2}$, the M axw ell distribution function. The above intenpolating form ula has also been obtained in Refs. 8 .

At thism om ent wem ay ask what otherm odi cationsm ust be brought to (9) if one would allow for interm ediate statistics betw eeen B ose and Ferm iones on one hand, relation (9) suggests a series expension in pow ens ofm ean occupation num ber $n$. This is what we $m$ ight expect because an intenpolating statistics presum ely contains m ore param eters and its com plete characterization needs higher $m$ om ents and/or higher powers of the rst $m$ om ent. O $n$ the other hand, higher order tem $s$ in (9) $m$ ust be $m$ ultiplied, for sure, by the factor $g\left(\begin{array}{ll}g & 1) \text {, }\end{array}\right.$ that exchudes for standard ferm ionic $(g=1)$ and bosonic $(g=0)$ statistics any extra term $s$ which, obviously, do not occur in (10). Lim iting ourselves to the next higher order term $n^{3}$ and using again the independence and equal weights assum ption (w ith the exception of $g\left(\begin{array}{ll}g & 1) \text { factor), we arrive at }\end{array}\right.$

The di erential equation can be solved by an elem entary integration. To this purpose and for later reference we $m$ ake the change of variable:

The di erential equation transform $s$ to

Form ulas (13) and (15) together gives im plicitely the $m$ ean occupation num ber as function of inverse tem perature. The physicalm eaning of the param eter $g$ can be drawn from the zero tem perature $\lim$ it (! 1 ):

Therefore, $\frac{1}{g}$ represents the $m$ axim um num ber of particles a quatum state can accom m odate. A ctually, form ulas (13), (15) represent exactly the particle distribution for geons at therm al equilibrium obtained by $H$ aldane [1] from a counting argum ent and from equilibrium condition requirem ents while (16) expresses the generalized exclusion principle.

W e have unfolded the derivation starting from the $m$ ean square value of the energy just to rem ind an historicalargum ent 7]. O fcourse we could have started from the $m$ ean square value of the $m$ ean num ber directly. It is an well-know $n$ fact that the uctuations in the num ber ofbosons is super-poissonian:

while for ferm ions is sub-poissonian:

The advantage of the above derivation of fractional statistics over the standard one consists in its sim plicity. The shortcom ing lies in the fact the form ulas for $n$ are valid only at equilibrium .

W hat are the transform ations that leave invariant the occupation num ber form ulas invariant, i.e. form ulas (13) and (15)? To be m ore speci c, we look for transform ations for $w$ that, while preserving the substitution (13) intact, $m$ akes relation (15), or, under the sam e boundary condition, the di erantialequation (14), form -invariant. An earlier derivation for such a tranform ation (5] and a theoretical prejudice lead us to consider transform ations of the form :

They are know $n$ astransform ationsbelonging to the m odulargroup SL ( $2, G$ ), or the fractional linear group, where $G$ stands for $C, R$ or $Z$ depending on whether the coe cients $a, b, c, d$ are com plex, real or integer, respectively. The group m ultiplication law m ay be represented by a 22 m atrix $=\mathrm{a} \mathrm{b}$
w ith unit determ inant $a d-\infty d=1$. T he theoretical prejudice alluded above refers to the fact the $S L(2, Z)$ has been found relevant for the com plex conductivities in the quantum H alle ect [8].

W e substitute Eq. (19) into the di erential equation (14) and look for the coe cients $a, b, c$ and $d$ that leave the equation in sam $e$ form. $R$ ather long but straightforw ard algebra show s that, excepting the identity, there are only
ve possible tranform ations of type (19) that leave the geon distribution form invariant. These transform ations ( $t_{k}$ ) are:

The rst transform ation has also been rem arked and derived in a di erent way in [5]. The others are new. N ote that in som e transform ations ( $t_{2}$ and $t_{5}$ ) the coe cients m ust be im aginary to com ply w ith the requirem ent of unit determ inant $\mathrm{ad}-\mathrm{c} b=1$.
$T$ hese transform ations deserve the nam e ofdualities because they extend the theory from weak values of the statistical param eter $g 2[0 ; 1]$ to strong values of the param eter g 2 [1;1] or the other way around. Indeed, starting with a weak $g 2[0 ; 1]$, transform ations $t_{1}$ and $t_{4}$ lead to form ulas valid on the whole realaxis for $g$ and on the range $g 2[1 ; 1]$, respectively. Starting $w$ ith a strong g $2[1 ; 1]$, transform ation $t_{3}$ leads to form ulas valid on the range $g 2[0 ; 1]$. Transform ations $t_{2}$ and $t_{5} \mathrm{~m}$ ap the dom ain of validity for $g$ (both $g$ and $g \mathrm{~m}$ ust be necessarily positive) into them selves. The dual distributions hold true at a tem perature scaled w ith a function of $g$, at energies below ( $t_{2}$ and $t_{5}$, 0 ) or above Ferm i level ( $t_{1}, t_{2}$ and $t_{4}, 0$ ).

A distribution with a greater than unit $g$ supports two interpretations:
(i) as a distribution forparticles; a physicalrealization is the H ubbard m odel [9], where due to the in nite repulsion, tw o sites can be occupied by at $m$ ost one electron. $(\mathrm{g}=2)$ : and
(ii) as a distribution for vacancies. For instance, the generalized exclusion principle (16) states that $\frac{1}{9}$ is them axim um num ber ofparticles a quantum state can accom $m$ odate; then $\frac{1}{g}$, where $g$ is the dual of $g$ under $t_{1}$ would represent the $m$ inim um num ber of states available for one particle.

The relationshipsbetw een a speci c distribution and its dualare given below

$T$ he last relationship is som ehow peculiar. A pparently, due to $g$ ! $1 \quad \mathrm{~g}$ transform ation, it seem $s$ to convert the distribution for ferm ions or near ferm ions g $\frac{1}{2}$ into the distribution for bosons or near bosons $g \quad \frac{1}{2}$ and vioe-versa, but the dualn $(\mathrm{e} ; \mathrm{g})$ of $\mathrm{n}(; \mathrm{g})$ is, in this case, negative

The above dualities im pose constraints on the expansion coe cients of therm odynam ic functions. For instance, the duality (20a) leads to a vanishing zero tem perature heat capacity ( R efs. 5-8). A detailed derivationand analysis of these constraints are relegated to an extended paper. H ere we are content to re$m$ ark that all ve transform ations are needed for these transform ations to close upon them selves, i.e. to form a group. $W$ e think the group property is the $m$ ost rem arkable feature and we give below the table for the group com position law :

where to denotes the identity. The left multiplication corresponds to entries along colum $n$, the right $m$ ultiplication to entries along row s. It is worthy to note that transform ations $t_{j}, j=3 ; 4$ are inverse of each other, a fact that can also be seen from rels. (20.3), (20.4)

## 3 C onclusions

To sum up, we have proved that the fractionalstatistics distribution is invariant to a nite, nonabelian subgroup of the fractional linear group.

W e have discussed the duality in term s oftransform ations that, while leaving the theory invariant, relate two di erent \coupling constant" $g$ regim es. There exists, also, anotherm eaning of duality in this letter, as illustrated, for instance, in relation (4), nam ely, the wave-particle duality. The rst term in the RHS of rel. (4) features the particle-like character of bosons and the second, the
w ave-like character. T he fact the two term s sim ply add togather expresses the complem entarity of the two features. In standard quantum $m$ echanics, this duality is embodied in the usual $m$ om entum -position com $m$ utator. We may wonder if the new ly introduced term $g(g 1) n^{3}$ for fractional statistics, in relation (12) signals the existence, in an analogous way, of another level of duality.

In view of the above rem arks it is tem pting to put forw ard the follow ing con jecture: there $m$ ust exist another type of duallyy, in the sense above, but betw een vortioes and particles (as in som em odels for anyons [11]). The con jecture is rather speculative at the m om ent. W e hope to retum w ith a m ore rigorous statem ent in the next future.
